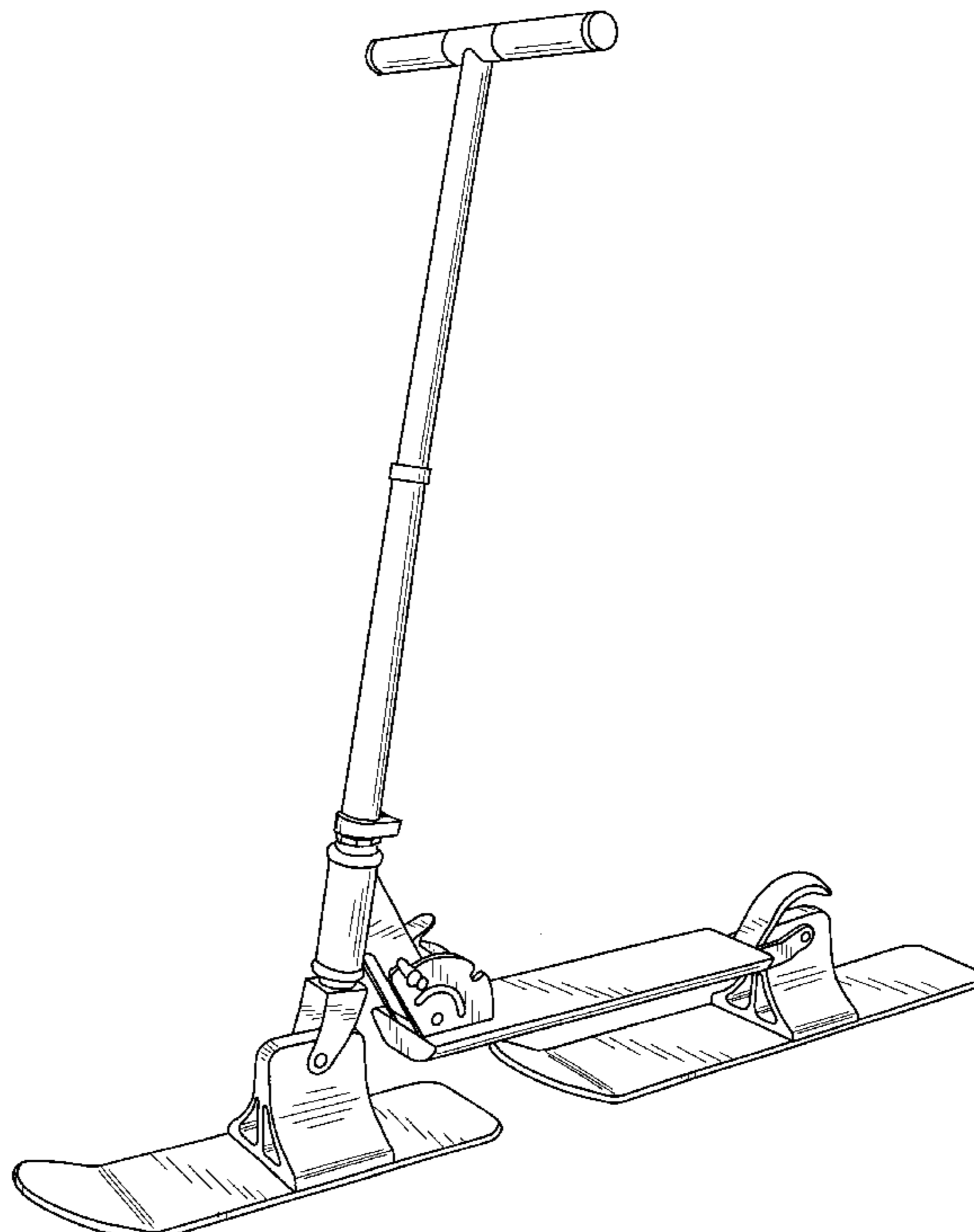

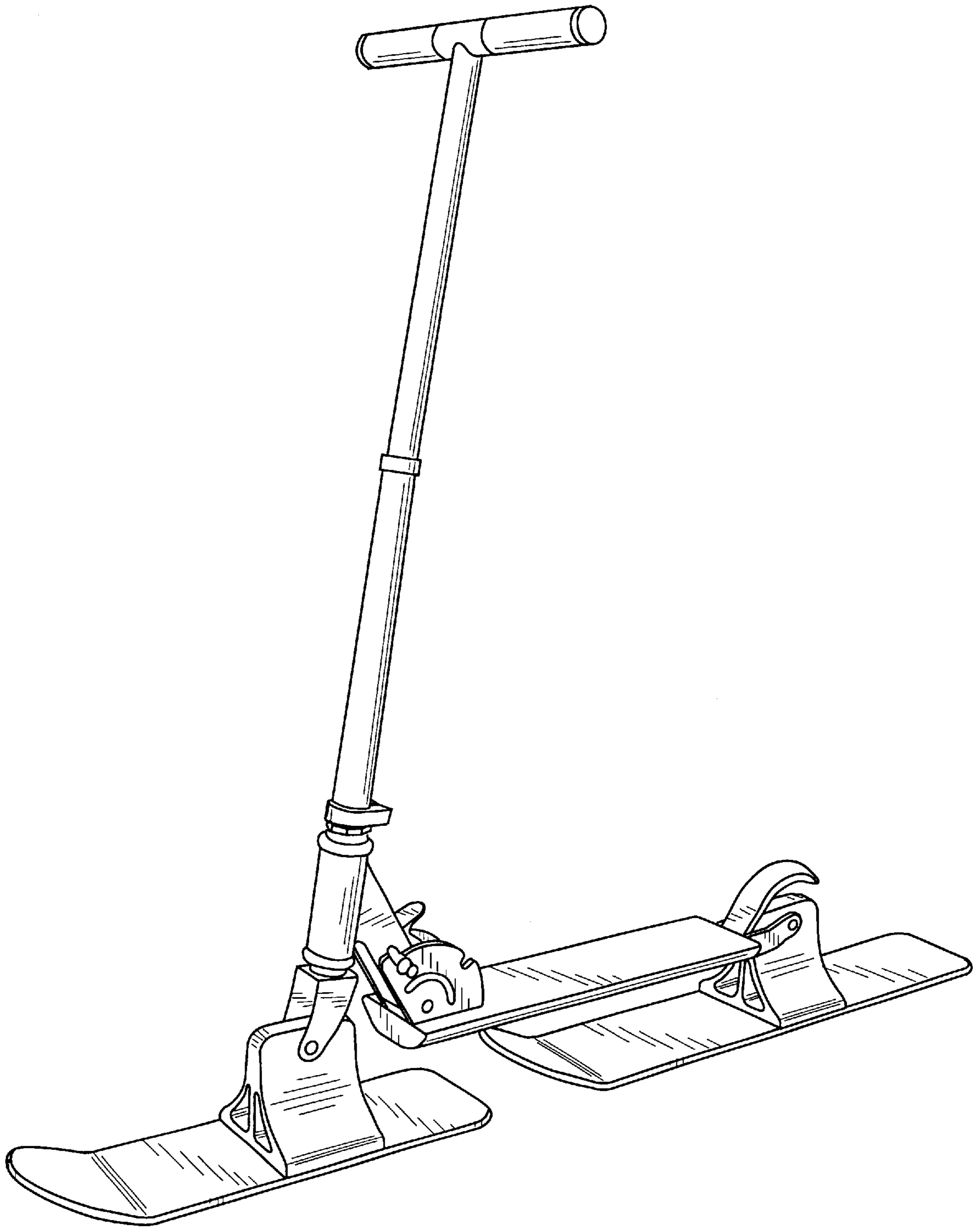
The ornamental design for a ski fitted scooter, as shown and described

**DESCRIPTION**

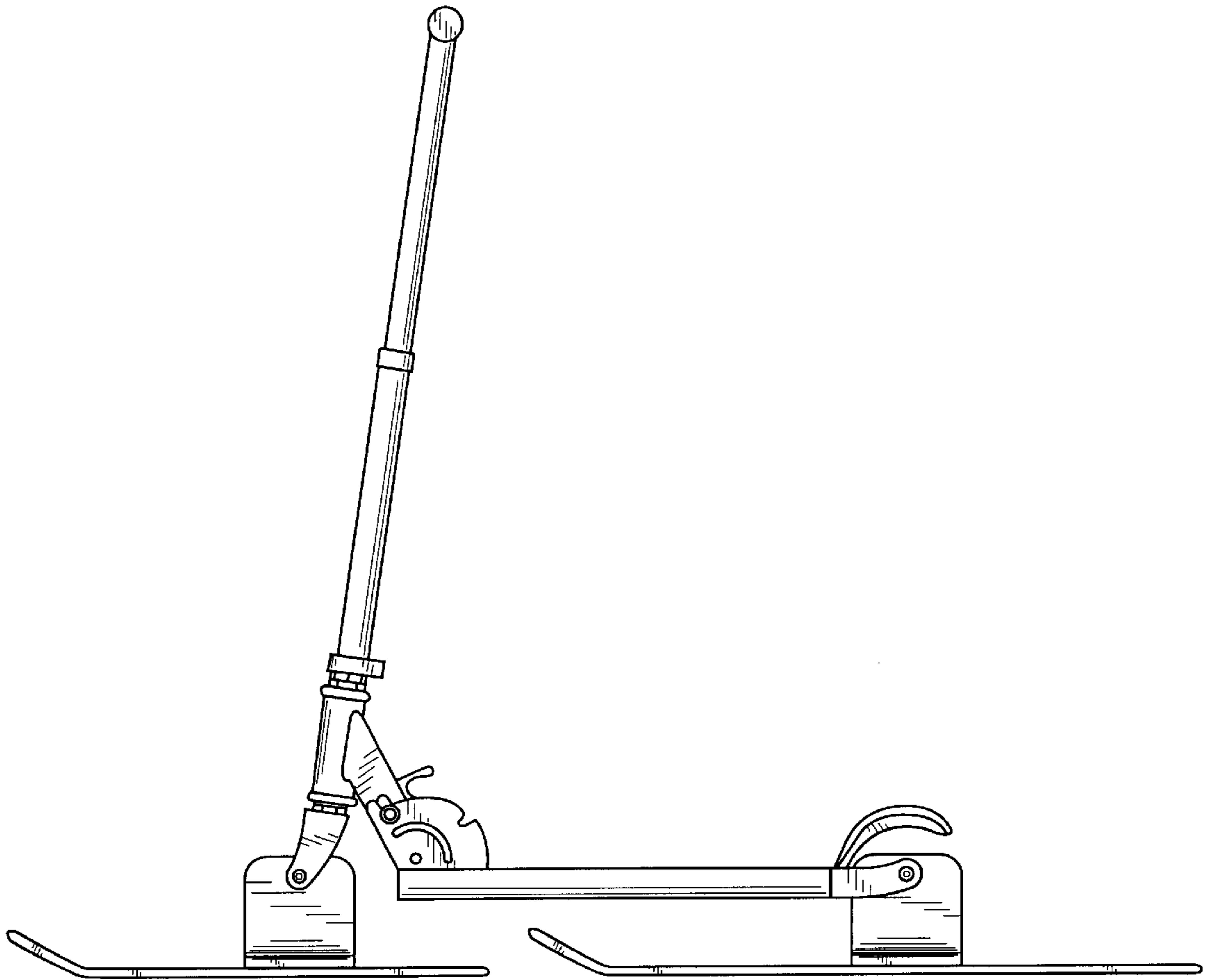
FIG. 1 is a perspective view of a ski fitted scooter showing my new design;

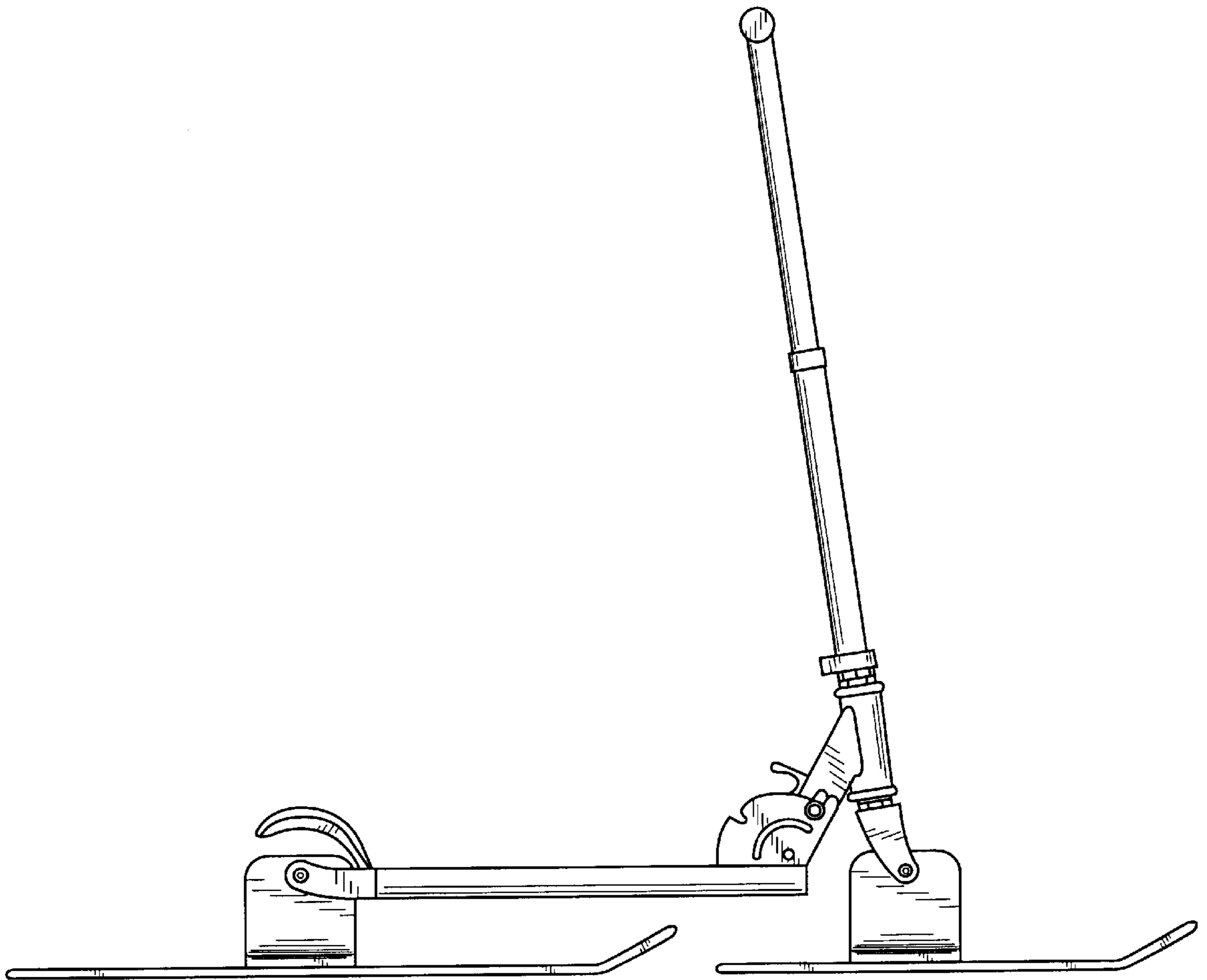




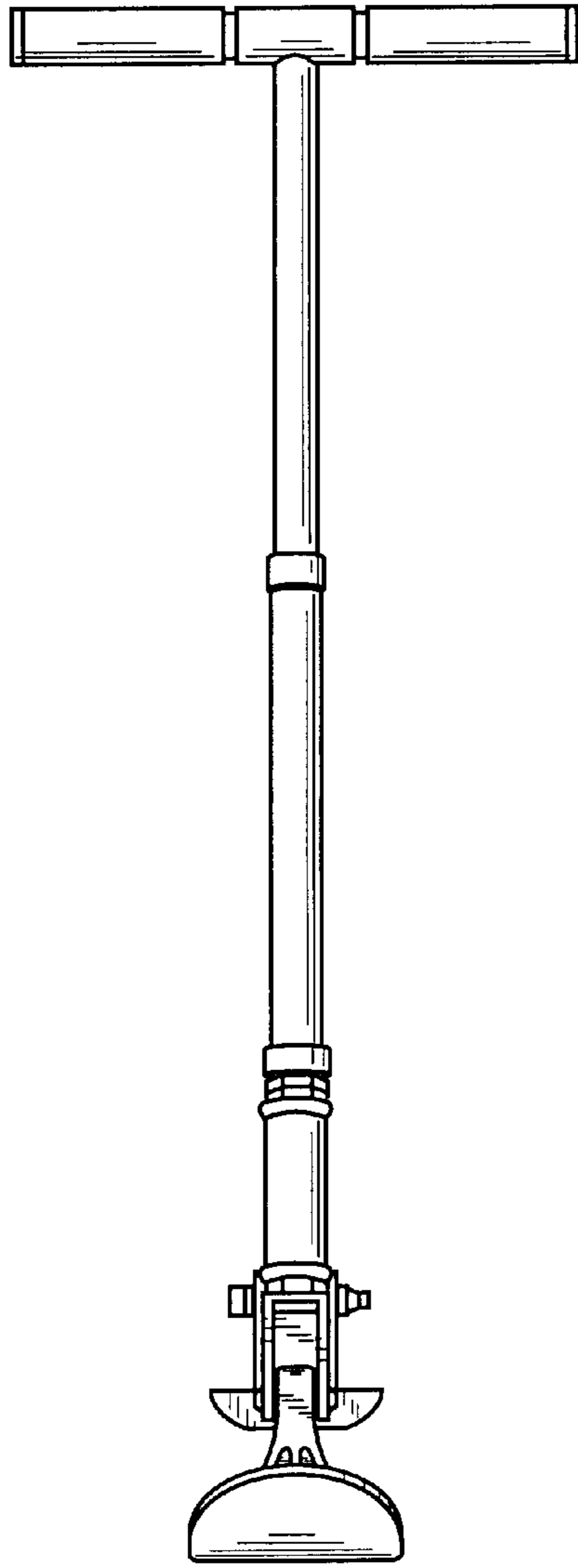

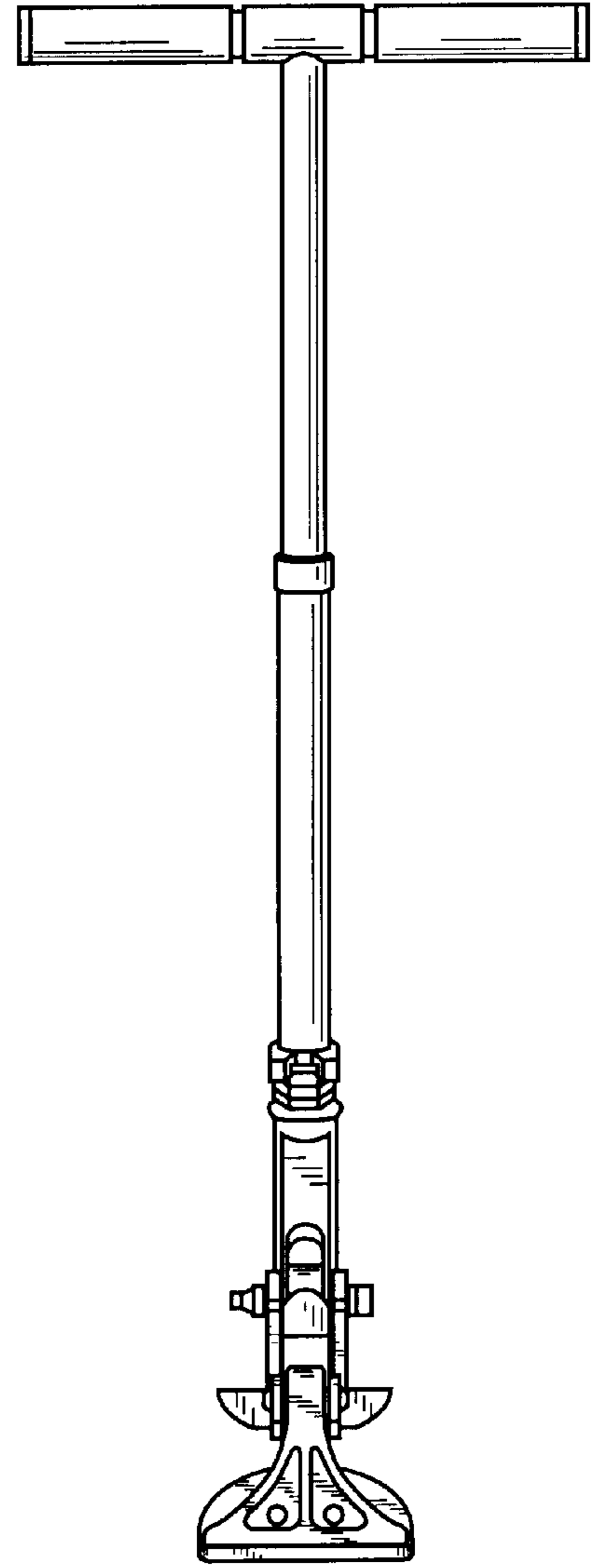

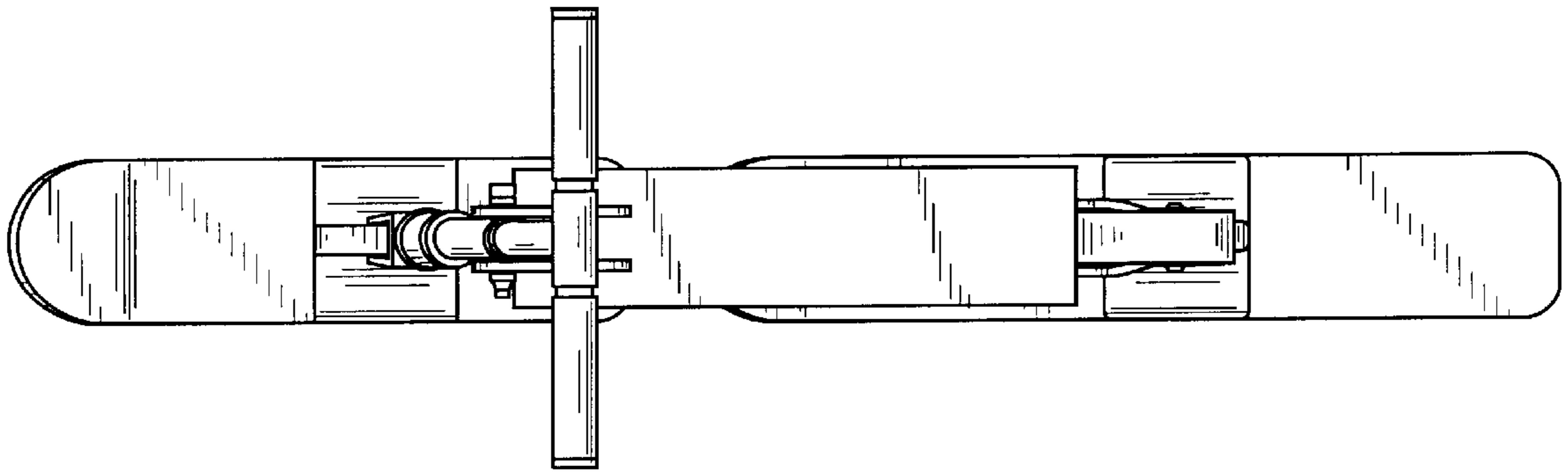

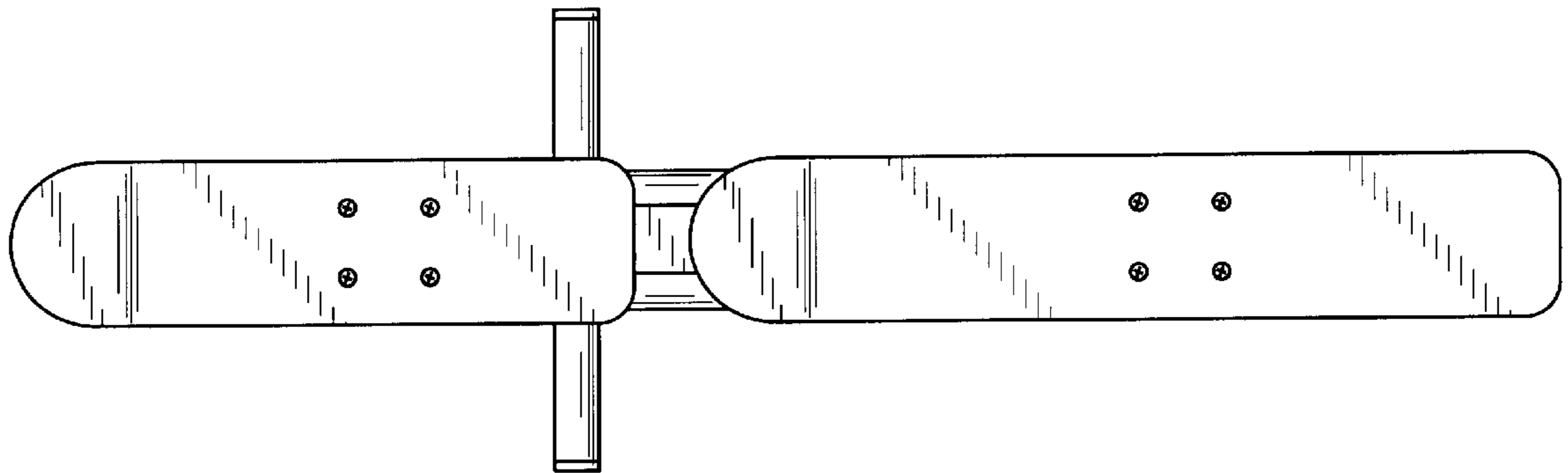
