(57) **CLAIM**

The ornamental design for a faucet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our new design for a faucet; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a right side view thereof, the left side being the same as the right side; FIG. 5 is a rear view thereof; and, FIG. 6 is a bottom view thereof.

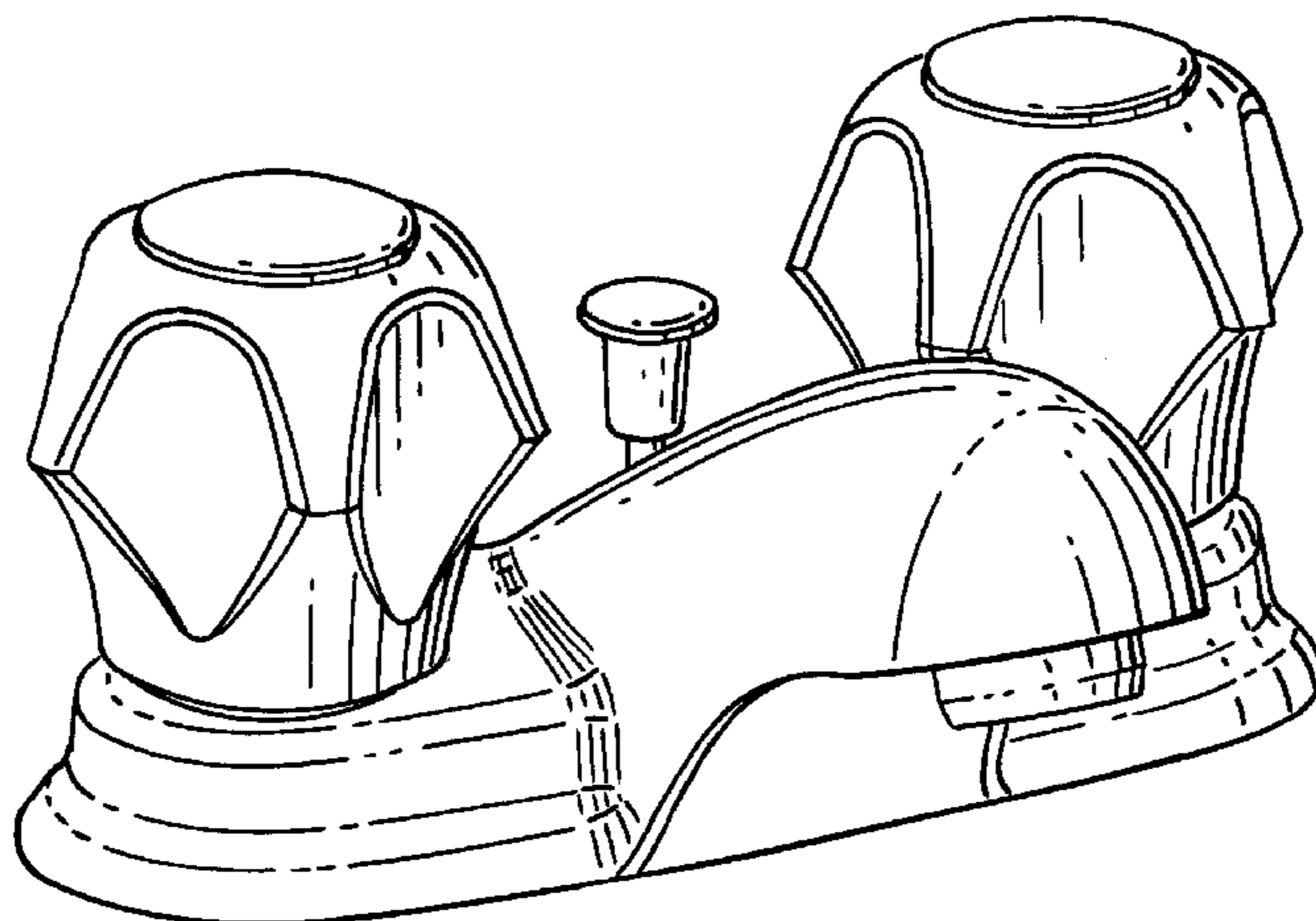

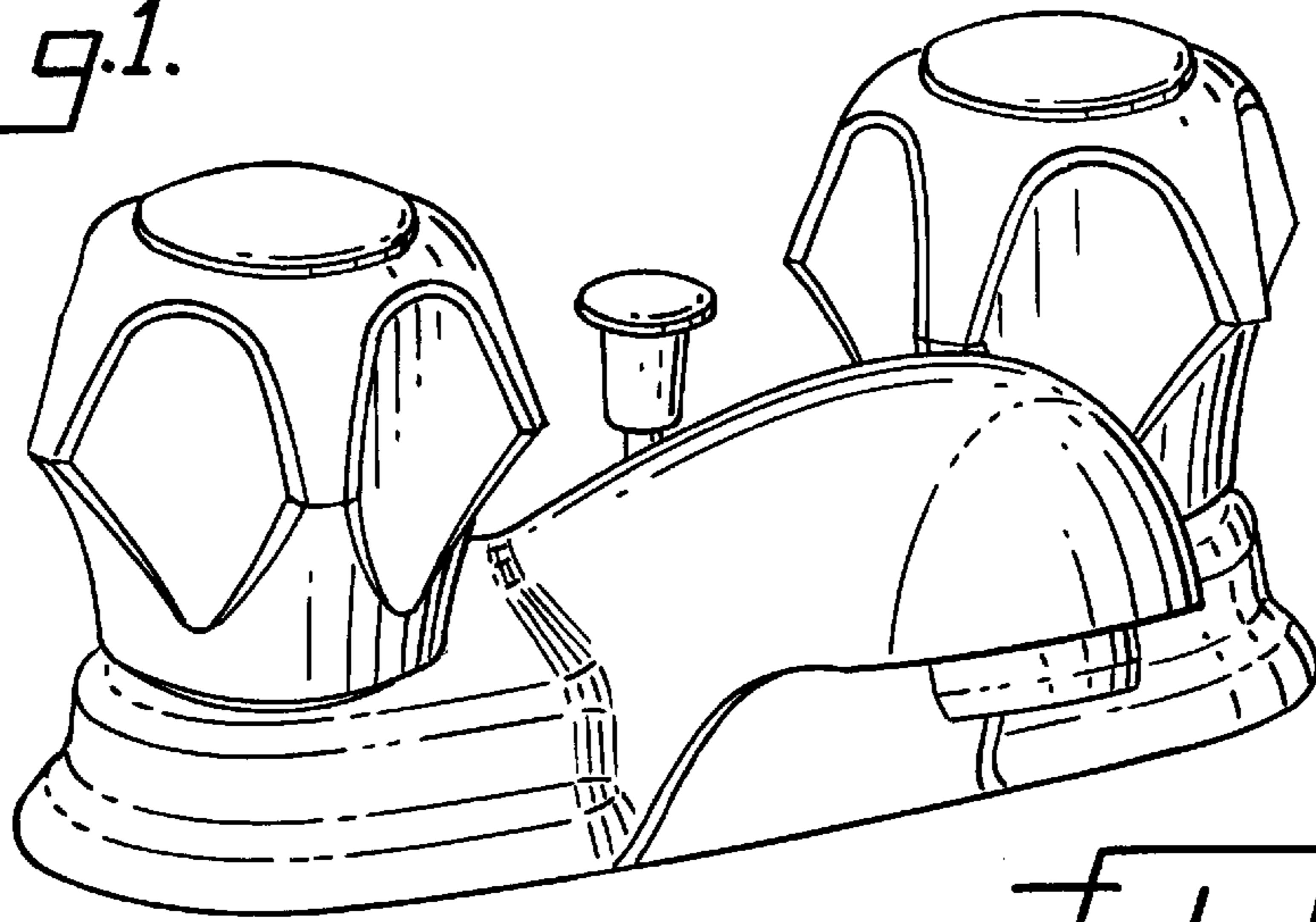

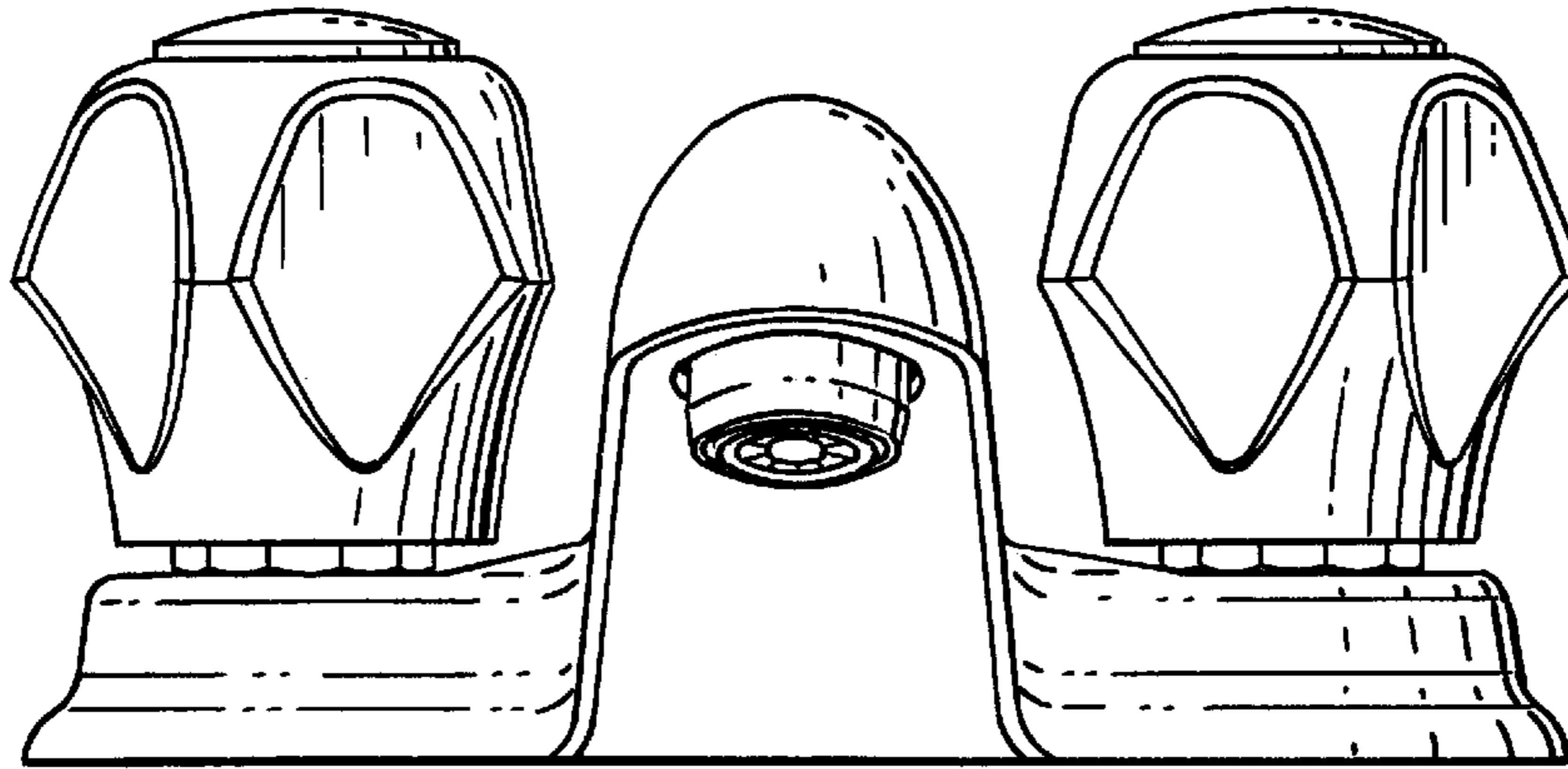
