FIG. 9 is a further perspective view showing the design in use with an alternate cosmetic container shown in broken lines.

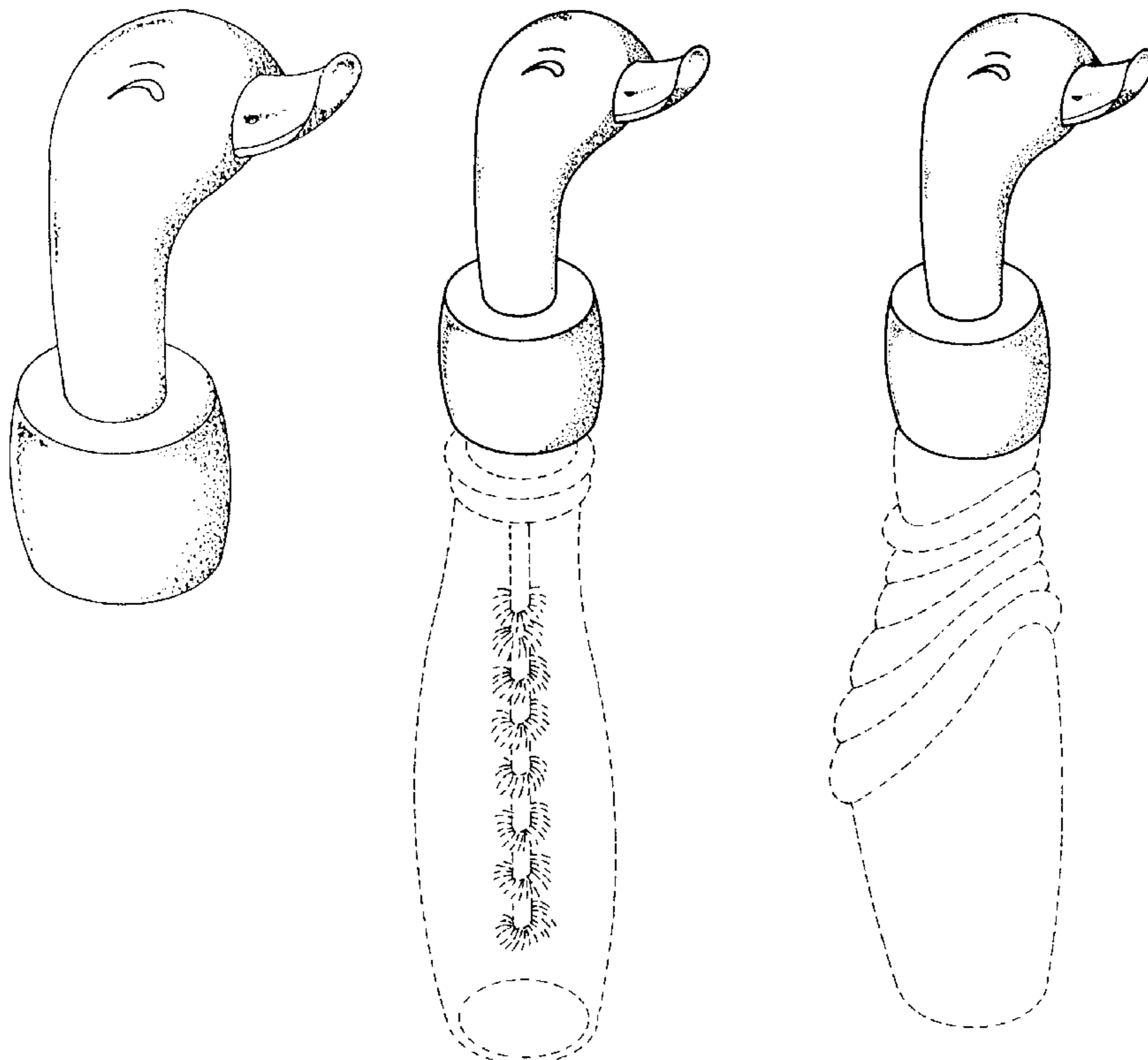

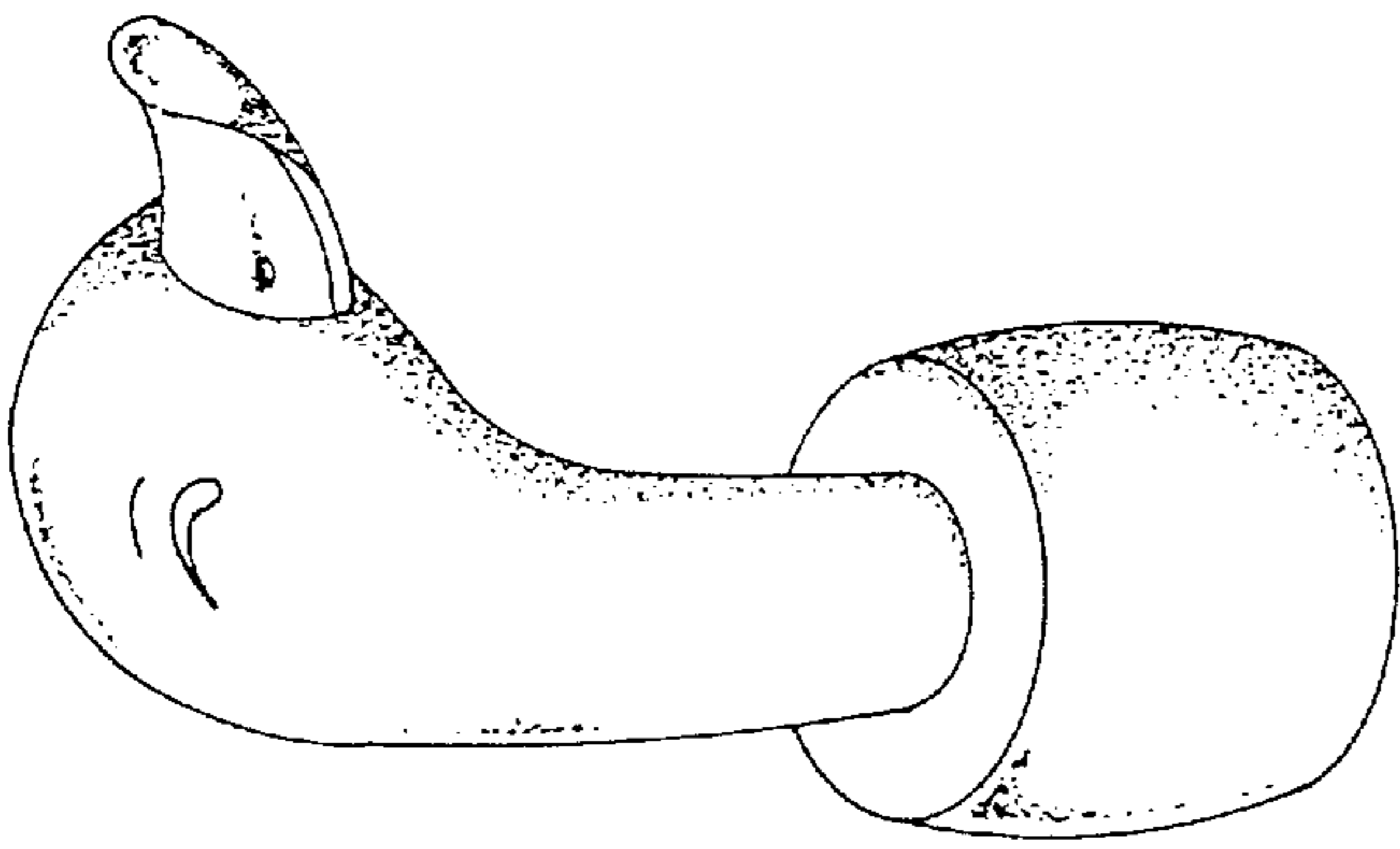

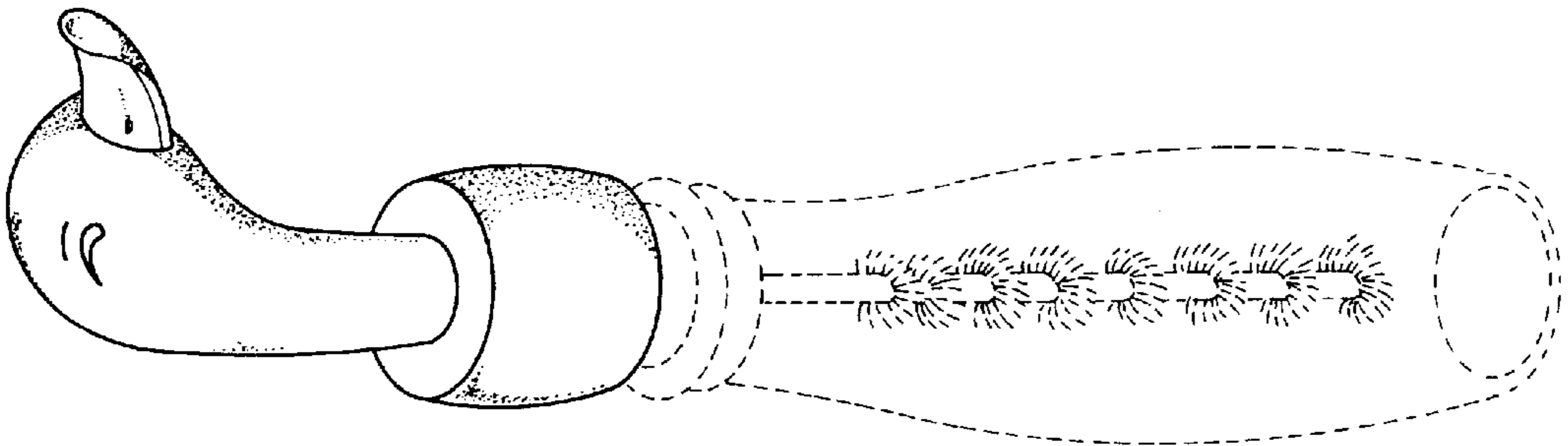

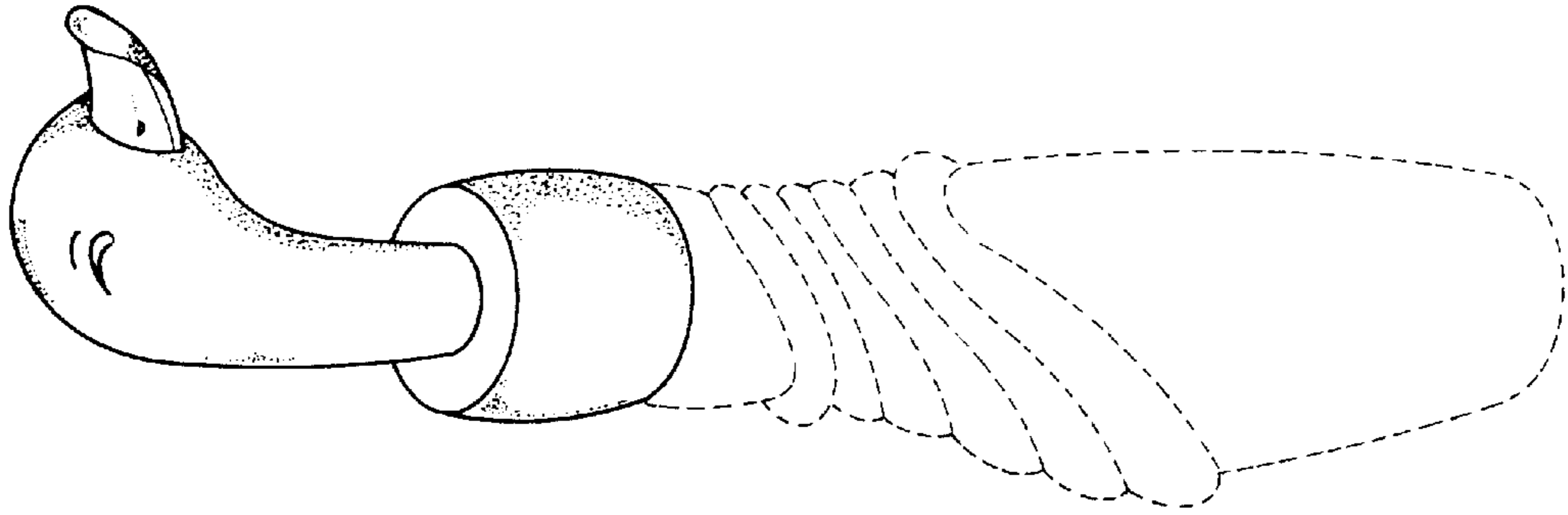

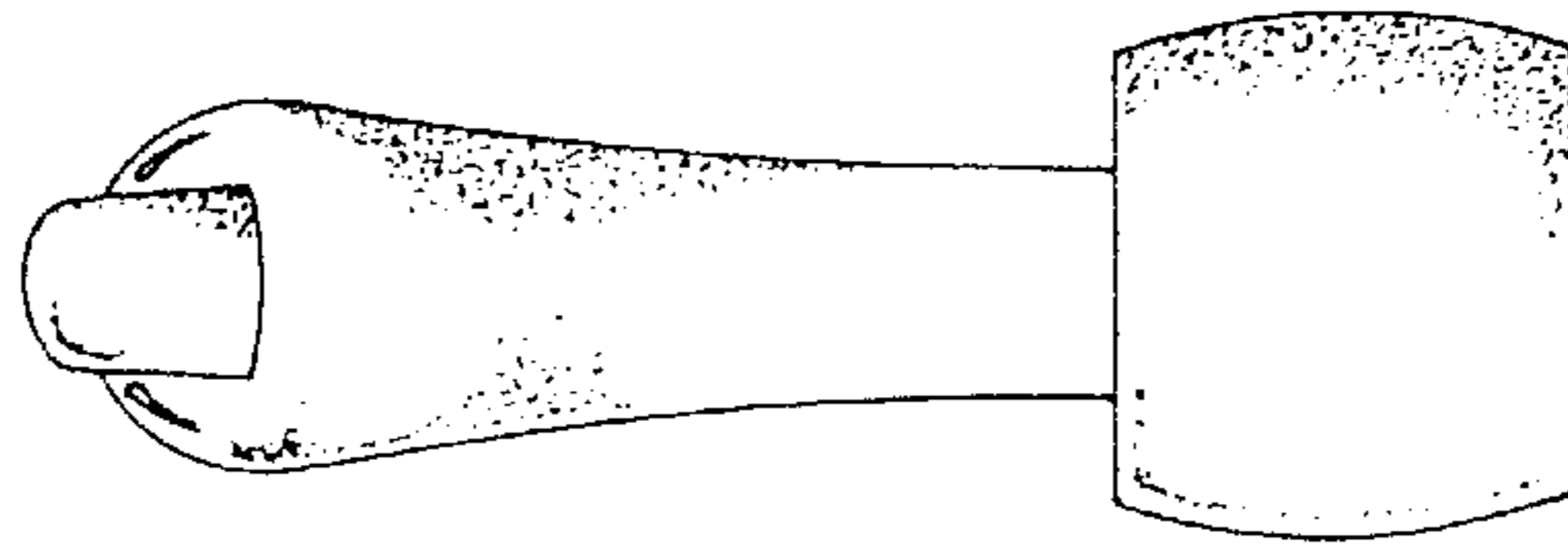

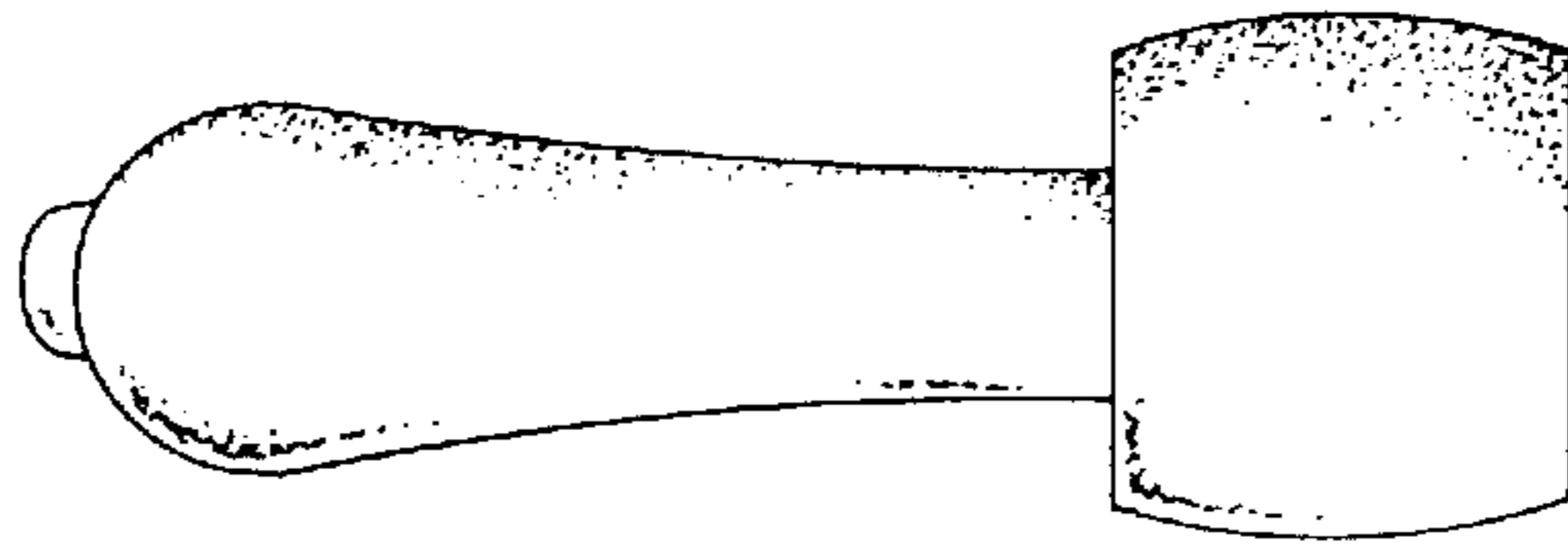

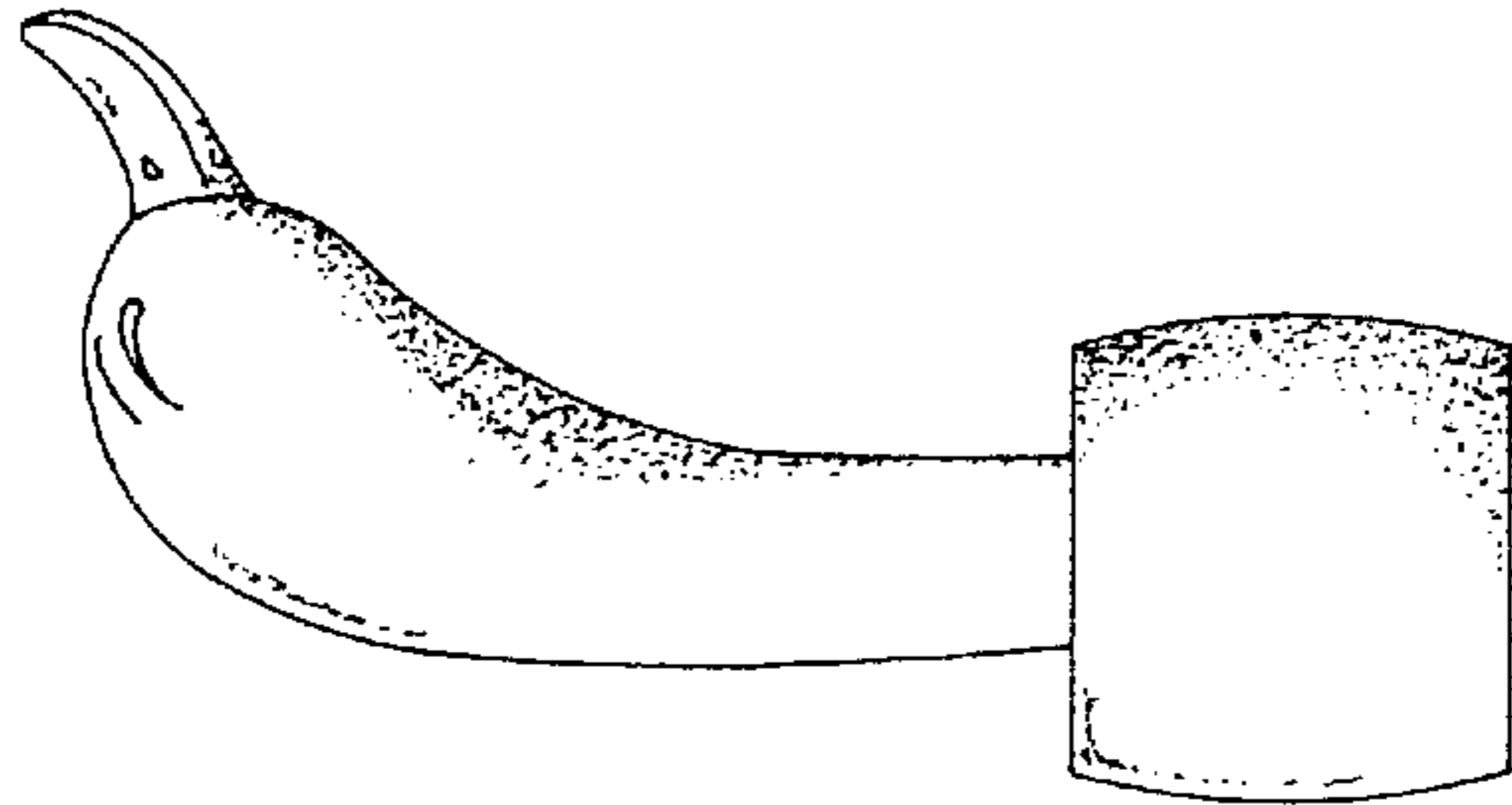

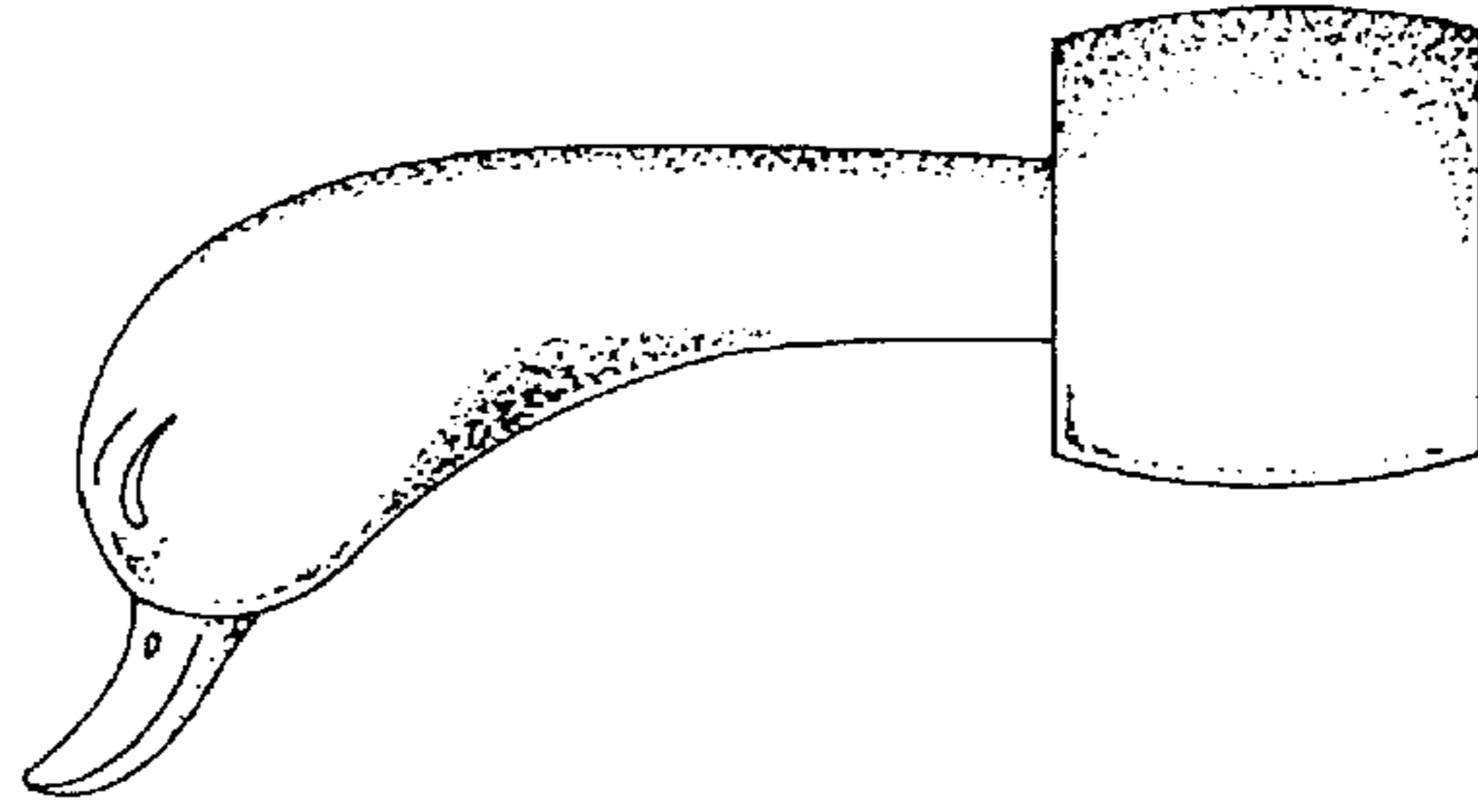

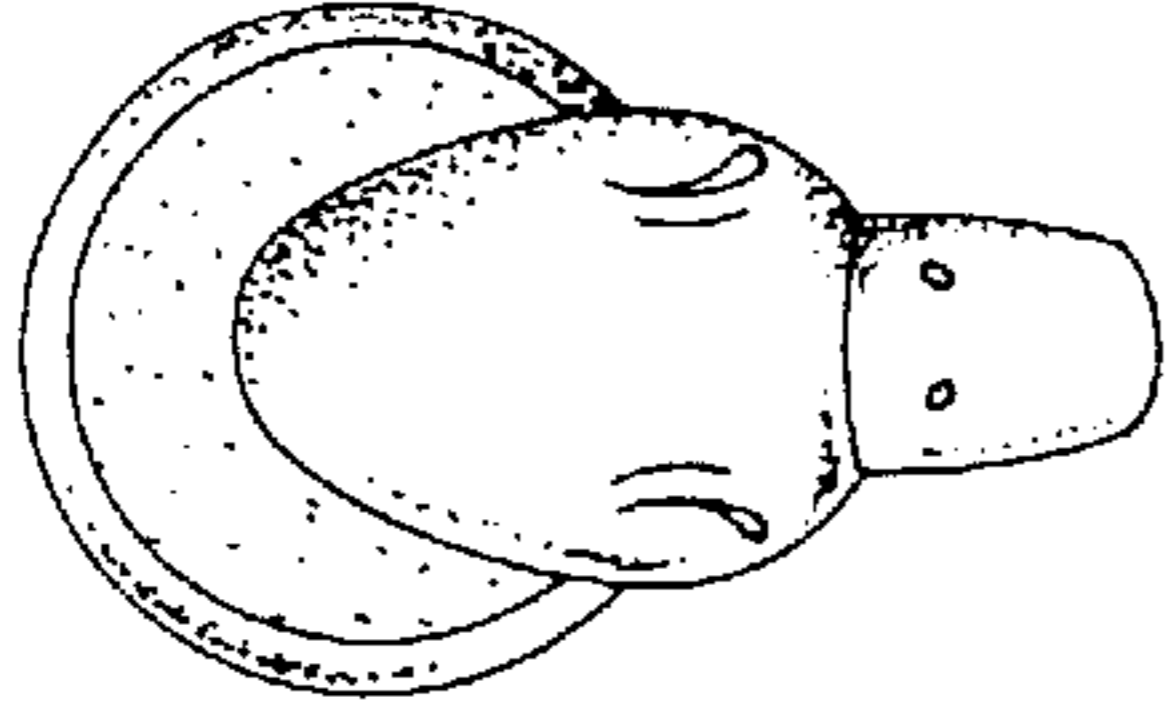

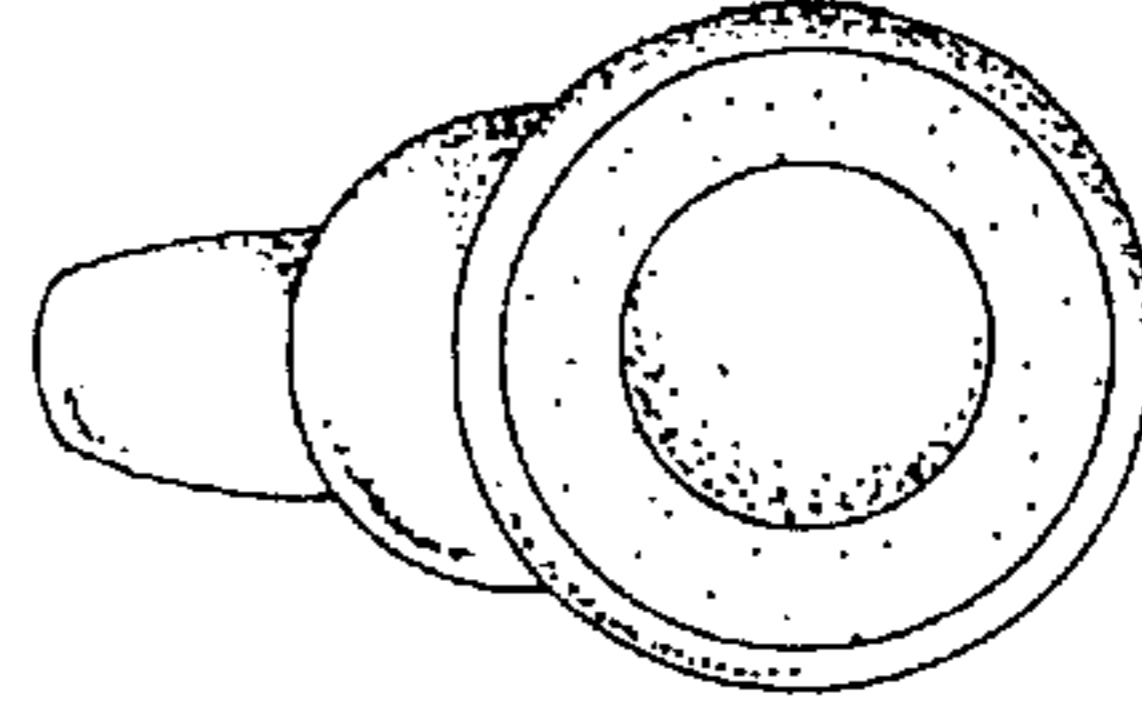
