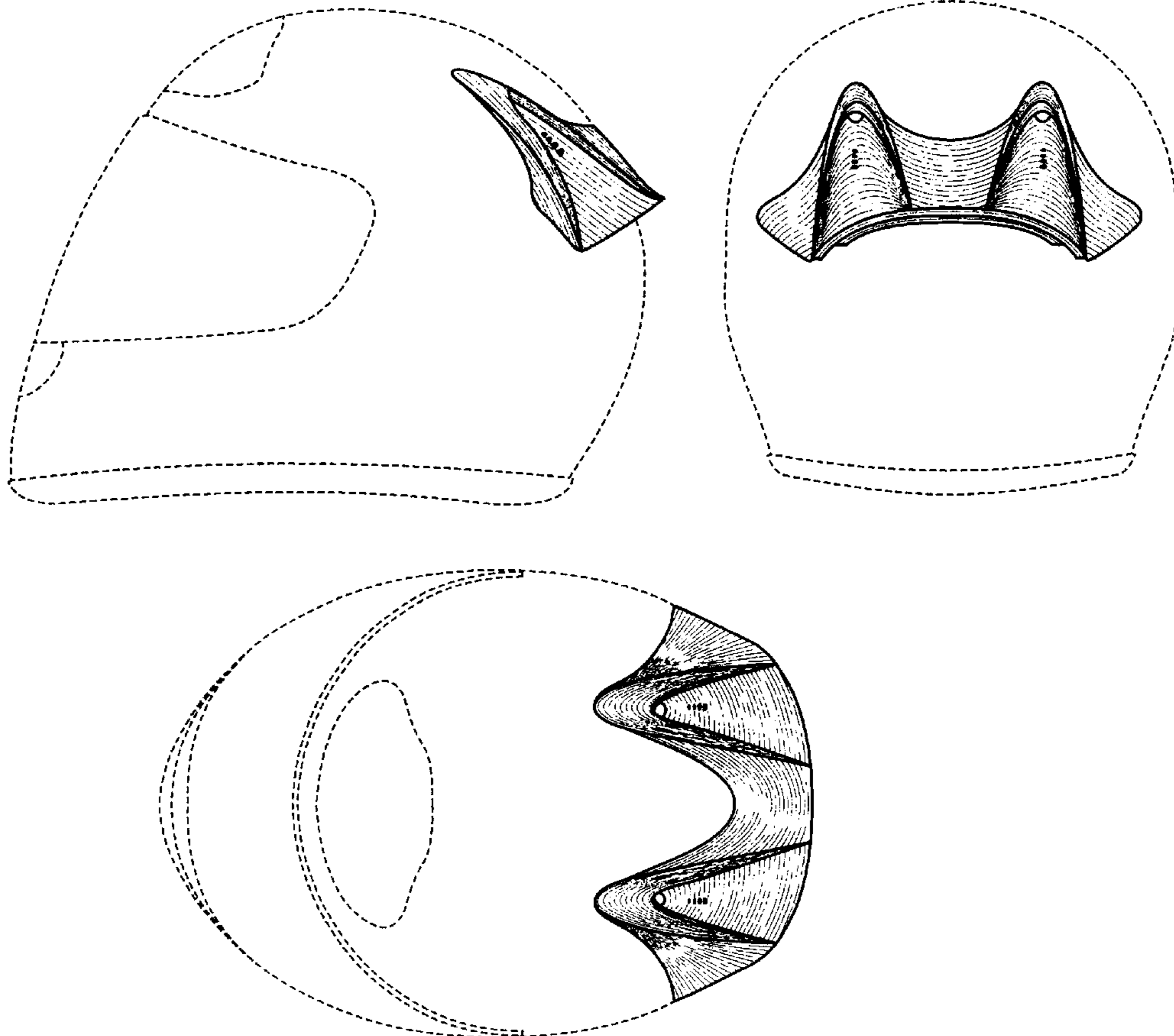
The ornamental design for a helmet, as shown and described.

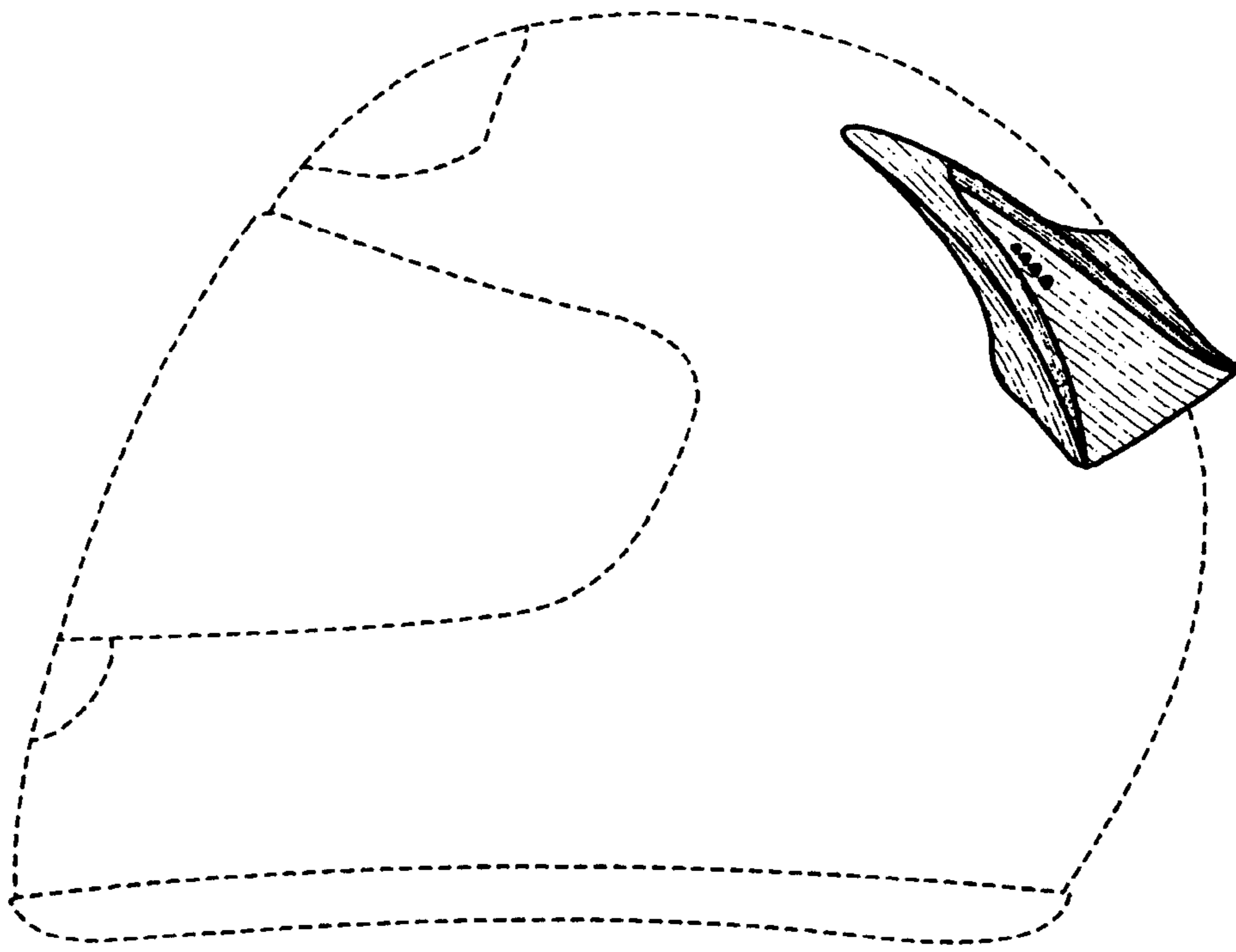
**DESCRIPTION**

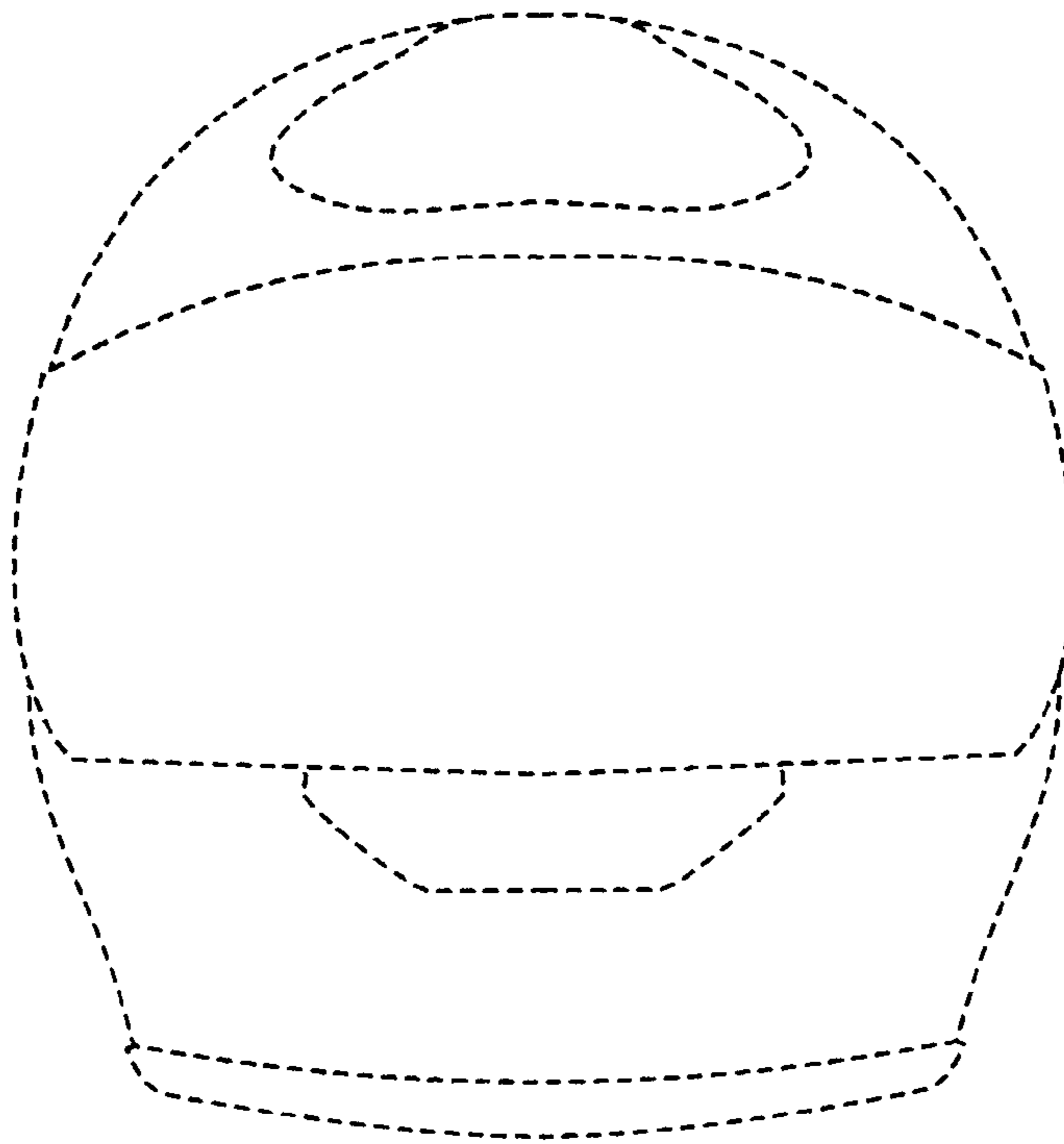
The broken lines in all views are for illustrative purposes only and form no part of the claimed design.

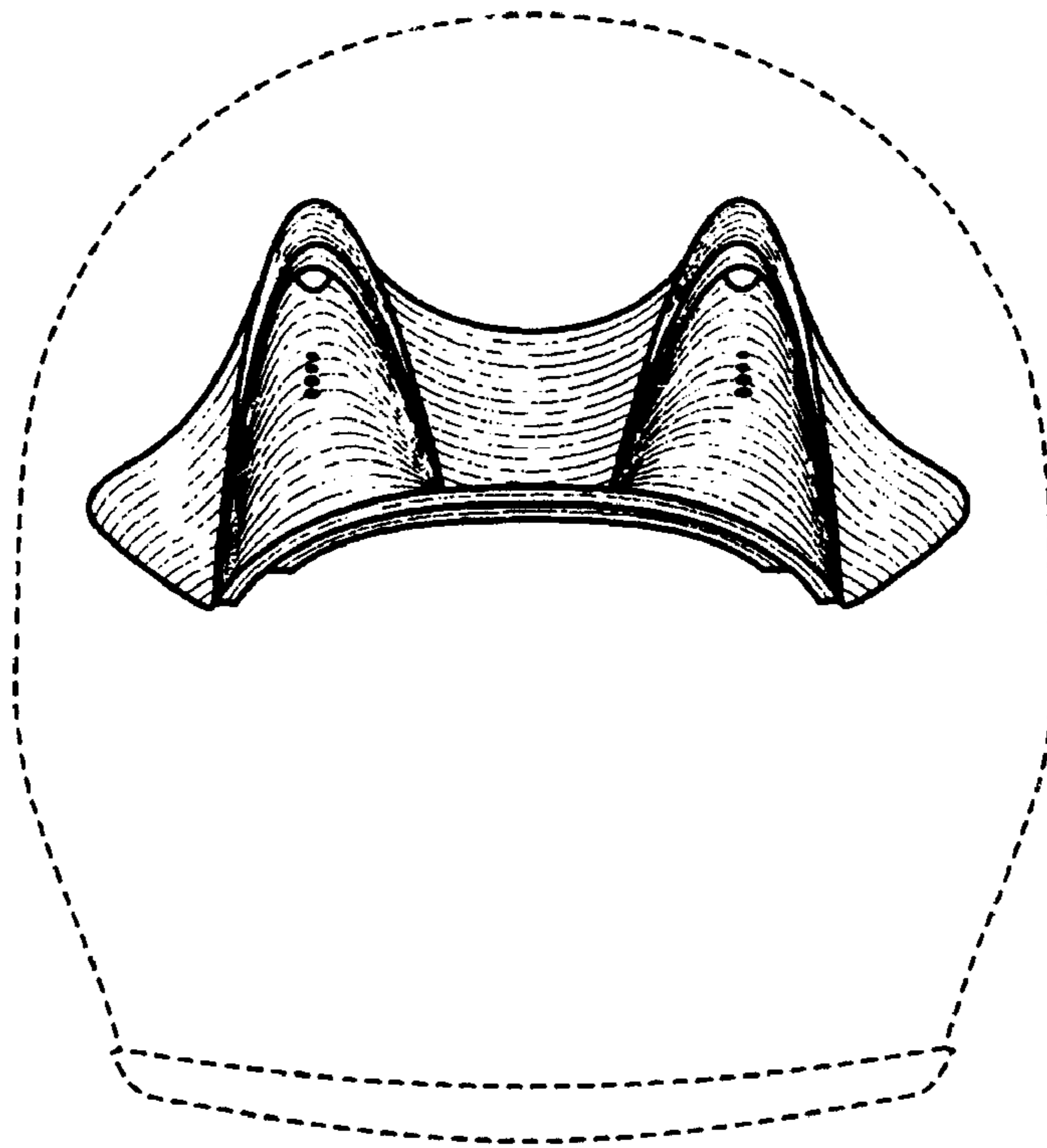




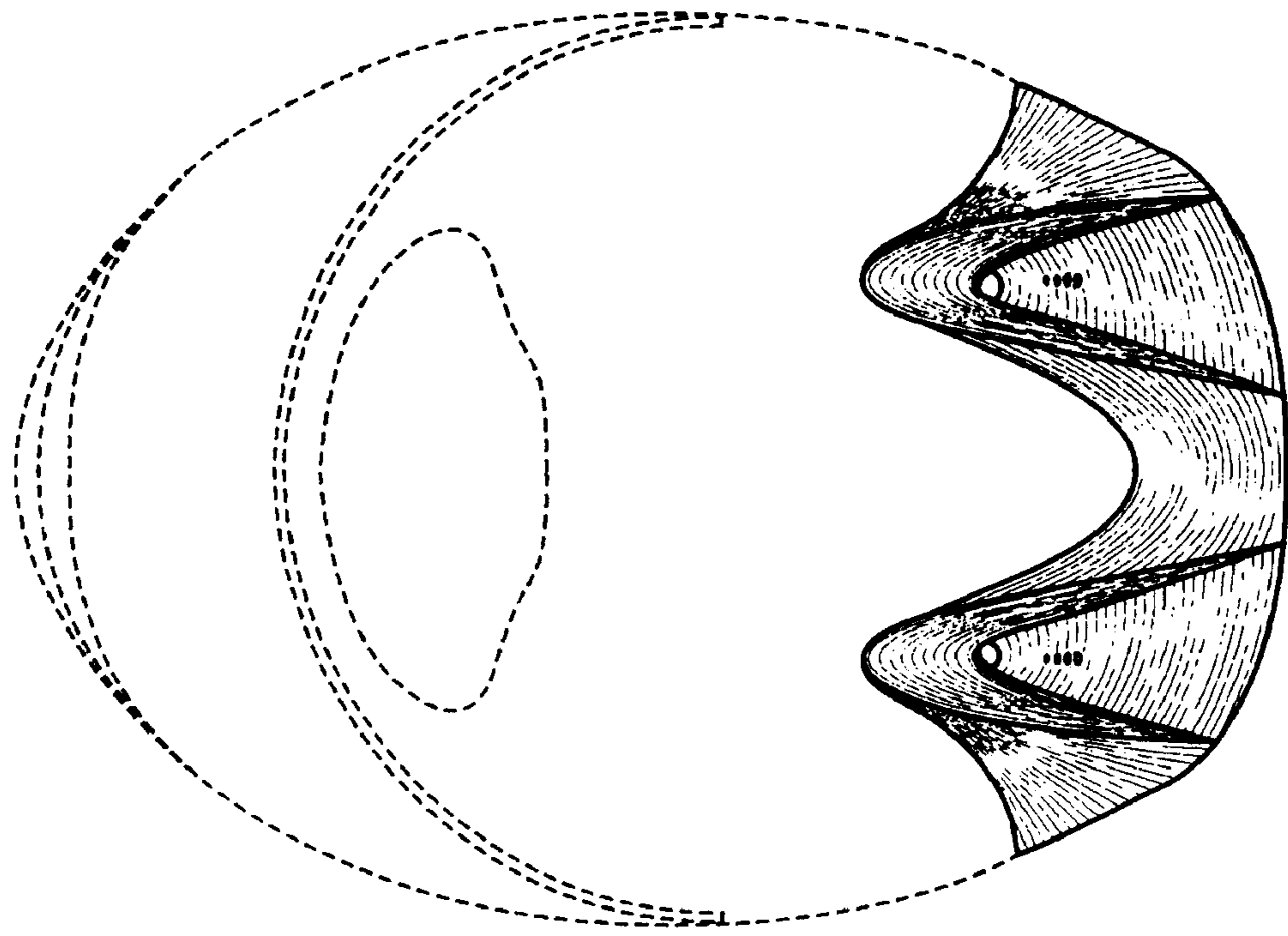

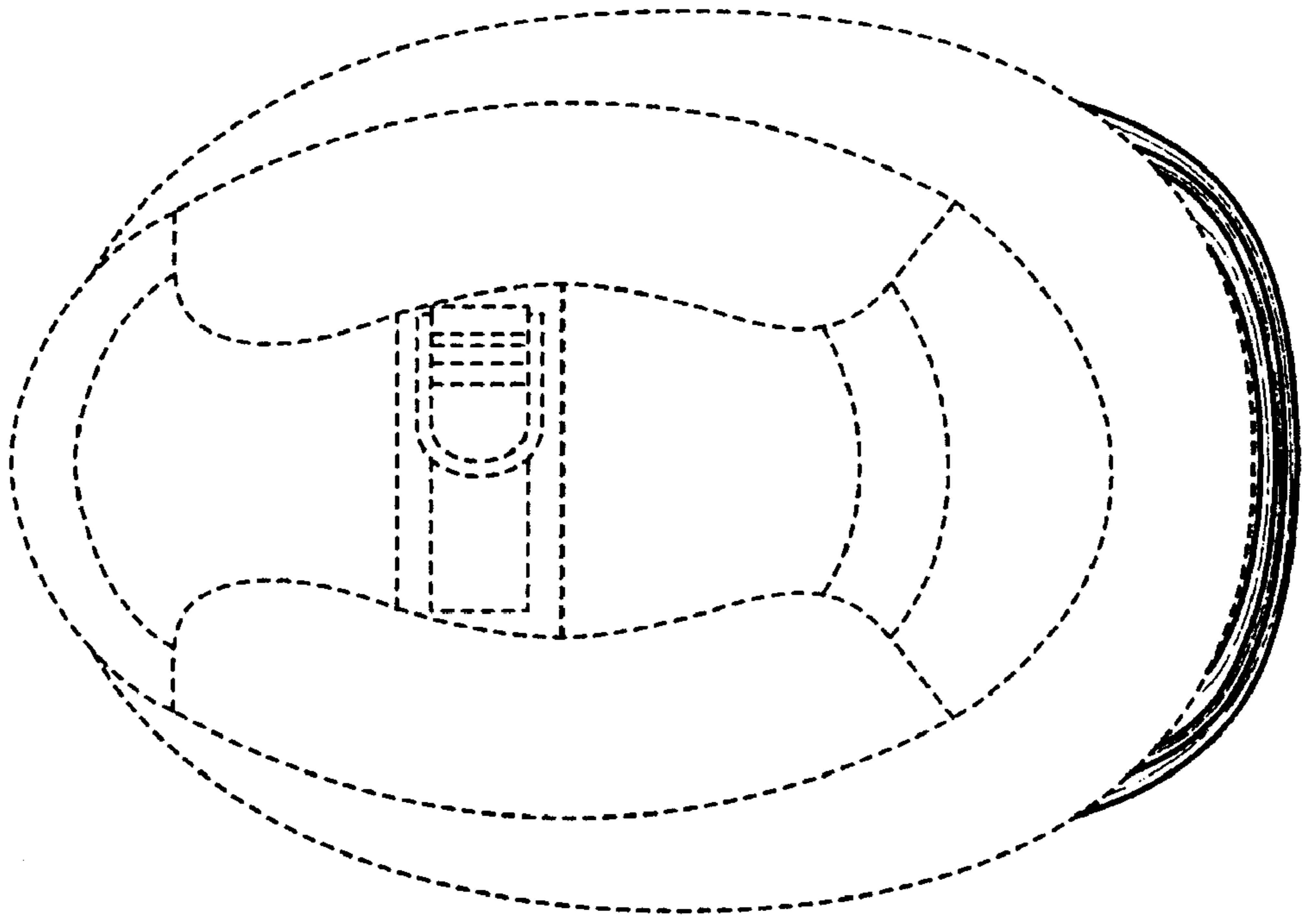

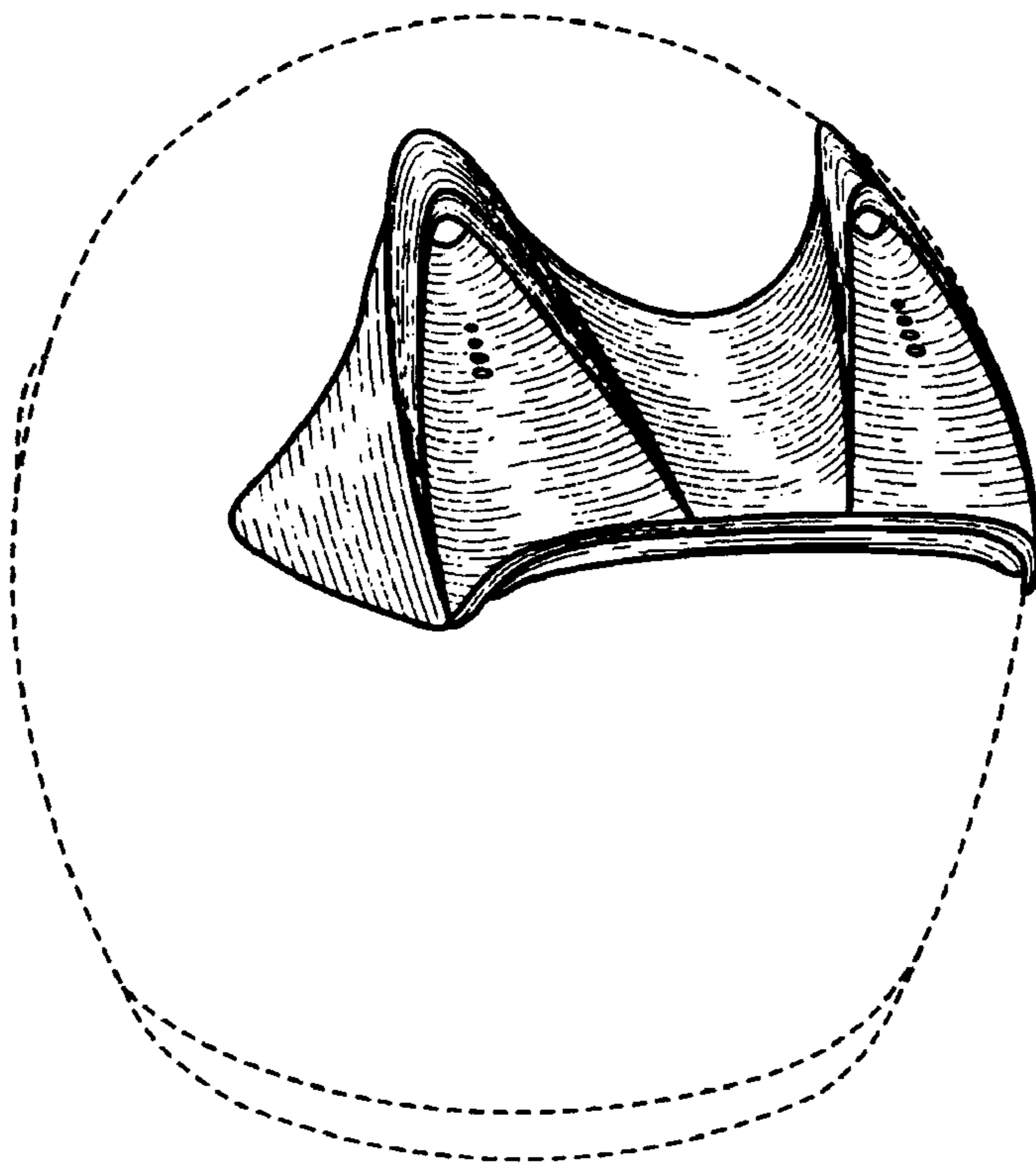
