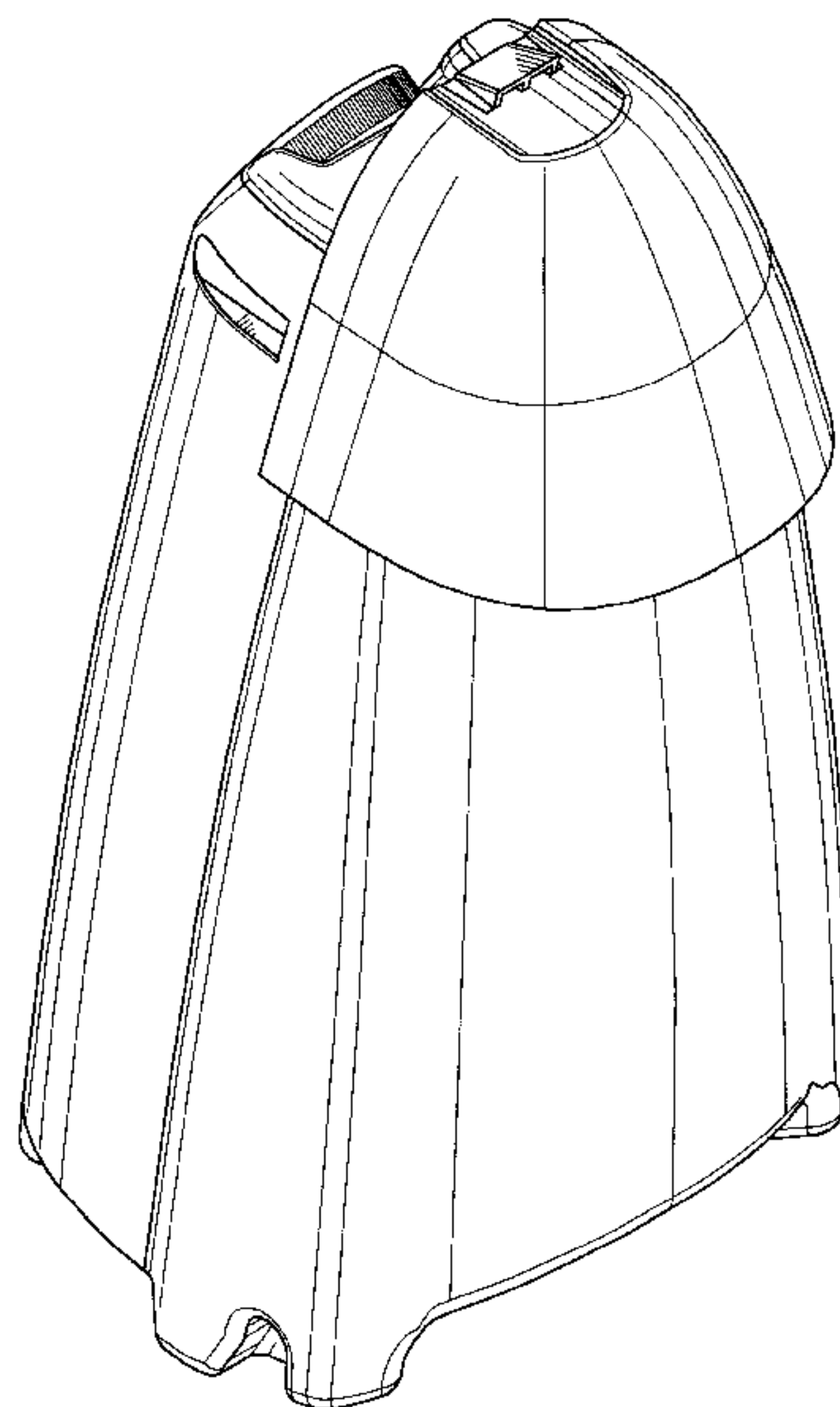
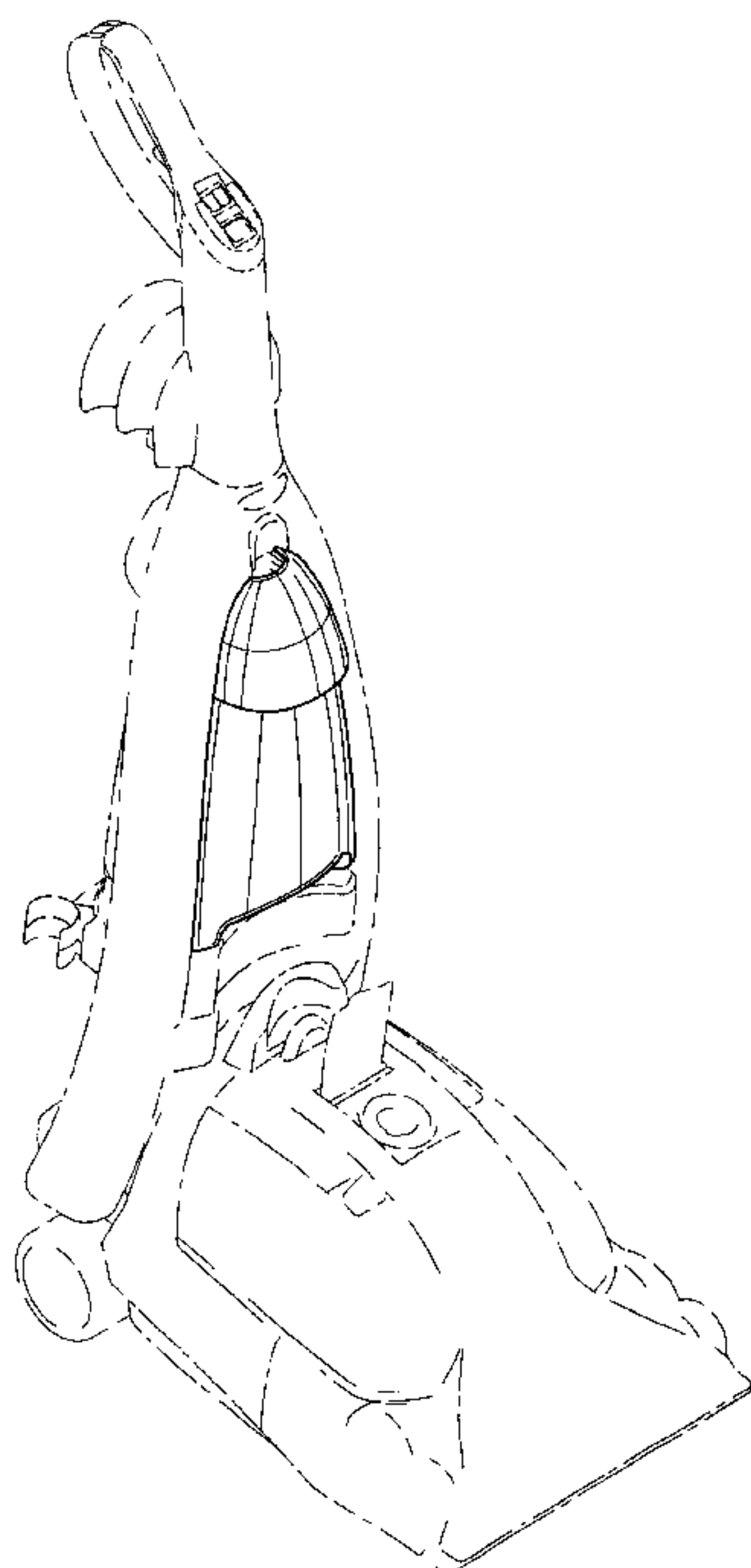
The ornamental design for a clean water tank for a carpet extractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a clean water tank for carpet extractor showing our new design; FIG. 2 is a perspective view of the clean water tank alone; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The carpet extractor parts shown in broken lines in FIG. 1 are shown for illustrative purposes only and form no part of the claimed design.

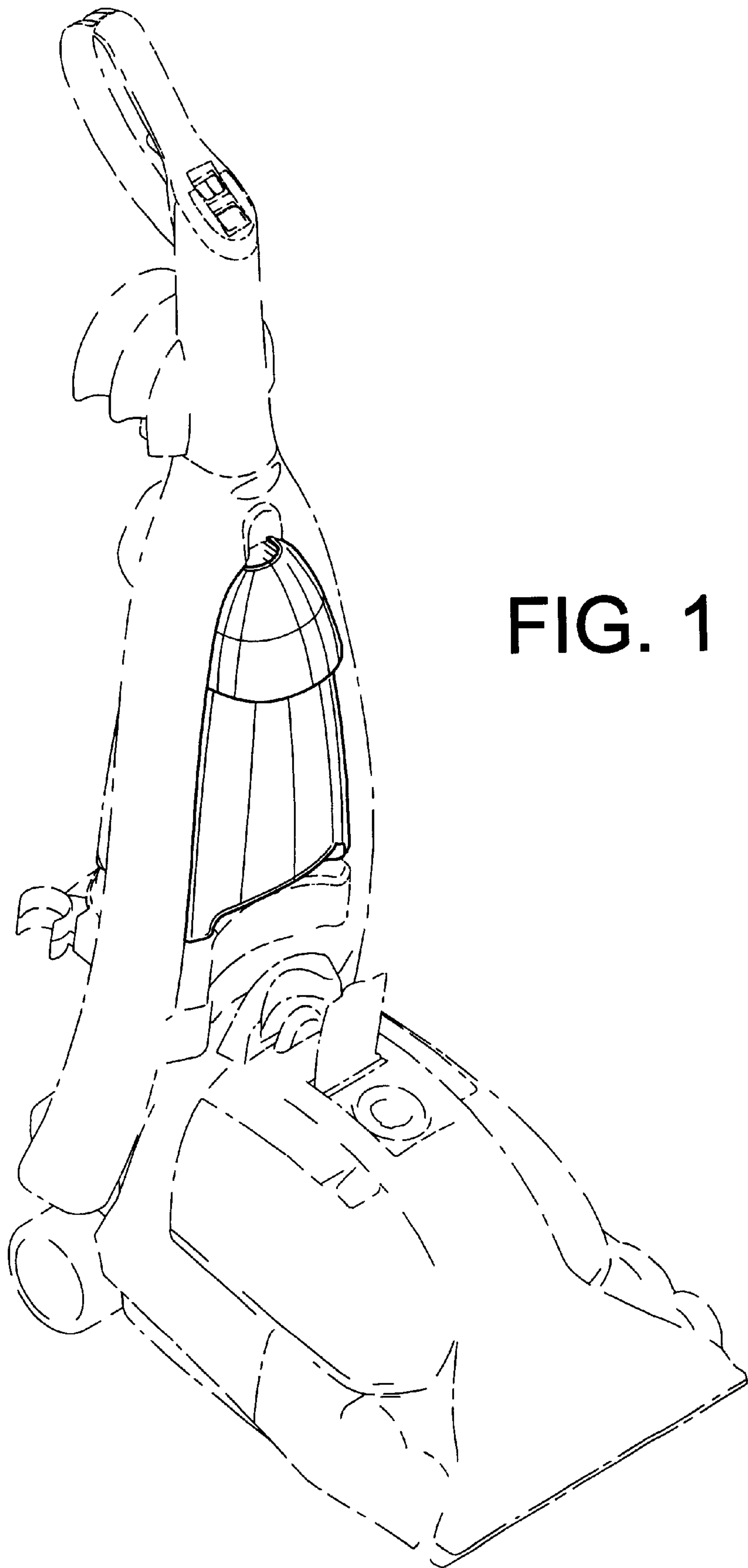

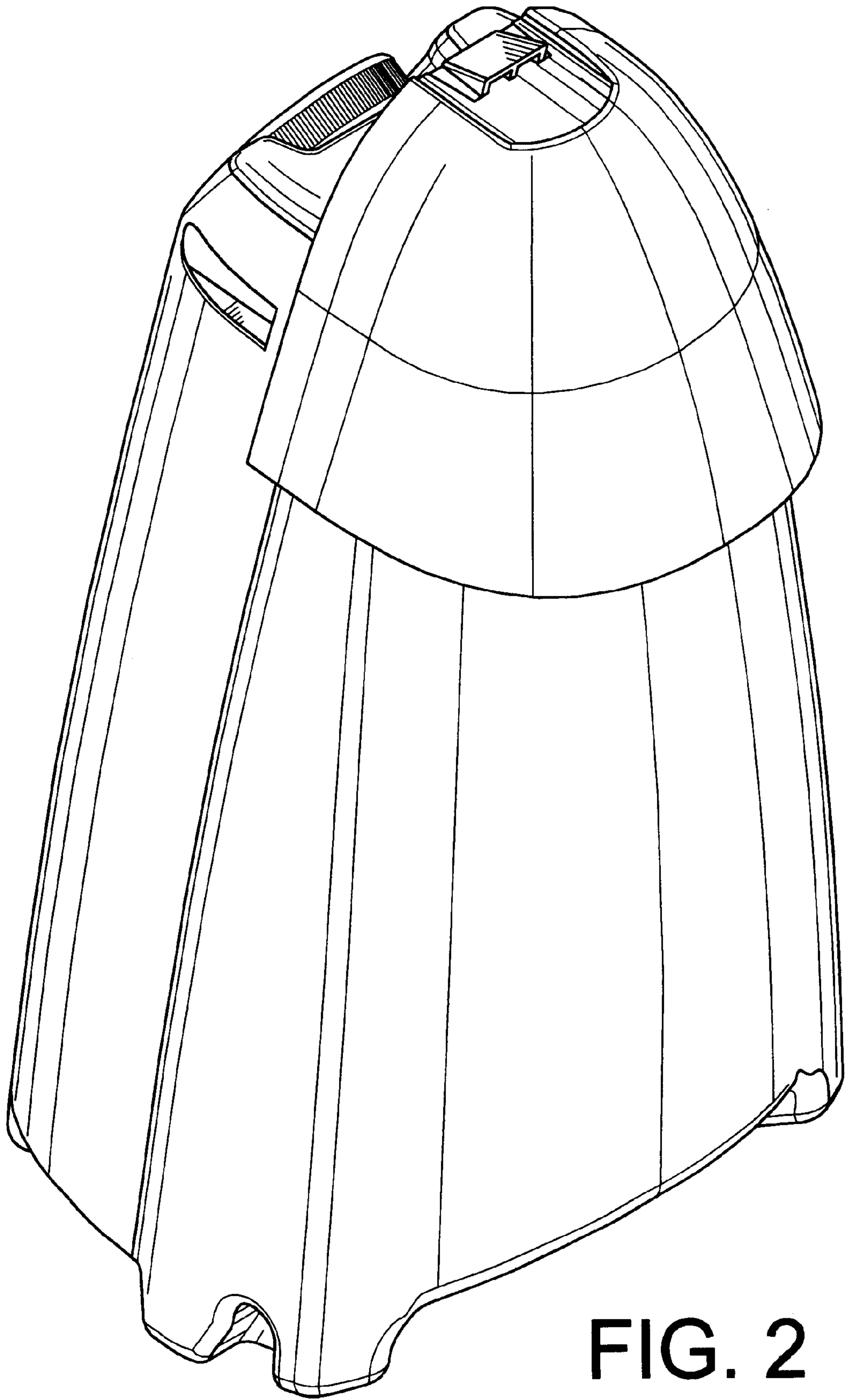

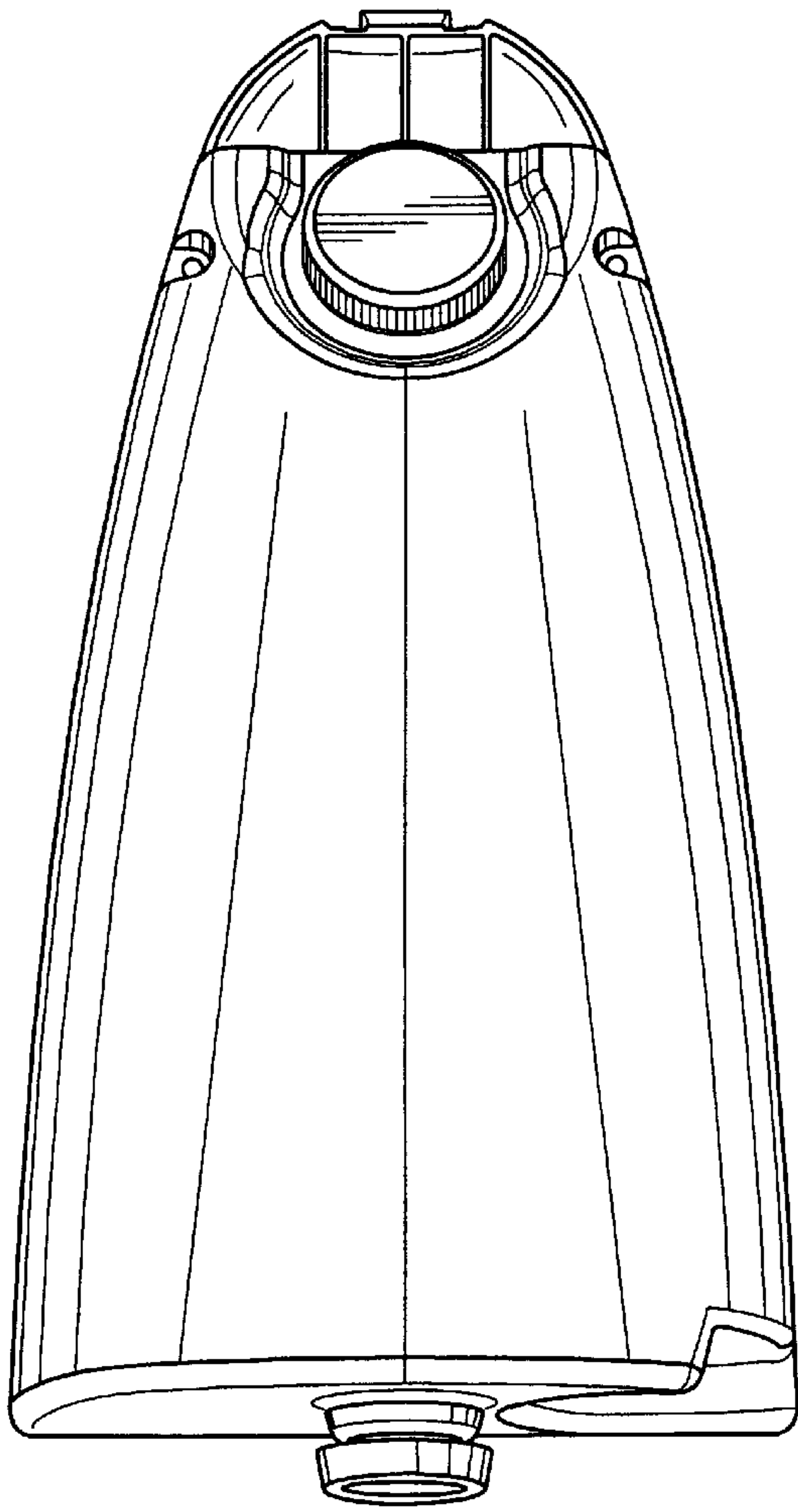

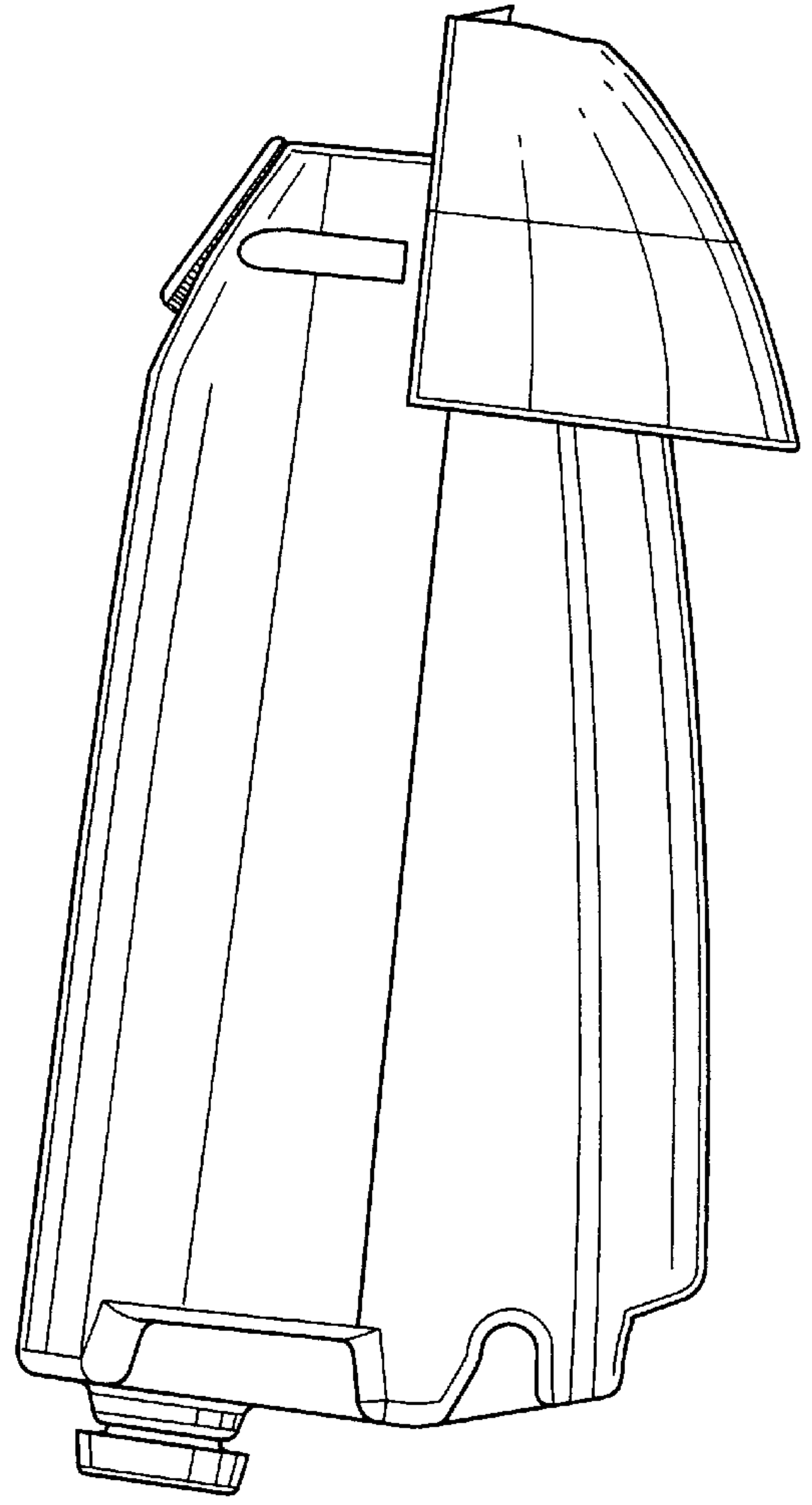

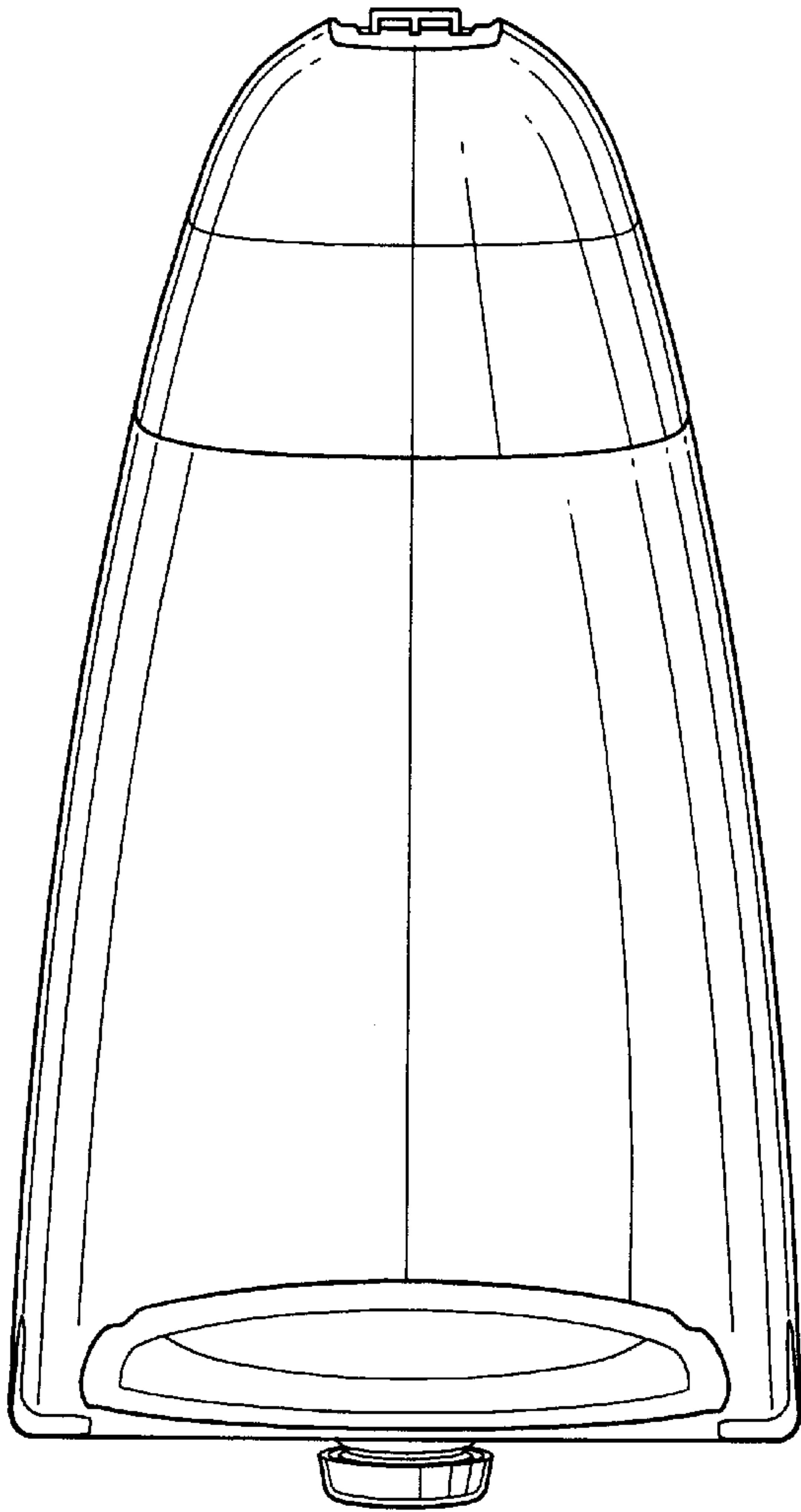

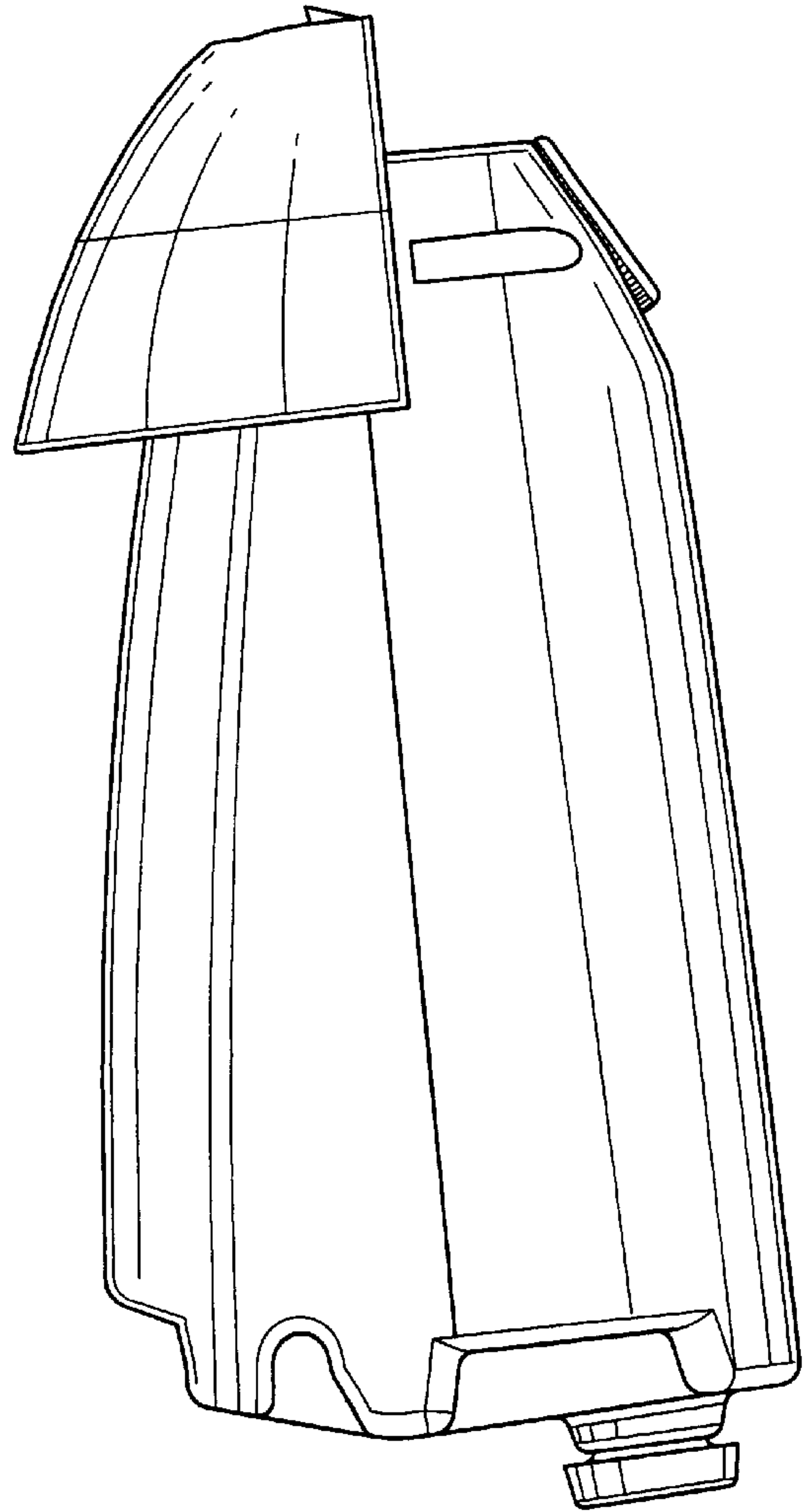

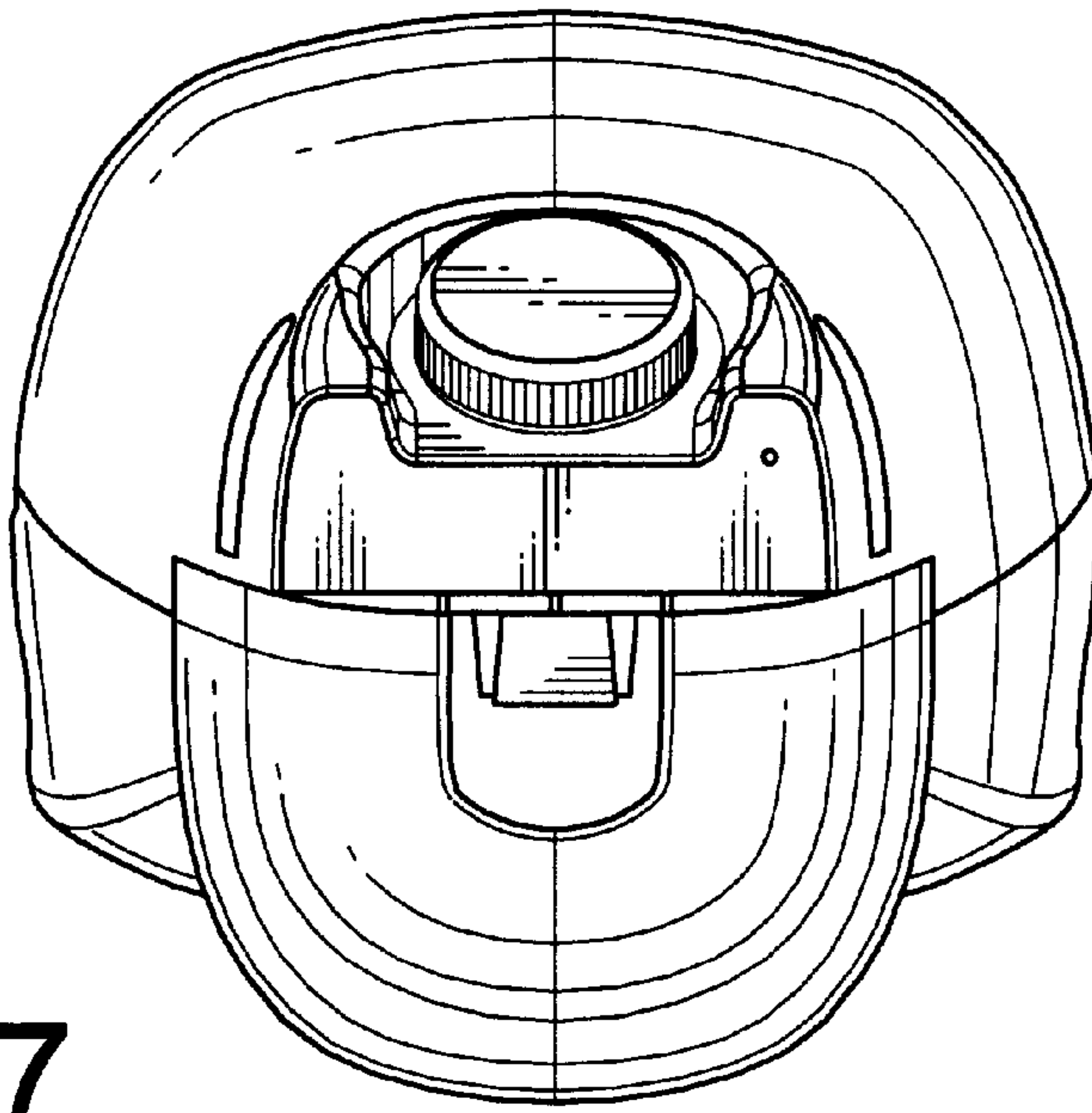
