DESCRIPTION

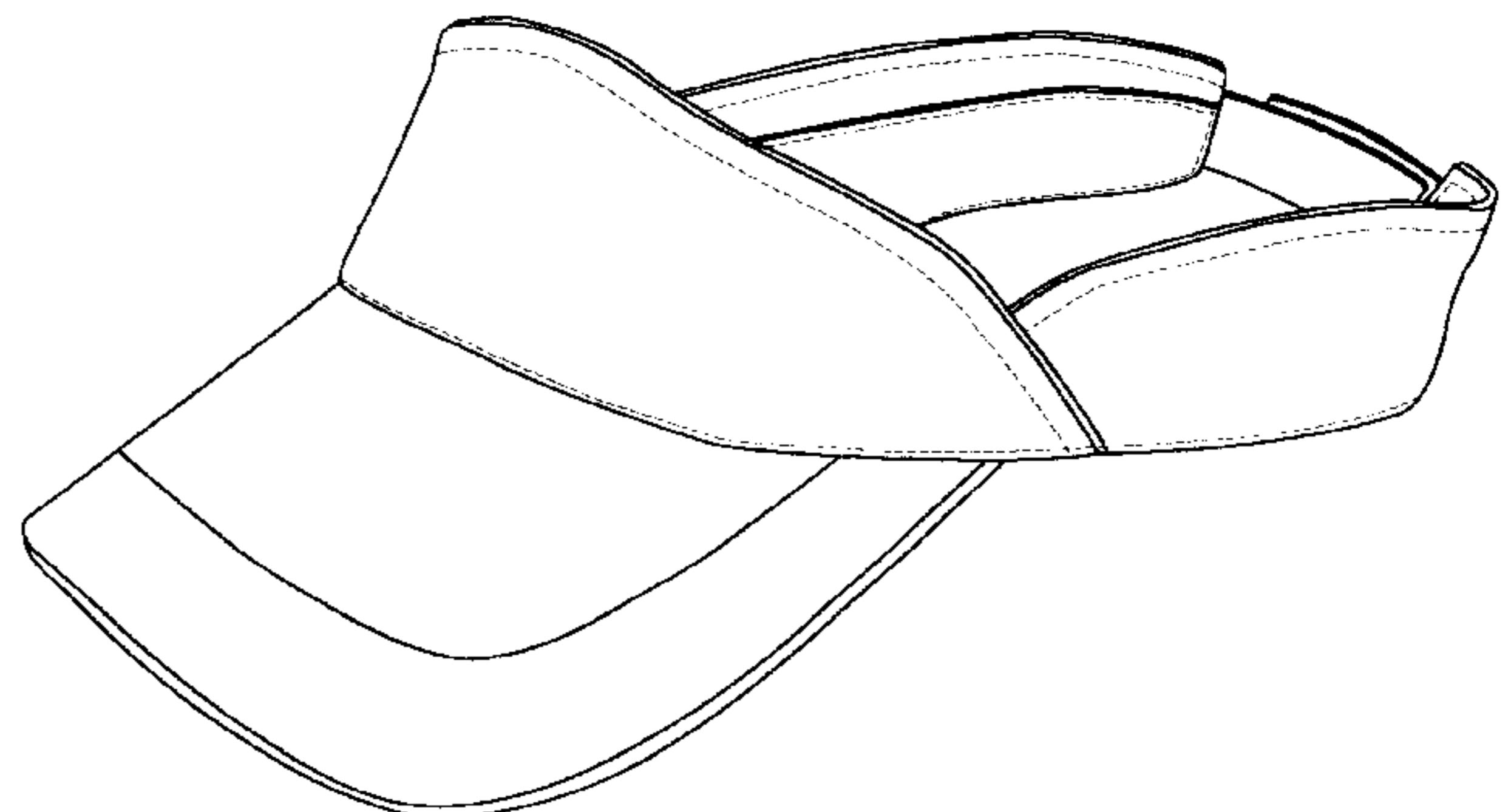
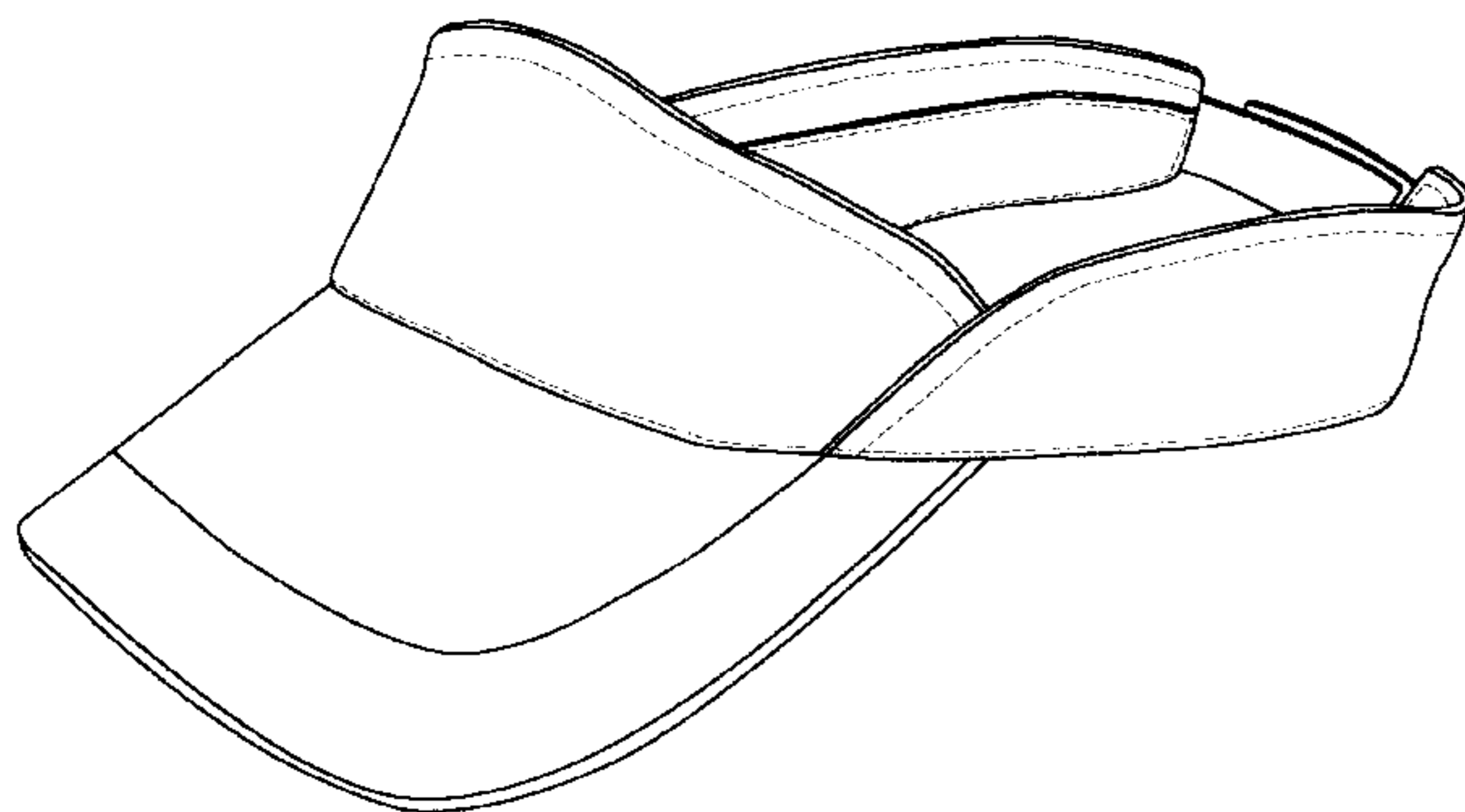

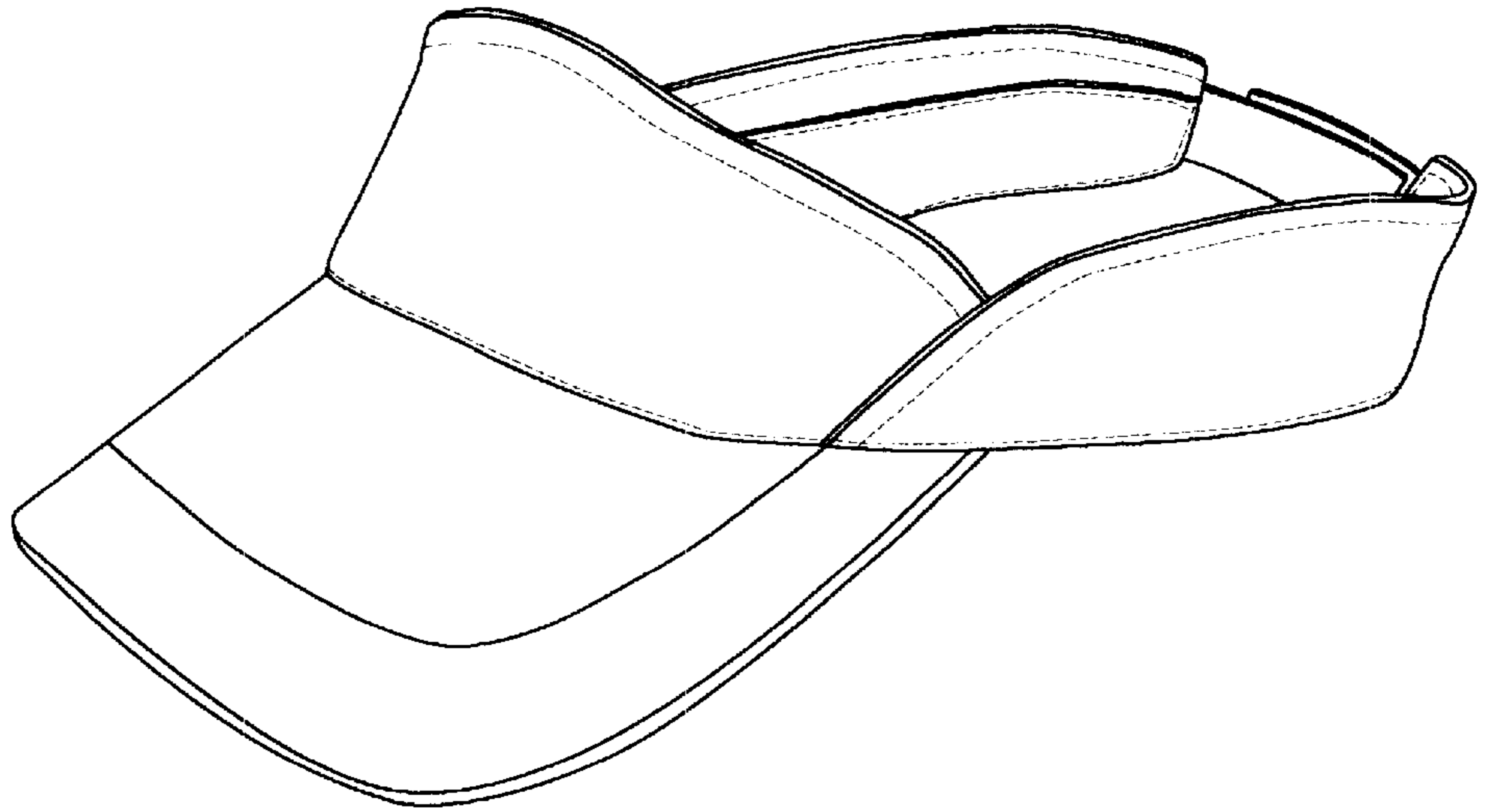

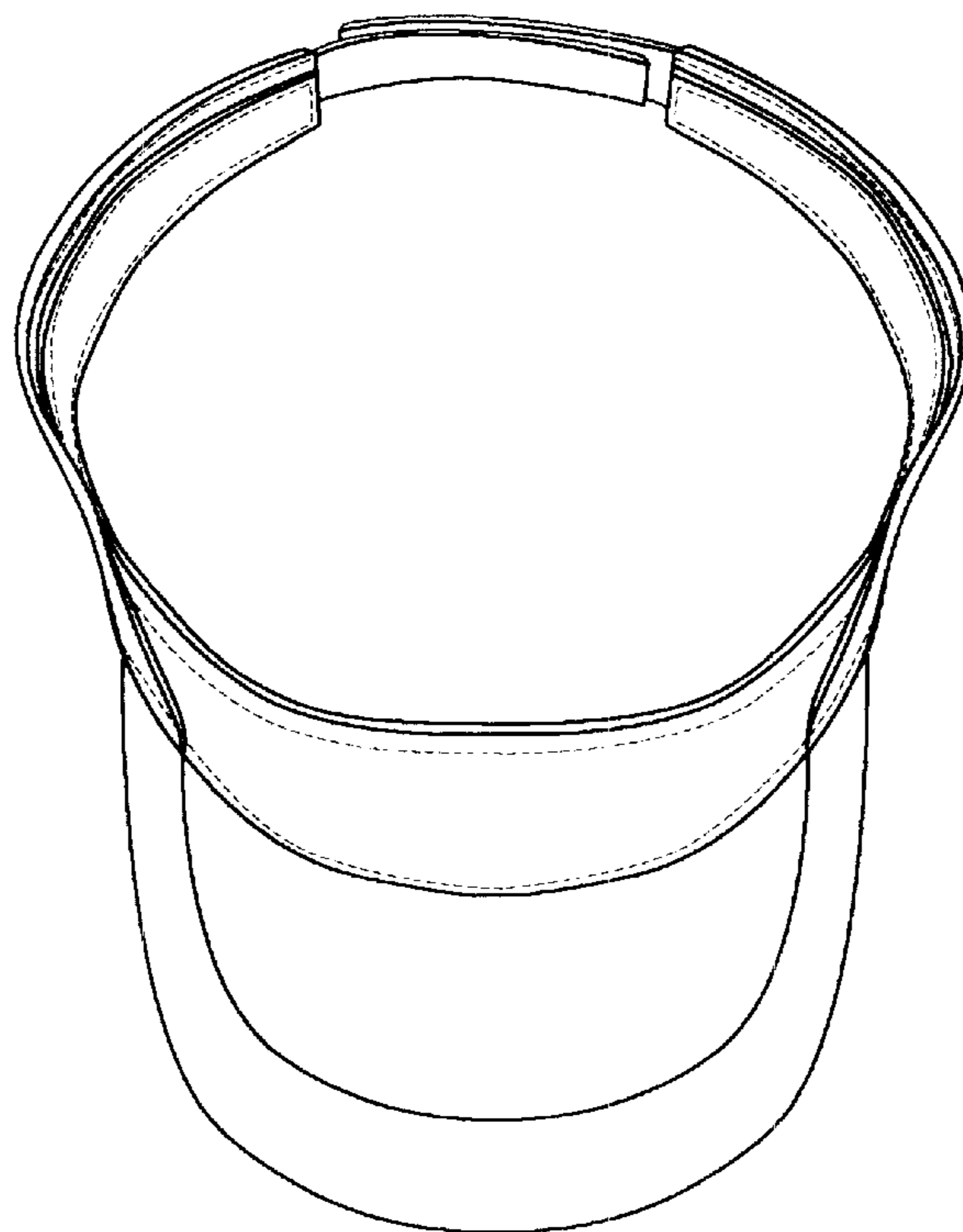

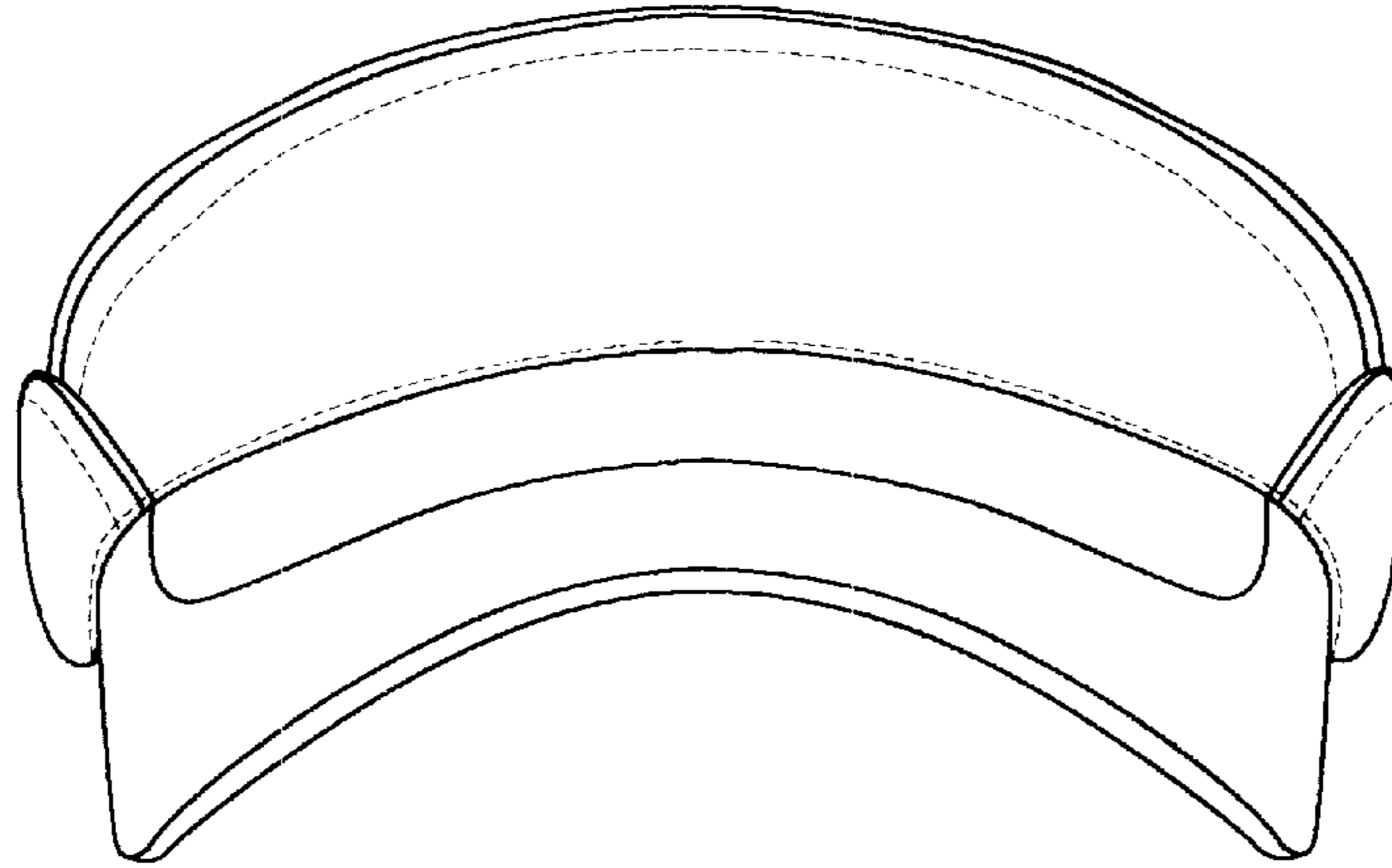

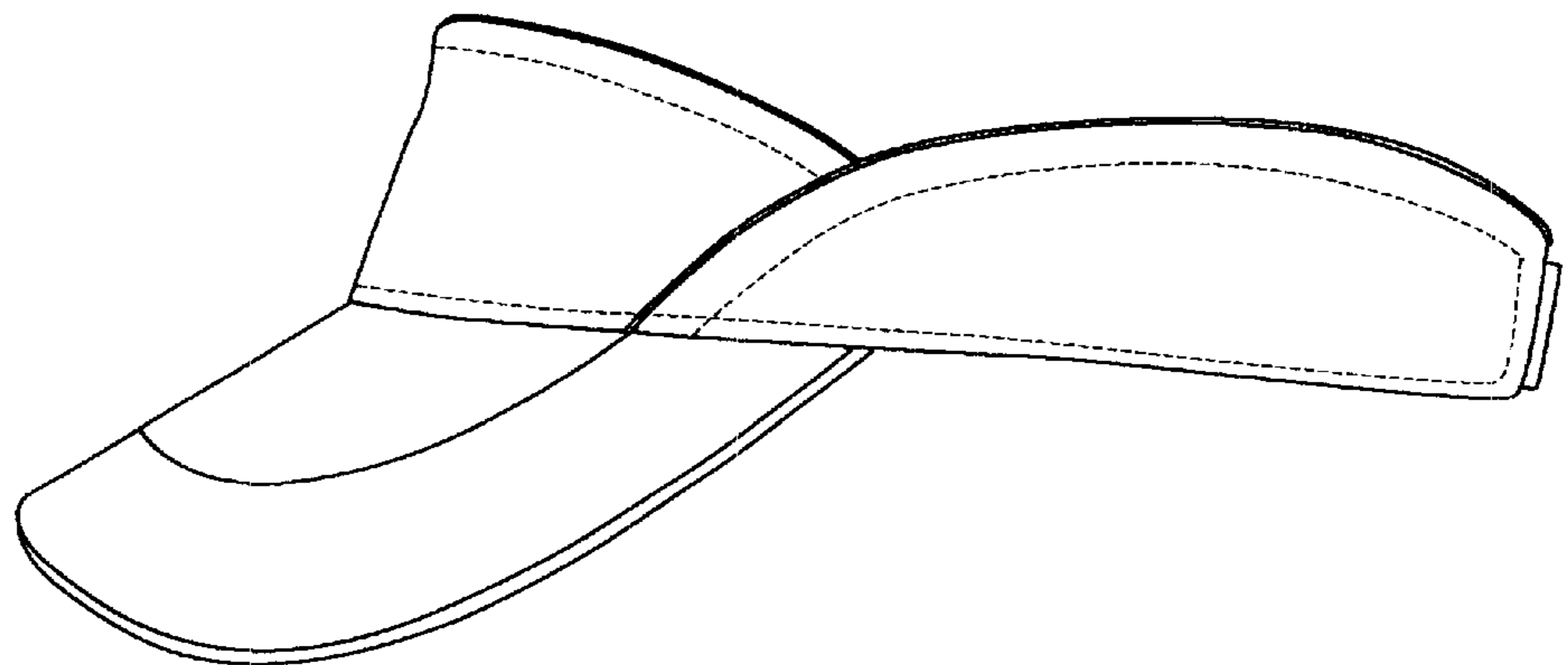

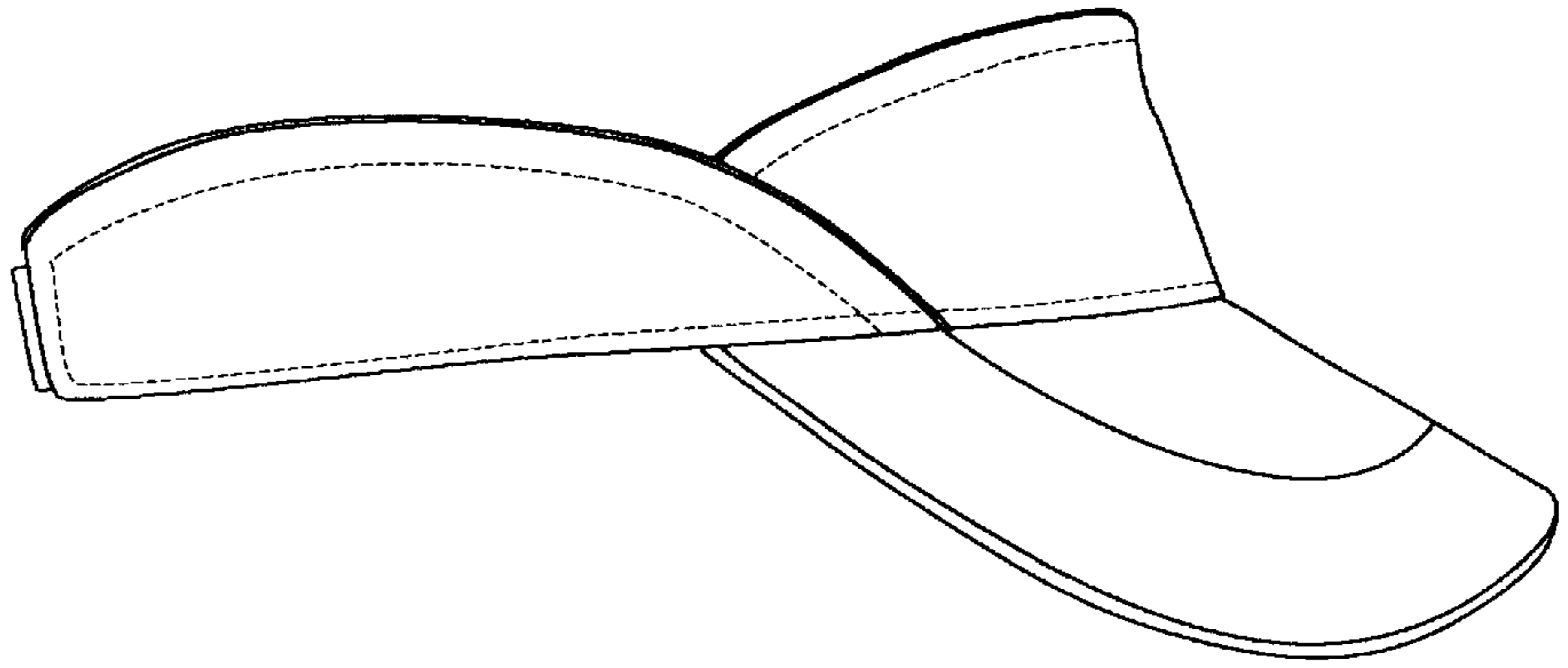

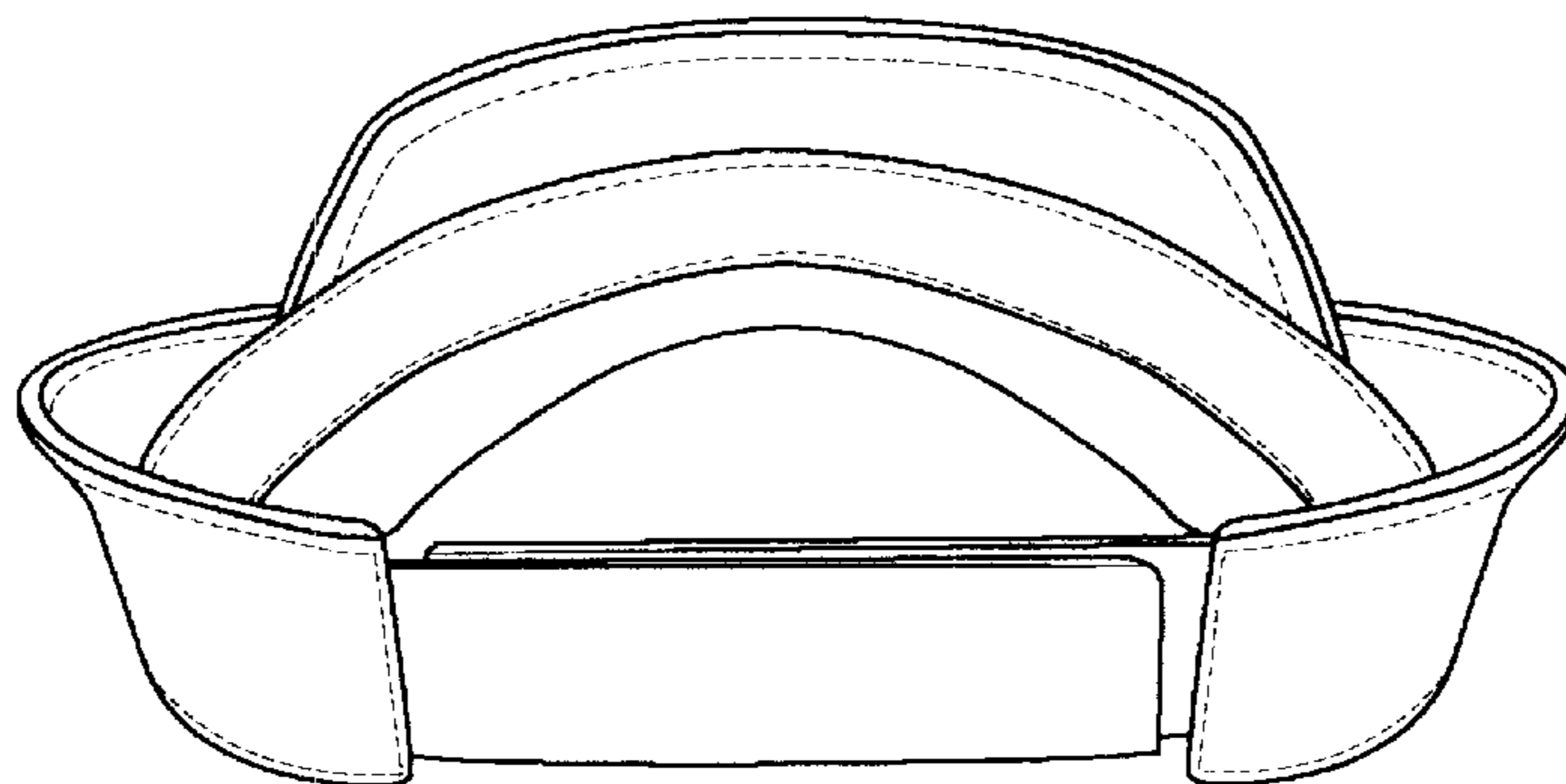

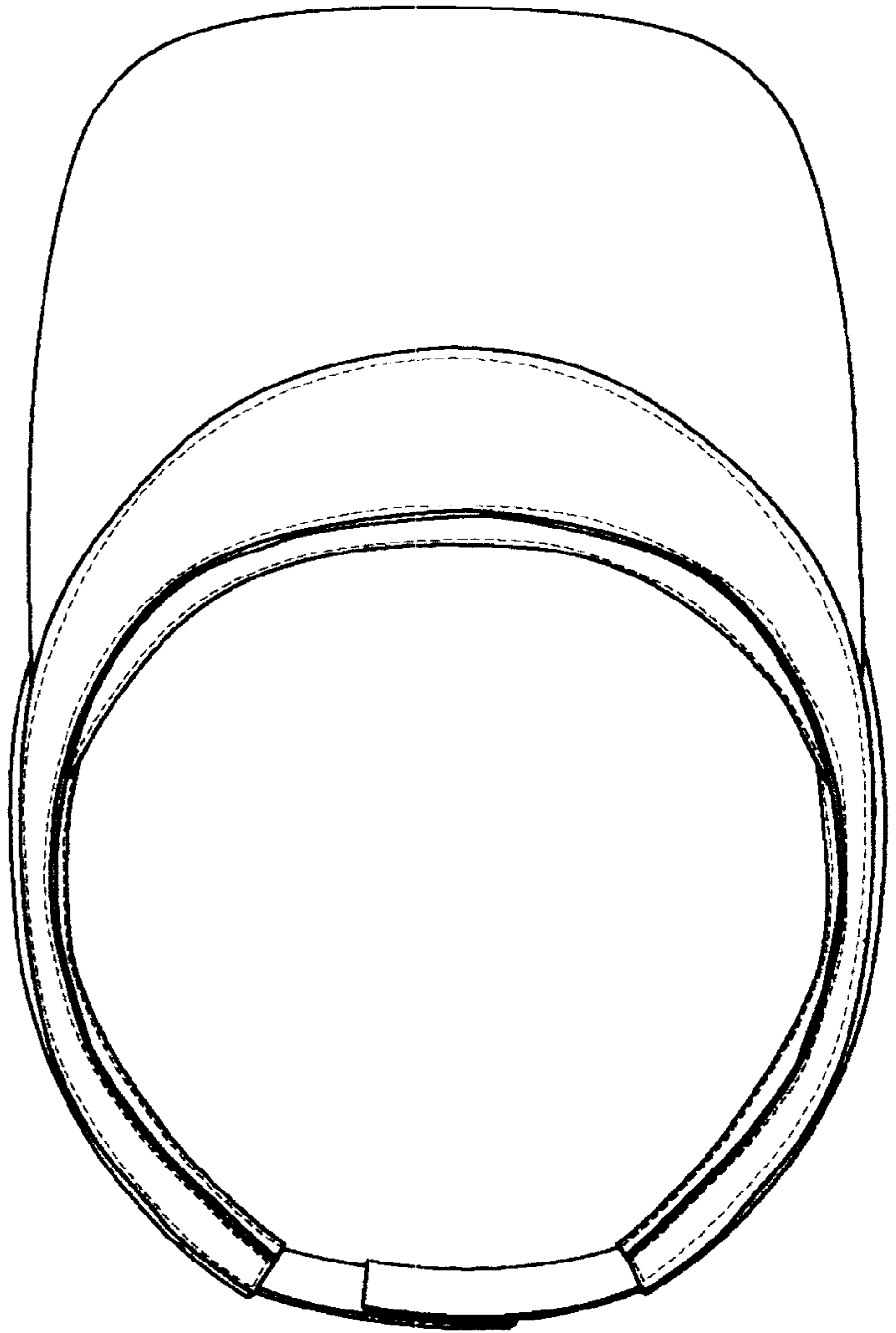

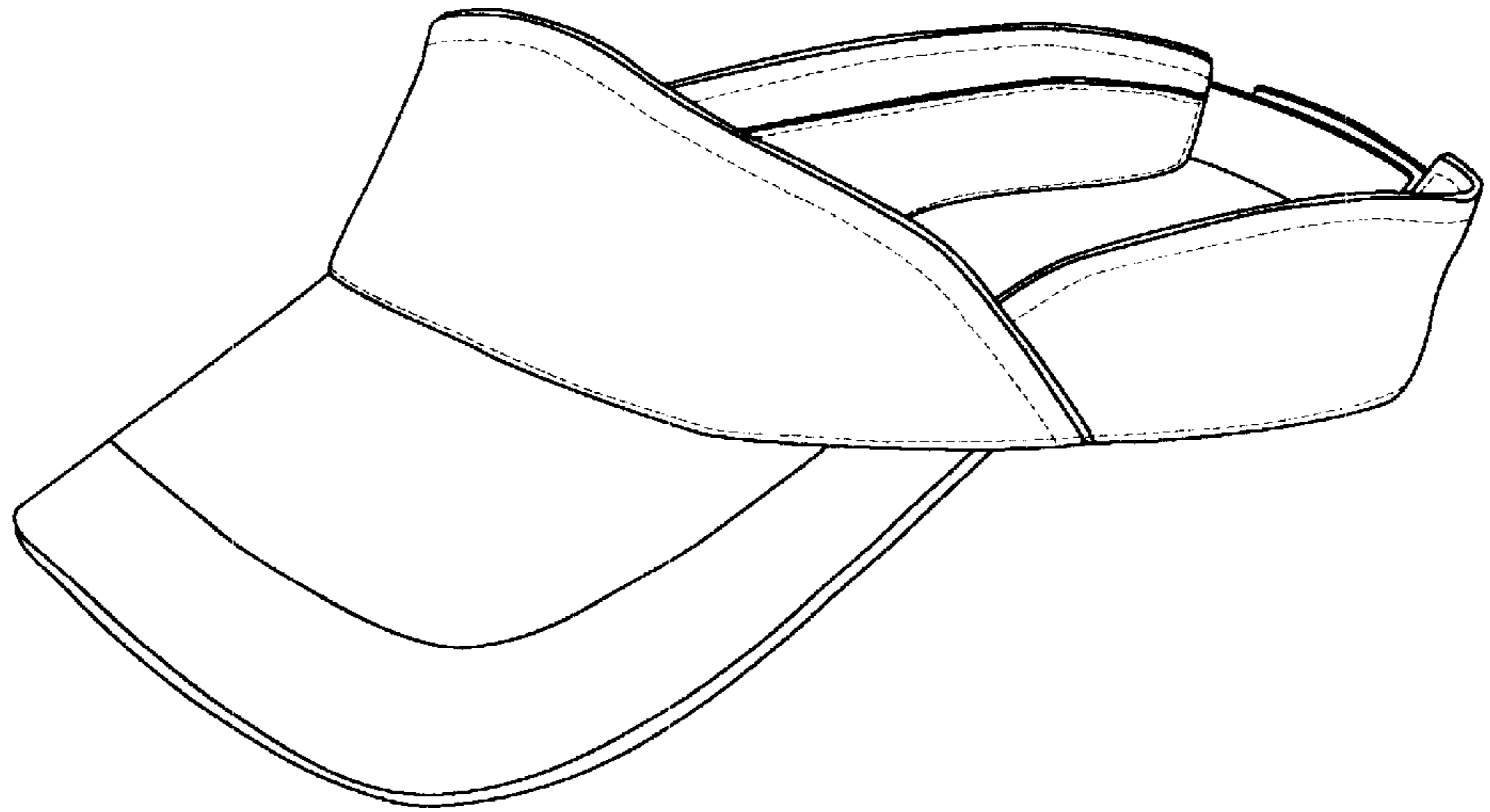

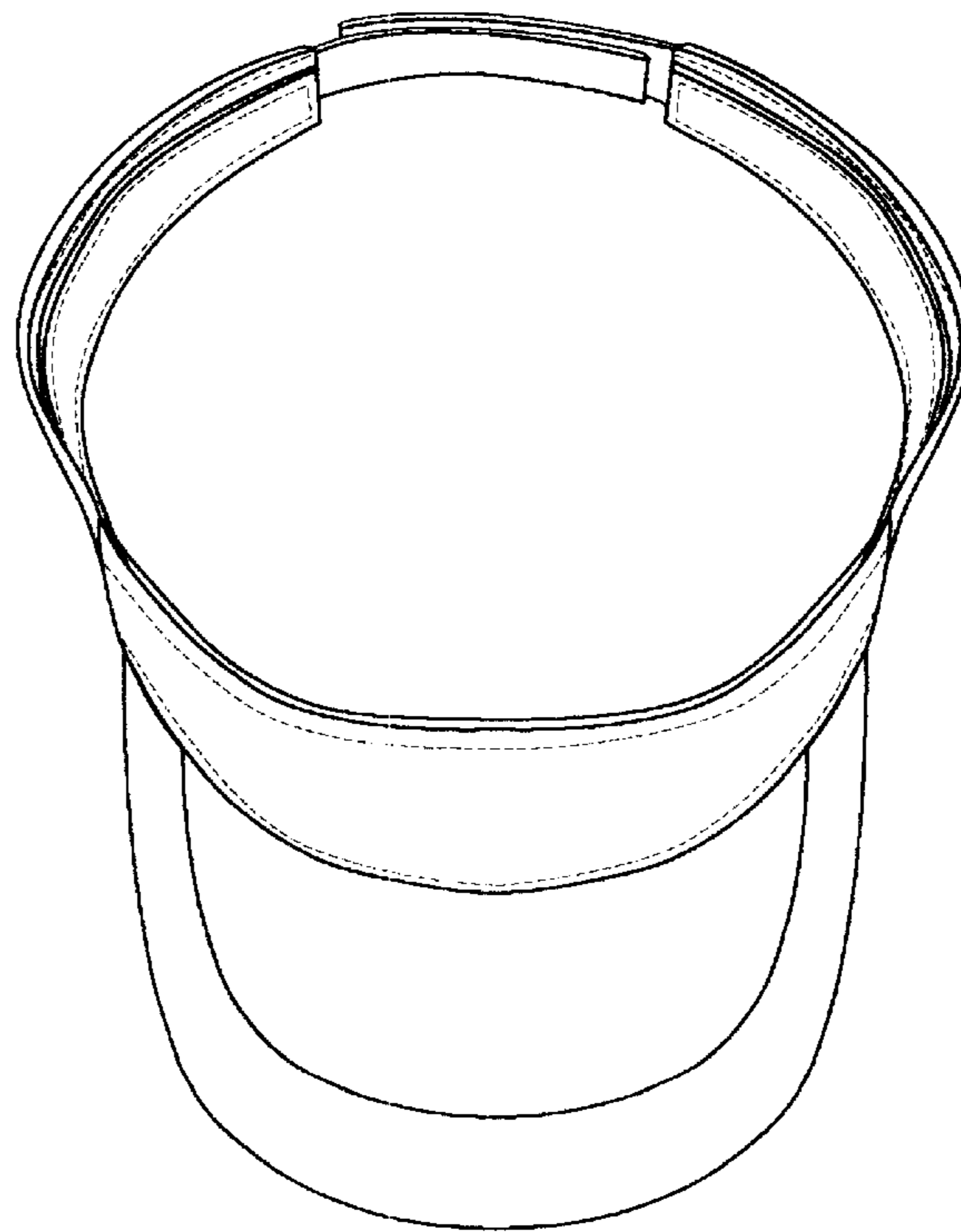

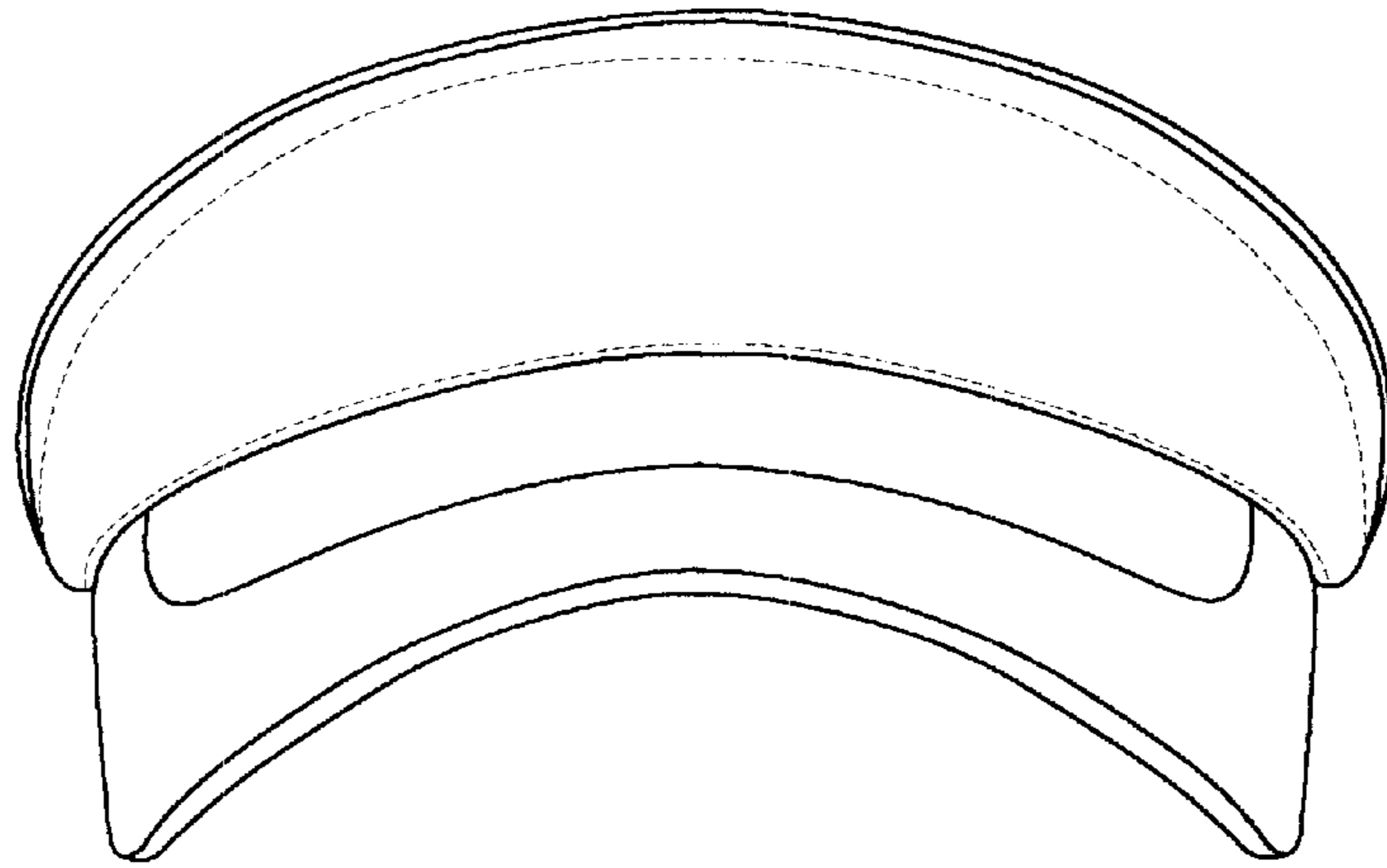

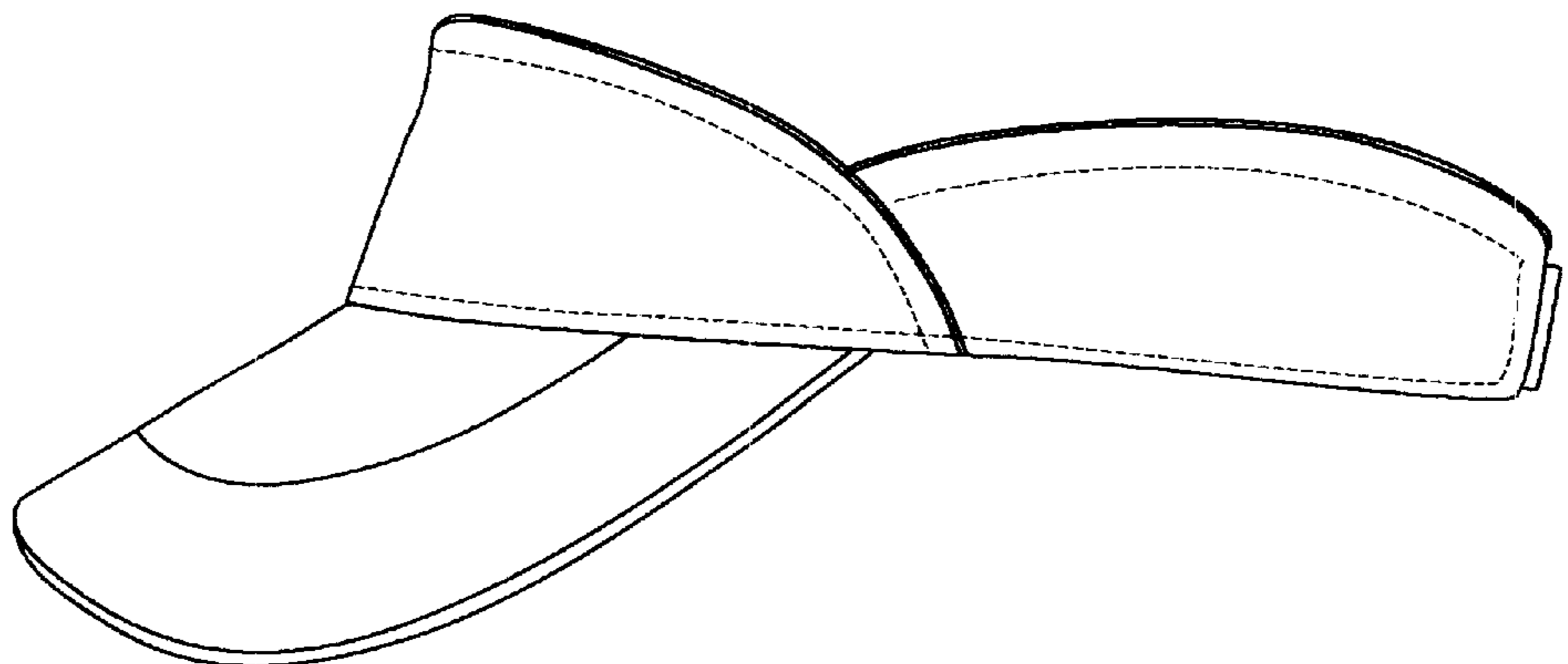

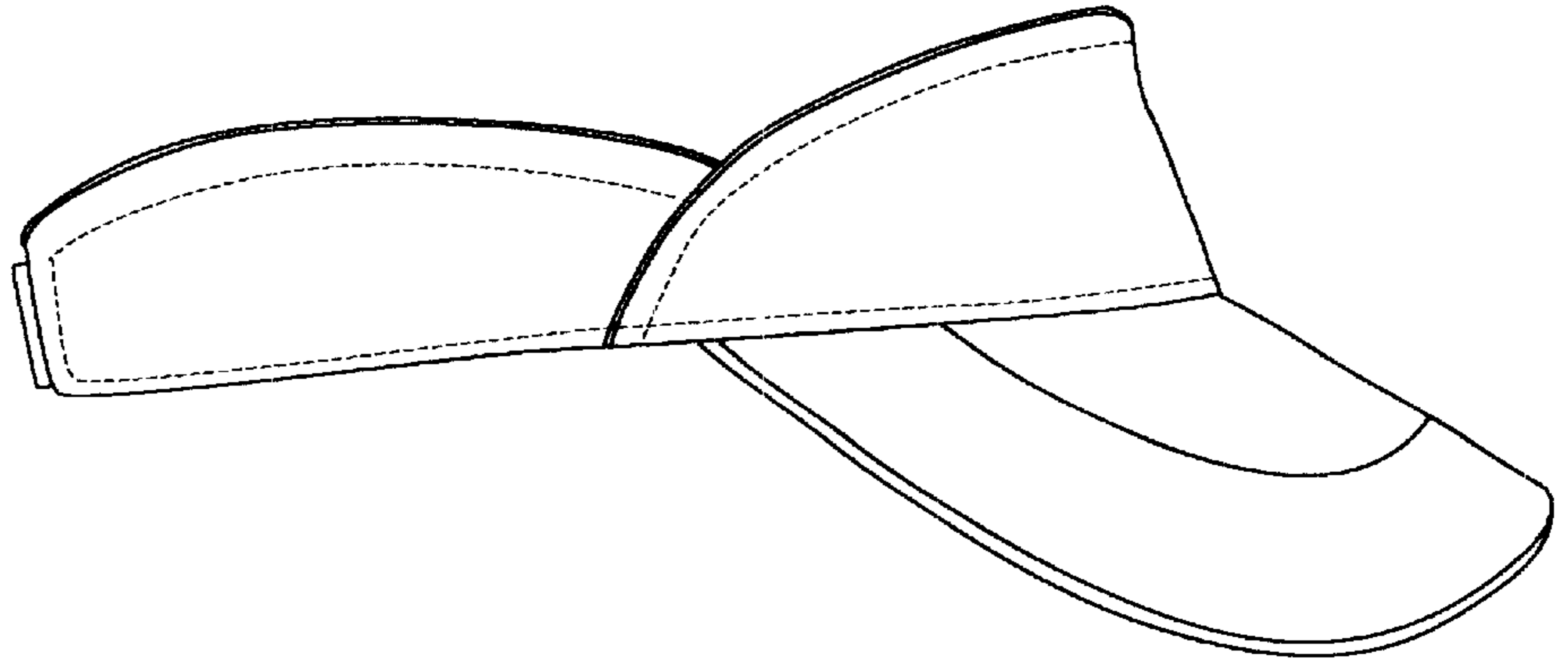

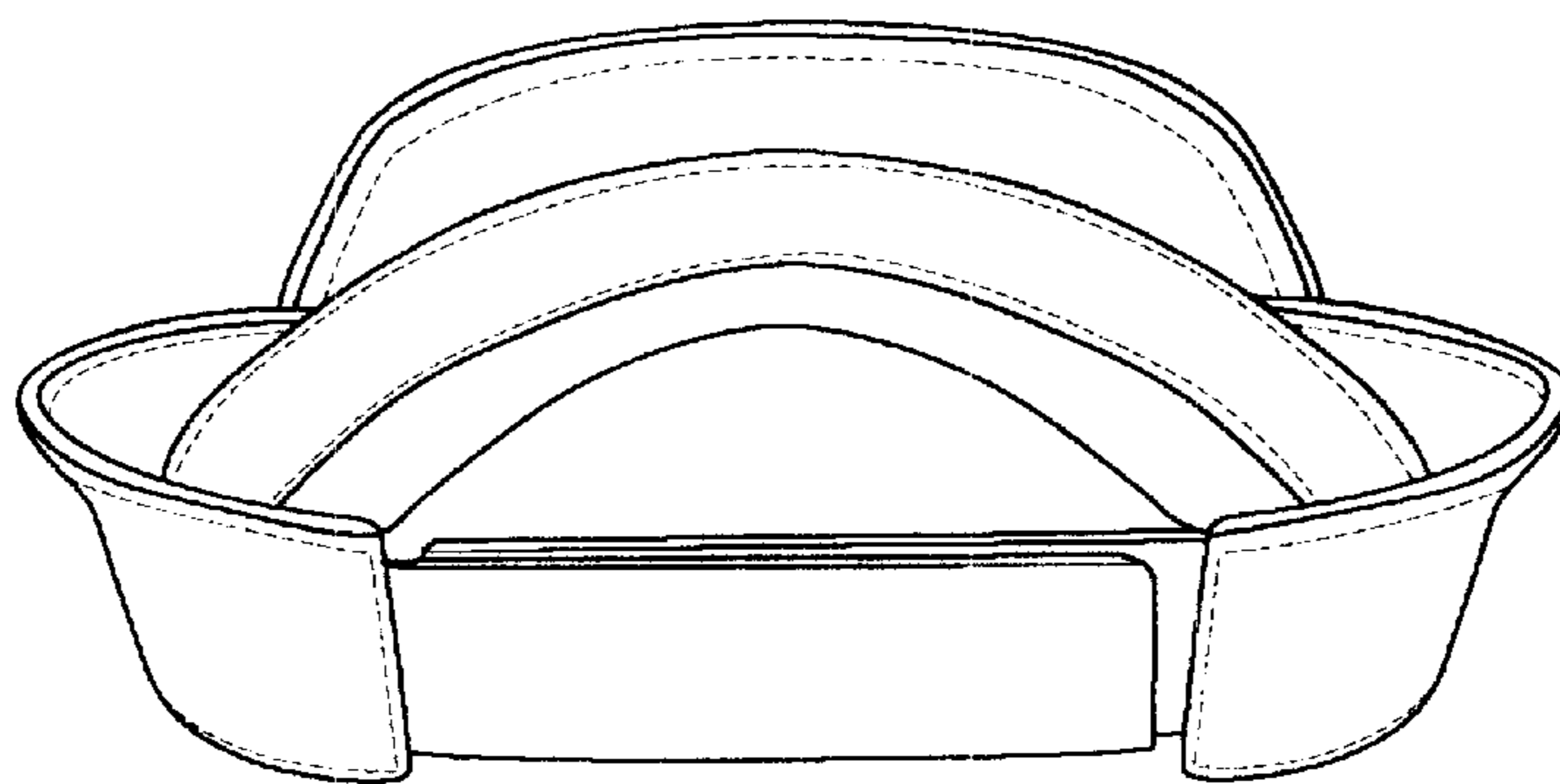
