FIG. 2 is a top plan view of the waterless bath and flea repel brush of the present invention.

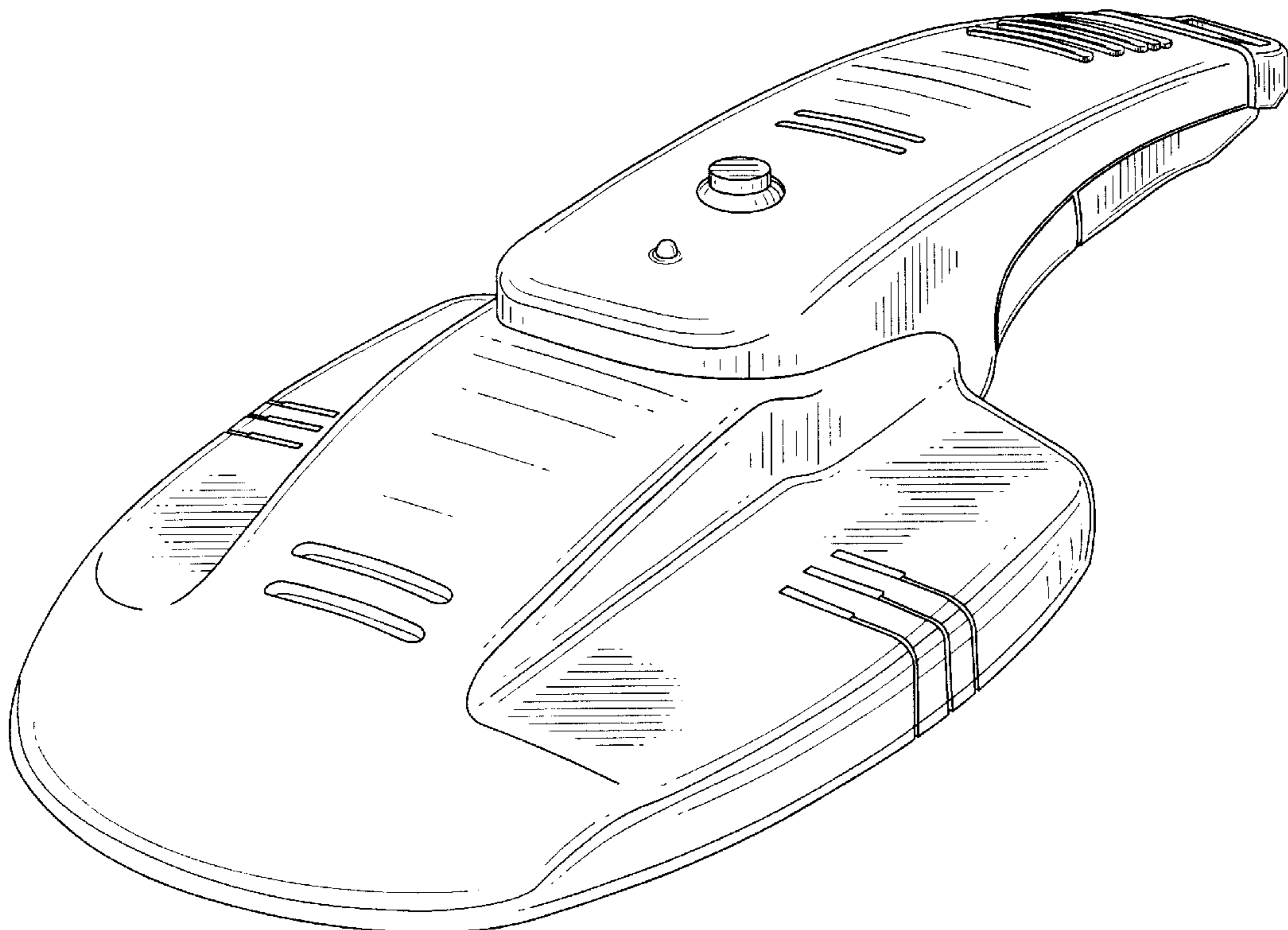
FIG. 3 is a right side elevation view of the waterless bath and flea repel brush of the present invention.

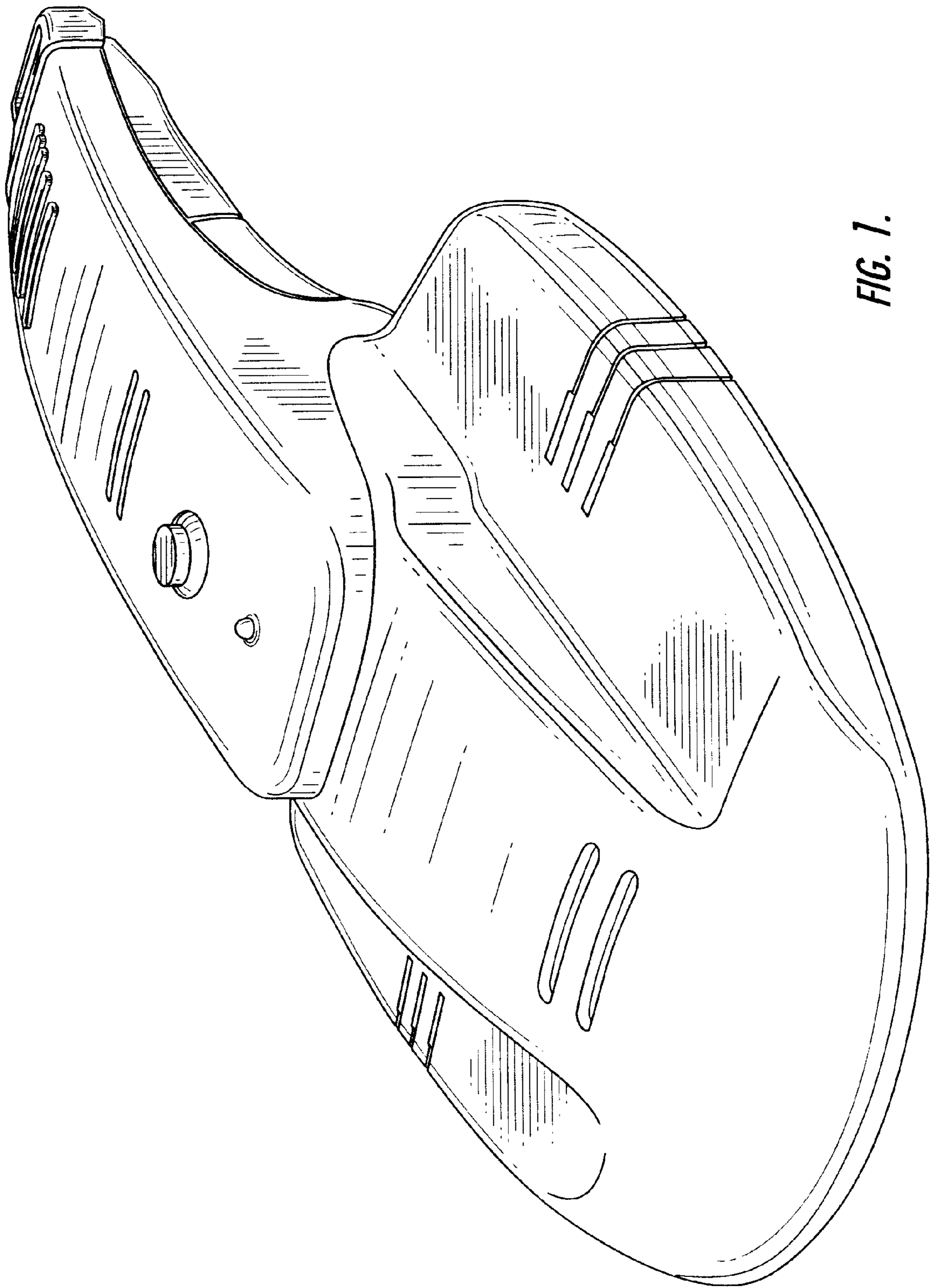

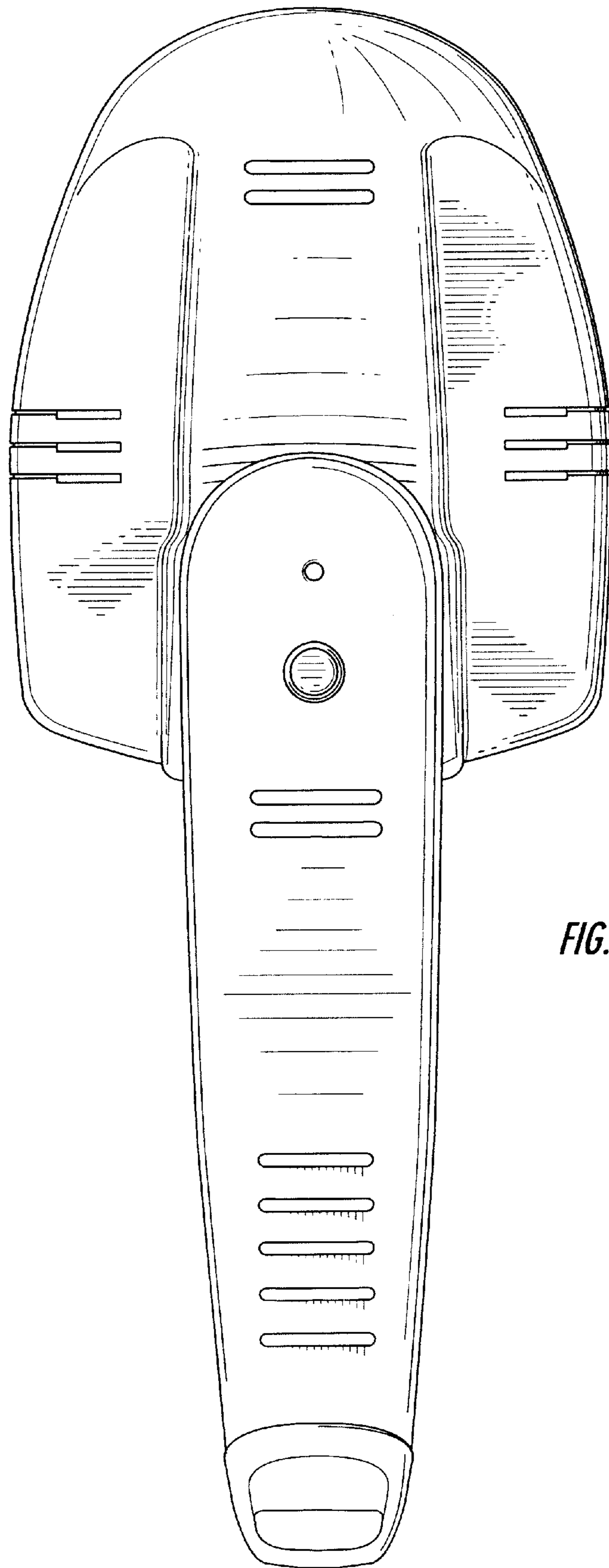

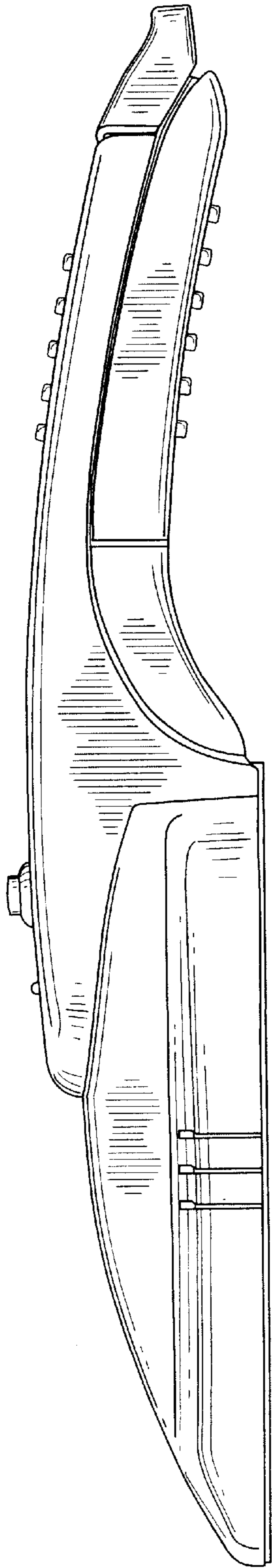

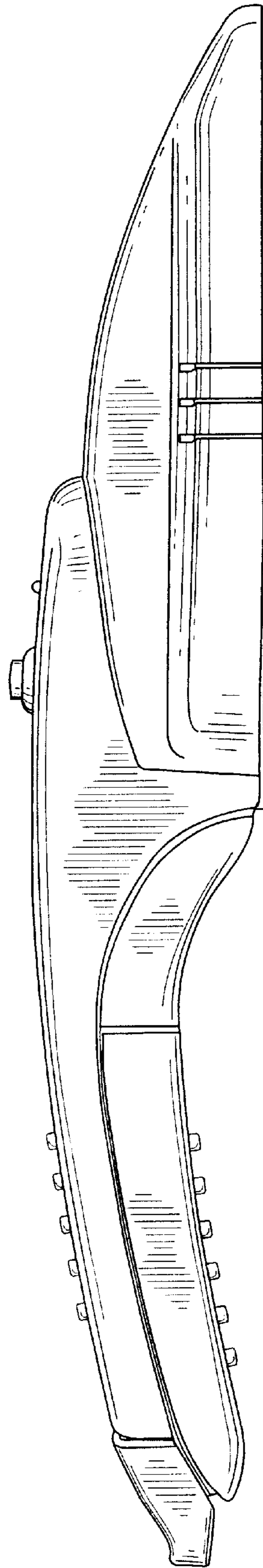
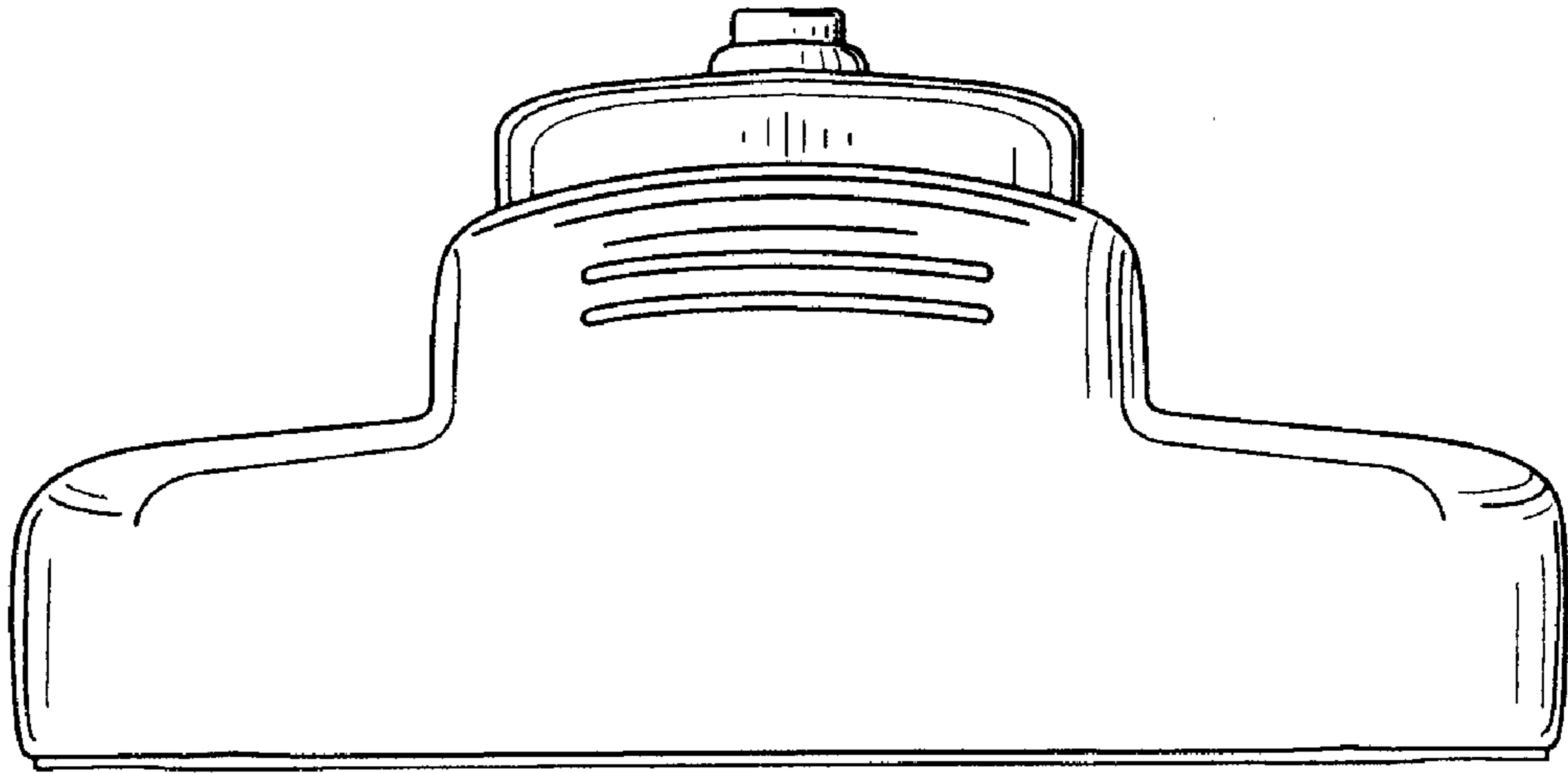
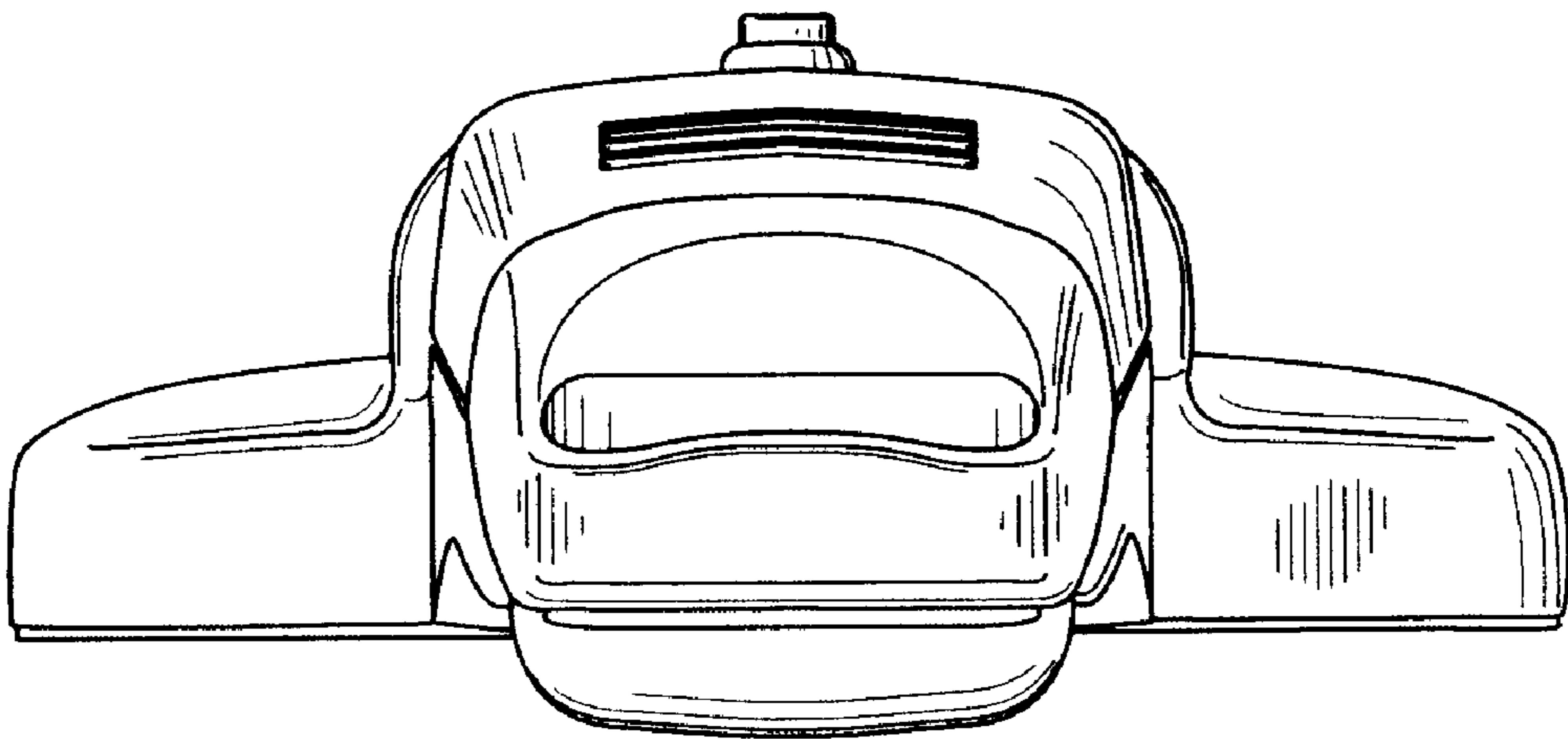
