**DESCRIPTION**

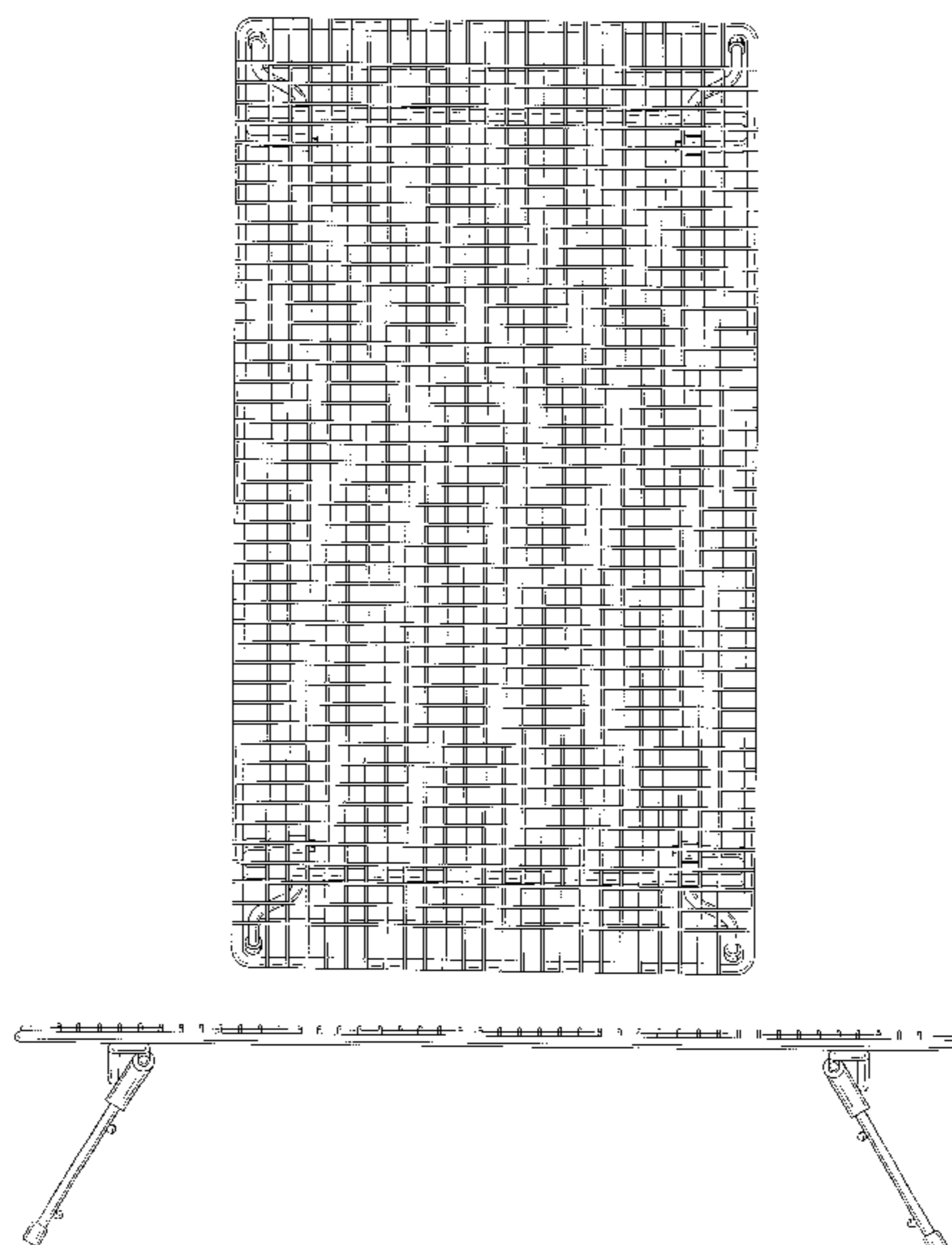
FIG. 1 is top plan view of a cooling rack embodying the inventive aspects of the present invention;

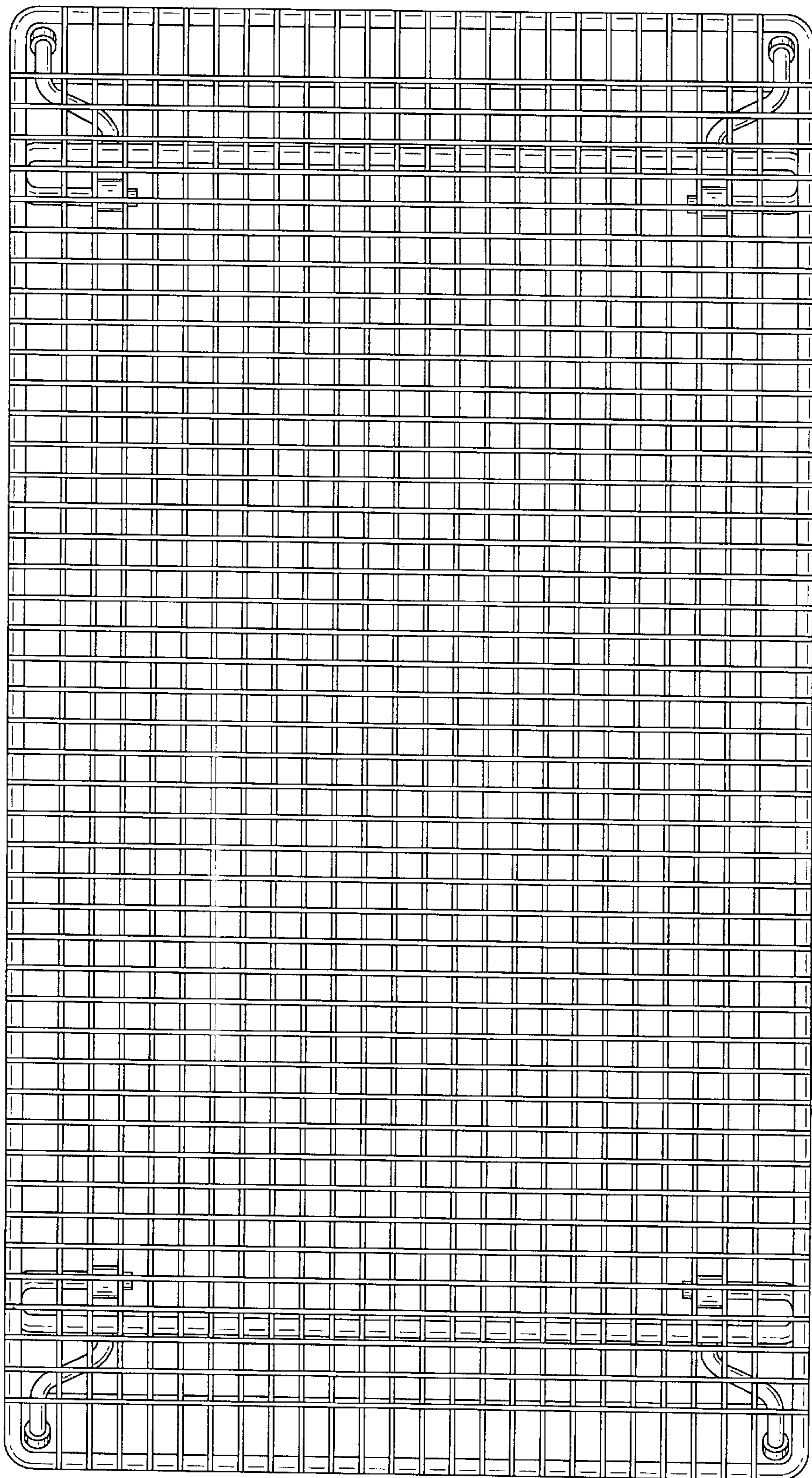

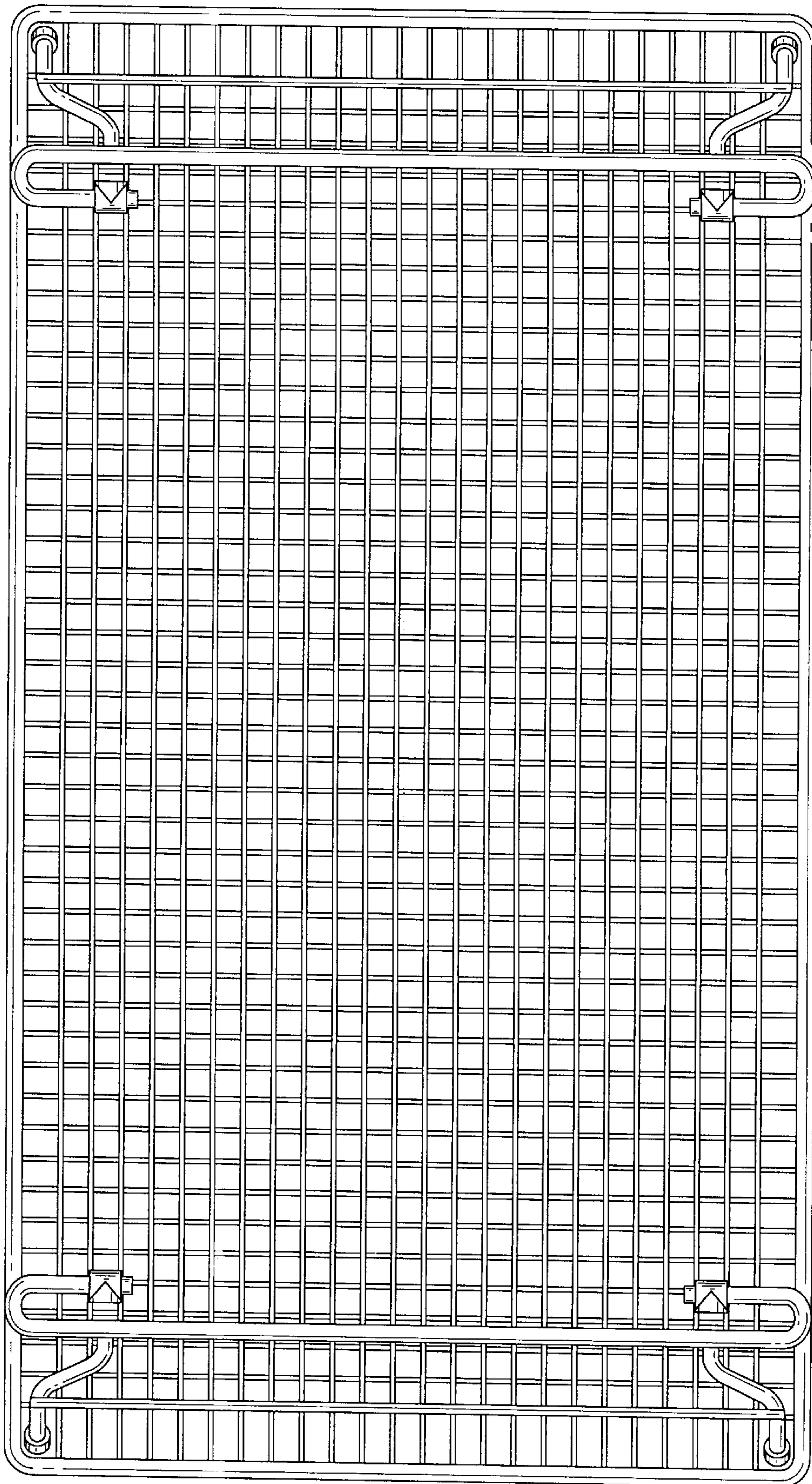

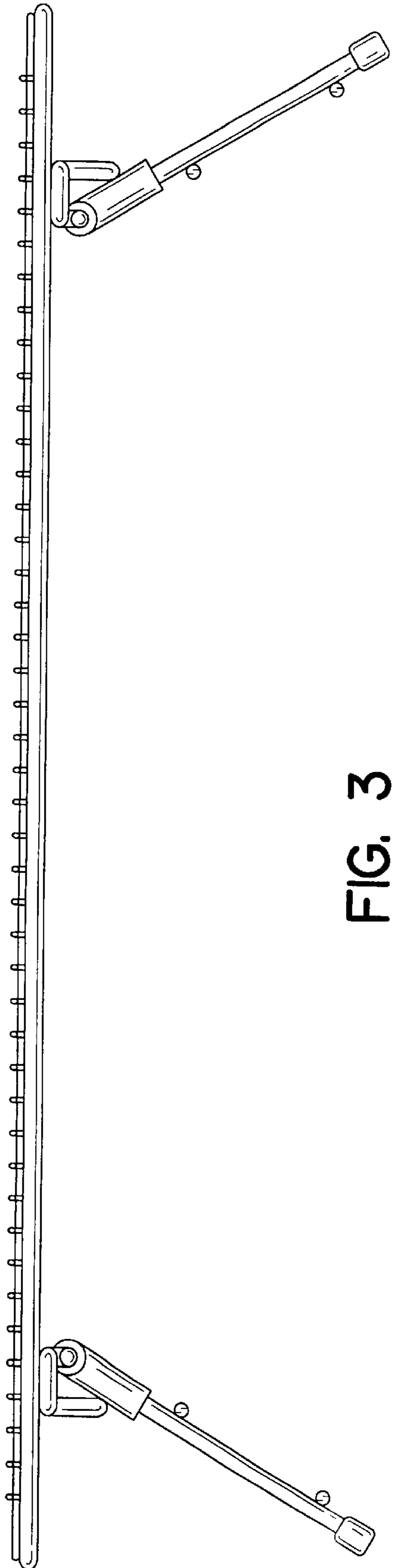

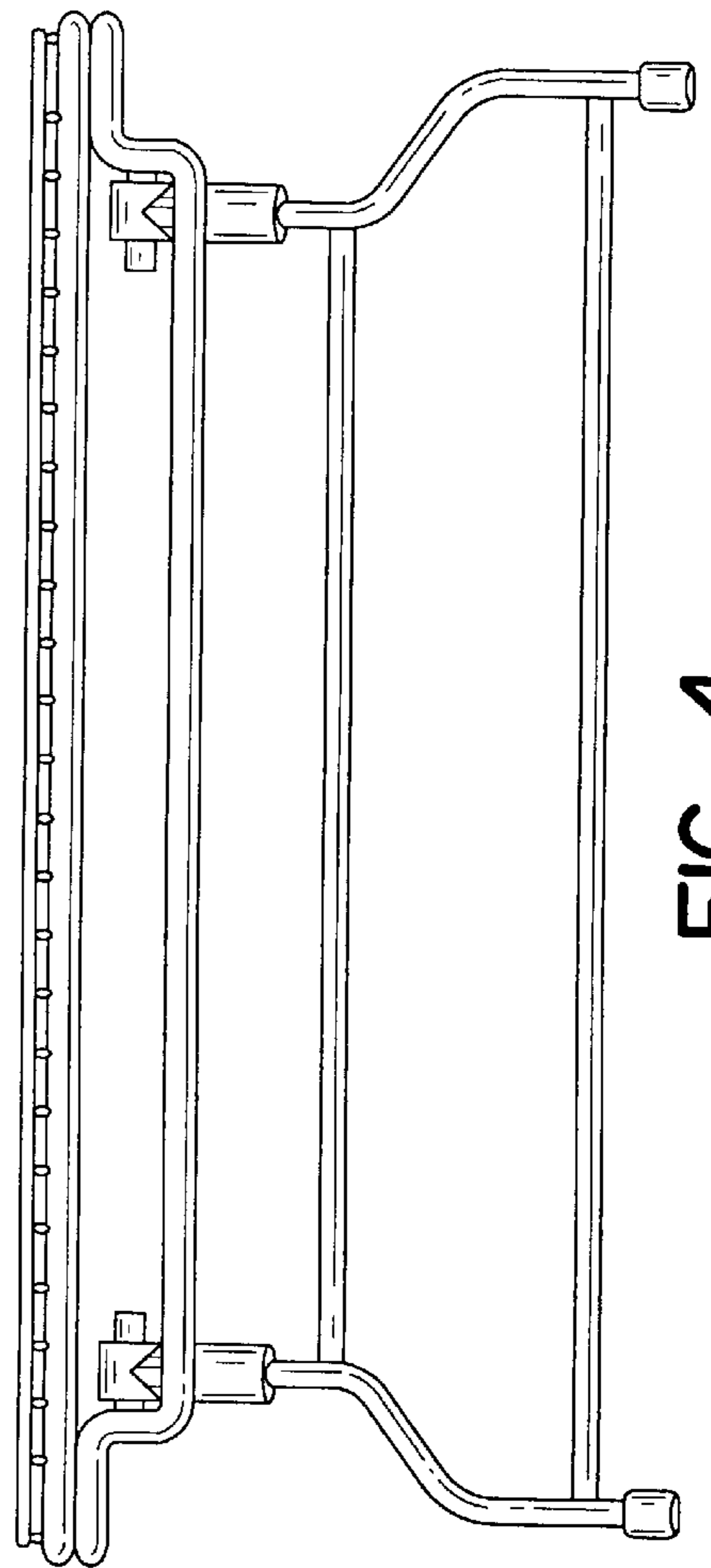
