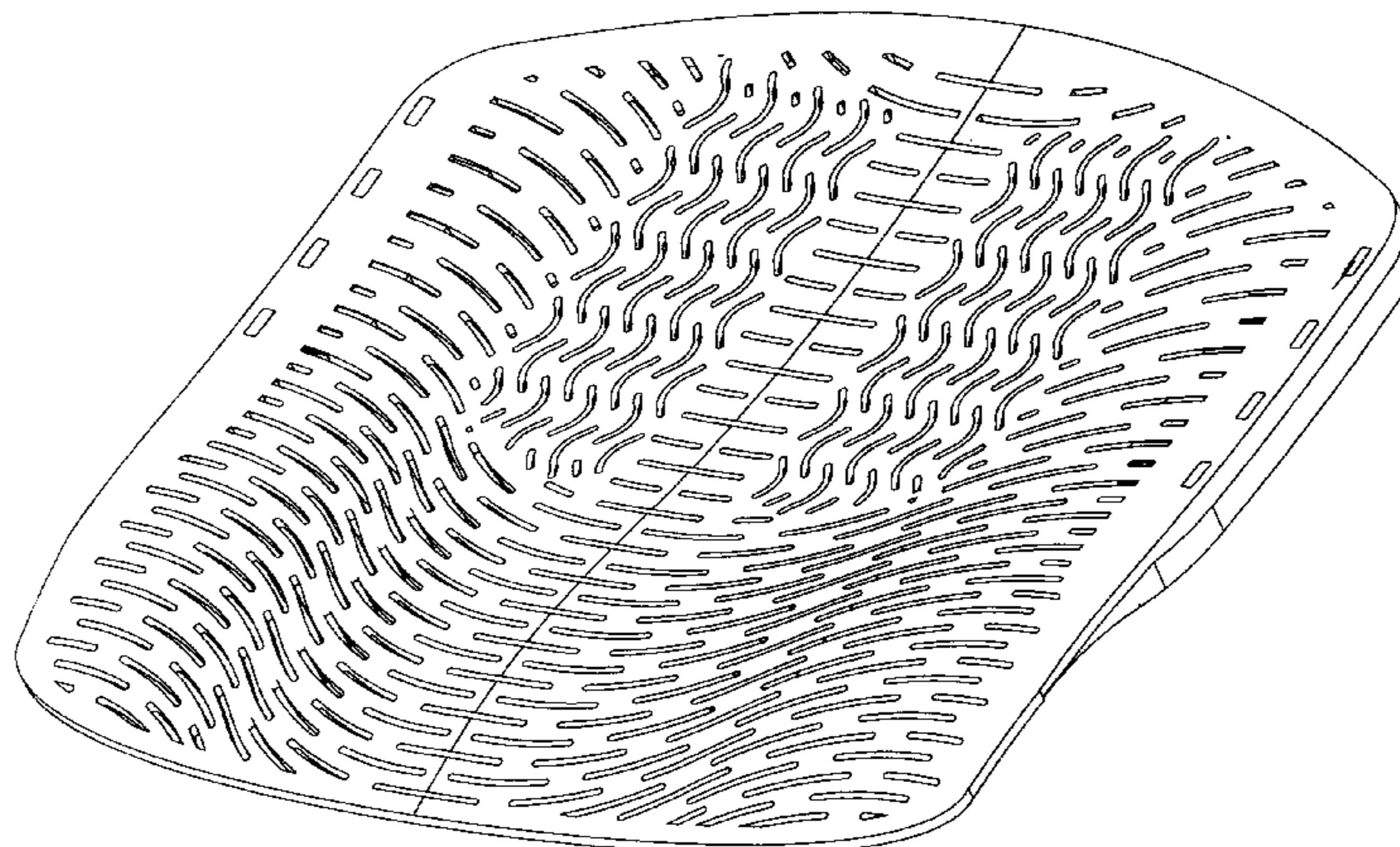
(57) **CLAIM**

The ornamental design for a slotted seat panel for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a slotted seat panel for a chair showing our new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is an enlarged front elevational view thereof;
 FIG. 4 is an enlarged rear elevational view thereof;
 FIG. 5 is an enlarged right elevational view thereof;
 FIG. 6 is an enlarged left elevational view thereof;
 FIG. 7 is a top plan view thereof; and,
 FIG. 8 is a bottom plan view thereof.

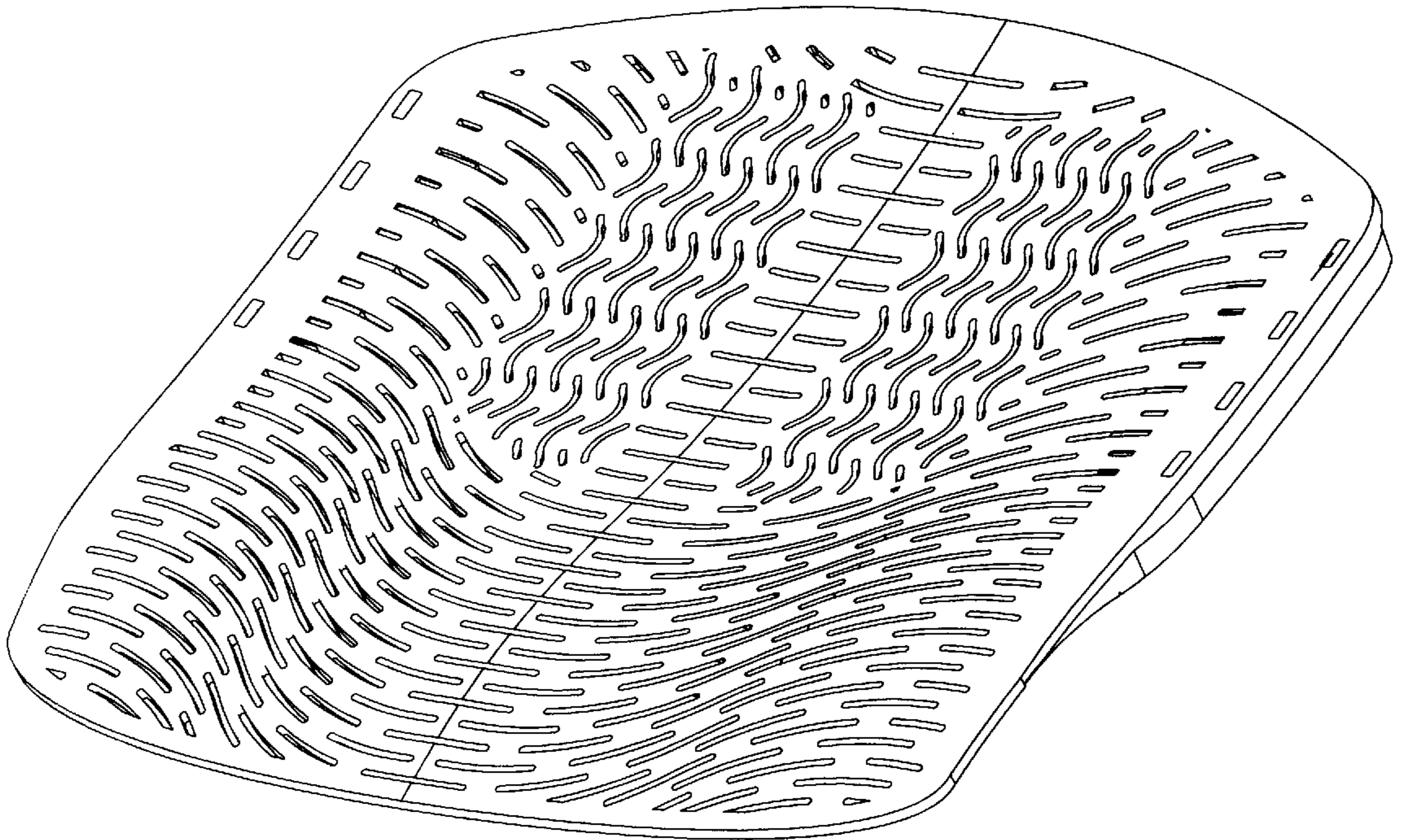

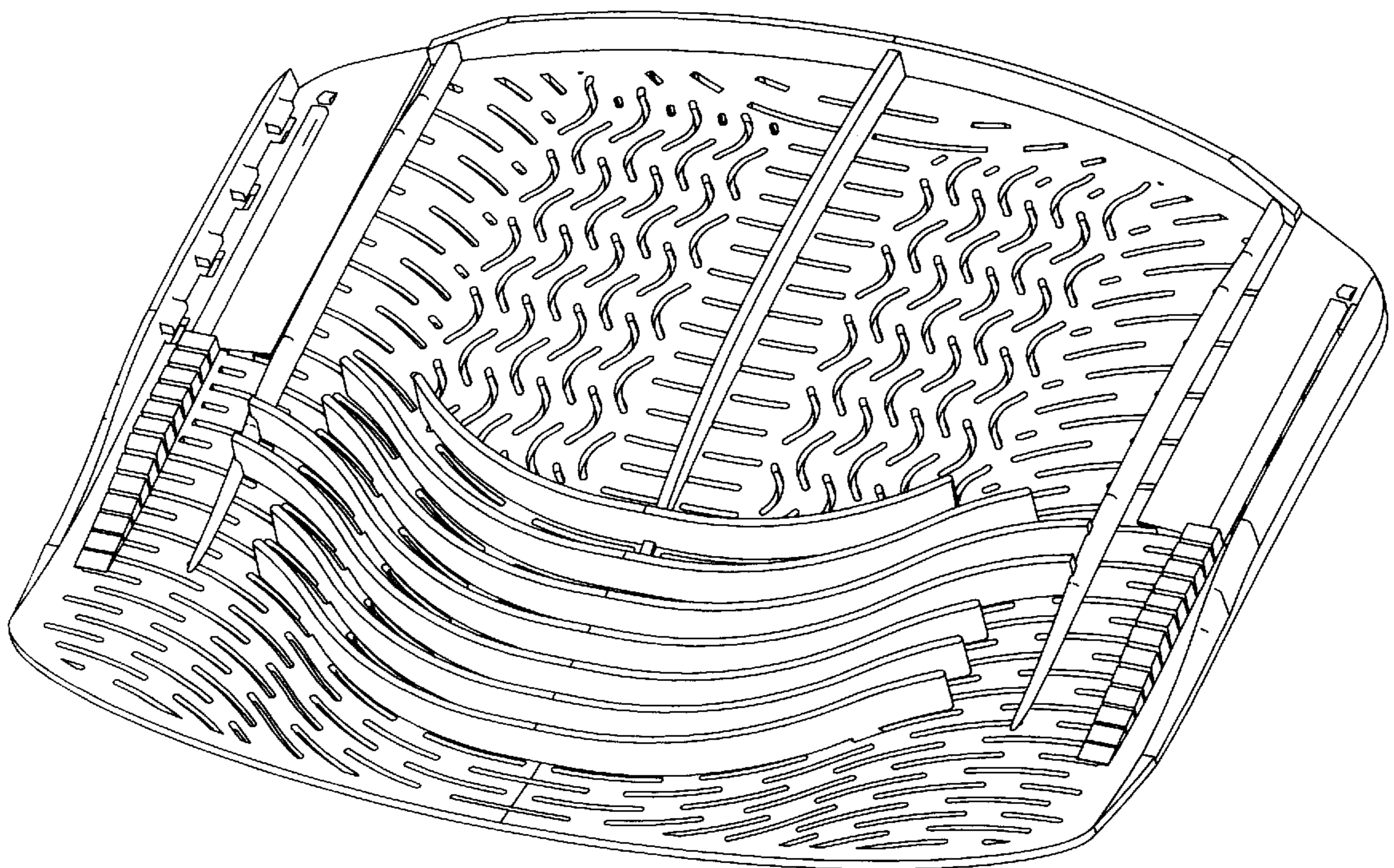

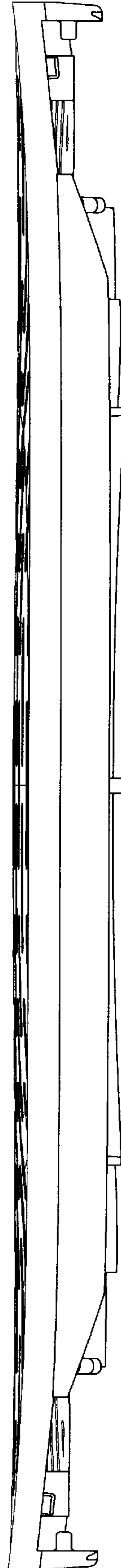

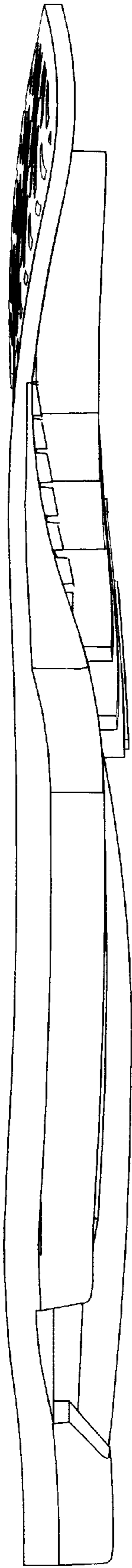

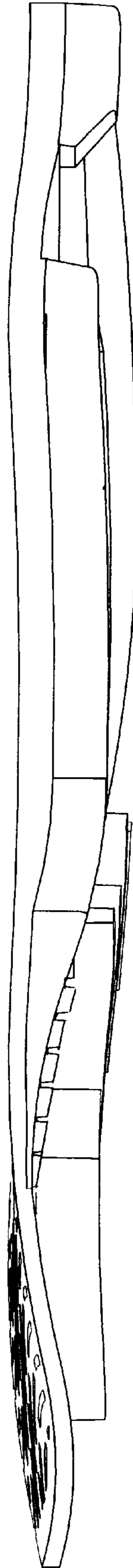

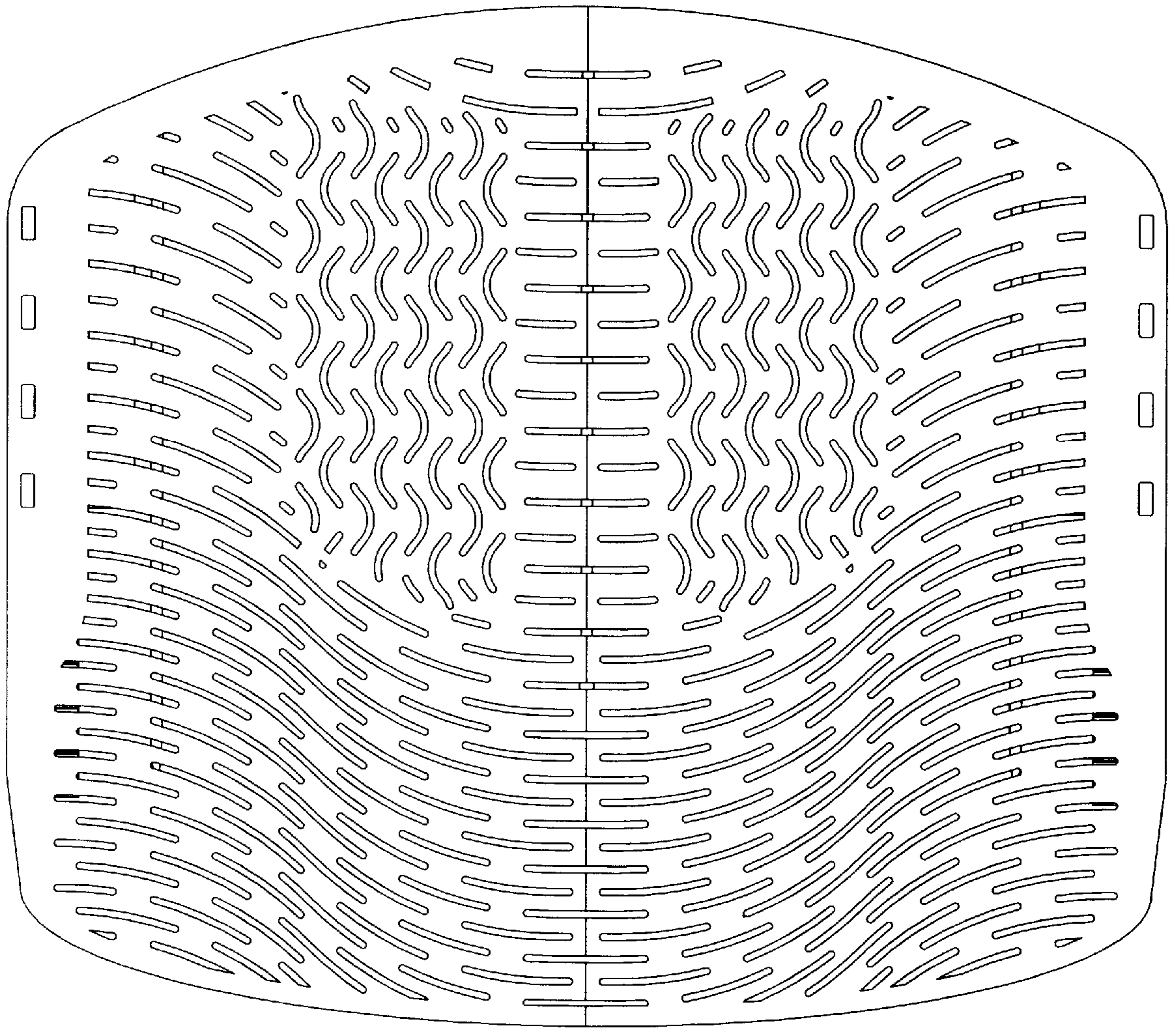

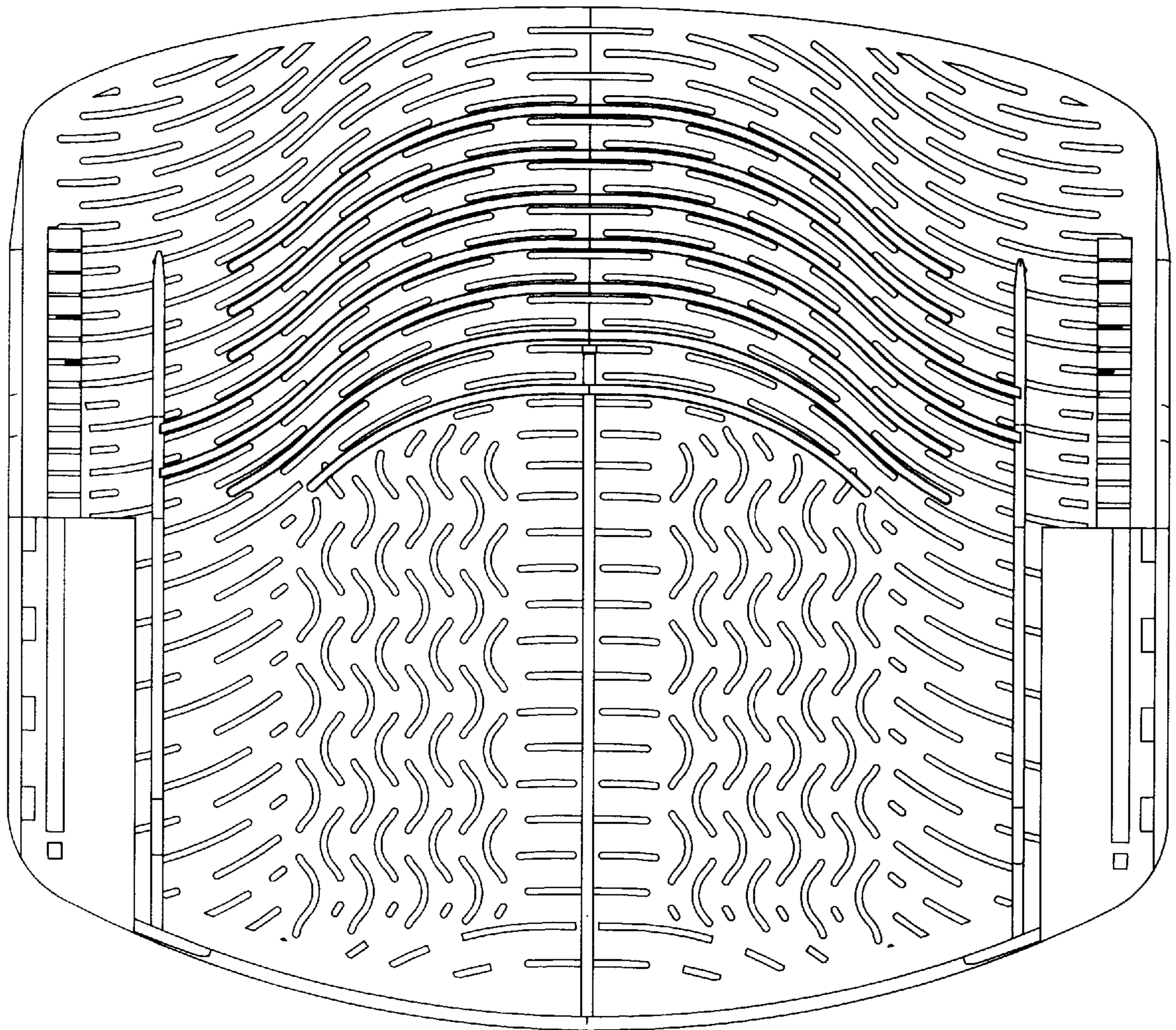
