FIG. 3 shows a right side view of the skull box.

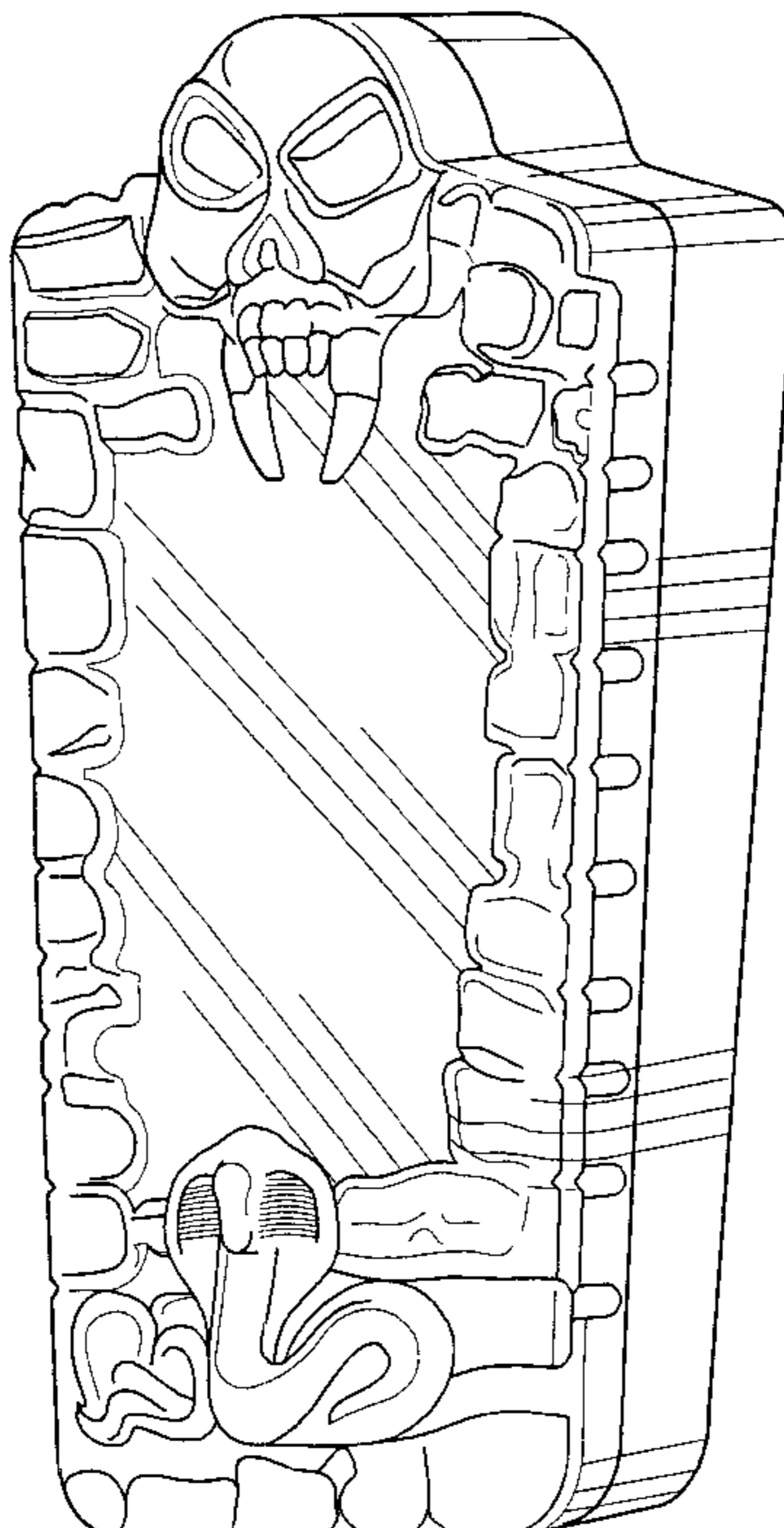
FIG. 4 shows a left side view of the skull box.

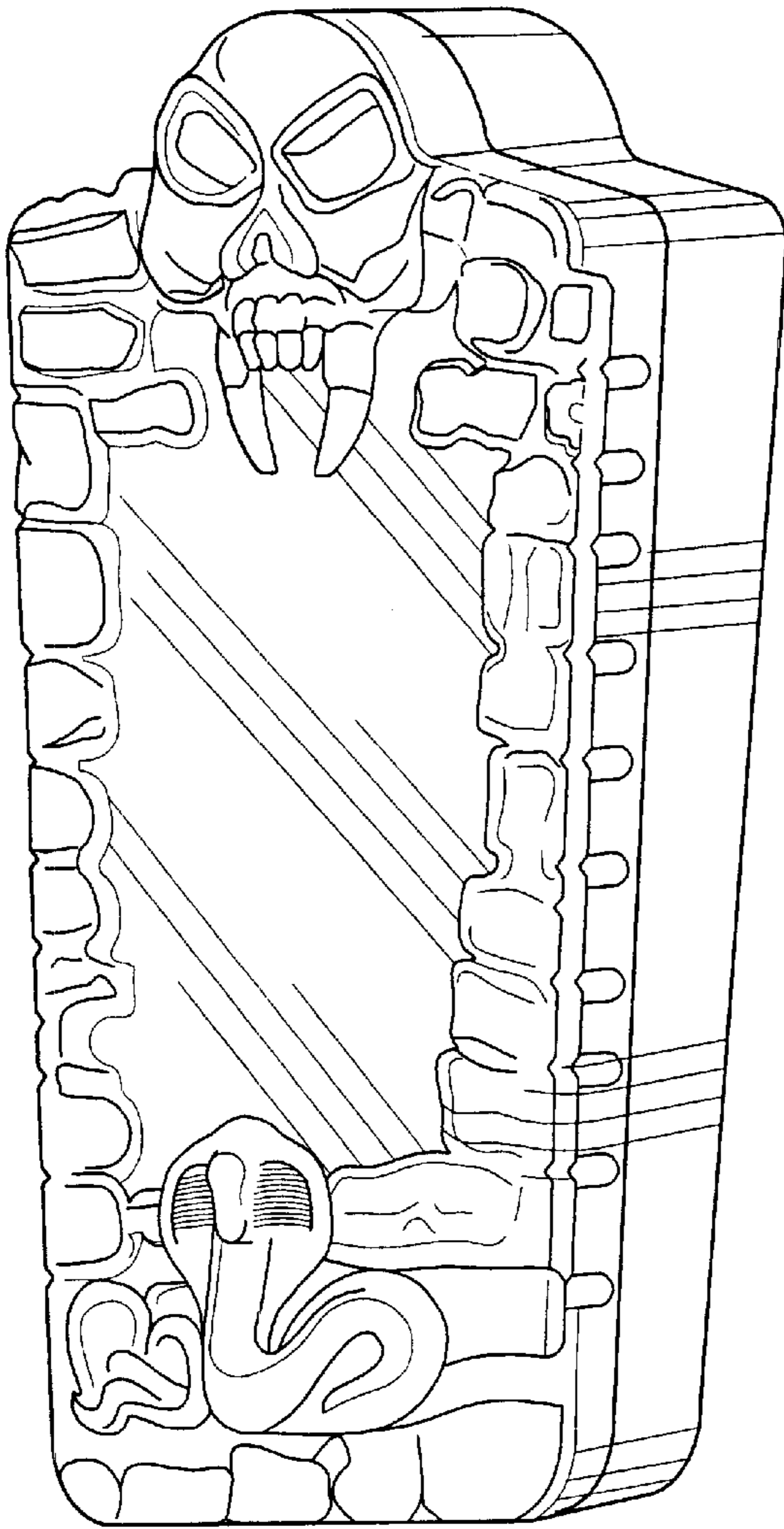

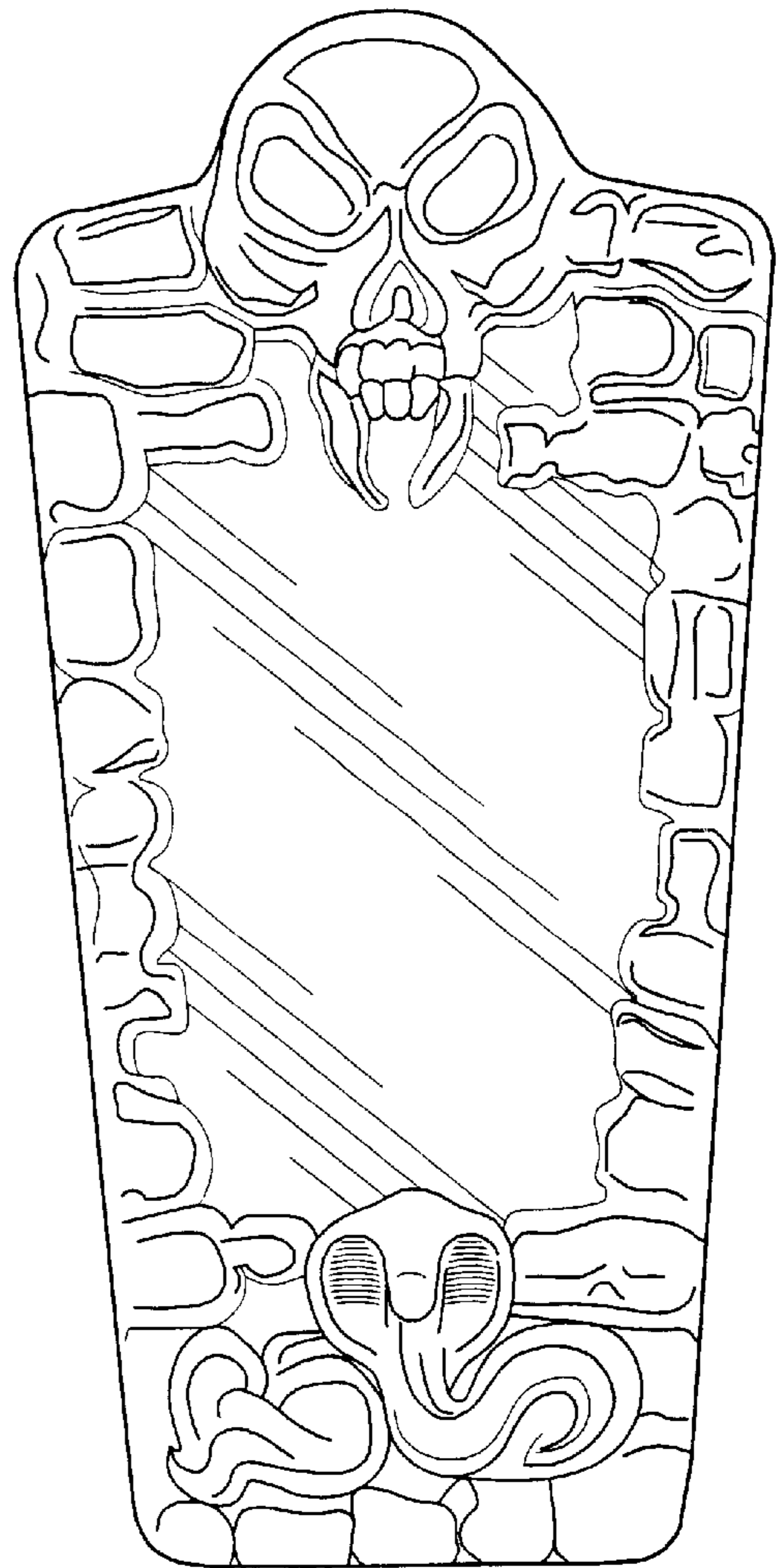

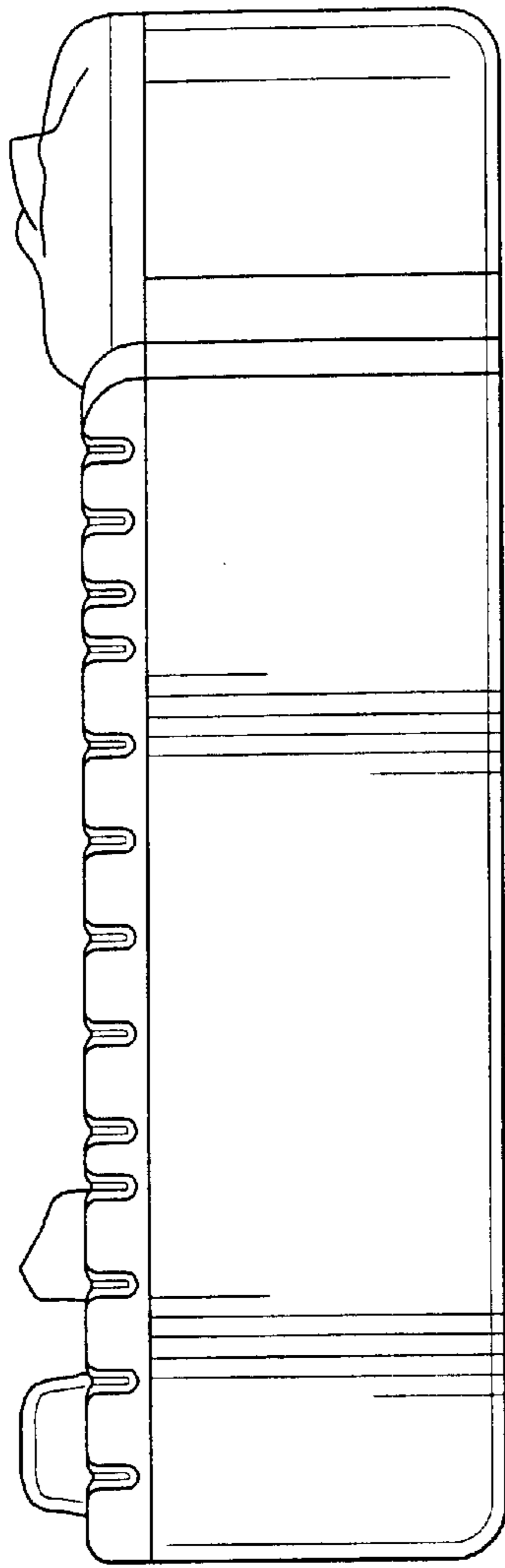

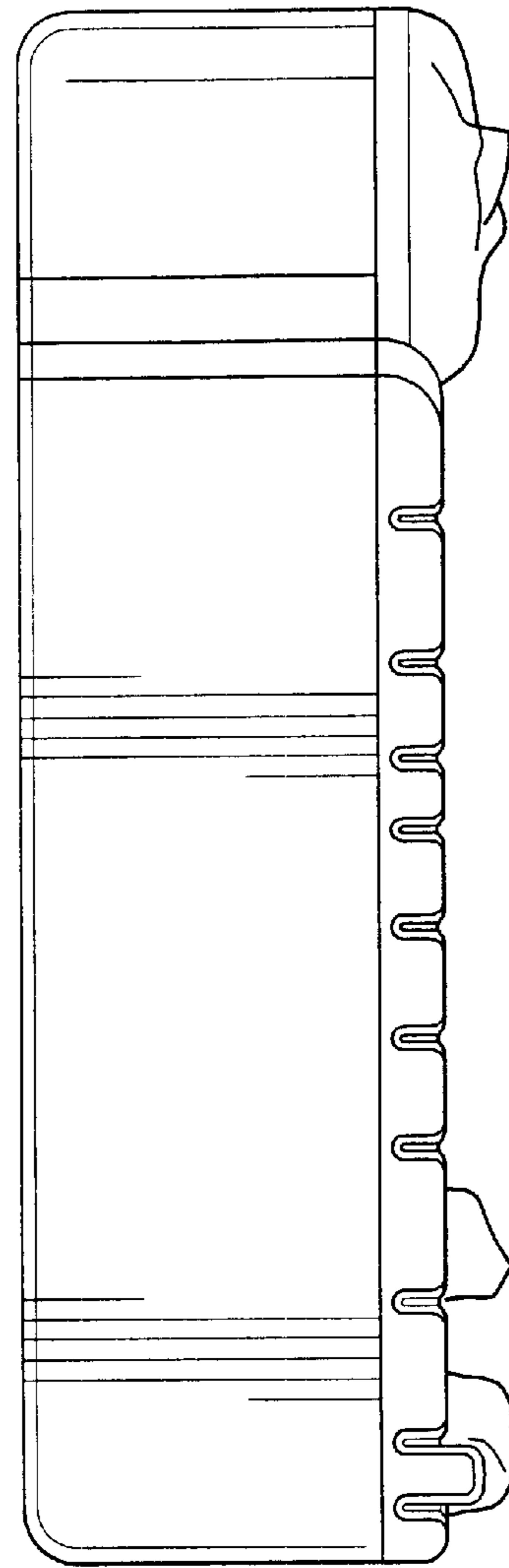

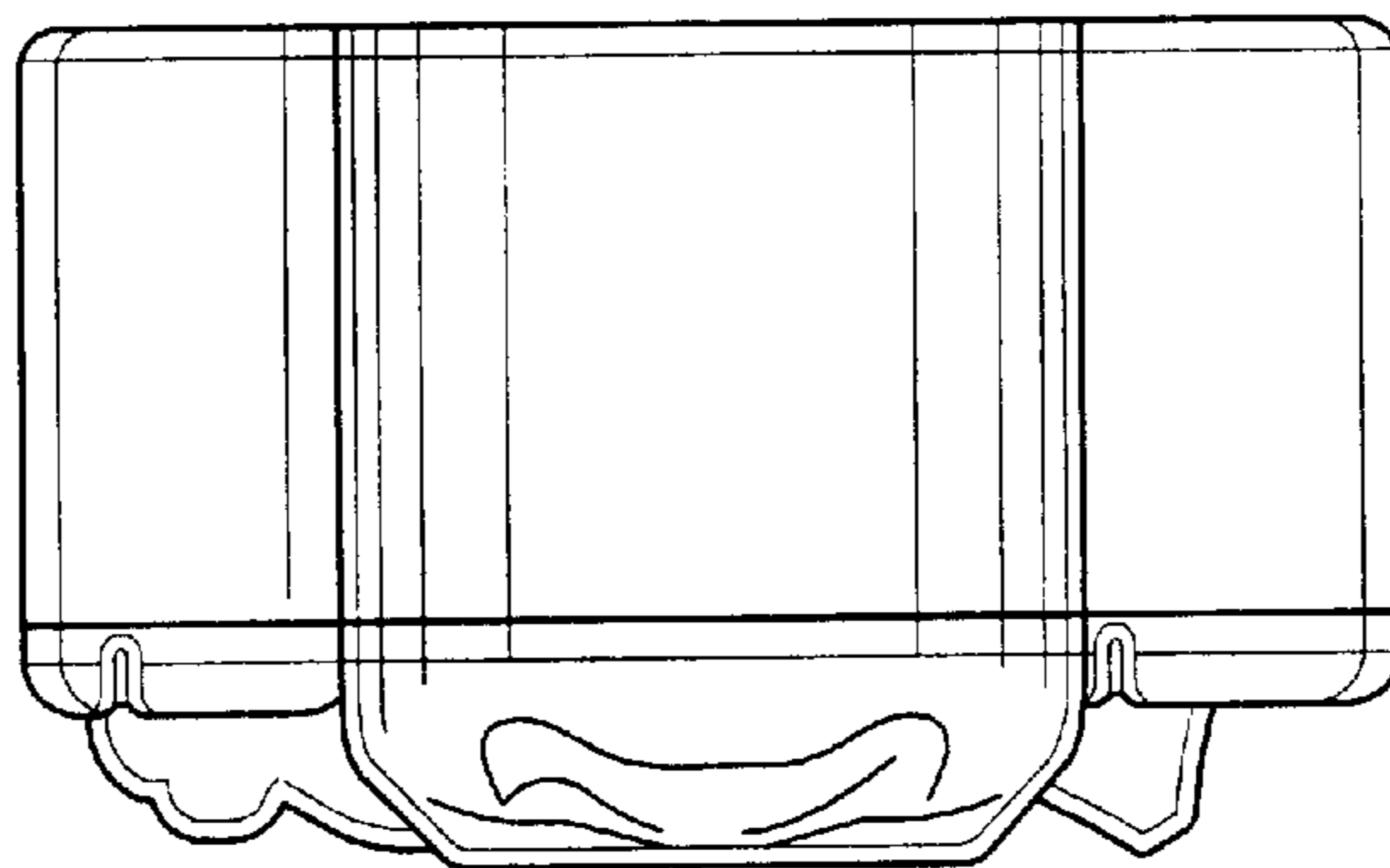

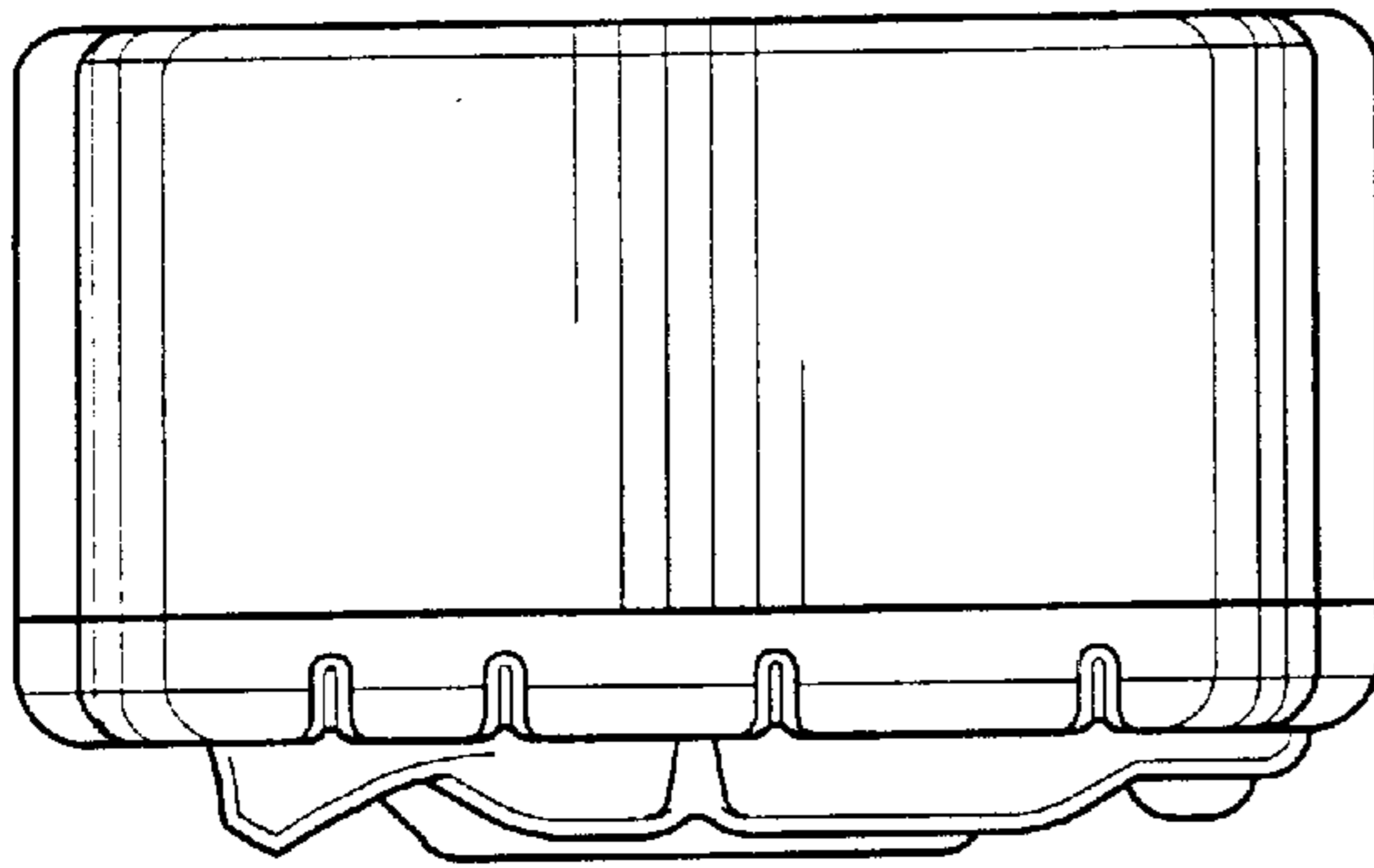

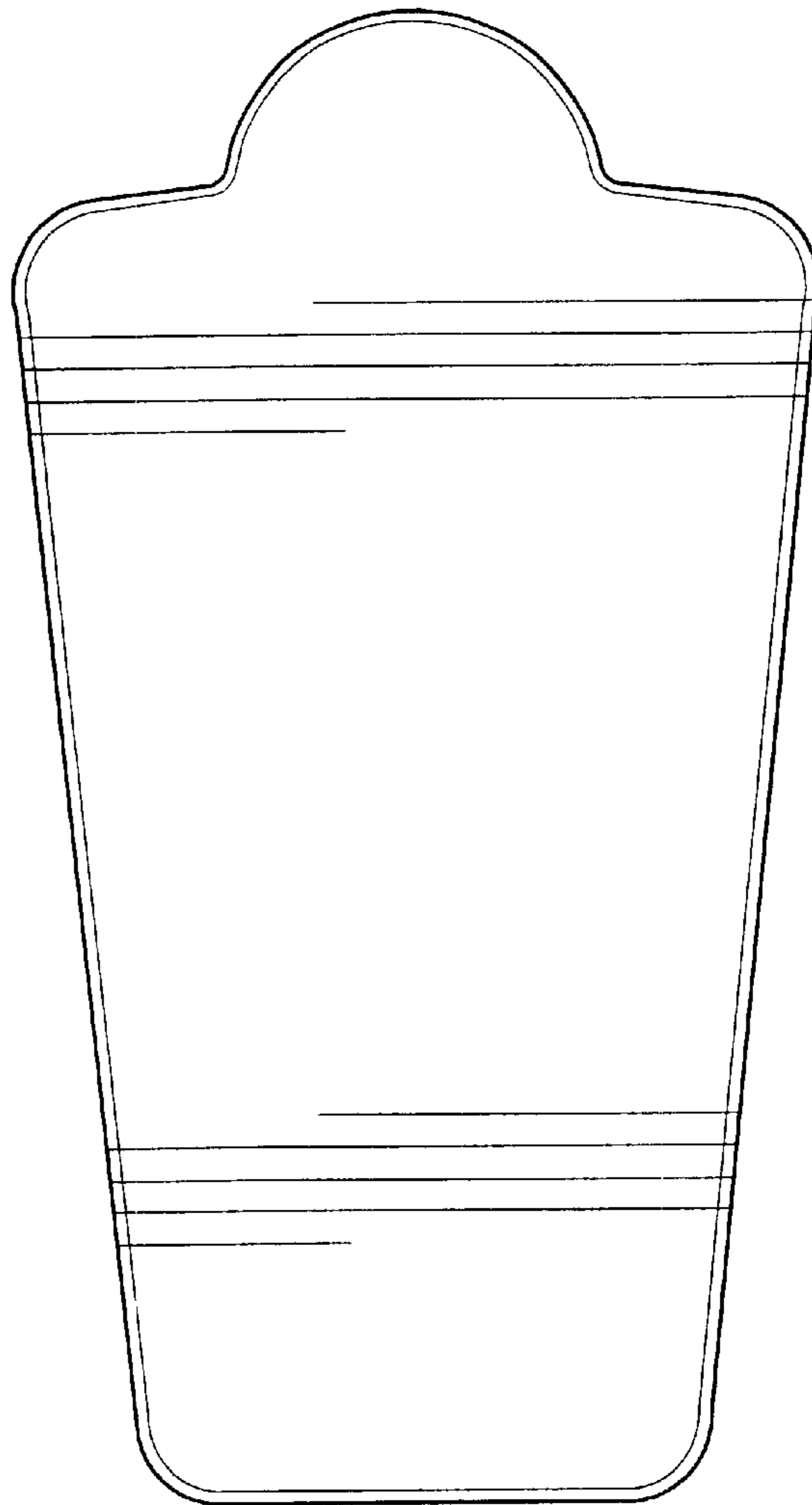
