An ornamental object, as shown and described.

DESCRIPTION

FIG. 1 is a top view of an ornamental object showing my new design;

FIG. 2 is a left side elevational view, the opposite being a mirror image;

FIG. 3 is a bottom view;

FIG. 4 is a top plan view of an ornamental object showing a second embodiment of my new design;

FIG. 5 is a left side elevational view of FIG. 4, the opposite being a mirror image; and,

FIG. 6 is a bottom view of FIG. 4.

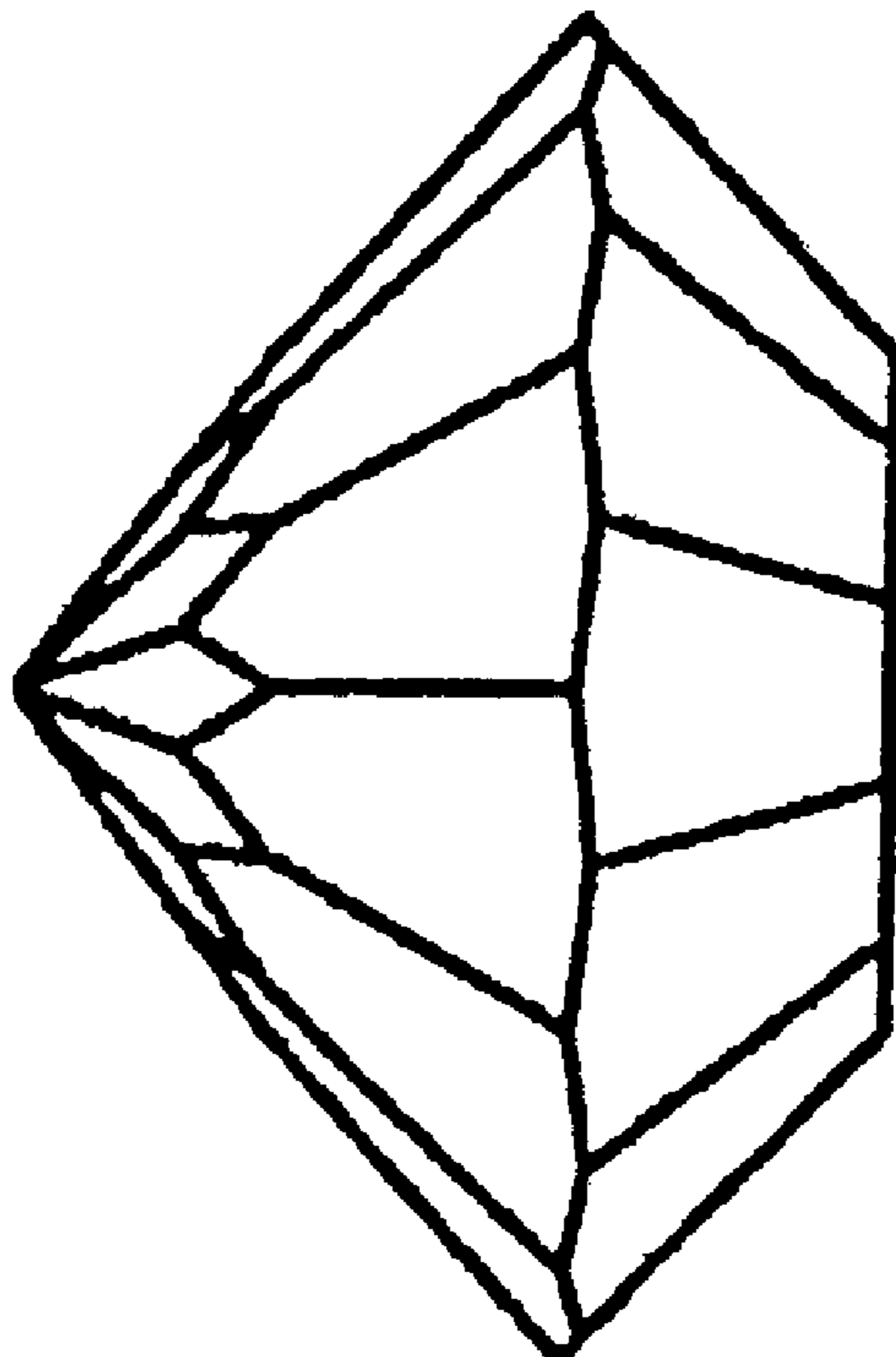

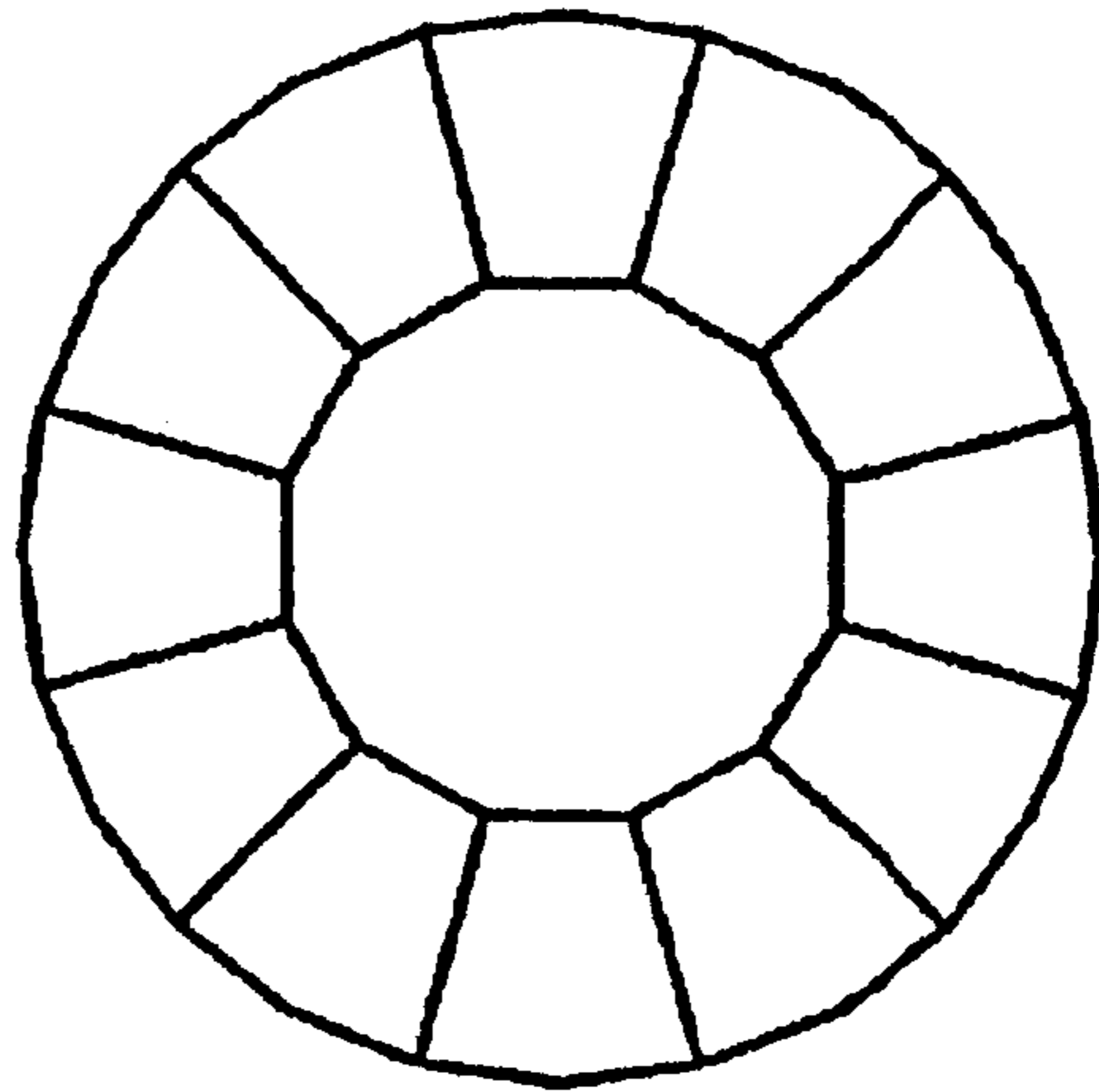

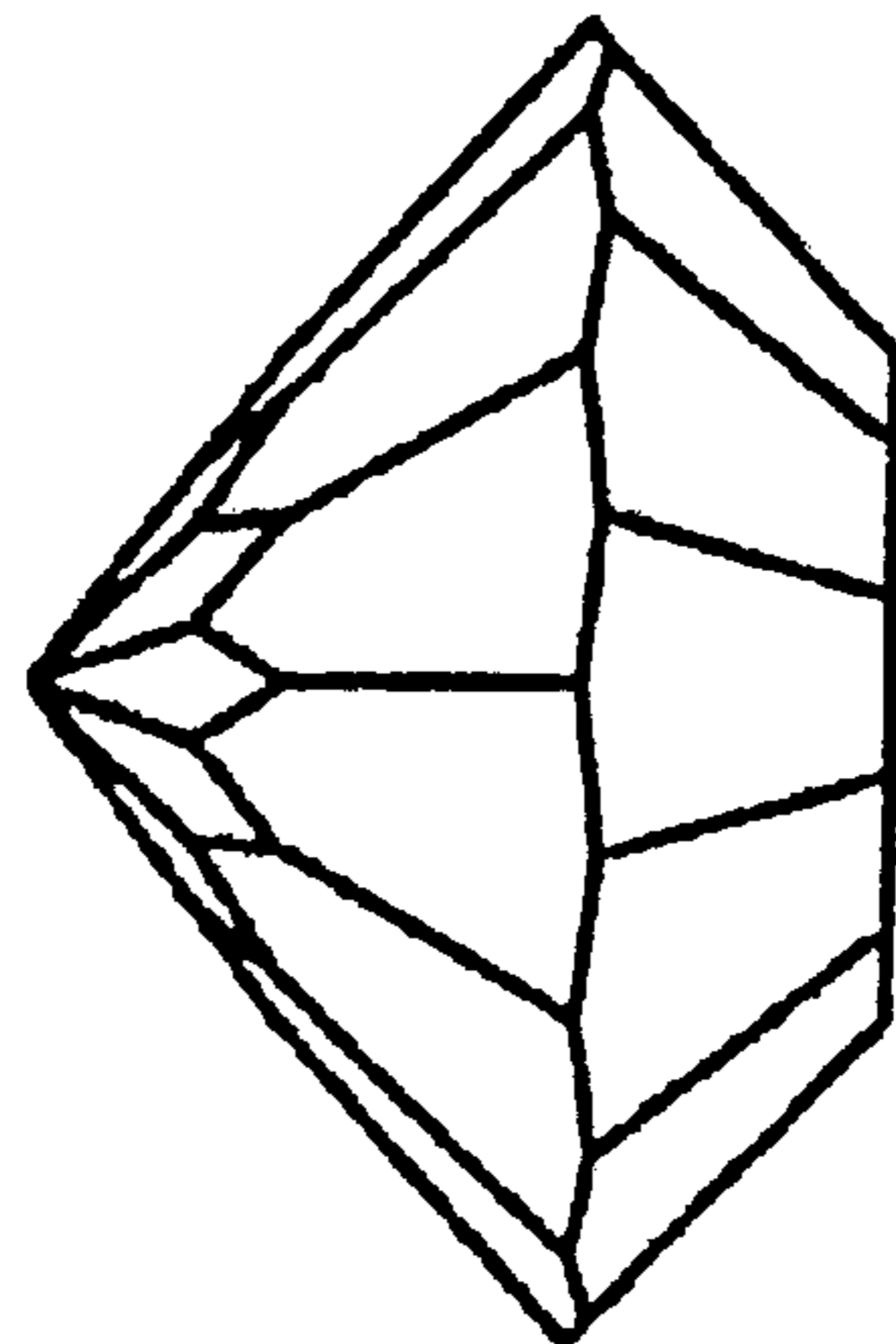

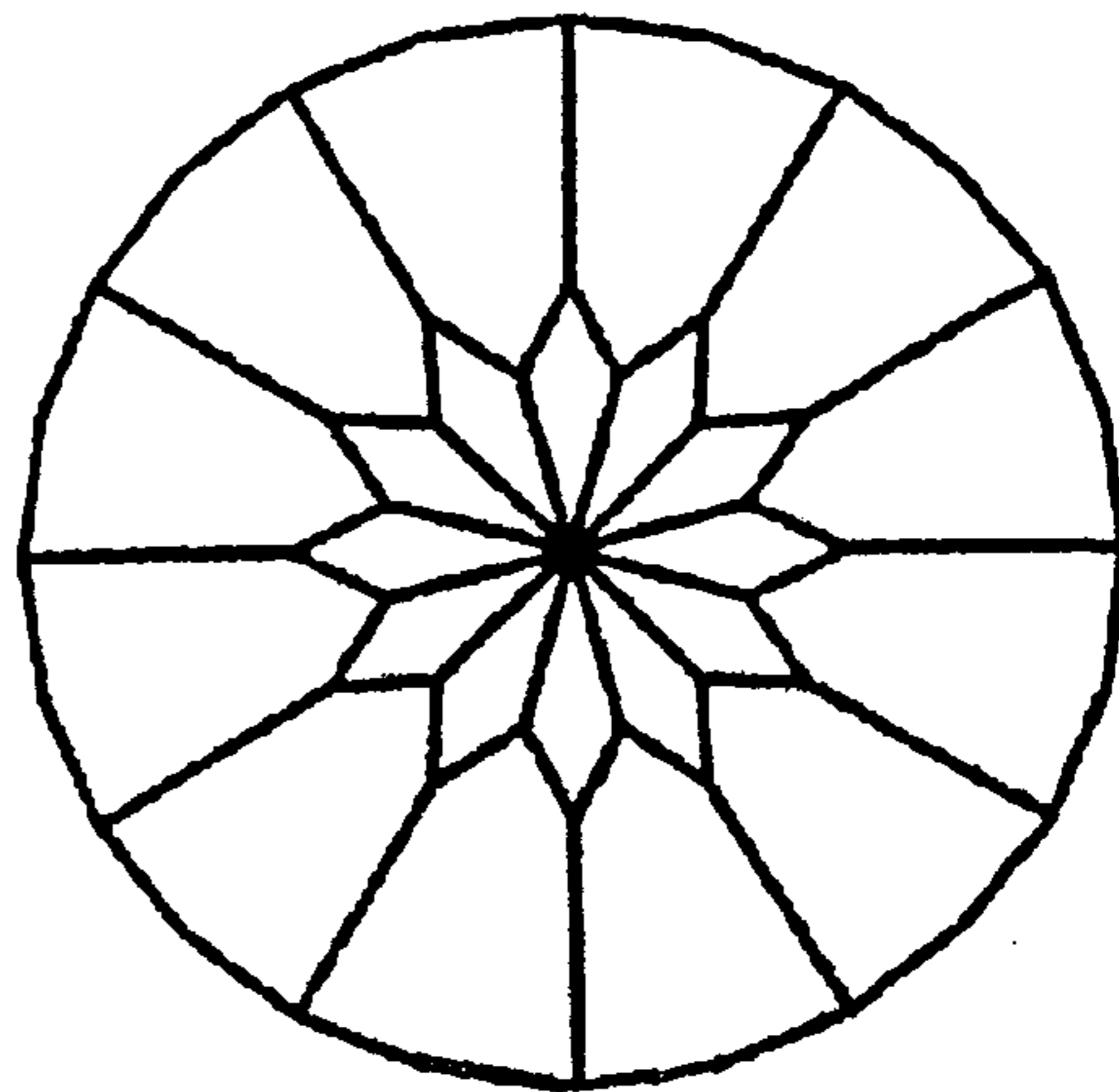

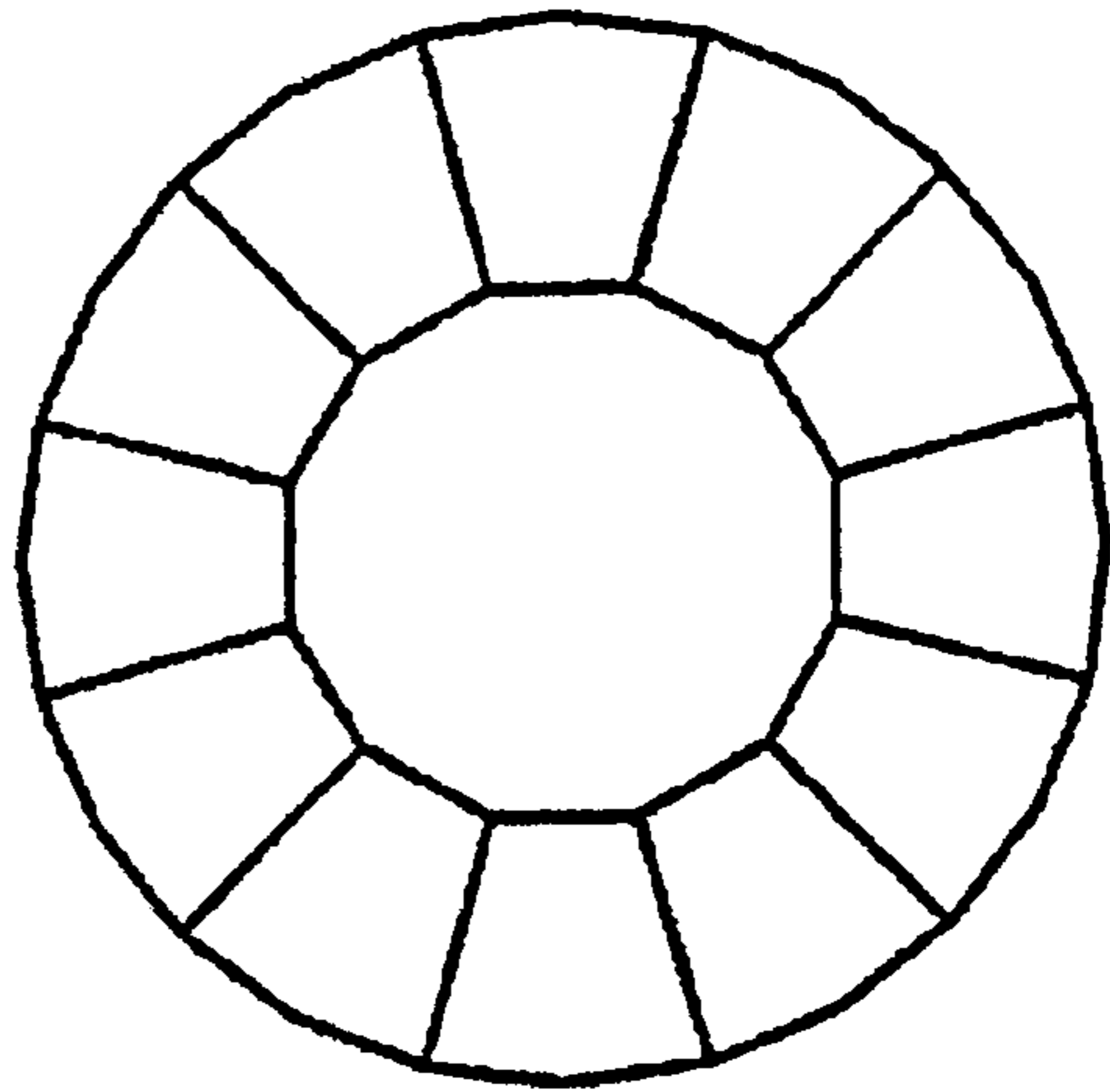

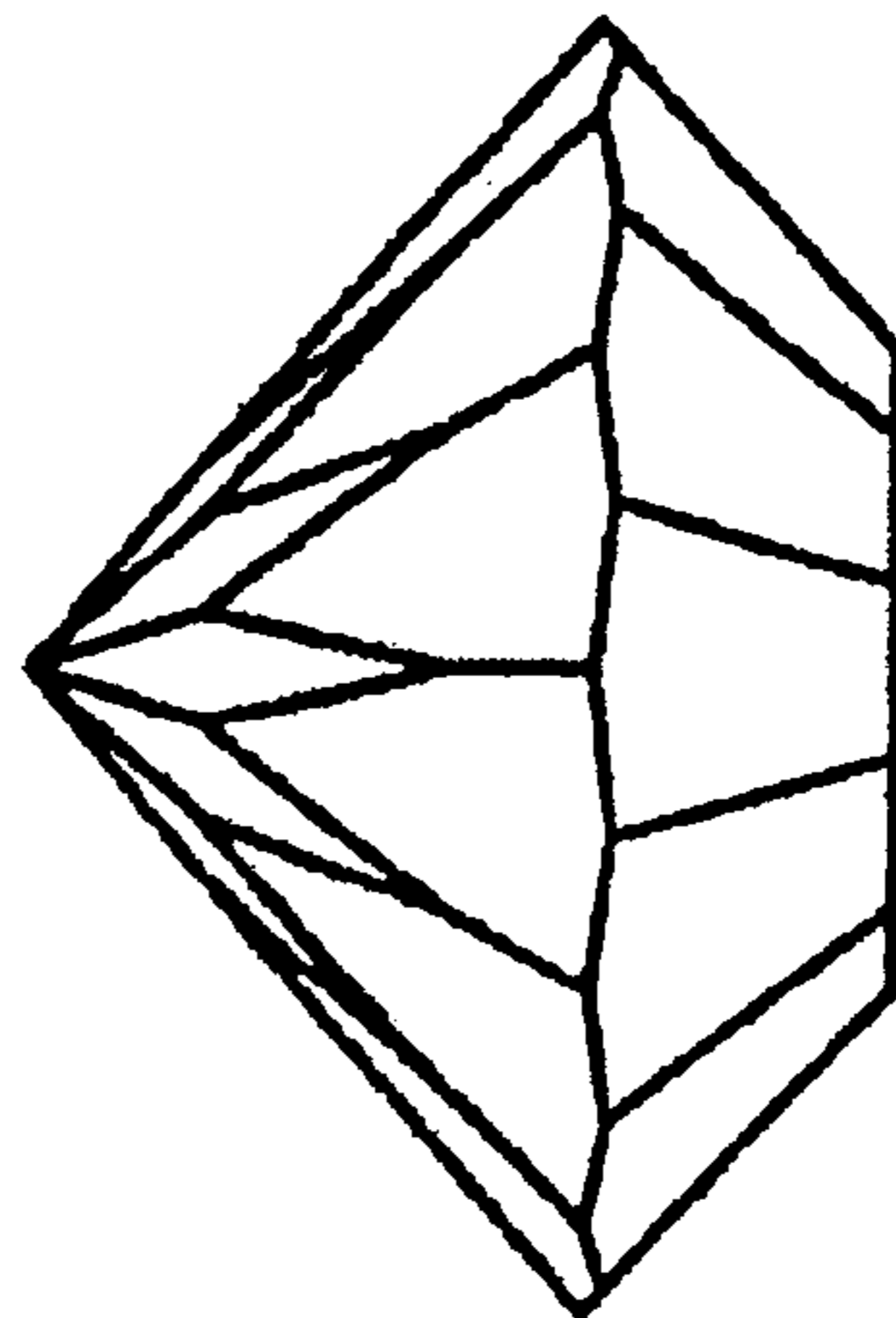
