The ornamental design for the window box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a window box comprising the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top view thereof;

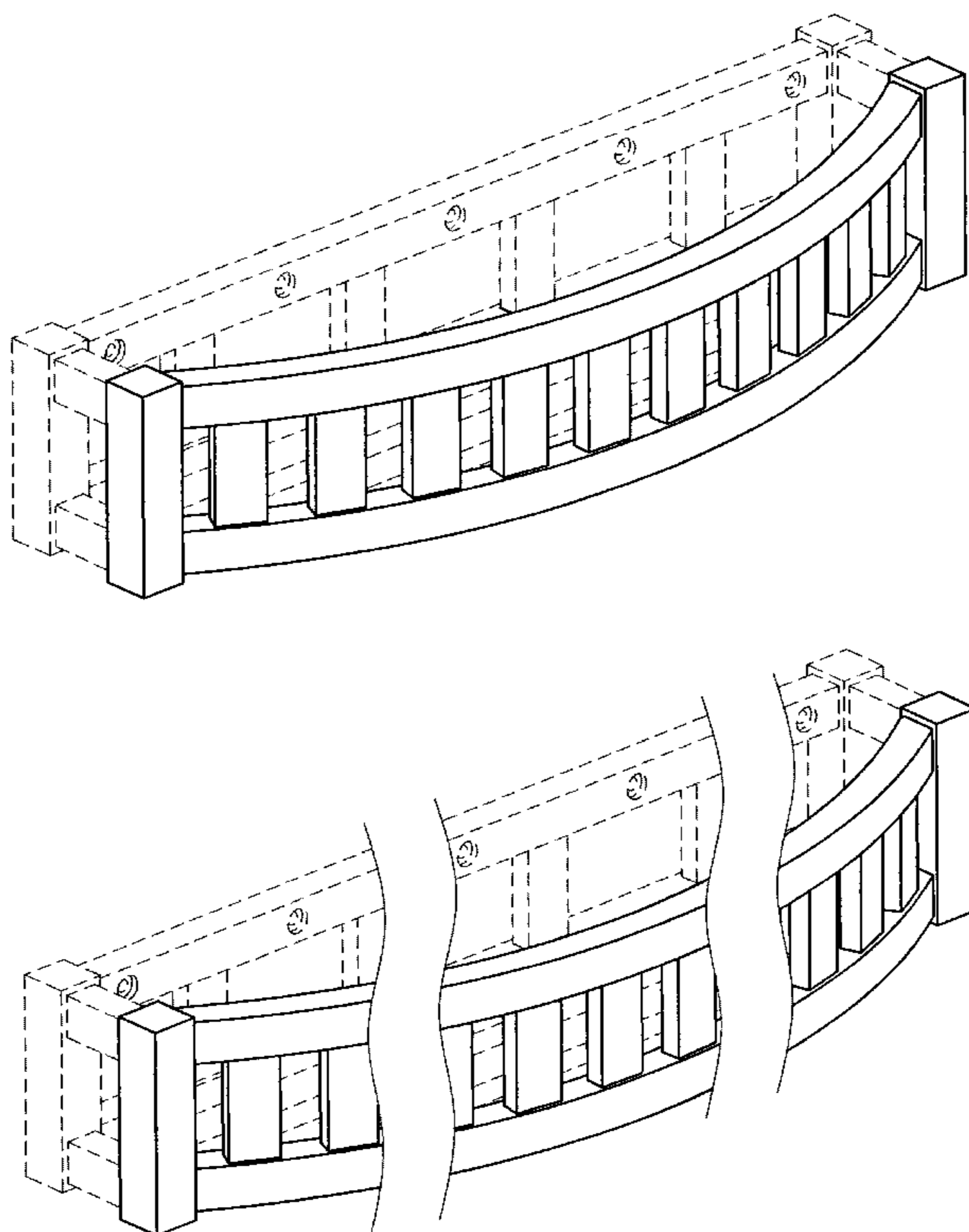
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 5 is a rear view thereof; and,

FIG. 6 is a perspective view of a second embodiment of a window box, portions of which are cut away to illustrate indeterminate length.

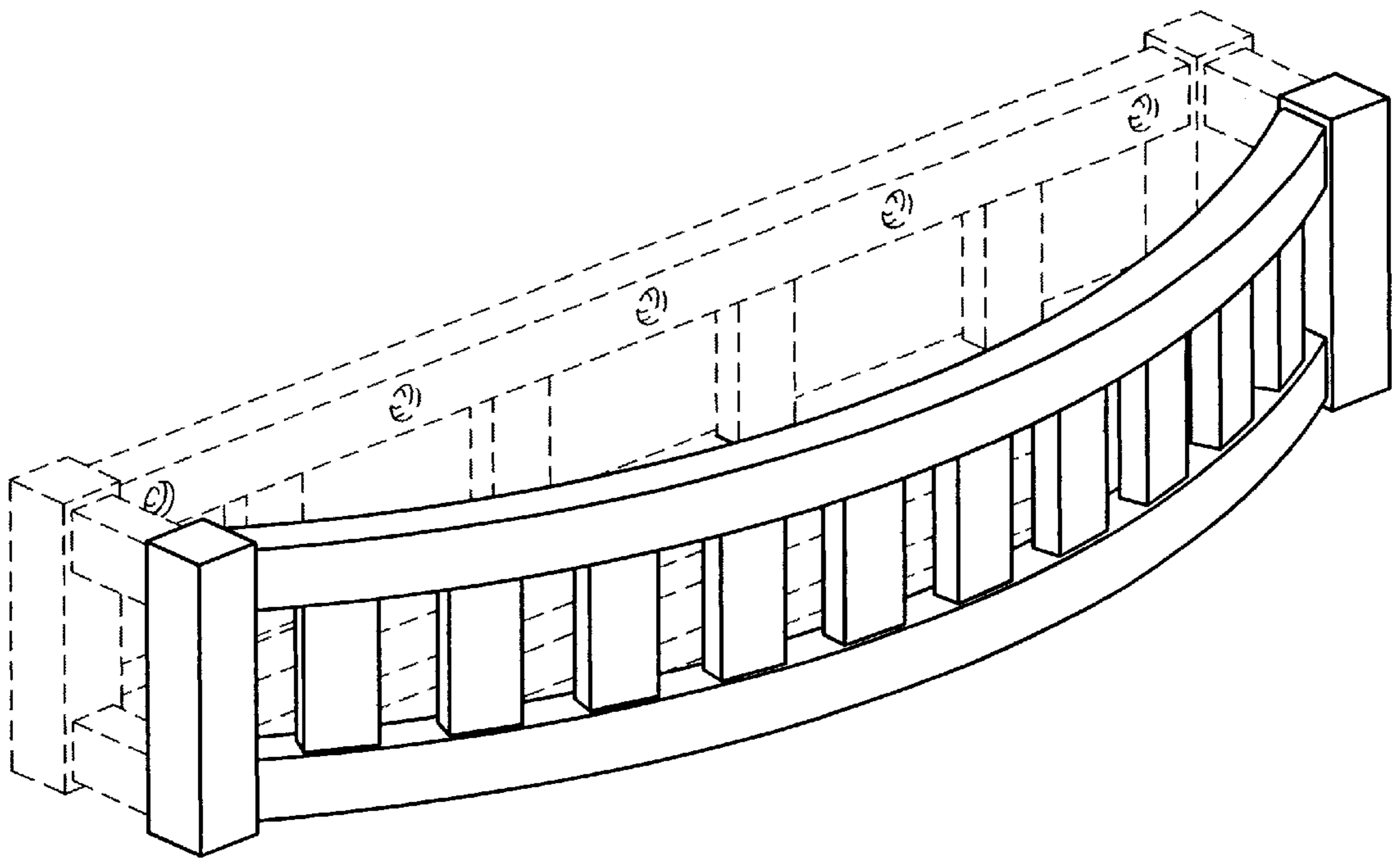

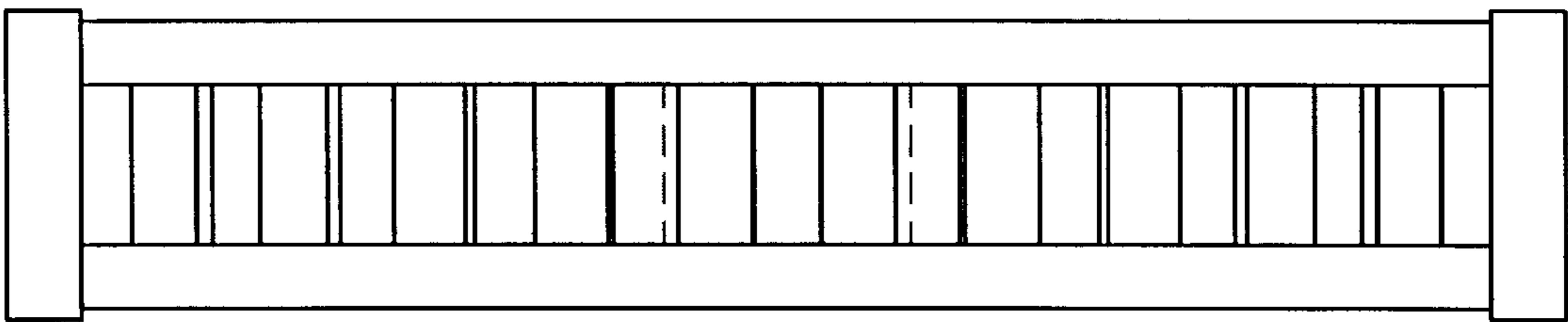

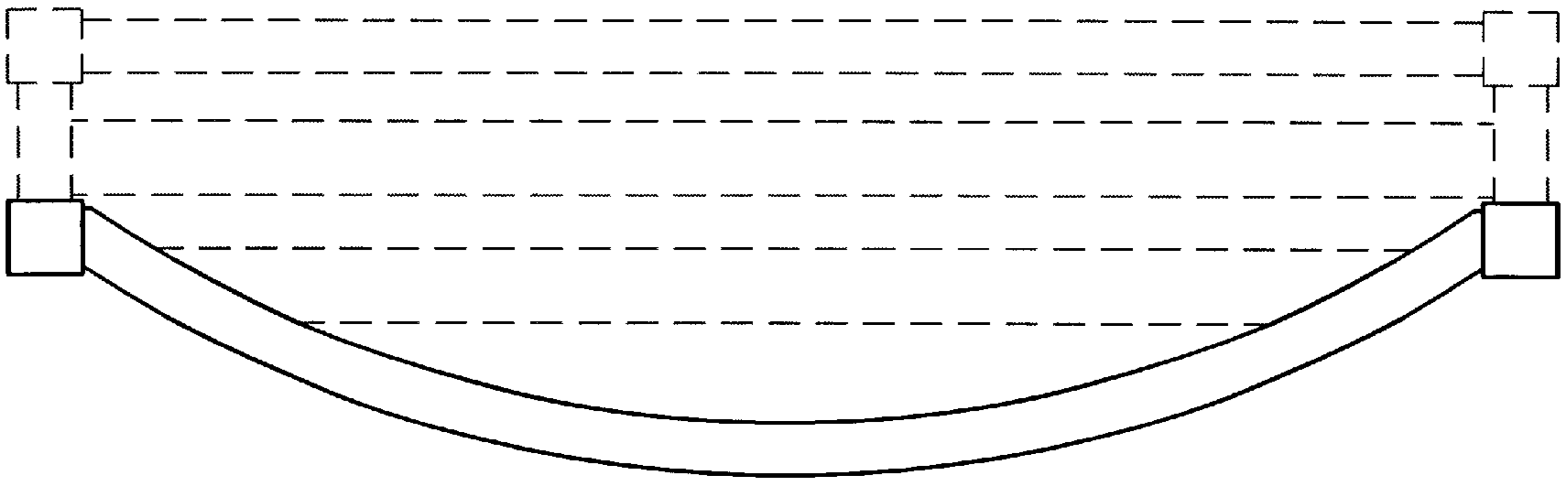

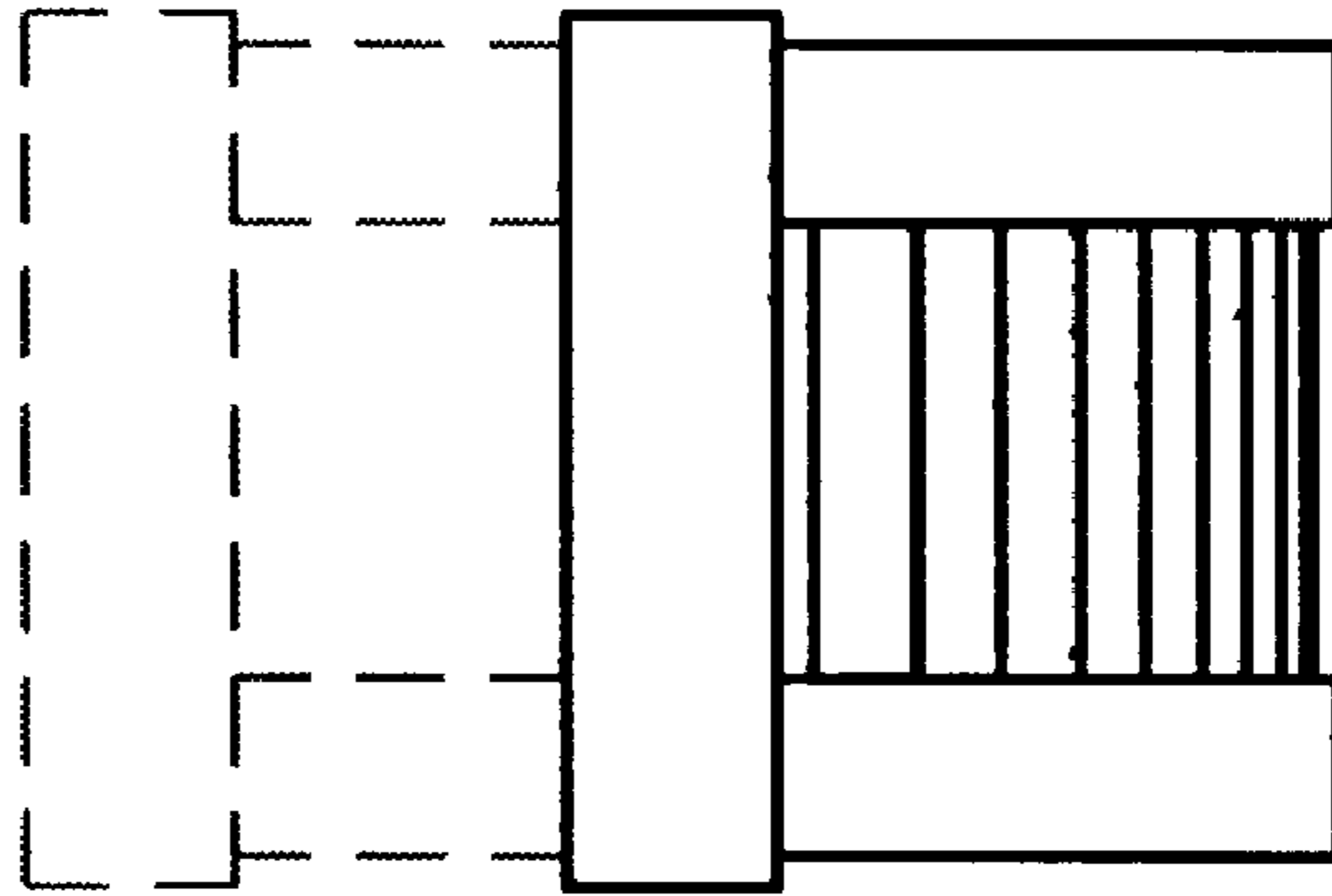

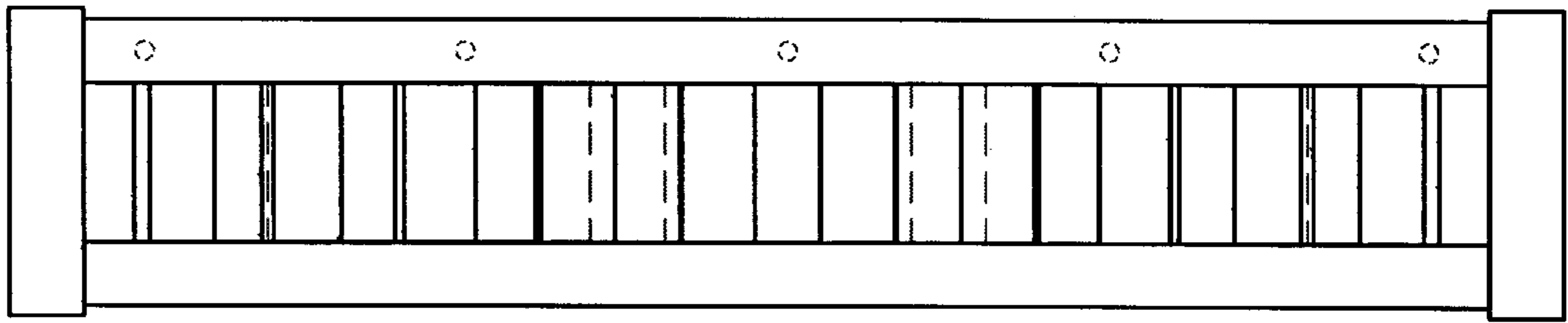

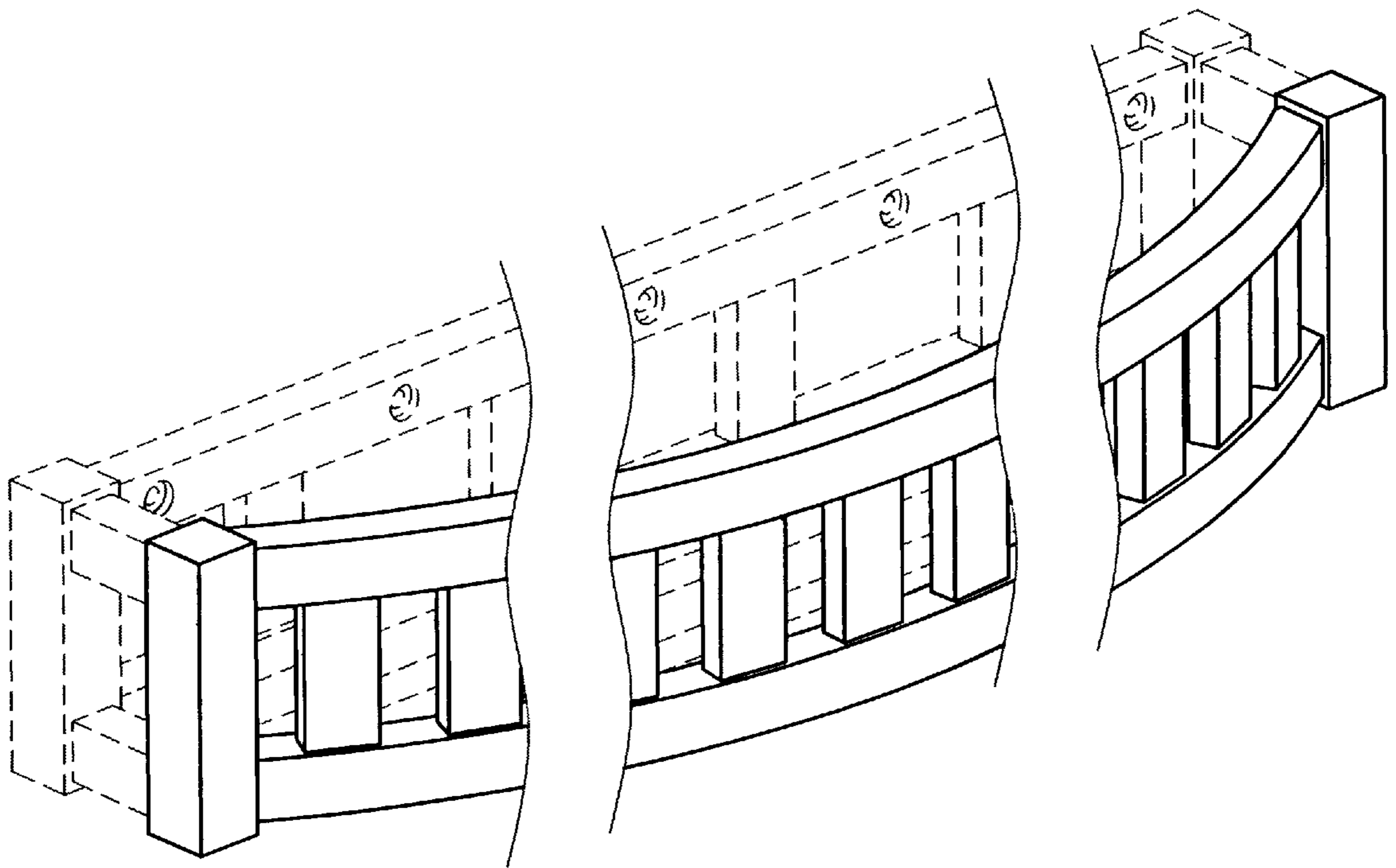
