FIG. 3 is a back plan view; and,

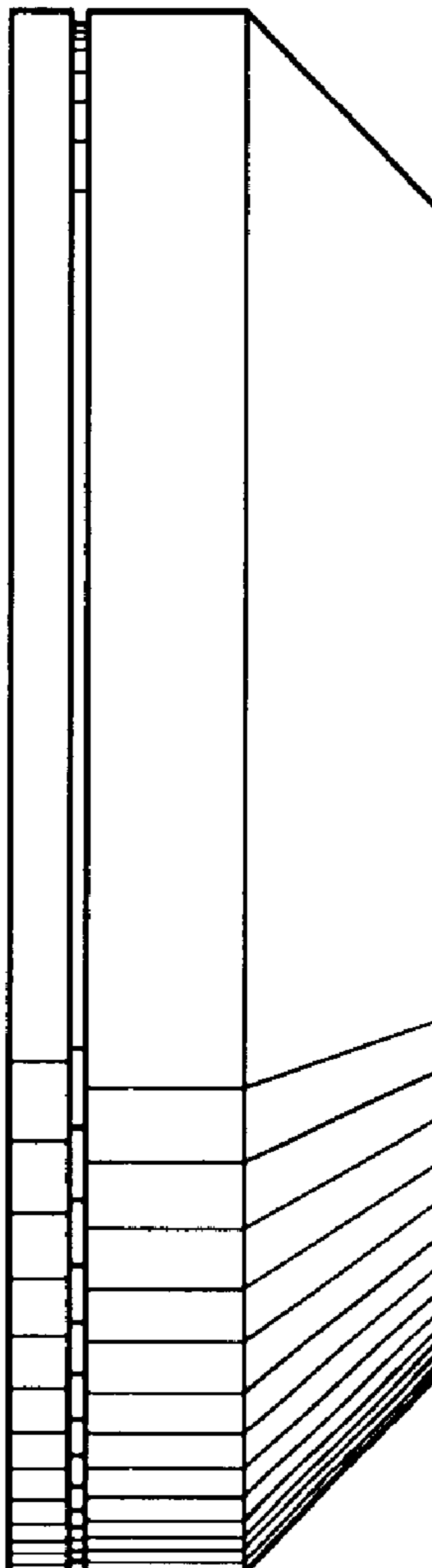
FIG. 4 is a right side elevational view.

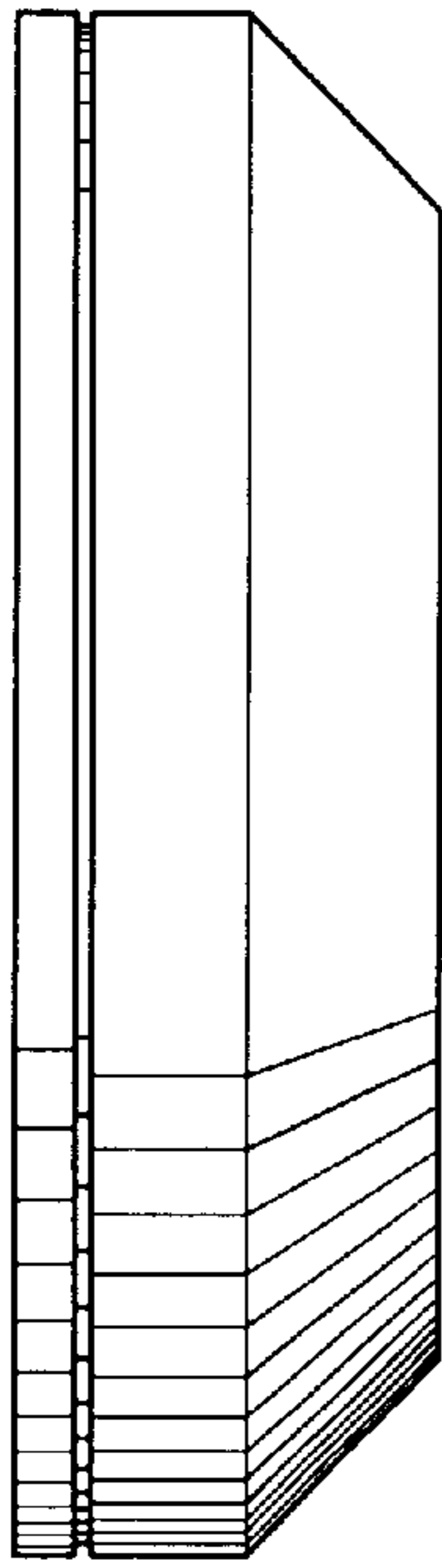

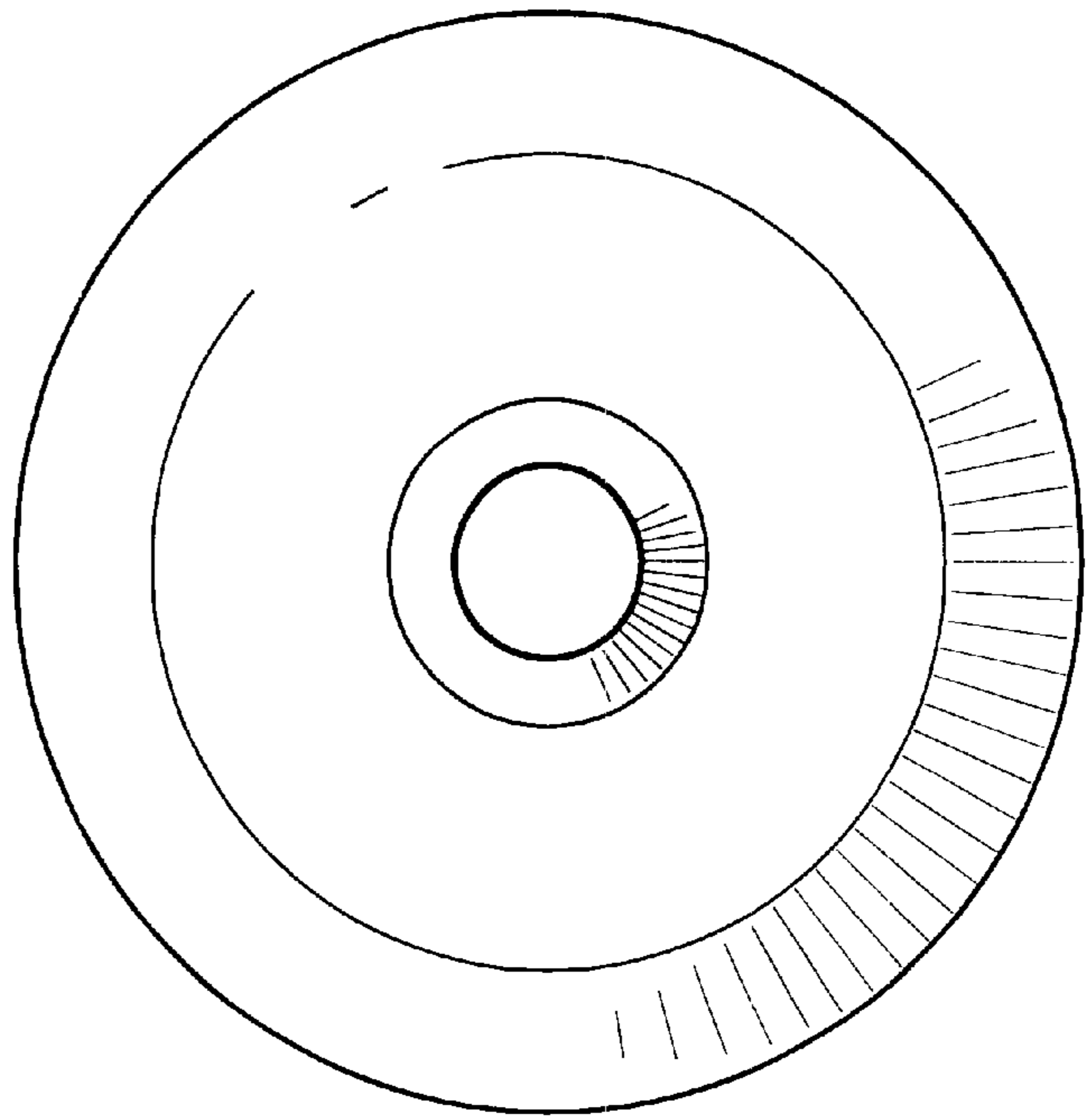

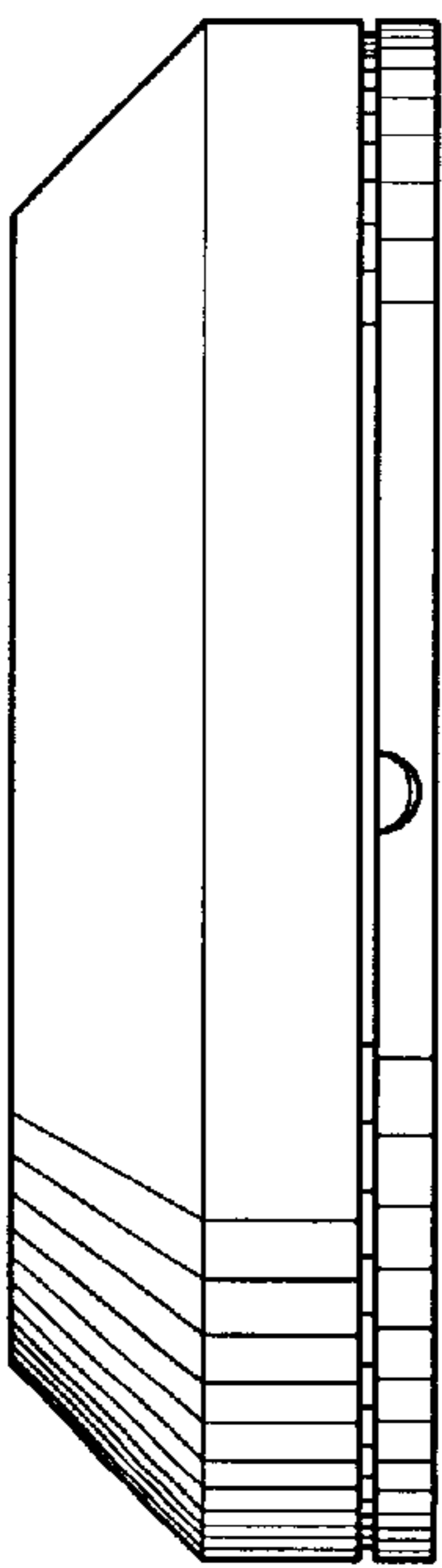

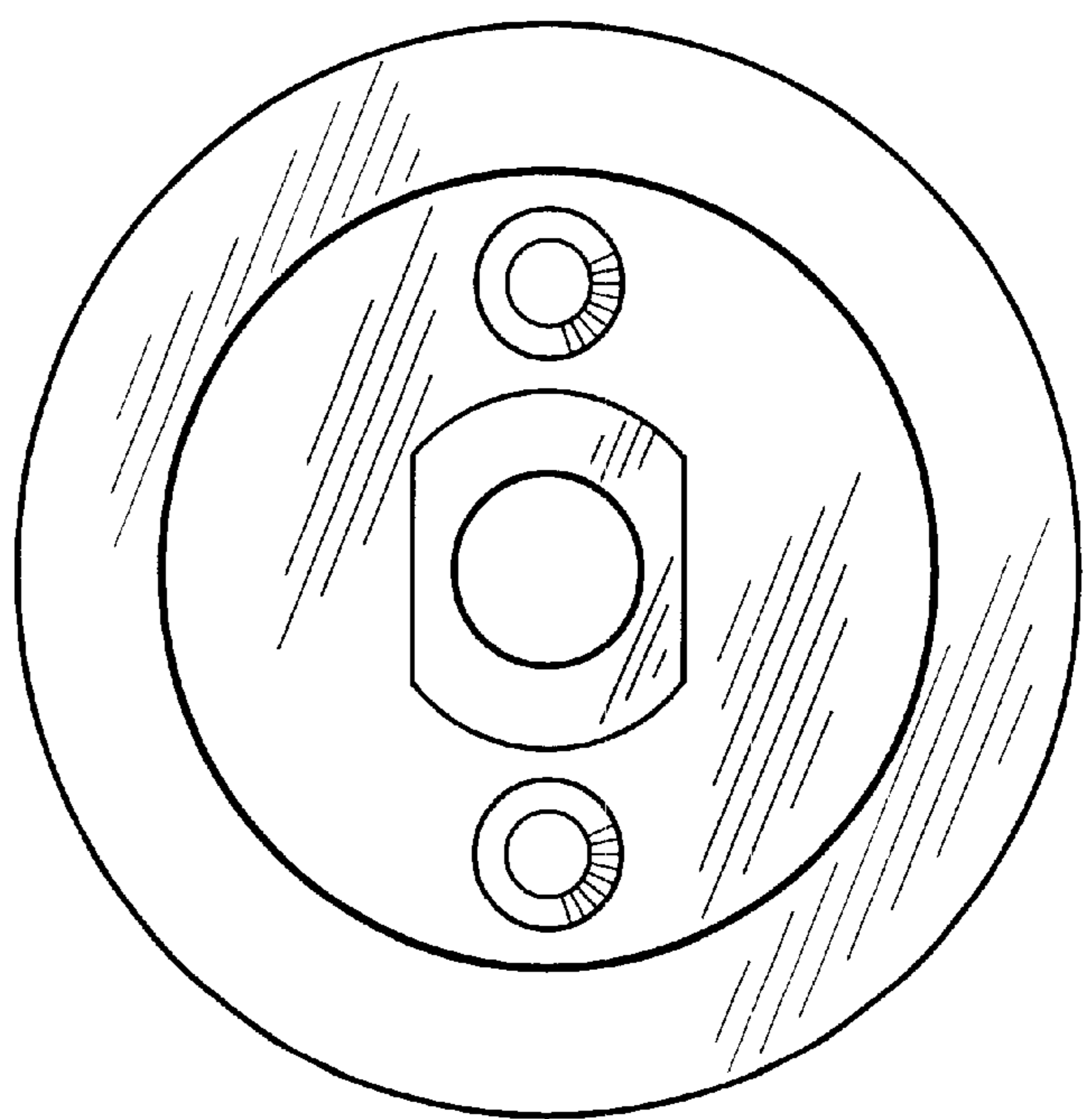
