FIG. 1 is a front elevational view of a hand-held electronic device showing our new design;

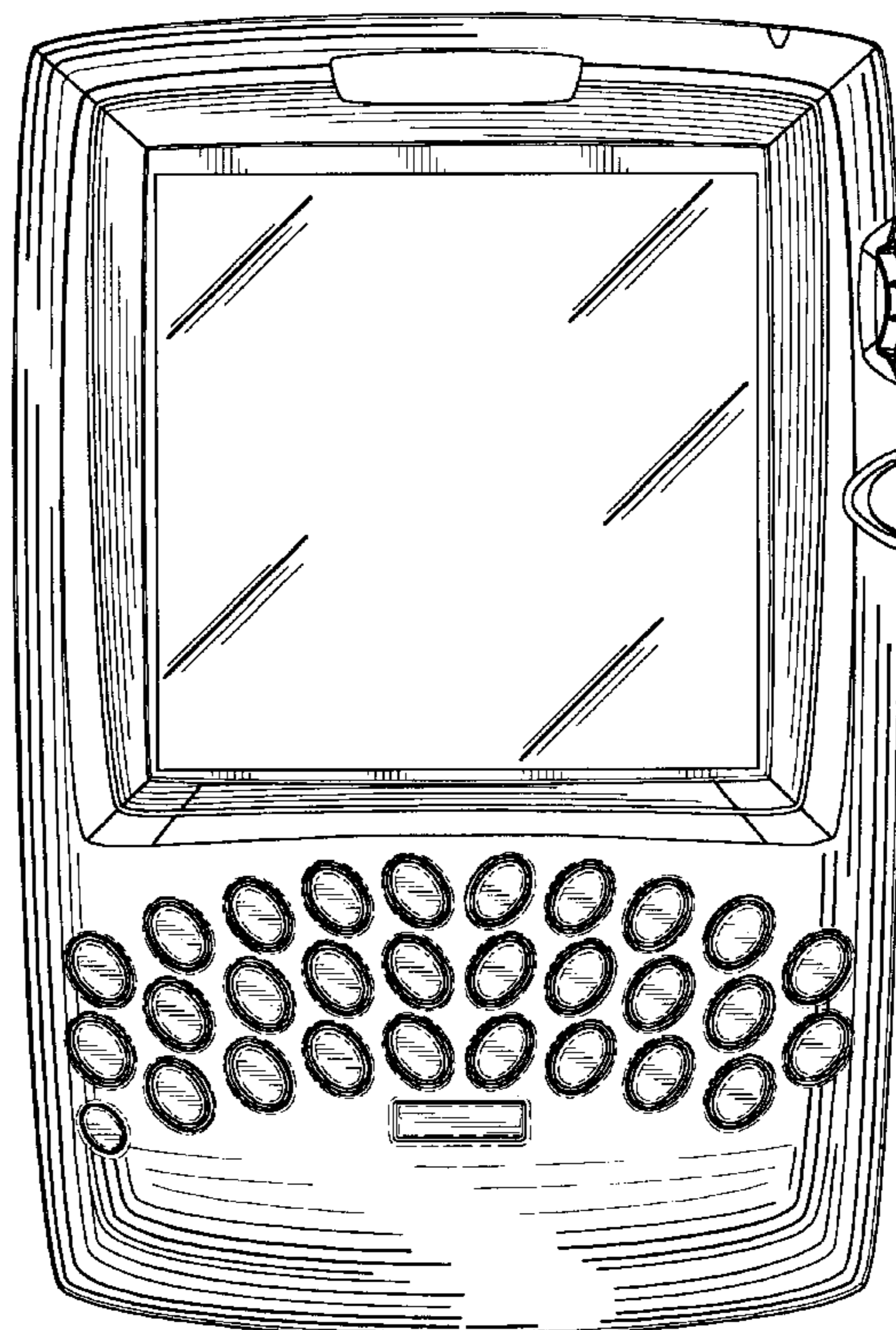
FIG. 2 is a front elevational view of a second embodiment of FIG. 1;

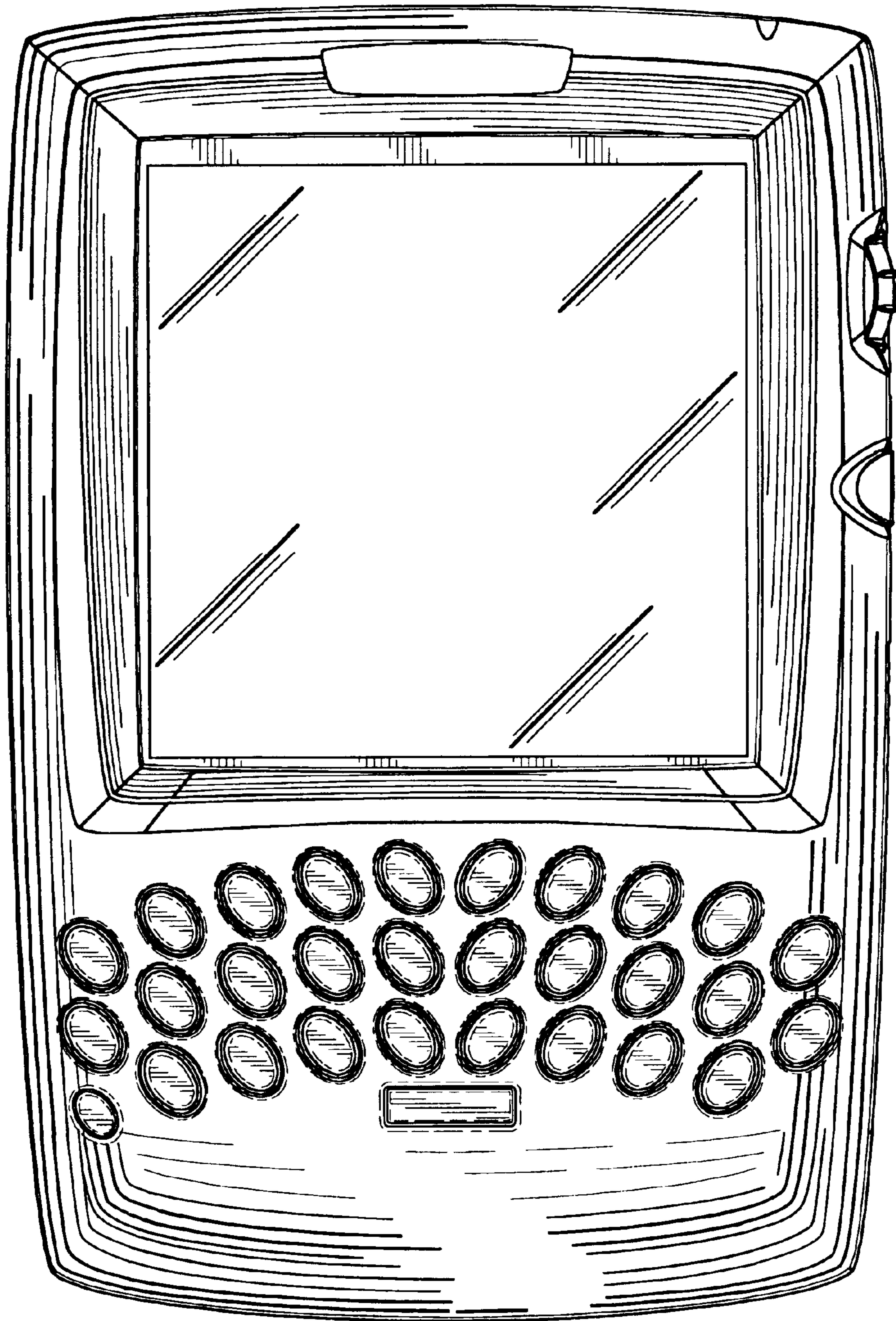

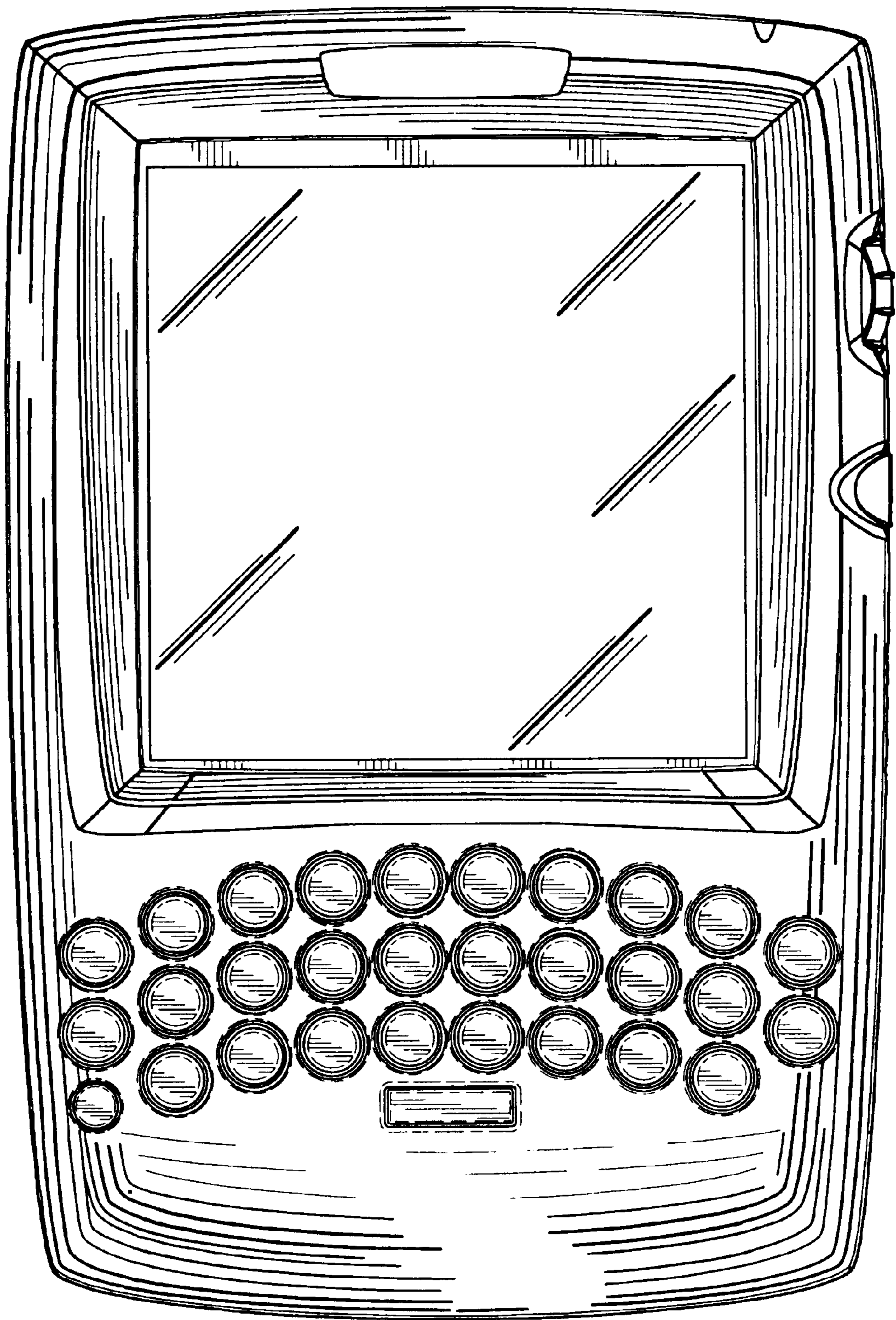

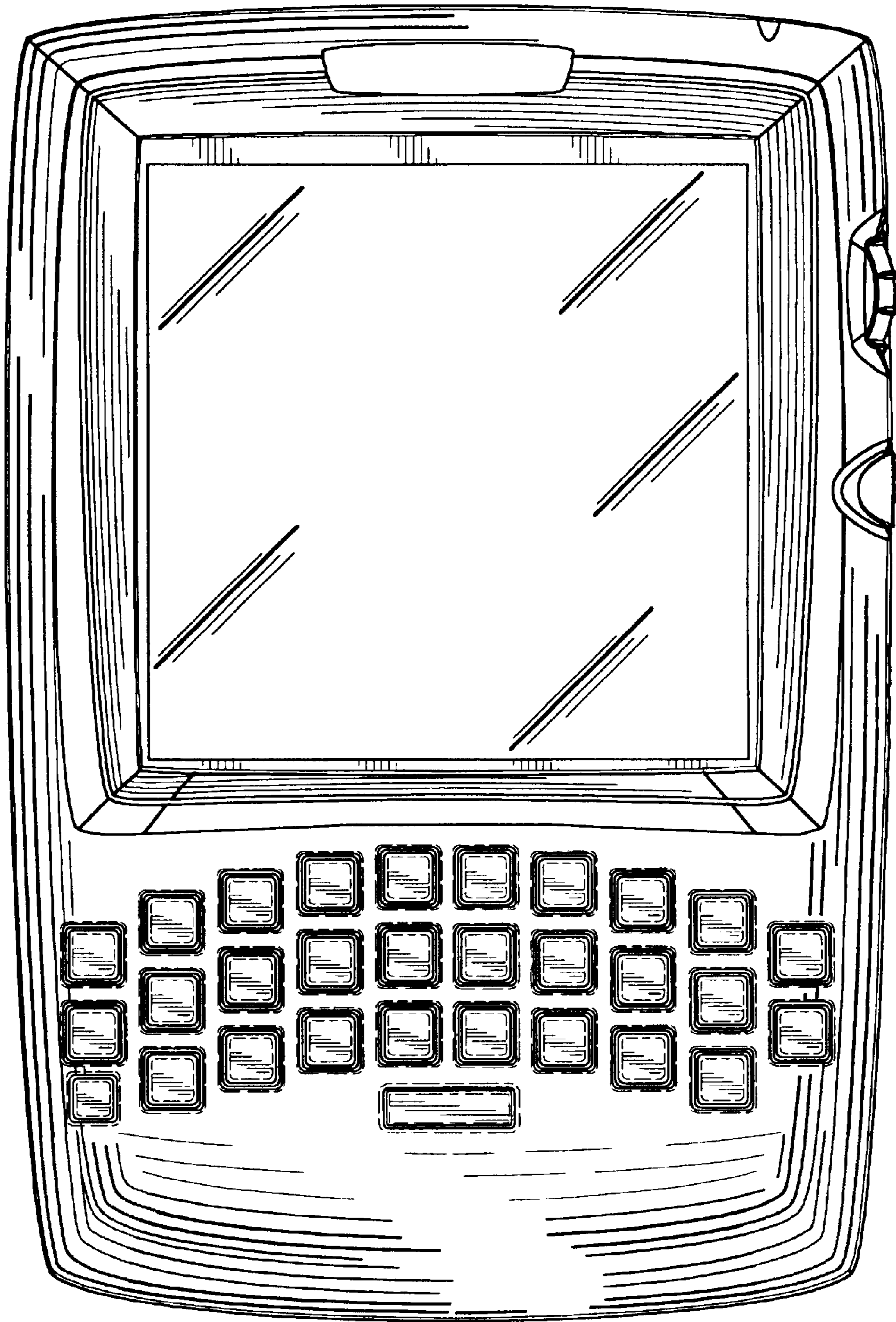

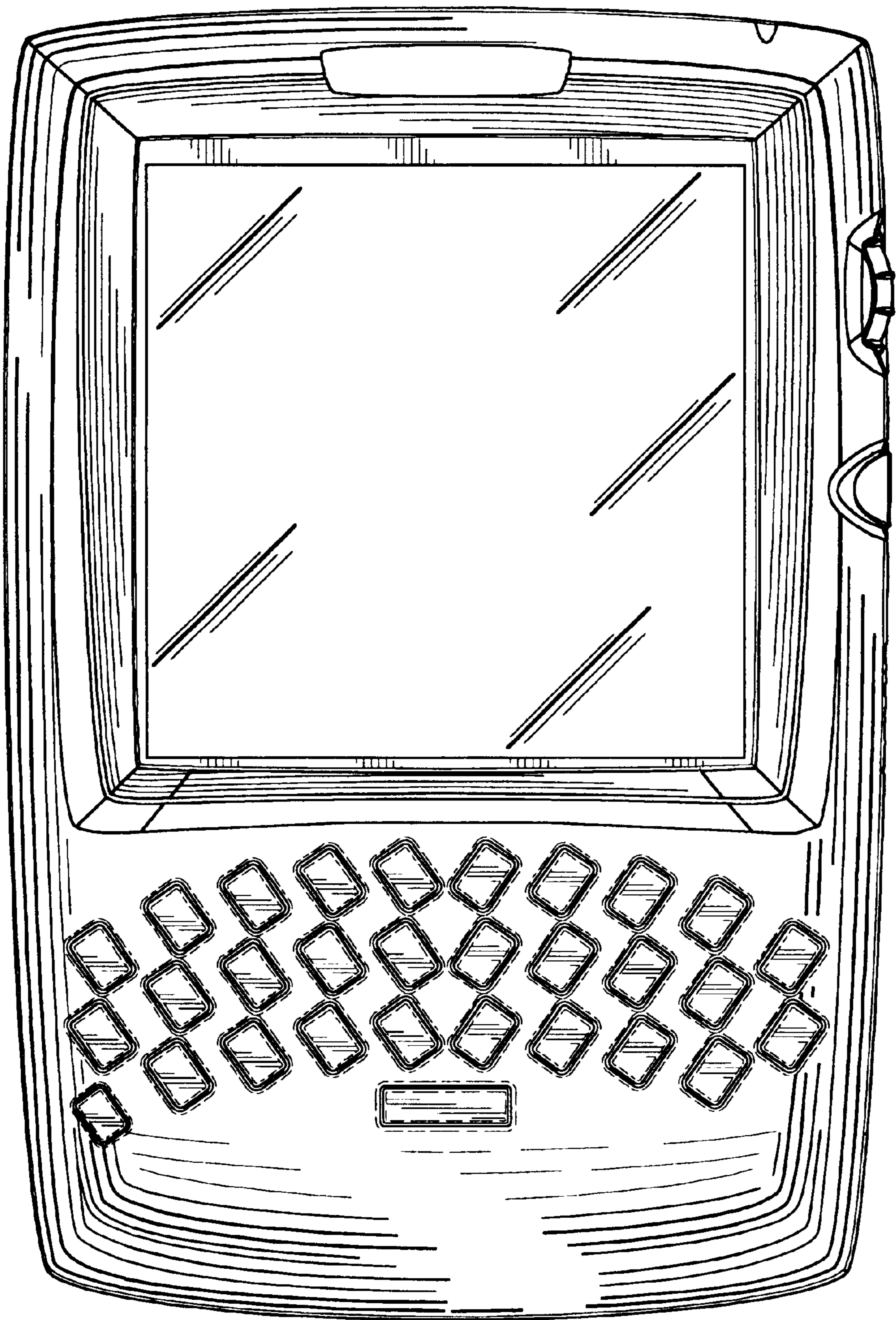
