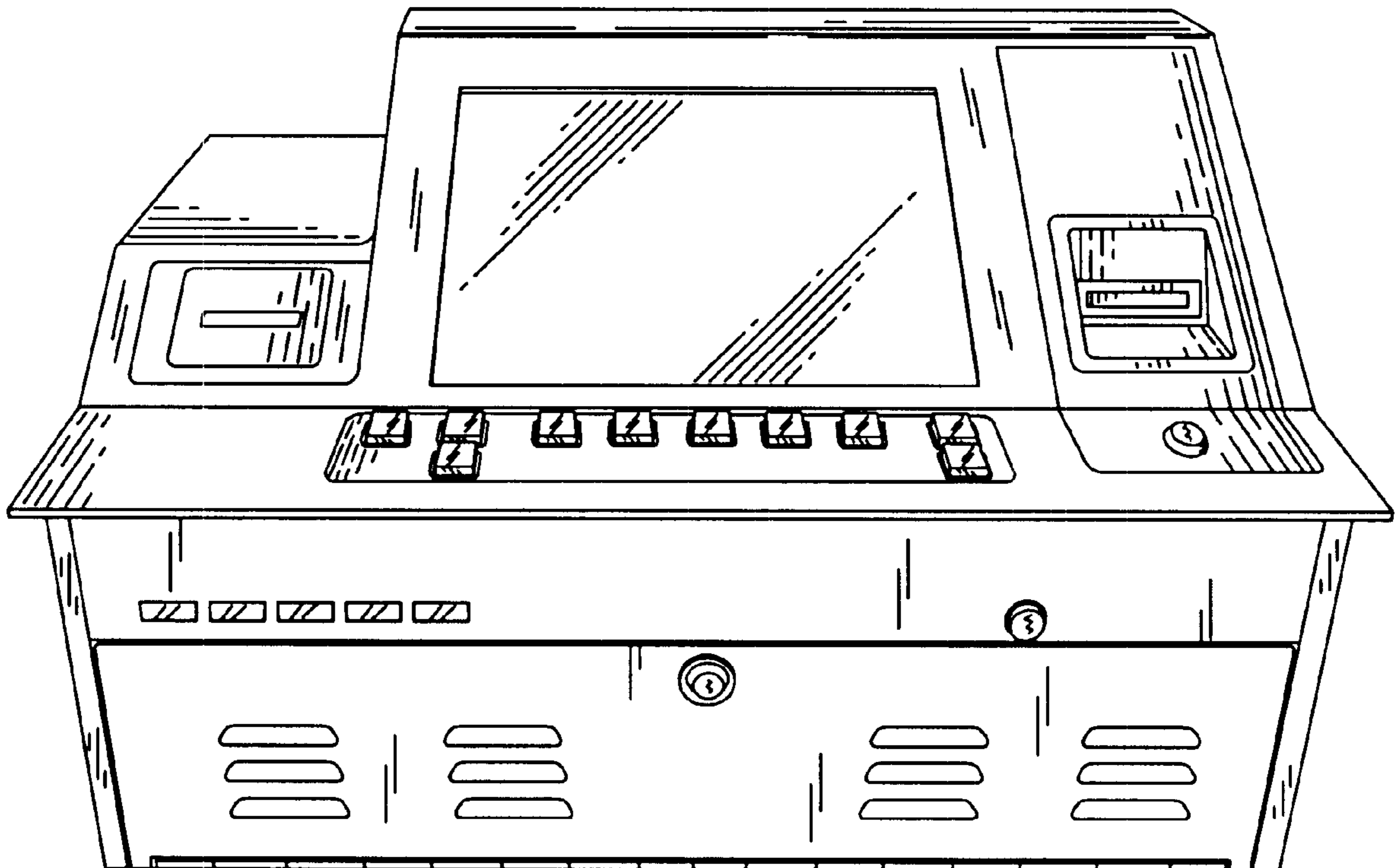
(57) **CLAIM**

The ornamental design for a bar top gaming unit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bar top gaming unit in accordance with the present invention;
 FIG. 2 is a top view of the bar top gaming unit of FIG. 1;
 FIG. 3 is a front plan view of the bar top gaming unit of FIG. 1;

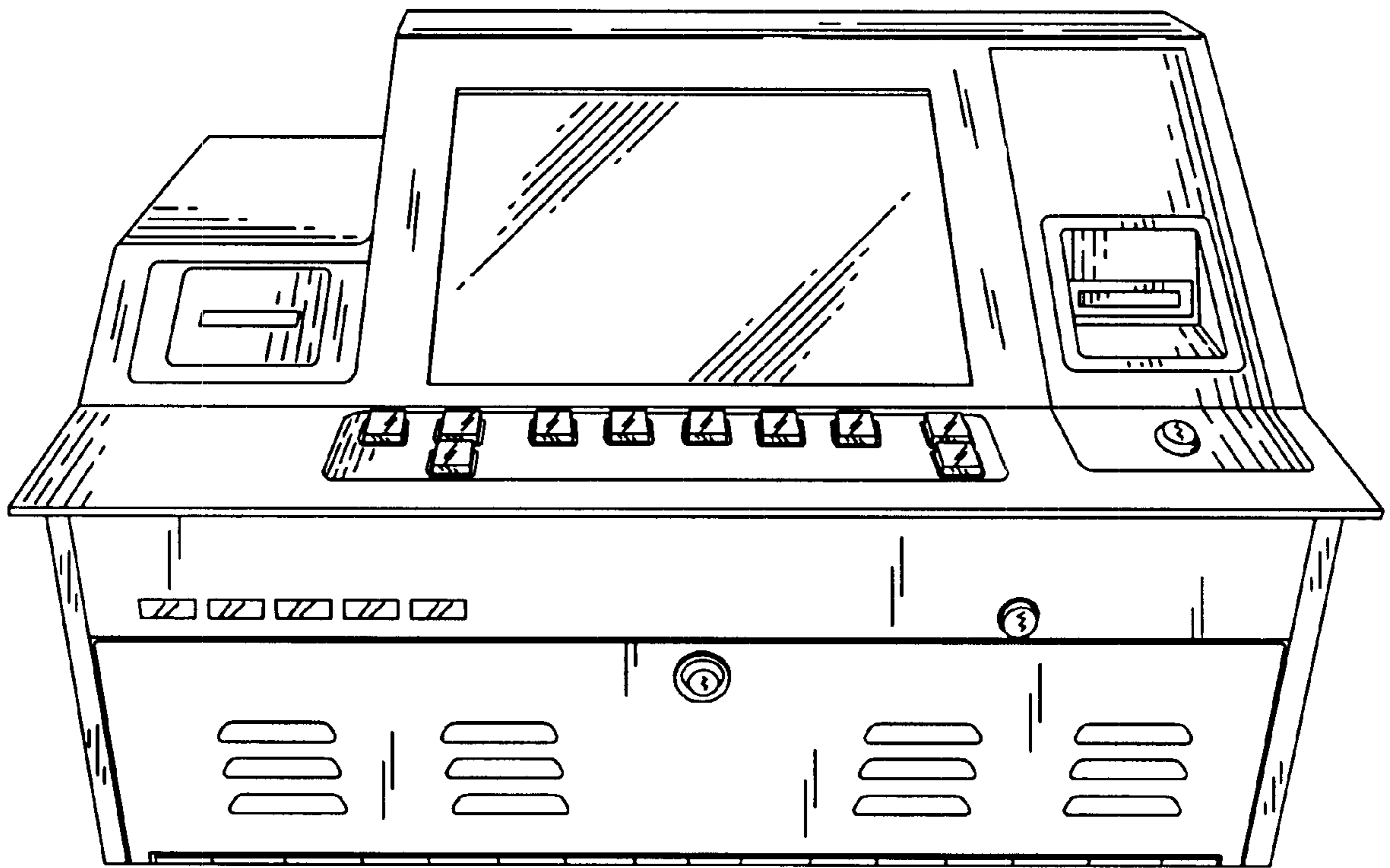

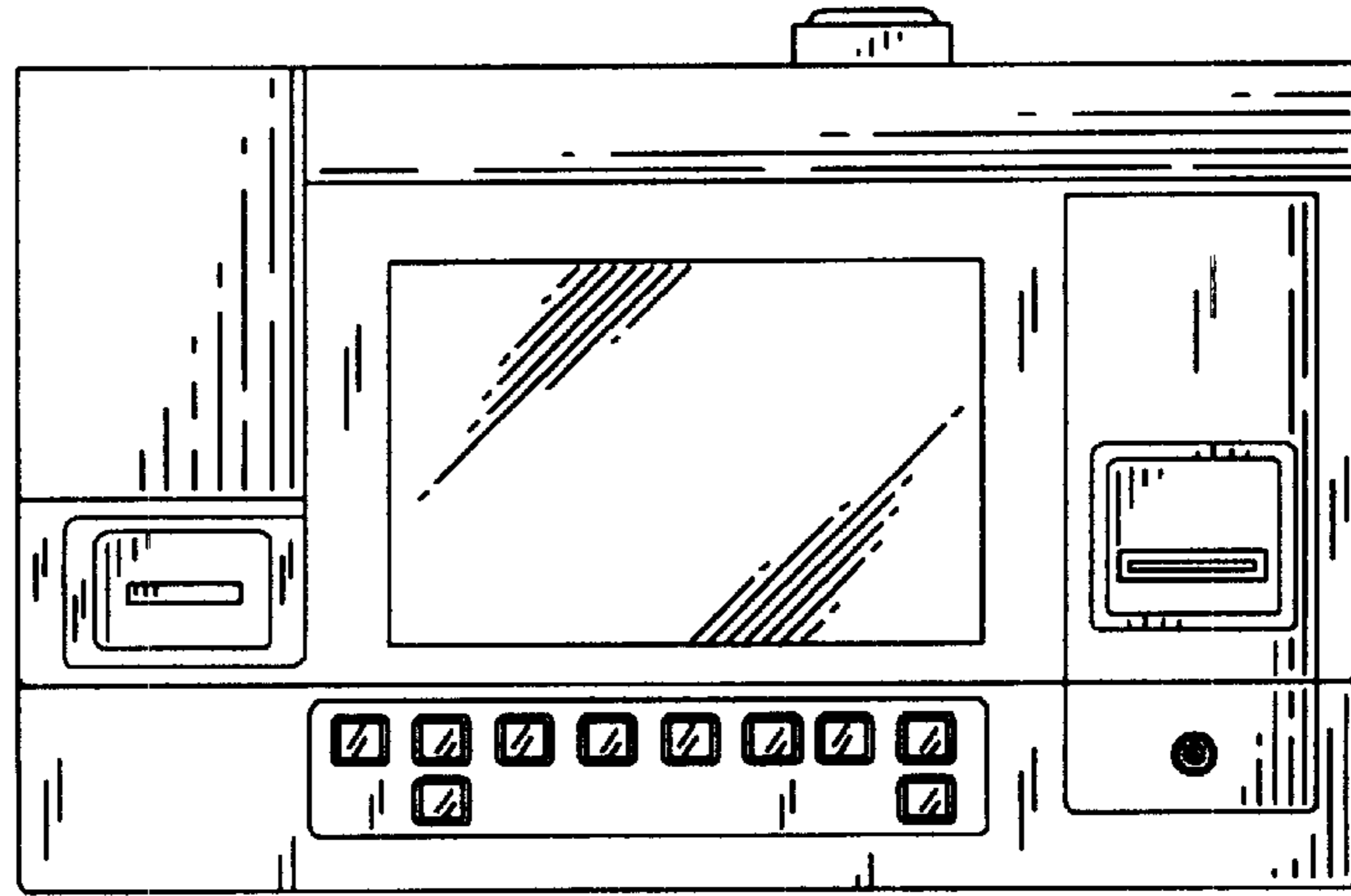

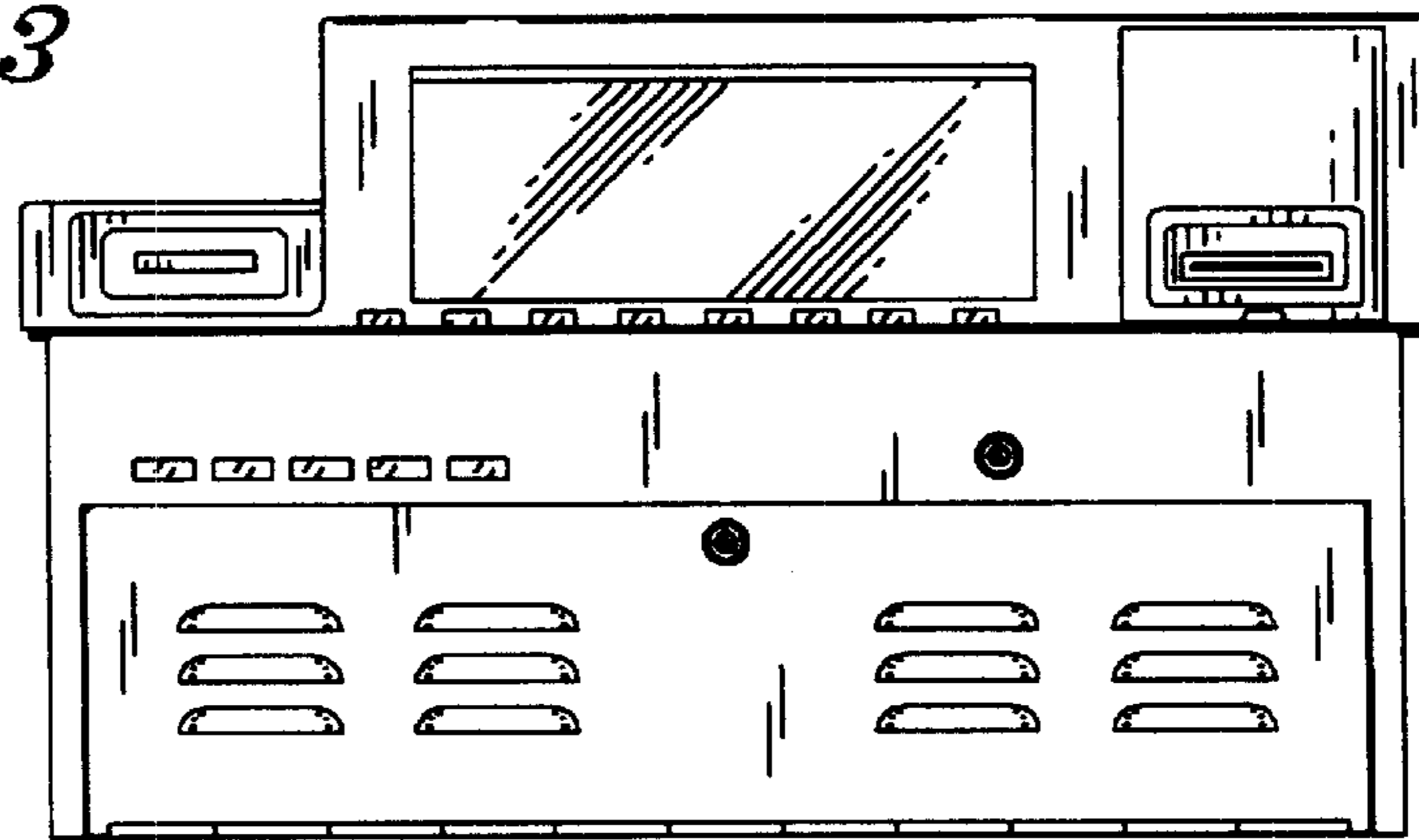
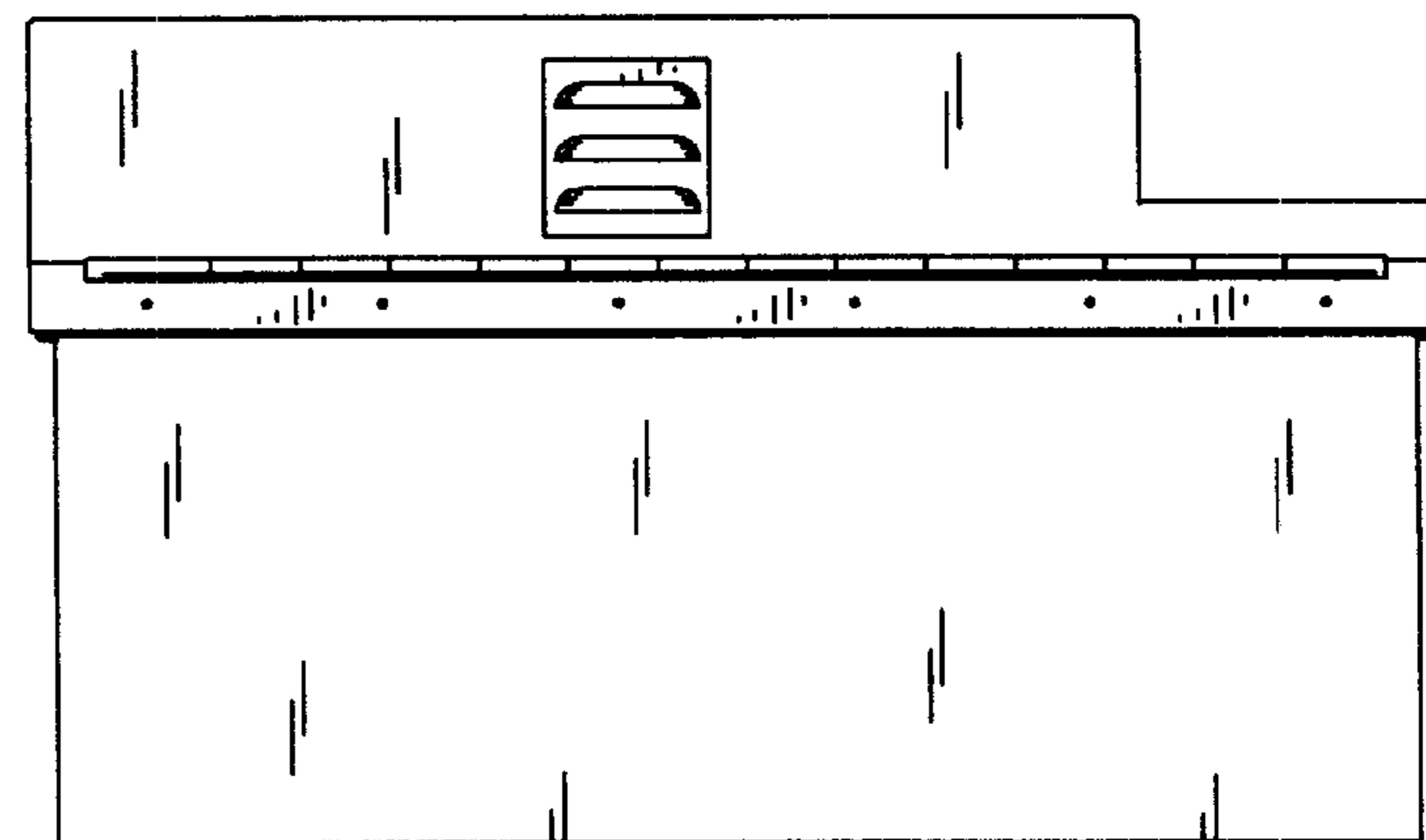

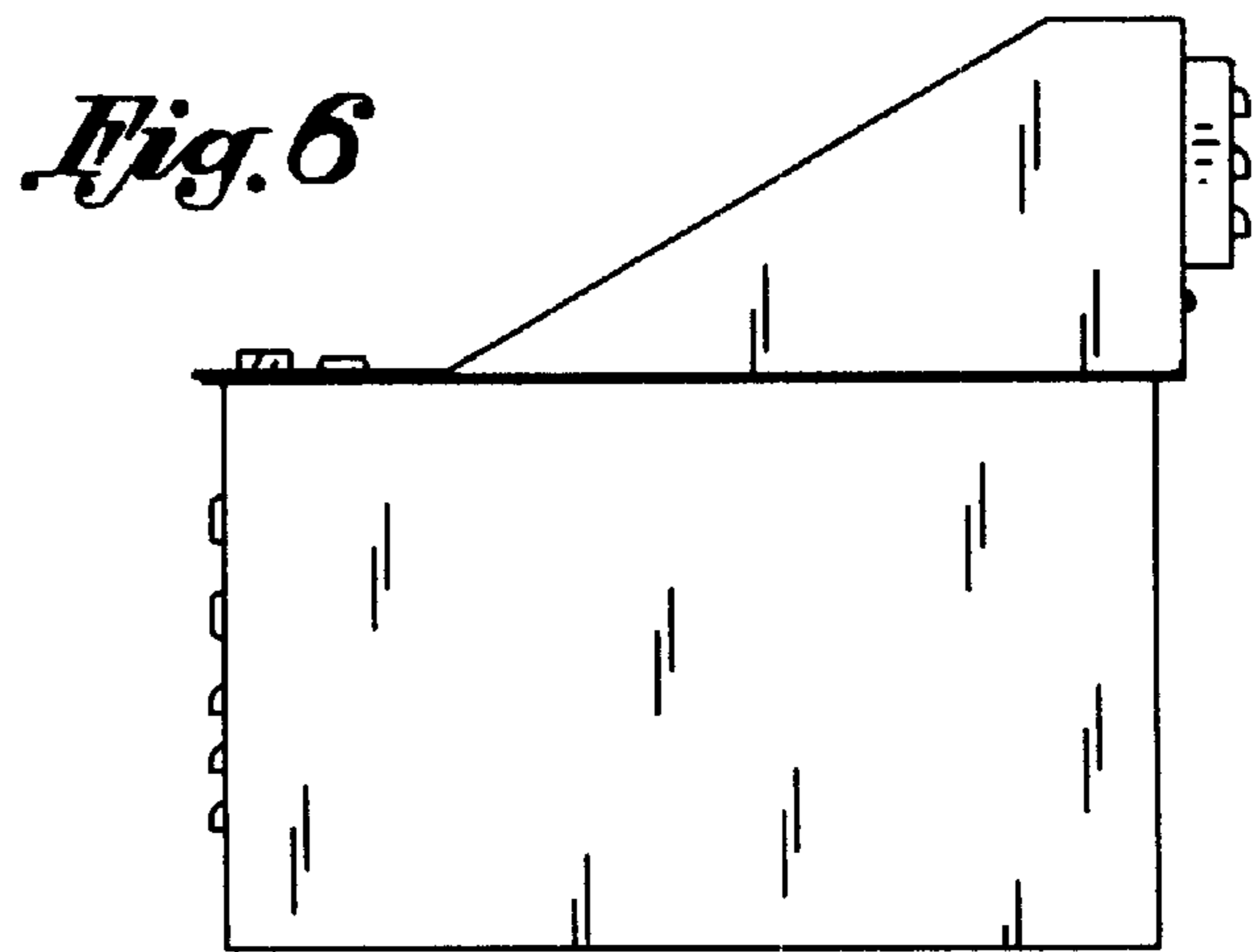
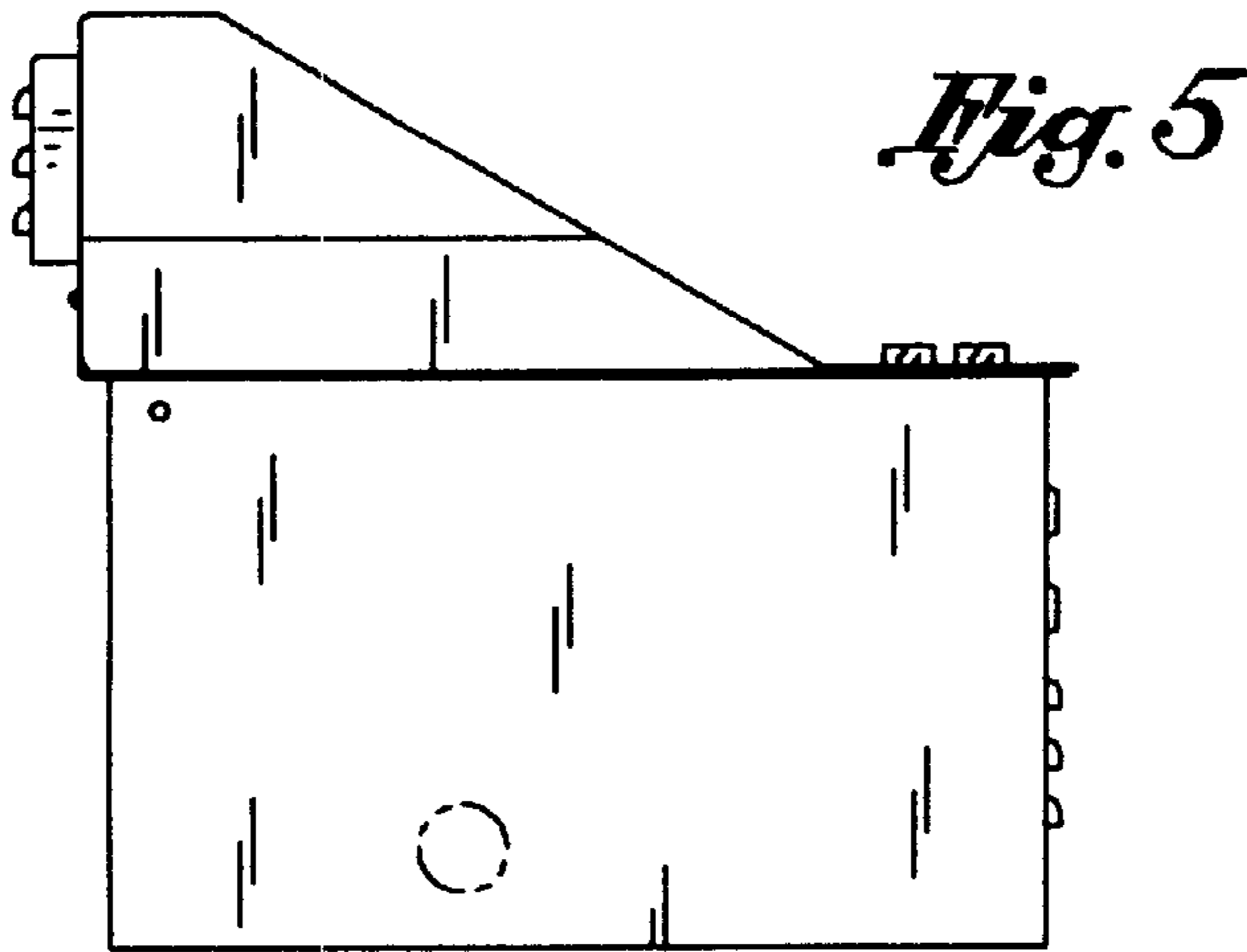
