(57) **CLAIM**

The ornamental design for a skull-shaped plasma lamp, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of an ornamental skull-shaped plasma lamp, according to one preferred embodiment of this invention;

FIG. 2 is a front view of the ornamental skull-shaped plasma lamp, as shown in FIG. 1;

FIG. 3 is a rear view of the ornamental skull-shaped plasma lamp, as shown in FIG. 1;

FIG. 4 is a side view of the ornamental skull-shaped plasma lamp, as shown in FIG. 1;

FIG. 5 is a side view of the ornamental skull-shaped plasma lamp, opposite the side view of FIG. 4, as shown in FIG. 1;

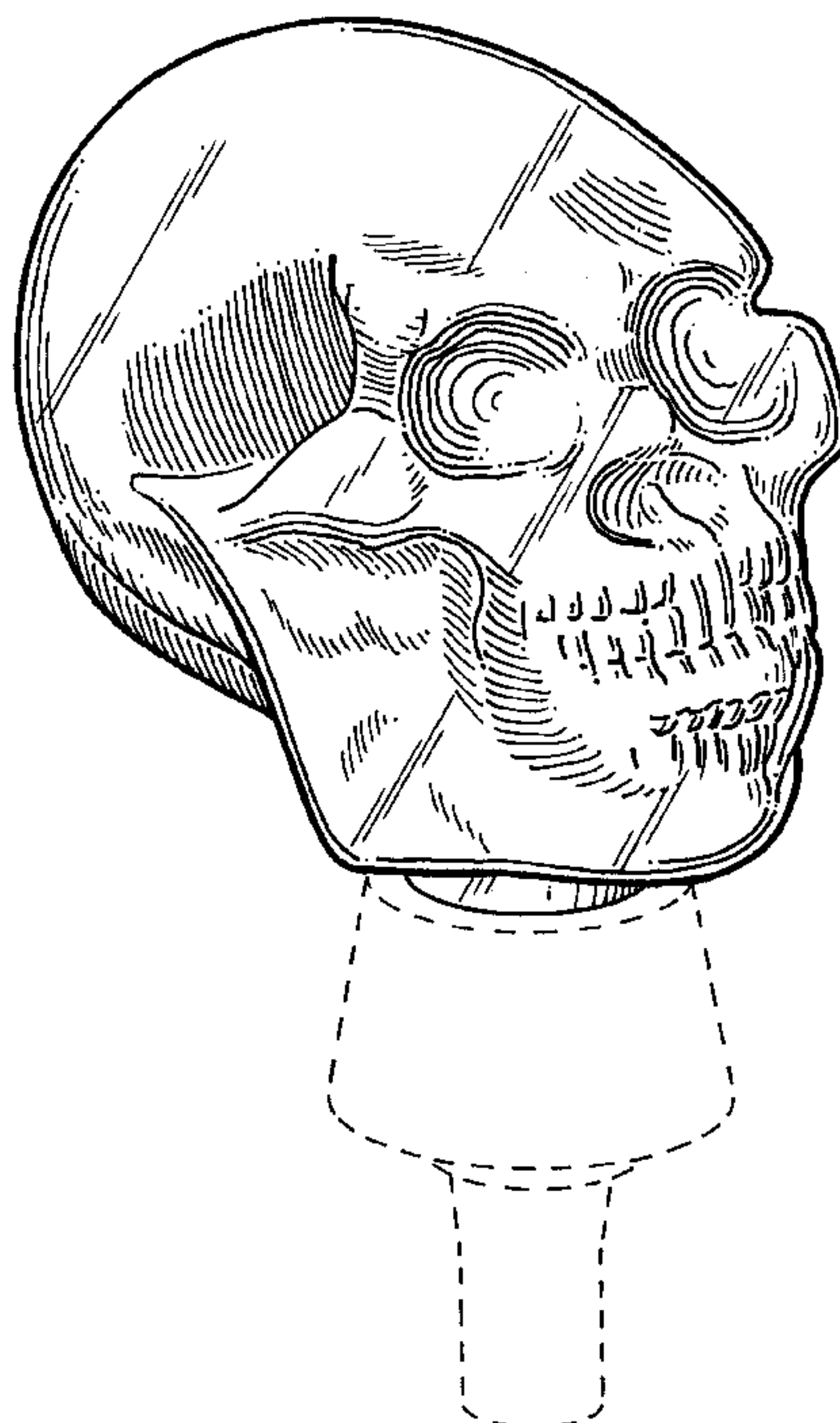
FIG. 6 is a top view of the ornamental skull-shaped plasma lamp, as shown in FIG. 1; and,

FIG. 7 is a bottom view of the ornamental skull-shaped plasma lamp, as shown in FIG. 1.

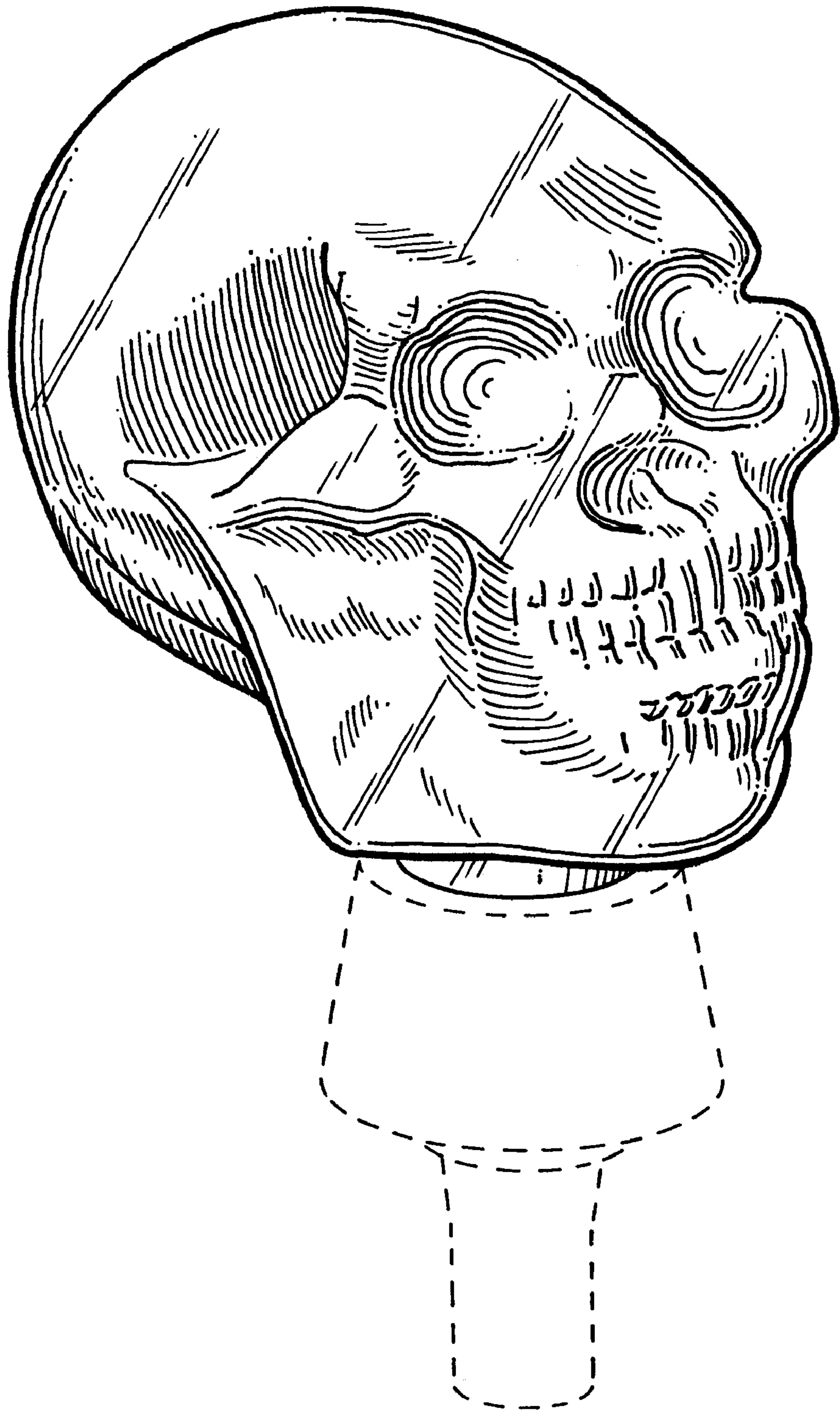

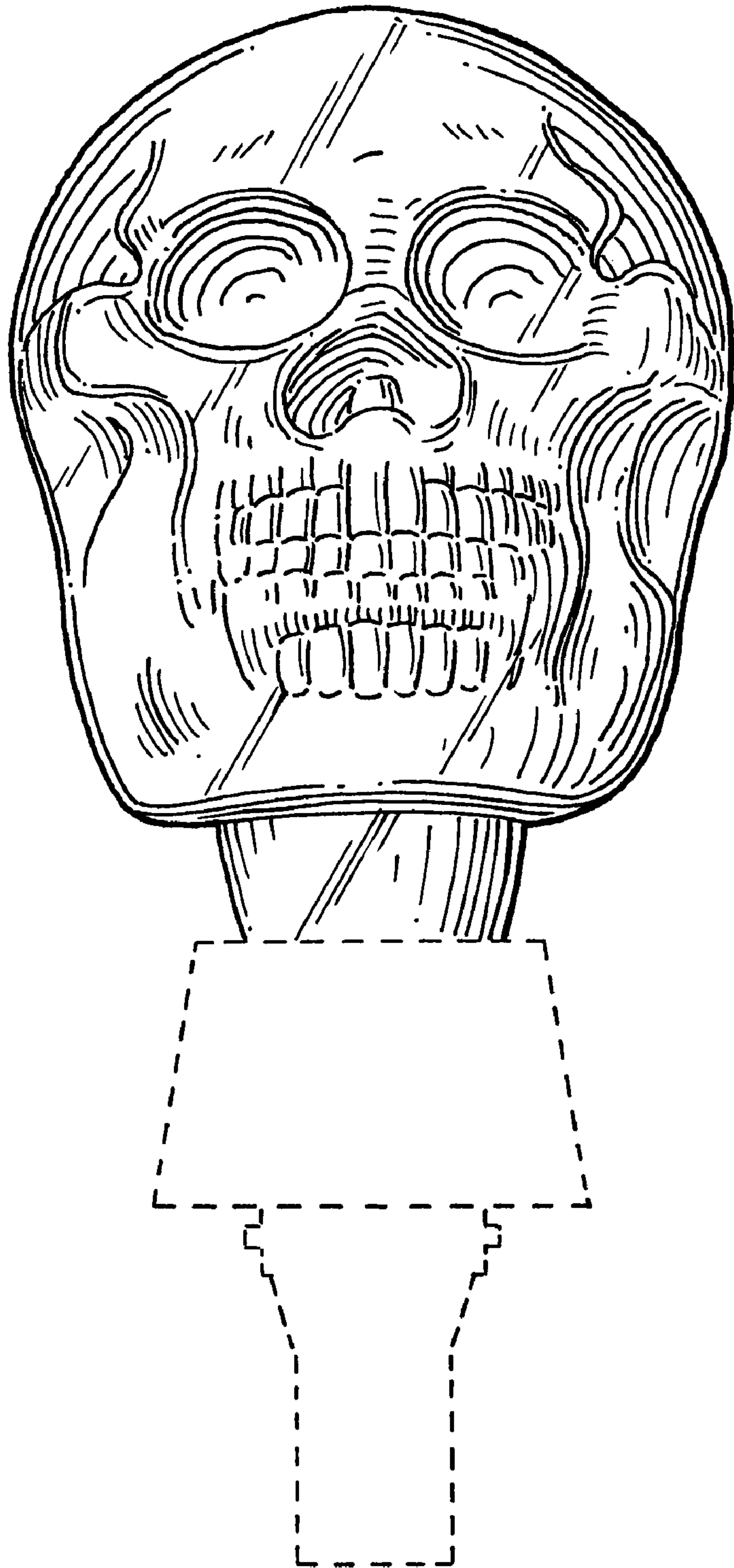

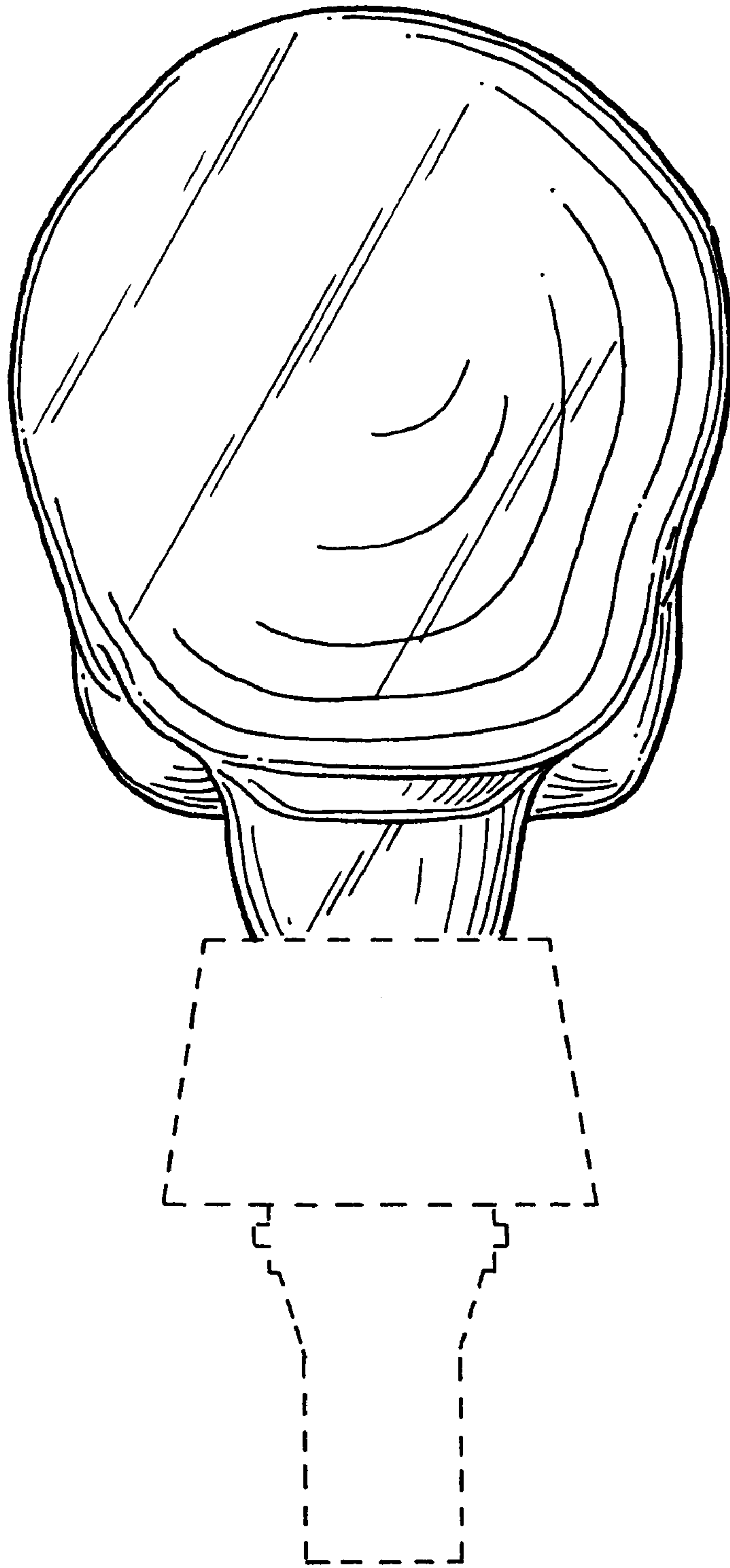

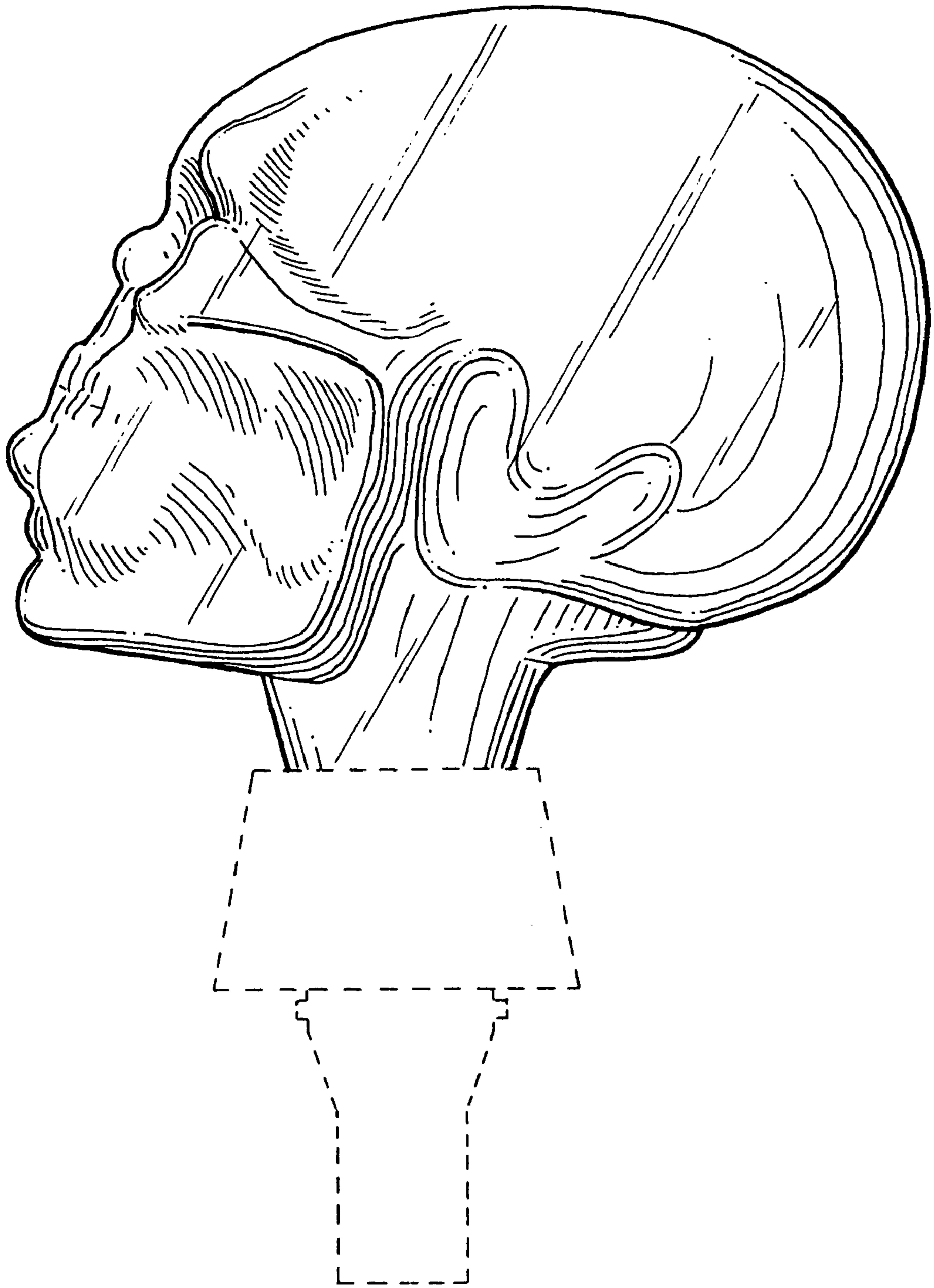

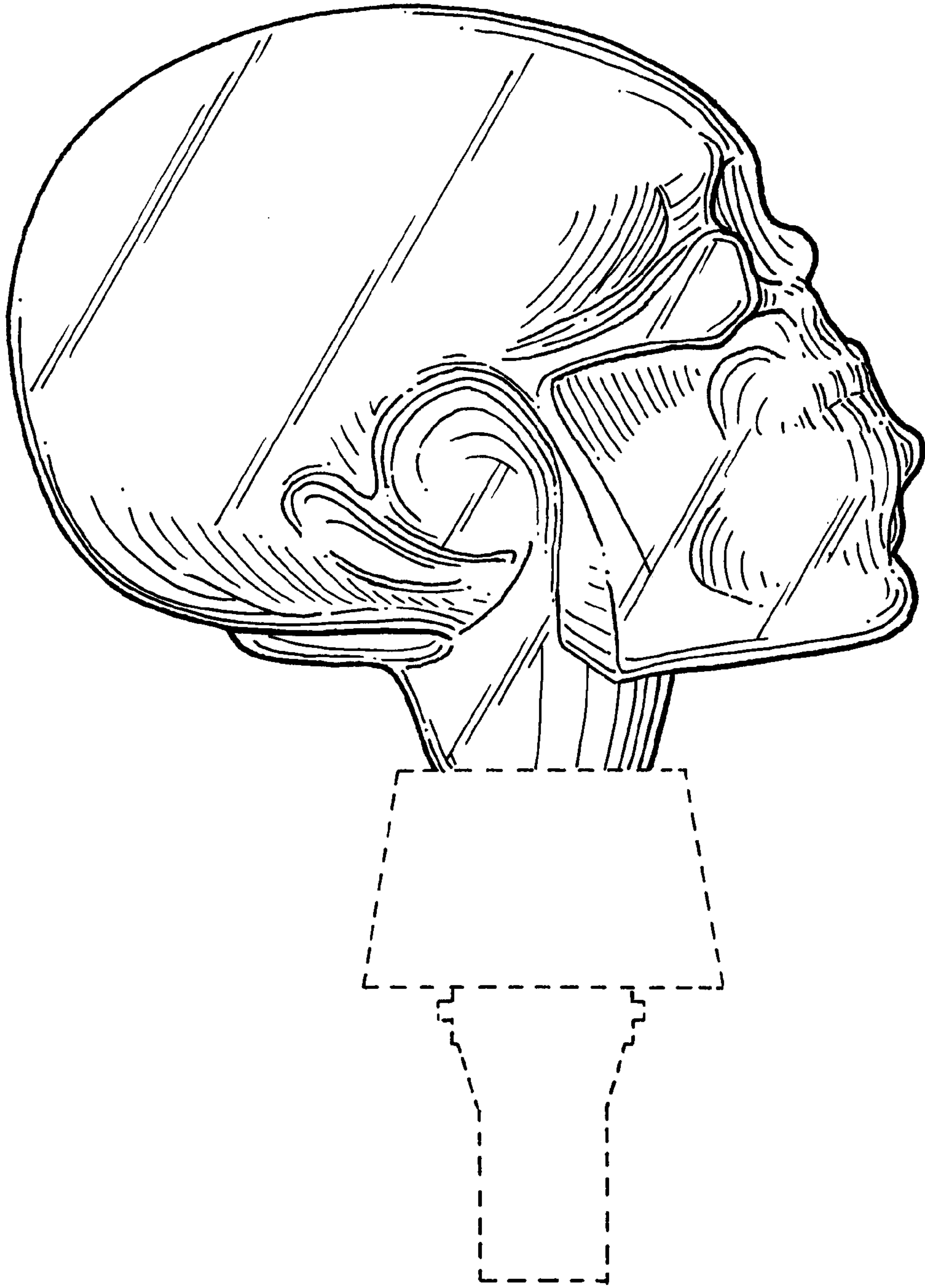

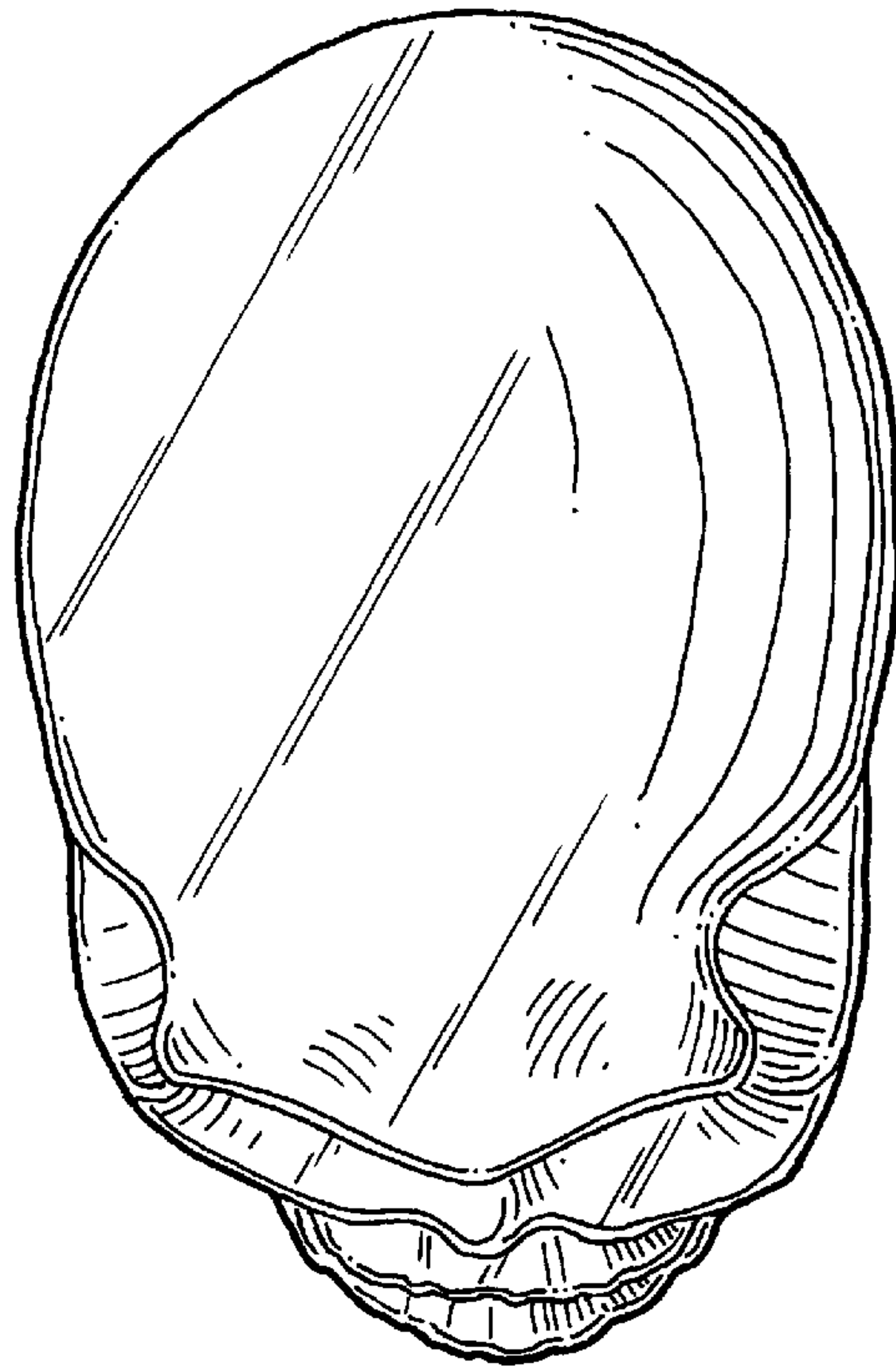

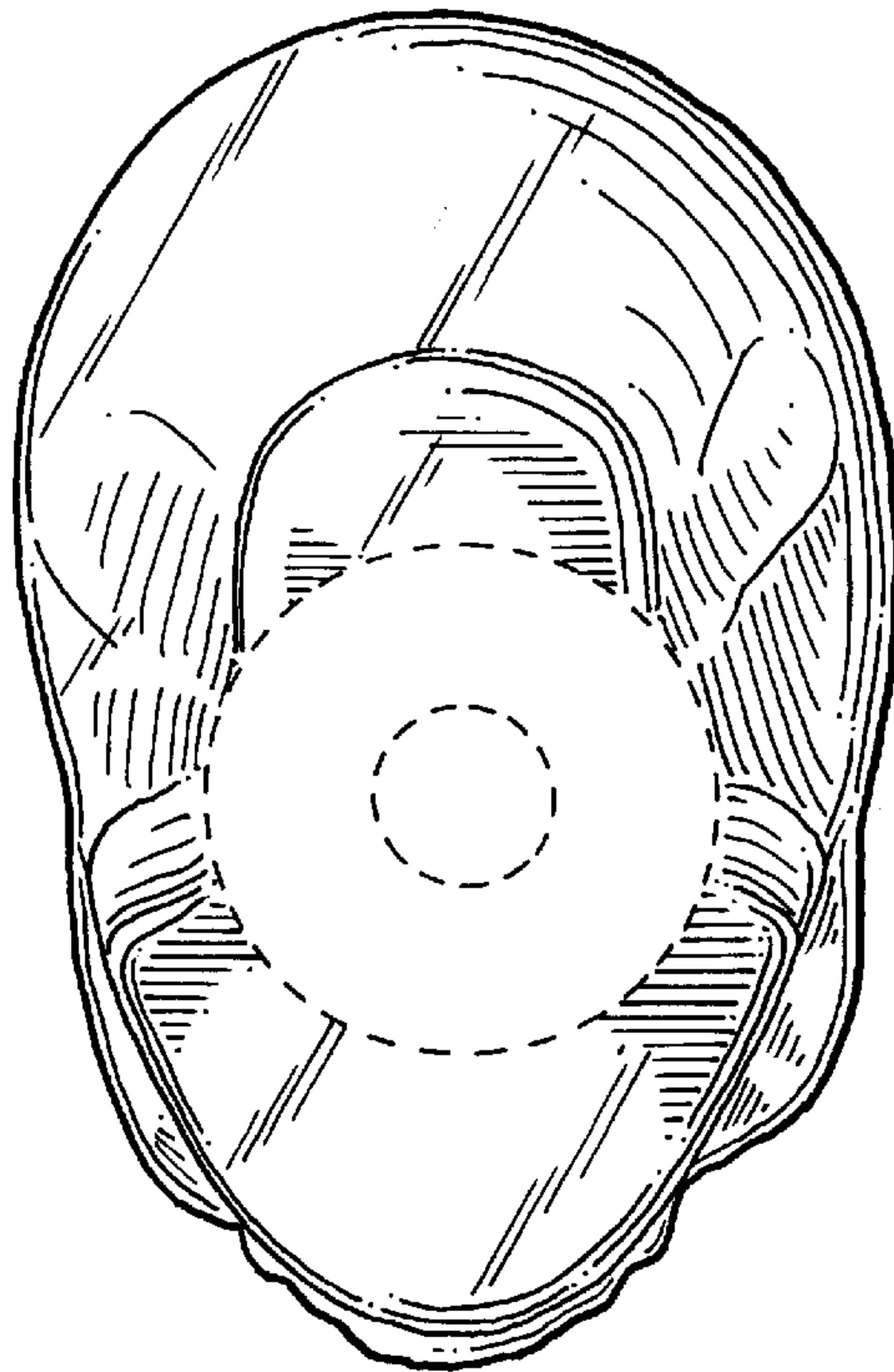
