(57) **CLAIM**

The ornamental design for a shoe sole, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe sole showing our new
design;

FIG. 2 is a bottom plan view thereof;

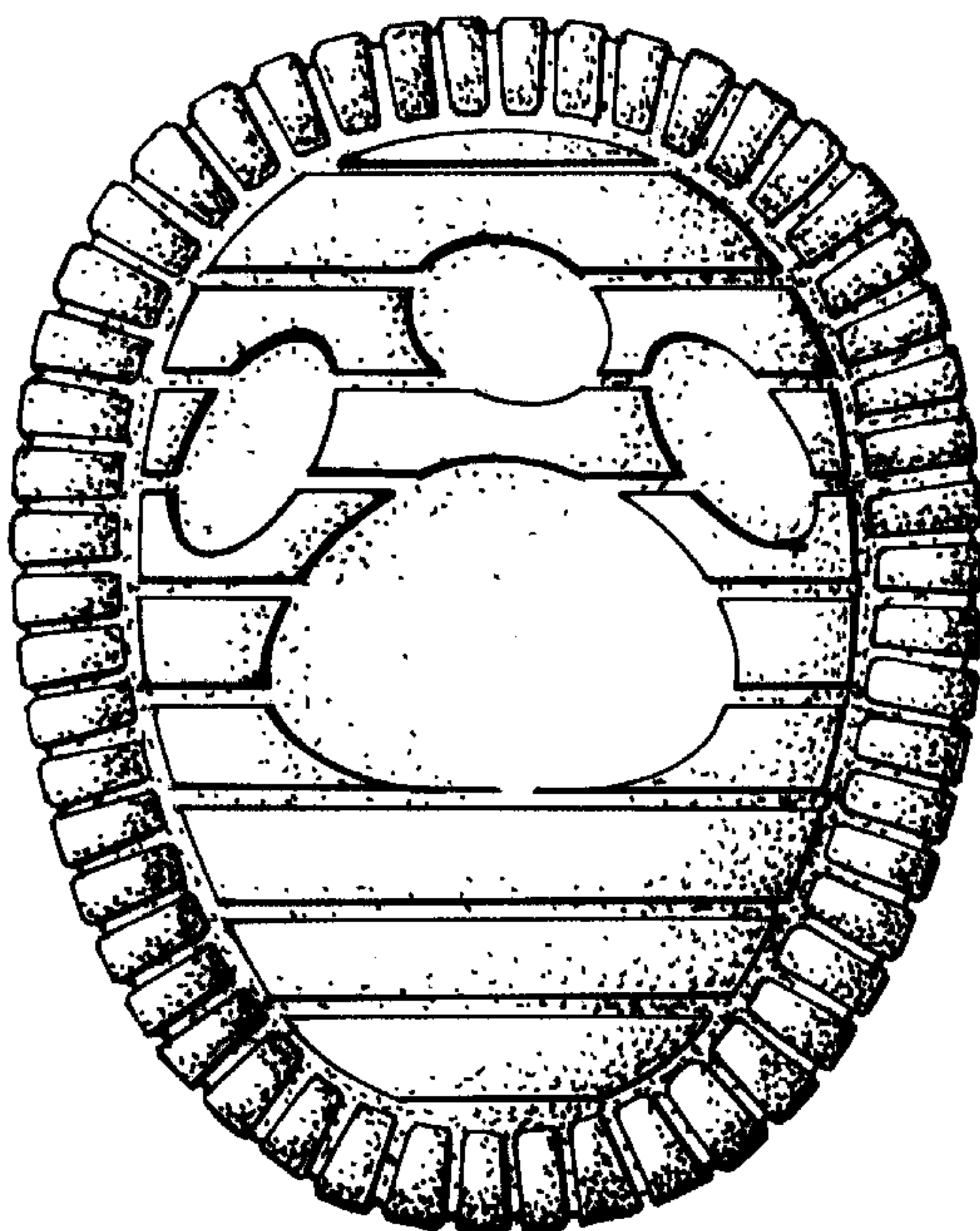
FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof; and,

FIG. 5 is a side elevational view thereof, the opposite side
being a mirror image.

The new design is for a shoe sole that is to be used on toy
stuffed animals, such as teddy bears. The broken line show-
ing a shoe upper in FIG. 1 illustrates a portion of a possible
environment for the shoe sole, but forms no part of the
claimed design. The surfaces which are not shown, form no
part of the claimed design.

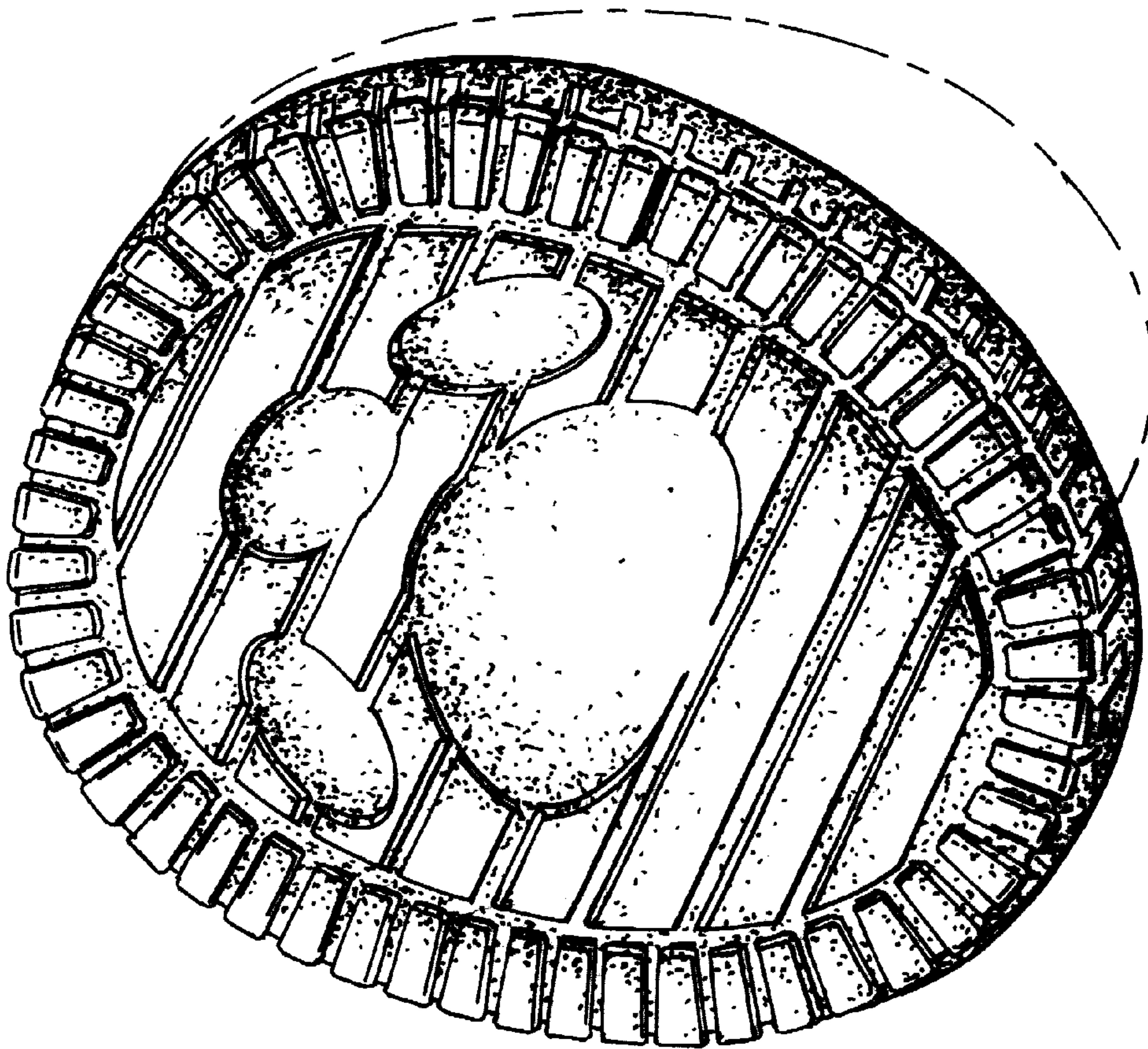

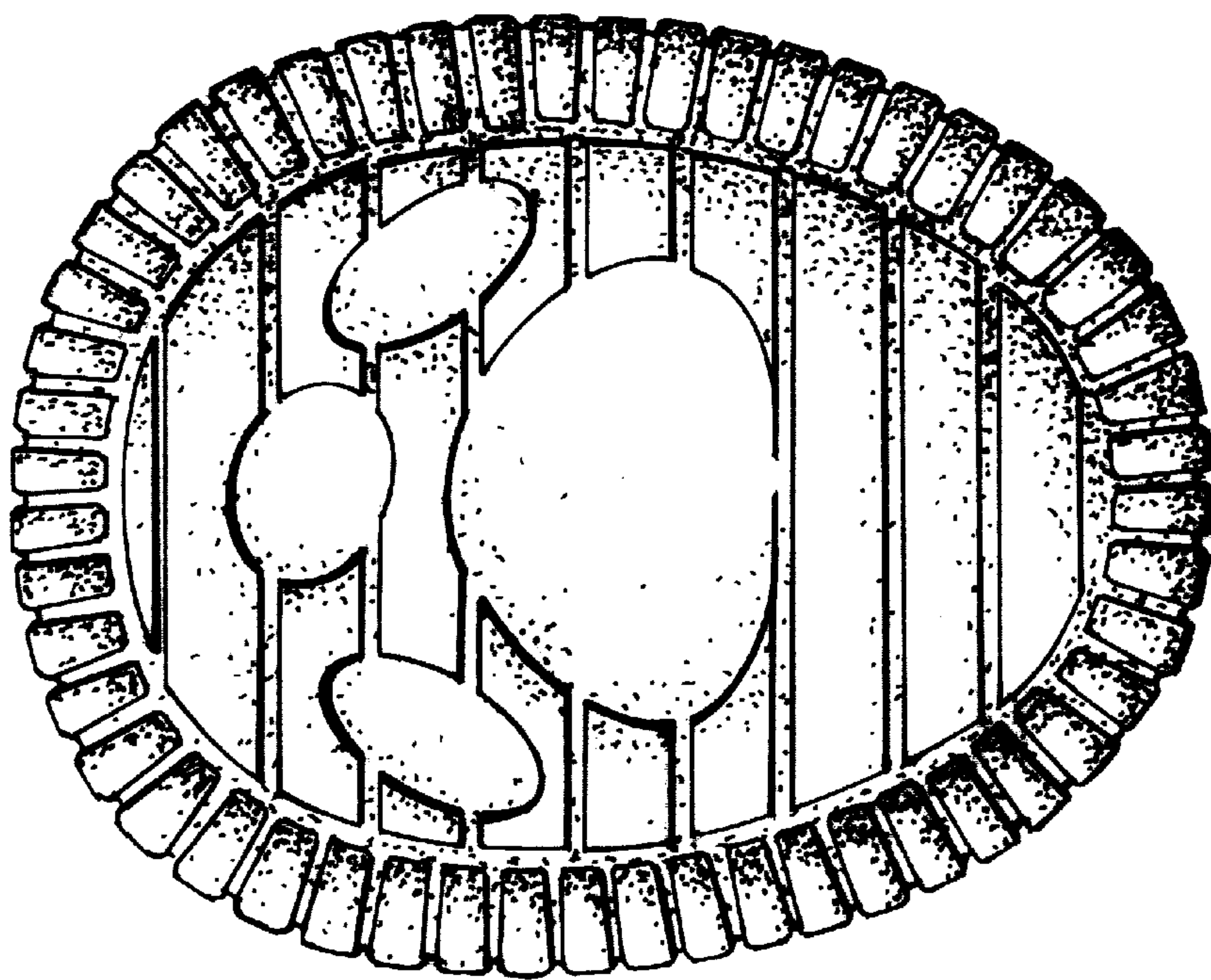

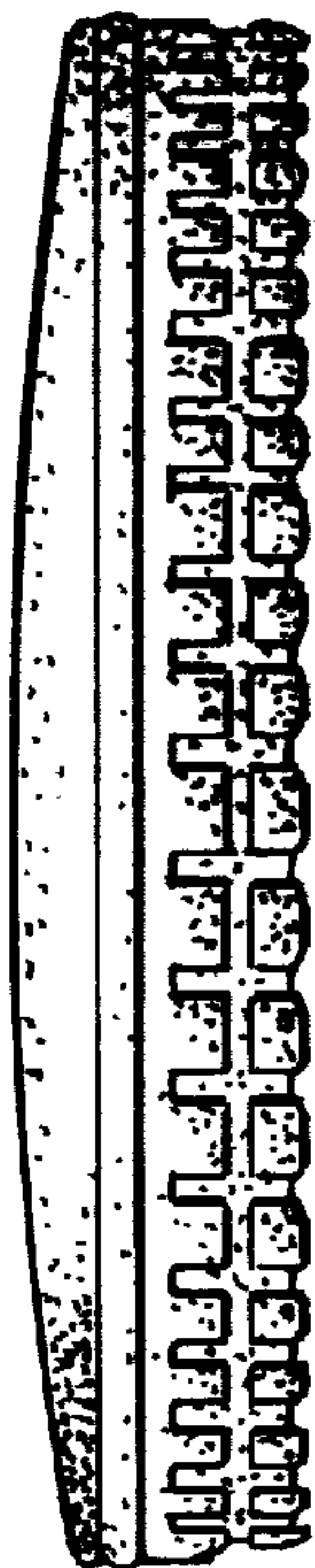

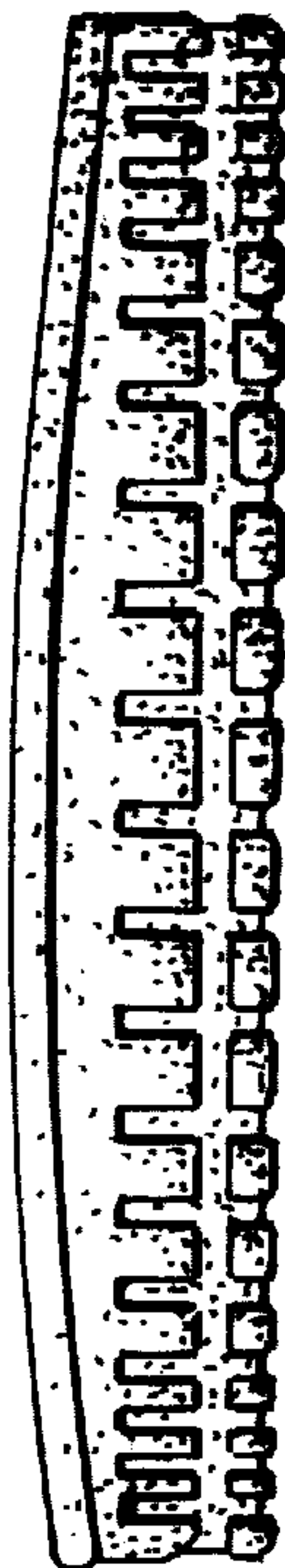

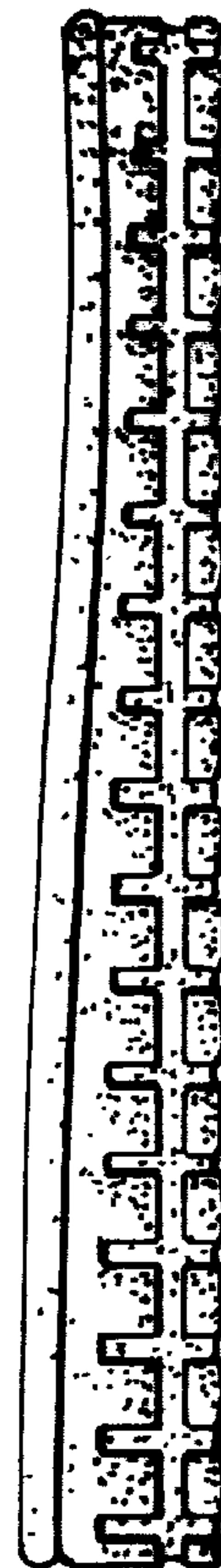
