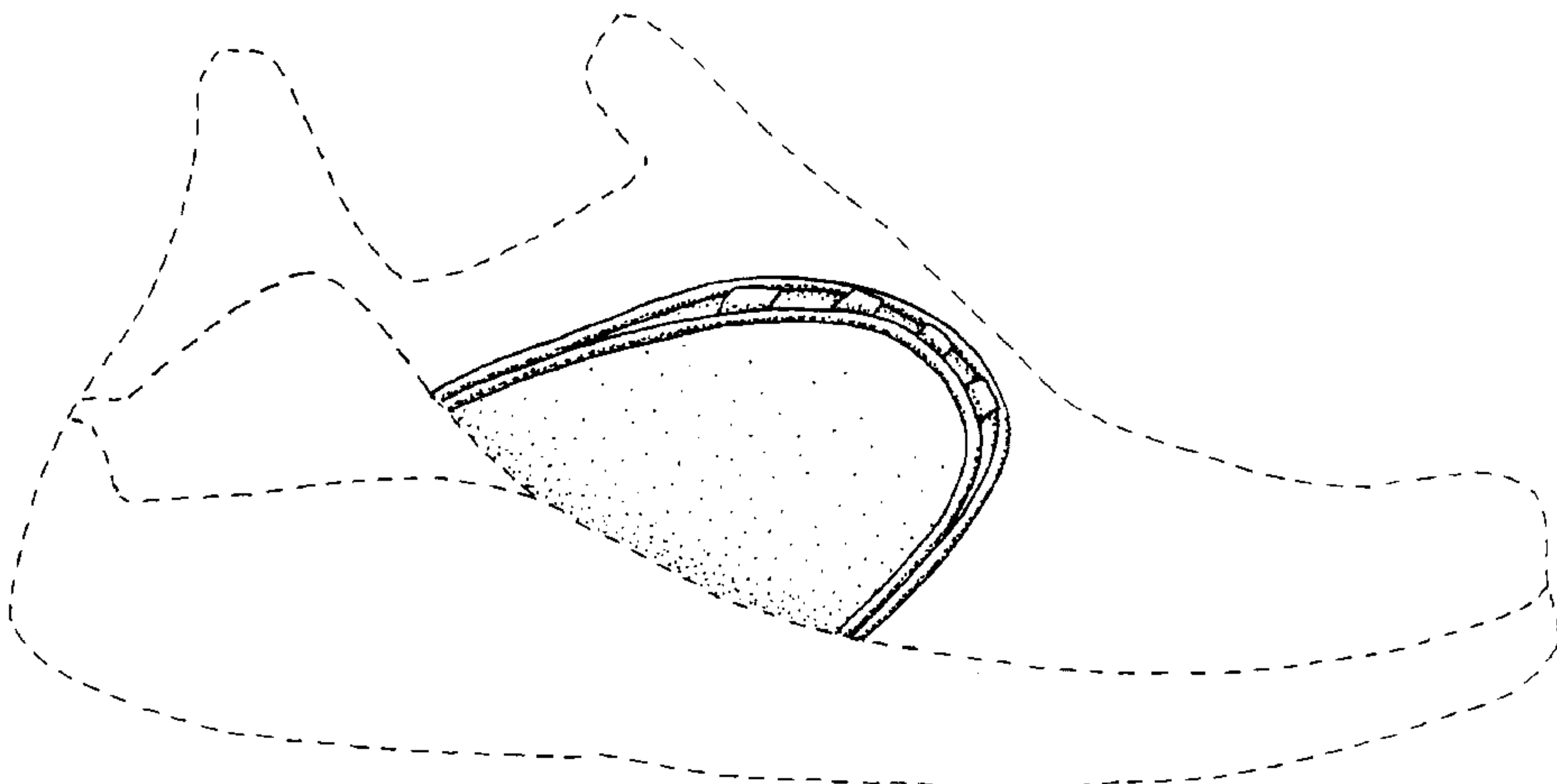
(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe upper showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a perspective view of a portion of a shoe upper showing a second embodiment of my new design;
FIG. 5 is a side view of the portion of a shoe upper of FIG. 4; and,
FIG. 6 is a top view of the portion of a shoe upper of FIG. 4.
The broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

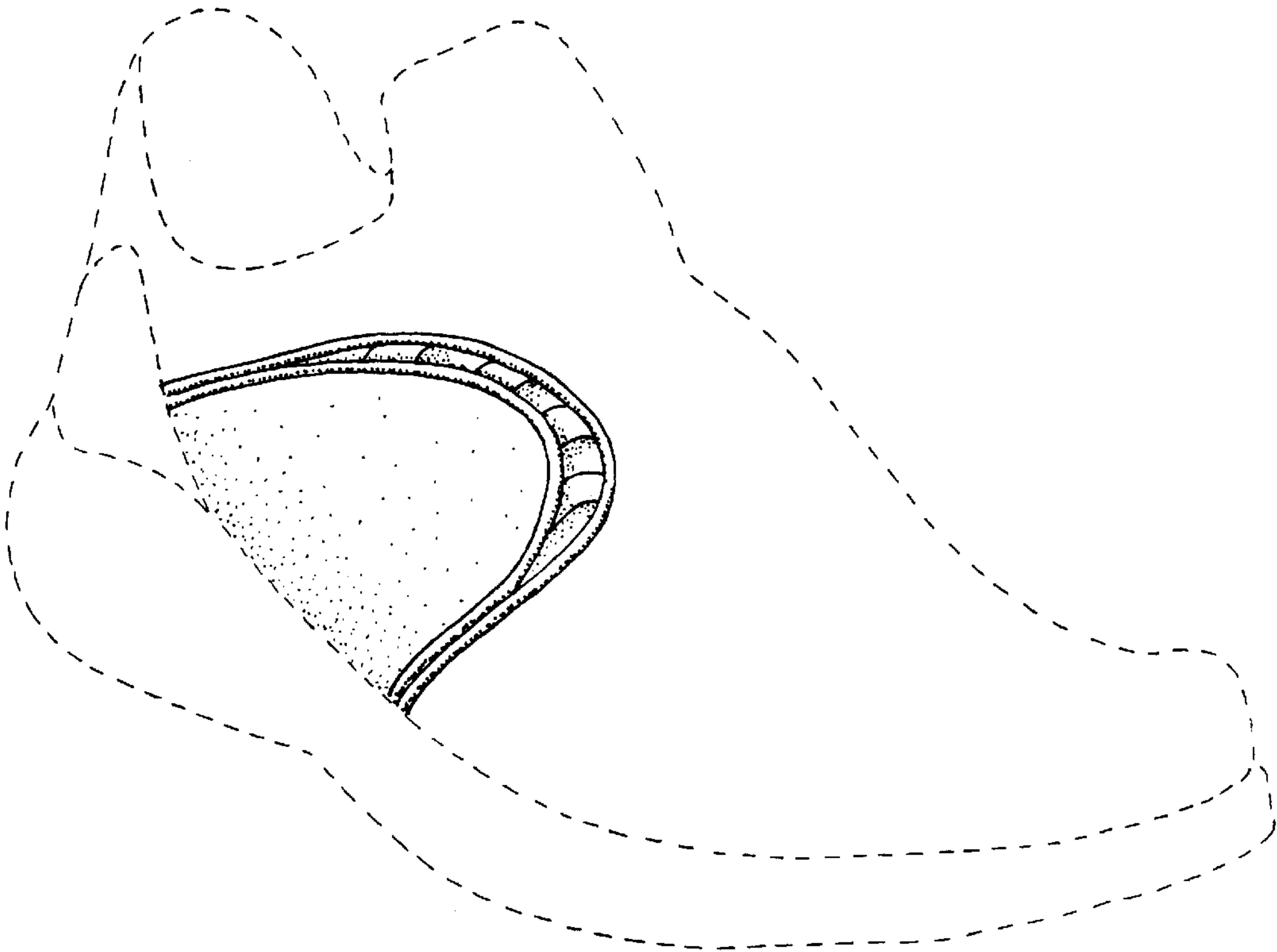

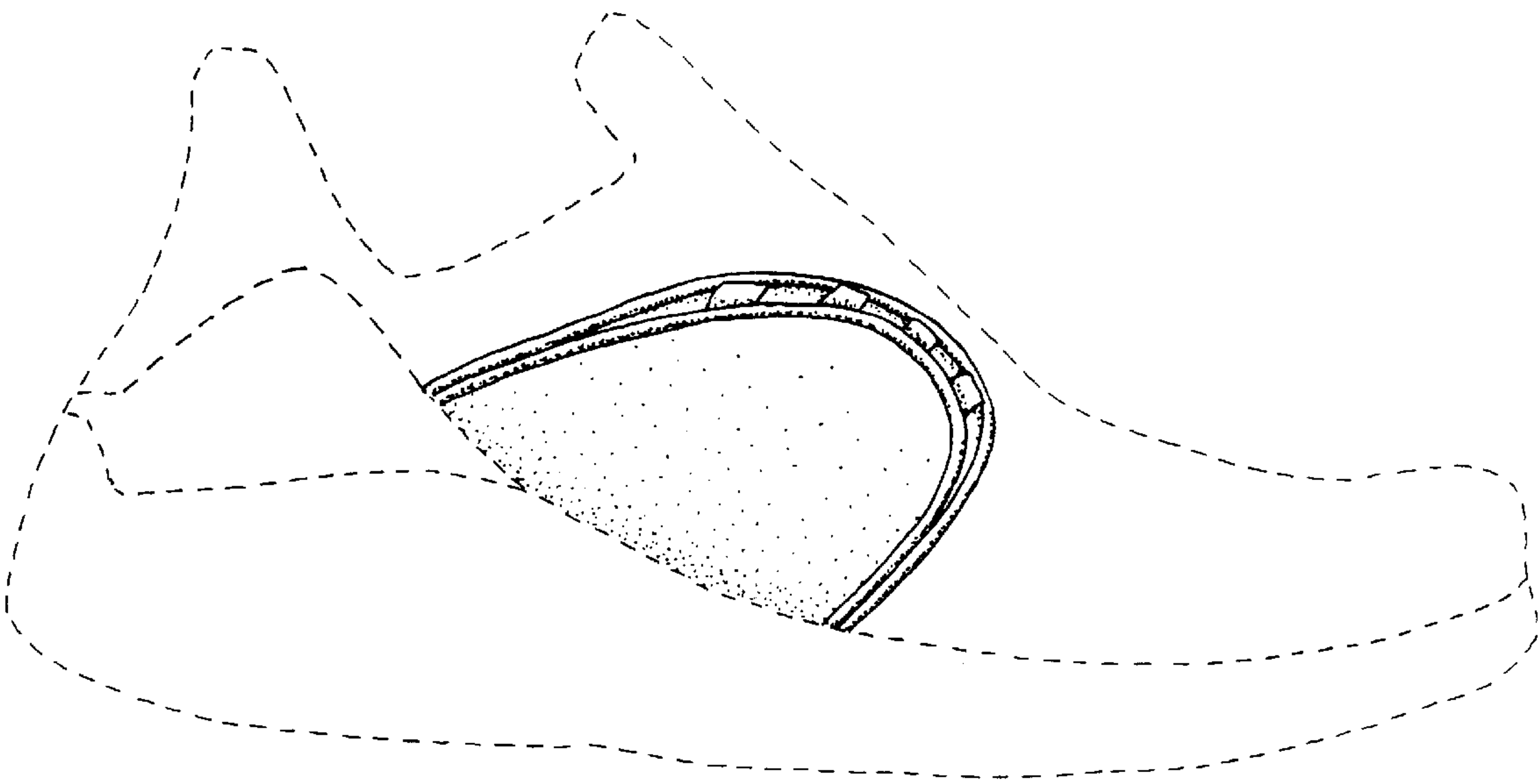

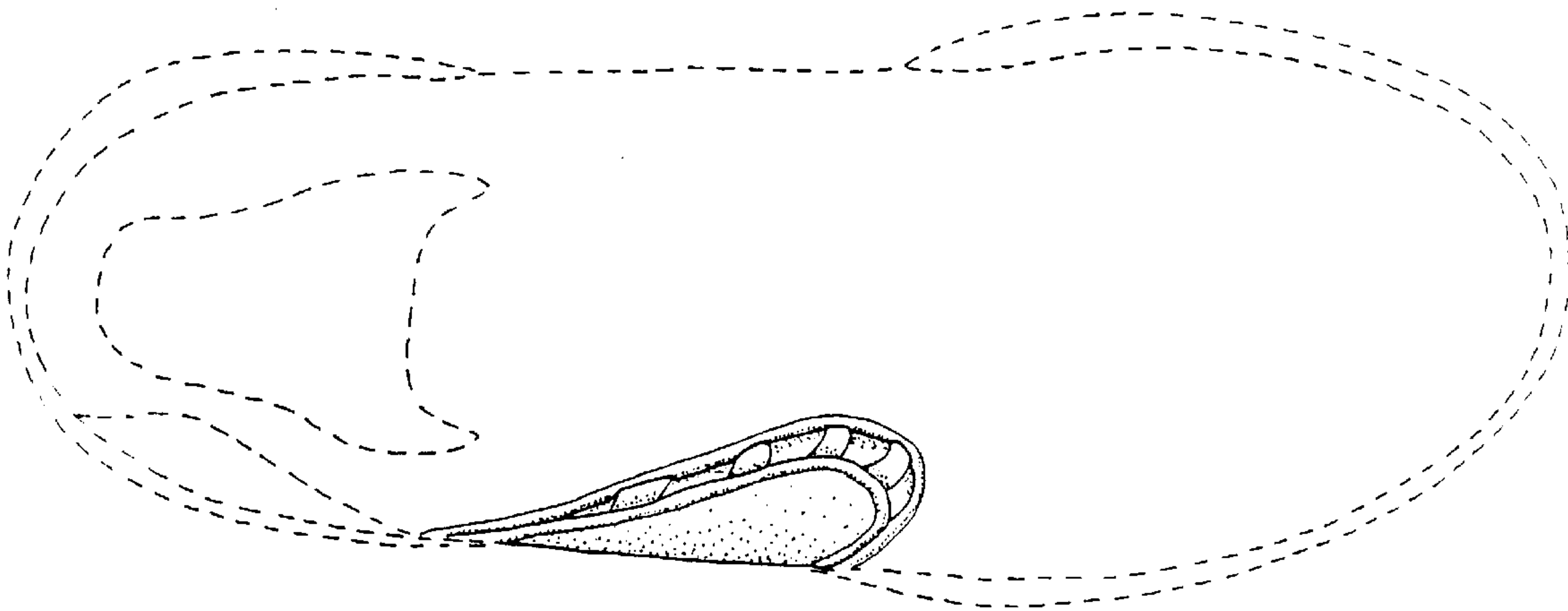

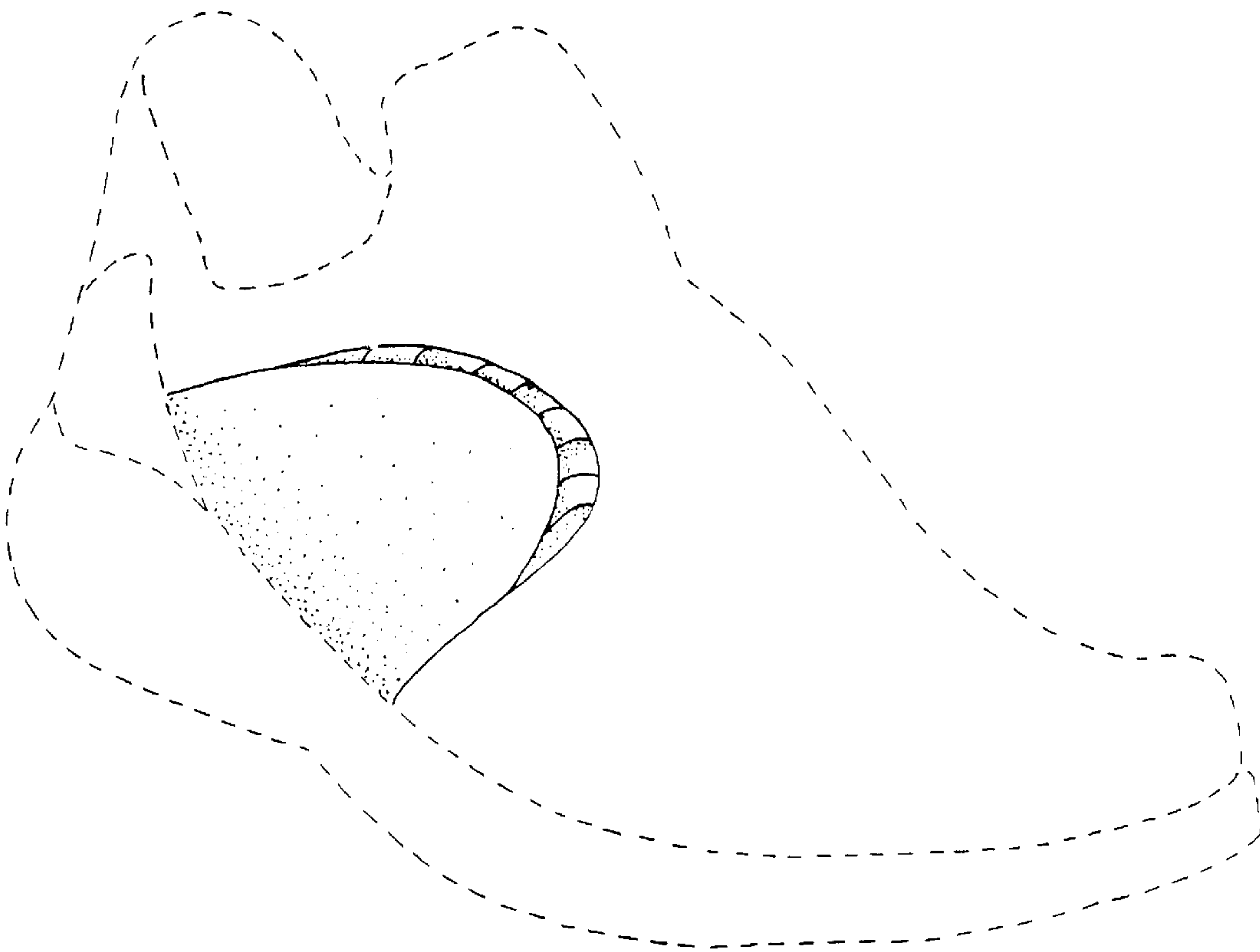

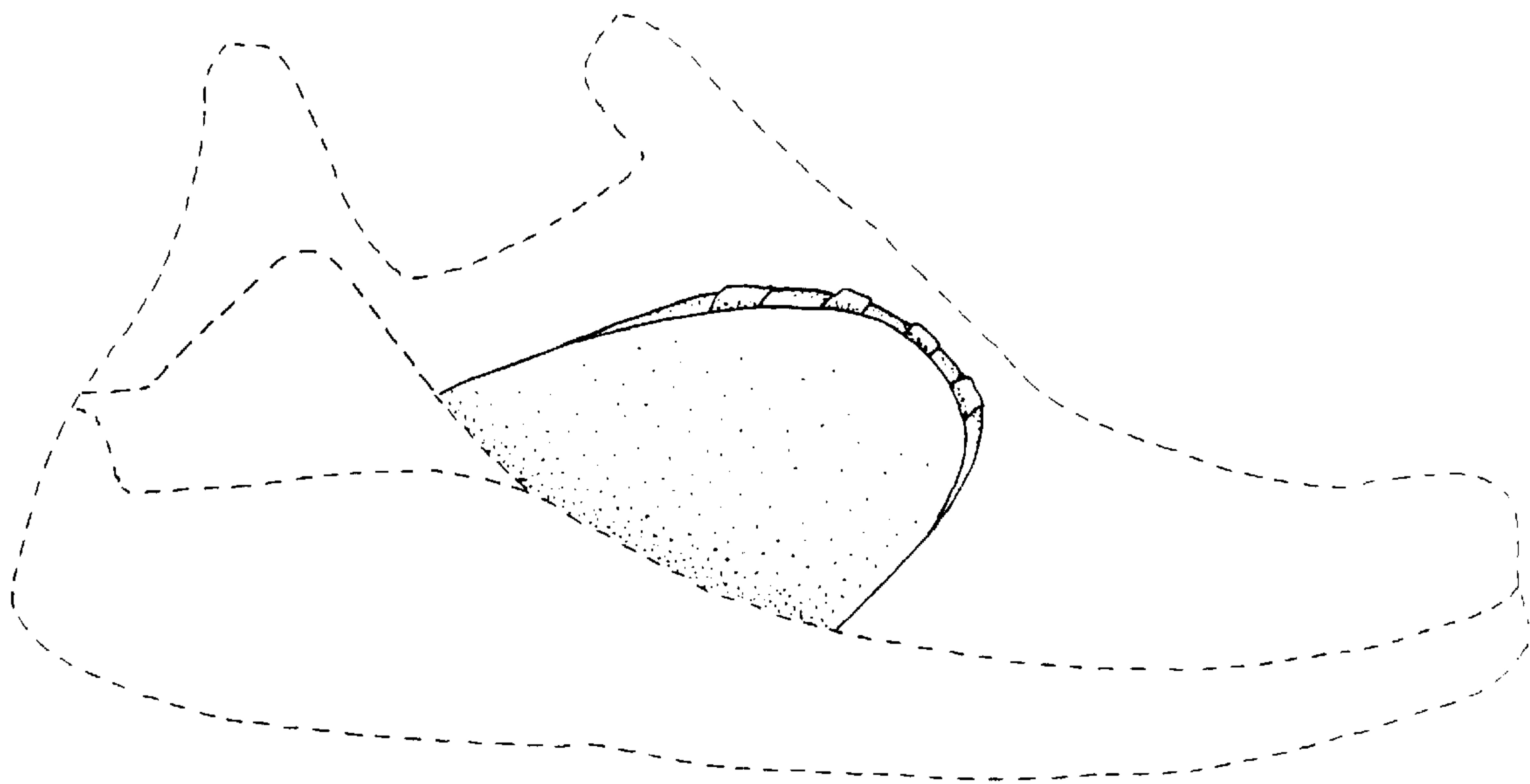

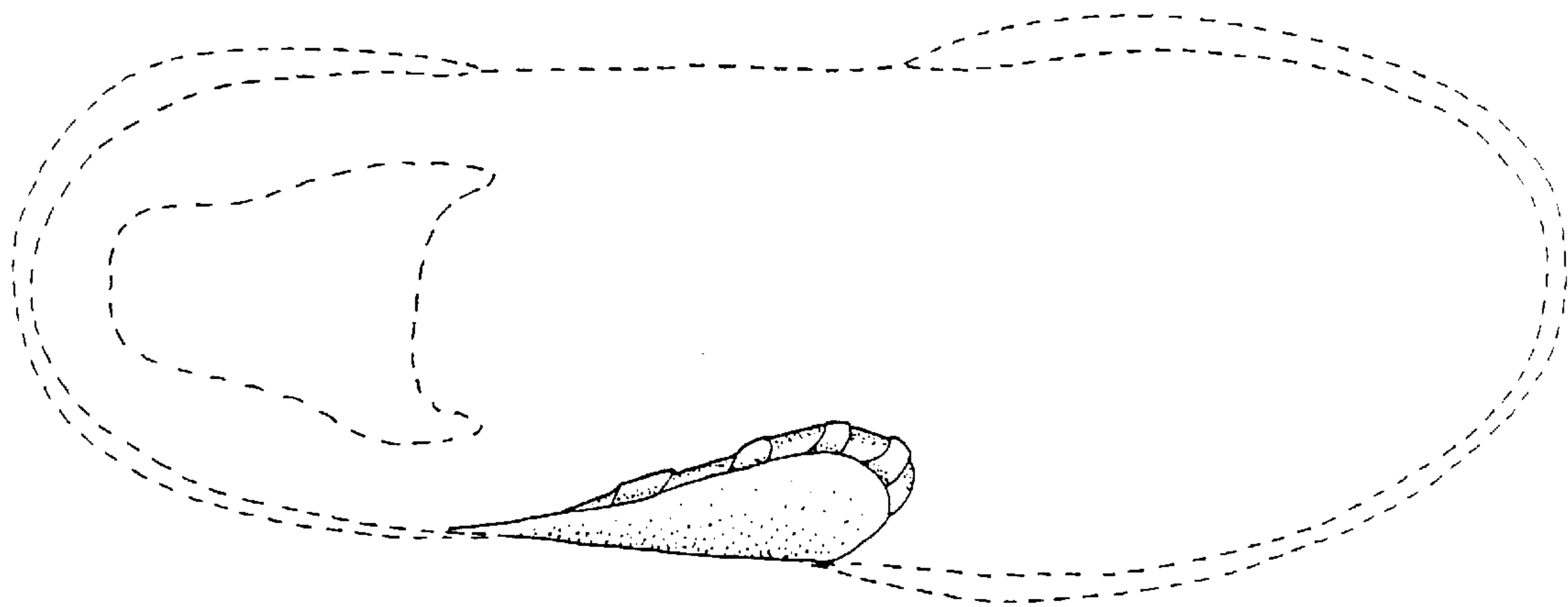
