(57) **CLAIM**

The ornamental design for a set of handles for cabinet door, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a set of handles for cabinet door in accordance with my invention;

FIG. 2 is a front elevation thereof;

FIG. 3 is a rear elevation thereof;

FIG. 4 is a side elevation thereof;

FIG. 5 is opposite side elevation thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is perspective view thereof with a handle portion in an open position

FIG. 9 is a front perspective view of an additional embodiment thereof;

FIG. 10 is a front elevation of the embodiment of FIG. 9;

FIG. 11 is a rear elevation of the embodiment of FIG. 9;

FIG. 12 is a side elevation of the embodiment of FIG. 9;

FIG. 13 is opposite side elevation of the embodiment of FIG. 9;

FIG. 14 is a top plan view of the embodiment of FIG. 9;

FIG. 15 is a bottom plan view of the embodiment of FIG. 9; and,

FIG. 16 is a perspective view of the embodiment of FIG. 9 with a handle portion in an open position.

The cabinet door handles are shown separately for convenience of illustration.

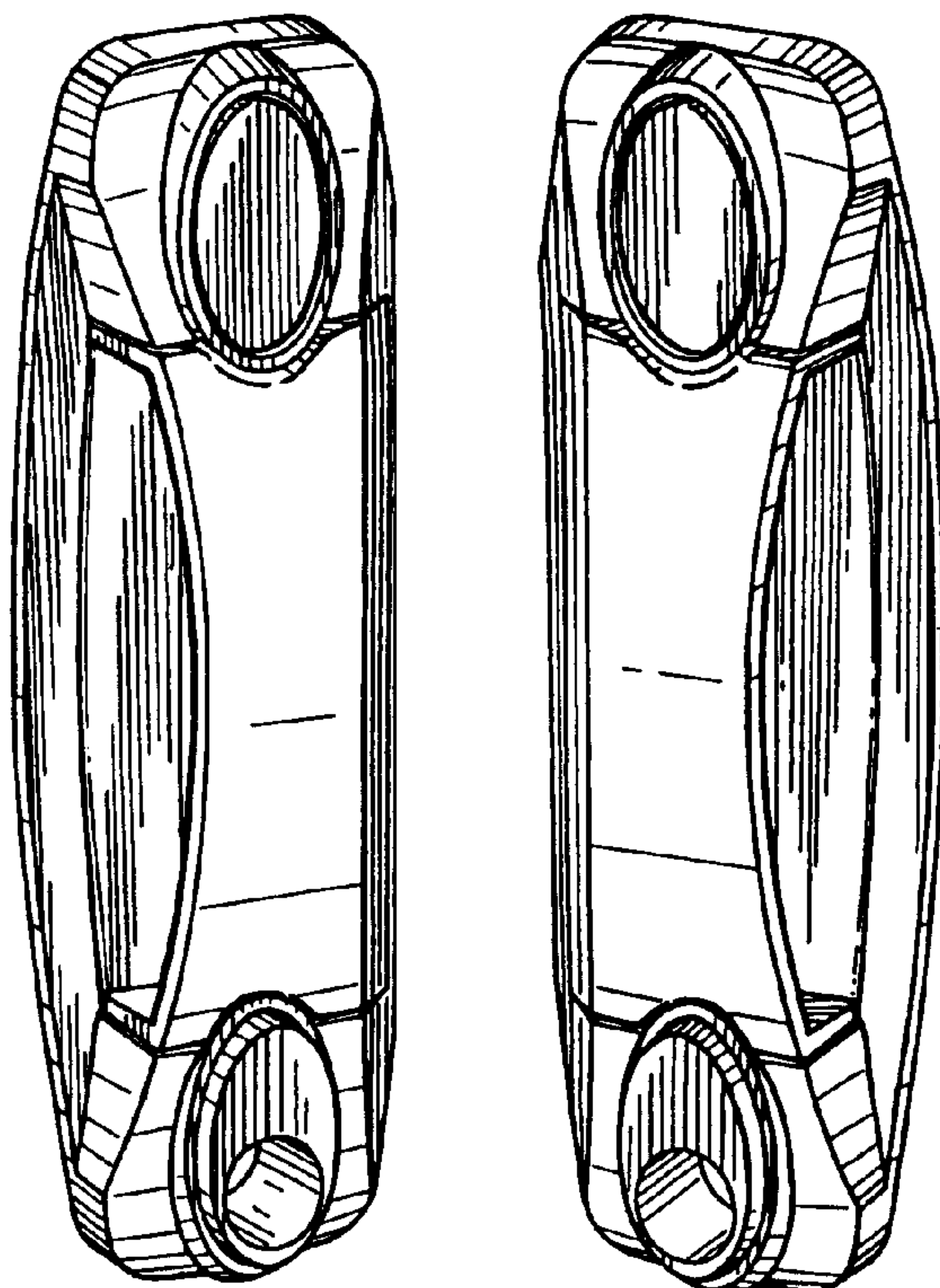

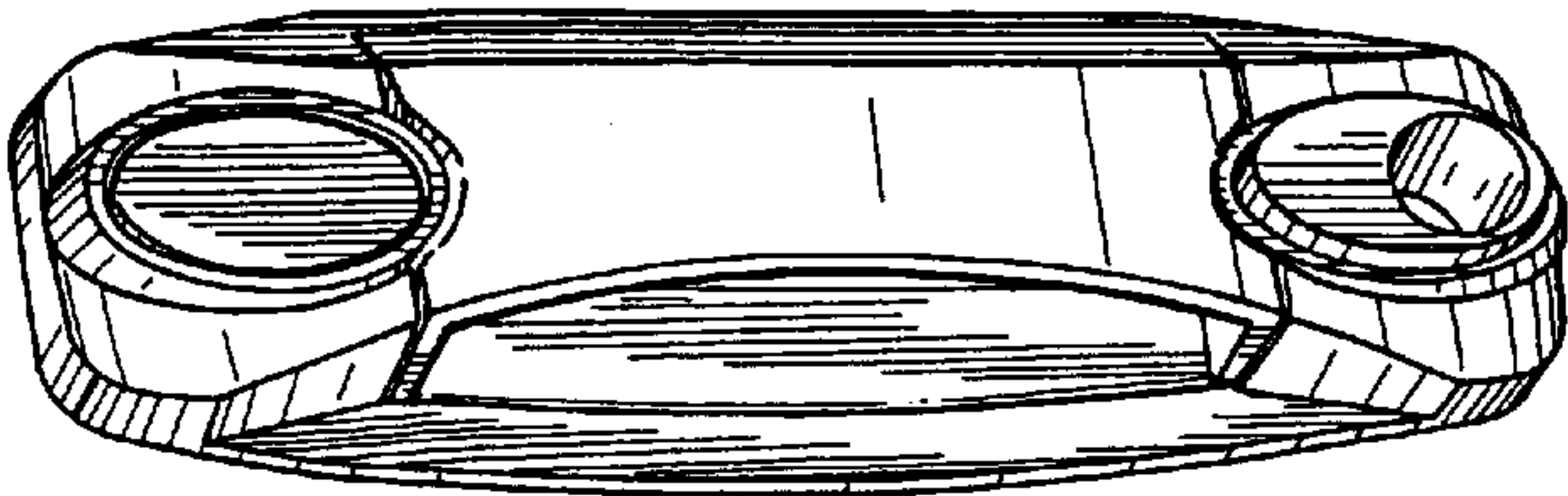

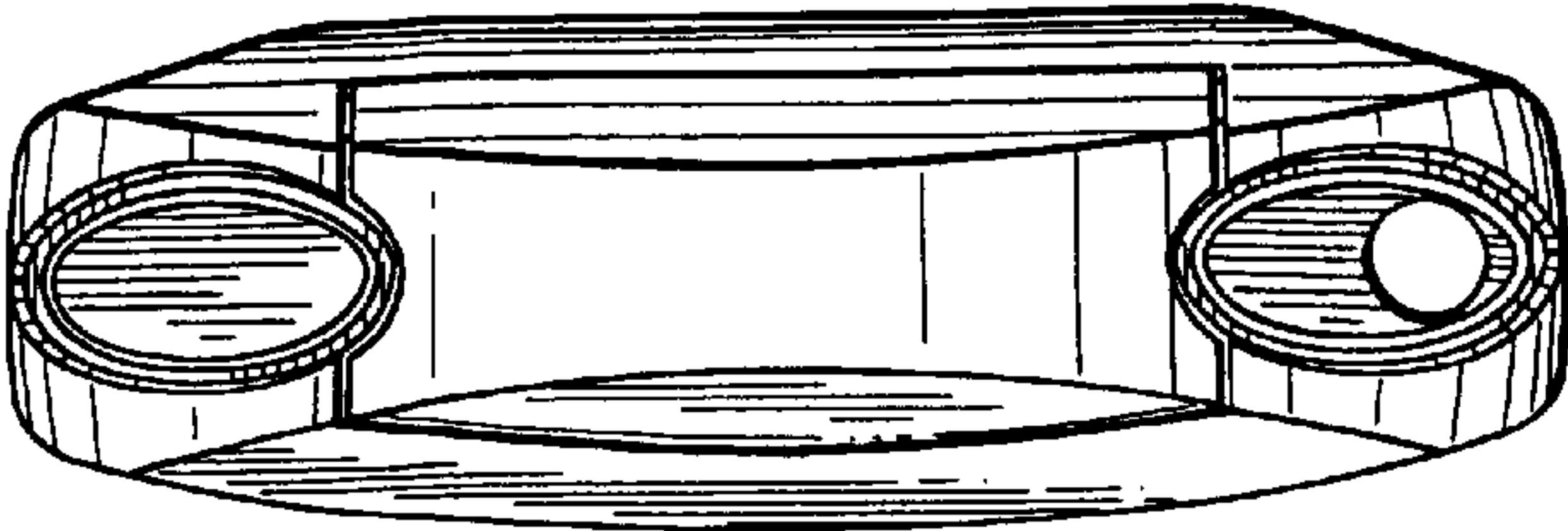

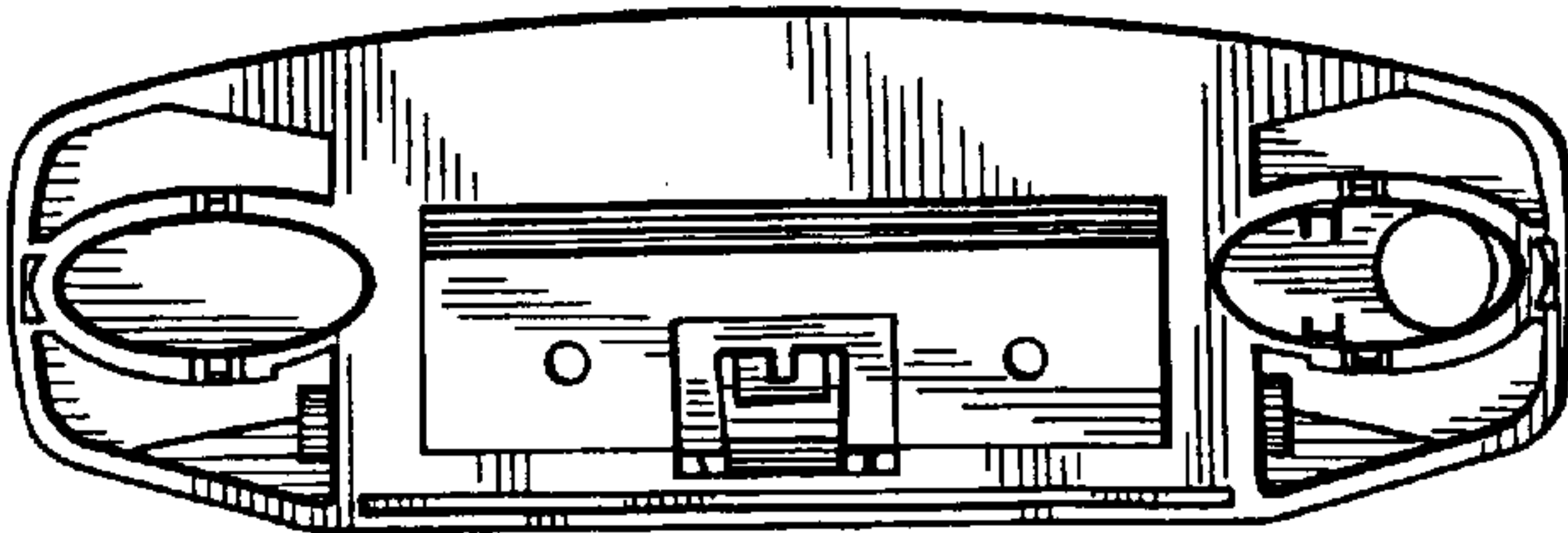

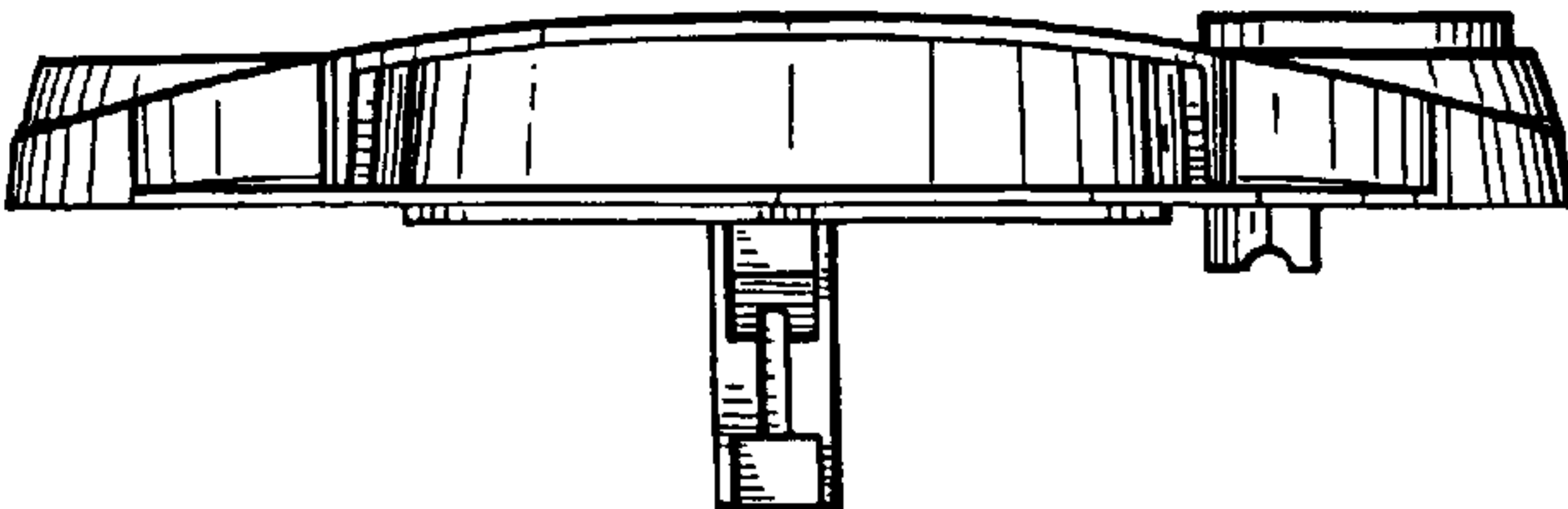

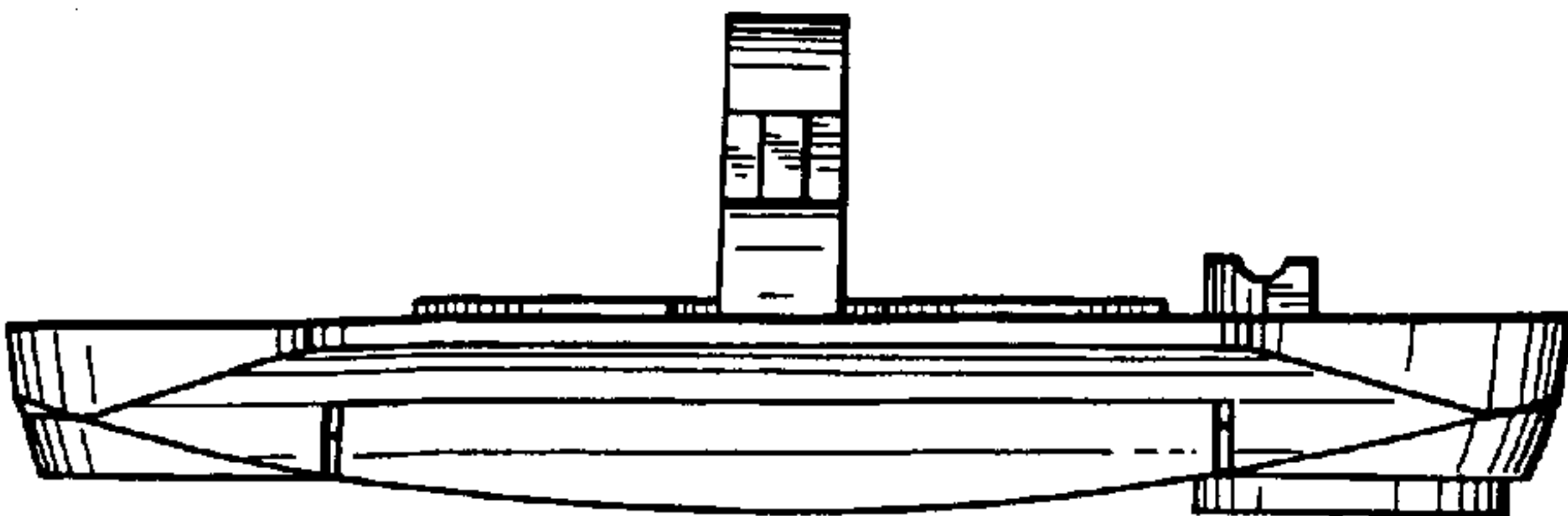

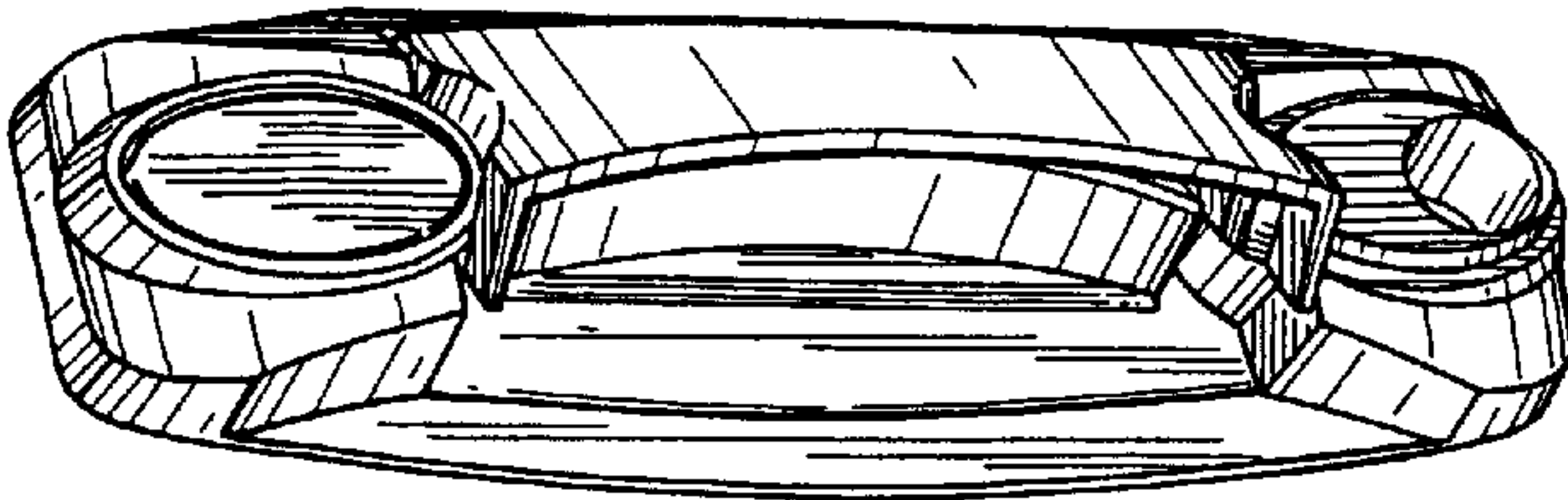

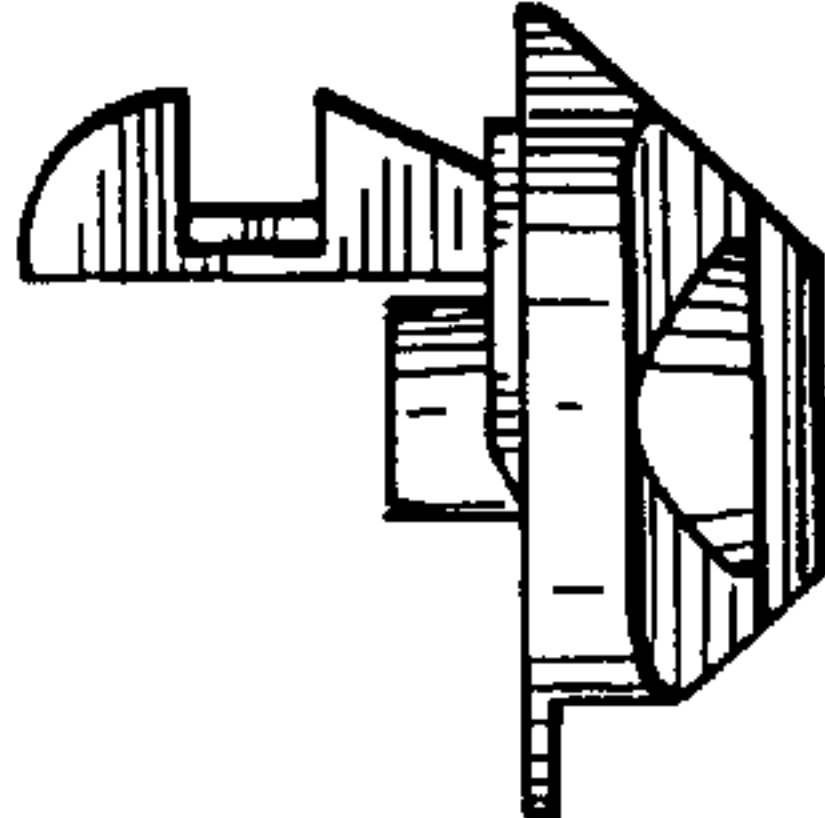

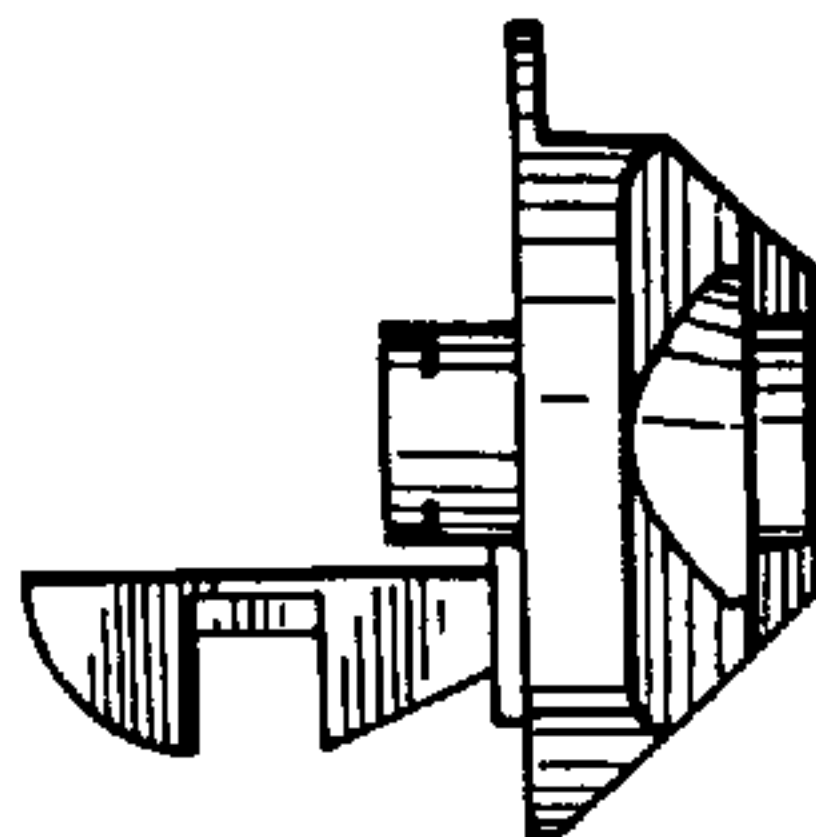

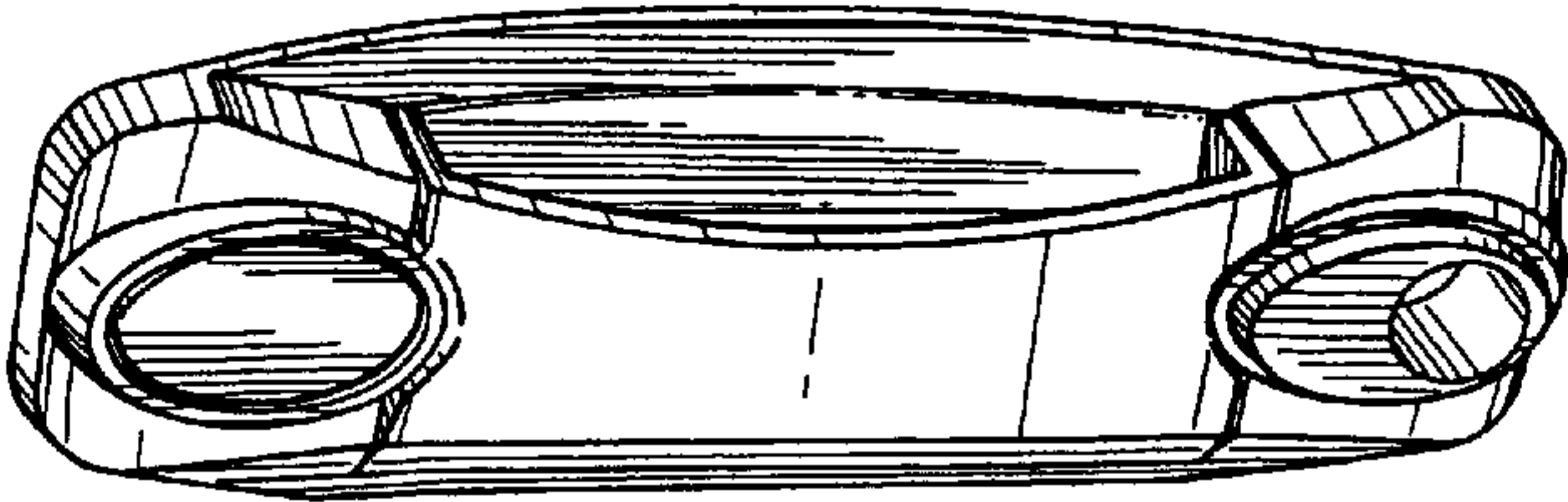

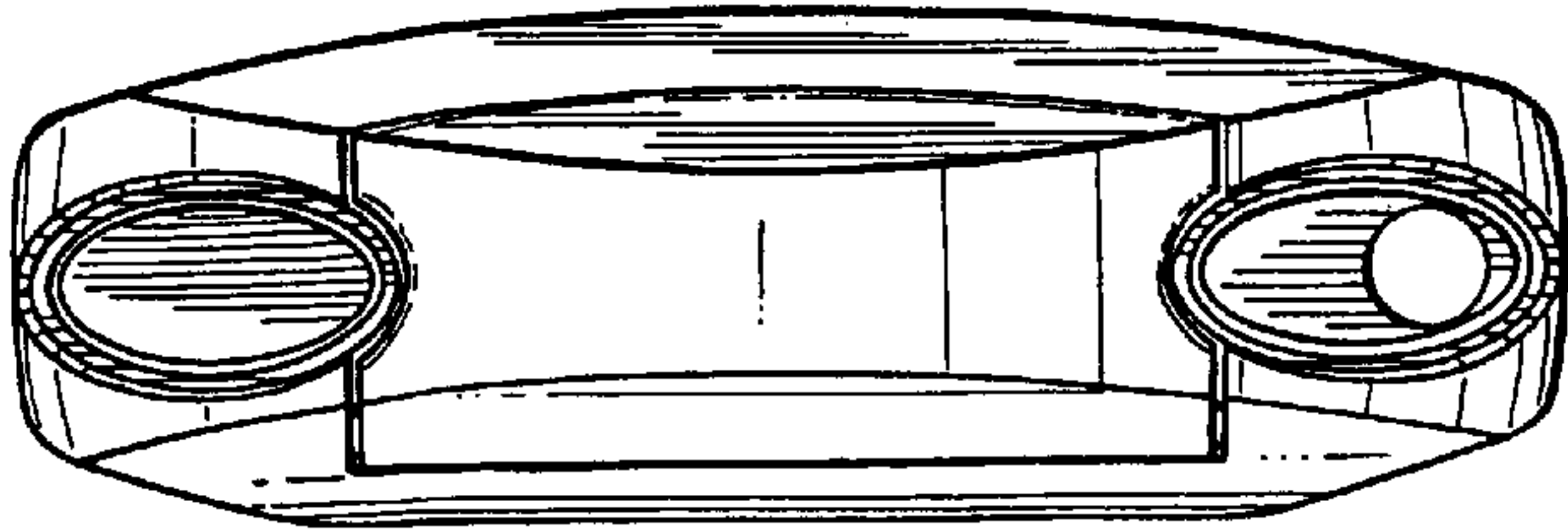

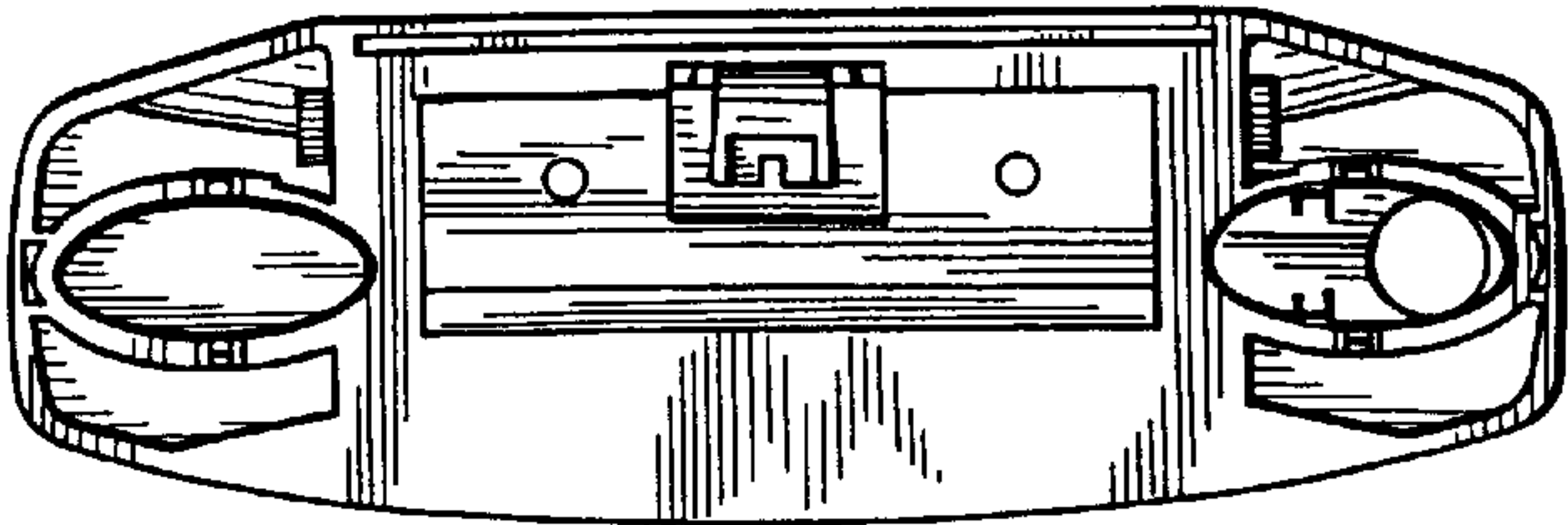

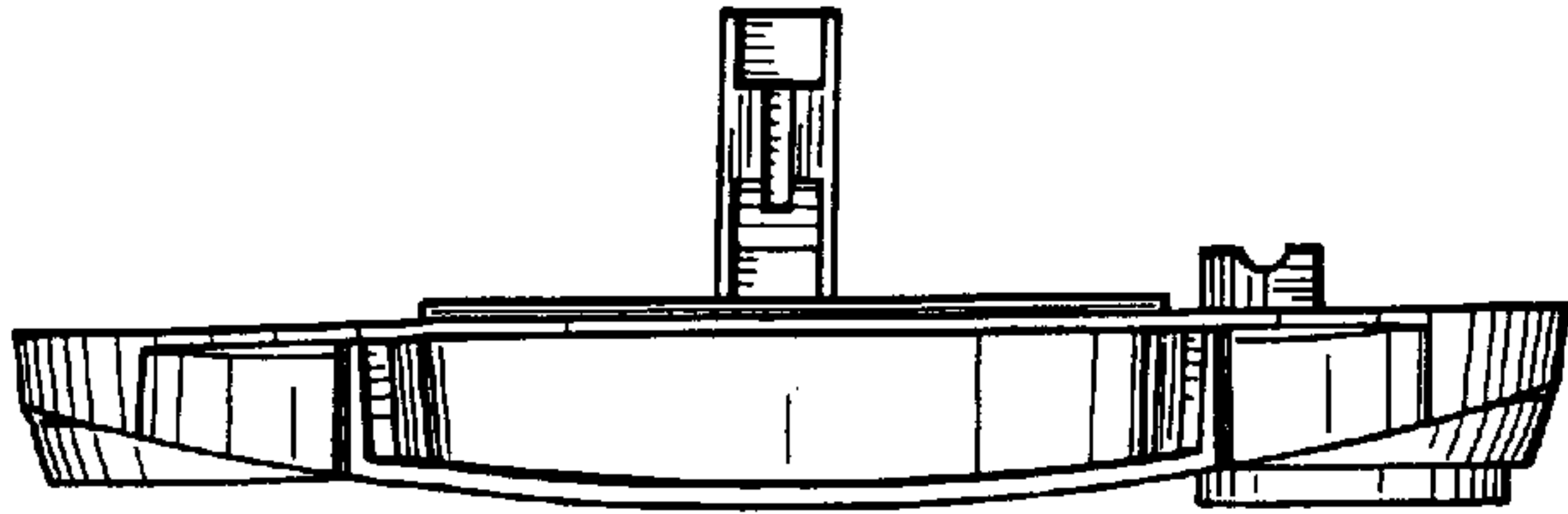

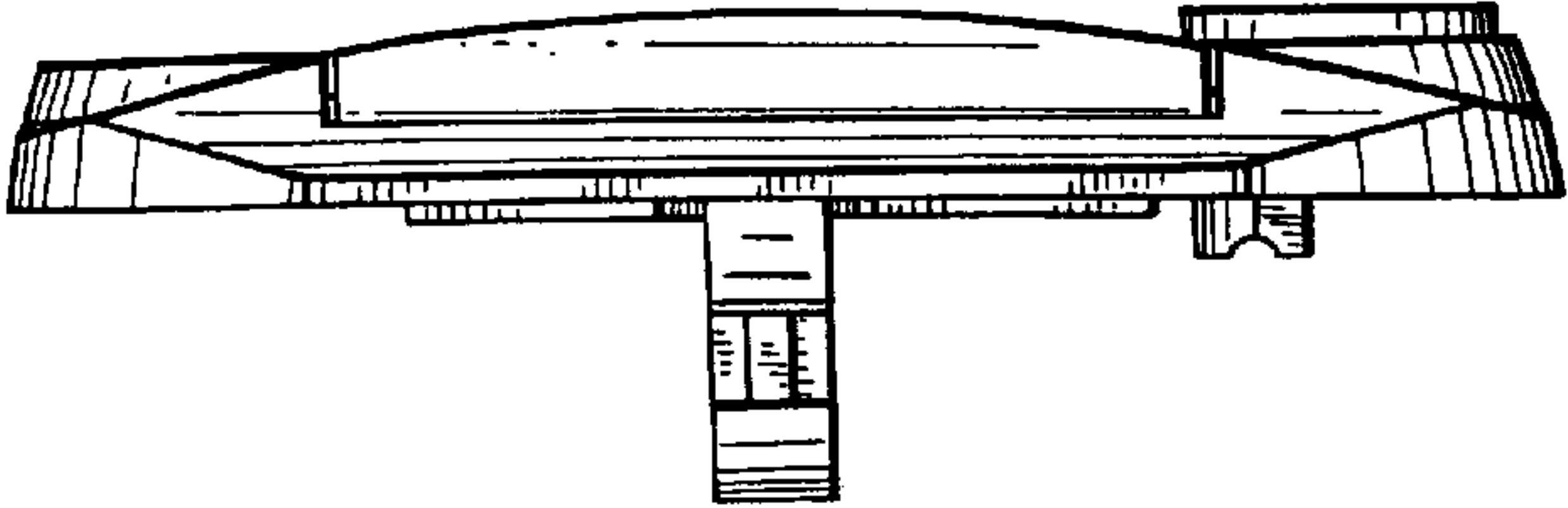

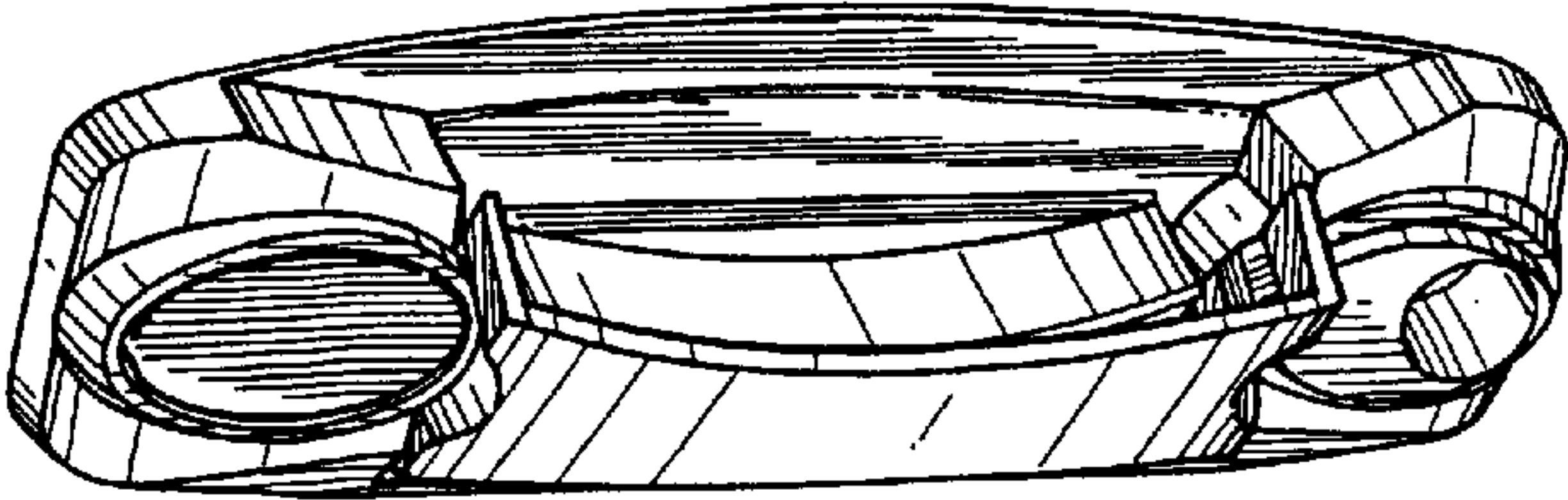

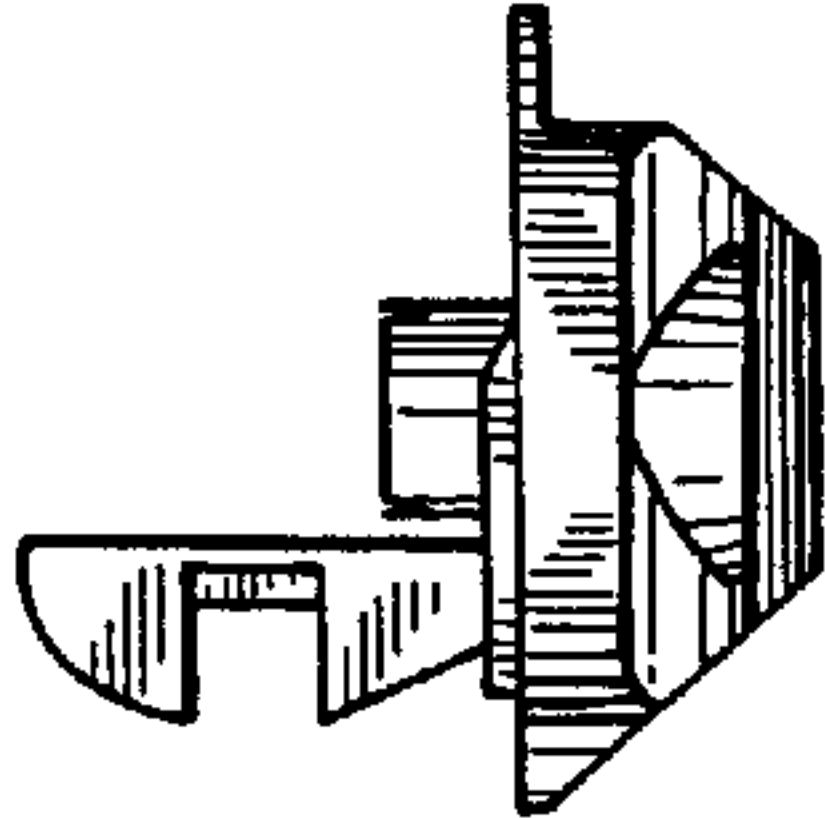
