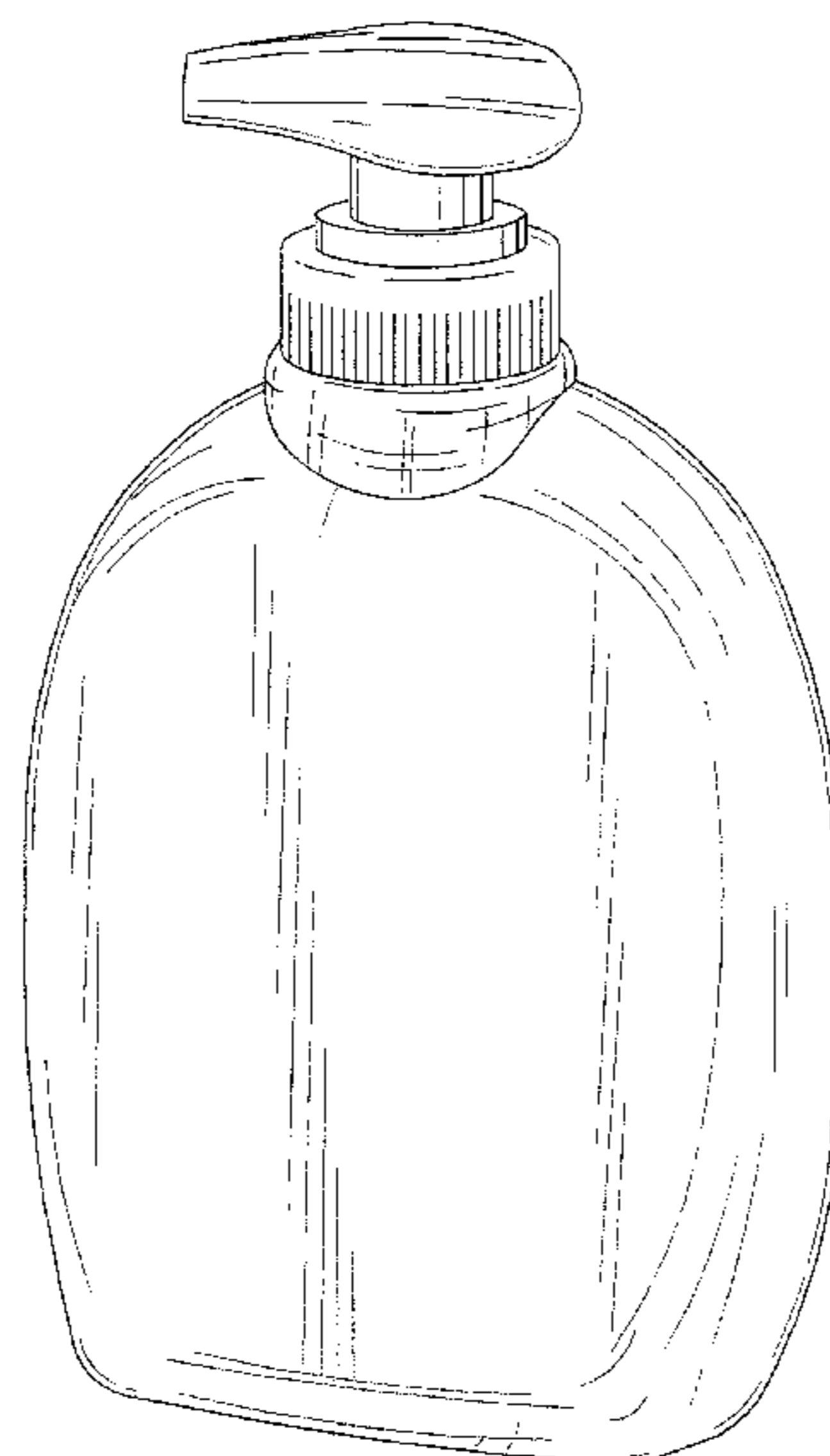
CLAIM

(57) The ornamental design for a container with pump, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the container with pump of
our design.
FIG. 2 is a left side elevation view thereof.
FIG. 3 is a right side elevation view thereof.
FIG. 4 is a front elevation view thereof, the rear elevation
view being a mirror image thereof.
FIG. 5 is a top plan view thereof.
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a left side elevation view of an alternate embodi-
ment of the container with pump, the other views being the
same.

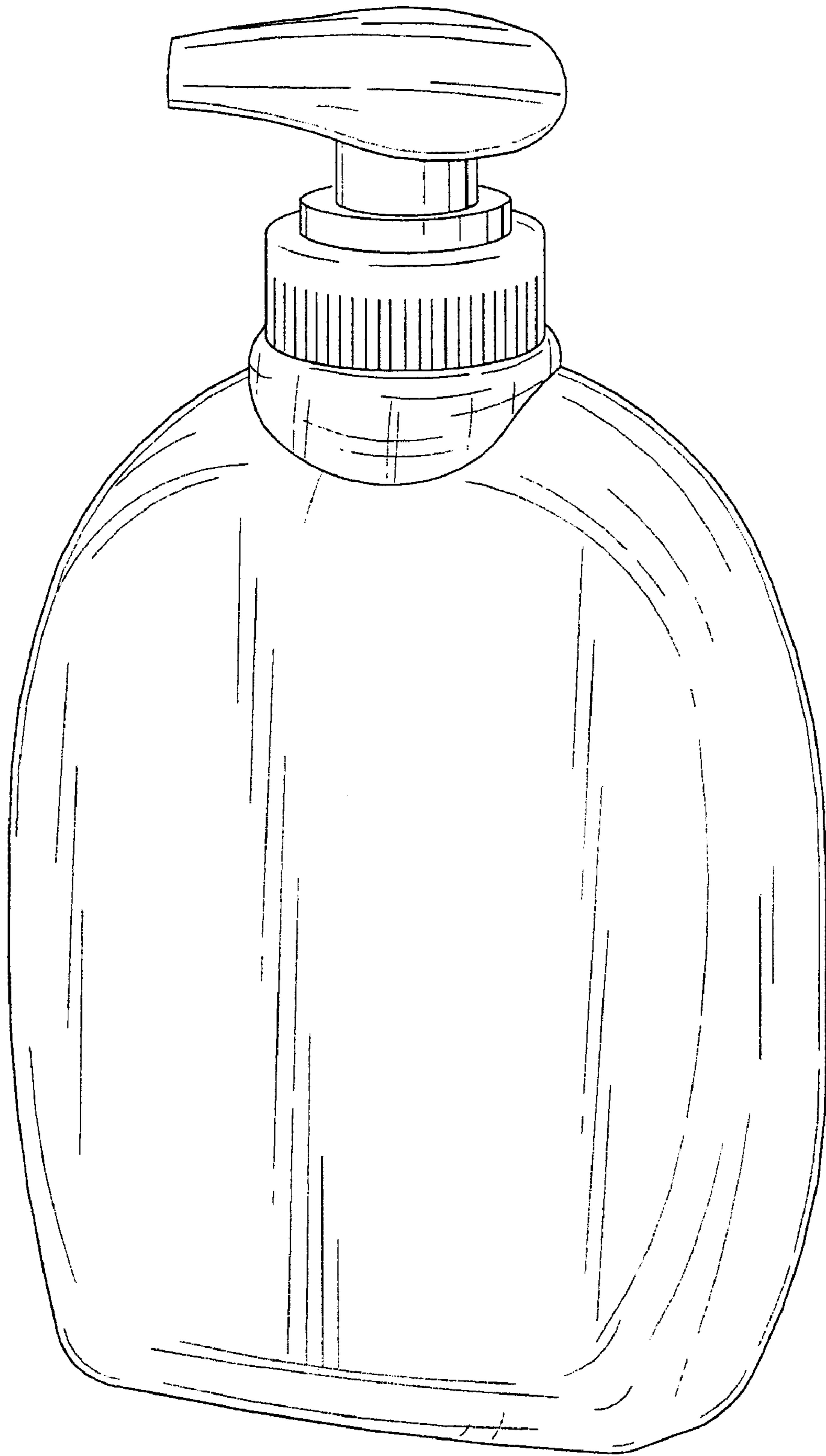

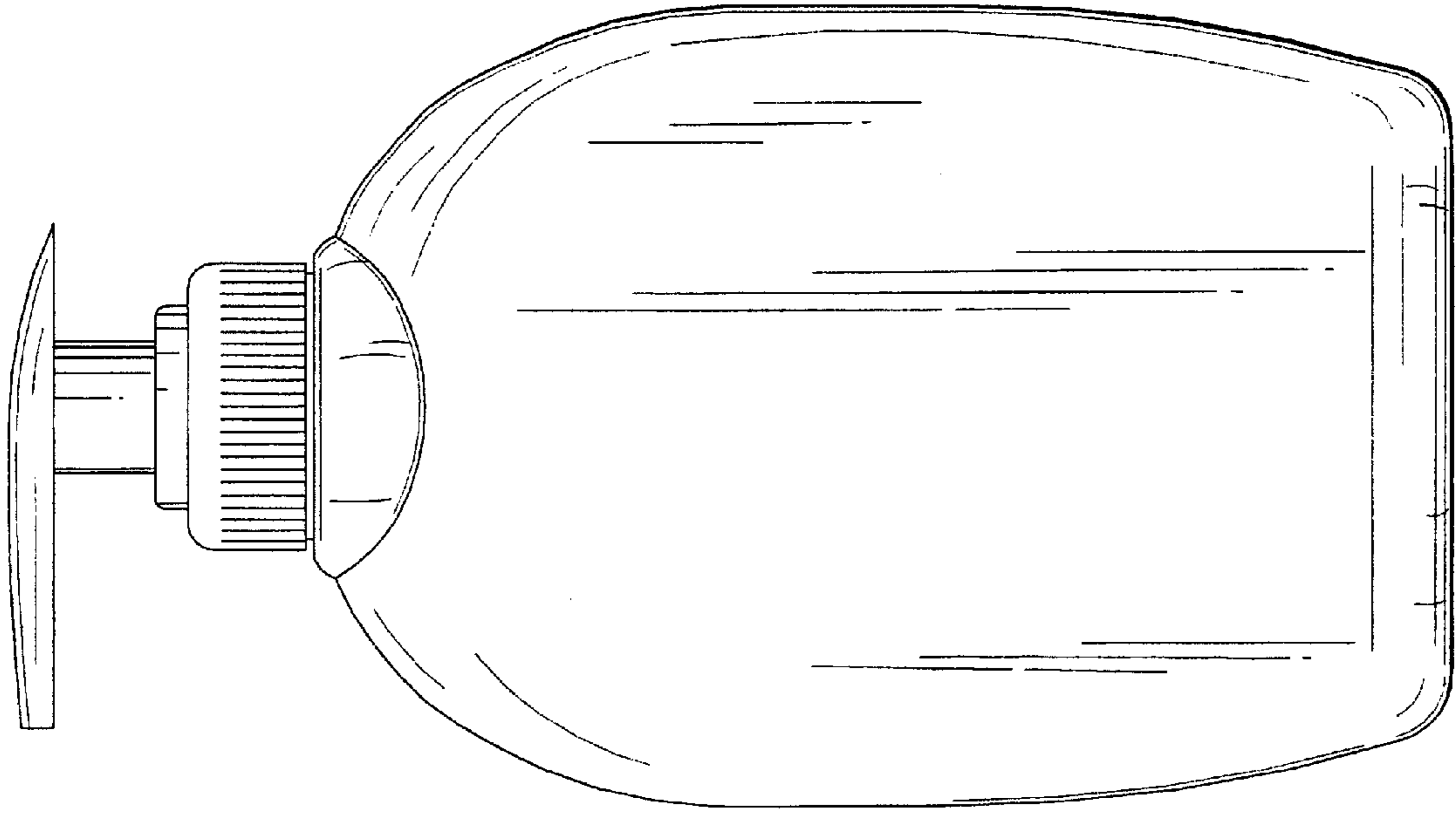

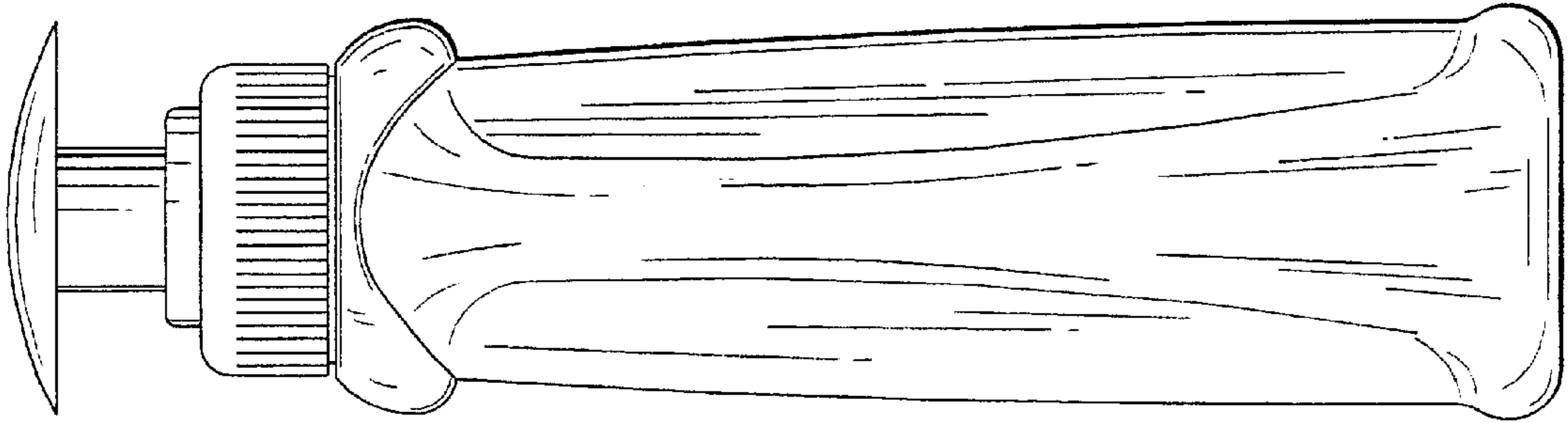

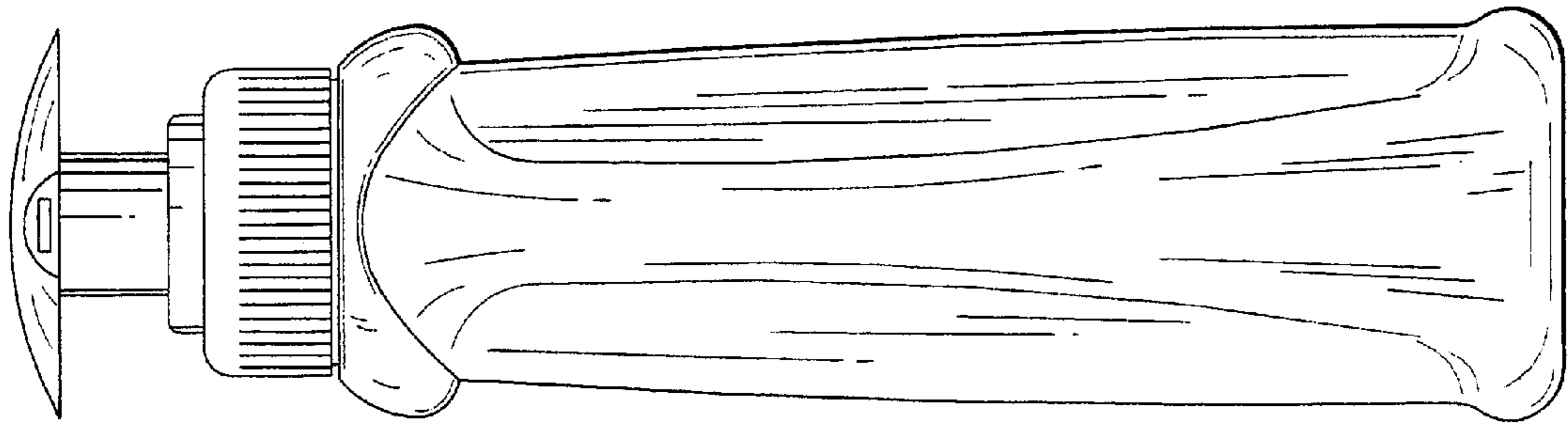

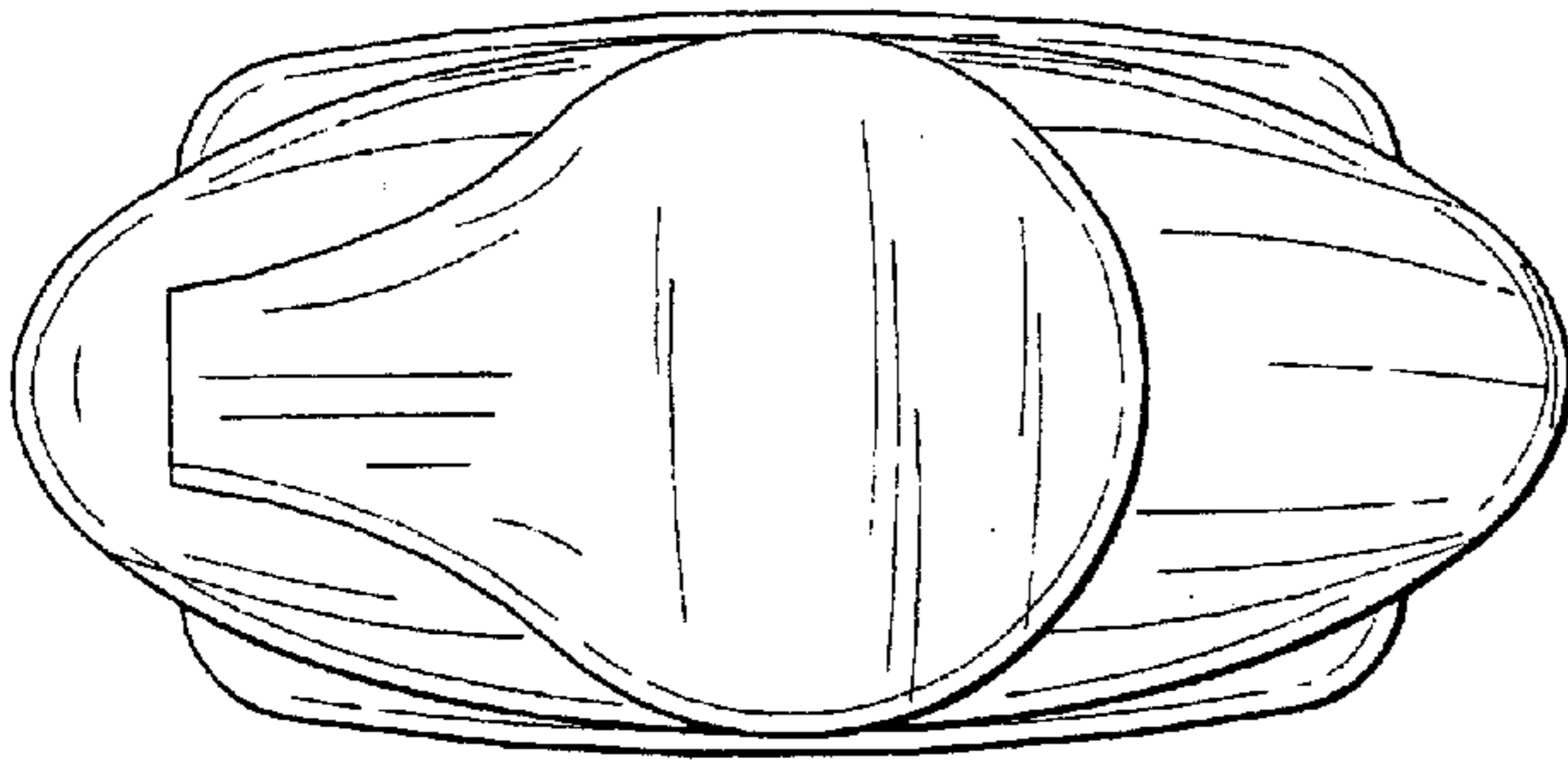

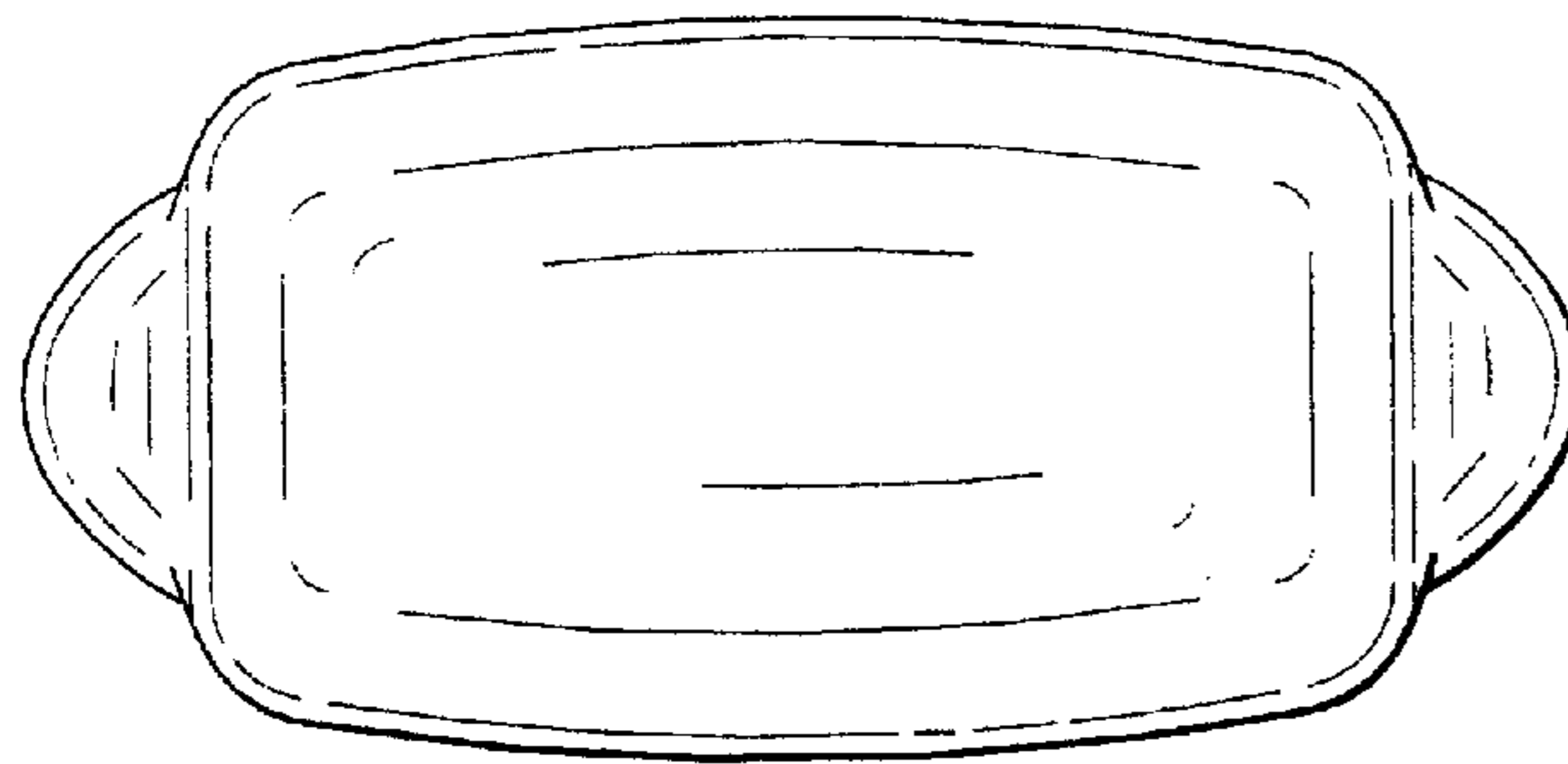

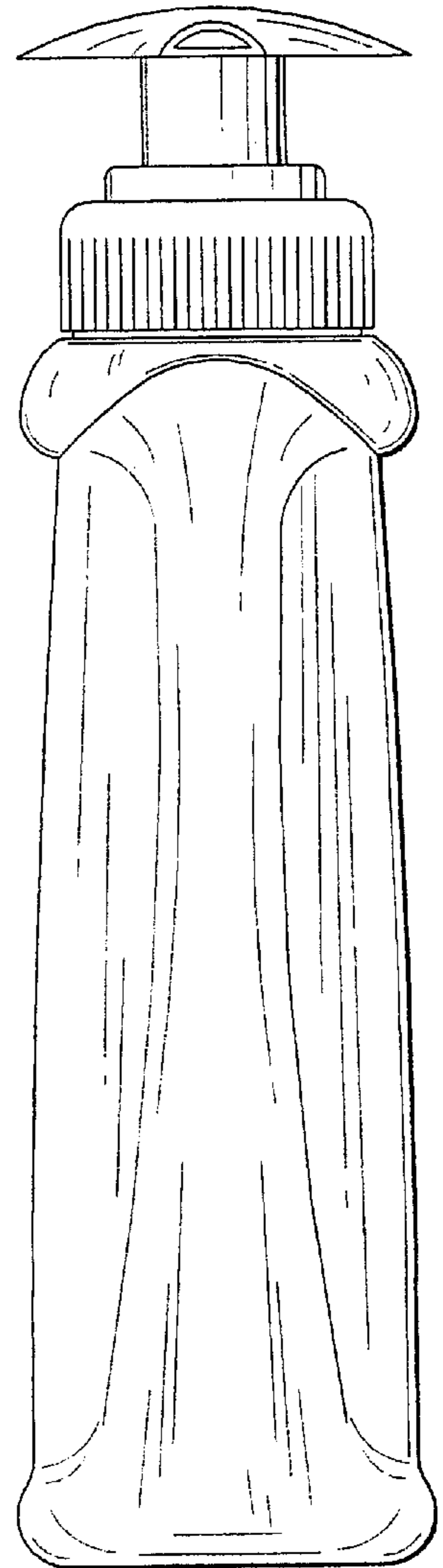
