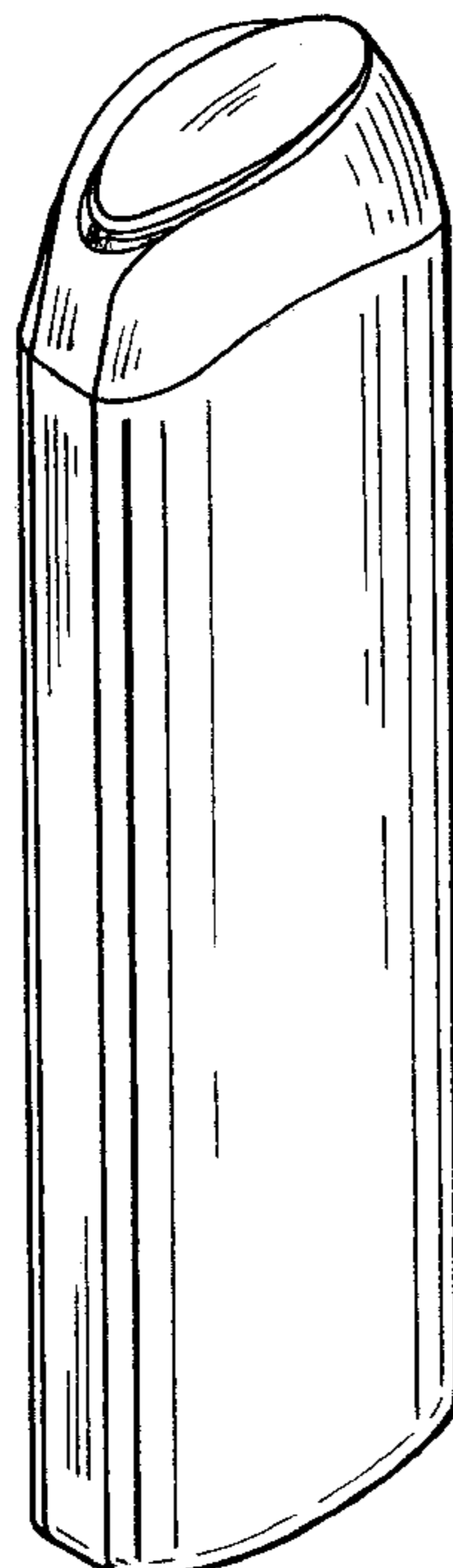
(57) **CLAIM**

I claim the ornamental design for a container with cap, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the front, right side, and top of the container with cap comprising the present invention; FIG. 2 is a perspective view of the rear, left side, and top of the container with cap comprising the present invention; FIG. 3 is a top elevational view of the container with cap shown in FIG. 1 and FIG. 2; FIG. 4 is a bottom elevational view of the container with cap shown in FIG. 1, FIG. 2, and FIG. 3; FIG. 5 is a front elevational view of the container with cap shown in FIG. 1, FIG. 2, FIG. 3, and FIG. 4; FIG. 6 is a rear elevational view of the container with cap shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, and FIG. 5; FIG. 7 is a side elevational view of the container with cap shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, FIG. 5 and FIG. 6; and, FIG. 8 is another side elevational view of the container with cap shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, FIG. 5, FIG. 6, and FIG. 7.

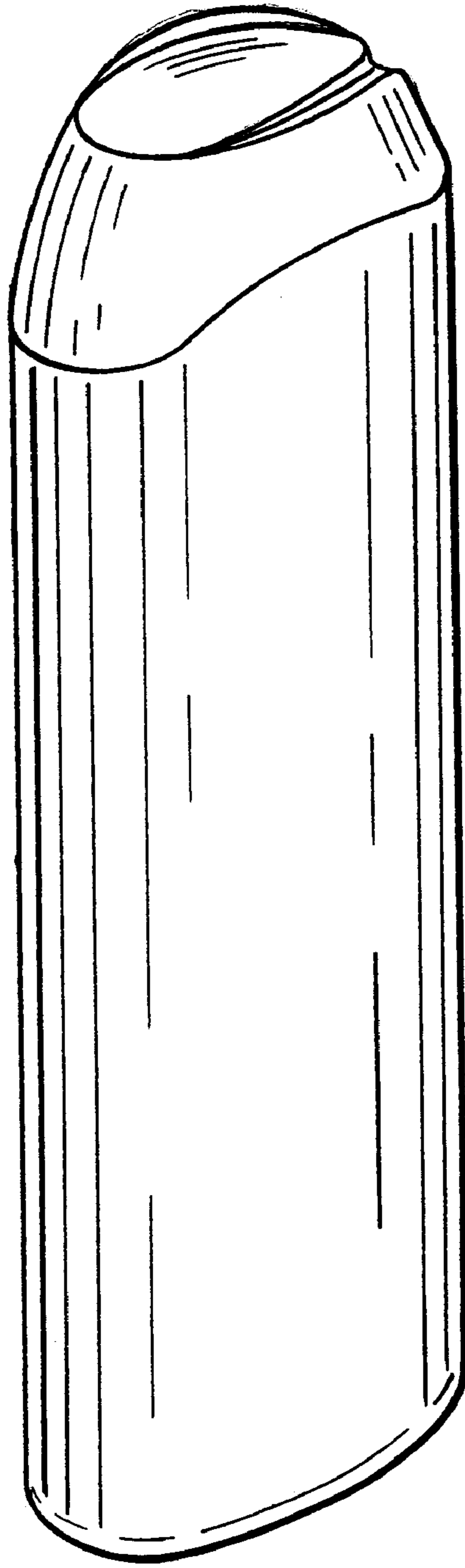

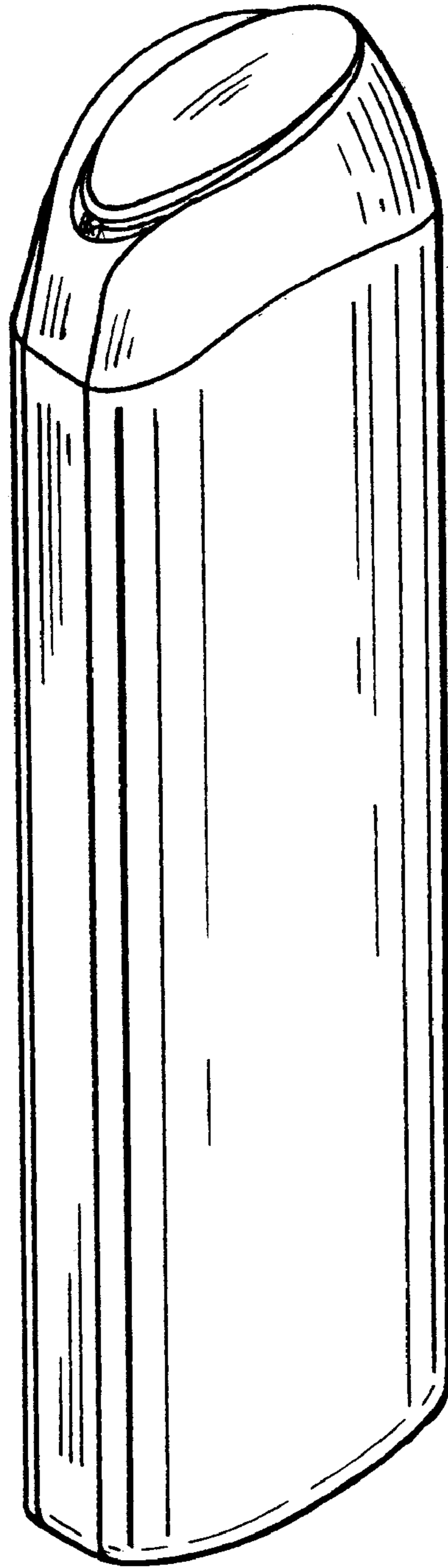

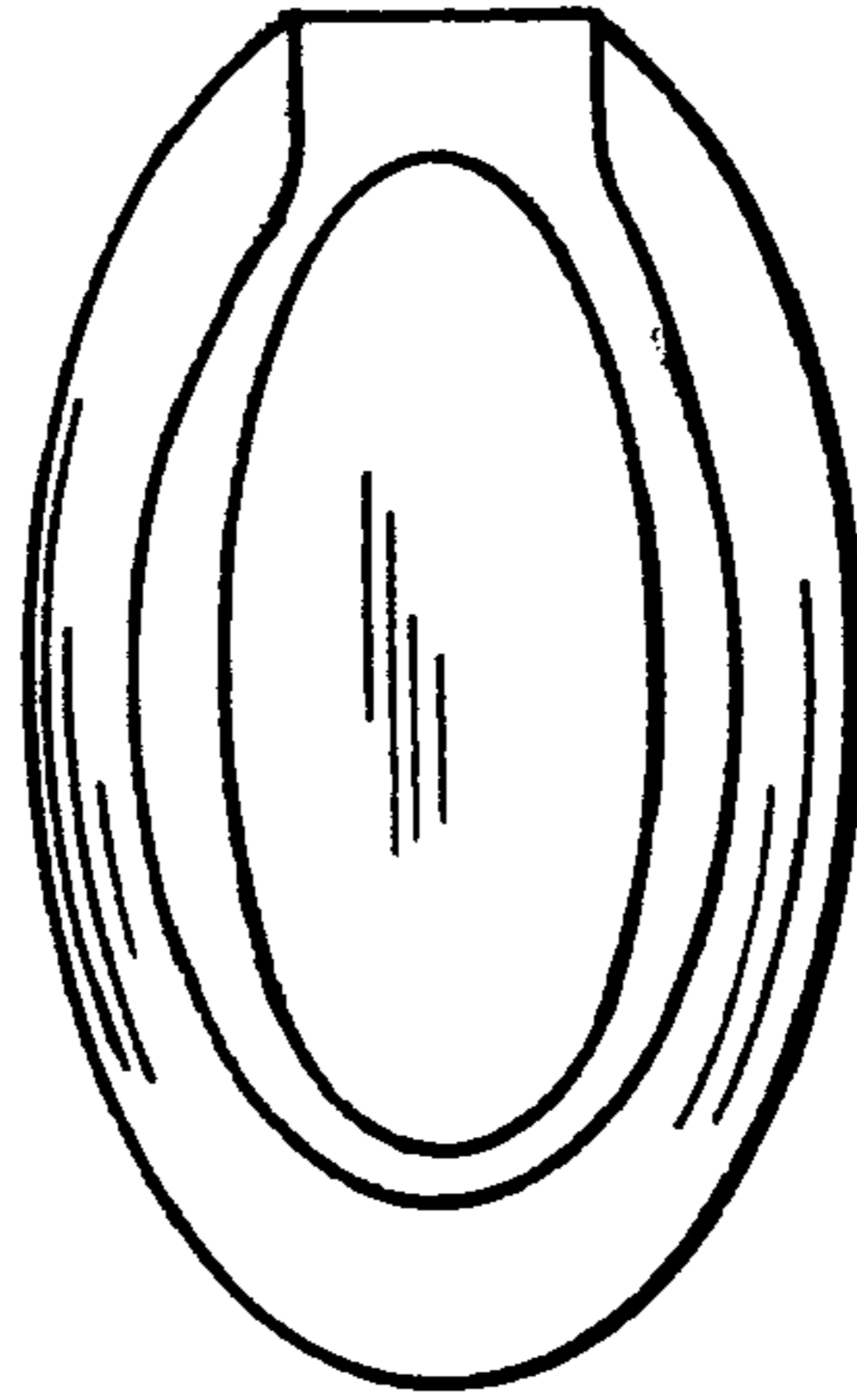

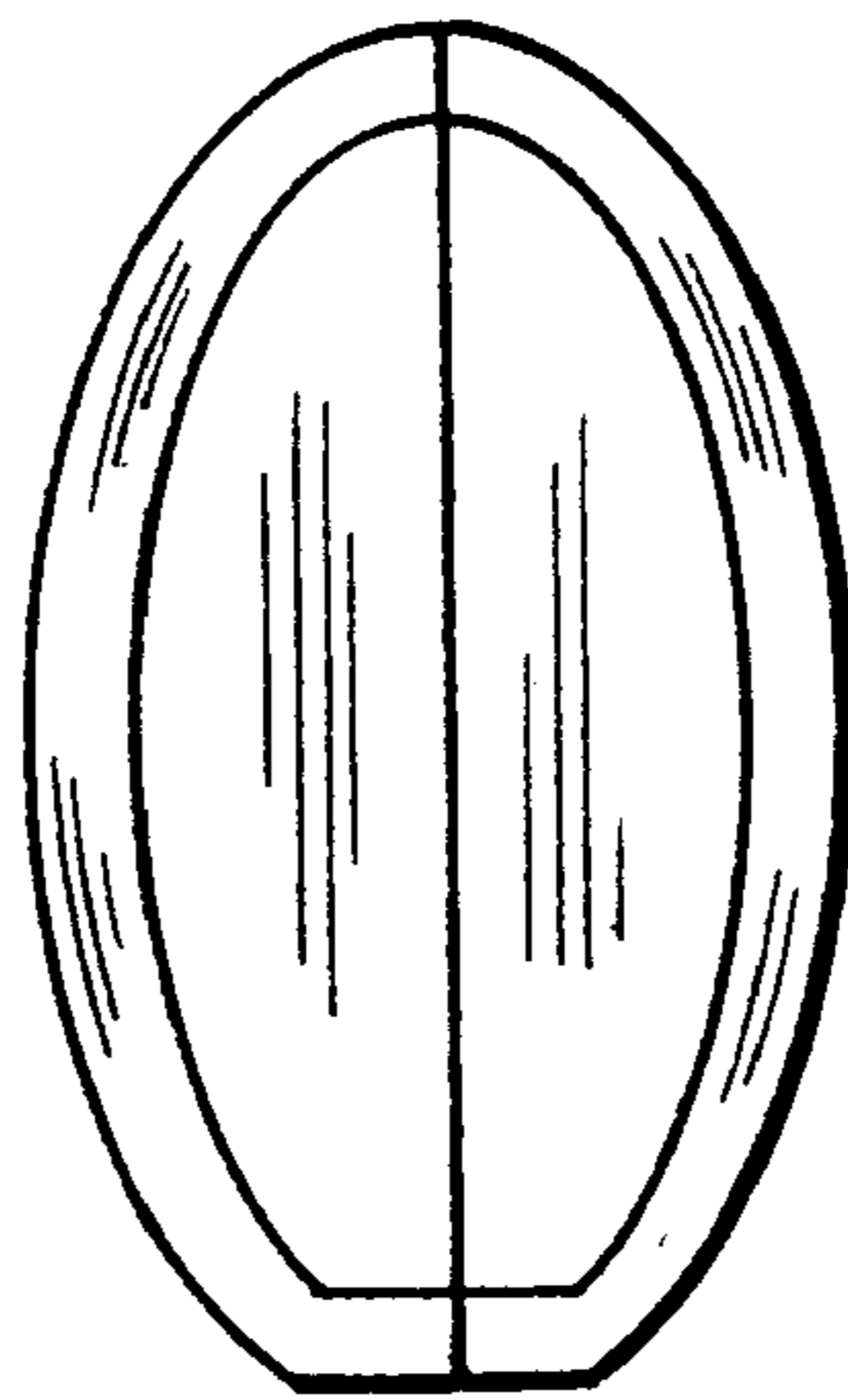

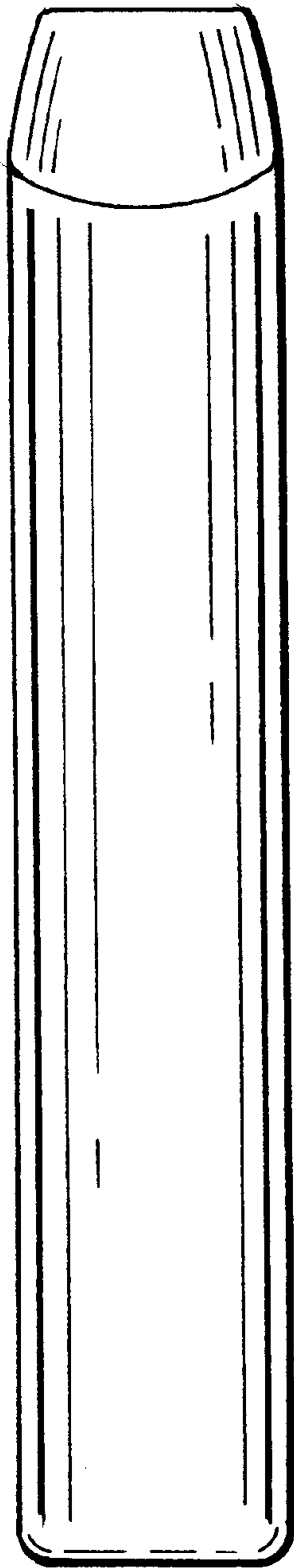

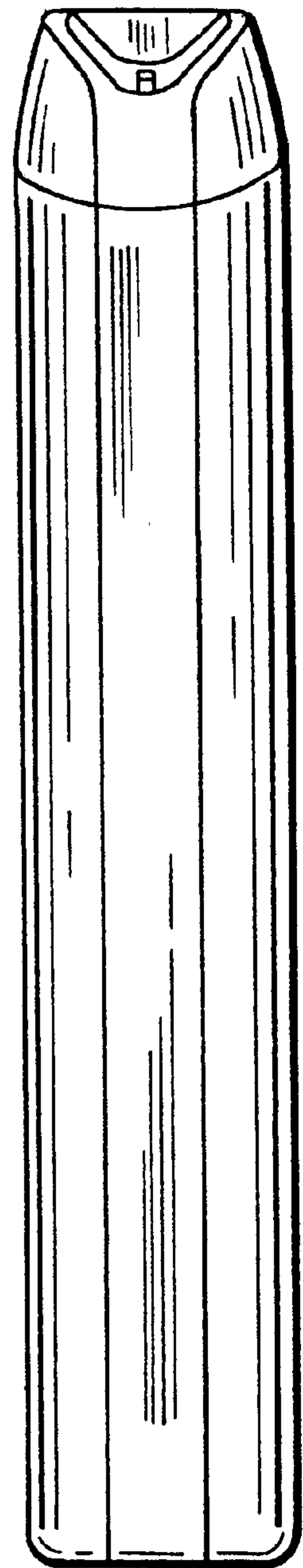

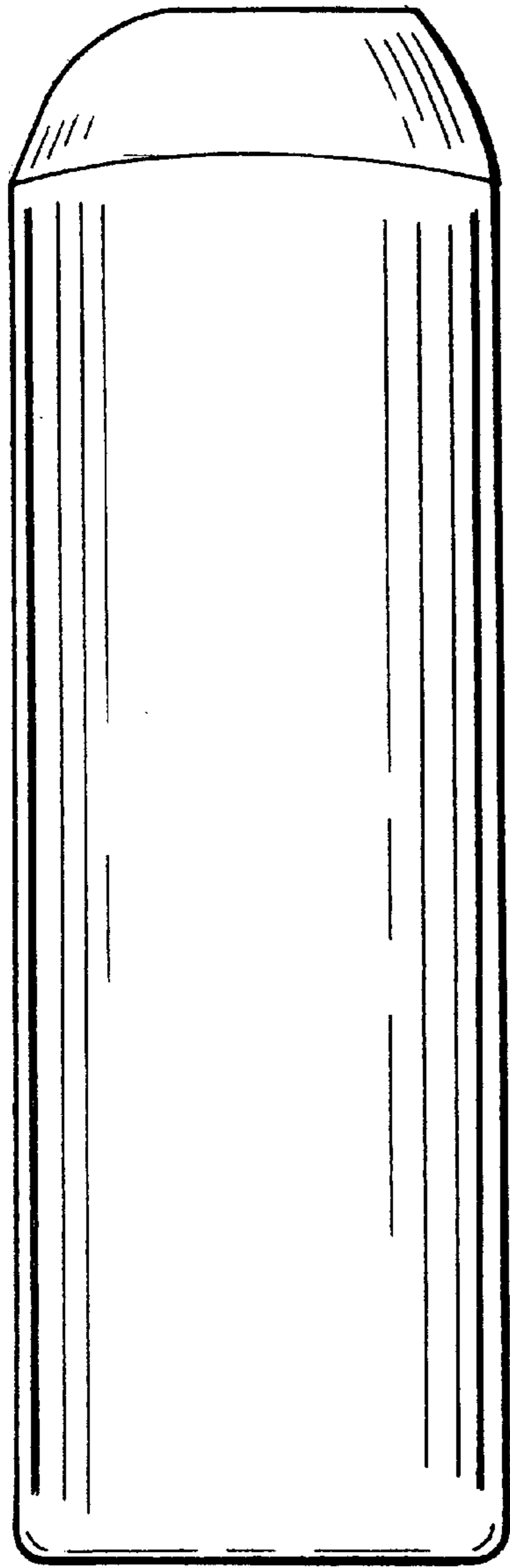

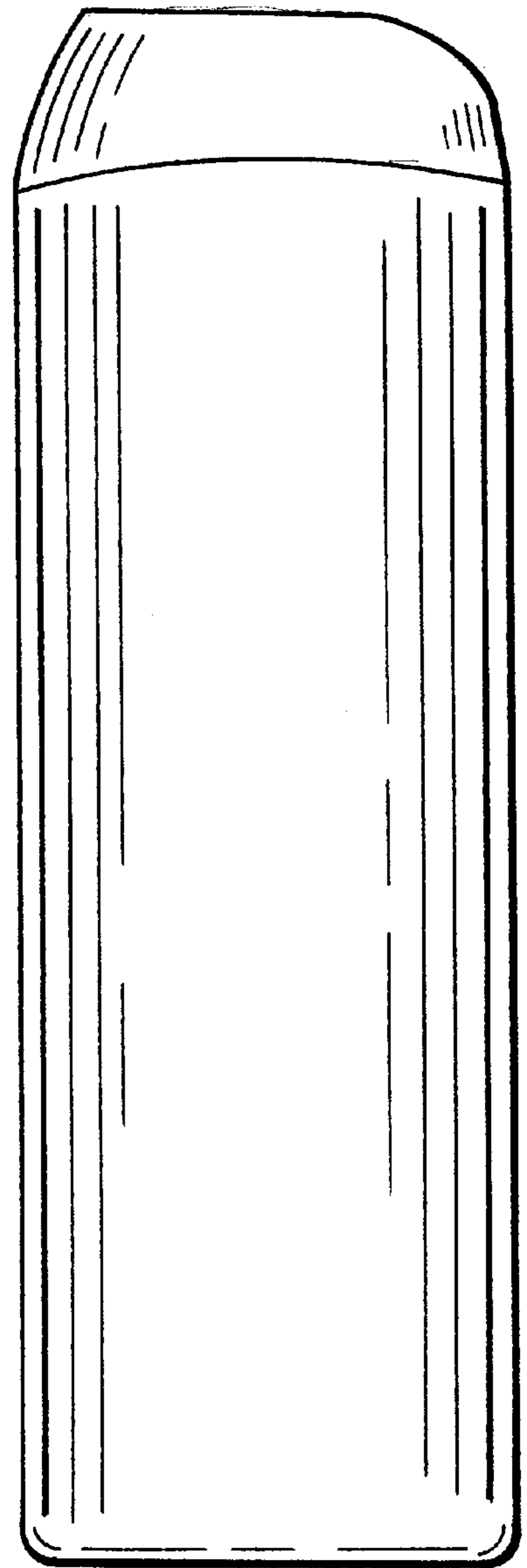
