(57) **CLAIM**

I claim the ornamental design for a glass pendant, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a glass pendant according to the present invention;
 FIG. 2 is a front elevation view of the glass pendant of FIG. 1;
 FIG. 3 is a left side elevational view of the glass pendant of FIG. 1;
 FIG. 4 is a bottom plan view of the glass pendant of FIG. 1;

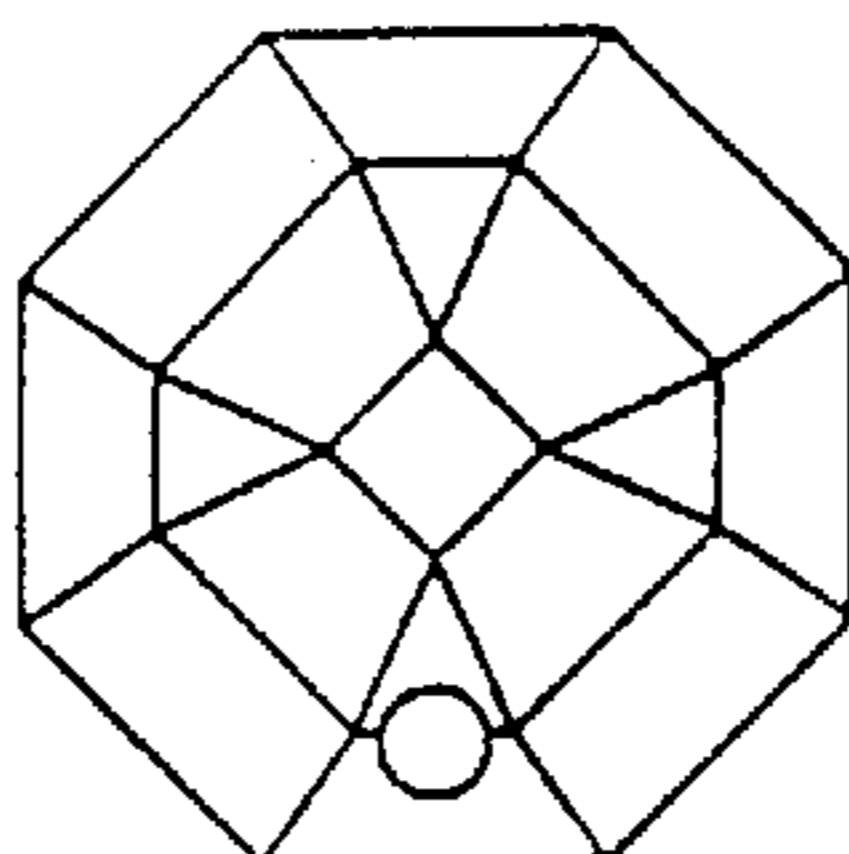

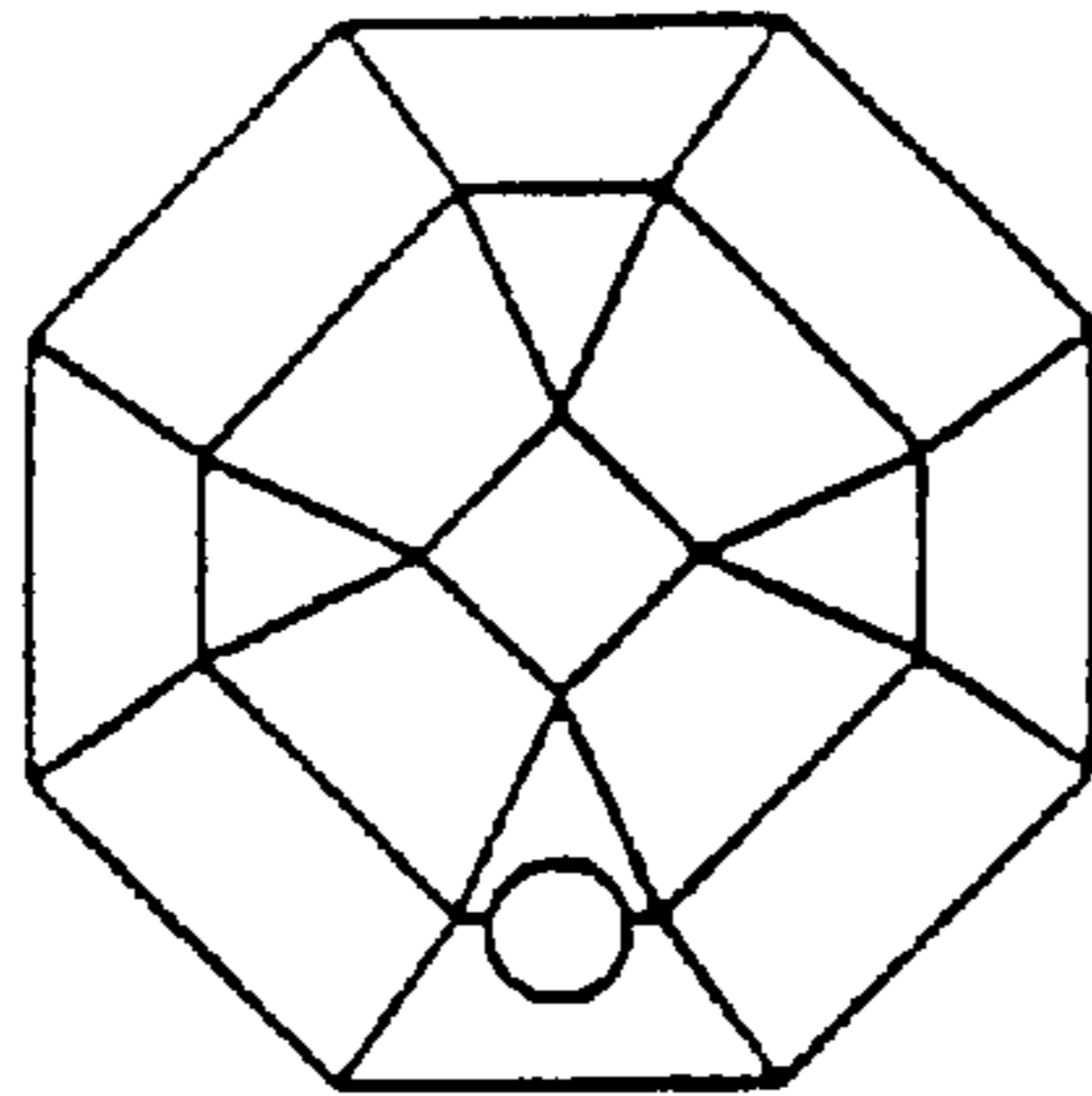

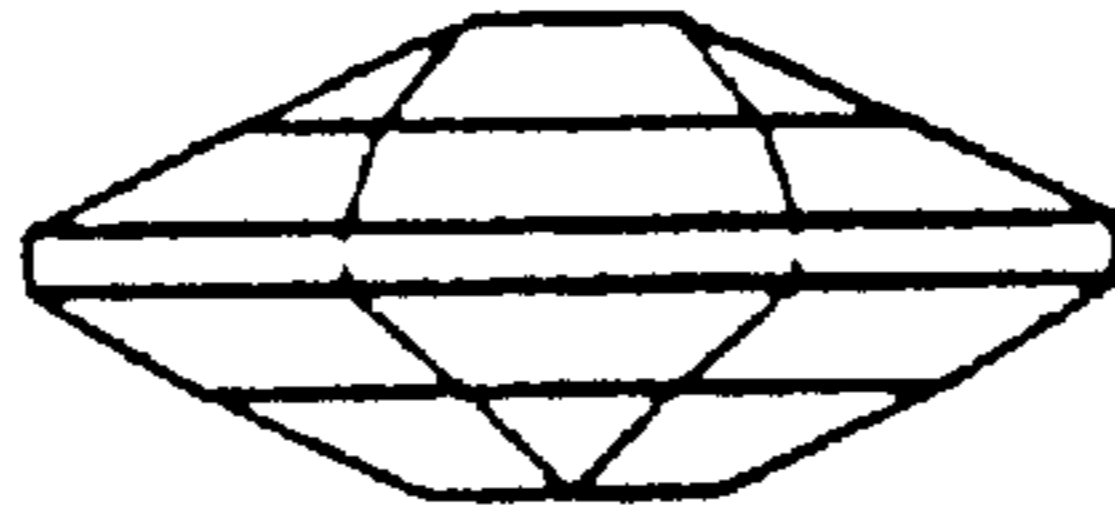

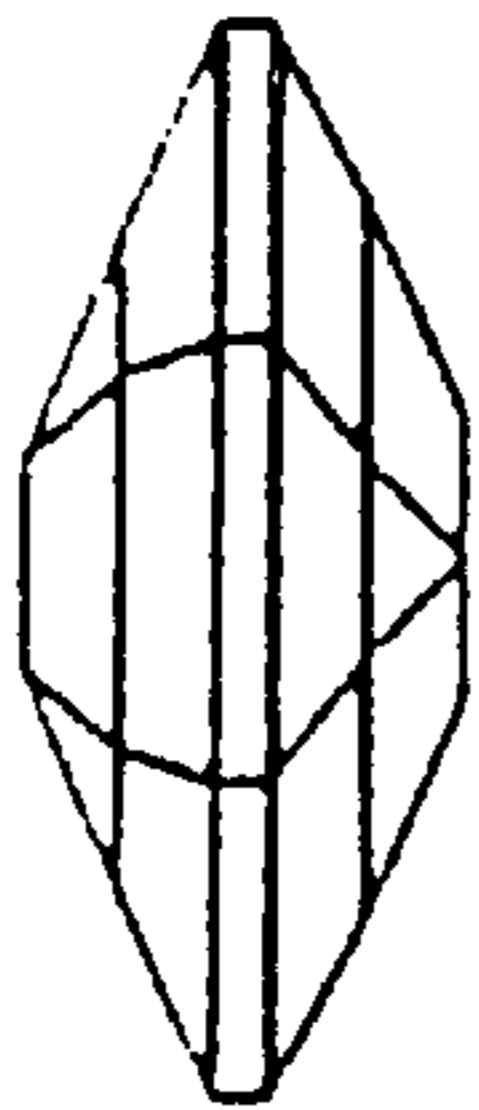

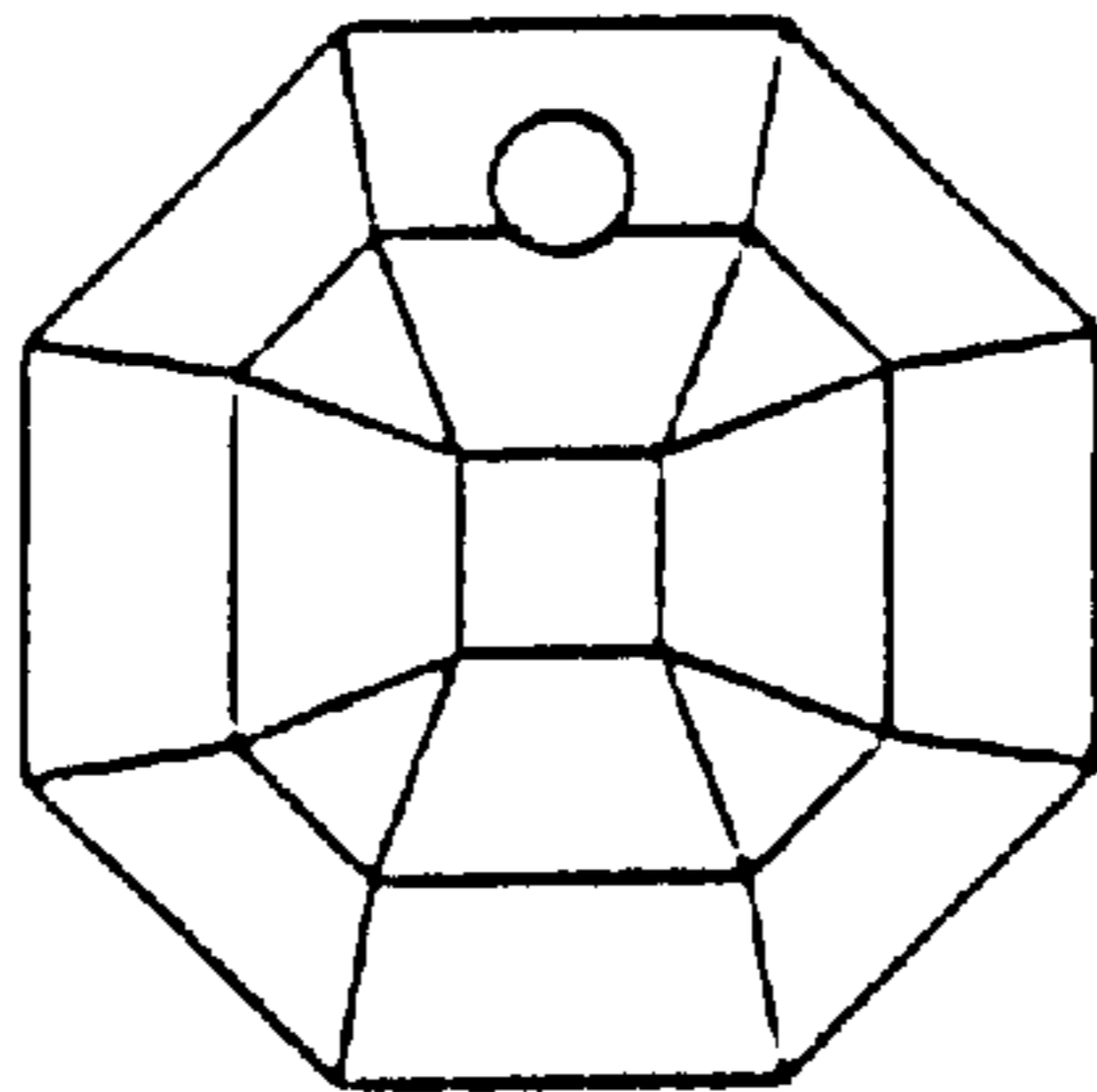

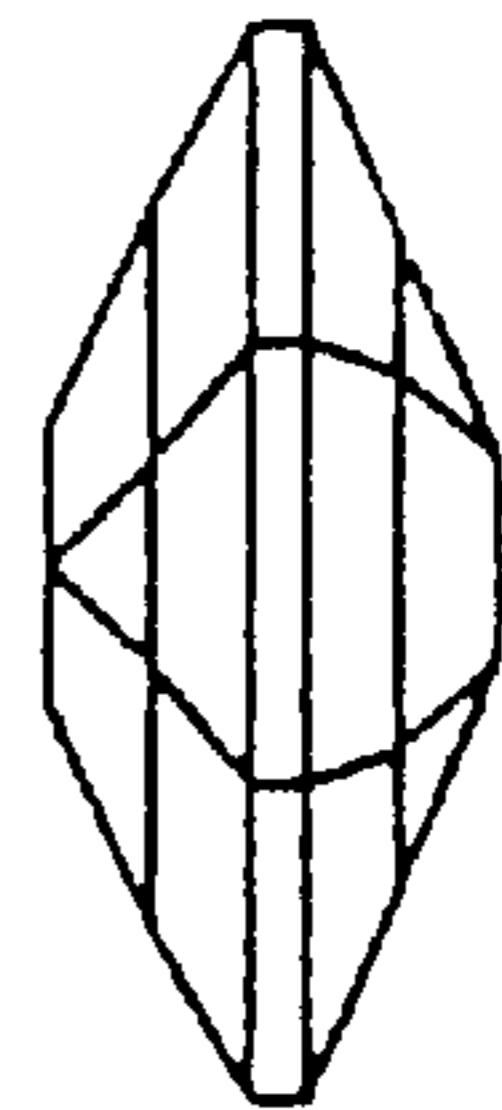

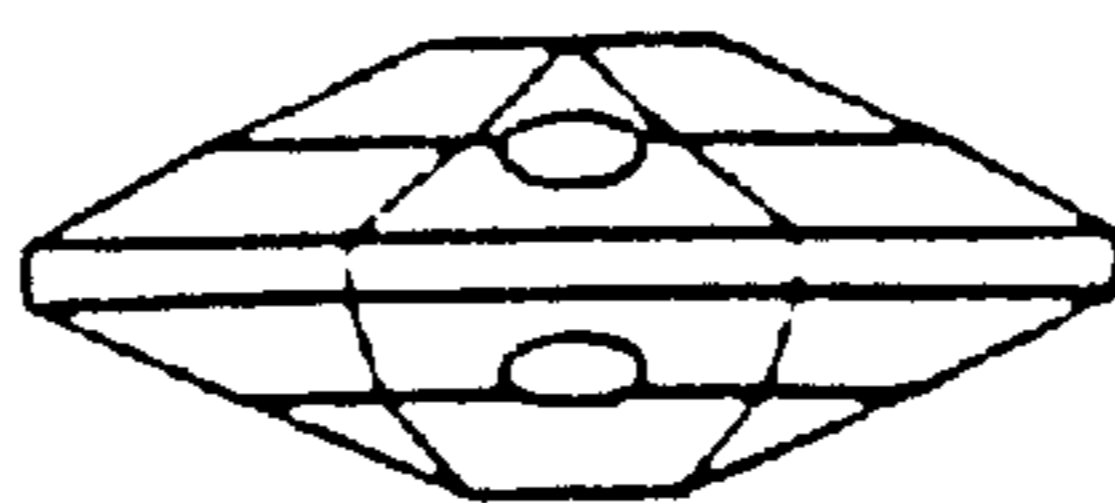

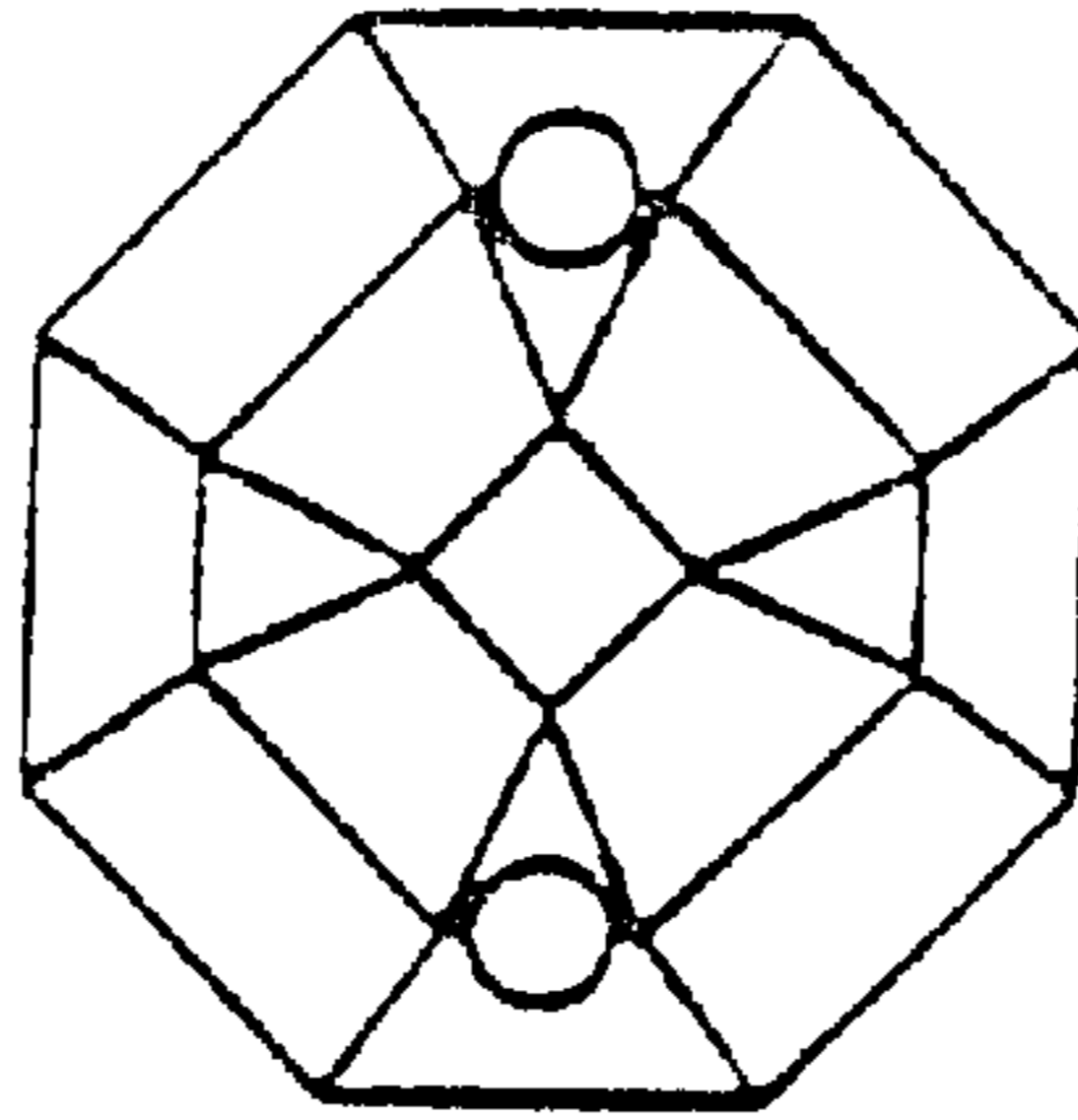

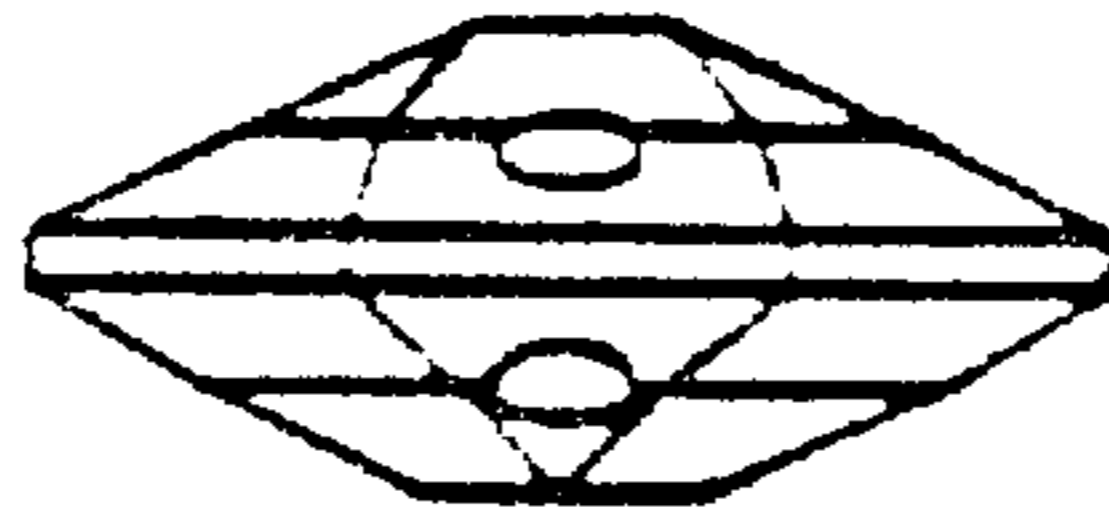

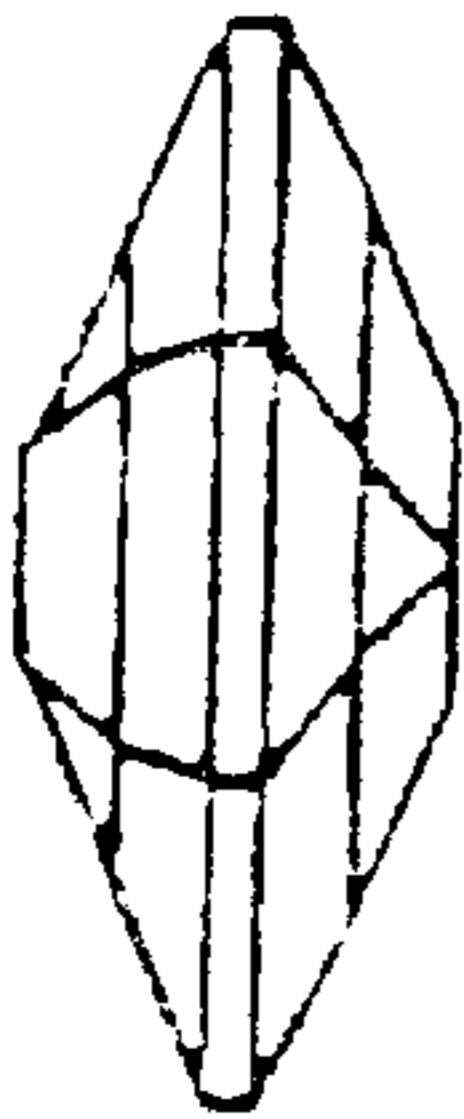

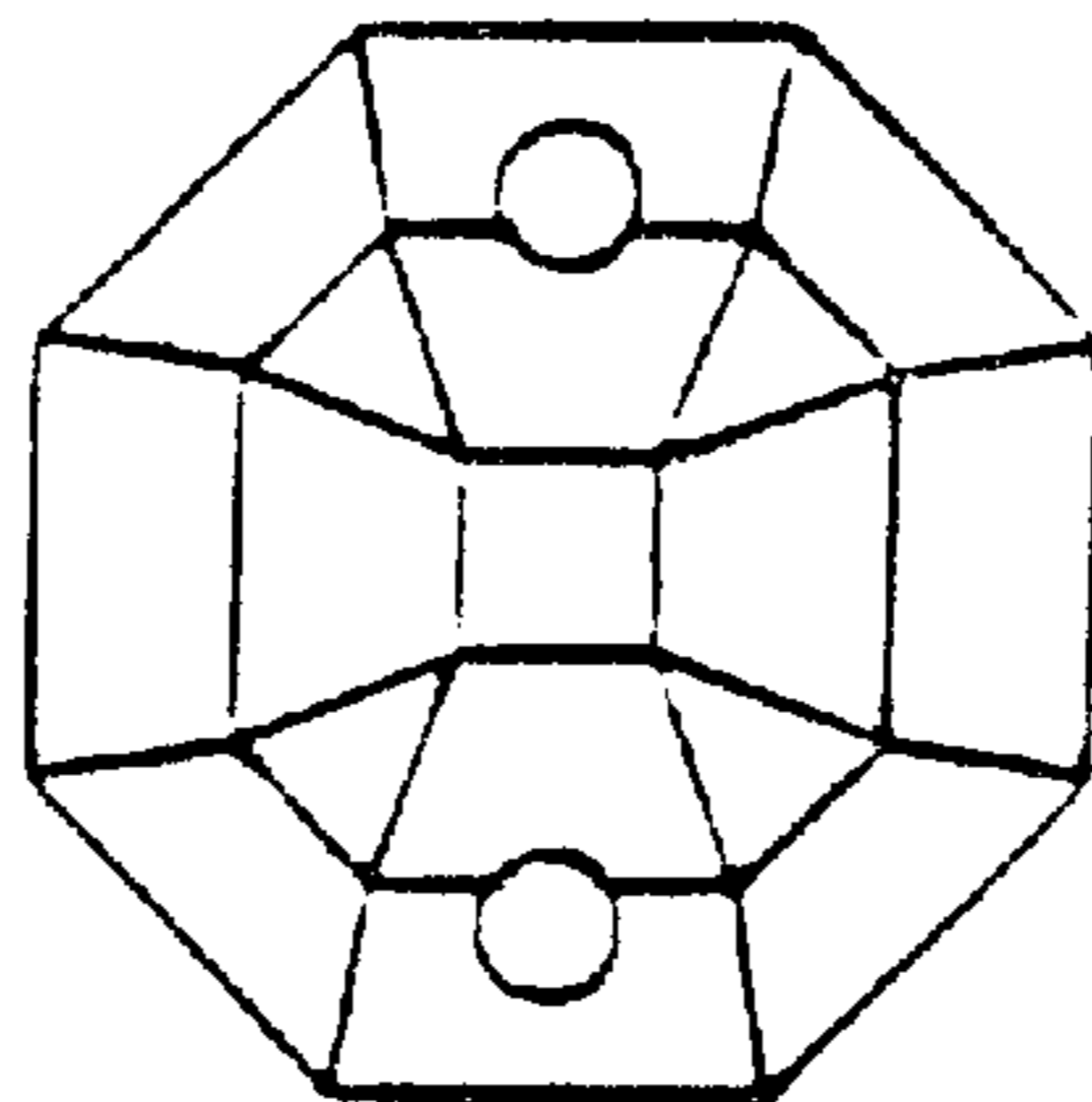

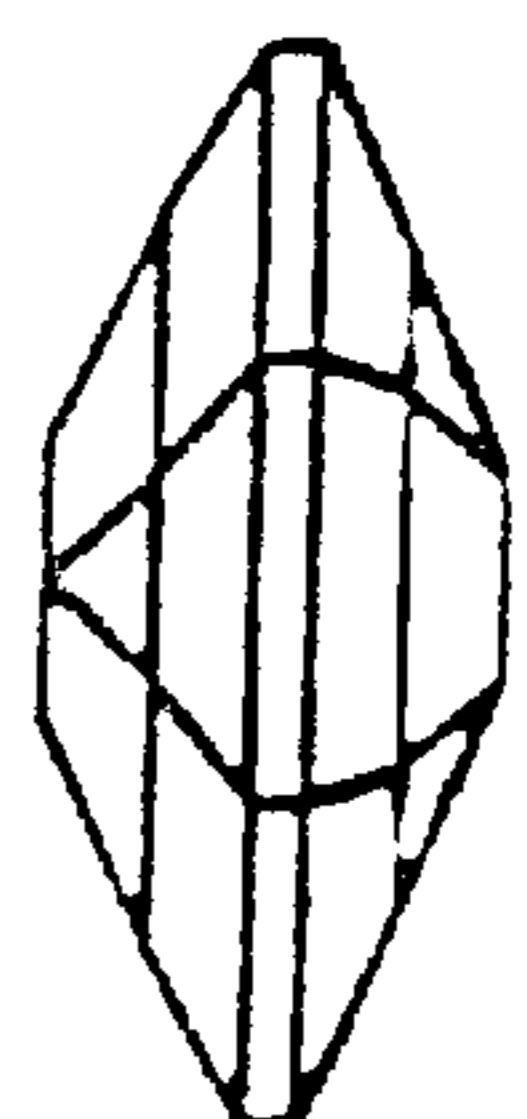

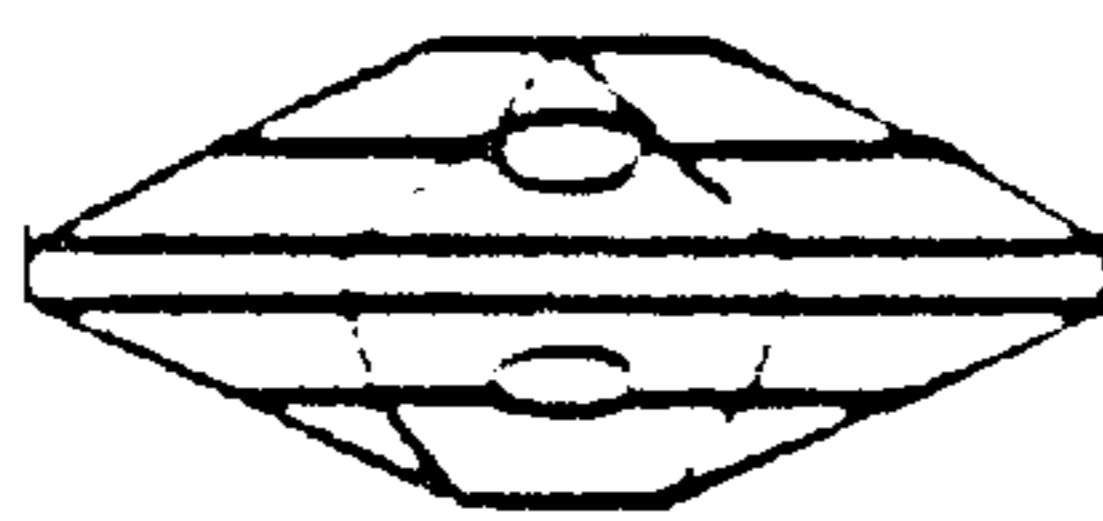

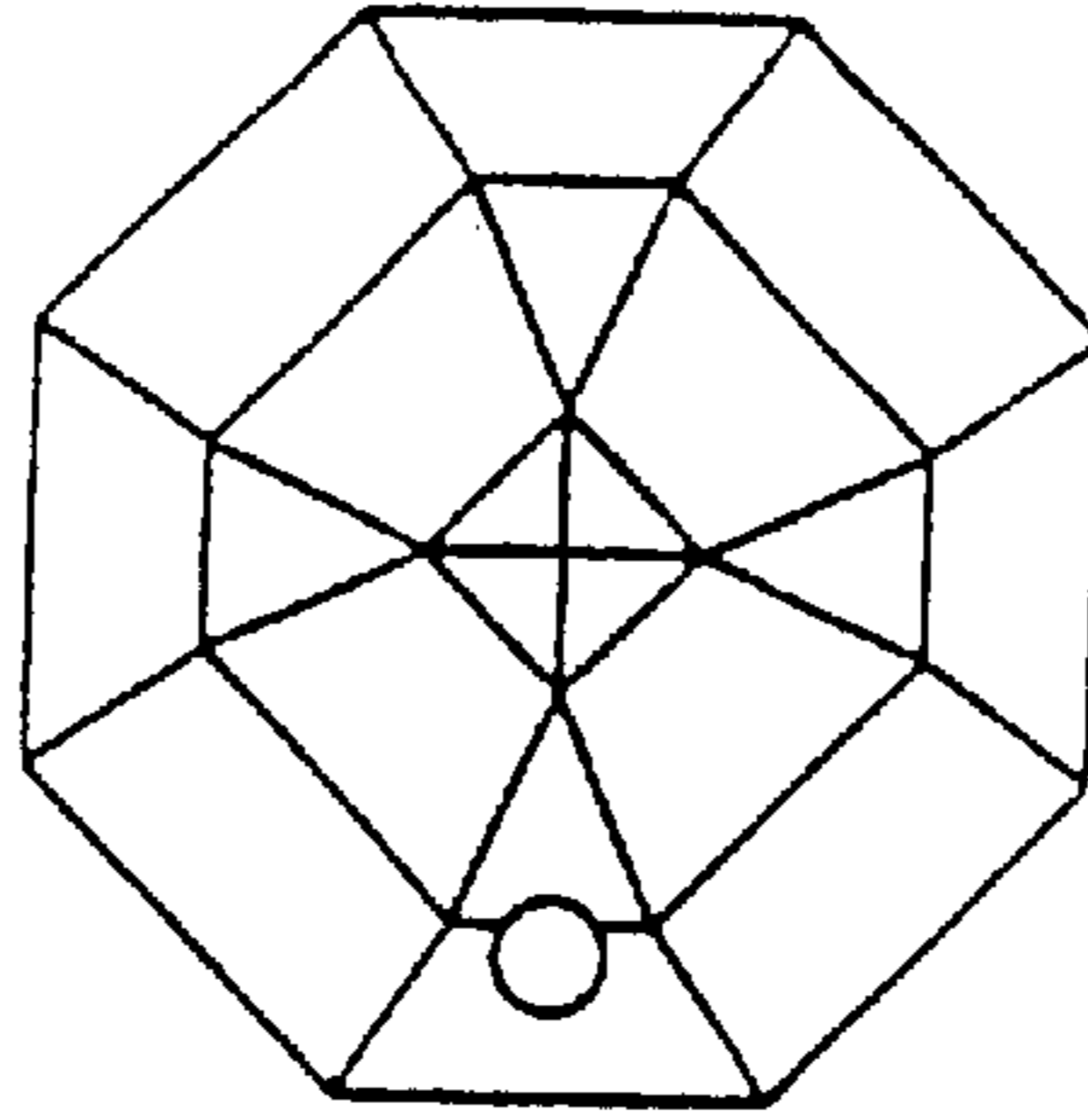

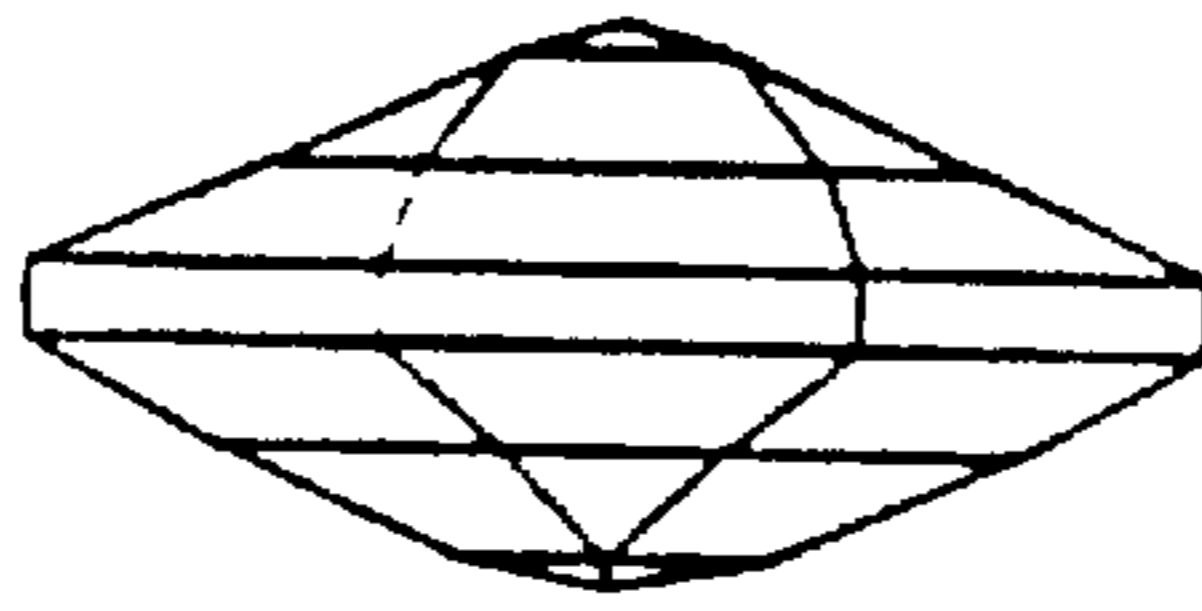

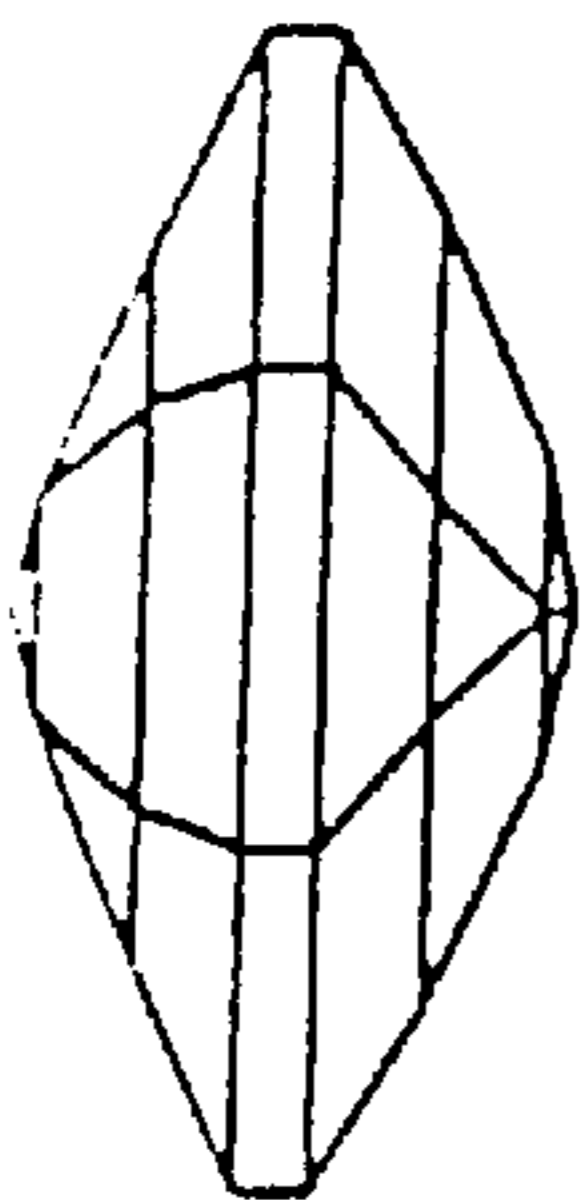

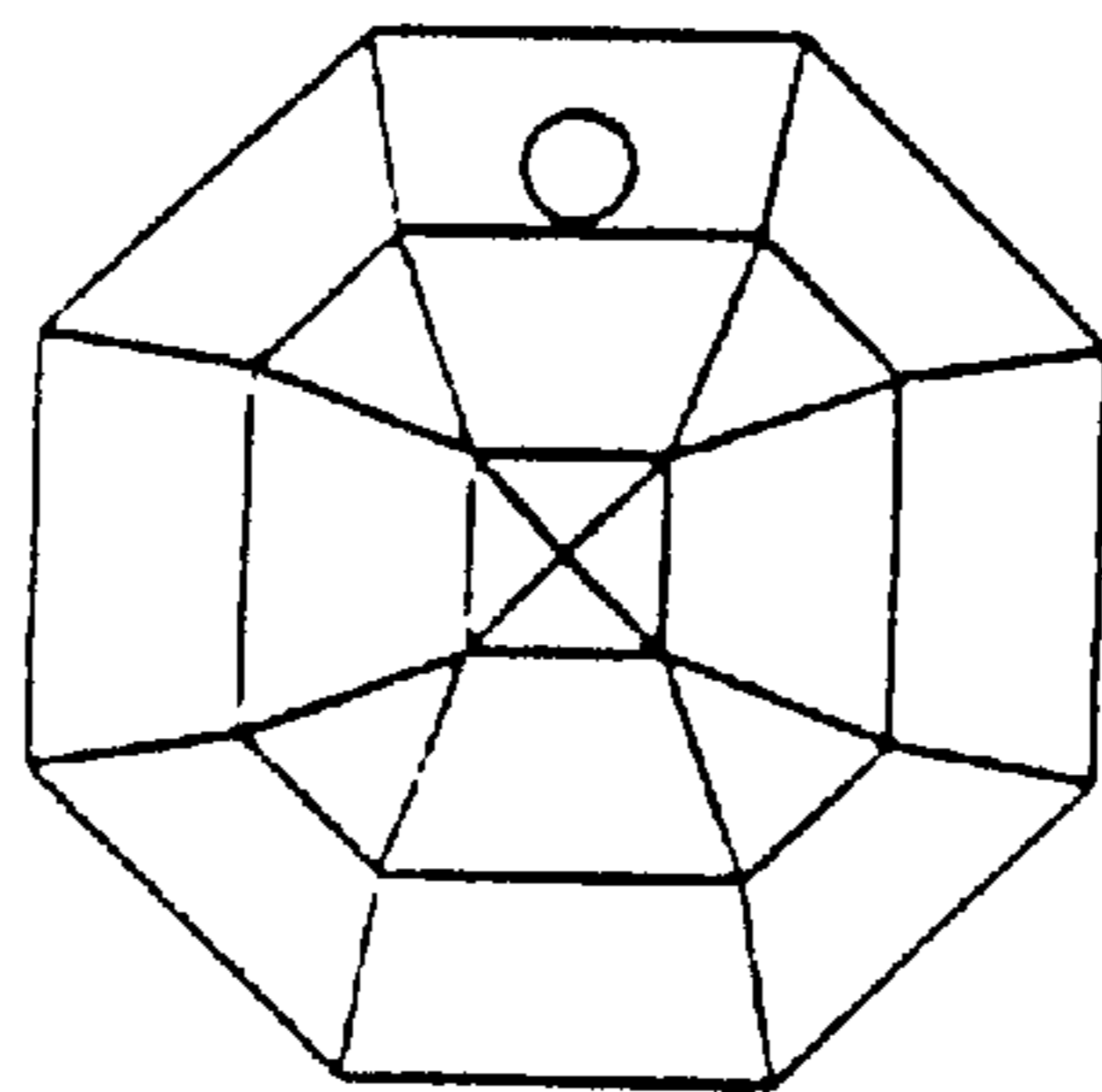

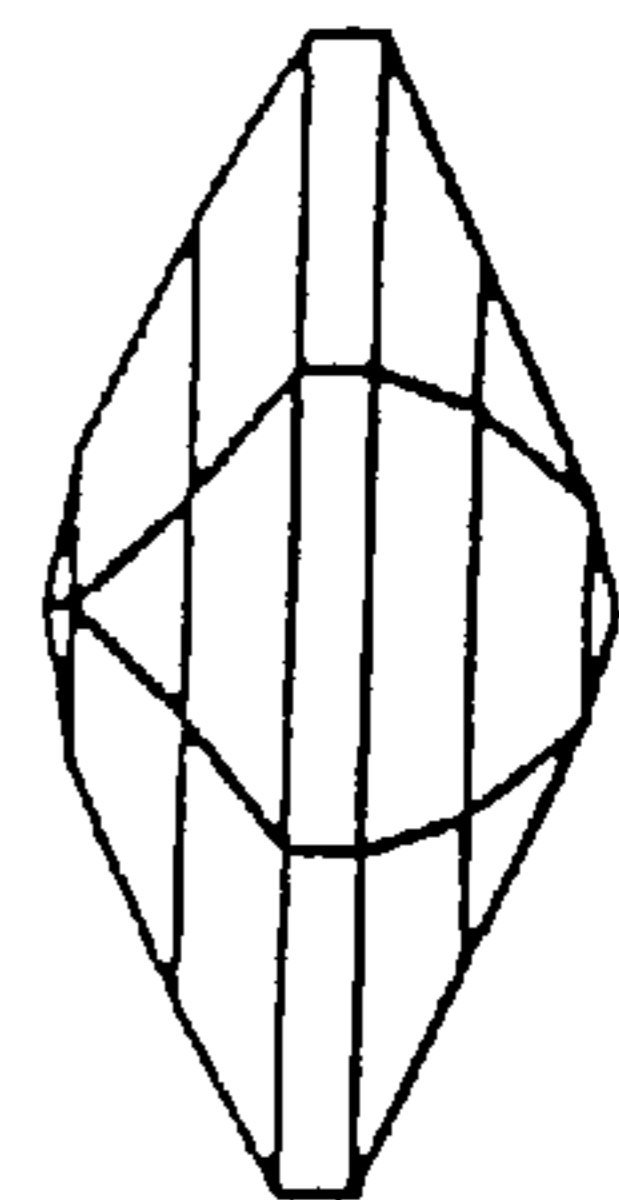

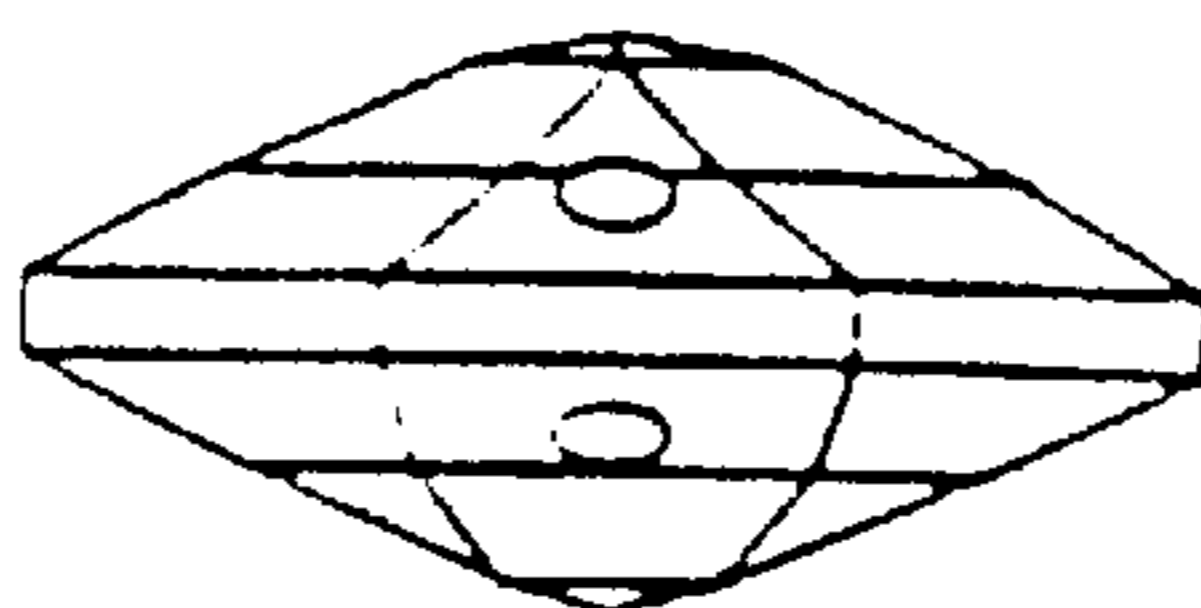

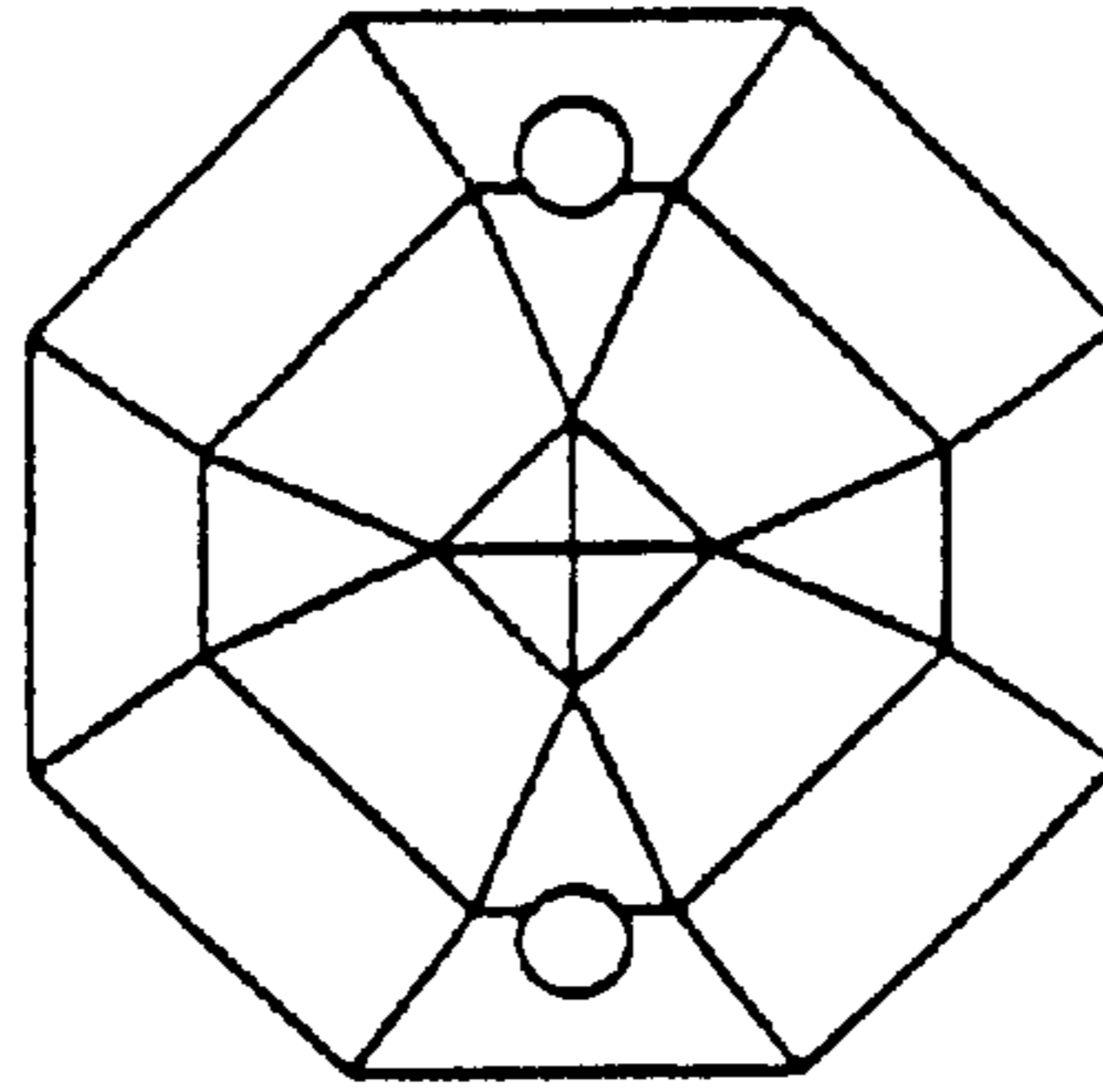

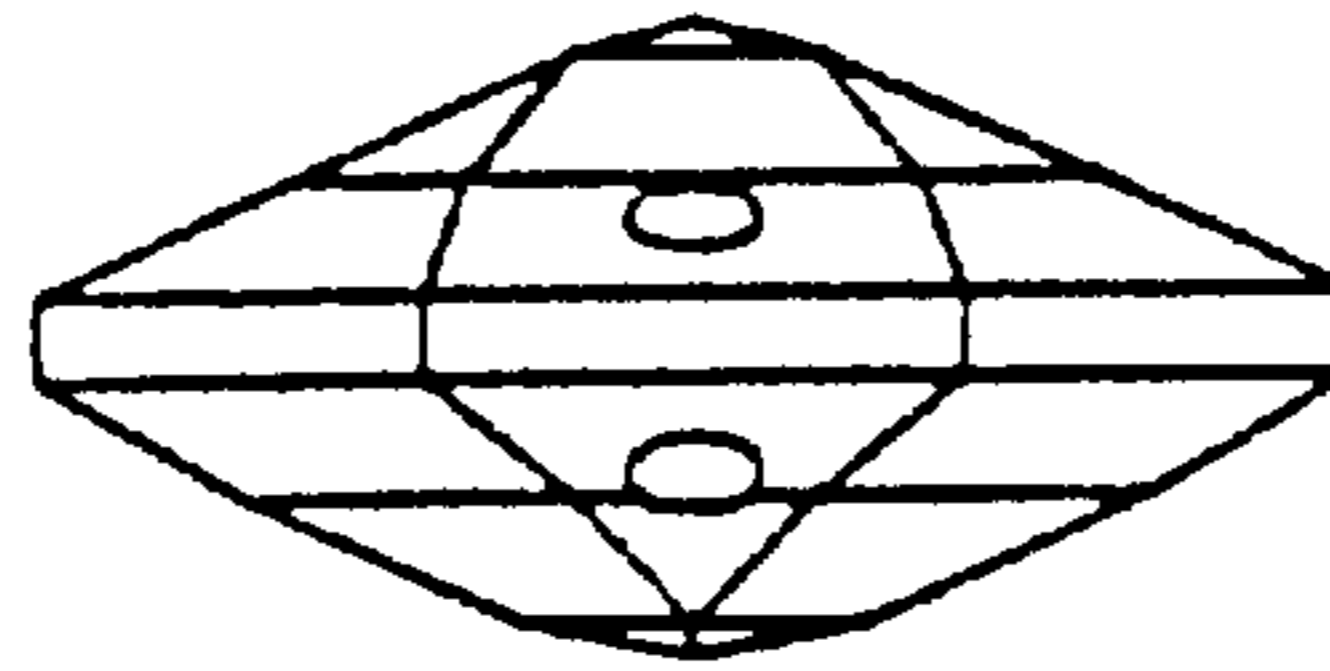

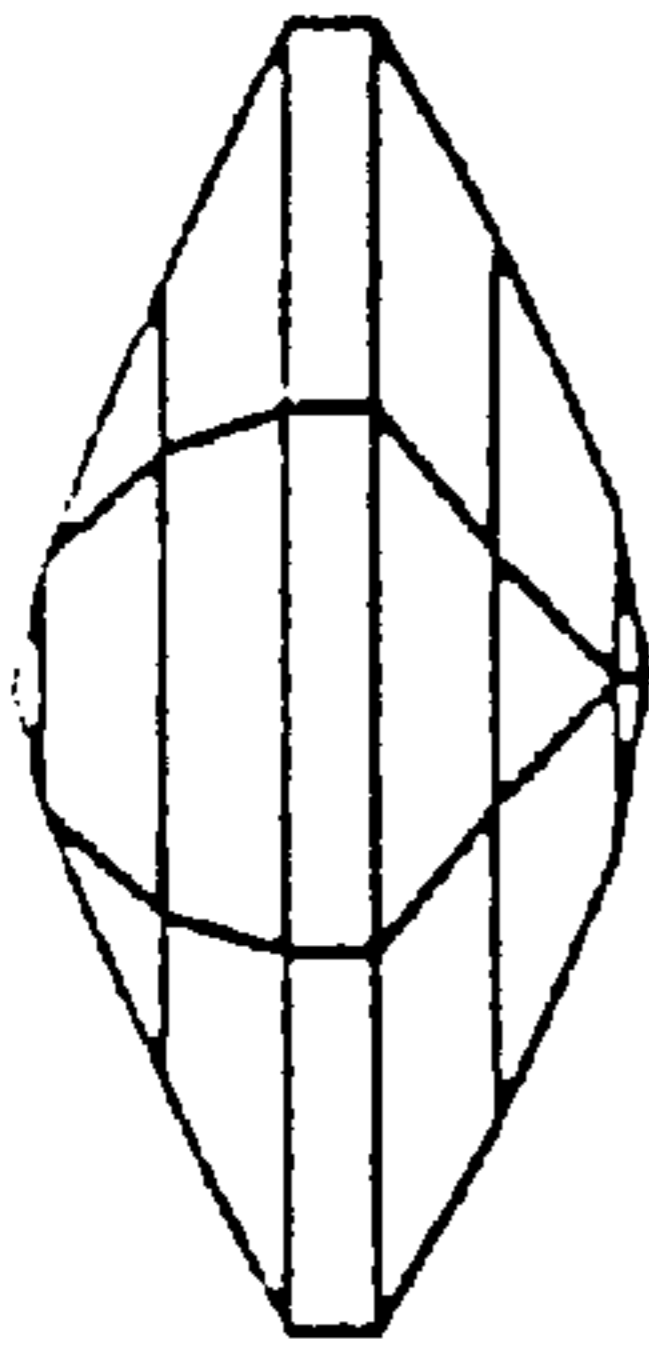

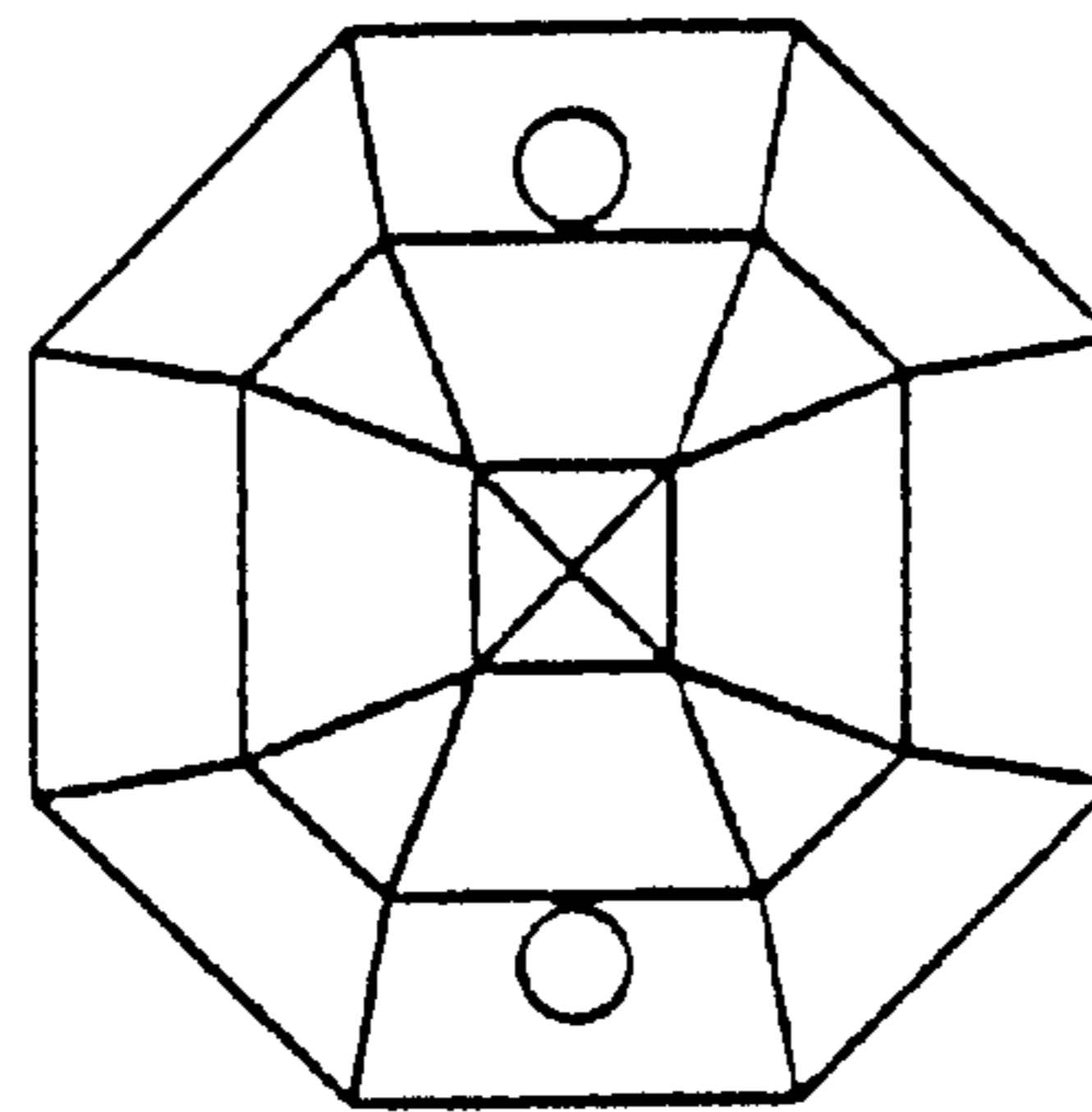

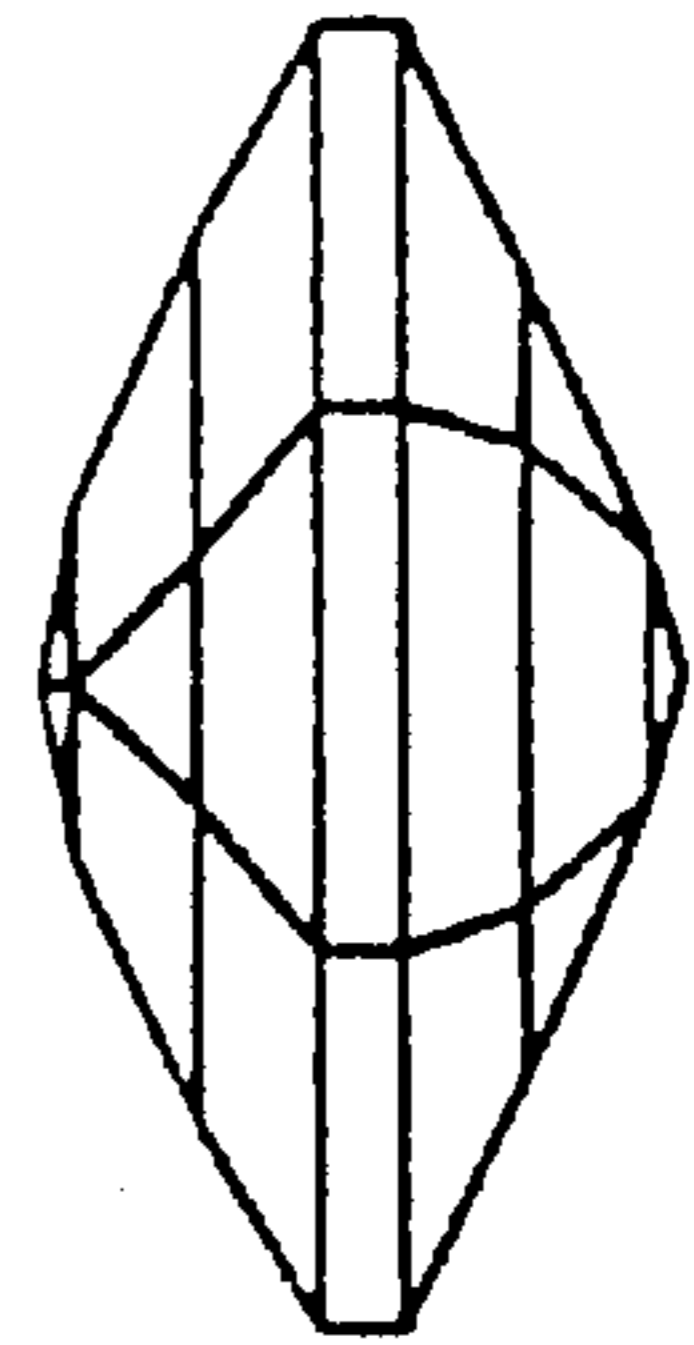

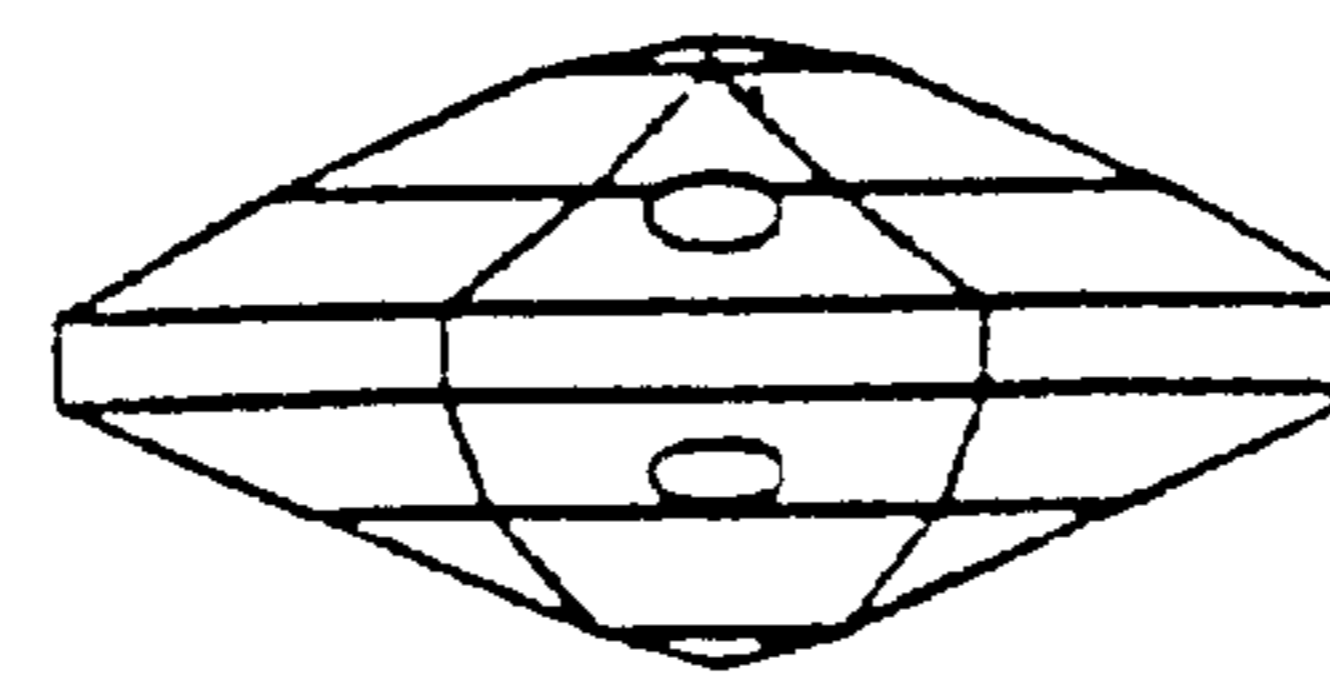

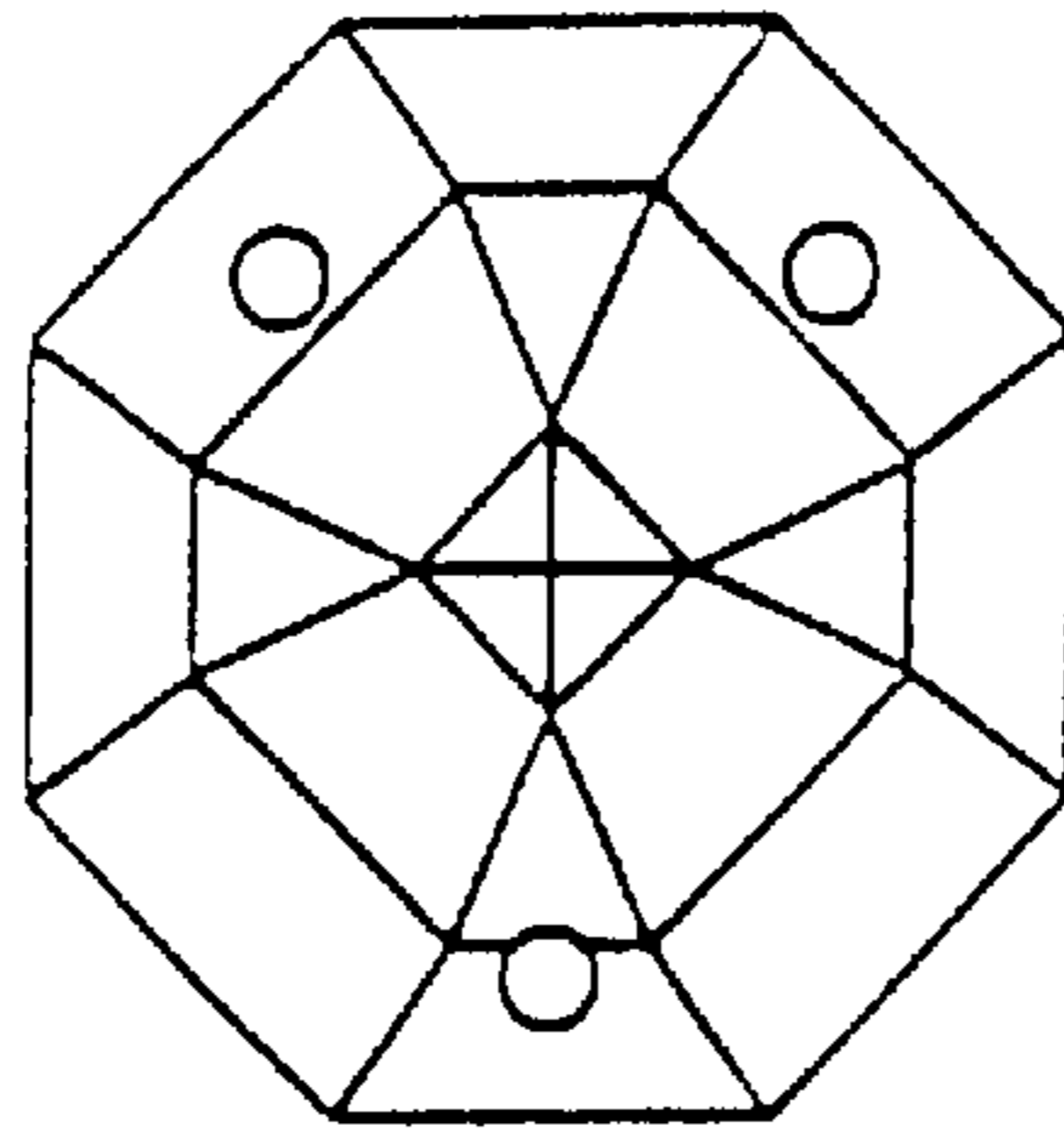

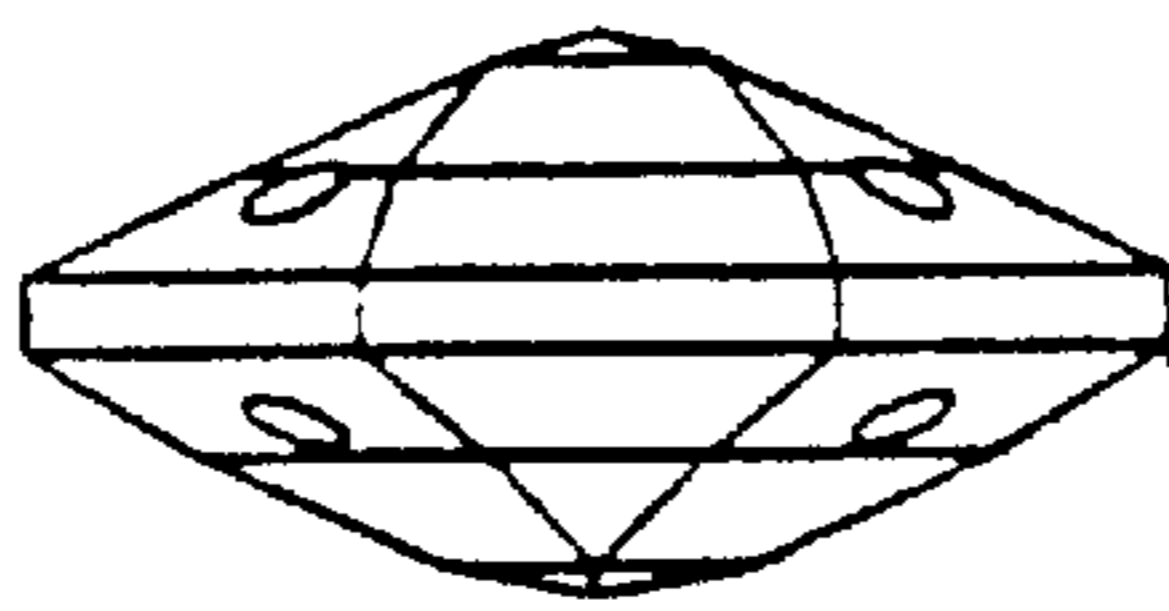

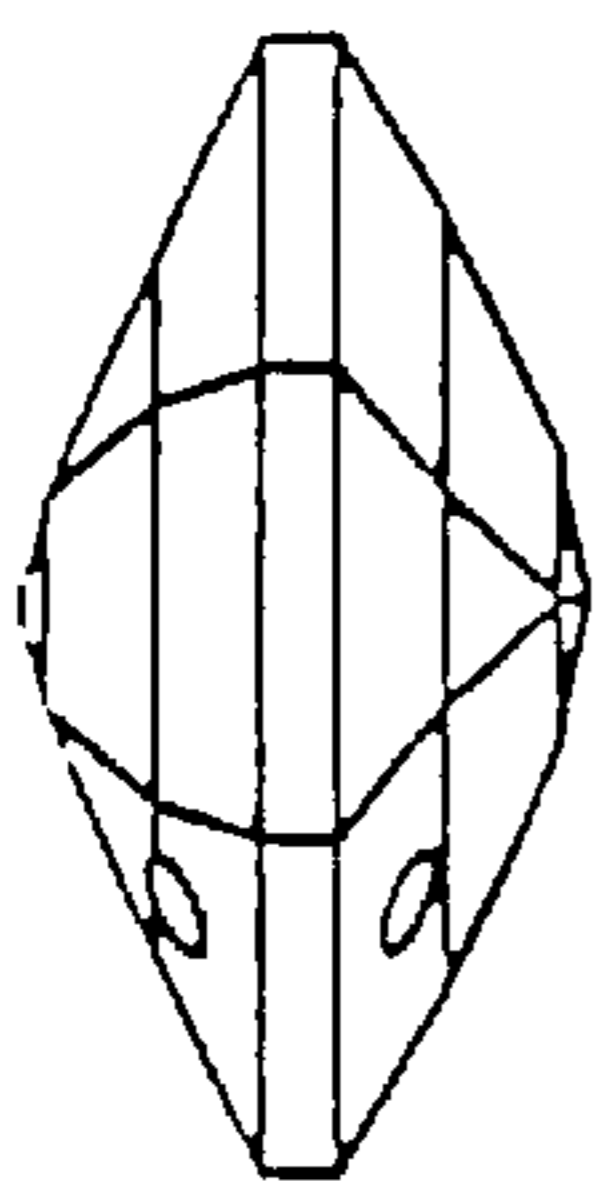

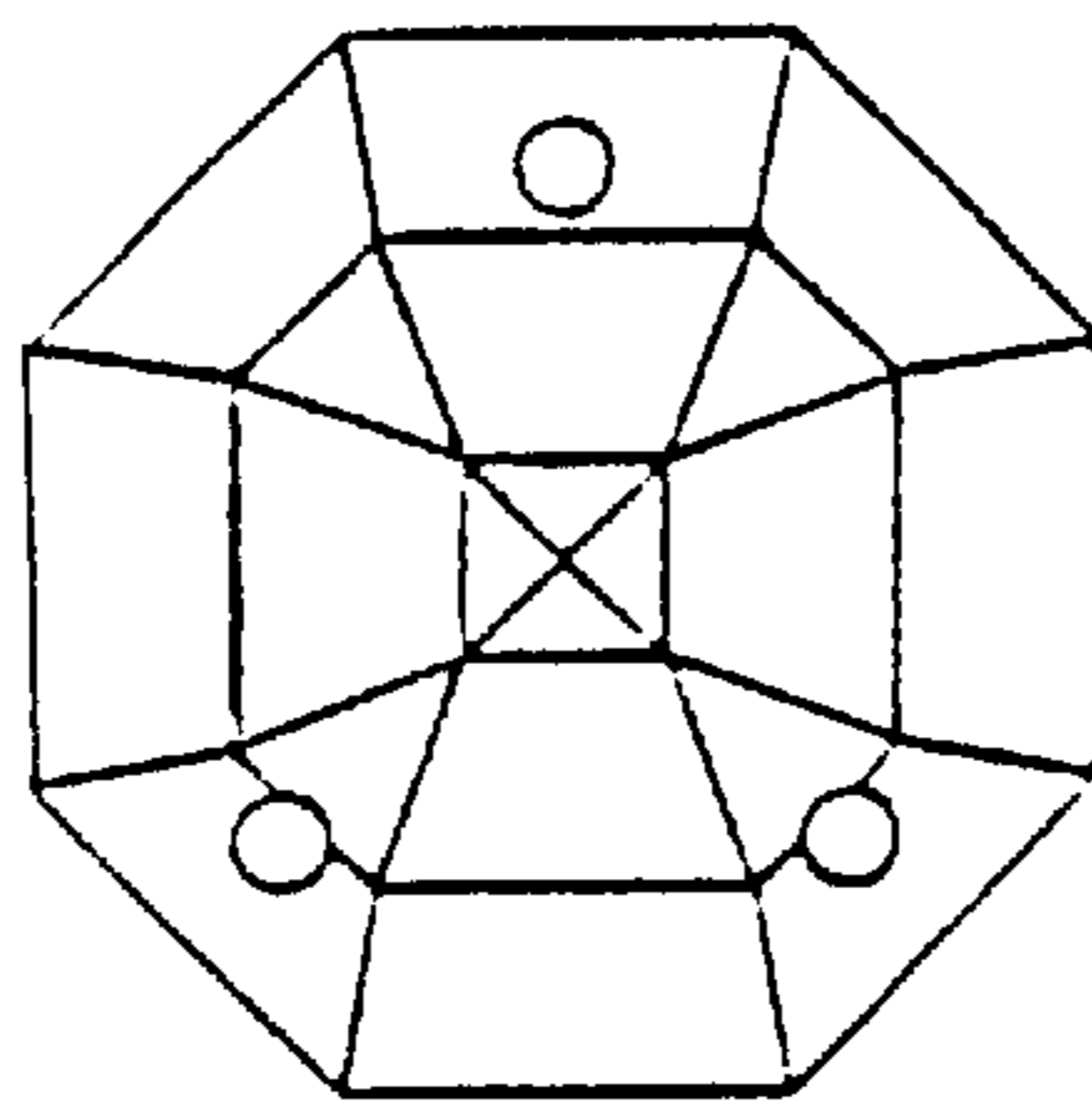

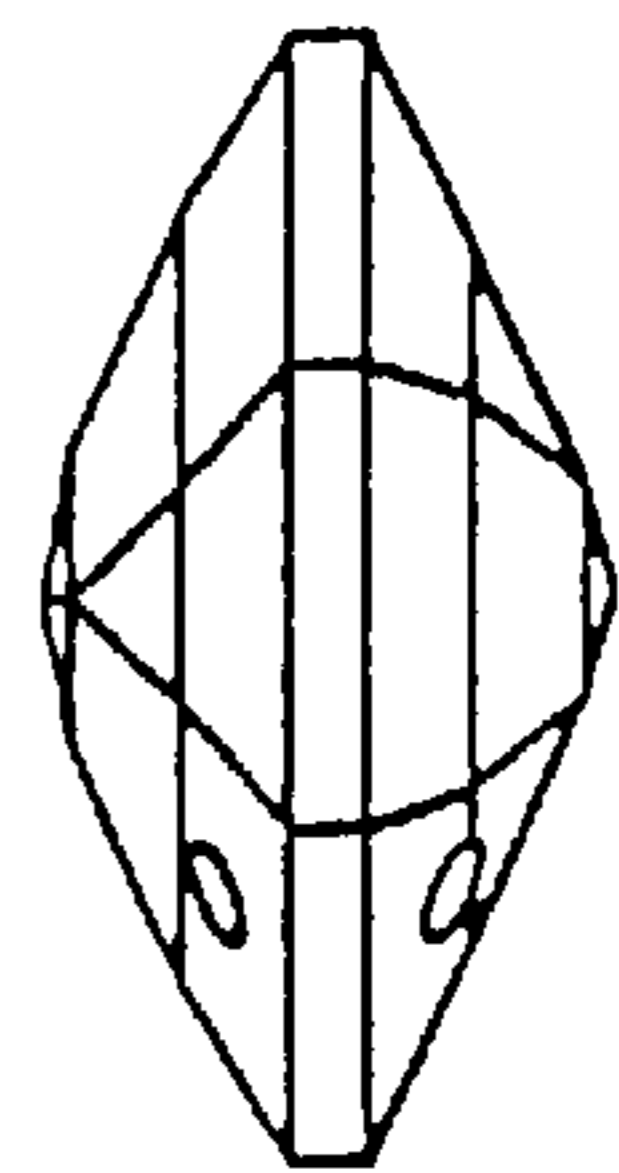

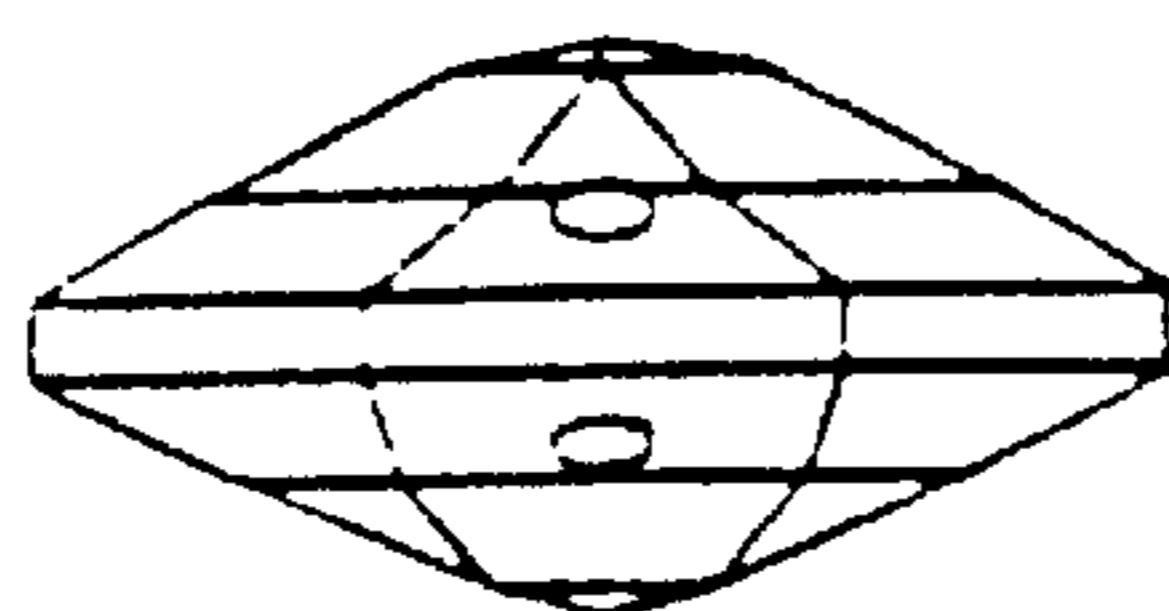

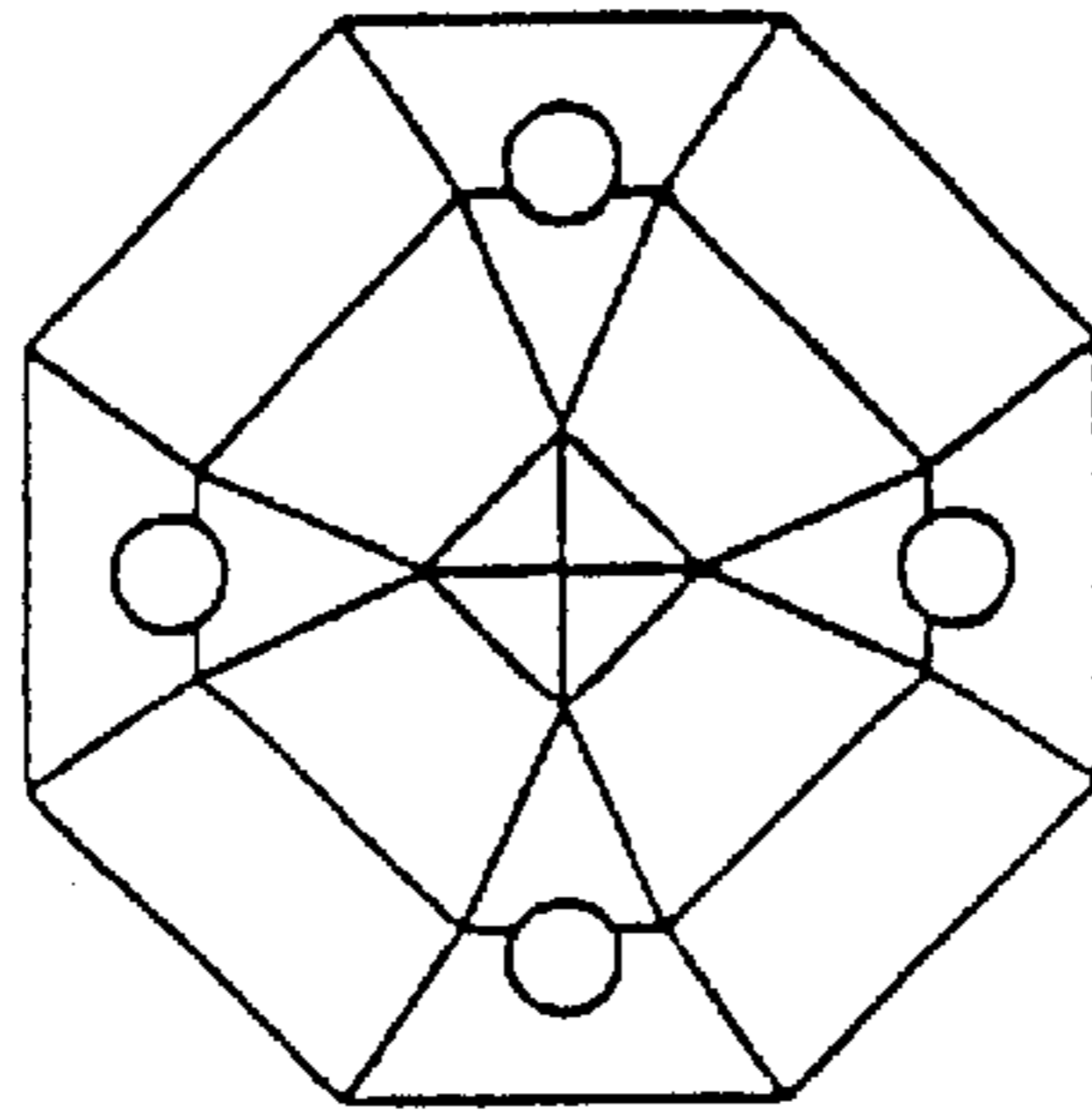

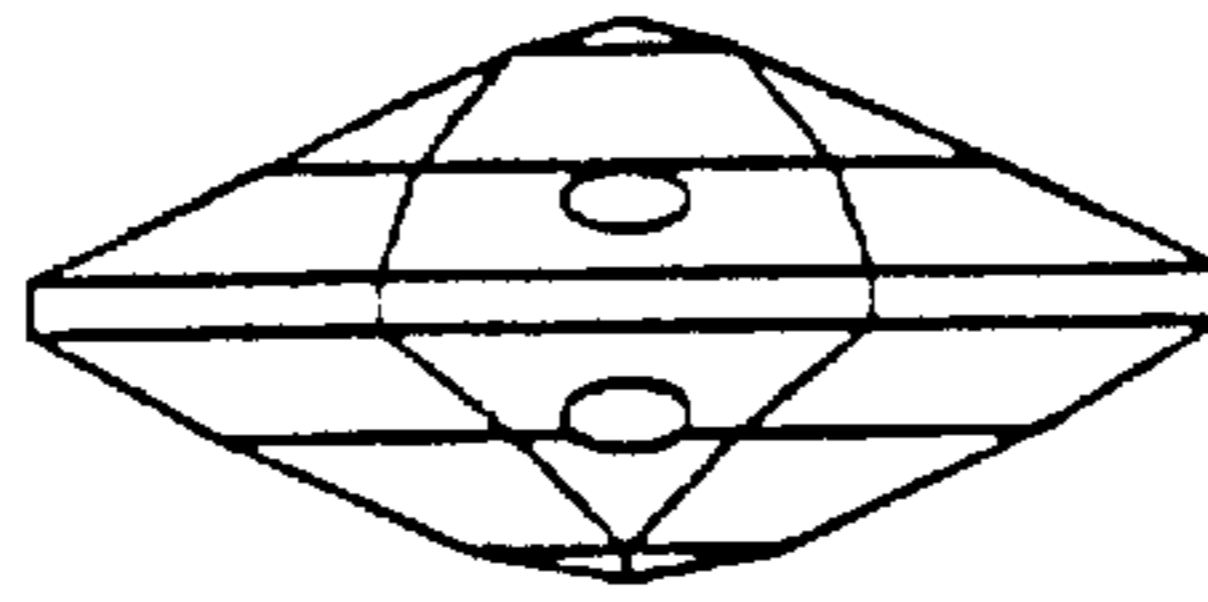

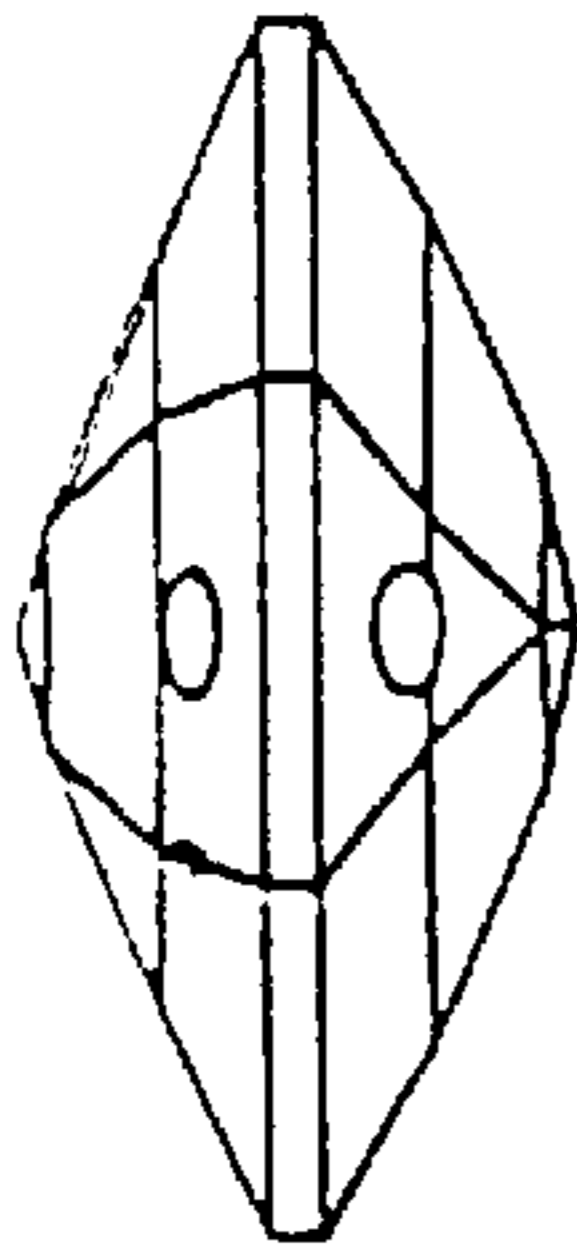

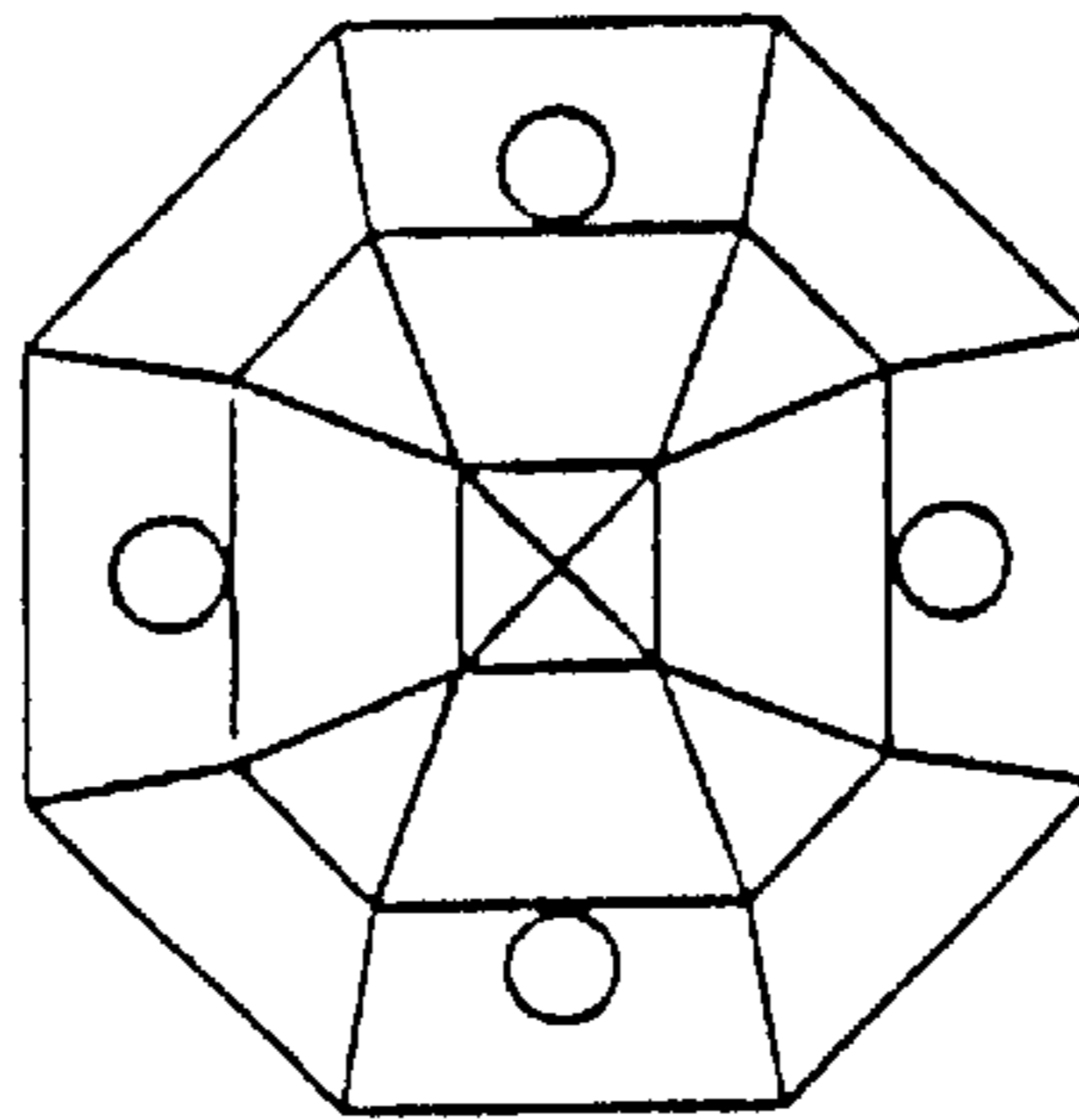

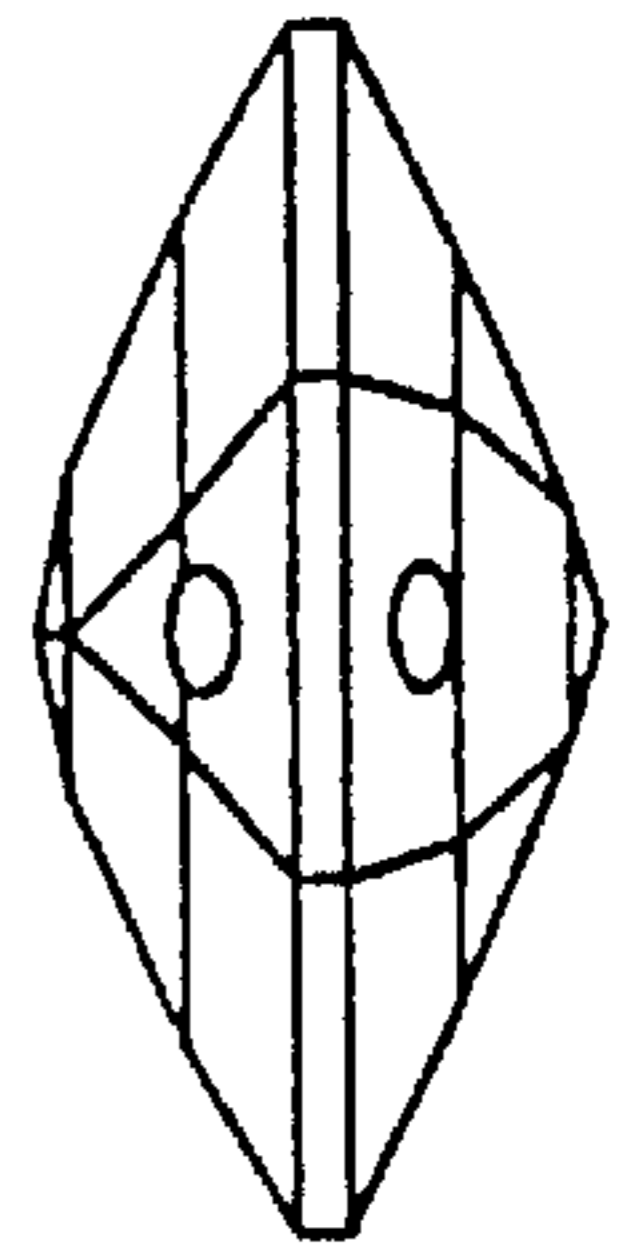
