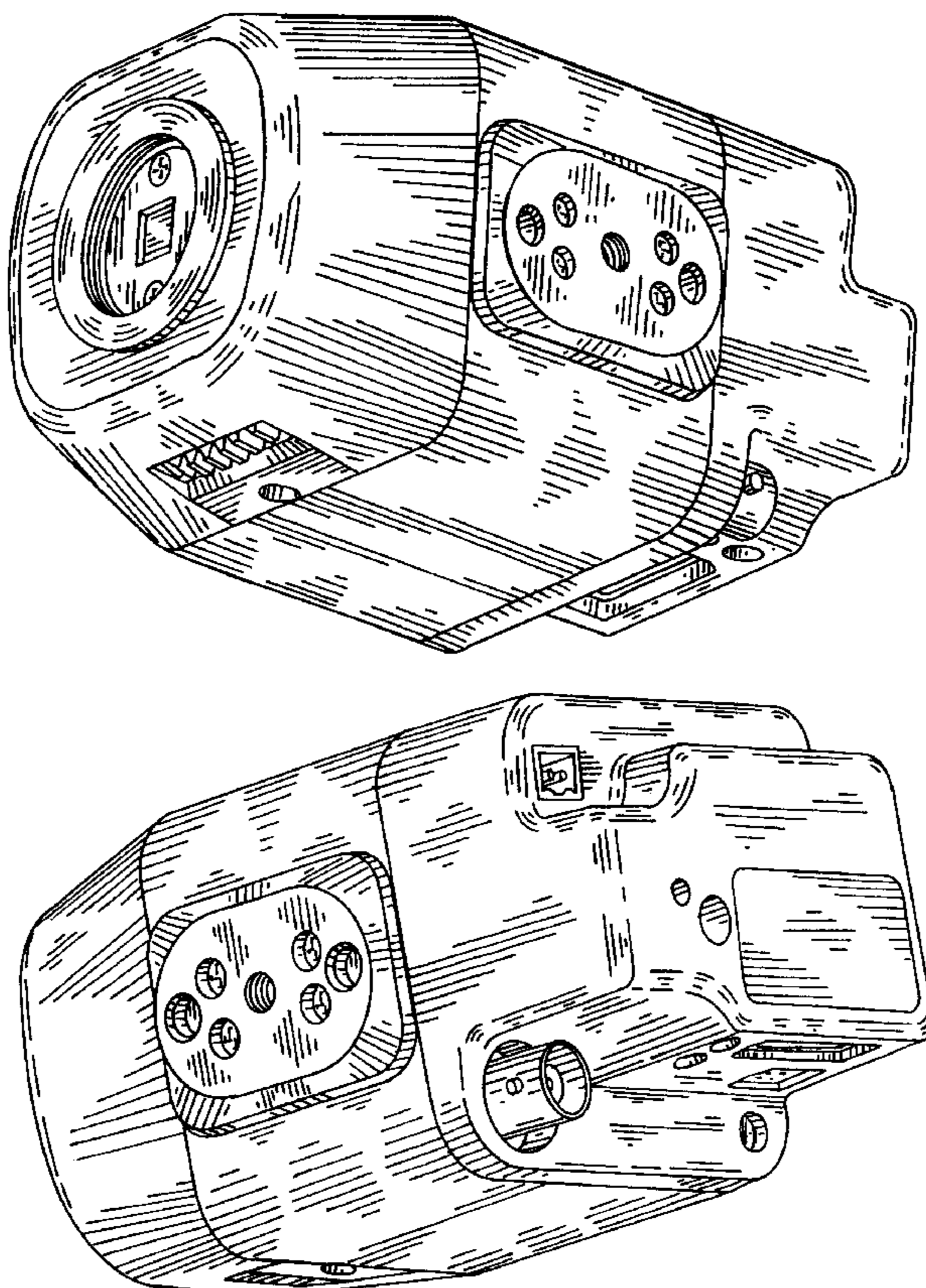
We claim the ornamental design for a notched camera case, as shown.

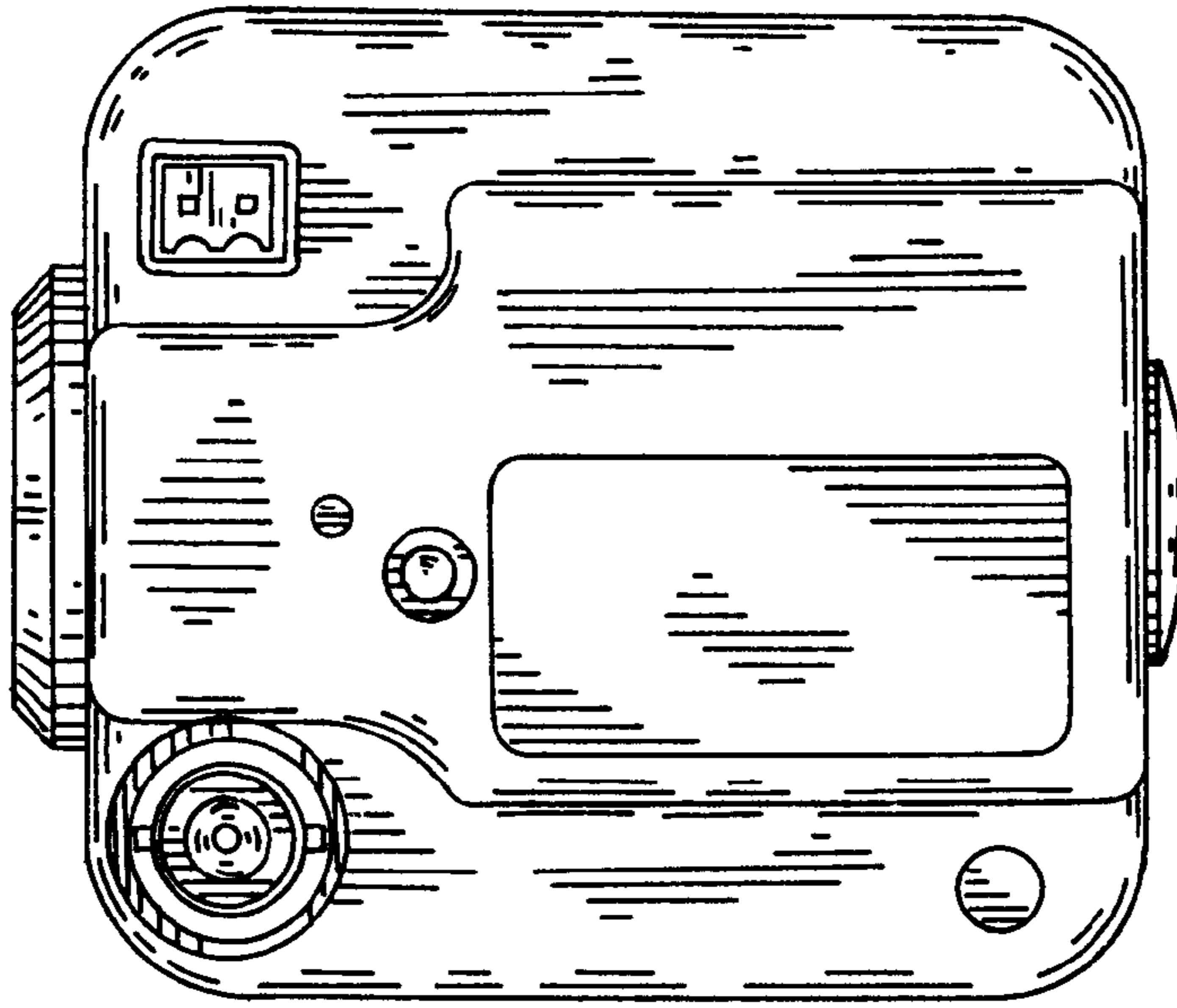

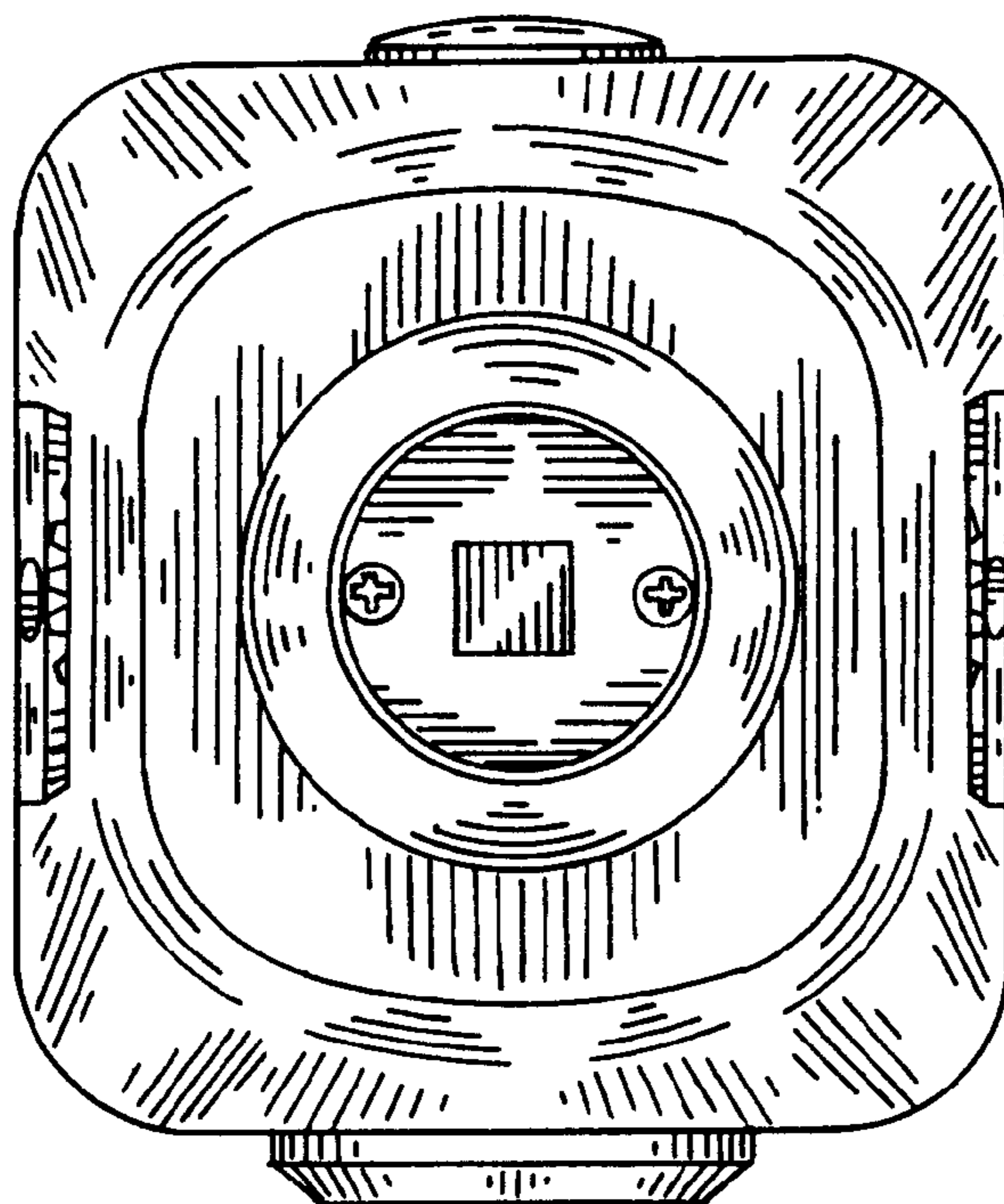

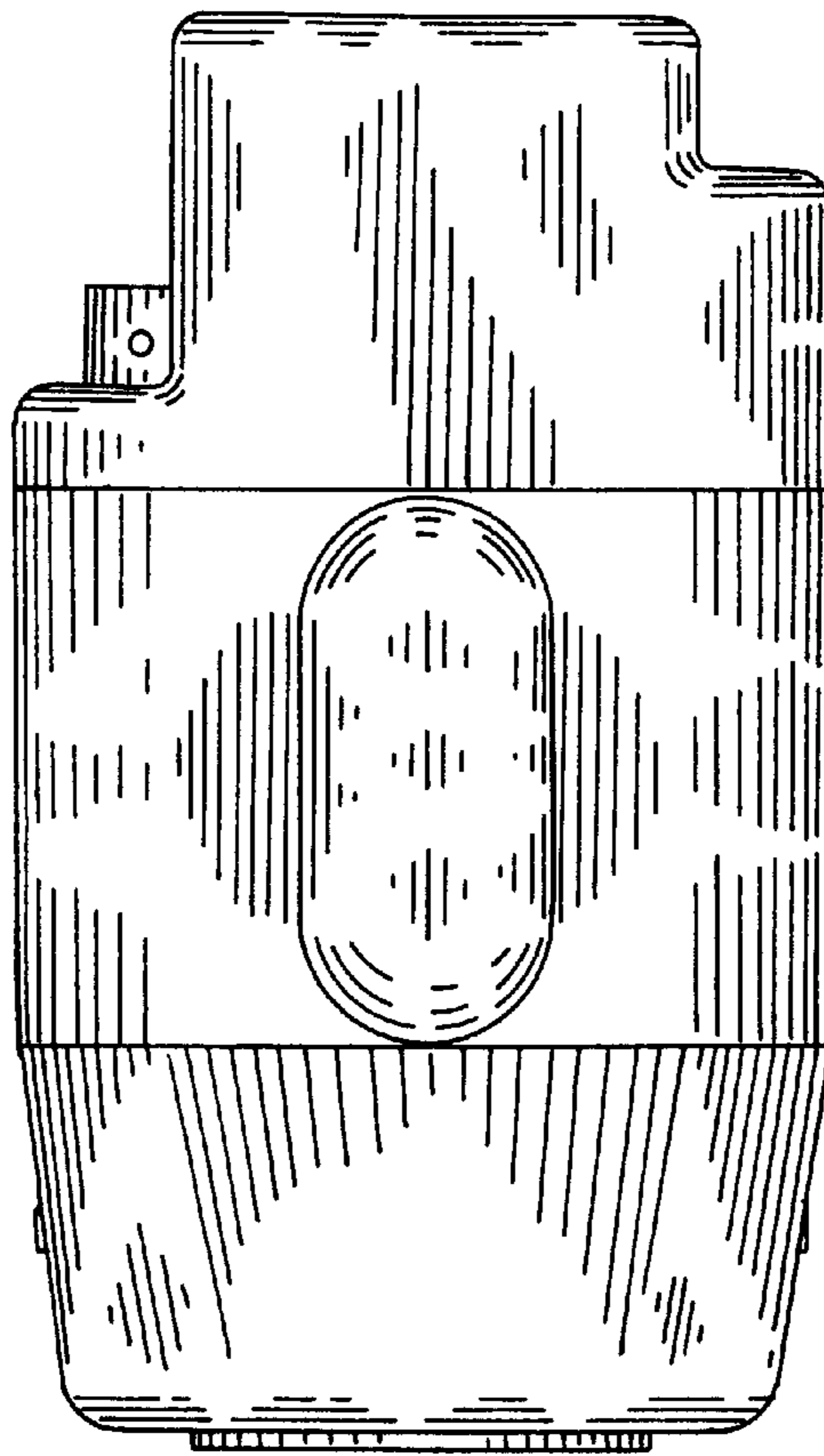

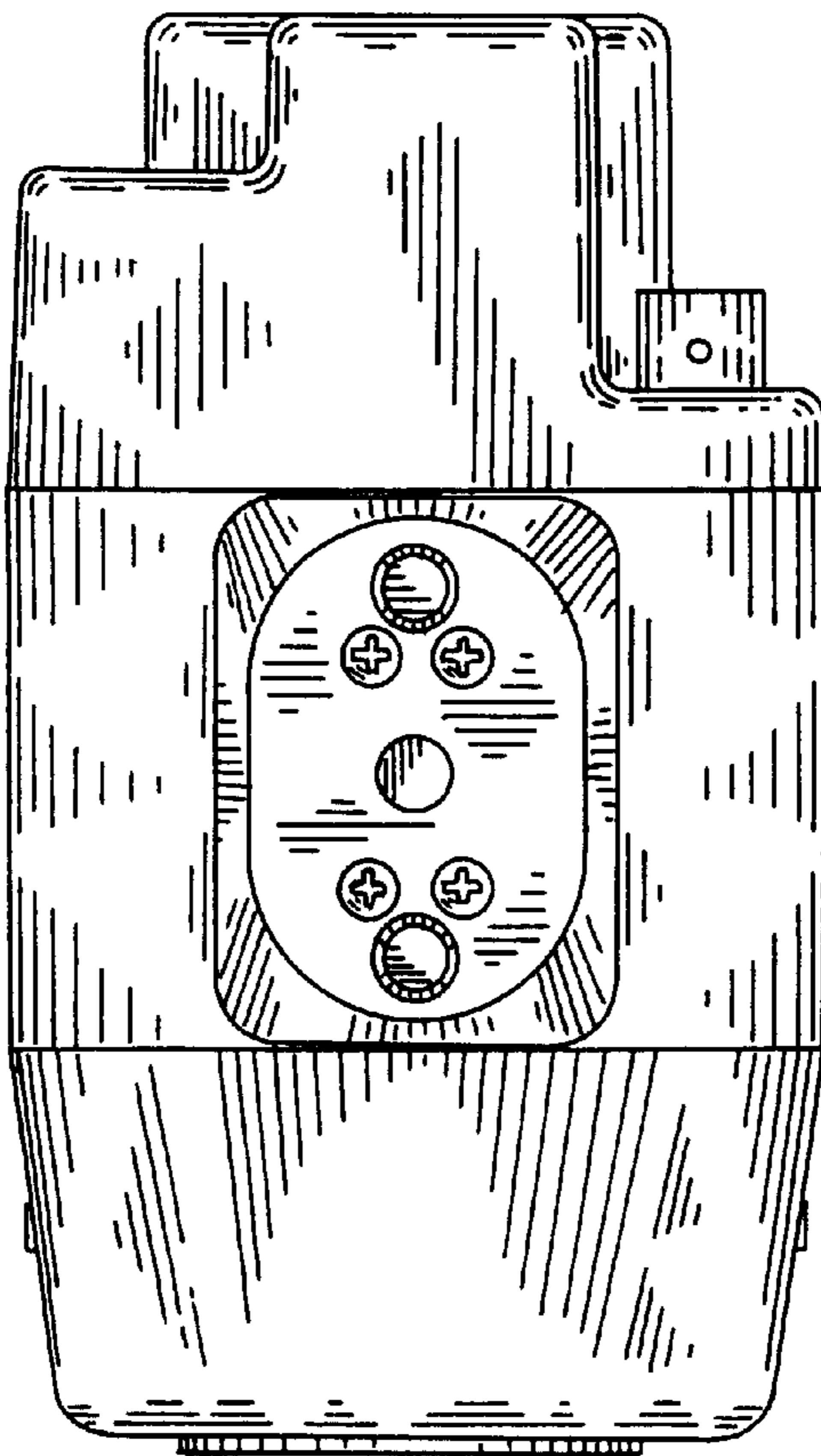

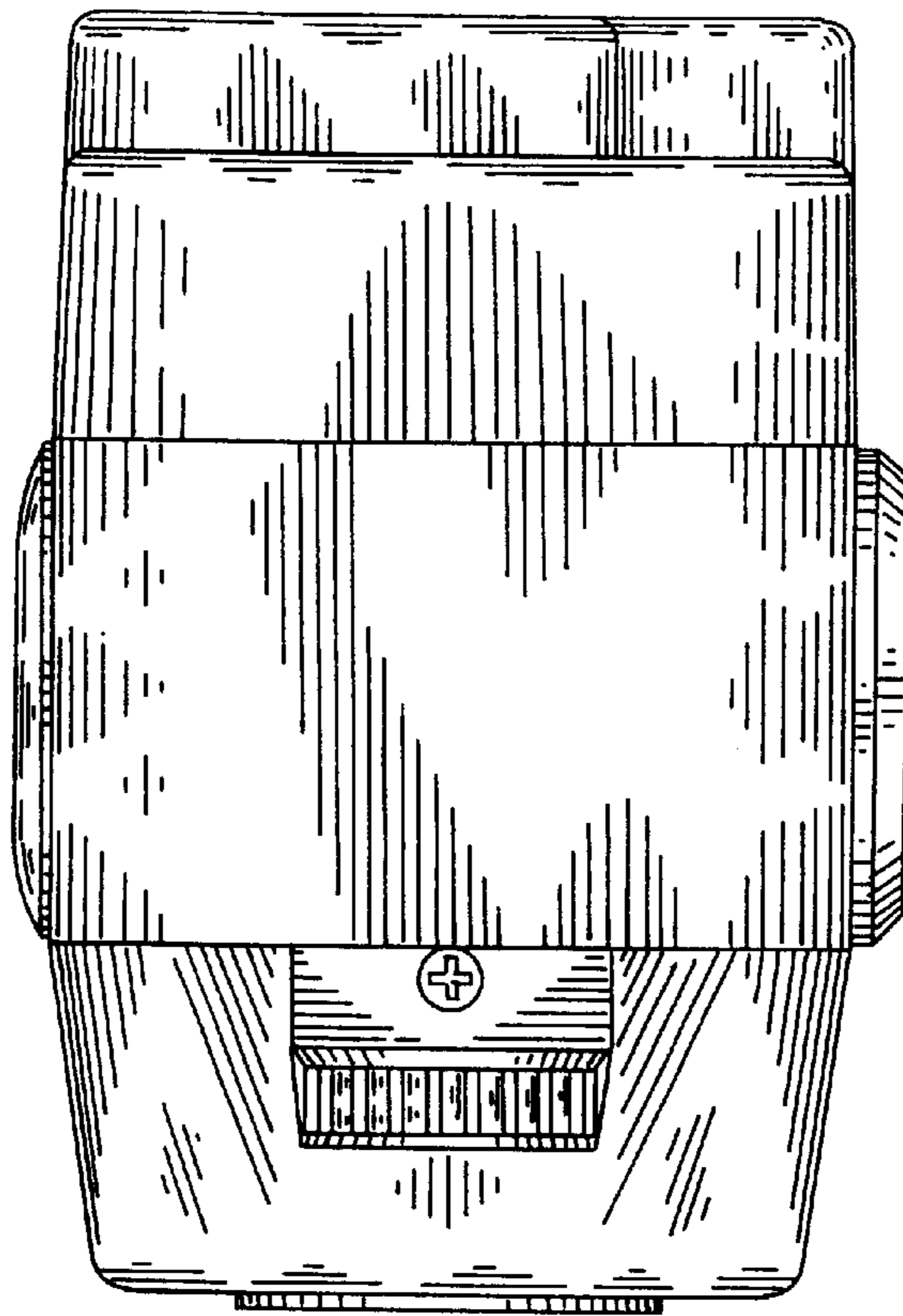

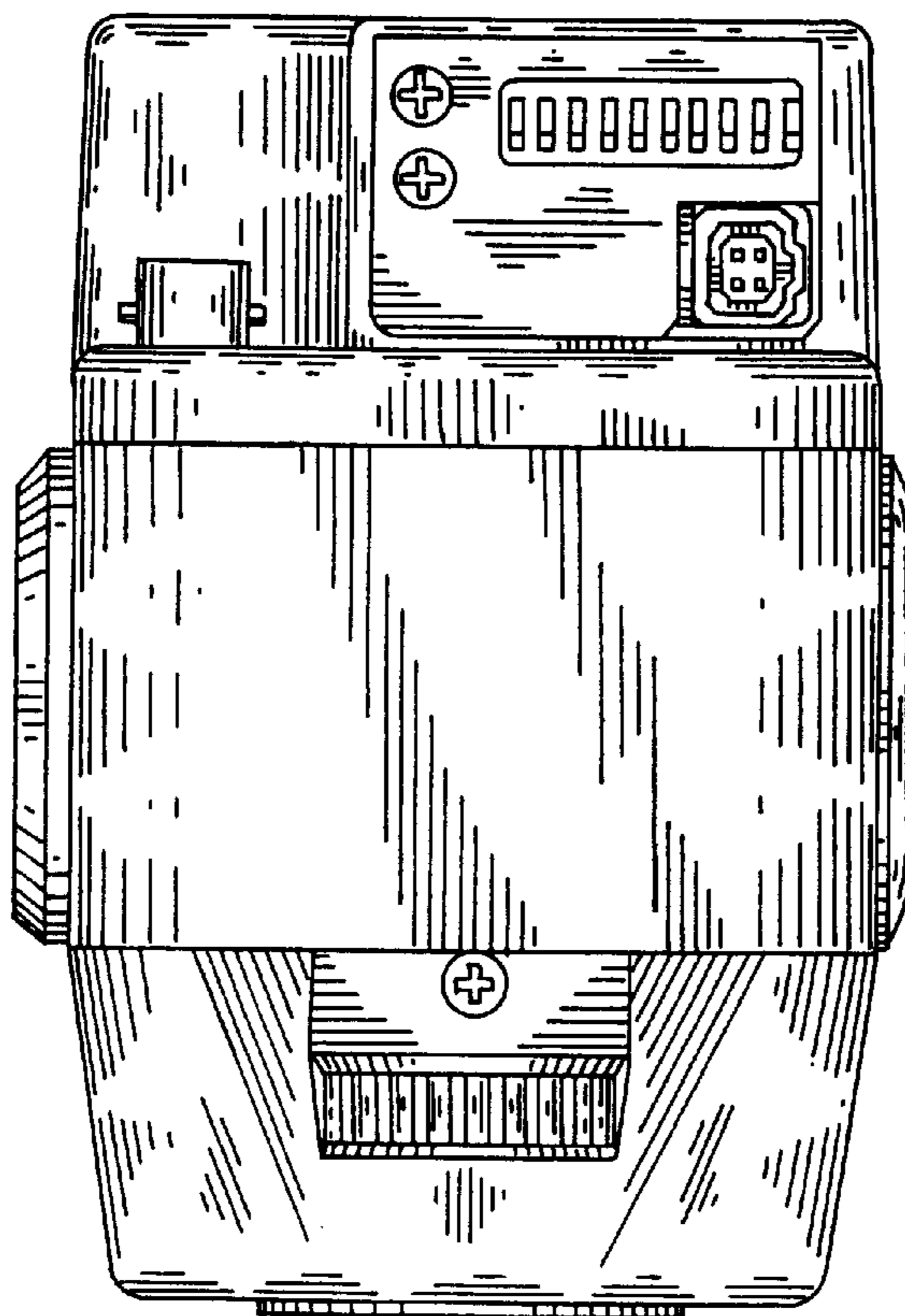

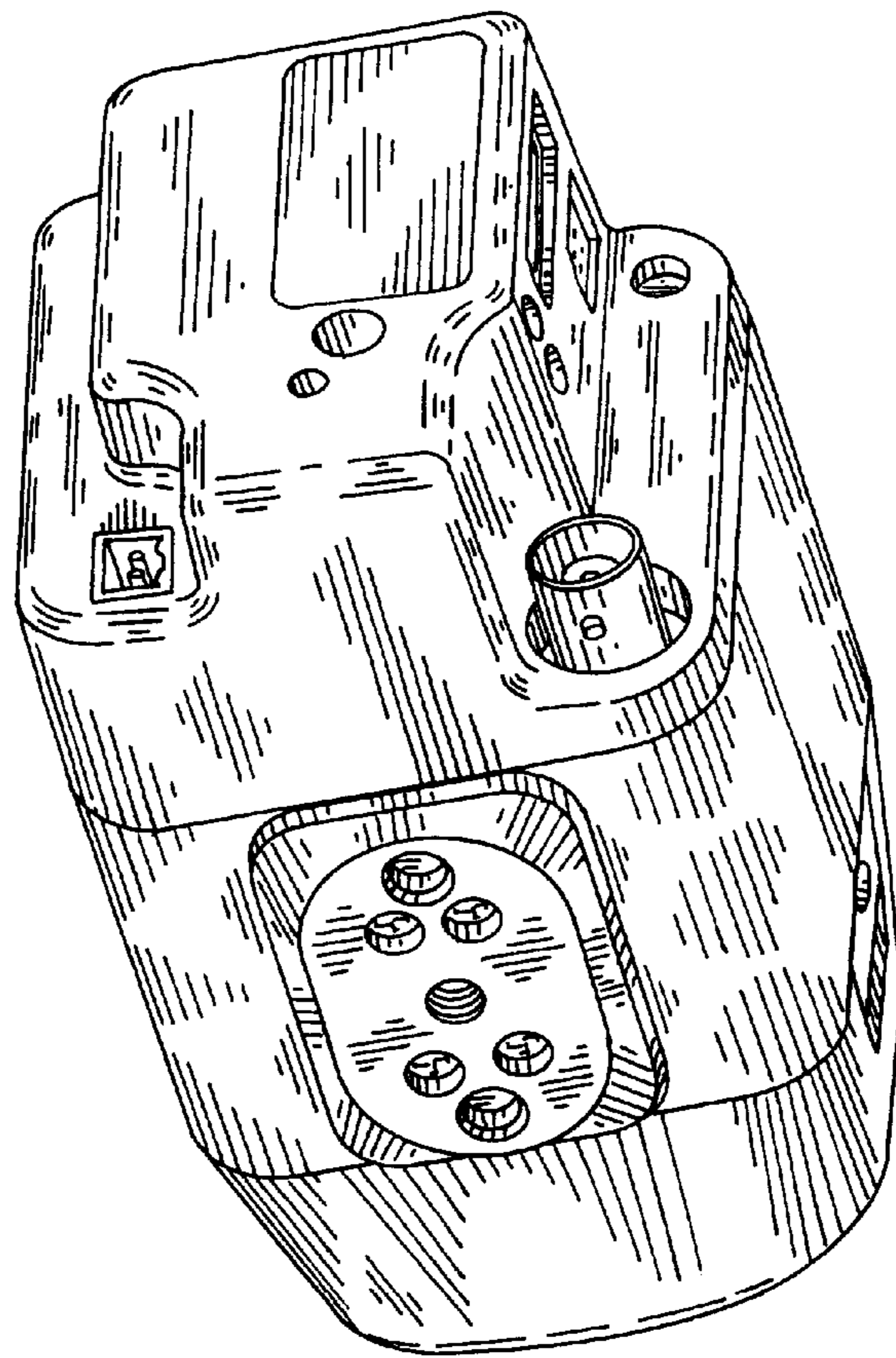

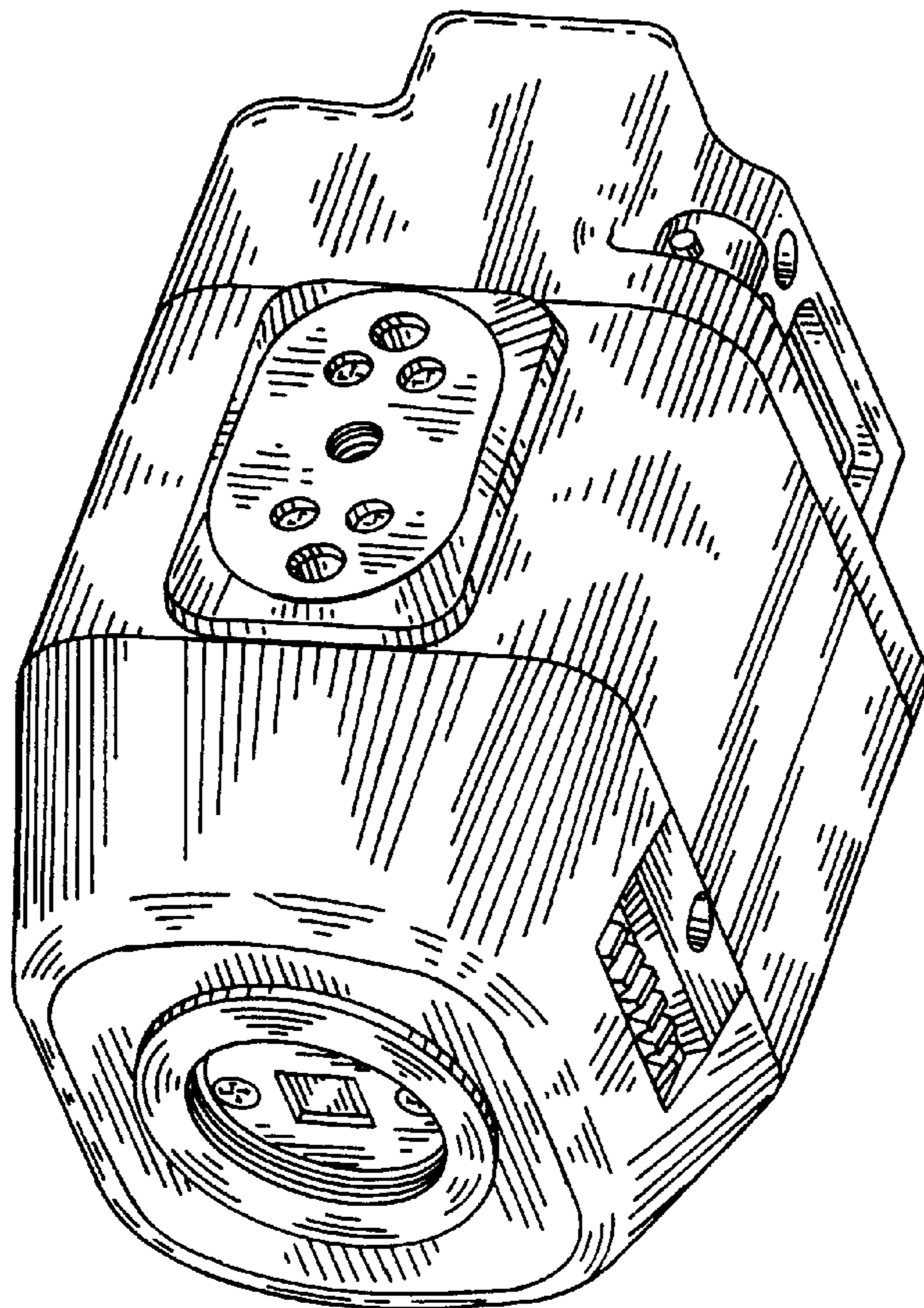
