(57) **CLAIM**

The ornamental design for a business form, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a business form showing my/our new design, the undisclosed rear being plain;

FIG. 2 is a side elevational view of the business form of FIG. 1, the opposite side elevational view being a mirror image;

FIG. 3 is a front elevational view of a second embodiment of a business form showing my/our new design, the undisclosed rear being plain;

FIG. 4 is a side elevational view of the business form of FIG. 3, the opposite side elevational view being a mirror image;

FIG. 5 is a front elevational view of a third embodiment of a business form showing my/our new design, the undisclosed rear being plain;

FIG. 6 is a side elevational view of the business form of FIG. 5, the opposite side elevational view being a mirror image;

FIG. 7 is a front elevational view of a fourth embodiment of a business form showing my/our new design, the undisclosed rear being plain;

FIG. 8 is a side elevational view of the business form of FIG. 7, the opposite side elevational view being a mirror image;

FIG. 11 is a front elevational view of a sixth embodiment of a business form showing my/our new design, the undisclosed rear being plain;

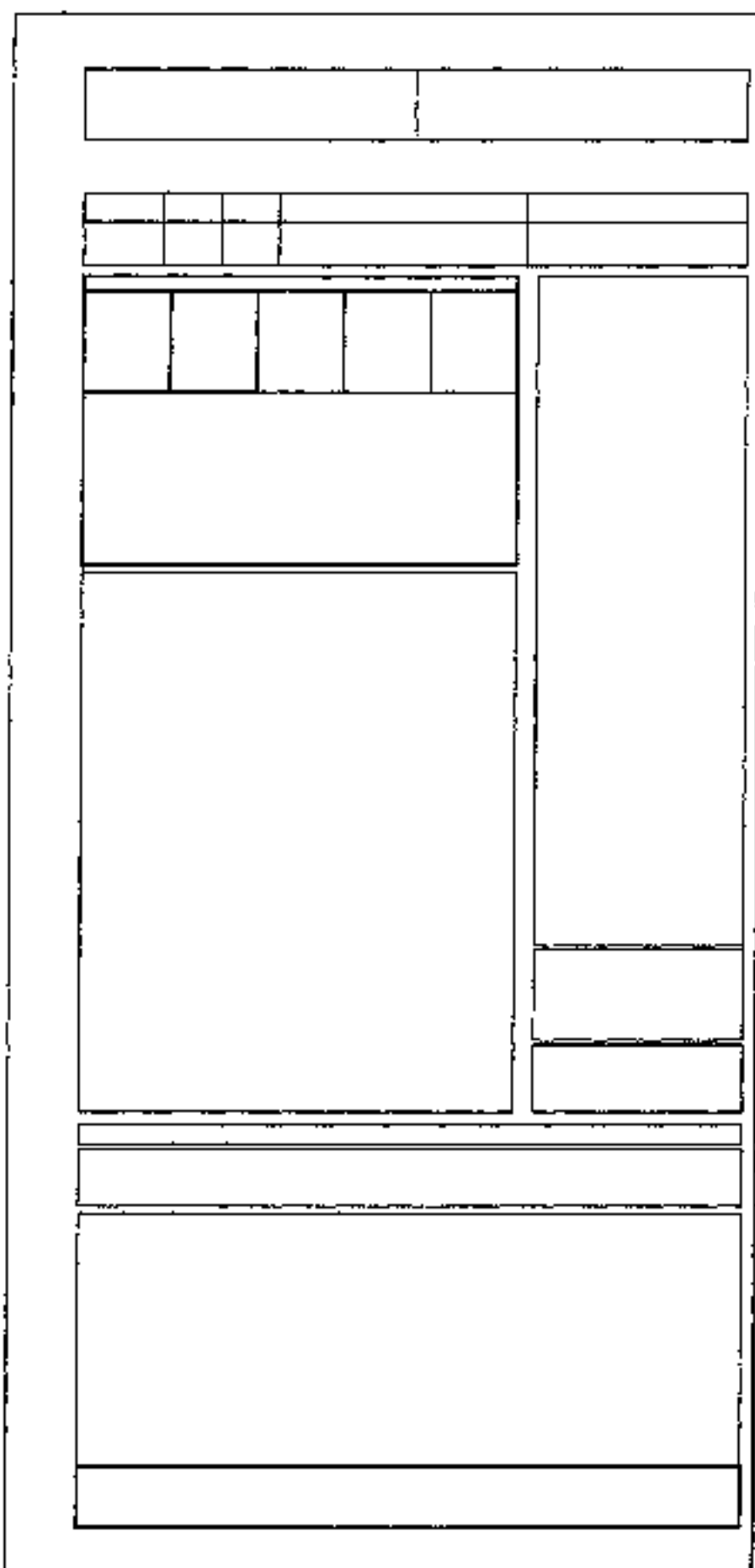


FIG. 12 is a side elevational view of the business form of FIG. 11, the opposite side elevational view being a mirror image;

FIG. 46 is a side elevational view of the business form of FIG. 45, the opposite side elevational view being a mirror image.

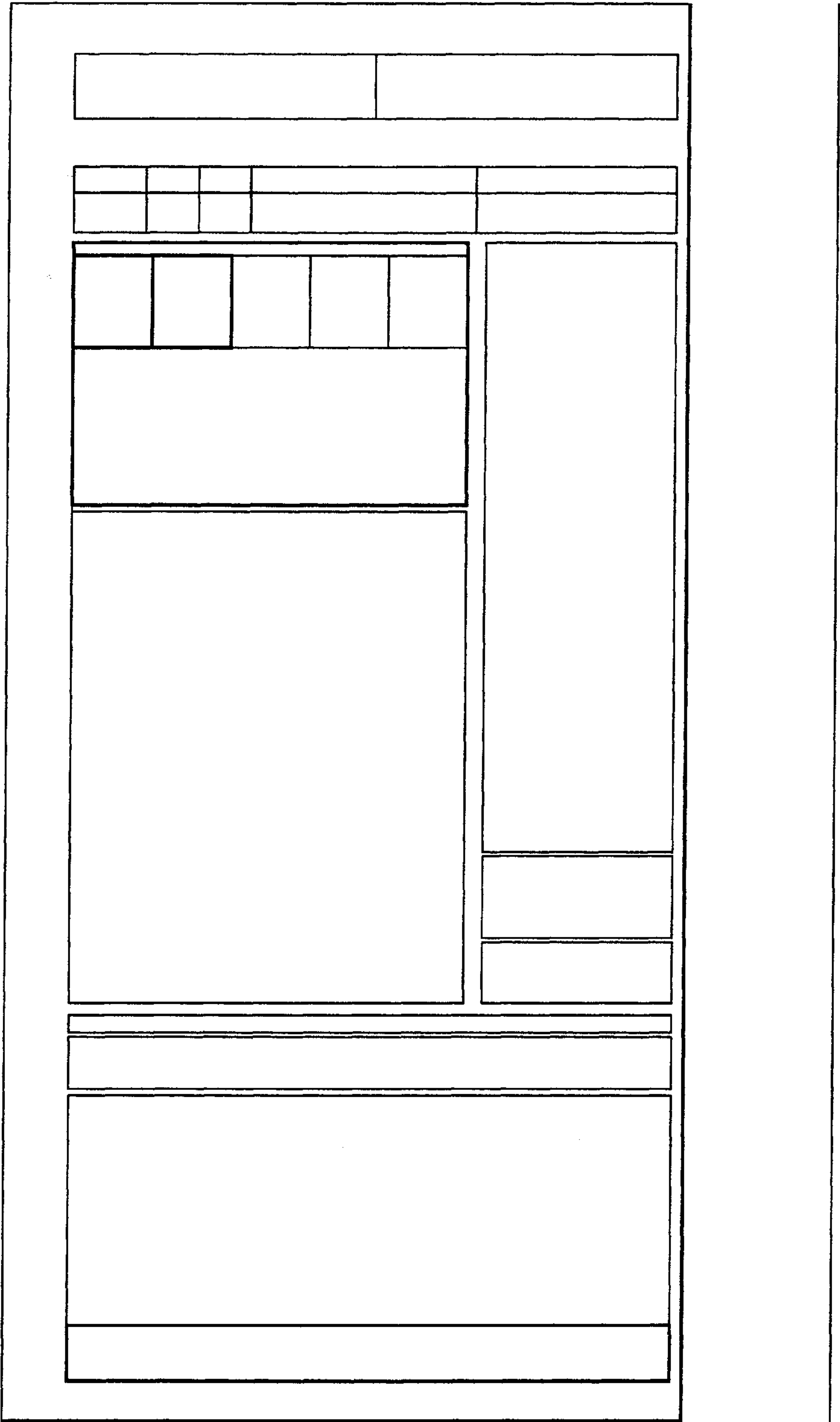

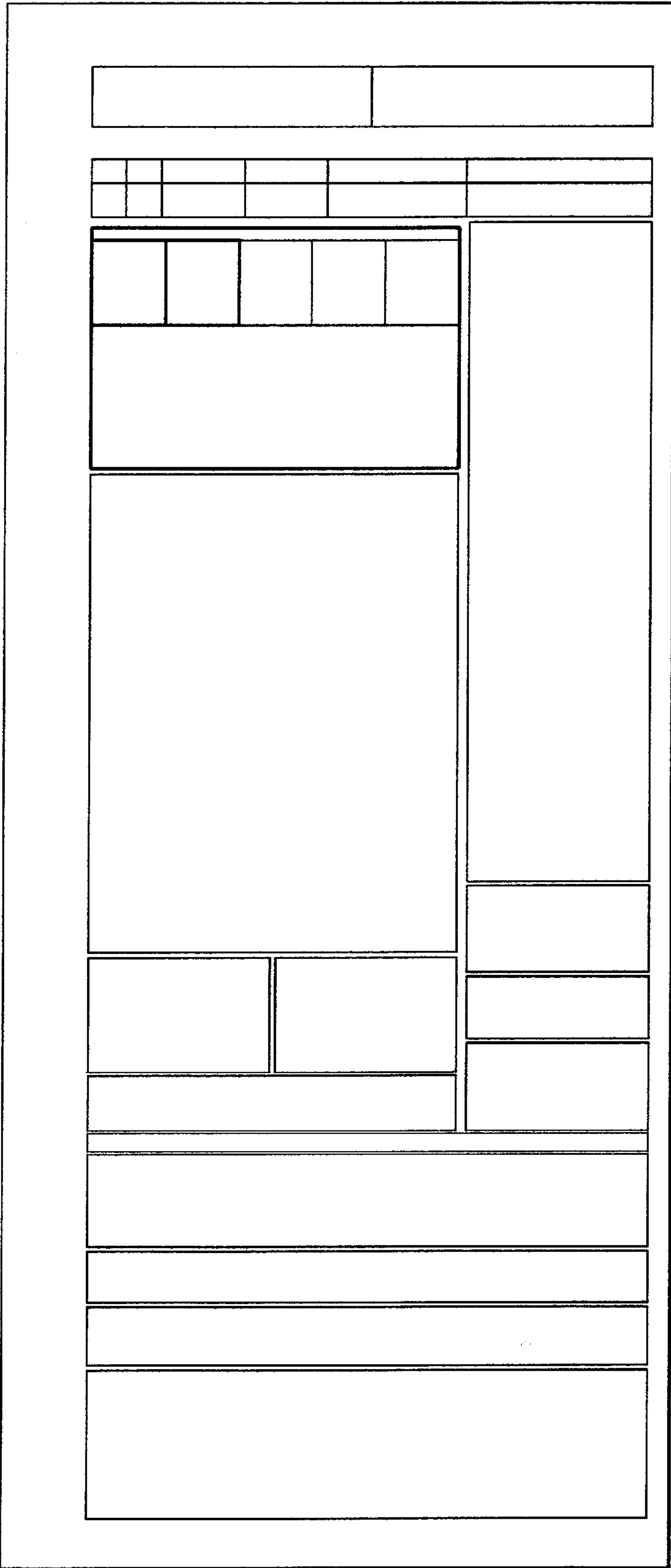

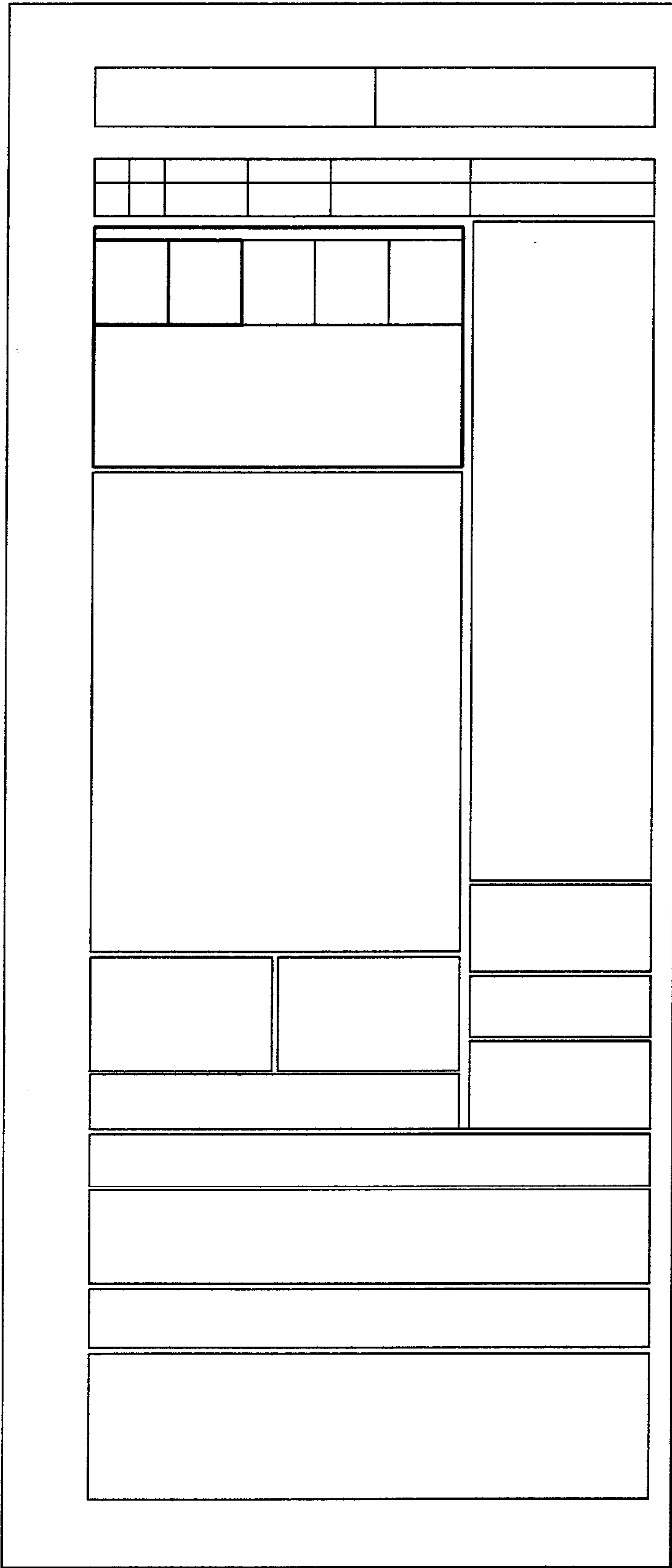

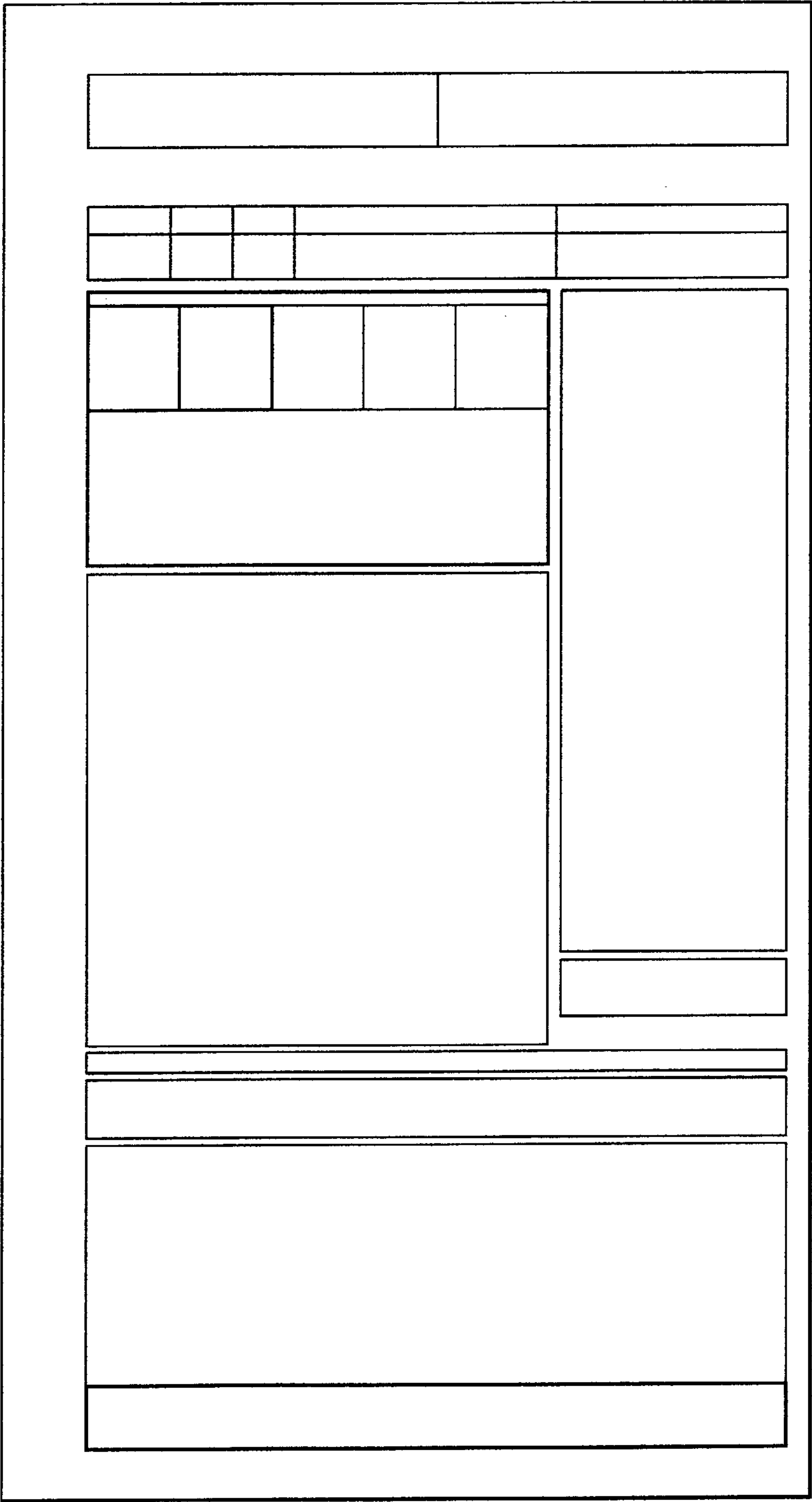

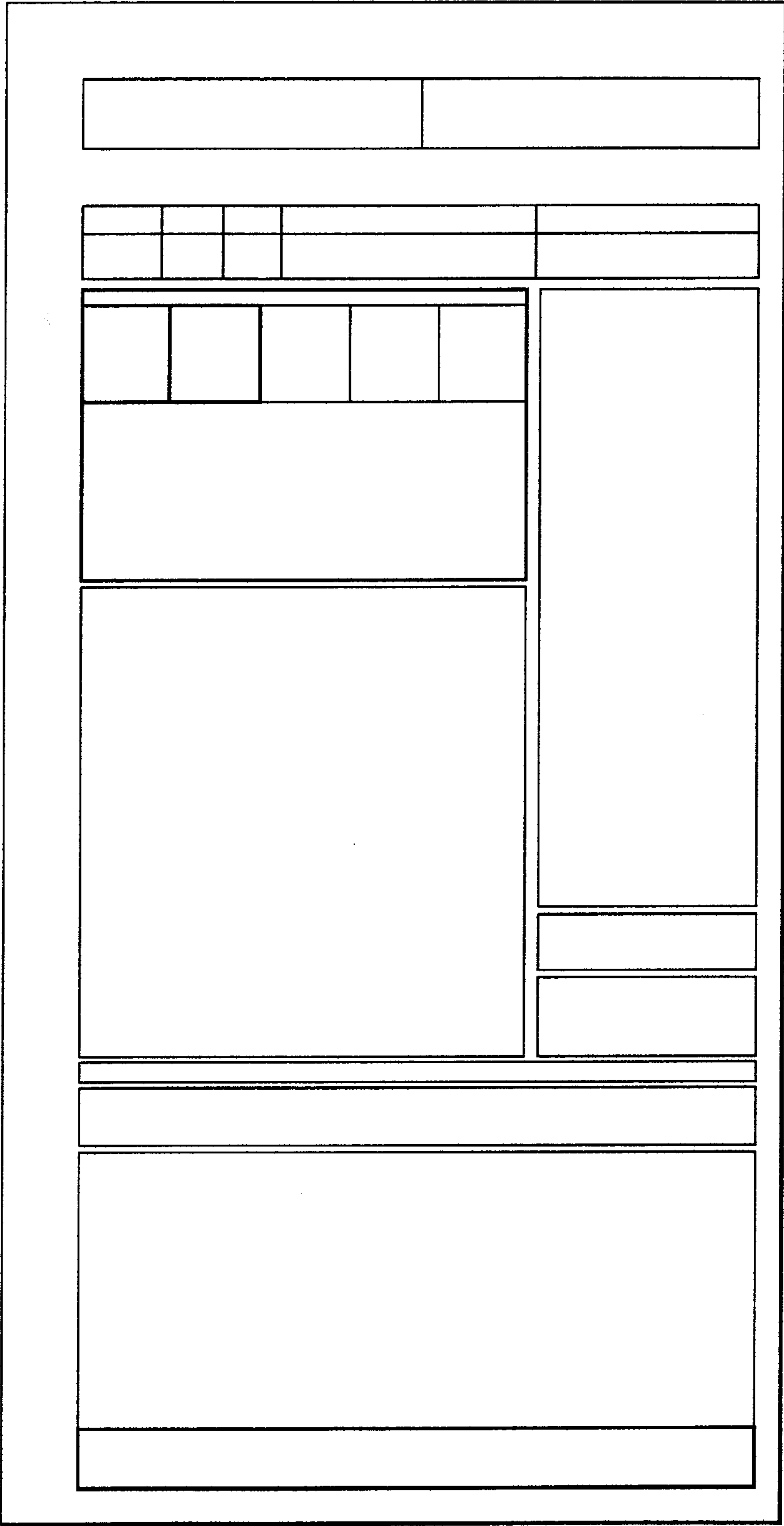

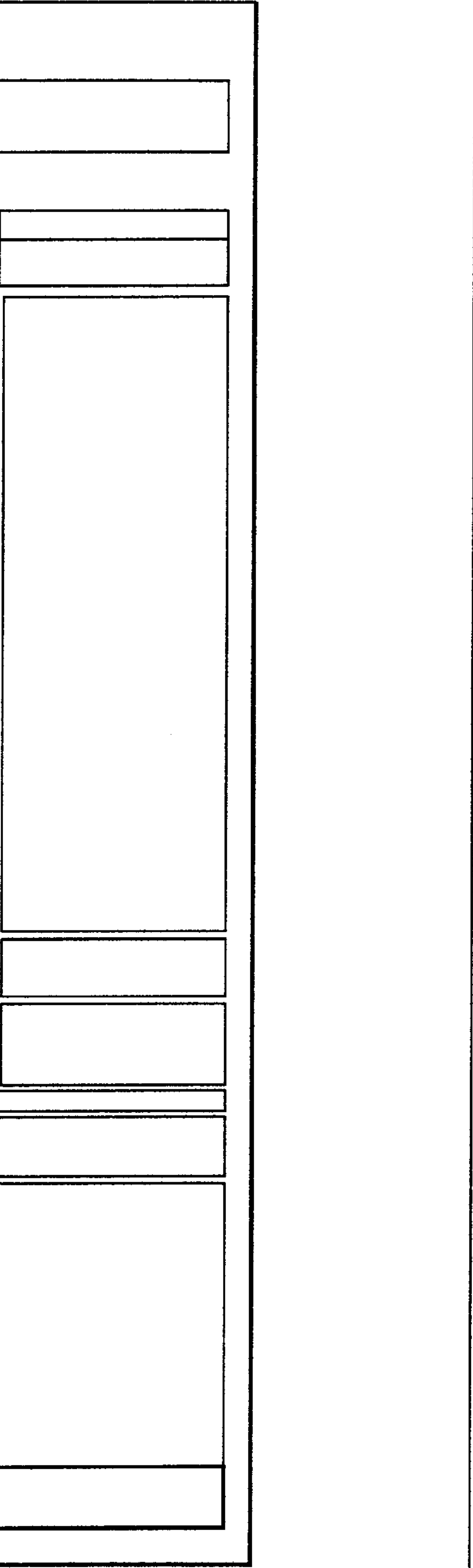

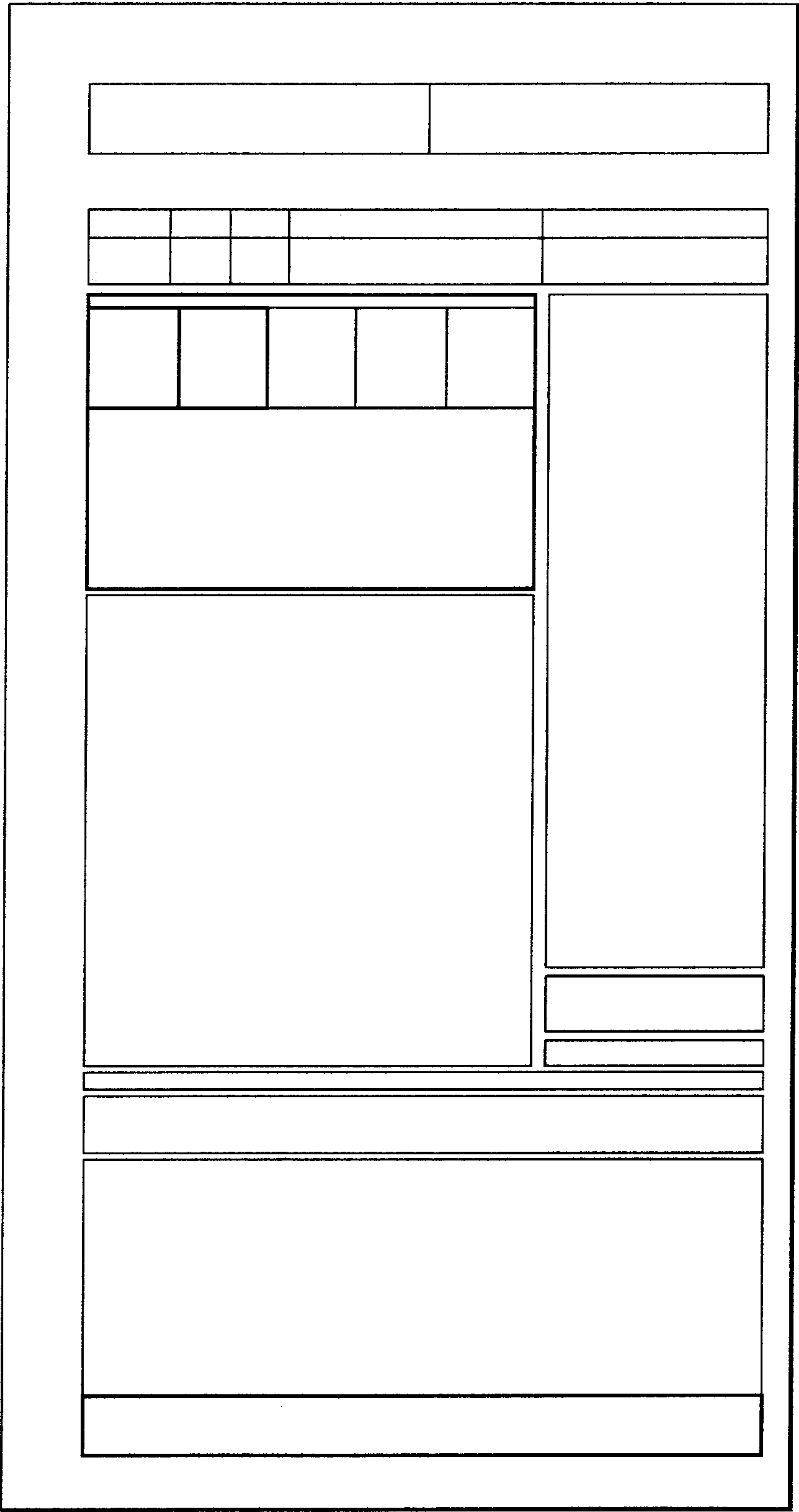

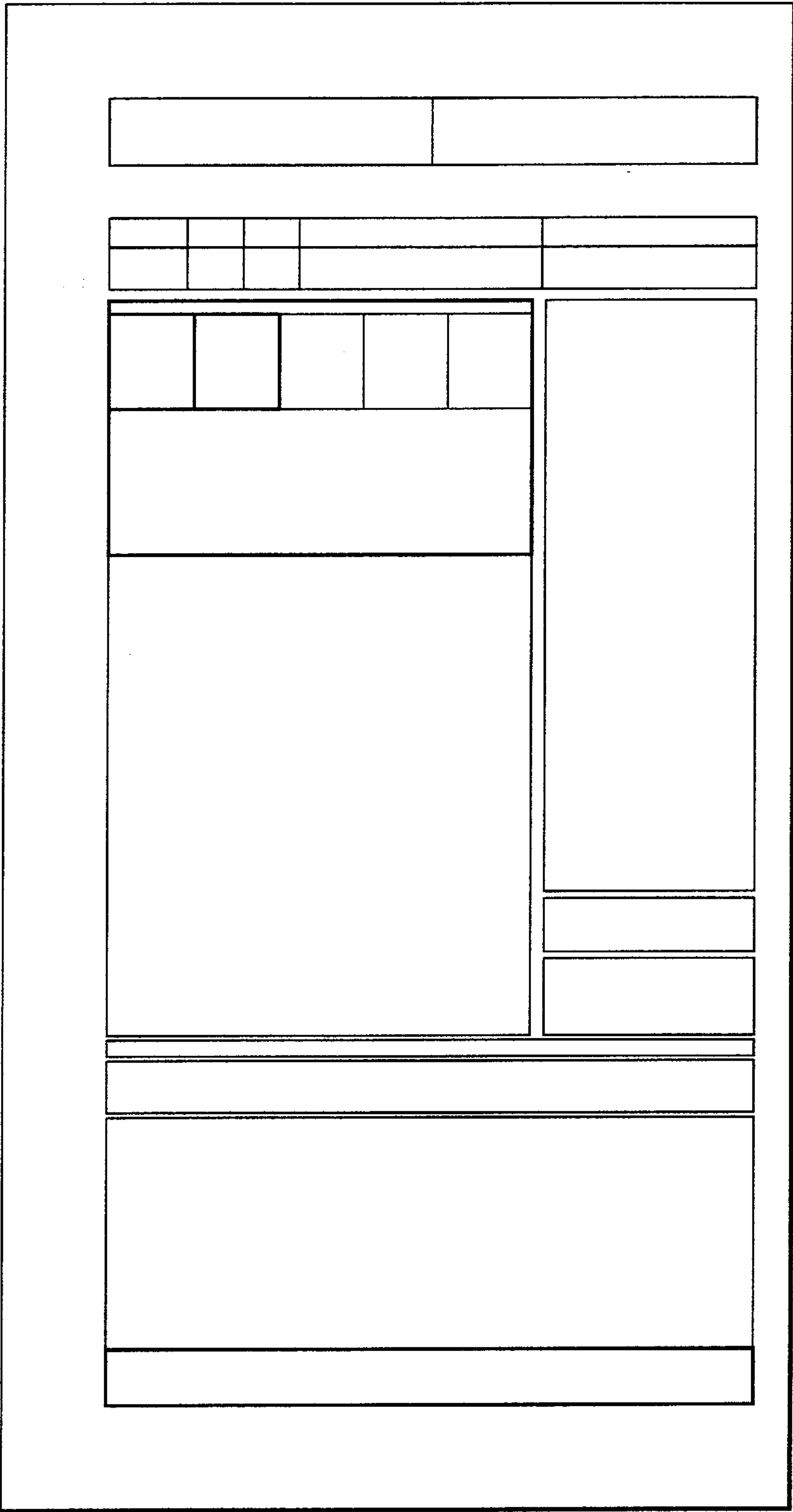

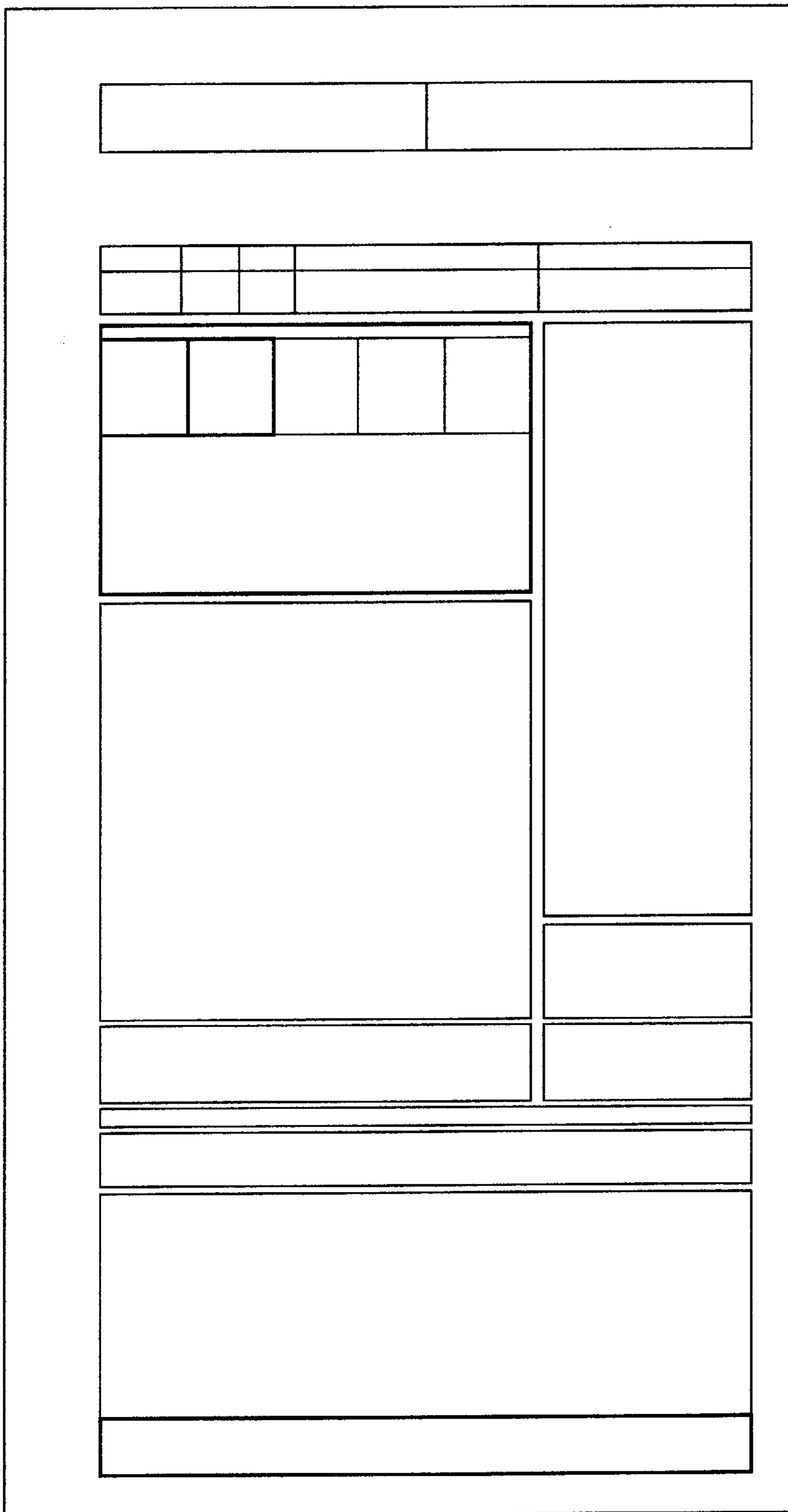

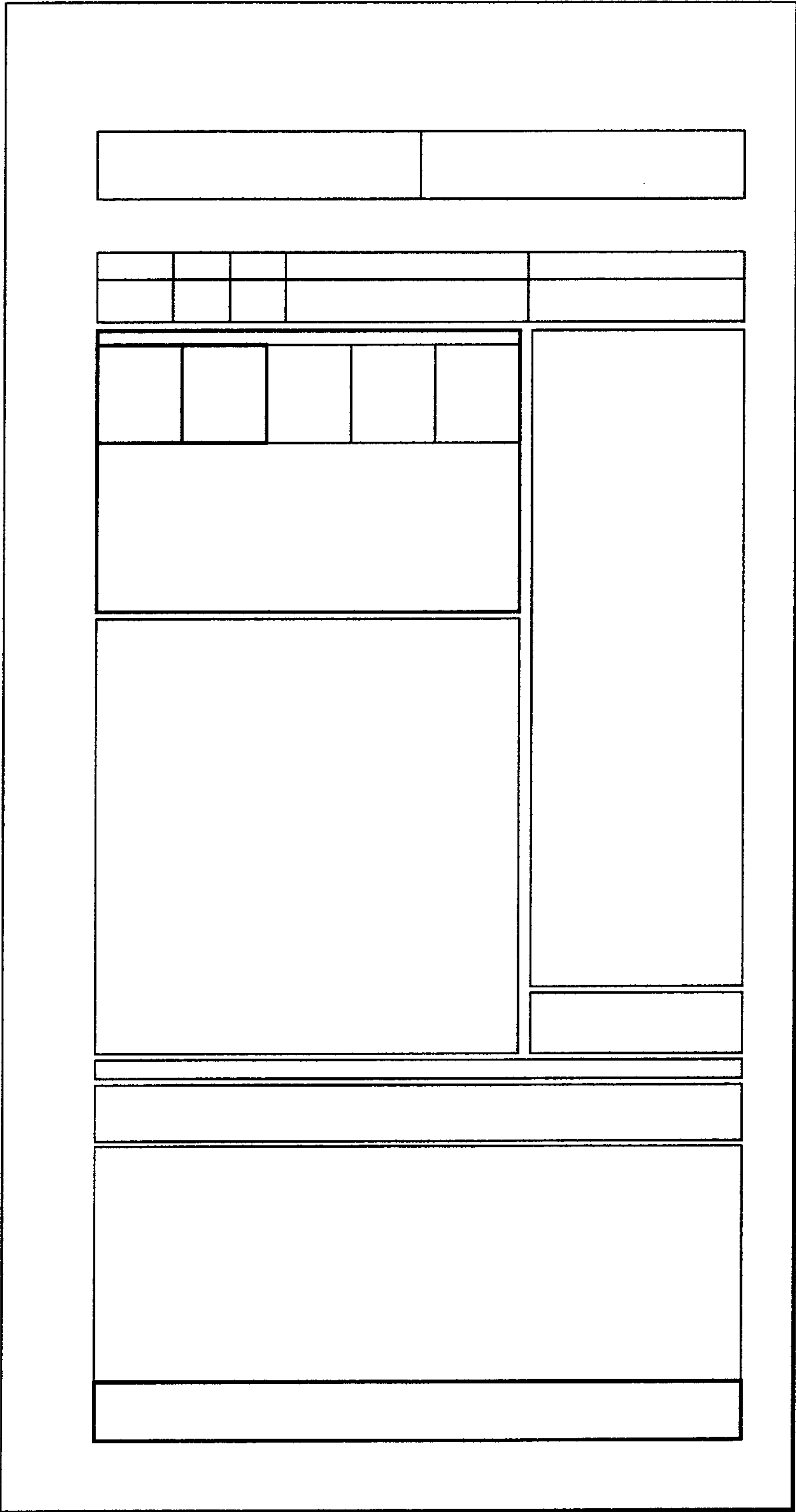

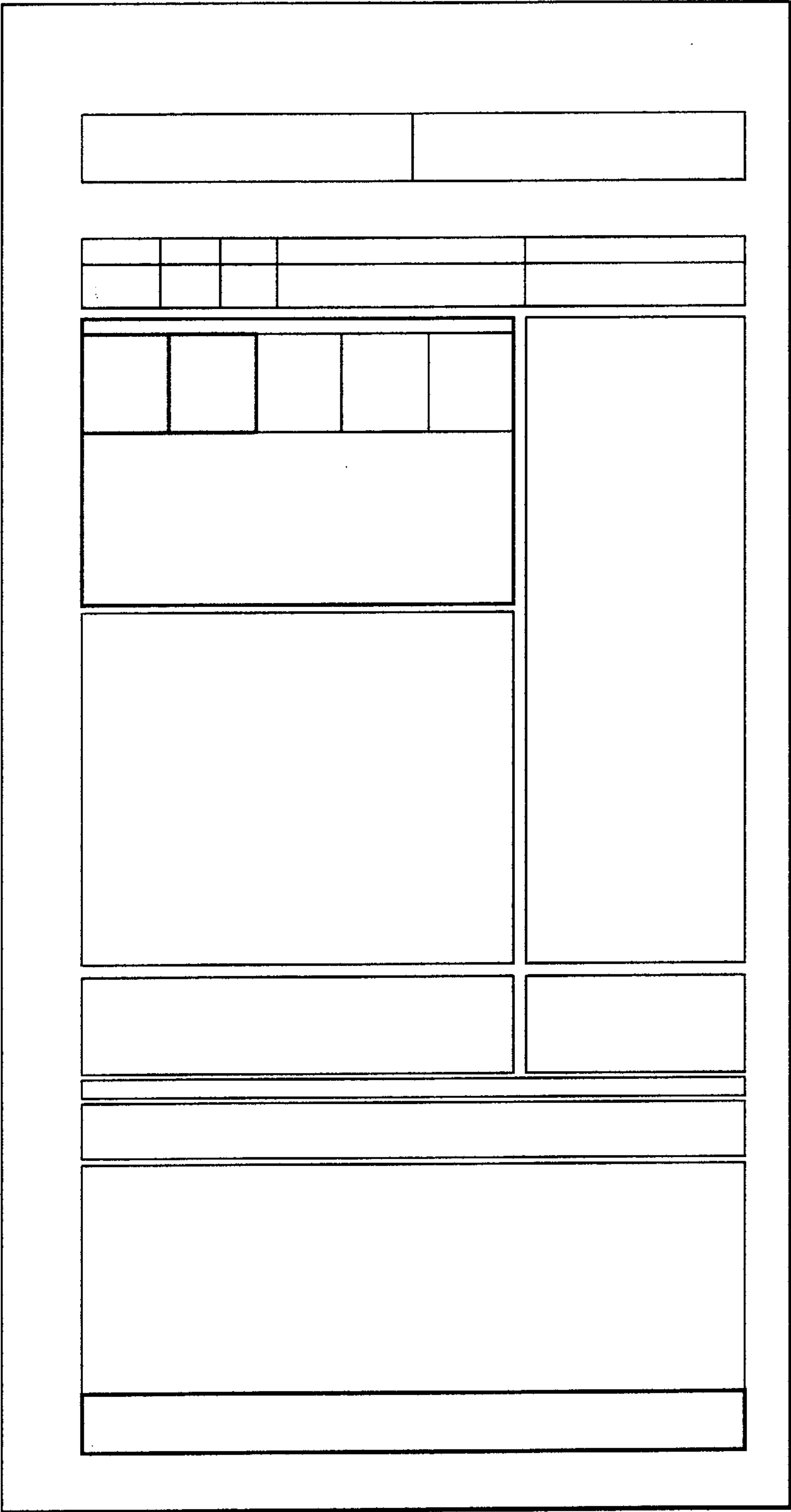

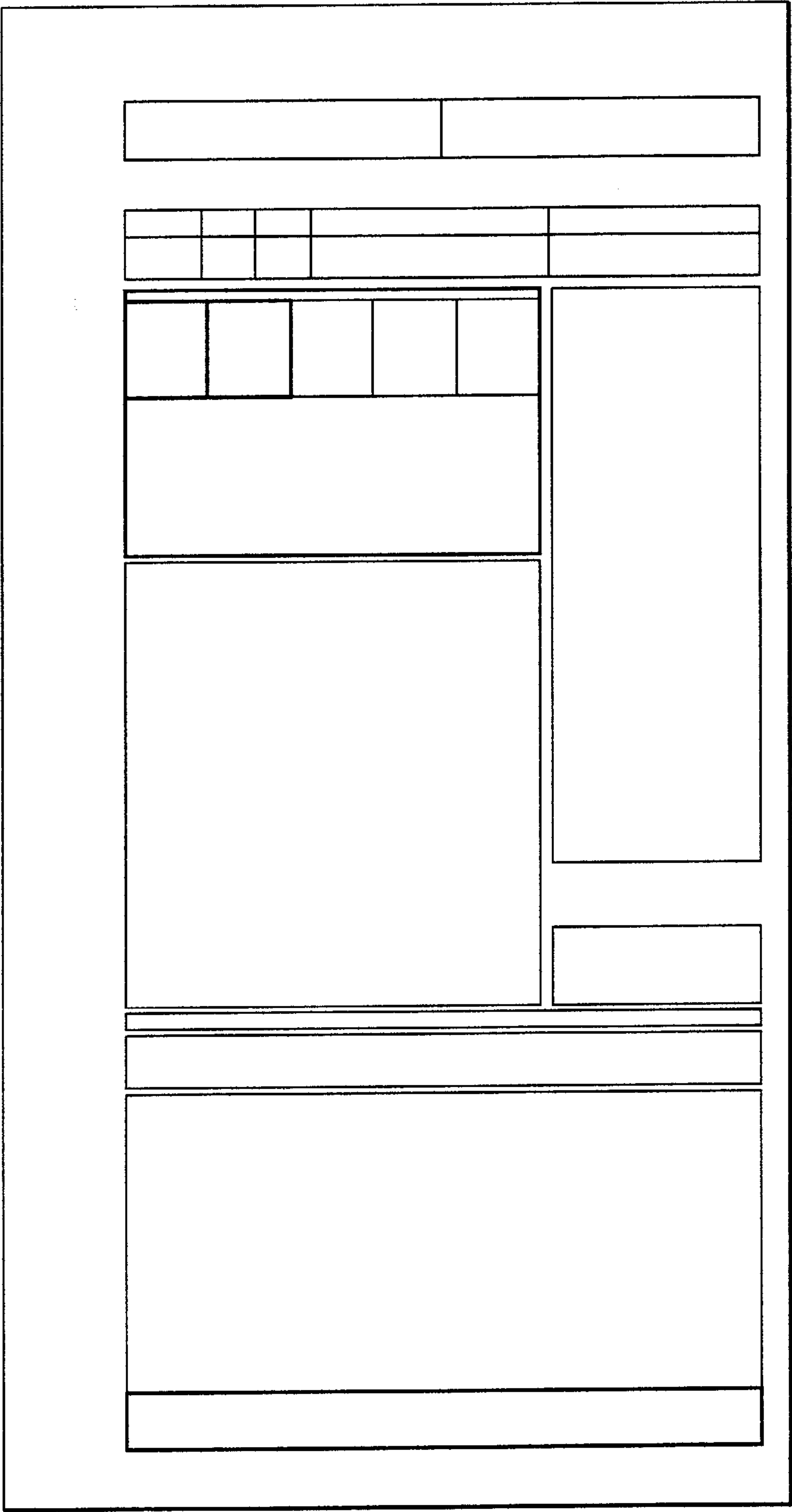

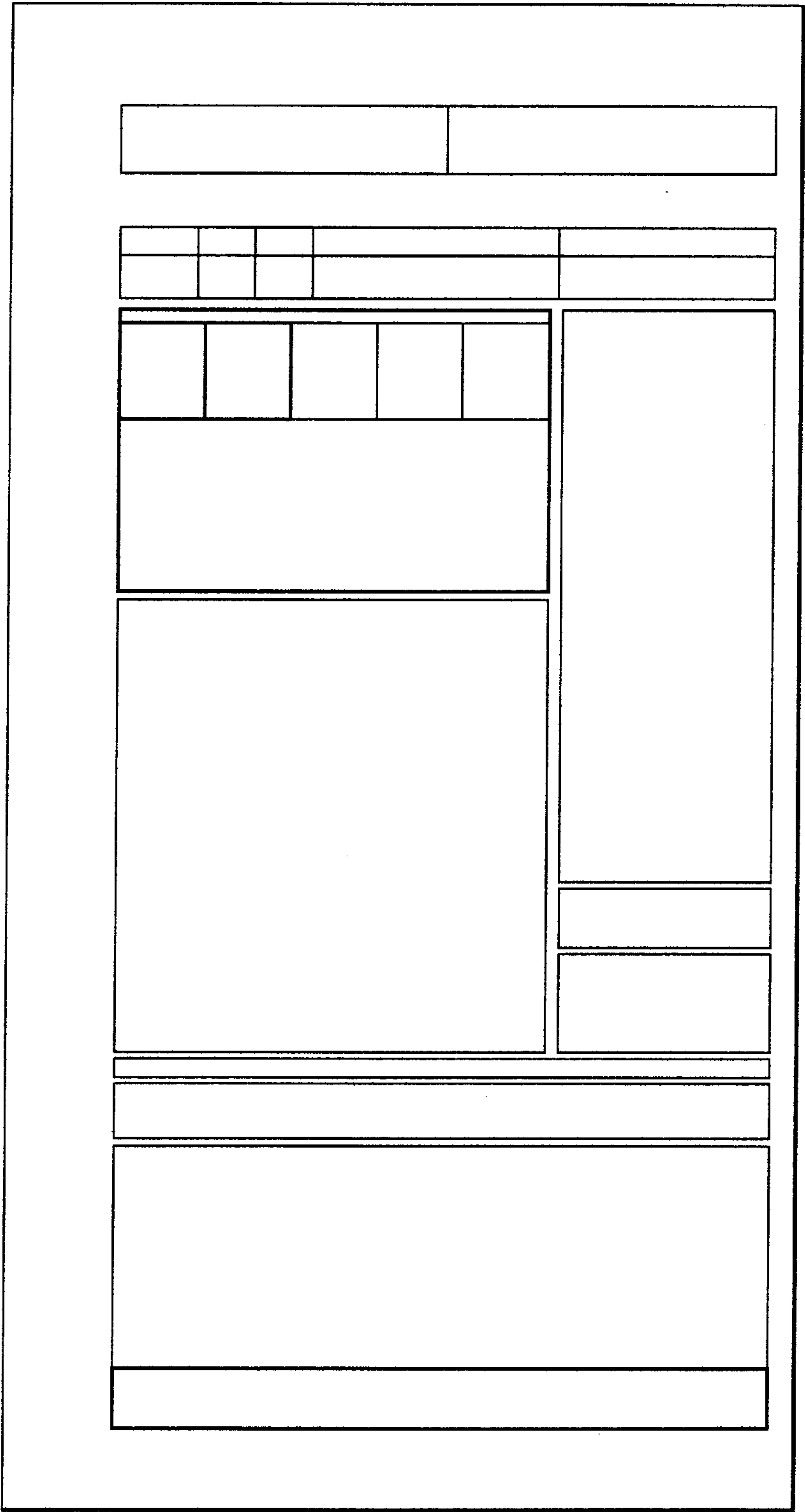

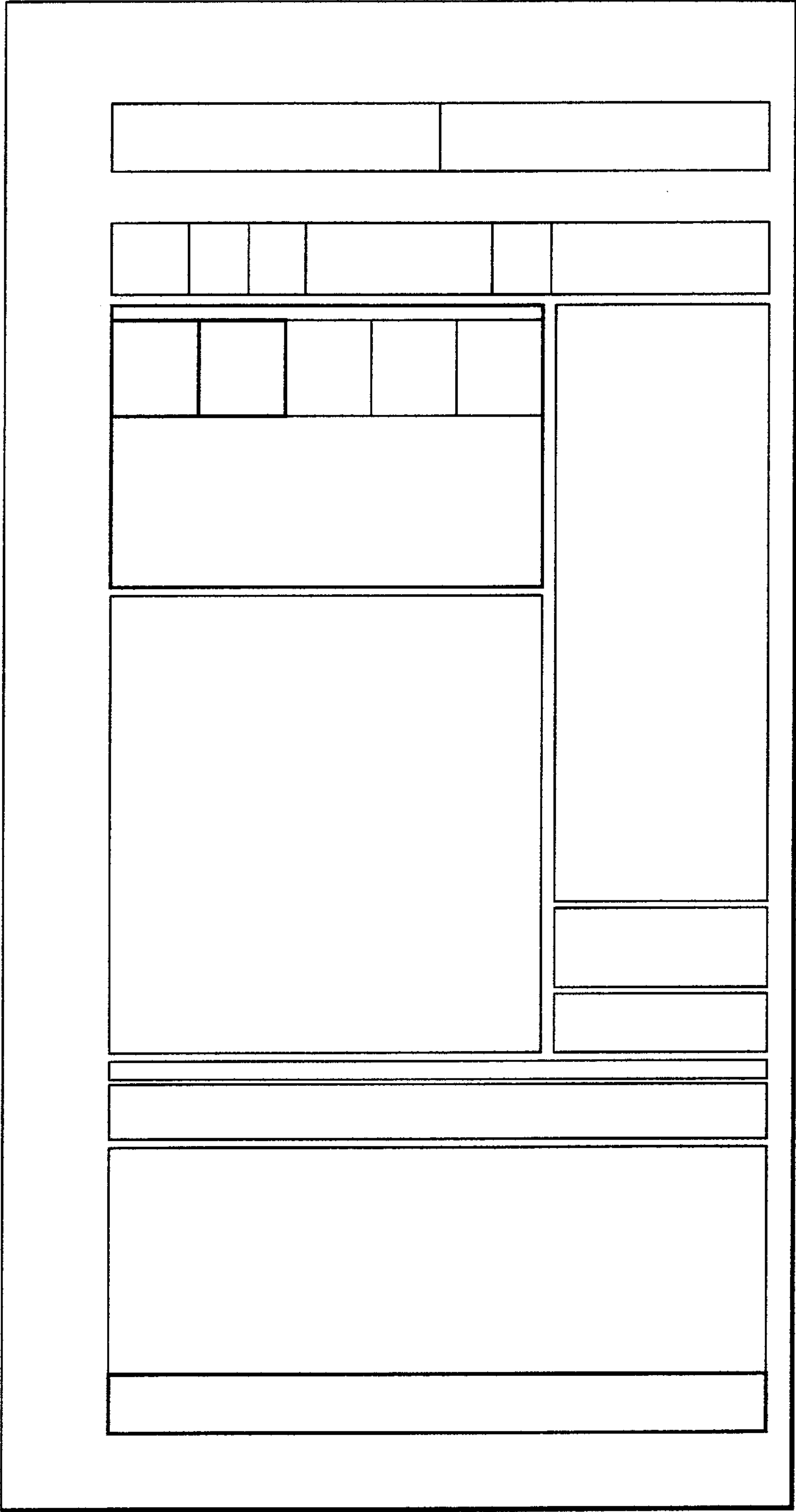

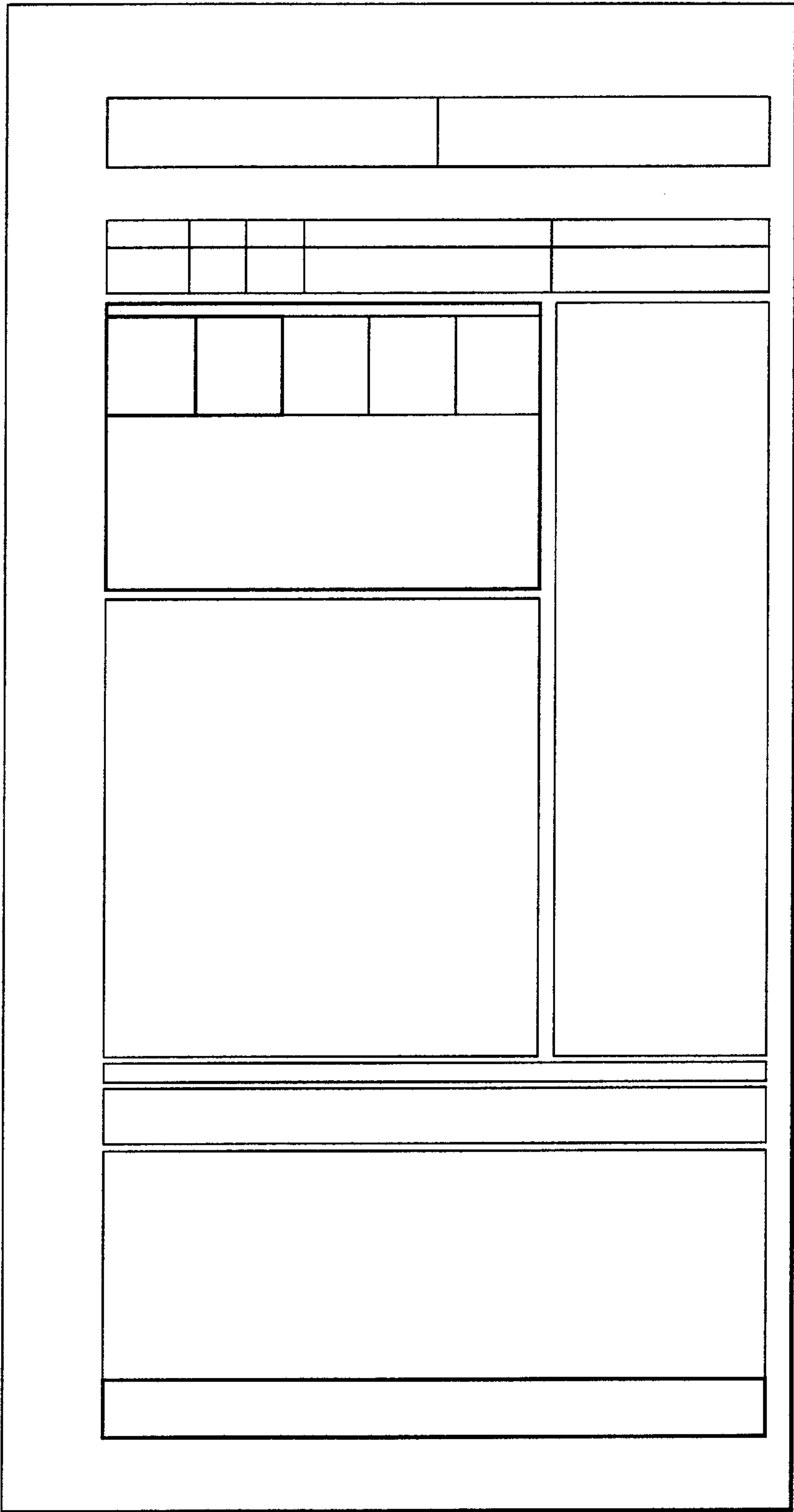

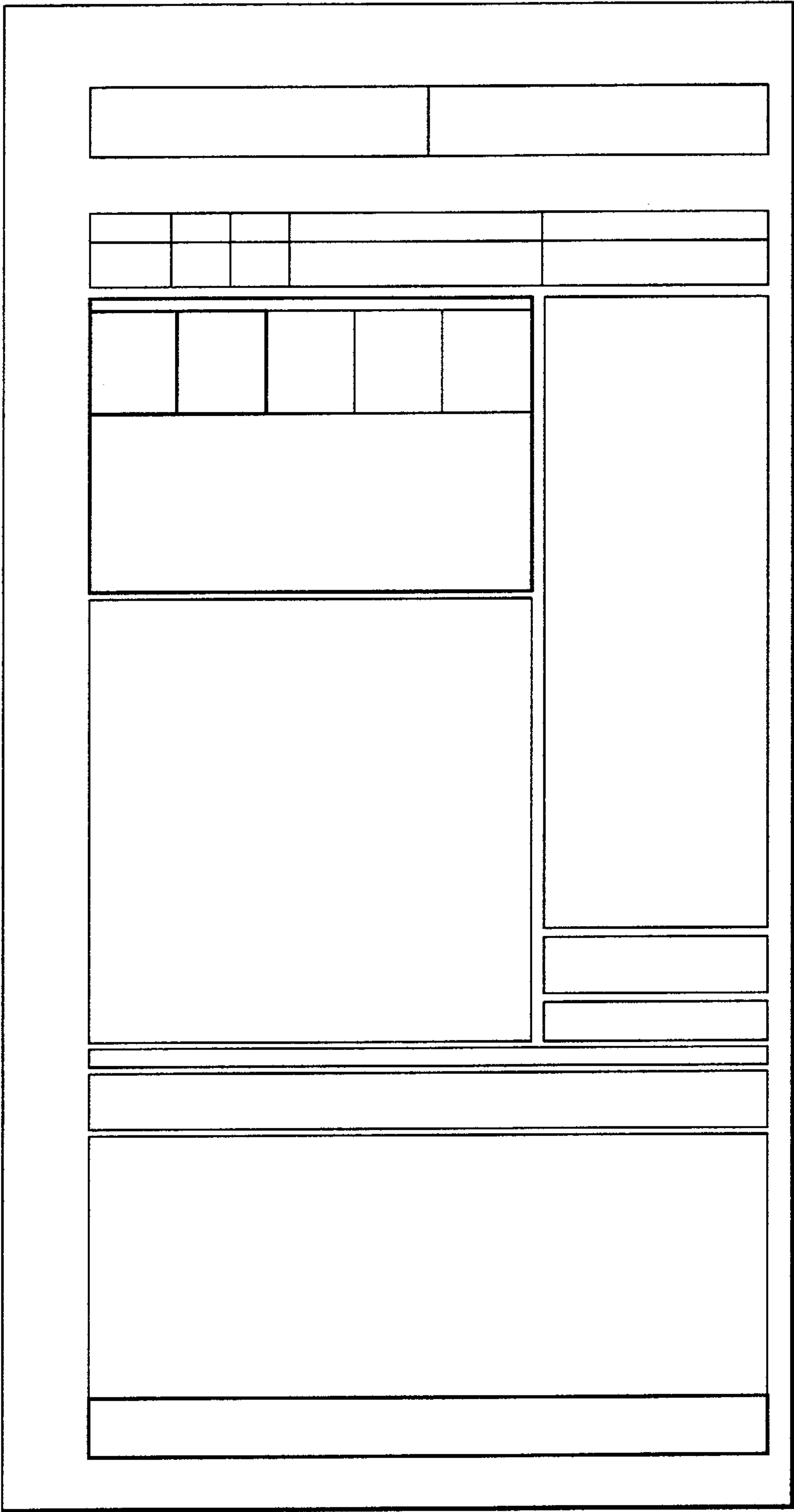

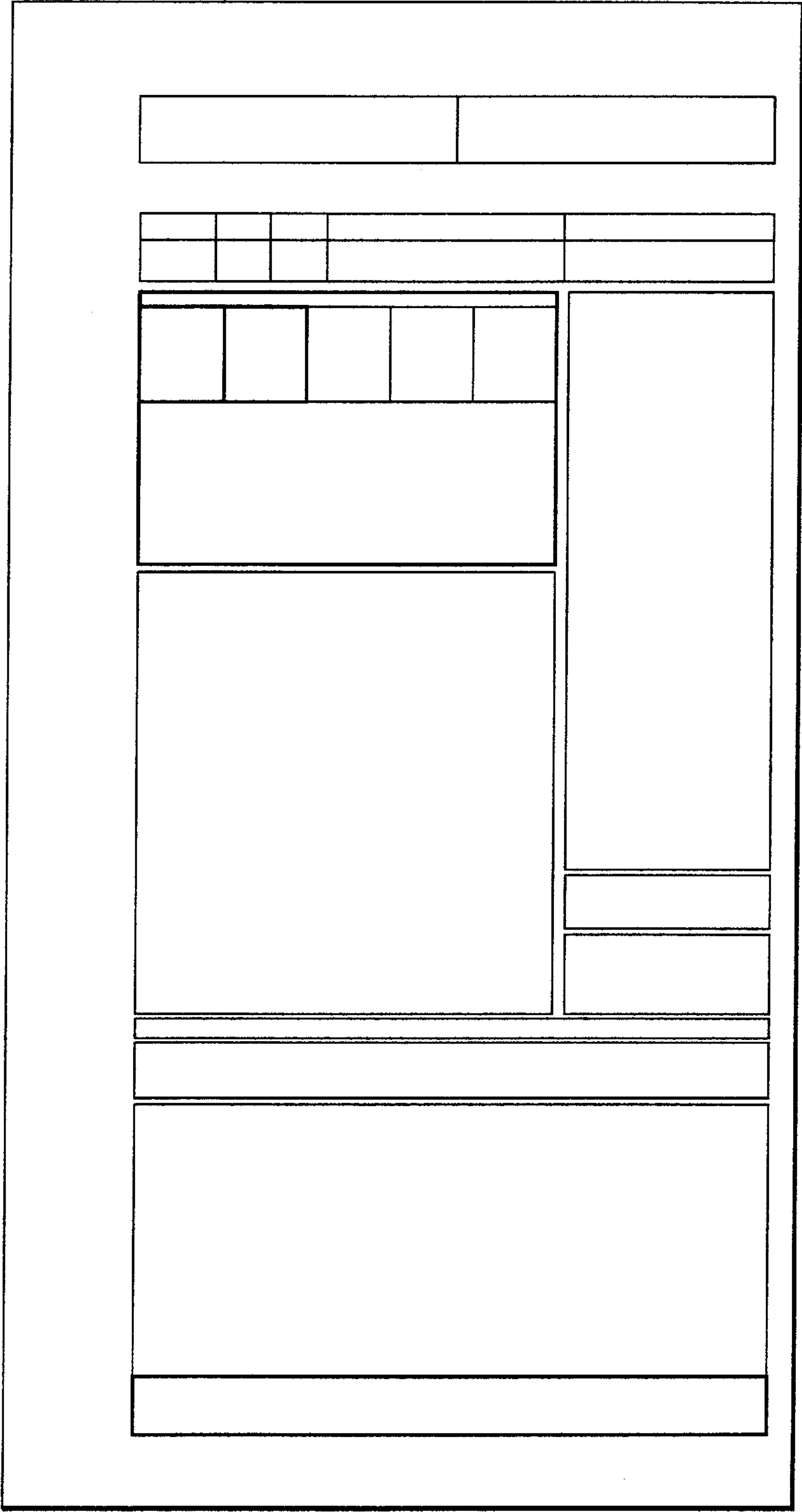

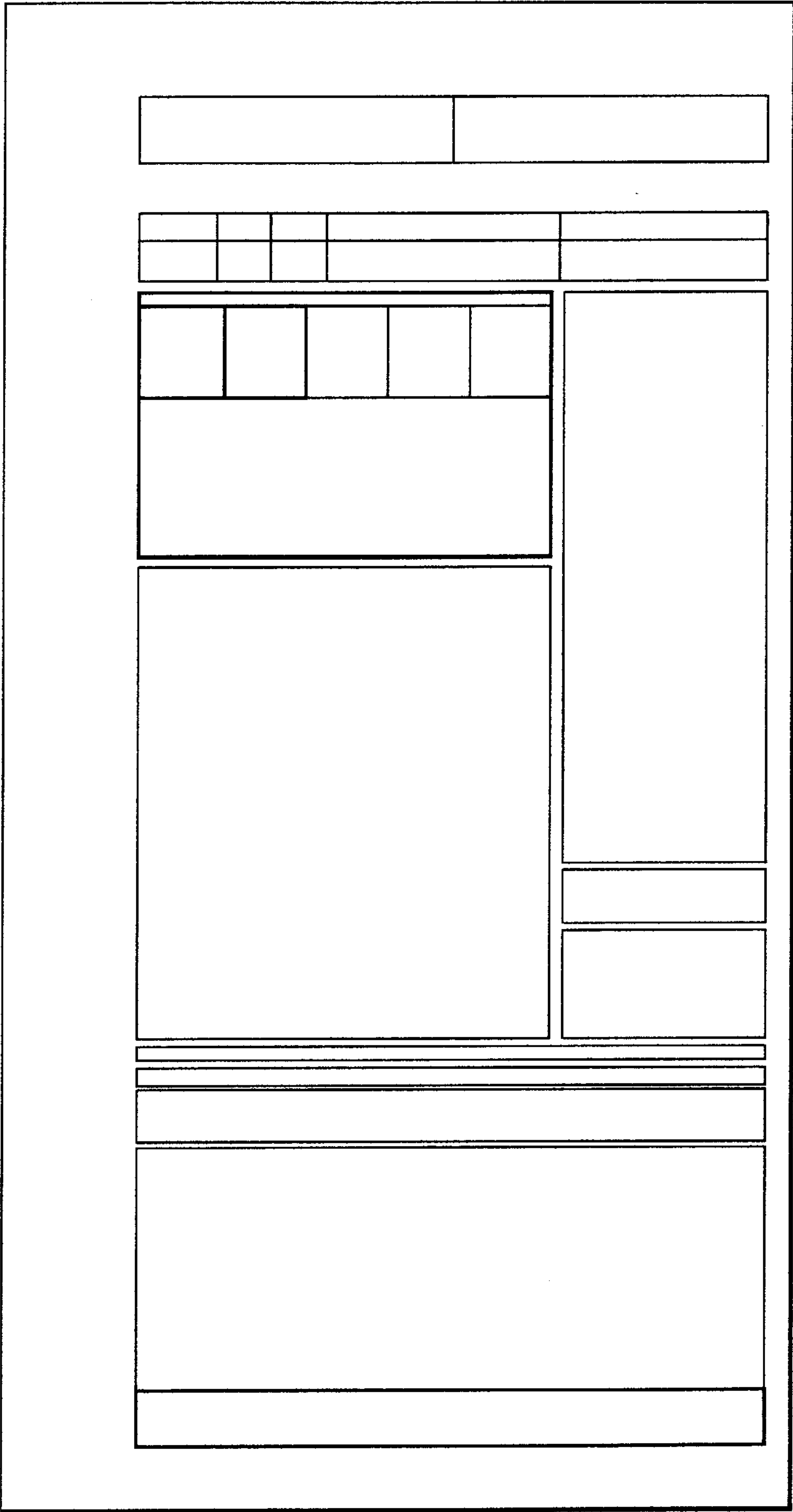

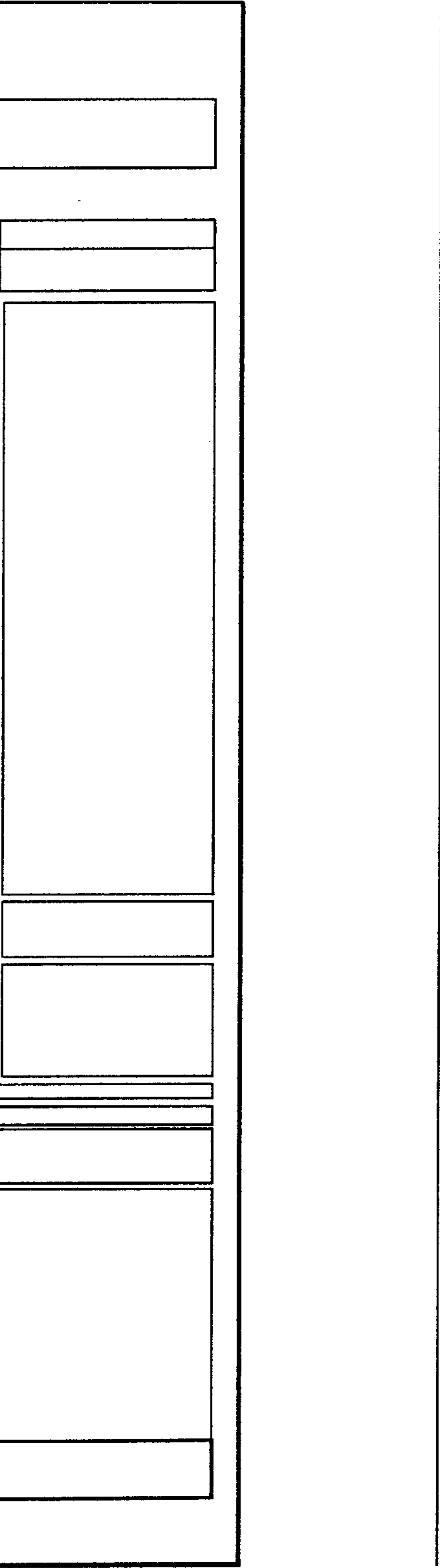

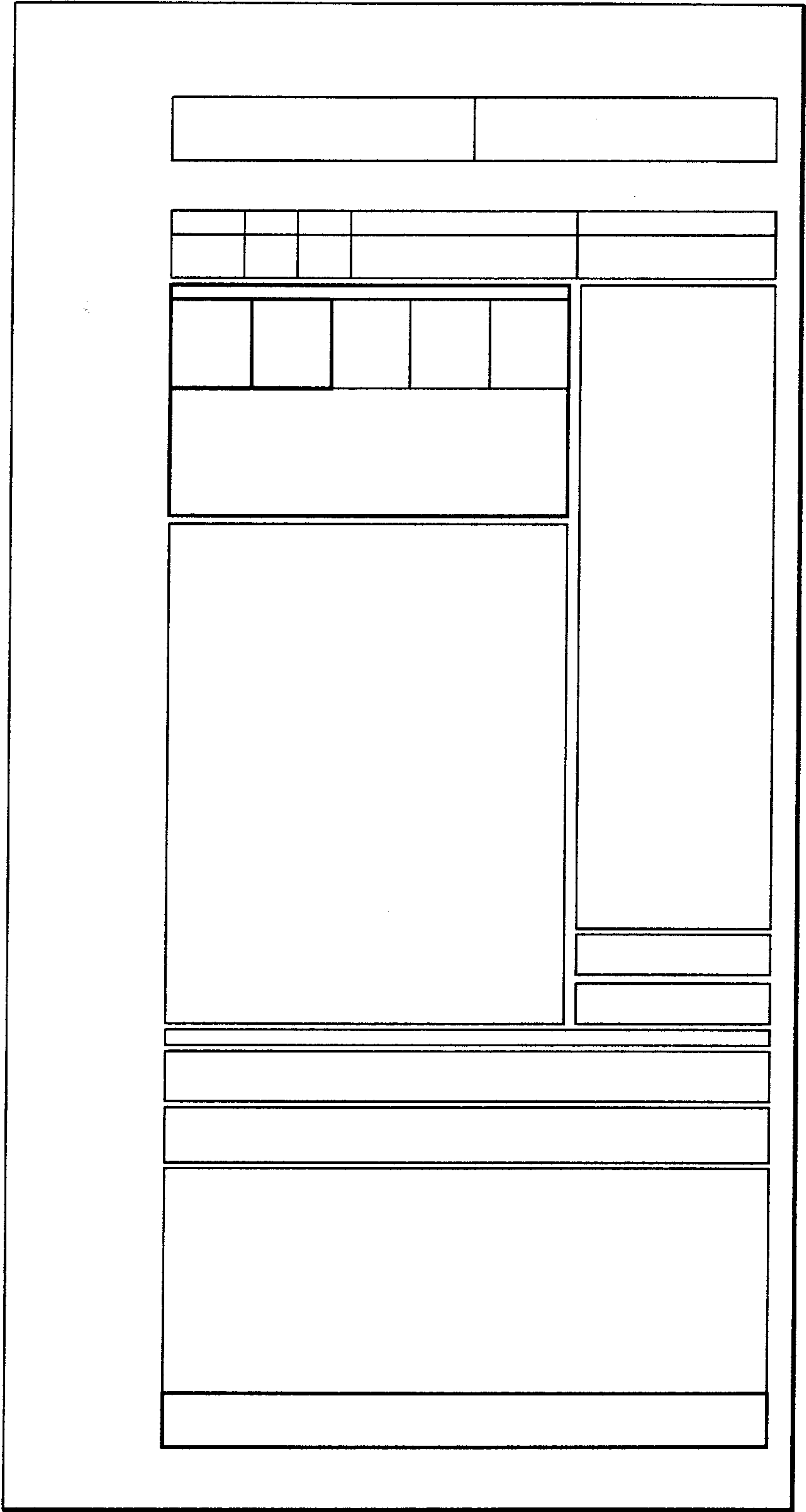

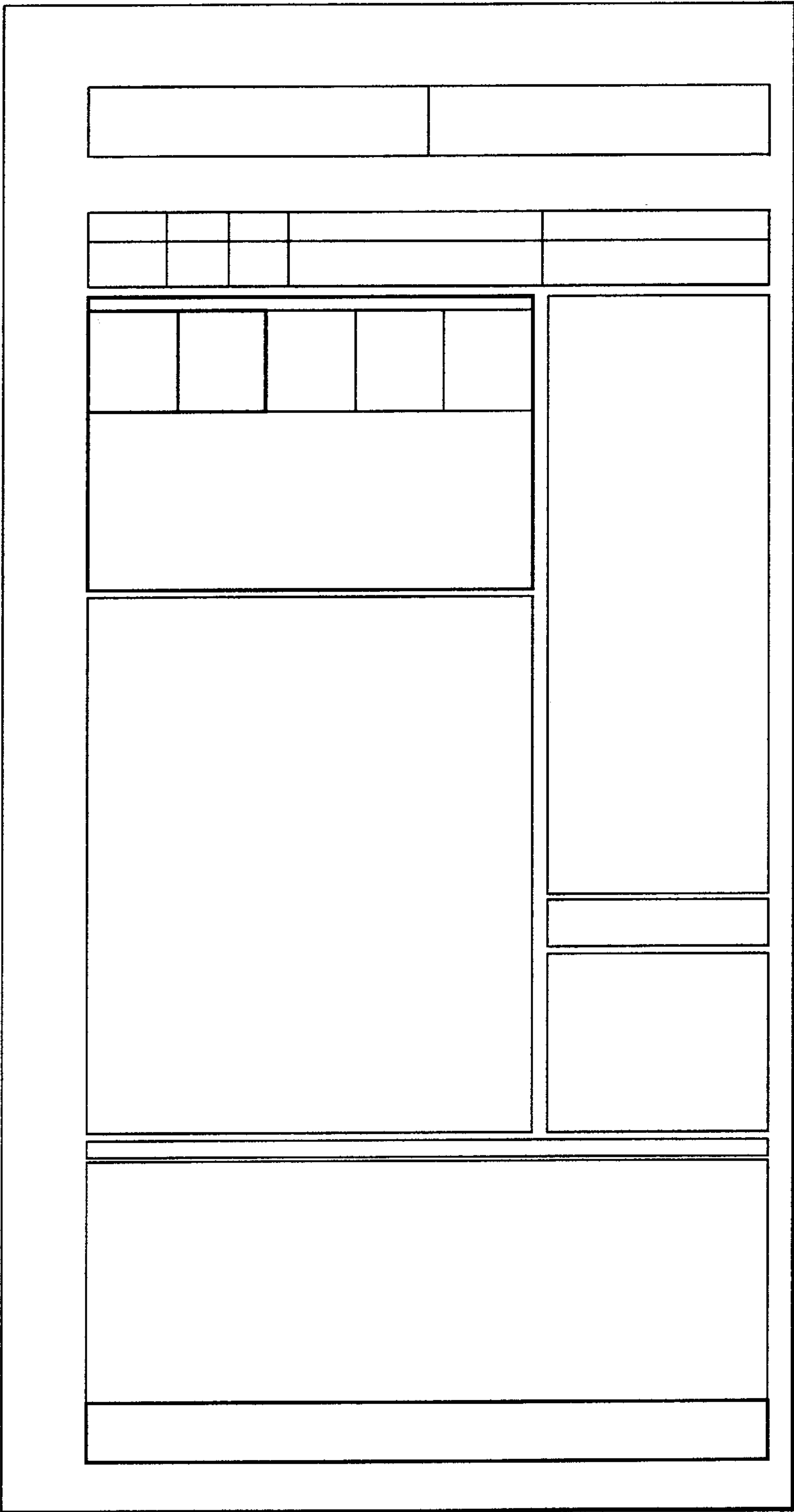

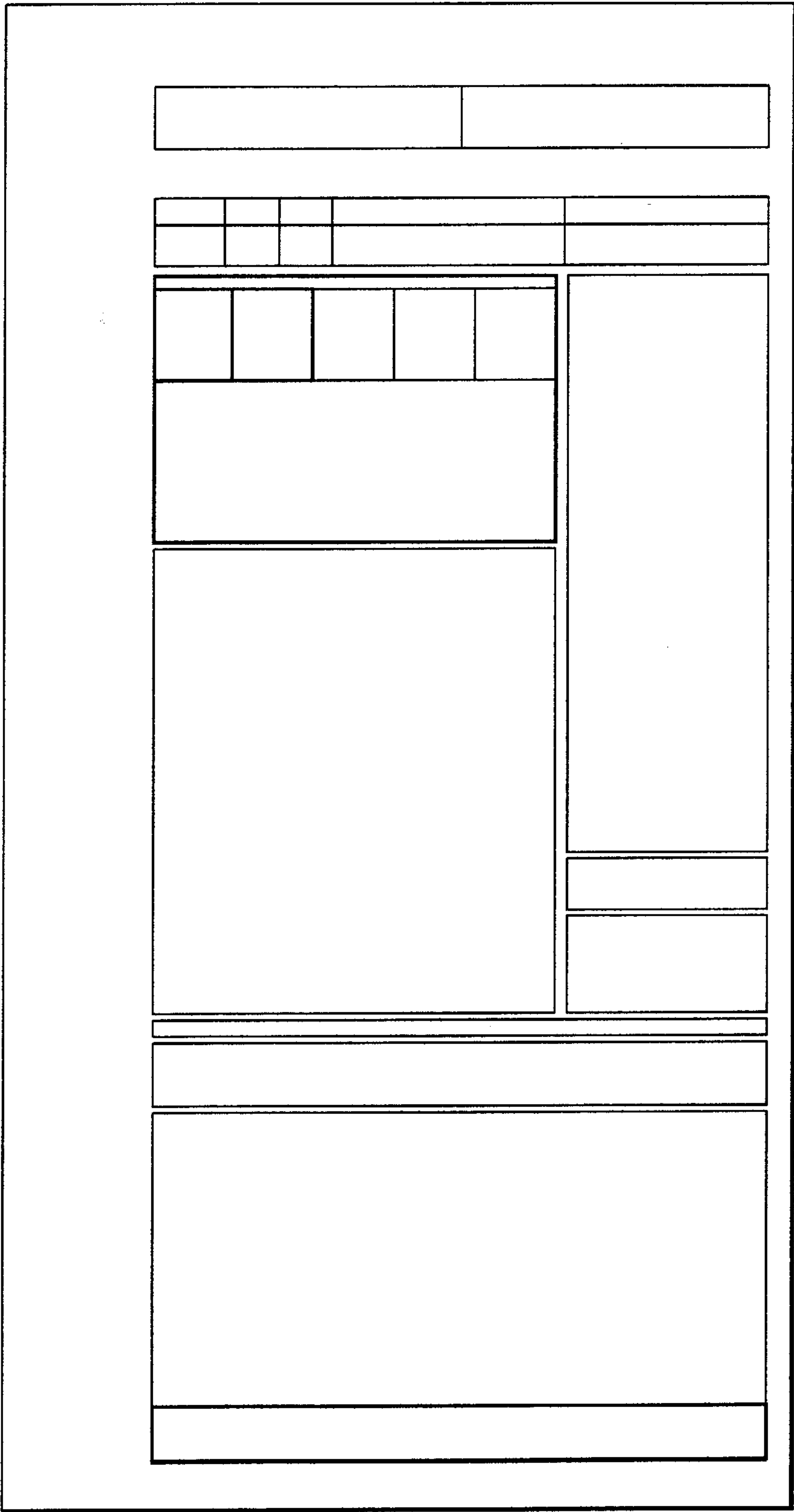

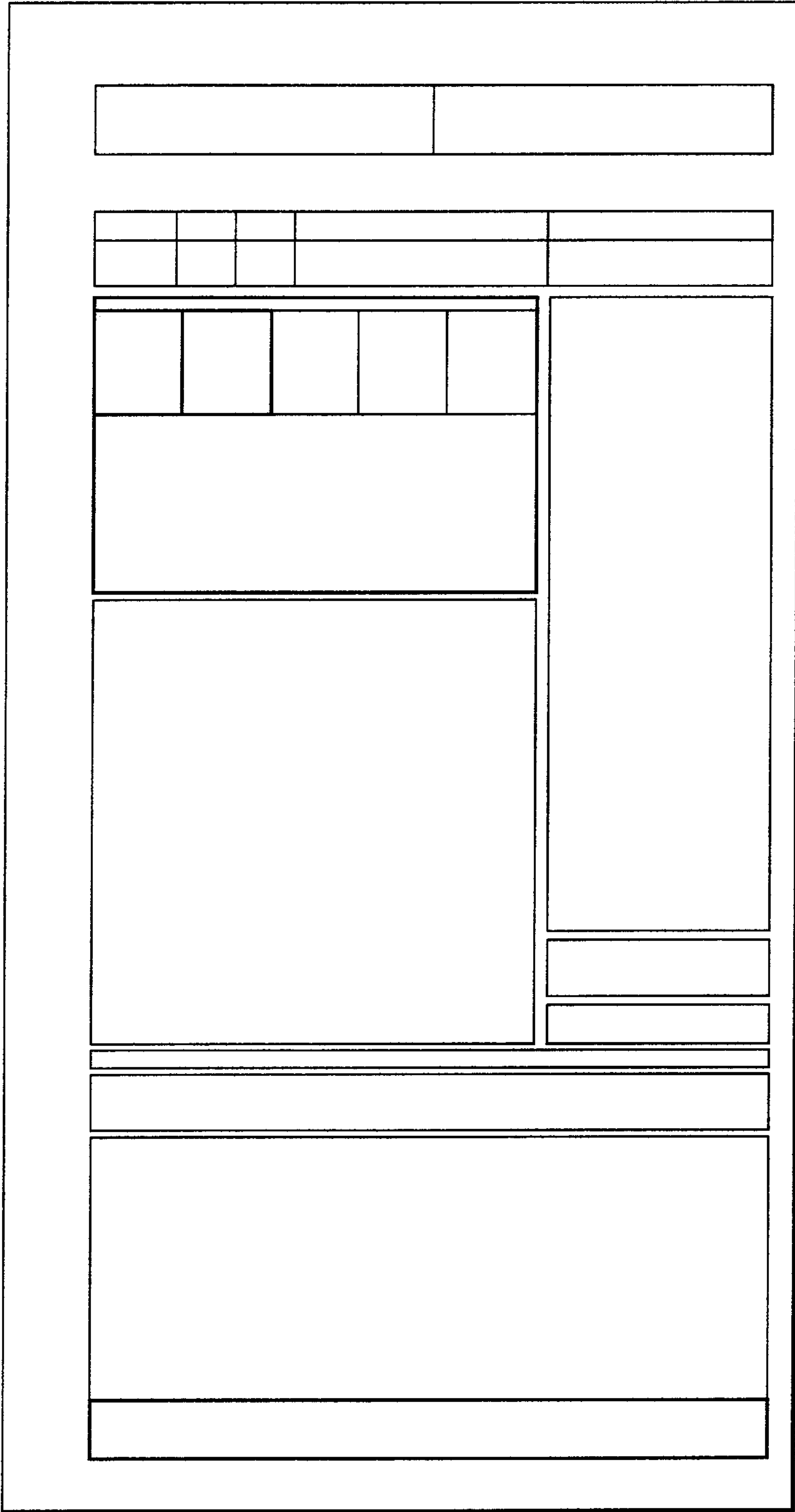

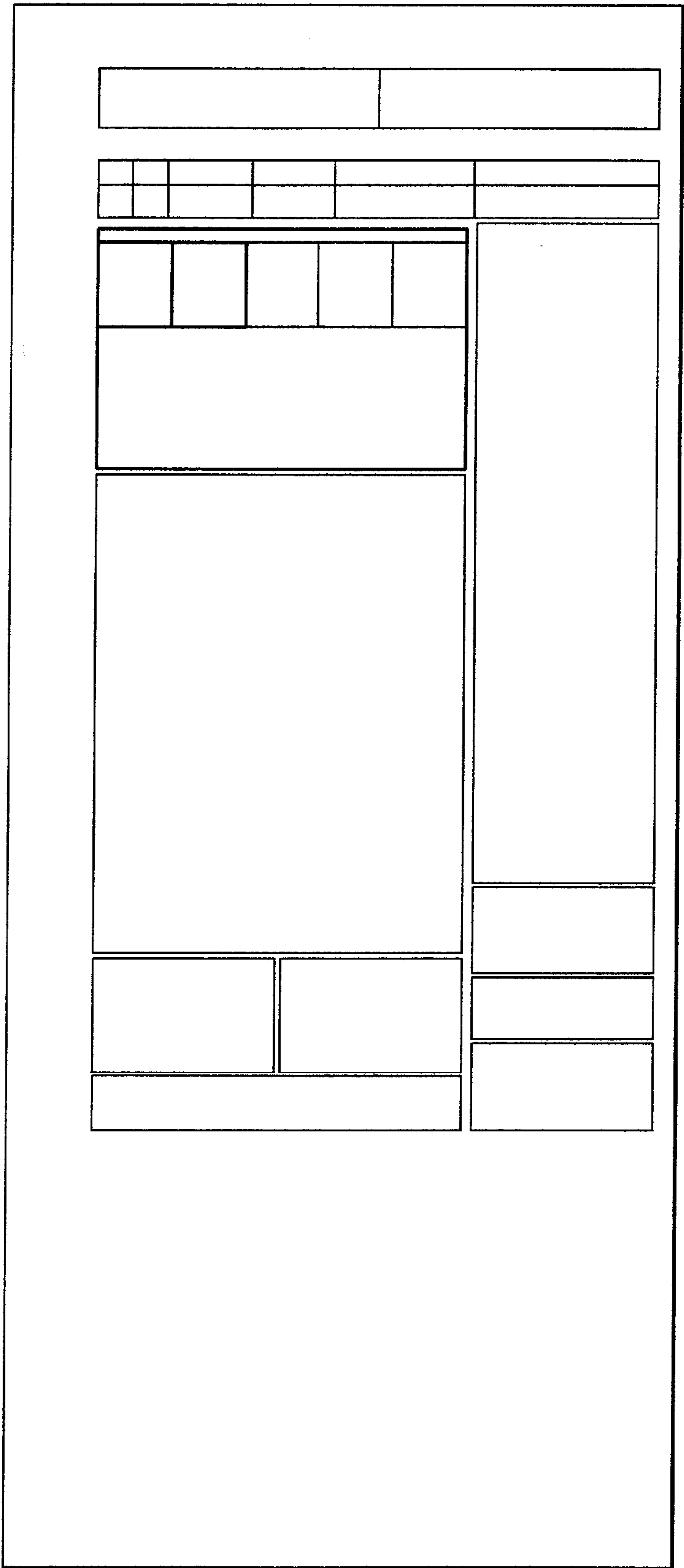

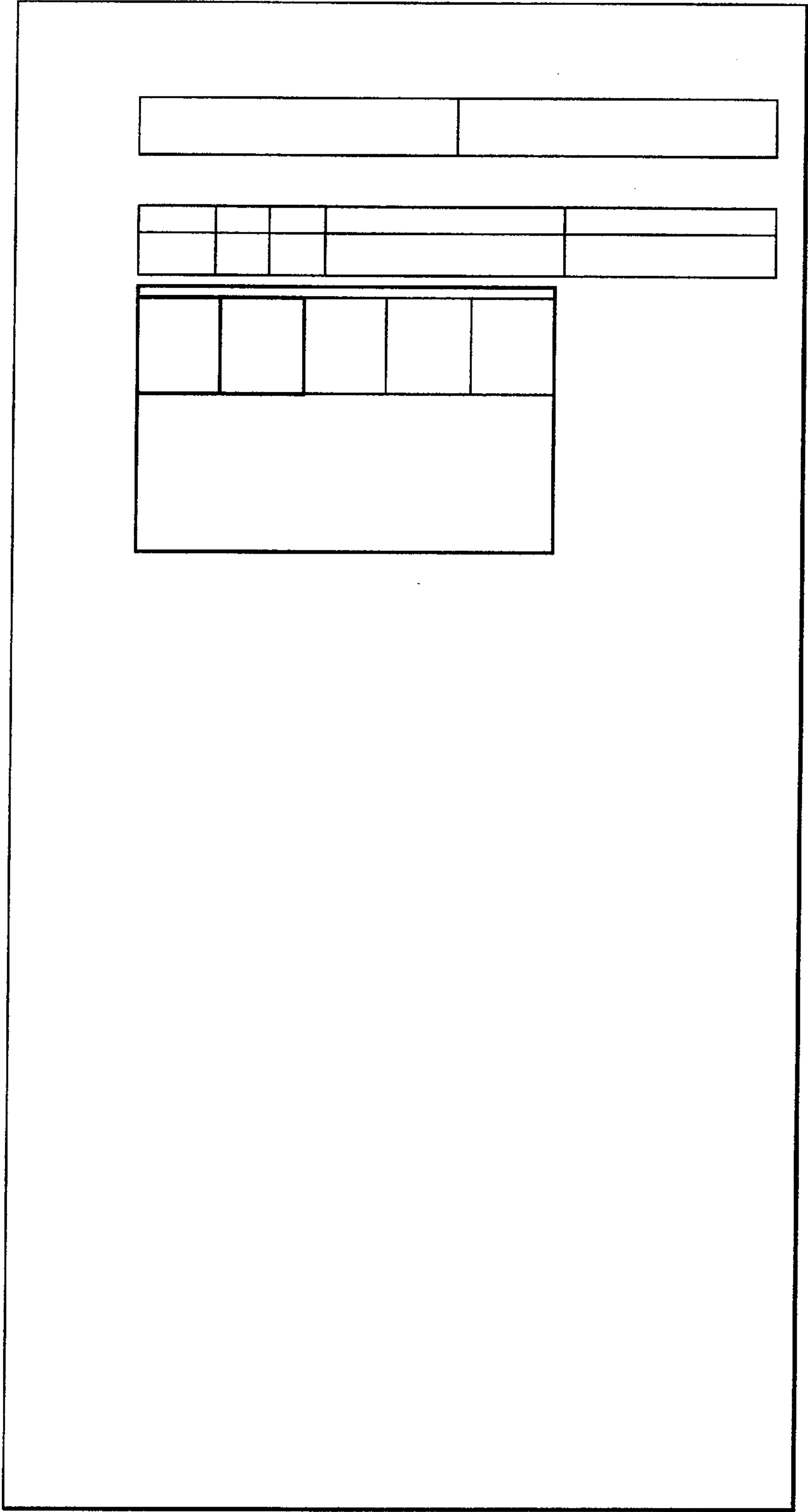
