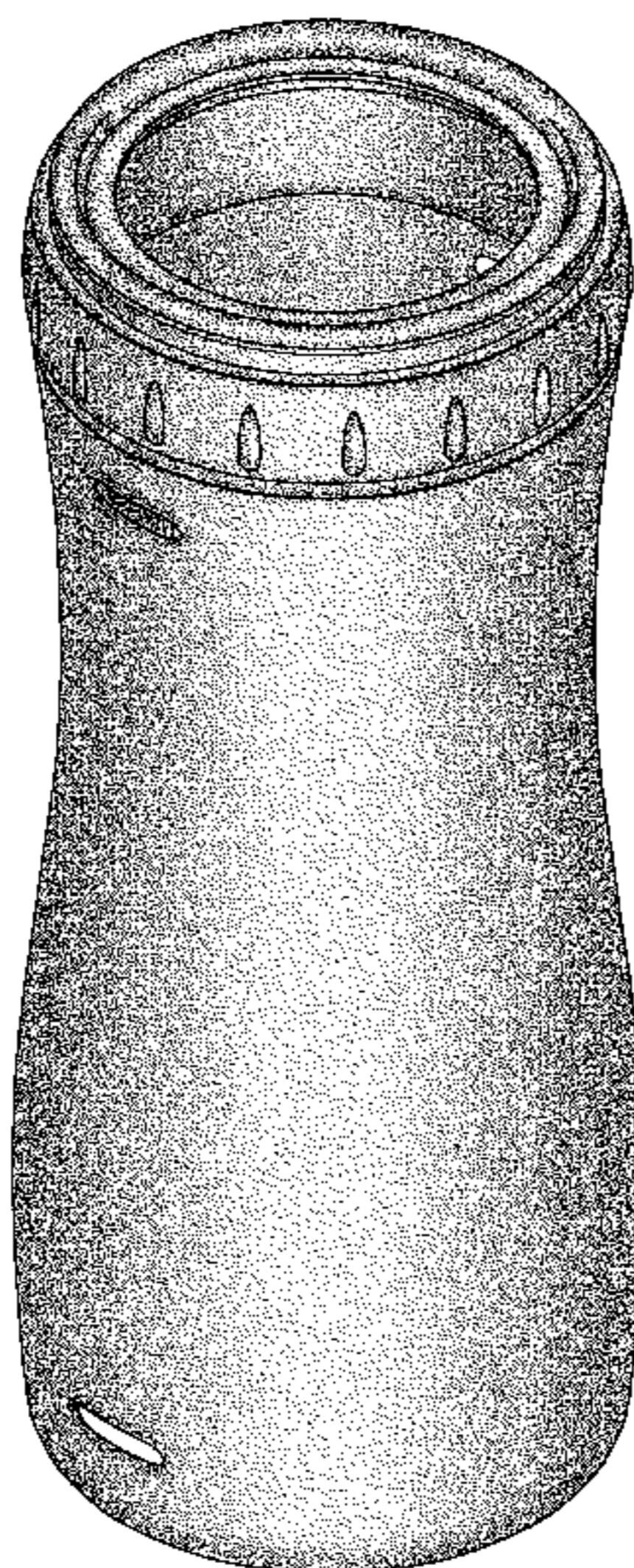
(57) **CLAIM**

The ornamental design for a combined nursing bottle holder and ring, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the combined nursing bottle holder and ring according to the present invention; FIG. 2 is a side view of the combined nursing bottle holder and ring of FIG. 1, the opposite side being identical; FIG. 3 is a front view of the combined nursing bottle holder and ring of FIG. 1; FIG. 4 is a top view of the combined nursing bottle holder and ring of FIG. 1; FIG. 5 is a bottom view of the combined nursing bottle holder and ring of FIG. 1; and, FIG. 6 is a bottom perspective view of the combined nursing bottle holder and ring of FIG. 1.

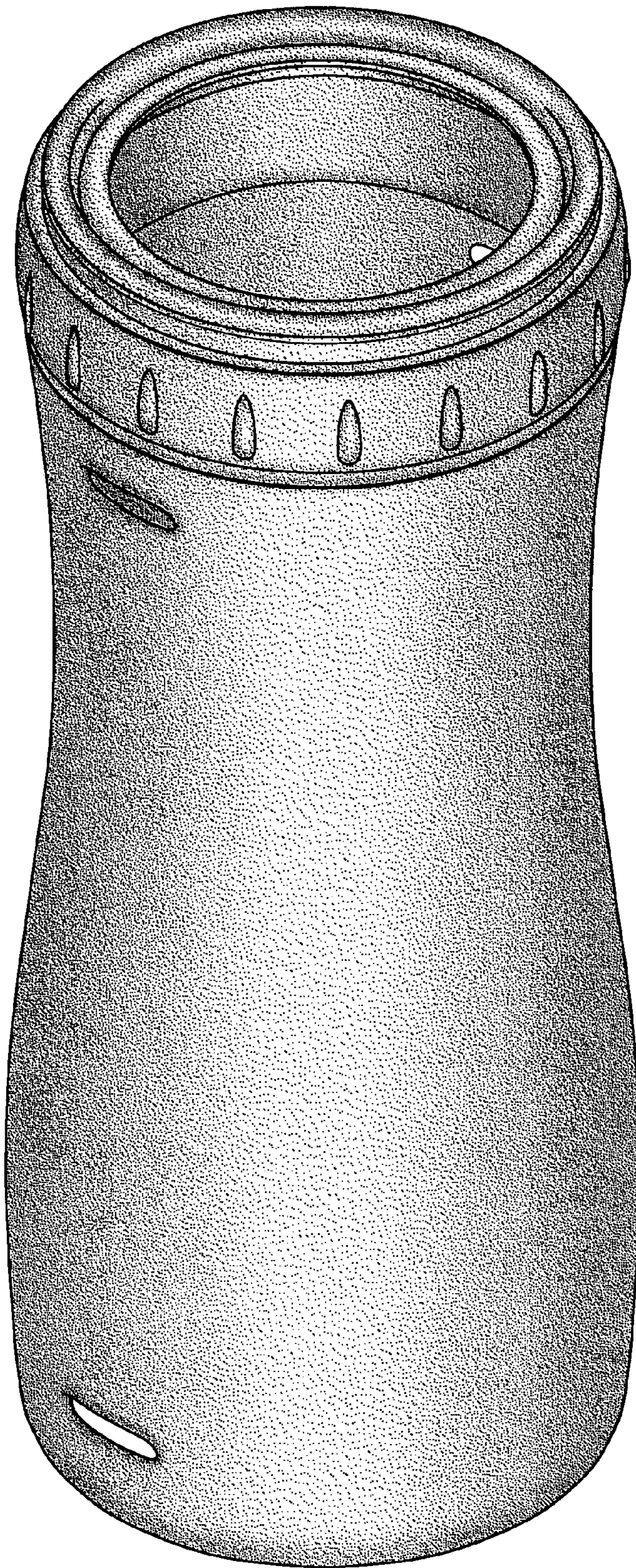

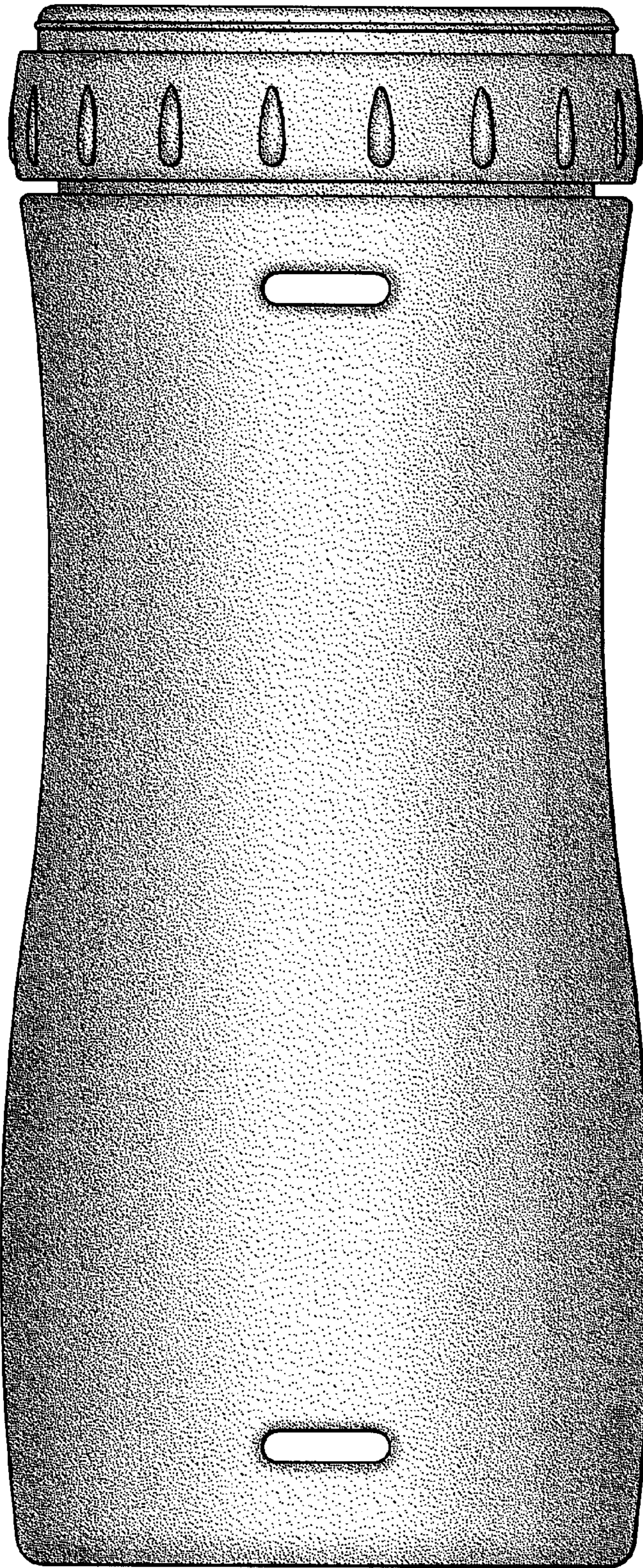

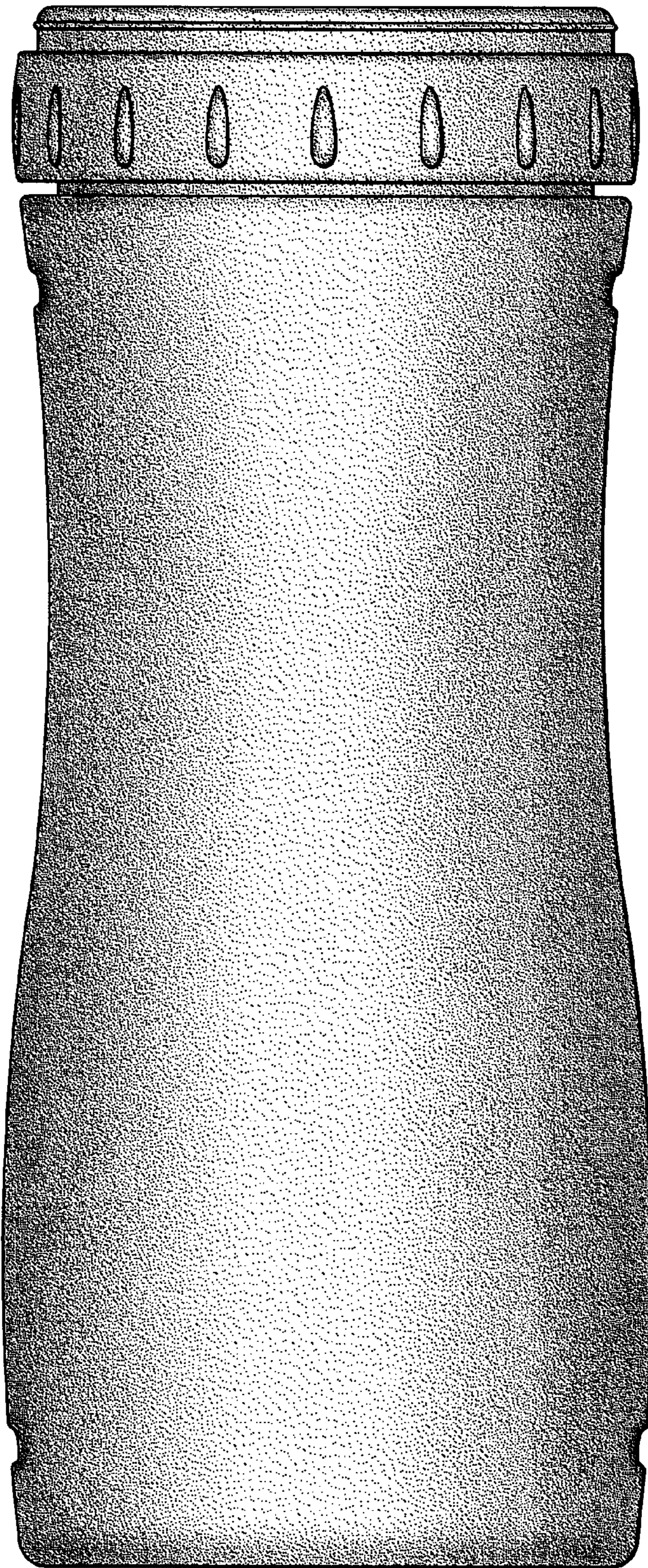

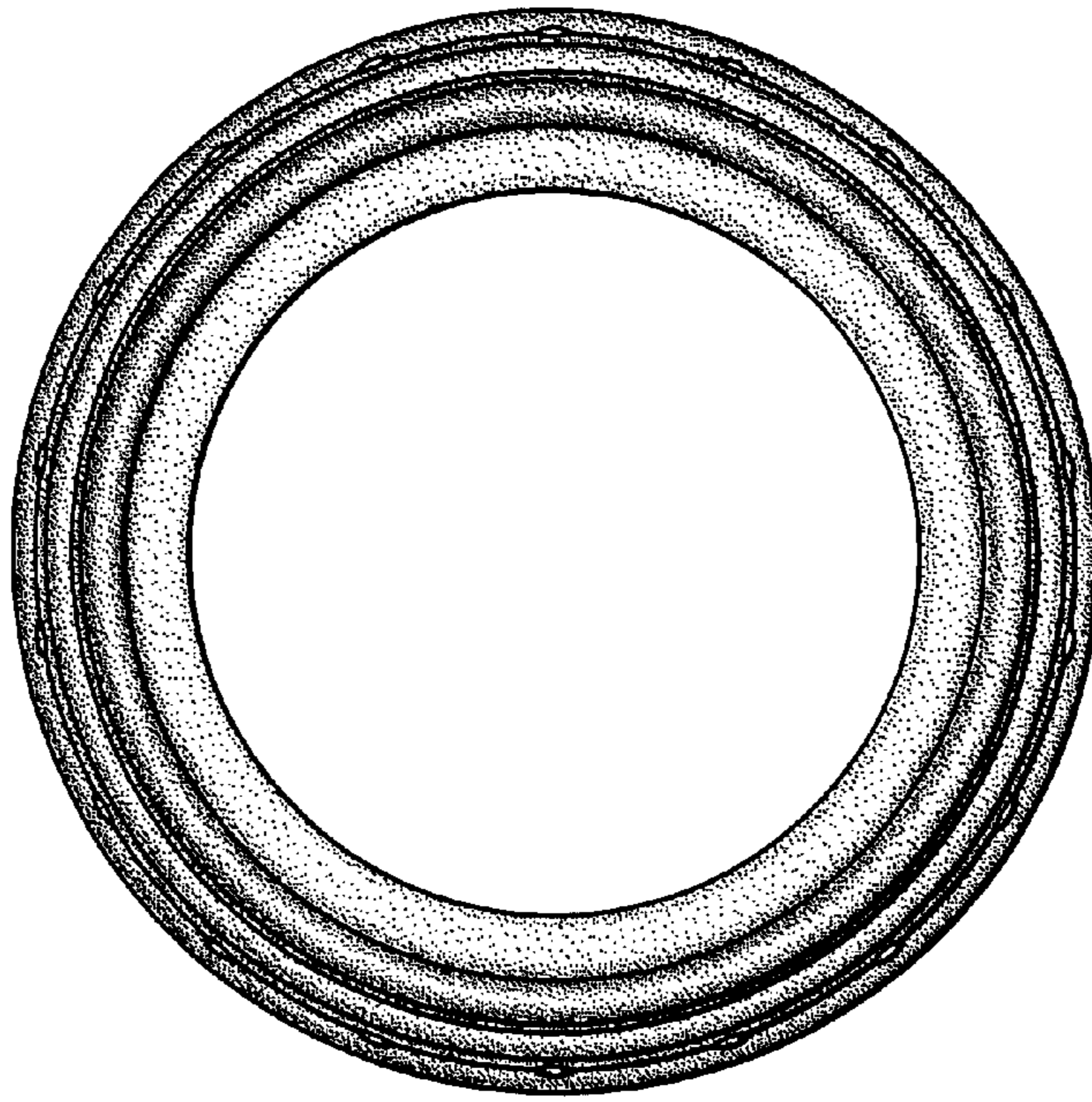

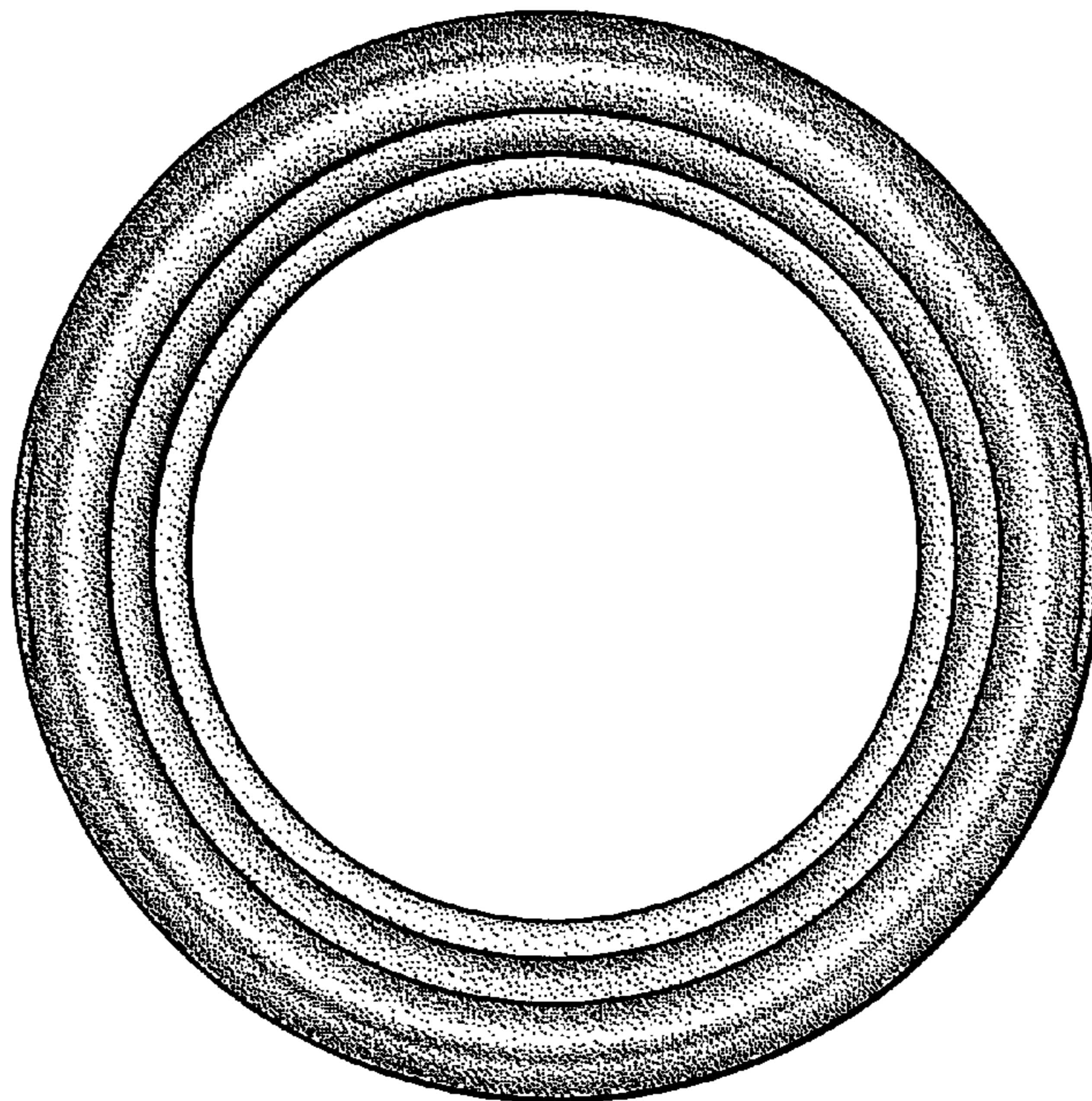

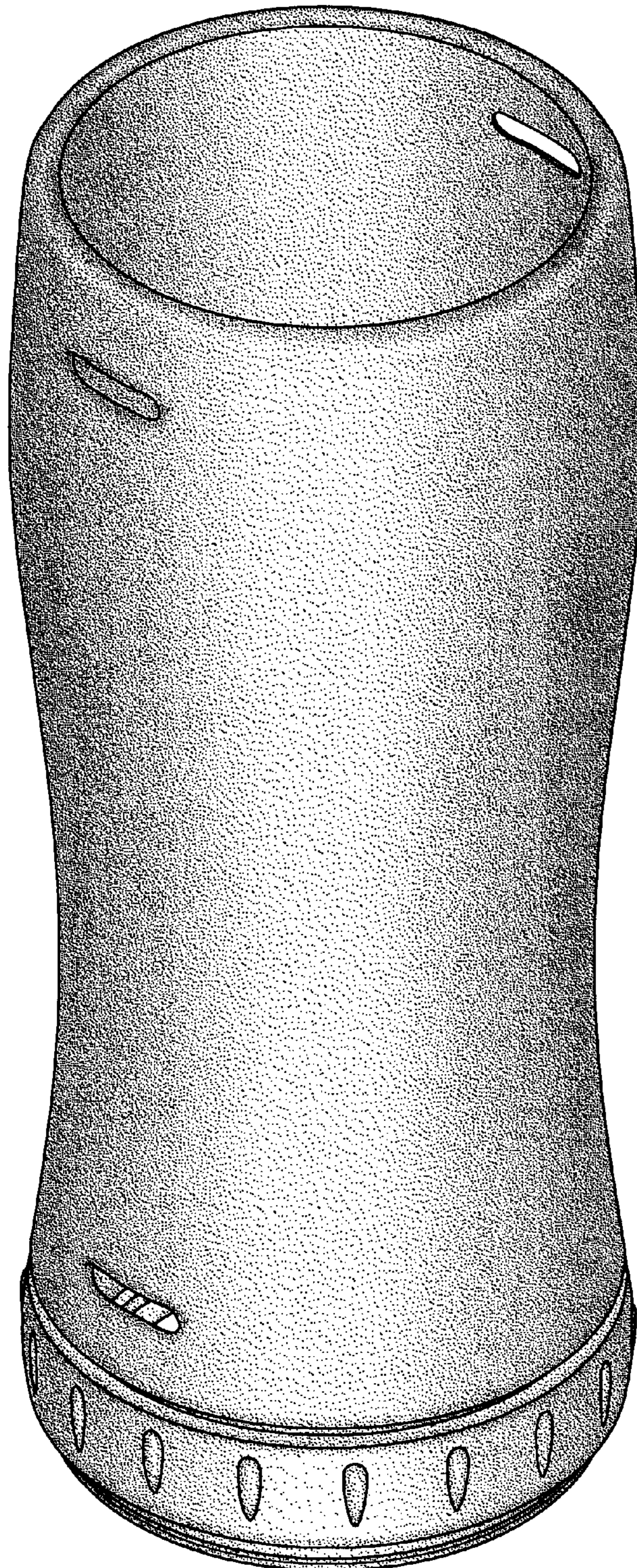
