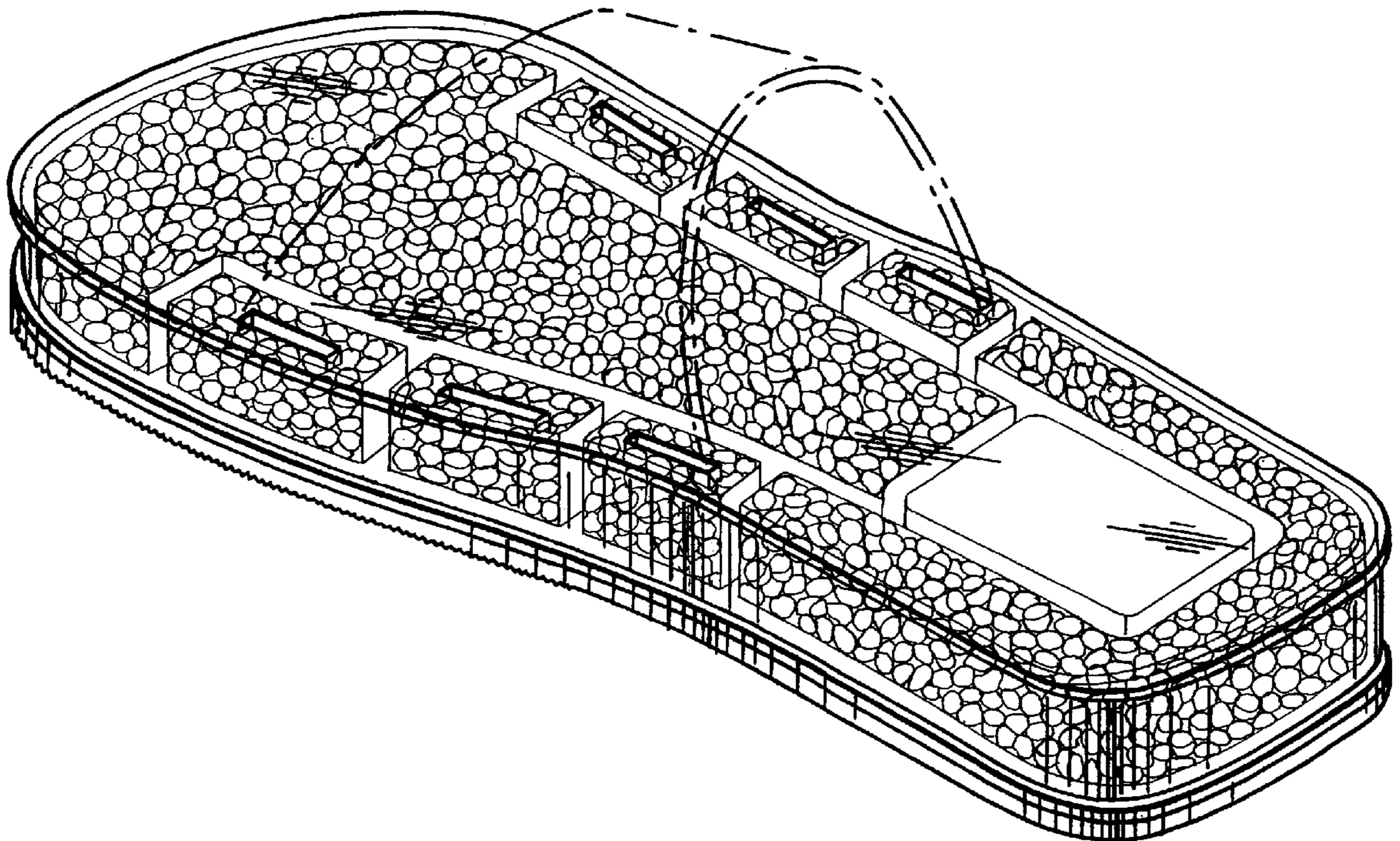
(57) **CLAIM**

The ornamental design for a bean bag shoe lower, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, of the bean bag shoe lower; FIG. 2 is a top plan view of the bean bag shoe lower of FIG. 1; FIG. 3 is a right side view of the bean bag shoe lower of FIG. 2; FIG. 4 is a left side view of the bean bag shoe lower of FIG. 2; FIG. 5 is a bottom plan view of the bean bag shoe lower of FIG. 1; FIG. 6 a front view of the bean bag show lower of FIG. 2; FIG. 7 is a rear view of the bean bag show lower of FIG. 2; and, FIG. 8 is a sectional view taken along line 8—8 of FIG. 2. 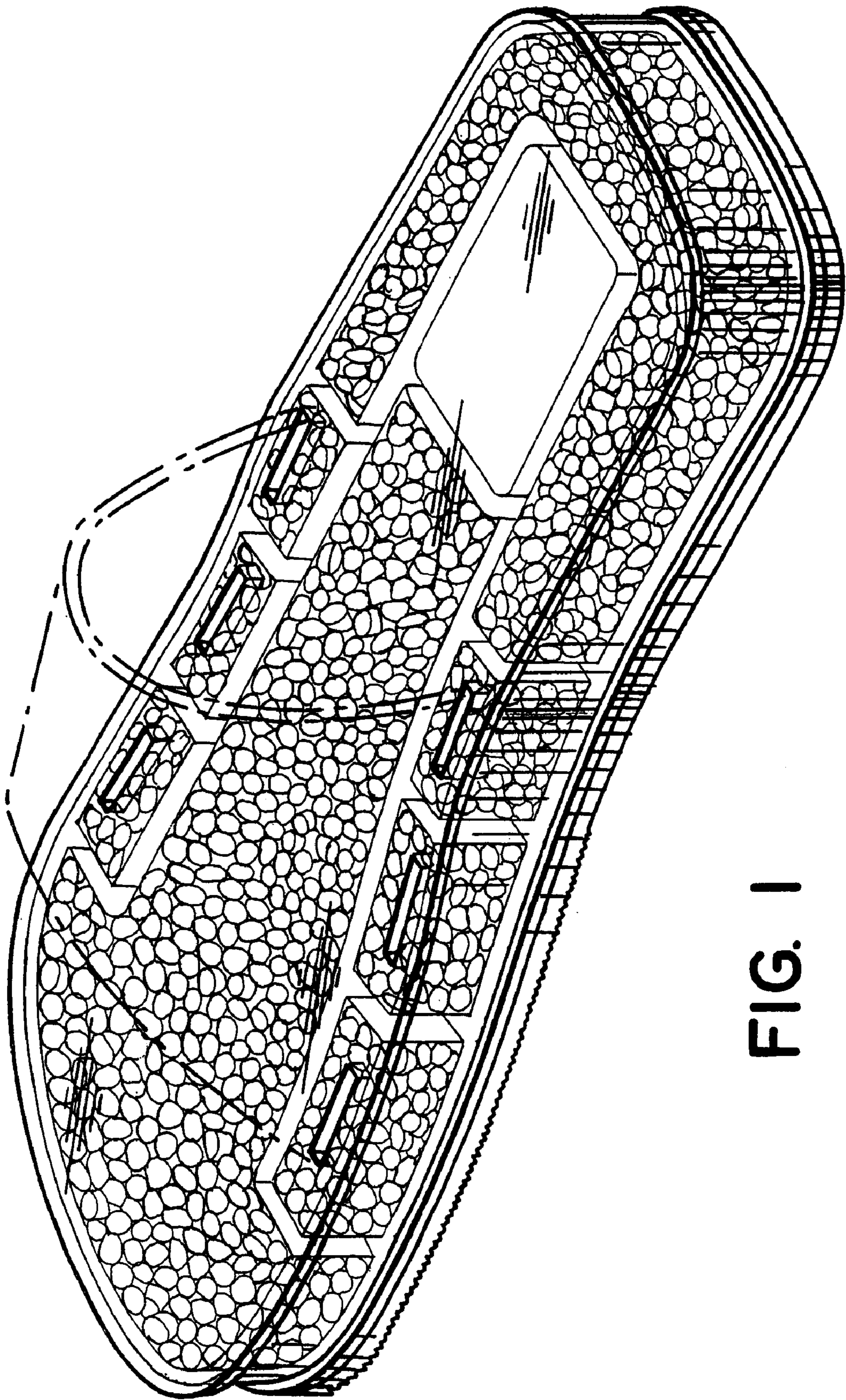

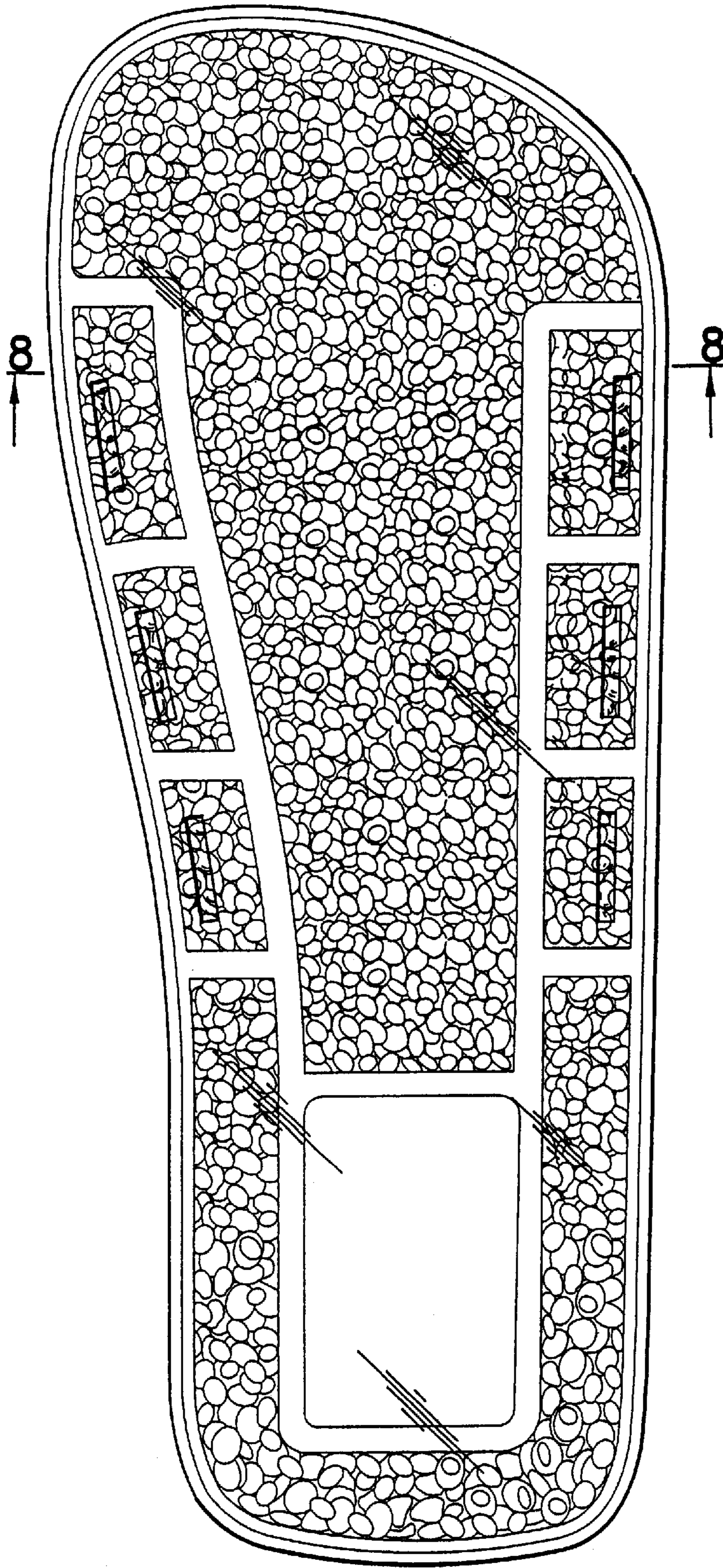

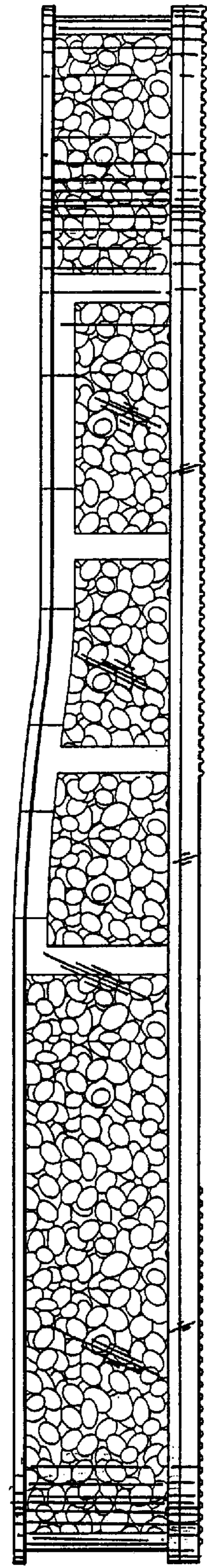

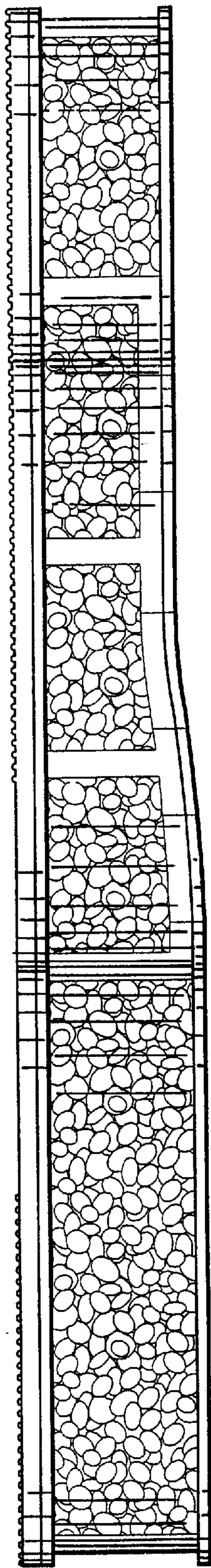

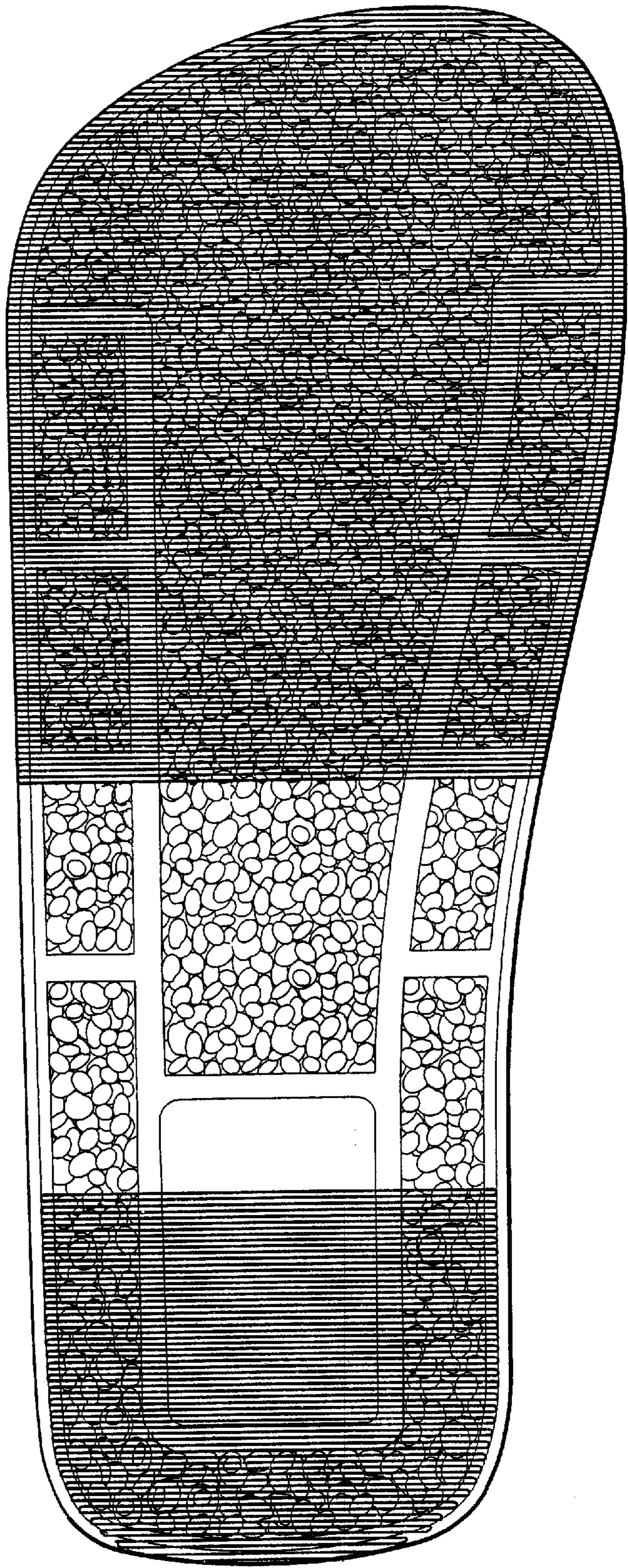

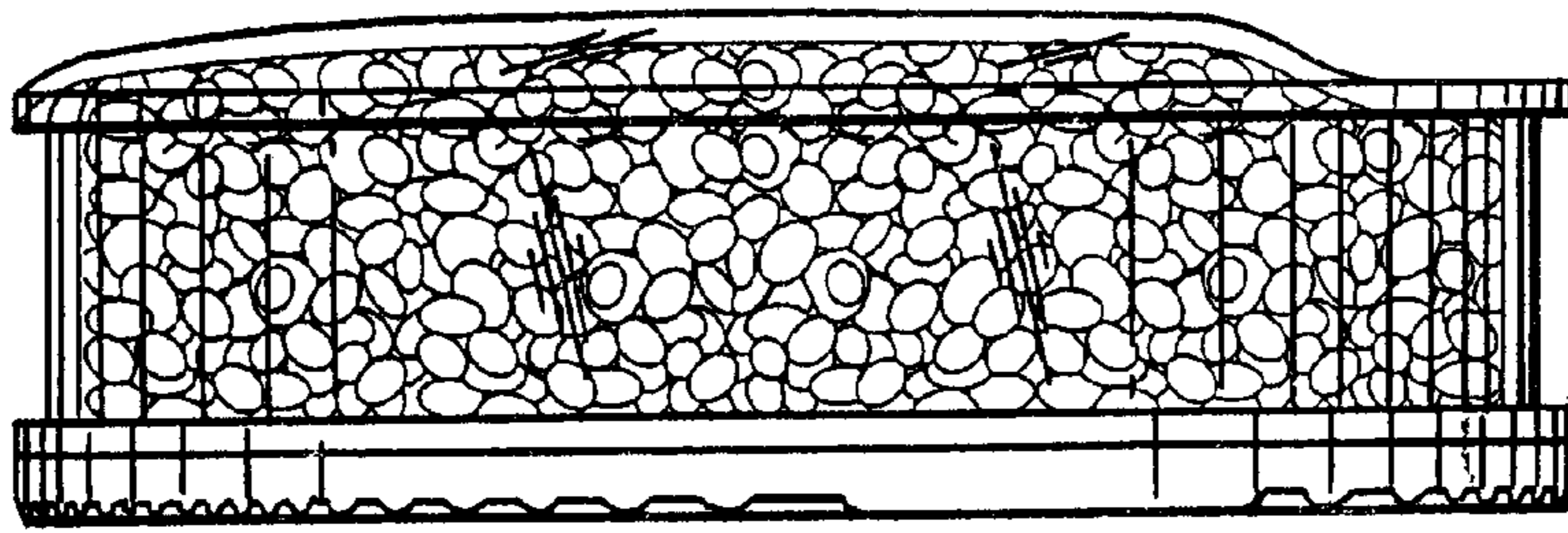

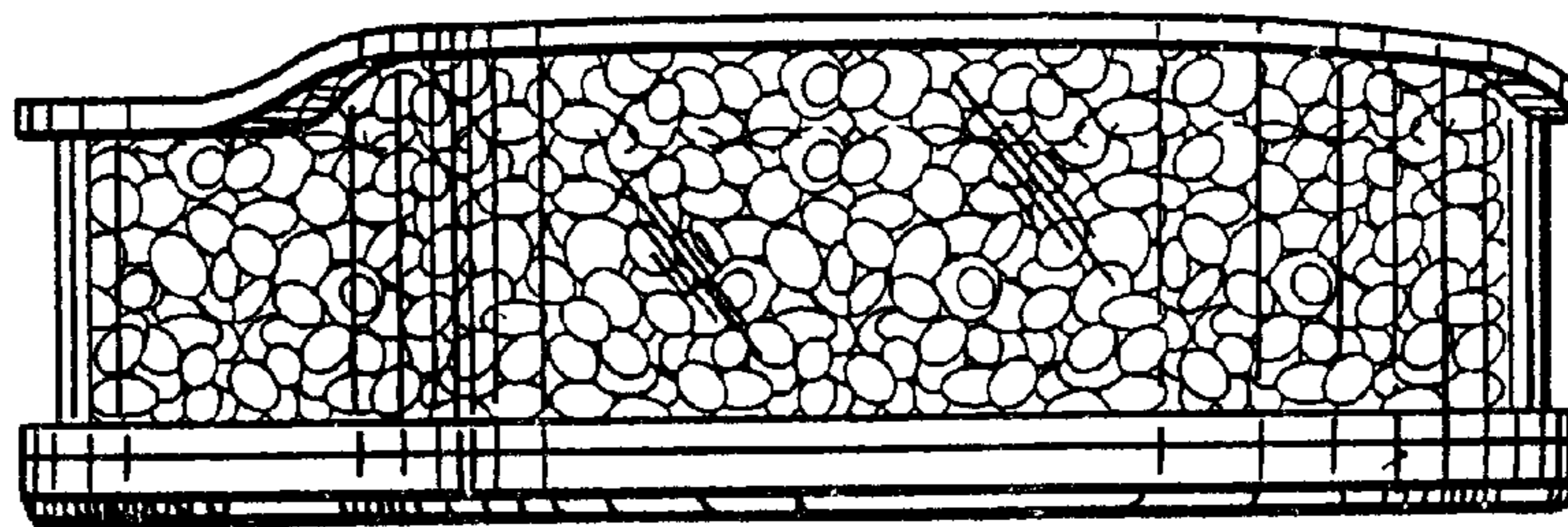

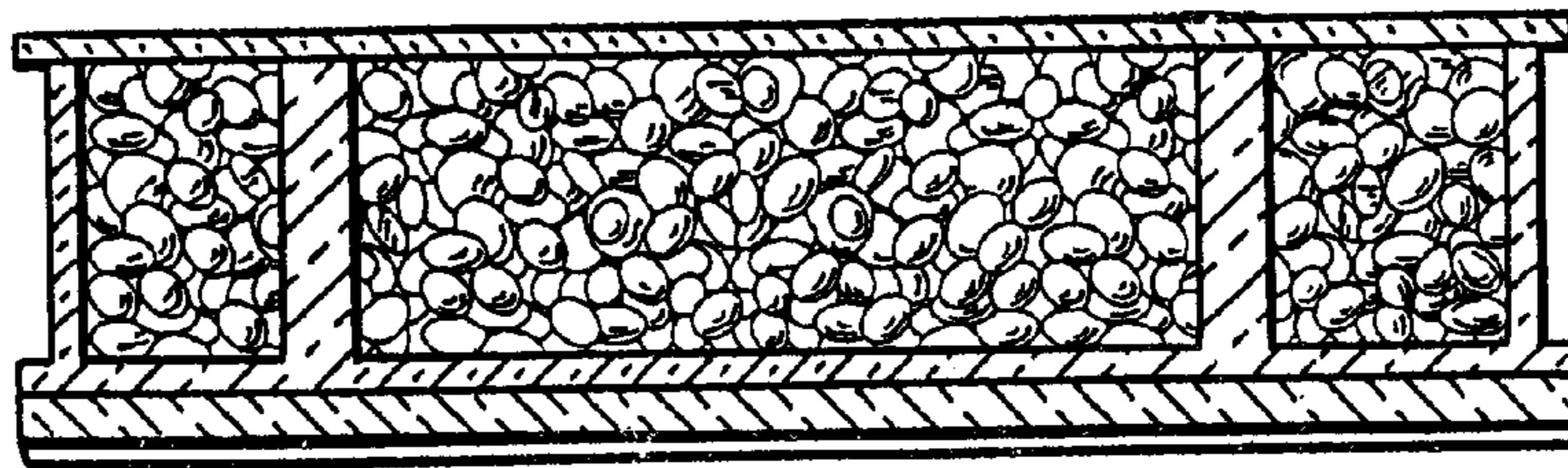
