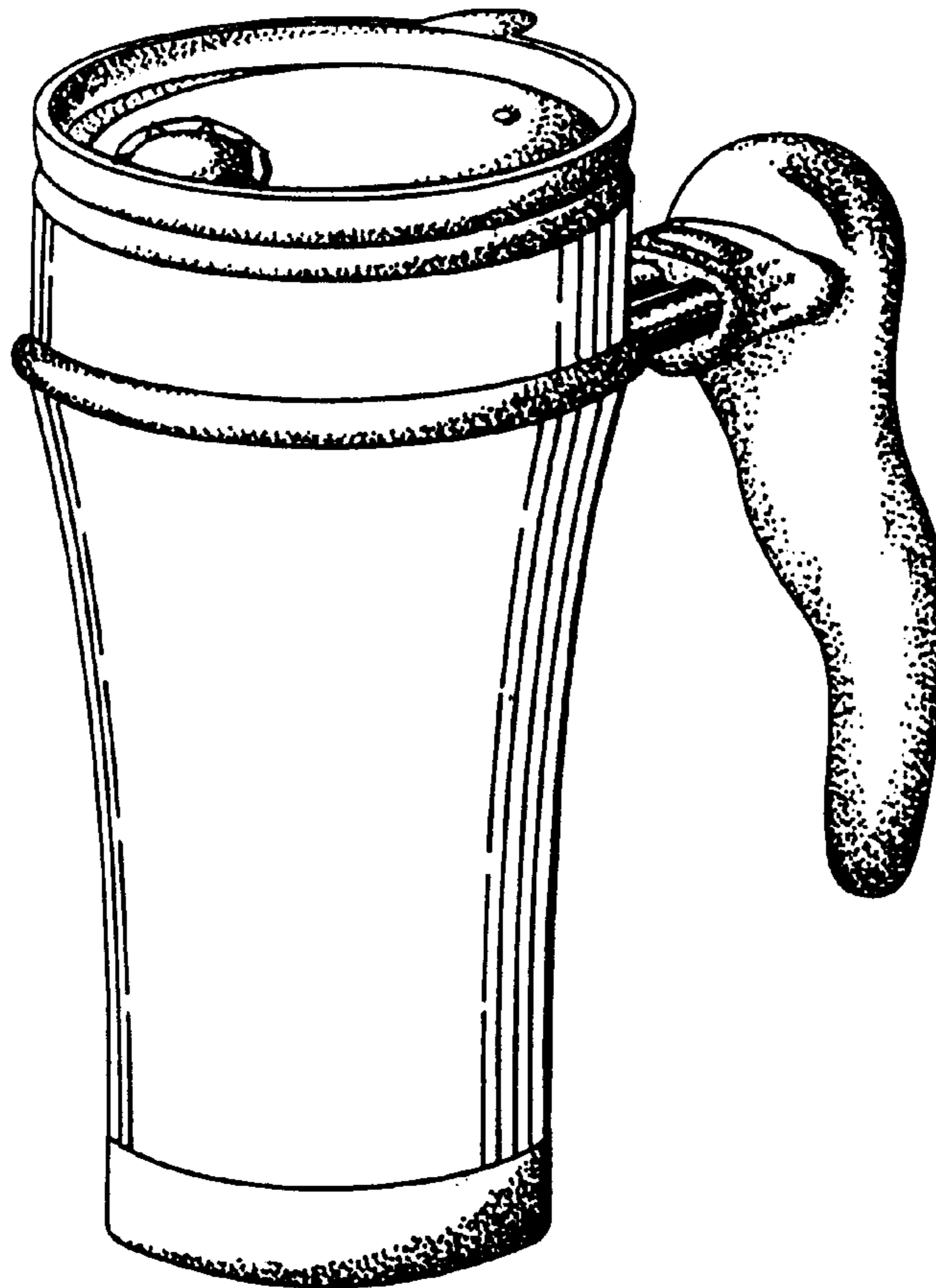
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a coffee mug with removable handle showing my new design;

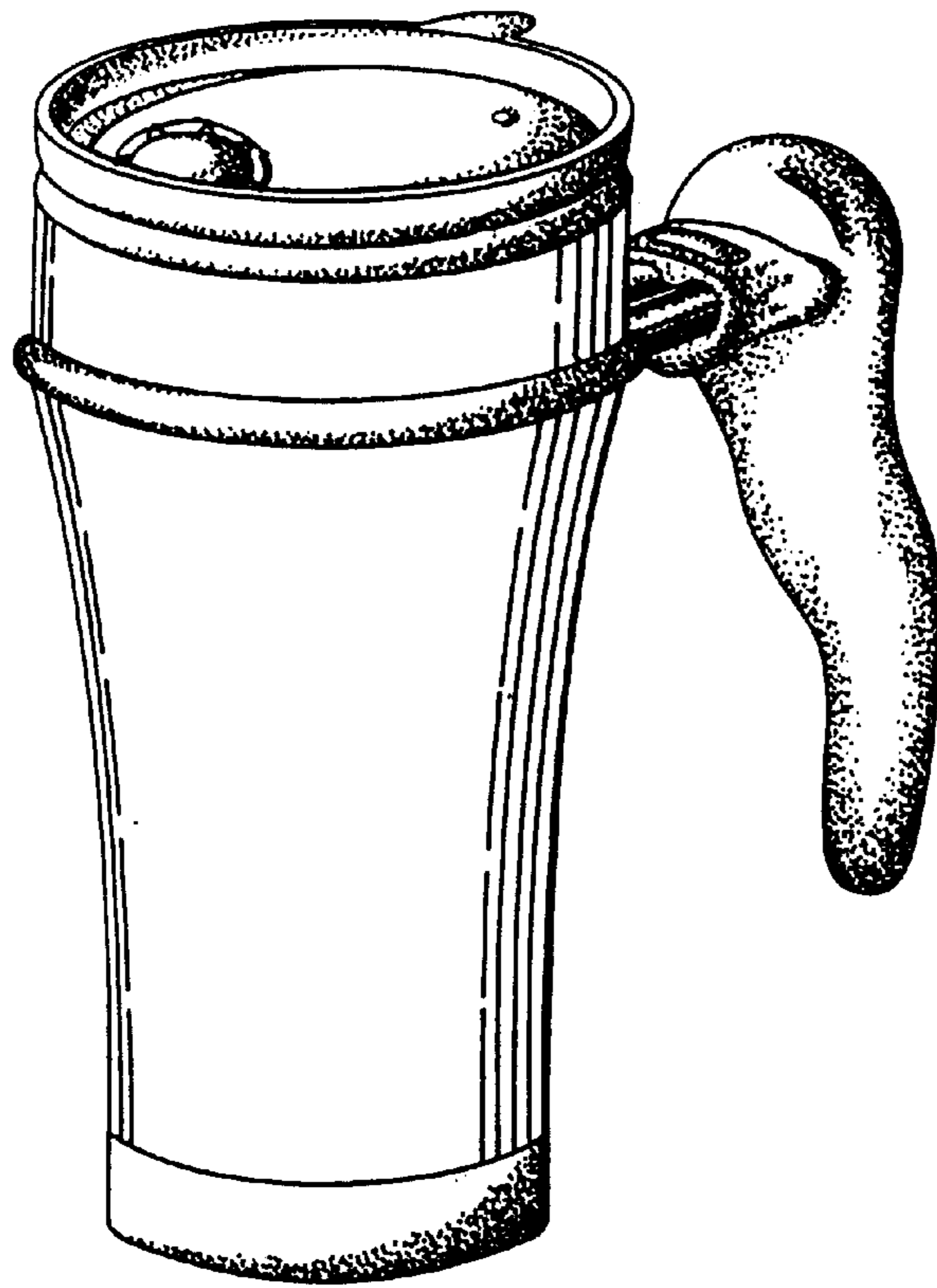

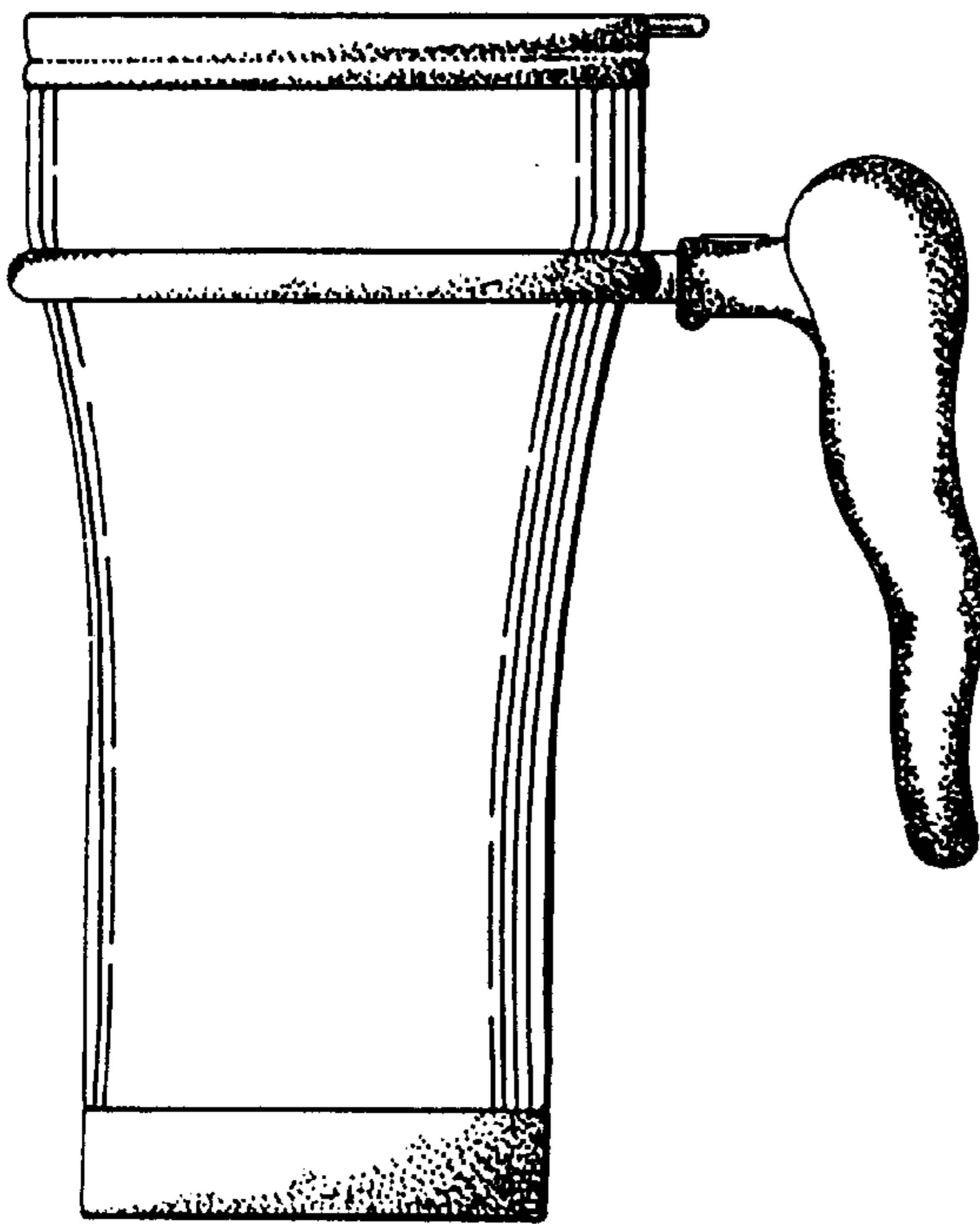

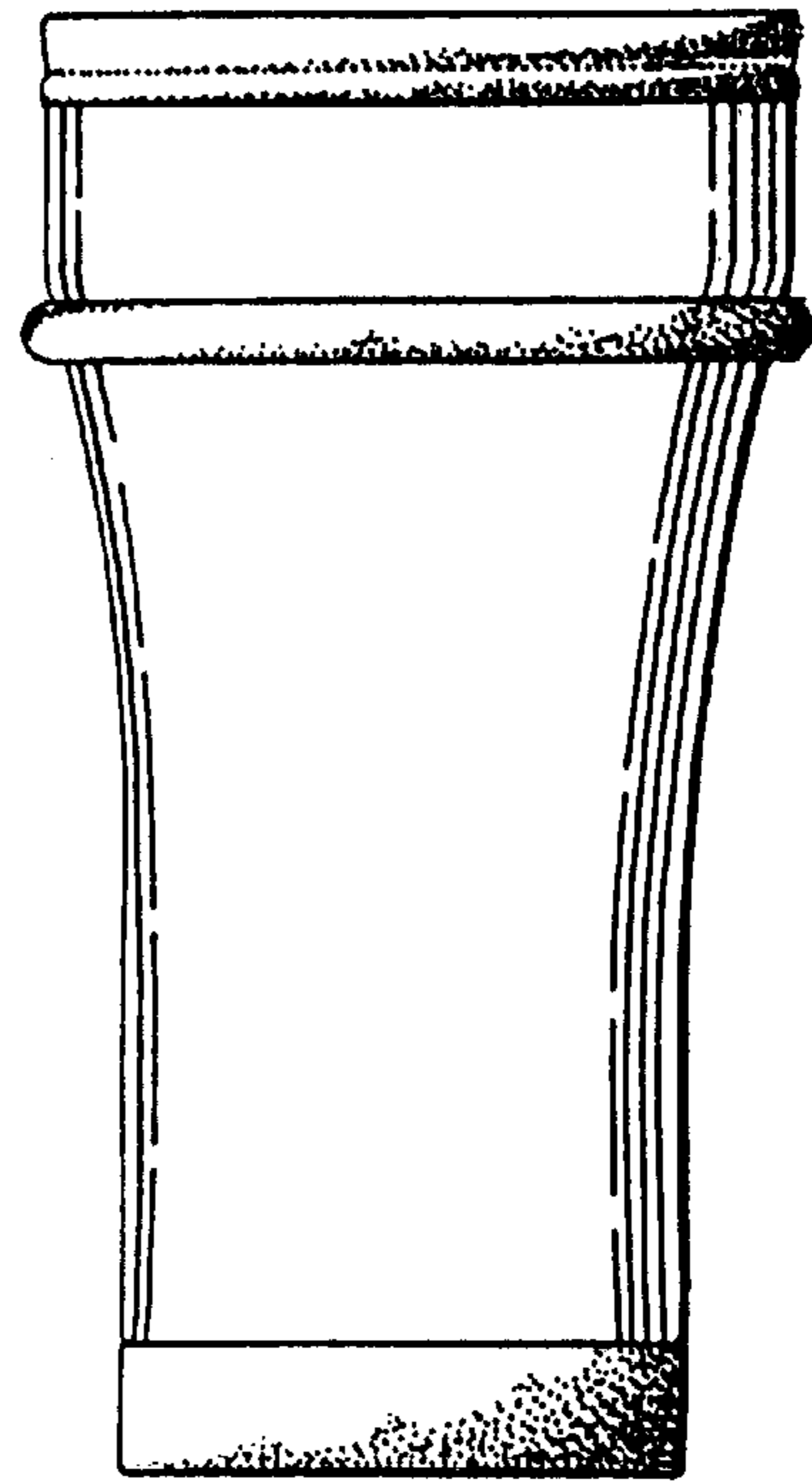

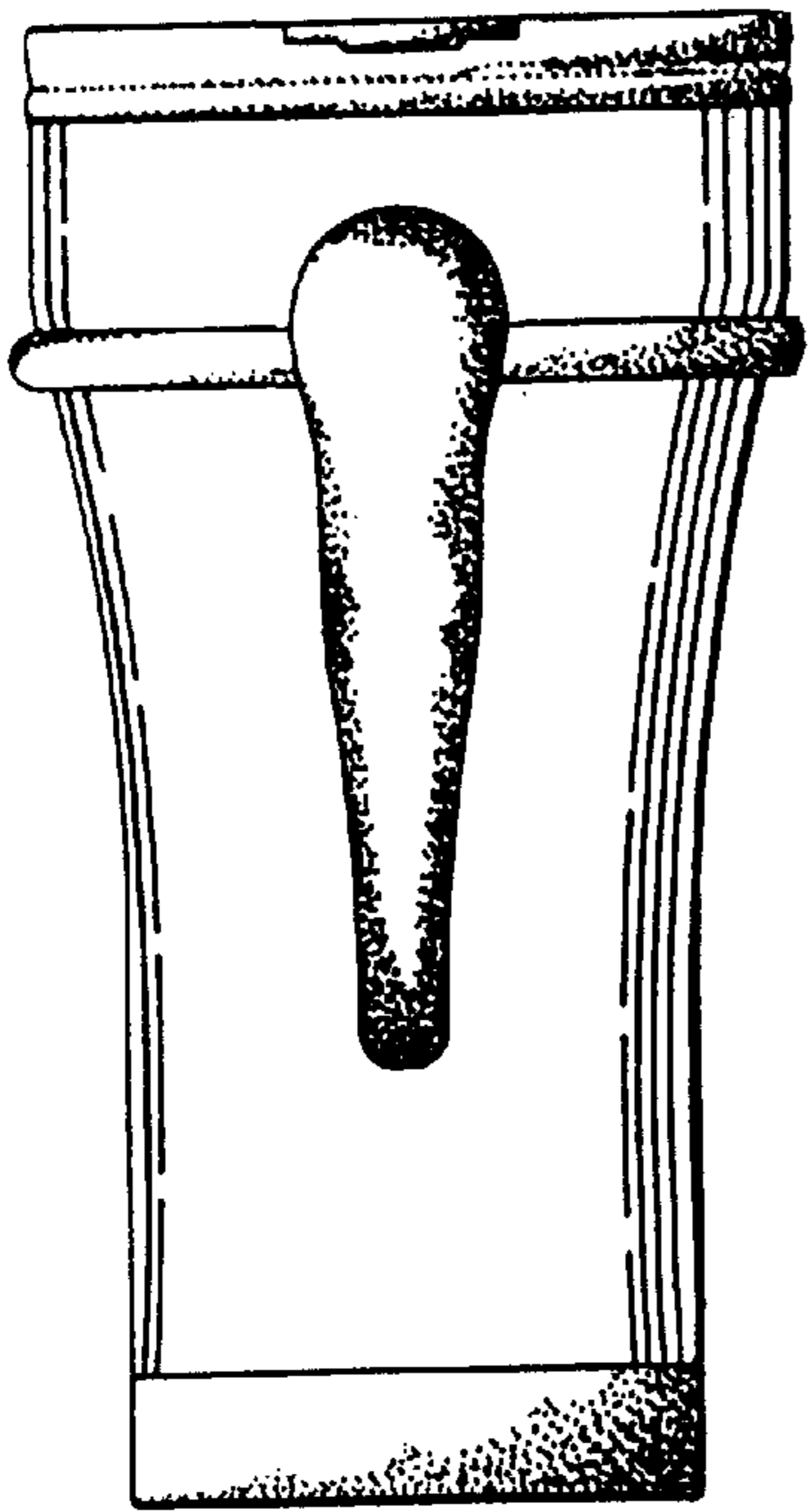

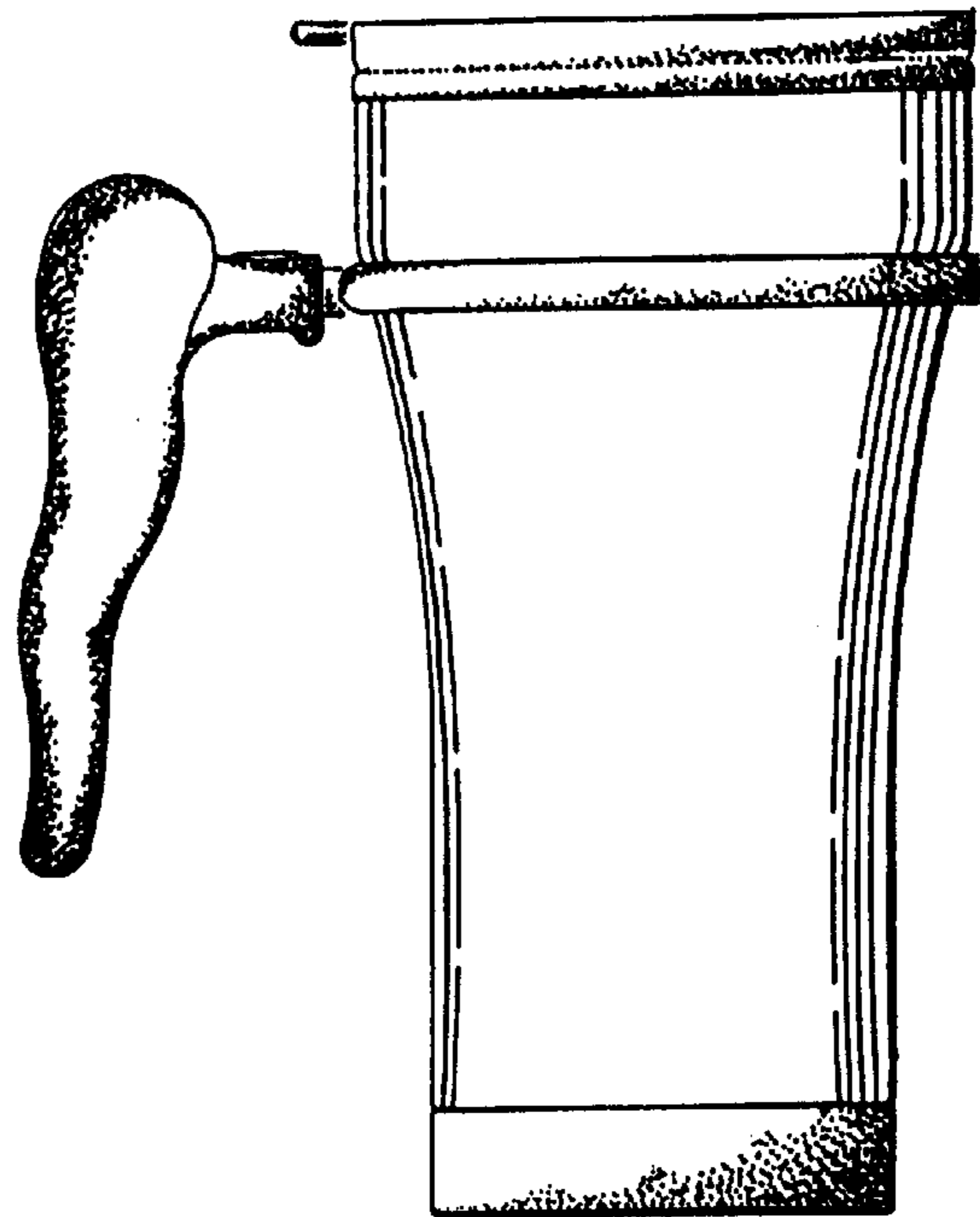

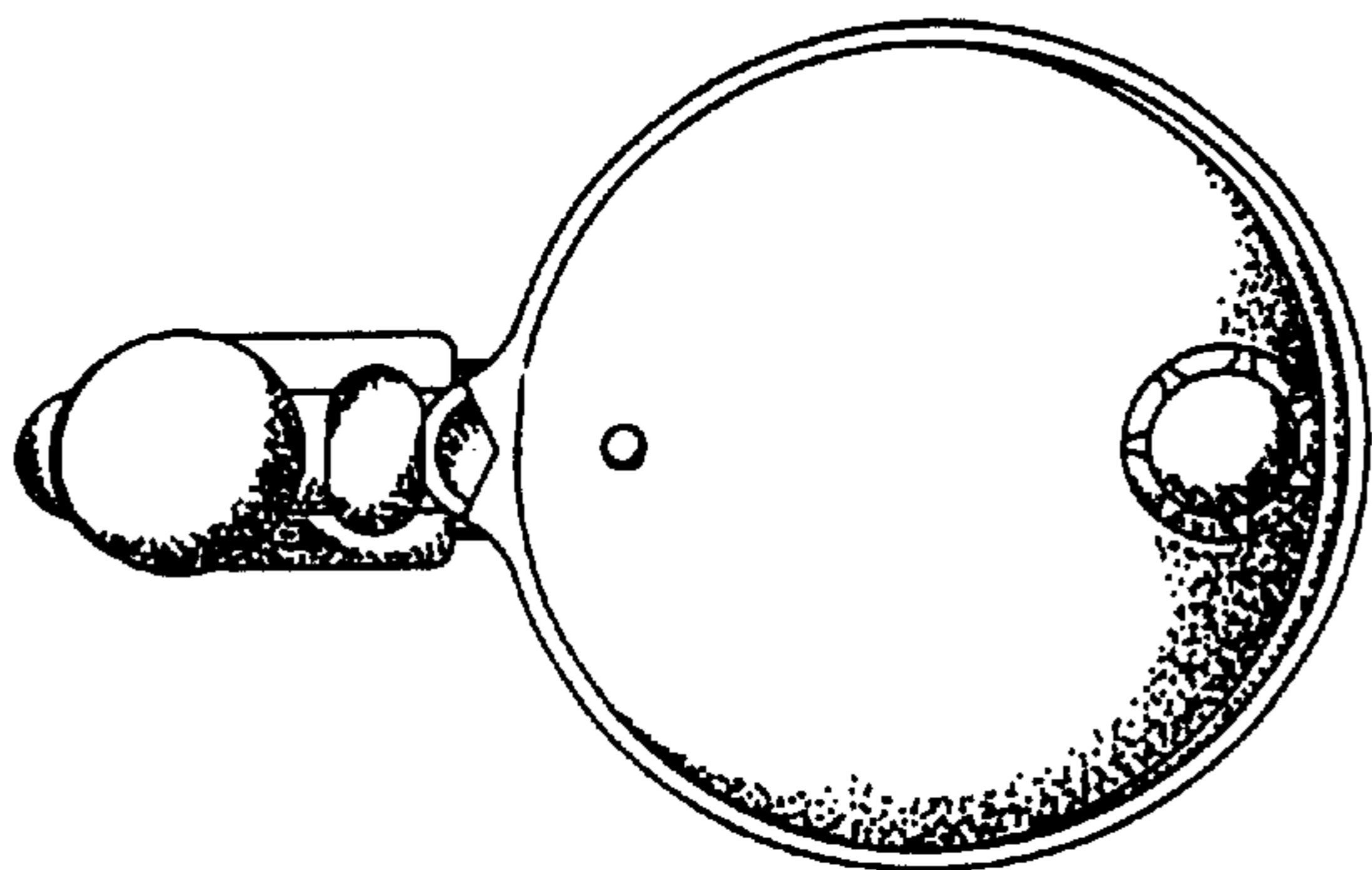

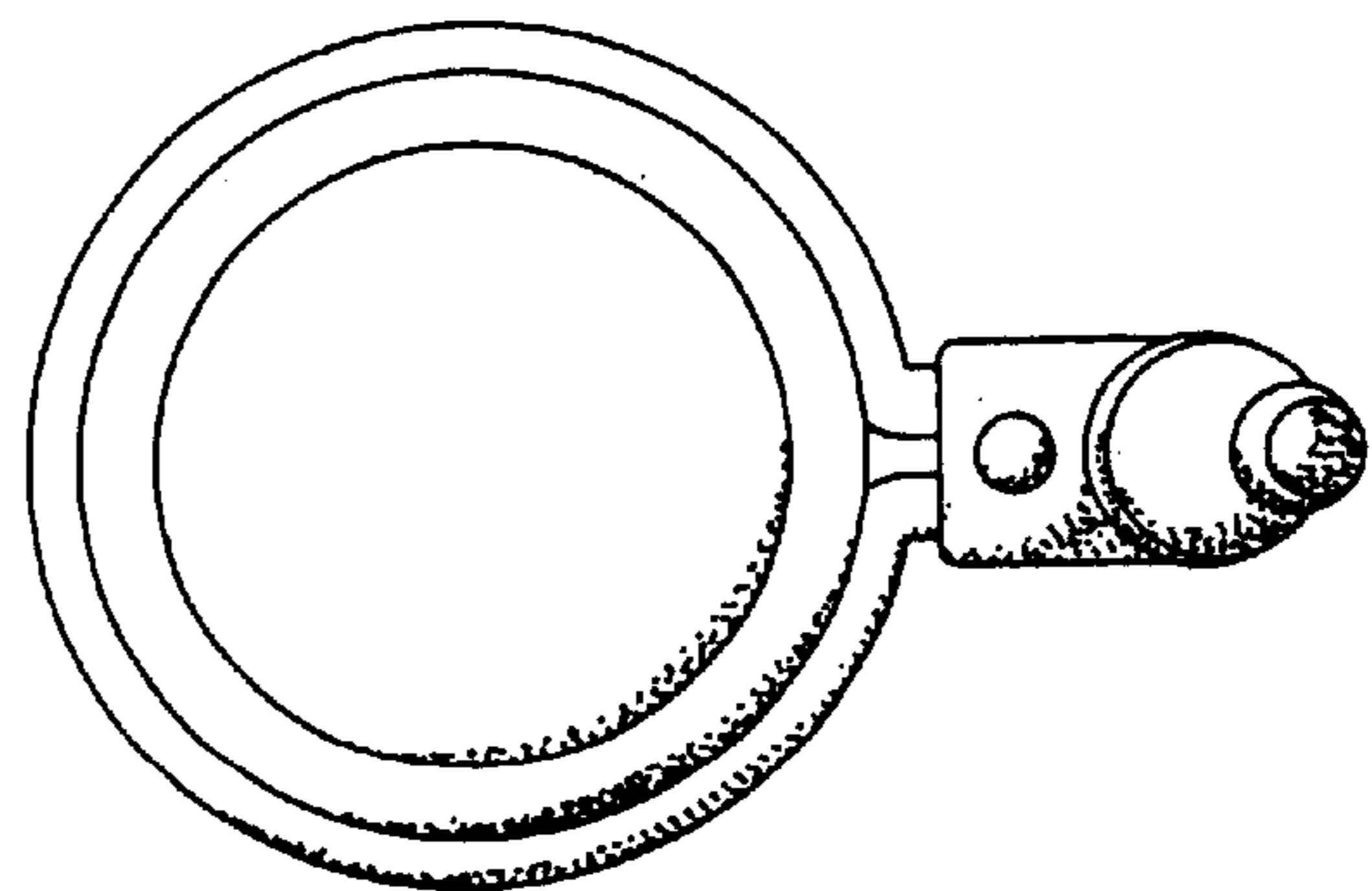
