**DESCRIPTION**

FIG. 1 is a perspective view of a ring showing a pair of spaced rotatable annular members separated by cylindrical bearings;

FIG. 2 is a front view thereof;

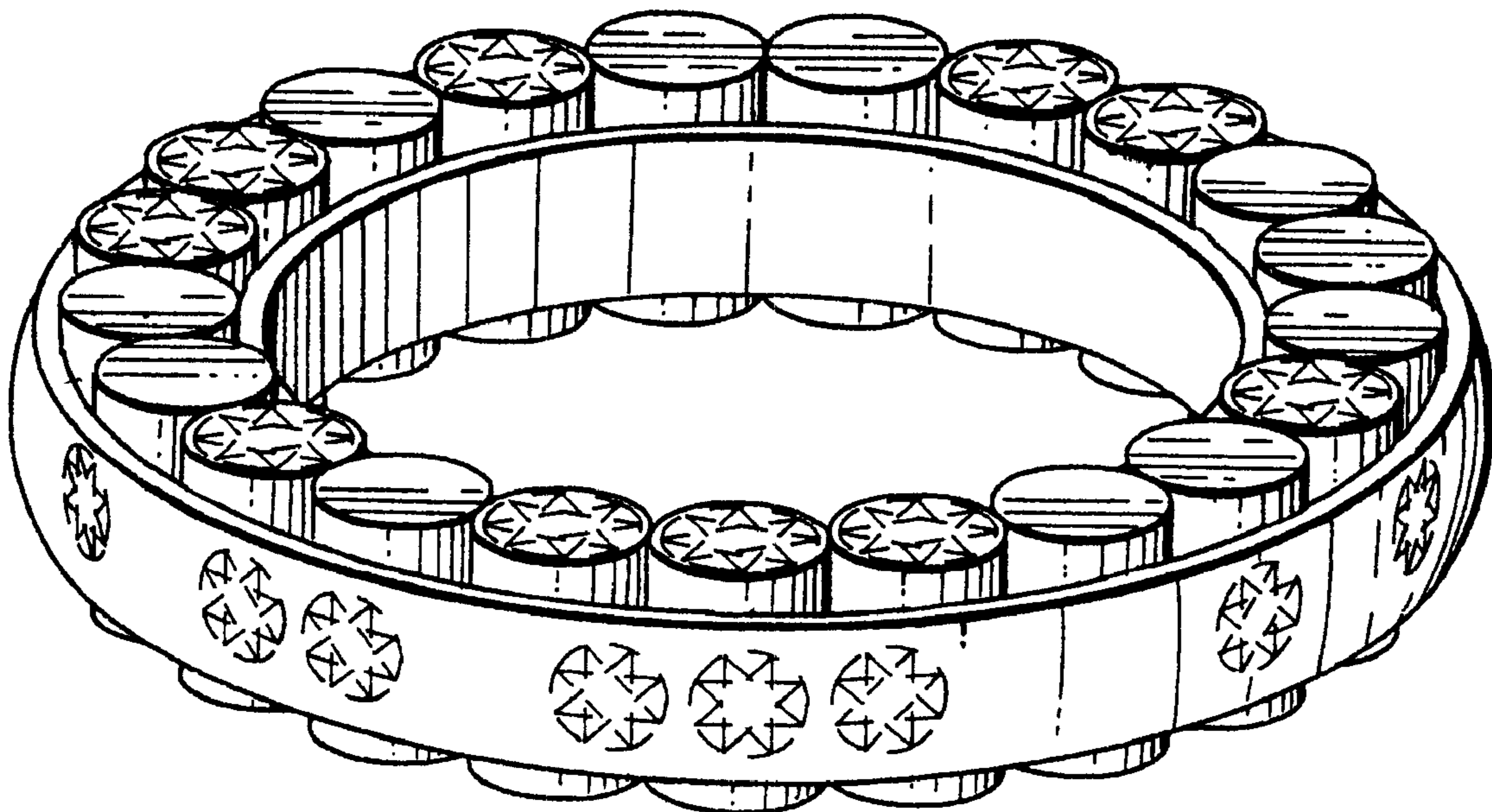
FIG. 3 is a side view thereof; and,

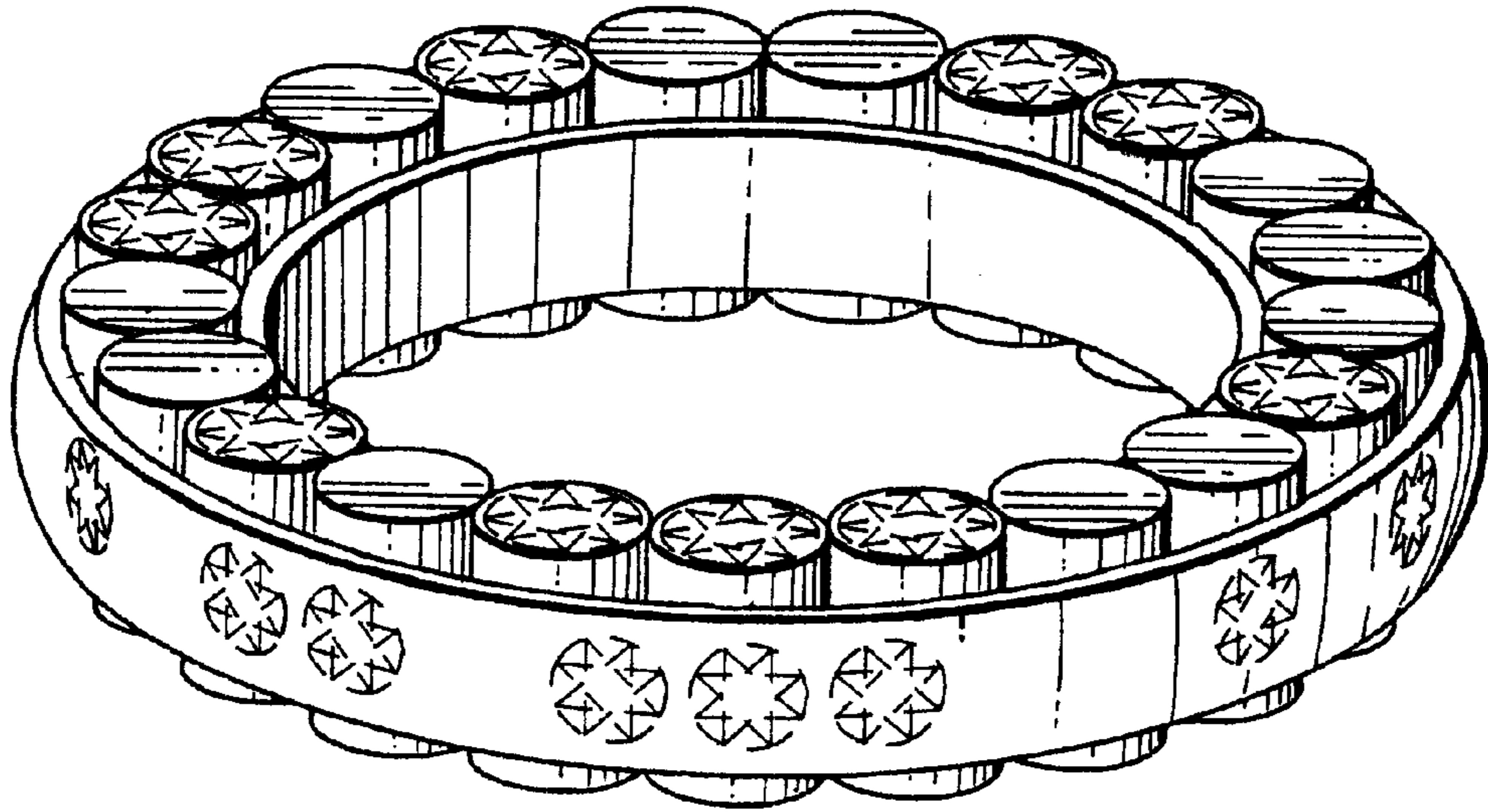

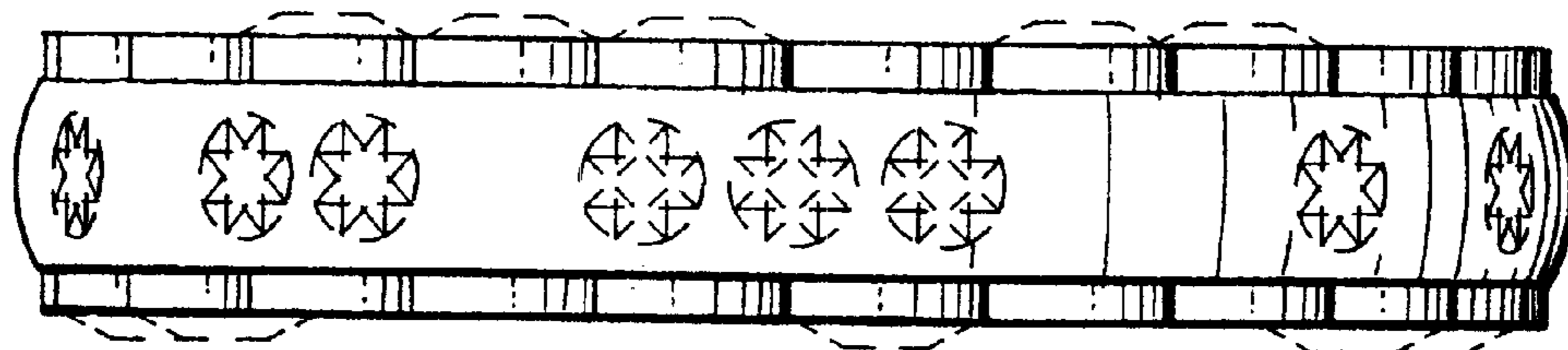

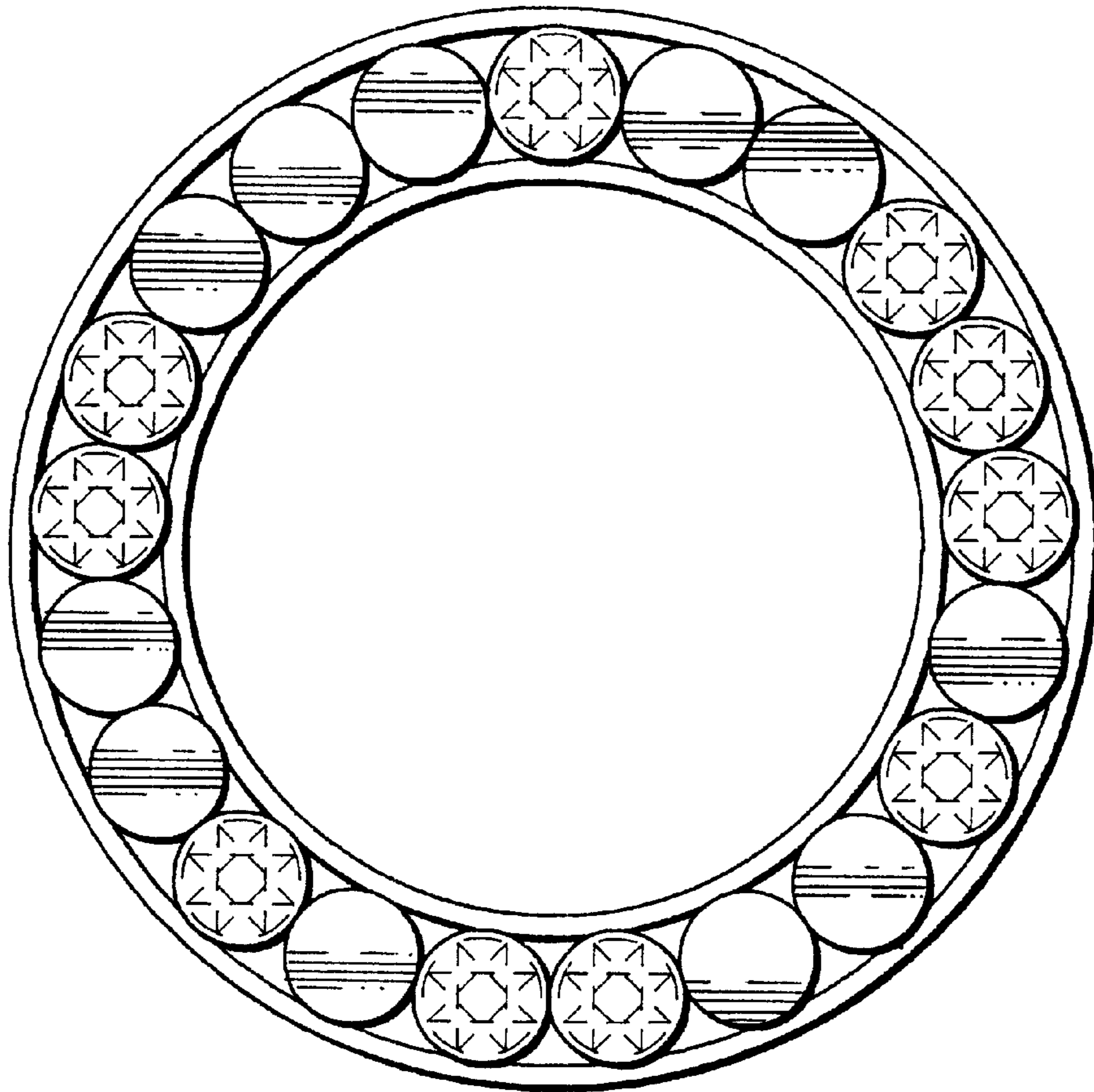

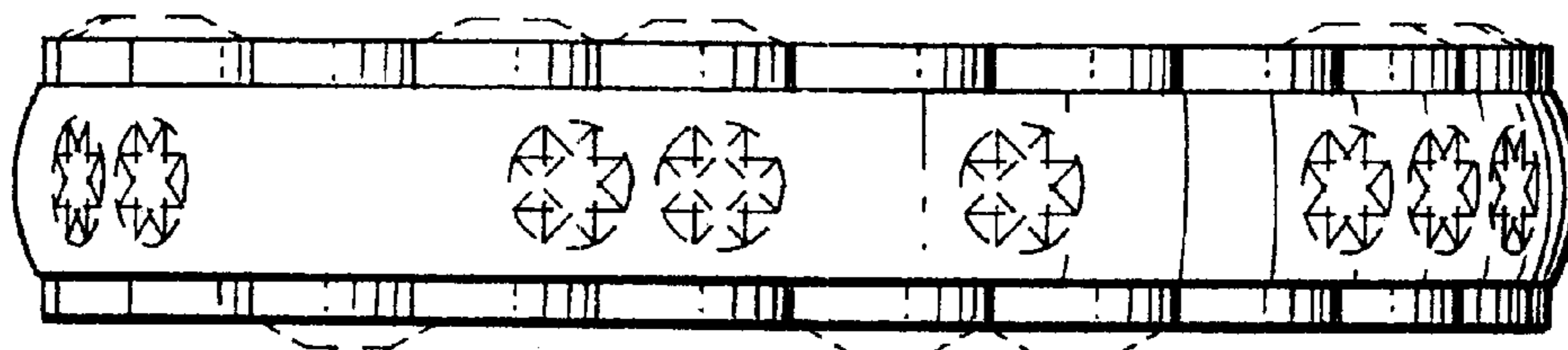
