(57) **CLAIM**

The ornamental design for the holder for a cellular telephone, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective frontal view of a holder for a cellular telephone, including the cellular telephone in broken lines;

FIG. 2 shows a perspective rear view of a holder for a cellular telephone, including the cellular telephone in broken lines;

FIG. 3 shows a perspective frontal view of the holder by itself;

FIG. 4 shows a frontal view of the holder;

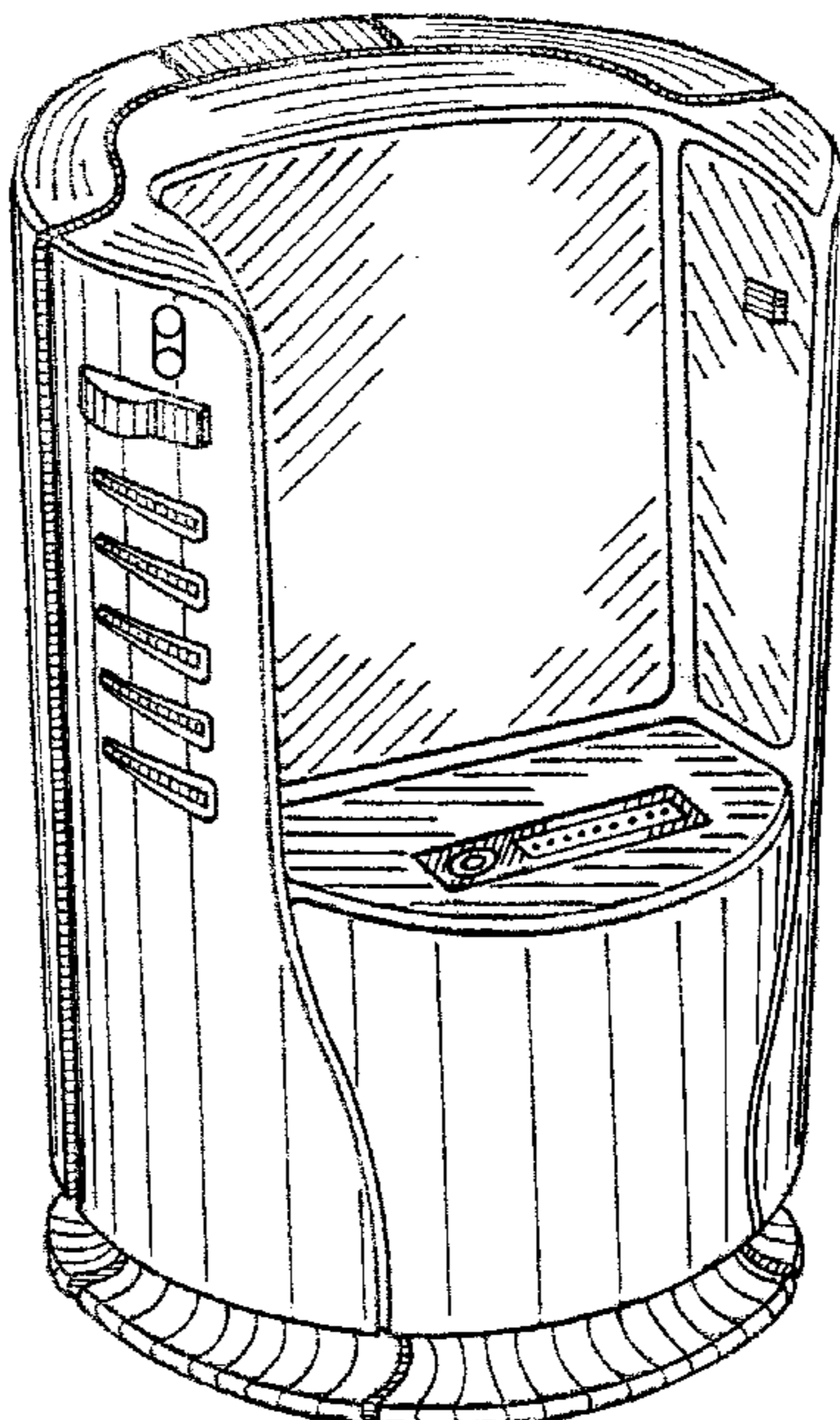
FIG. 5 shows a bottom view of the holder;

FIG. 6 shows a rear view of the holder; and,

FIG. 7 shows a side view of the holder.

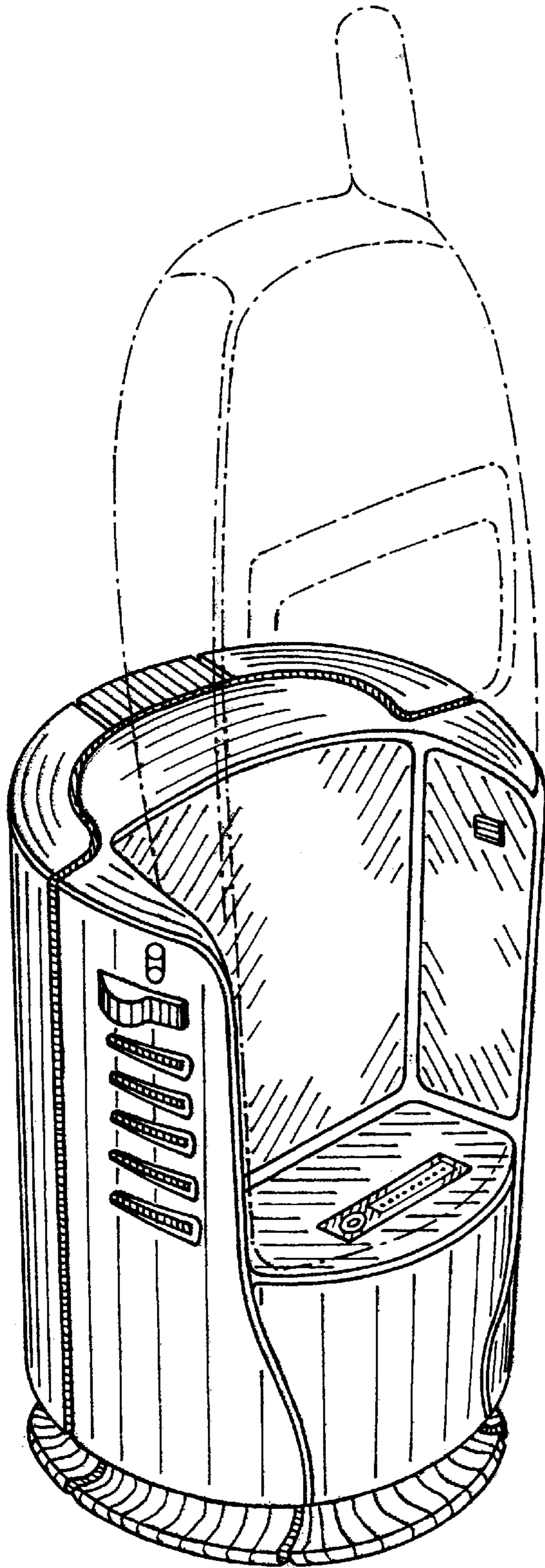

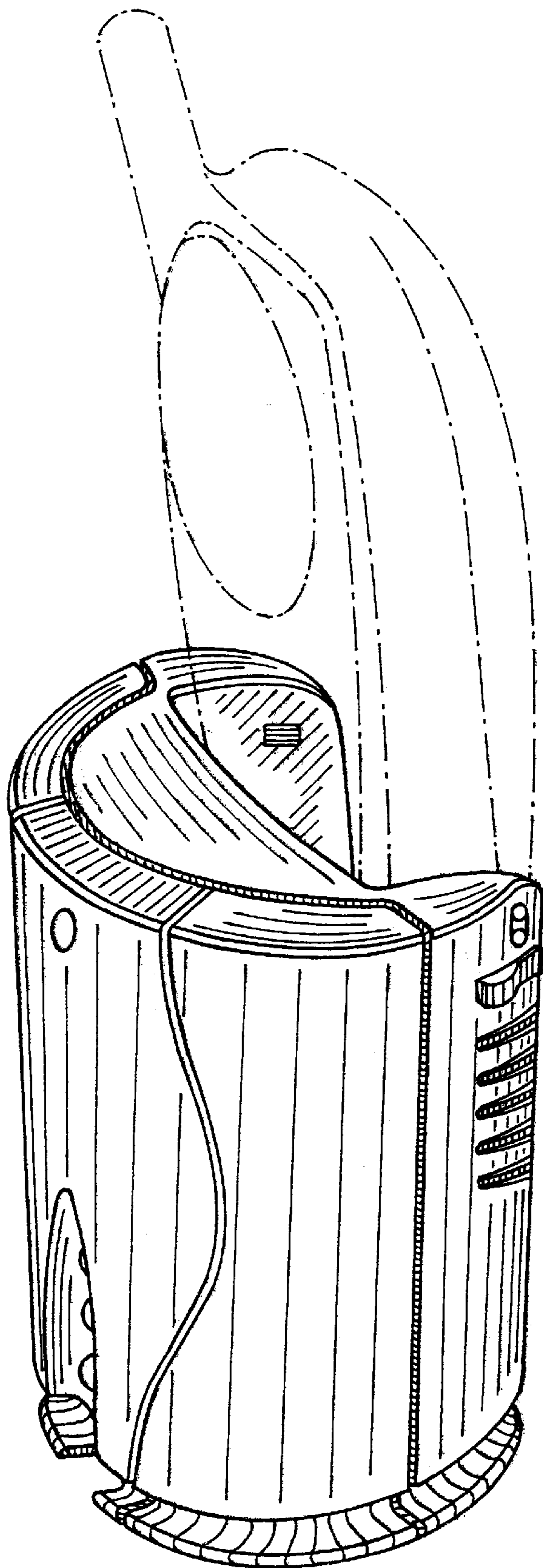

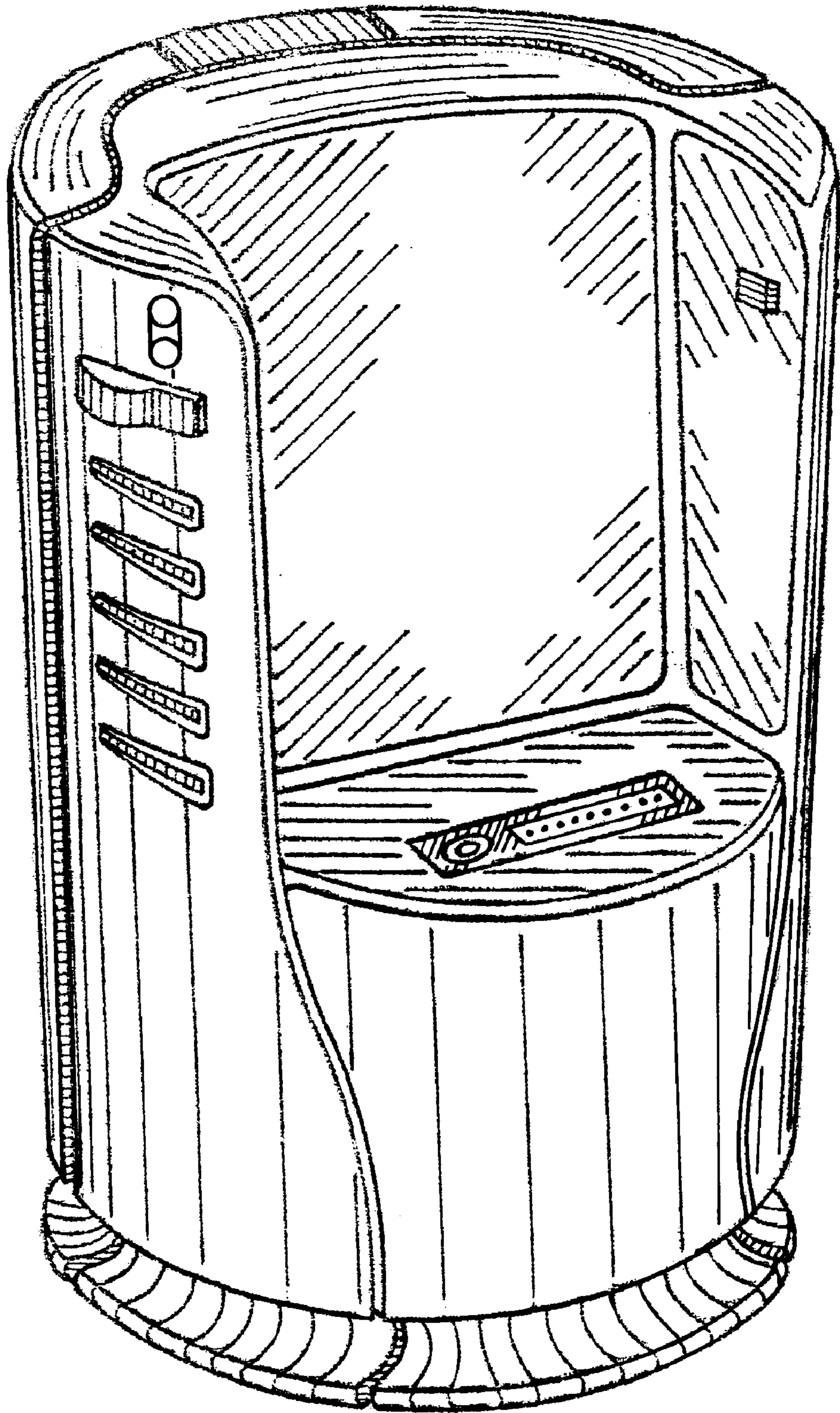

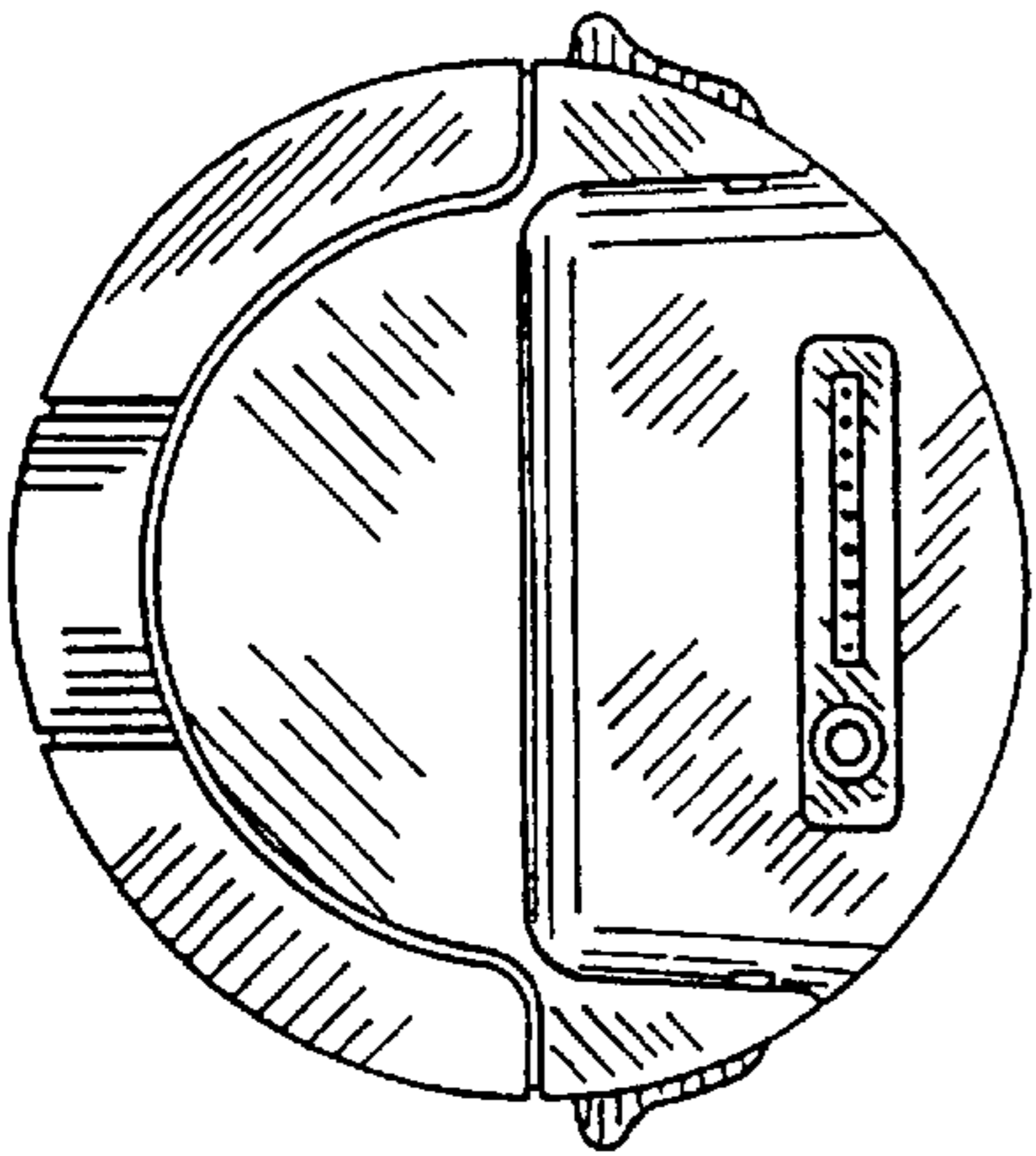

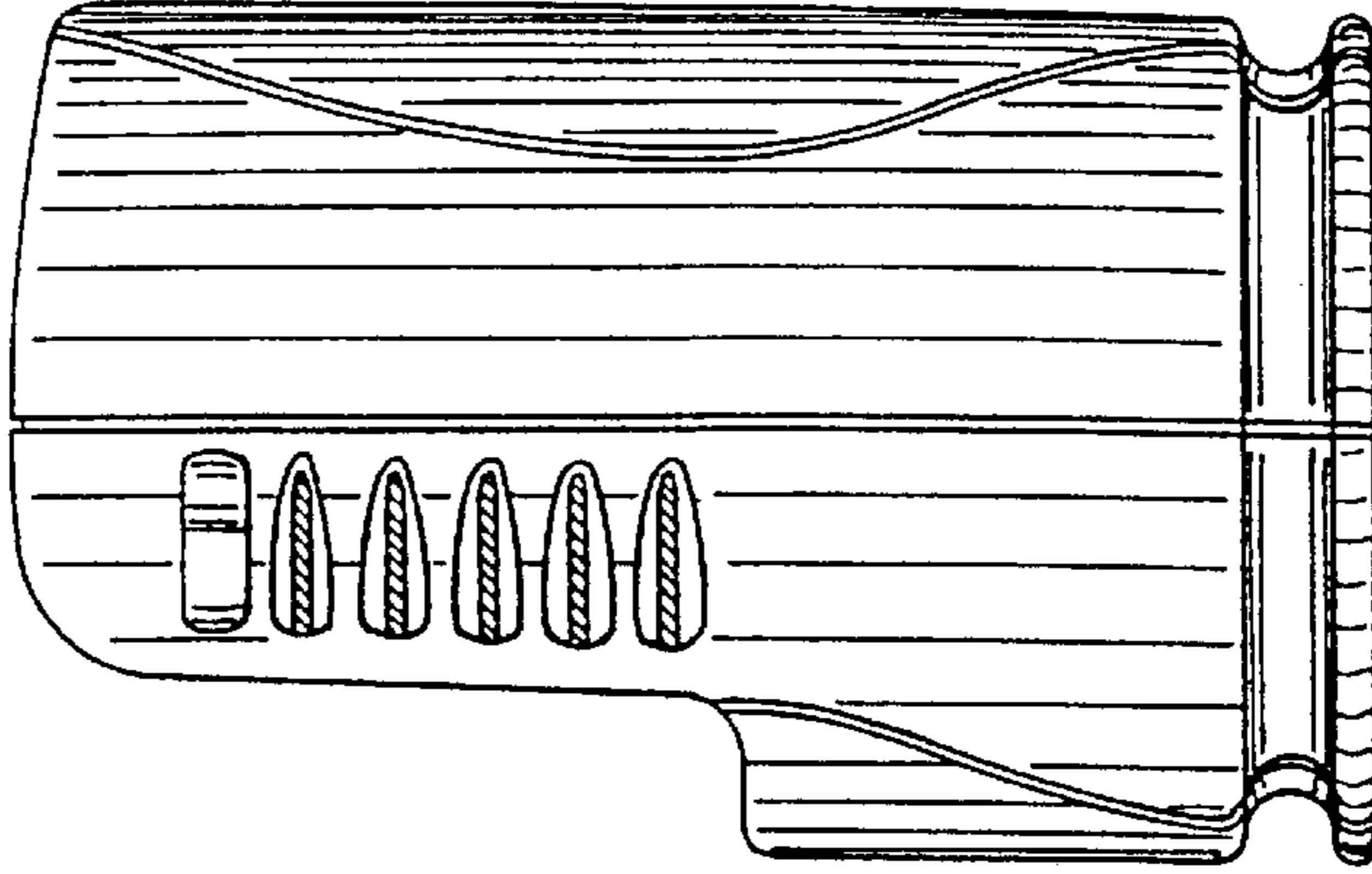

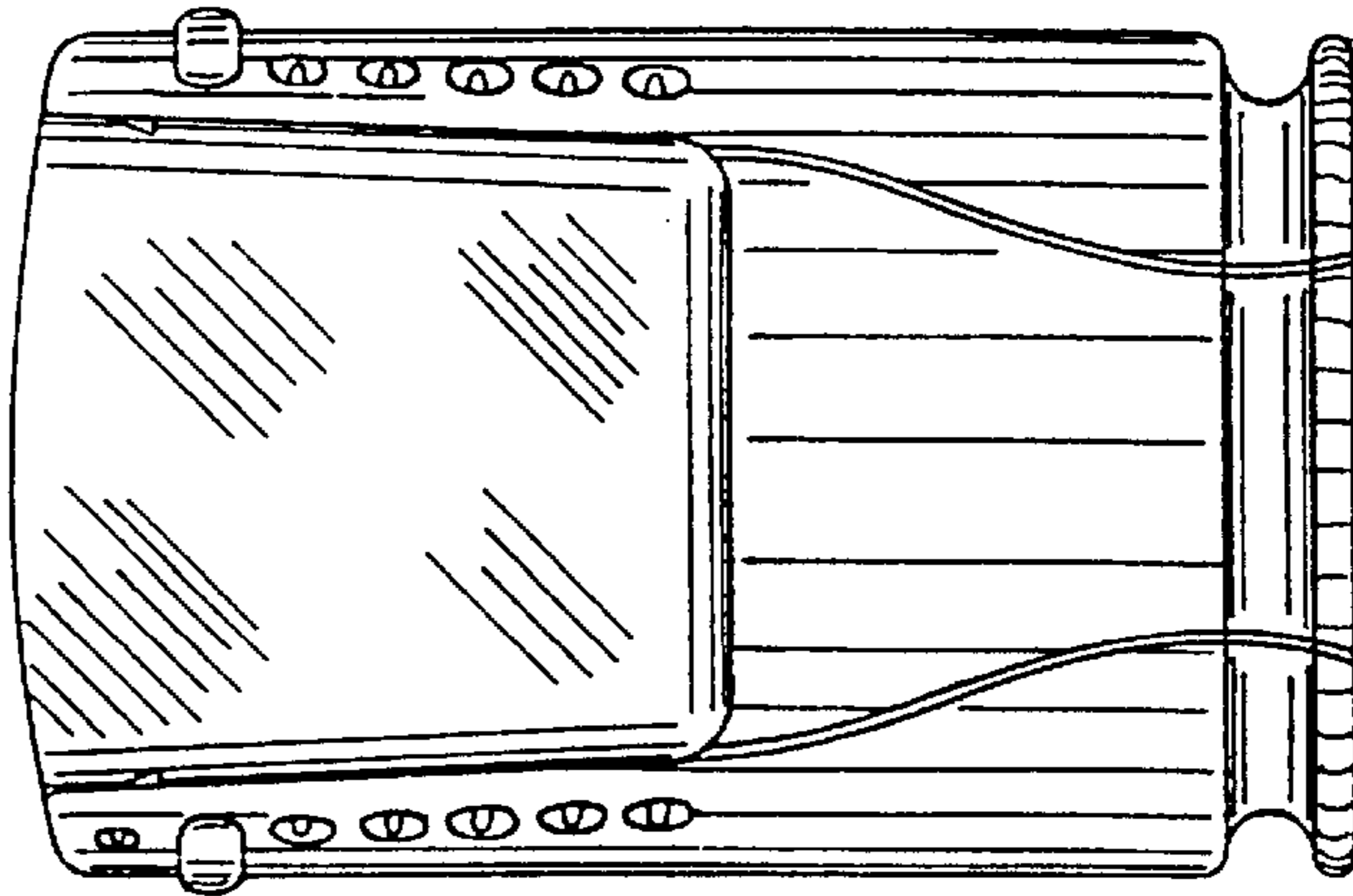

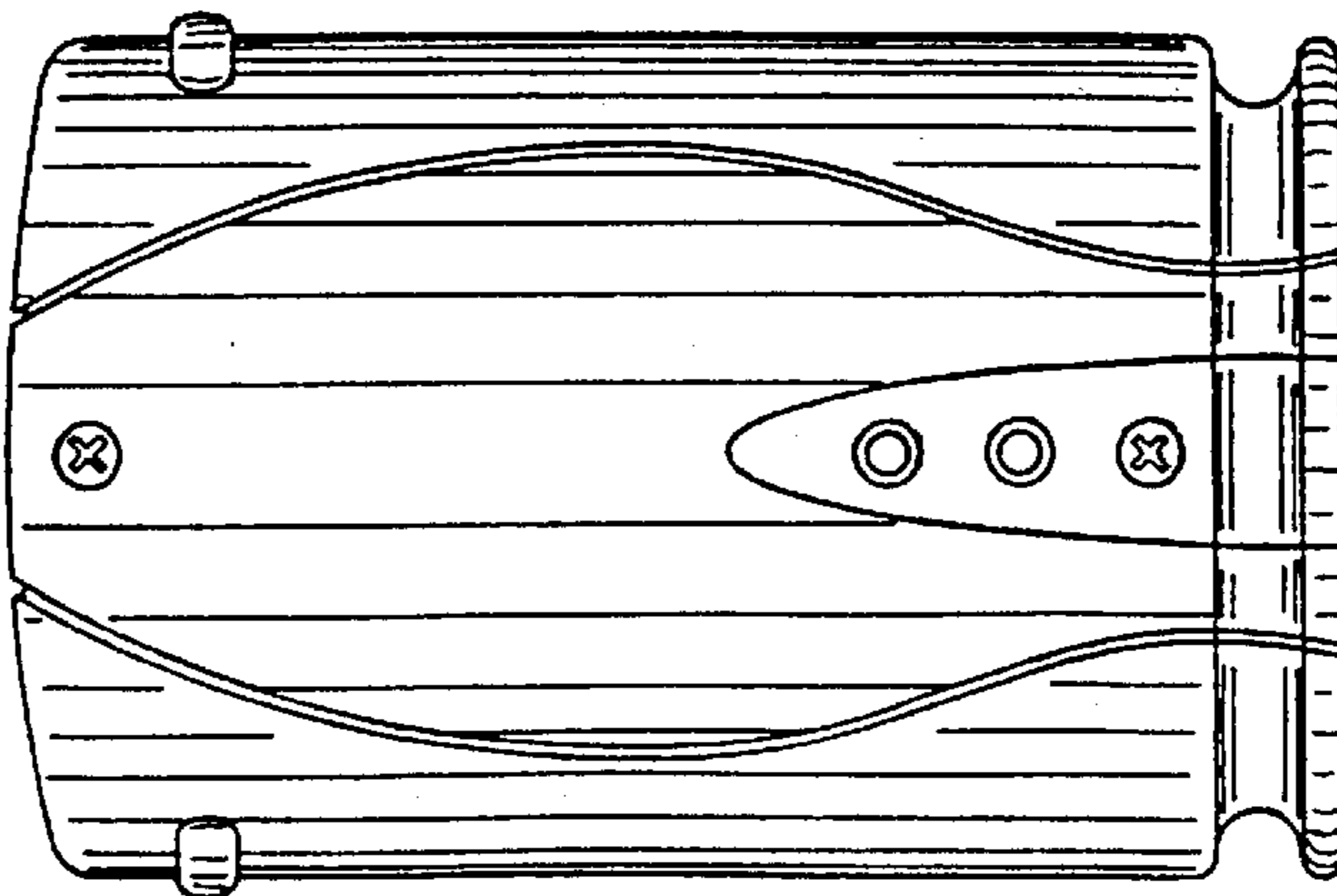
