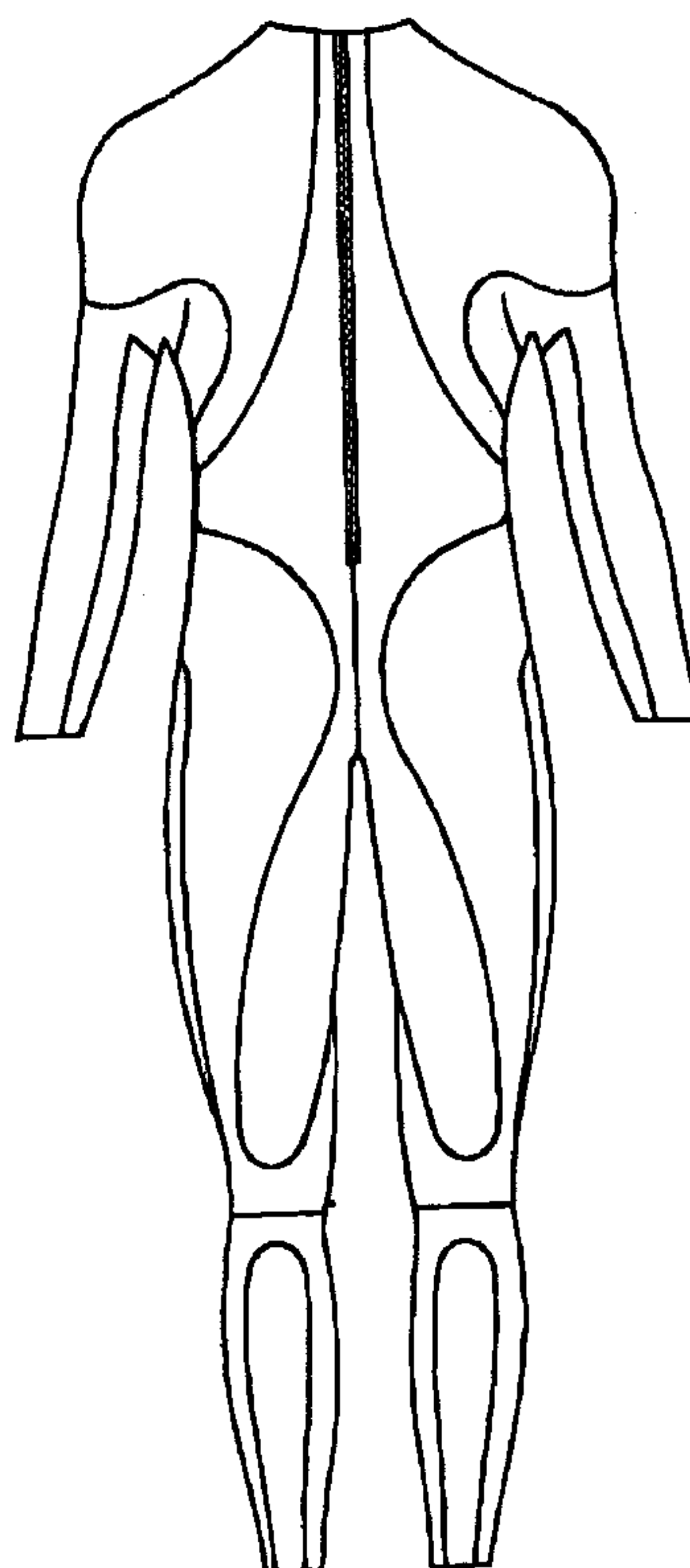
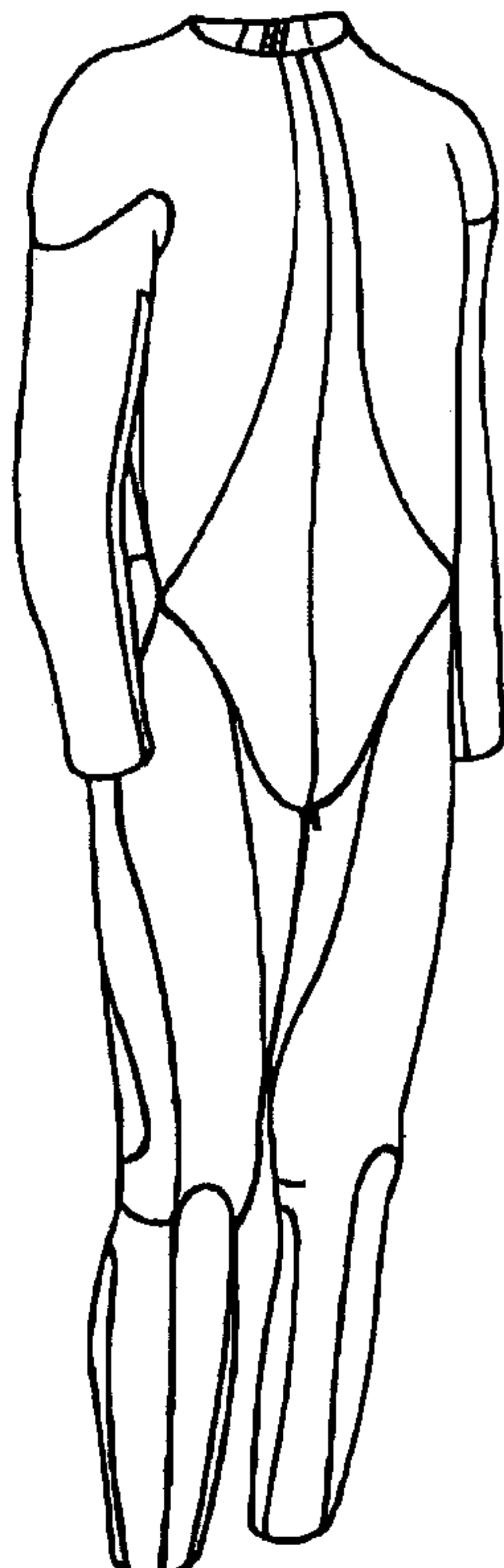
FIG. 1 is a perspective view of a garment showing our new design;

FIG. 6 is a right side elevational view thereof with the arm raised.

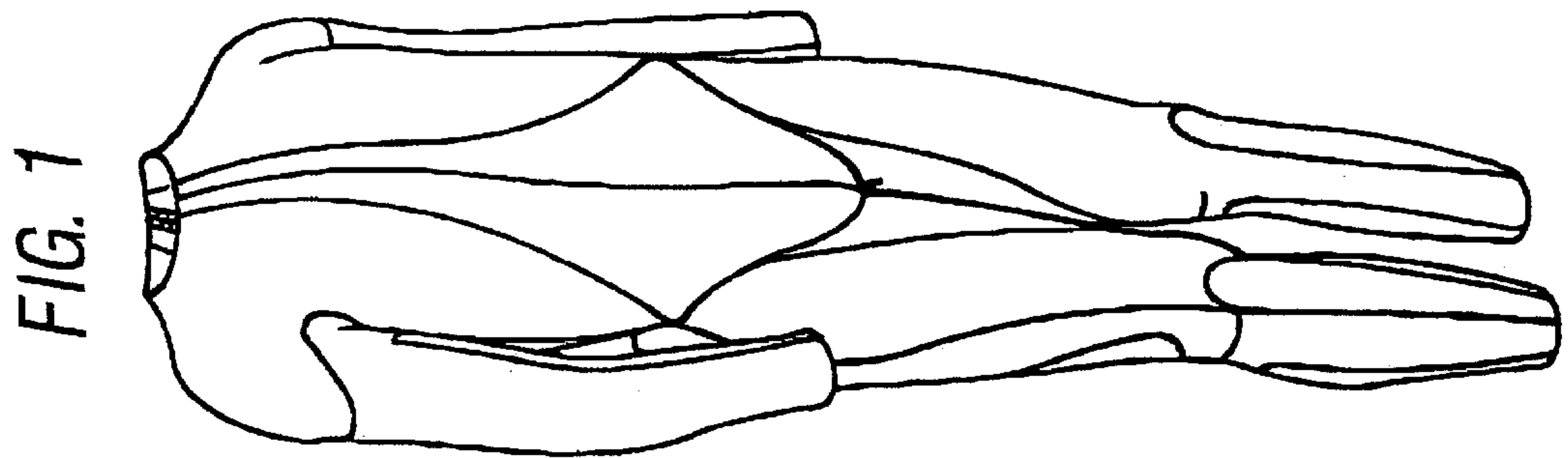
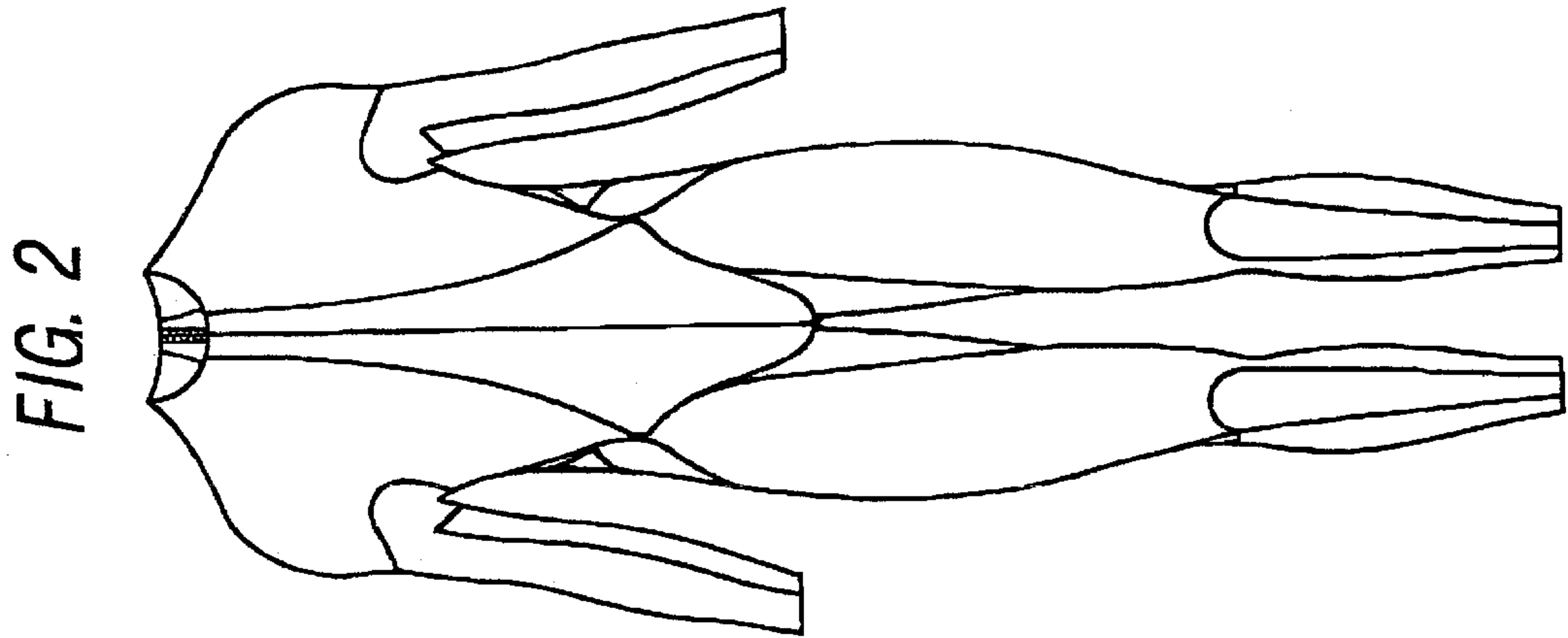
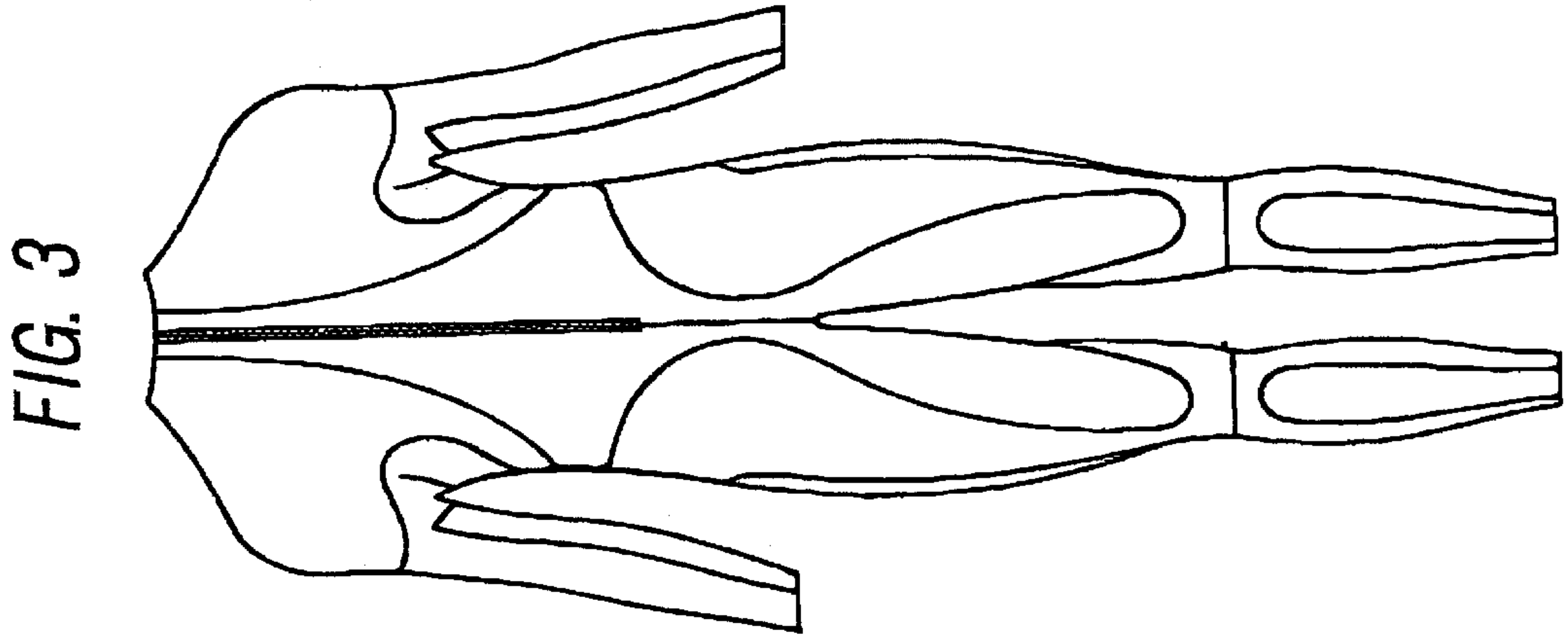

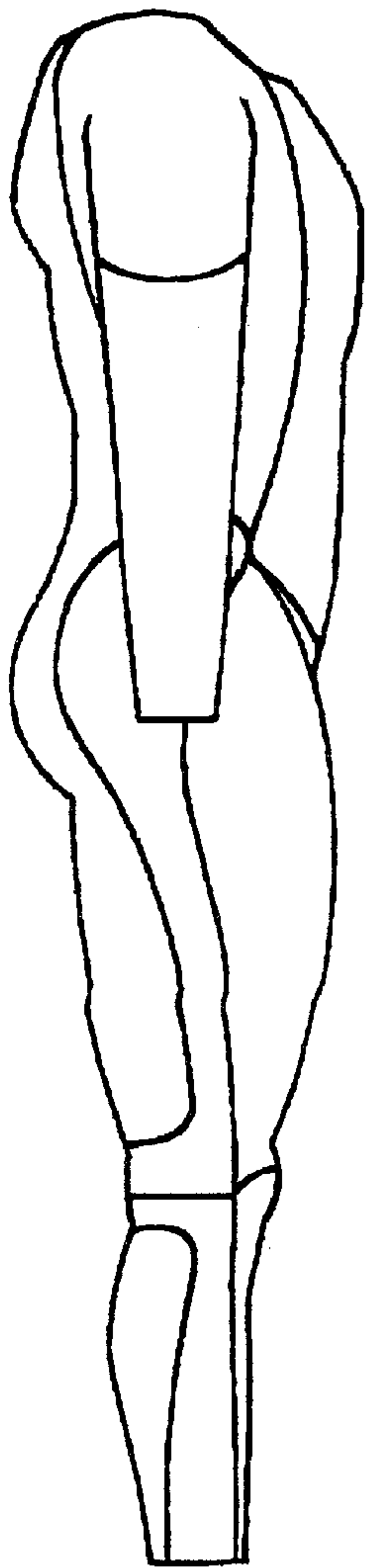

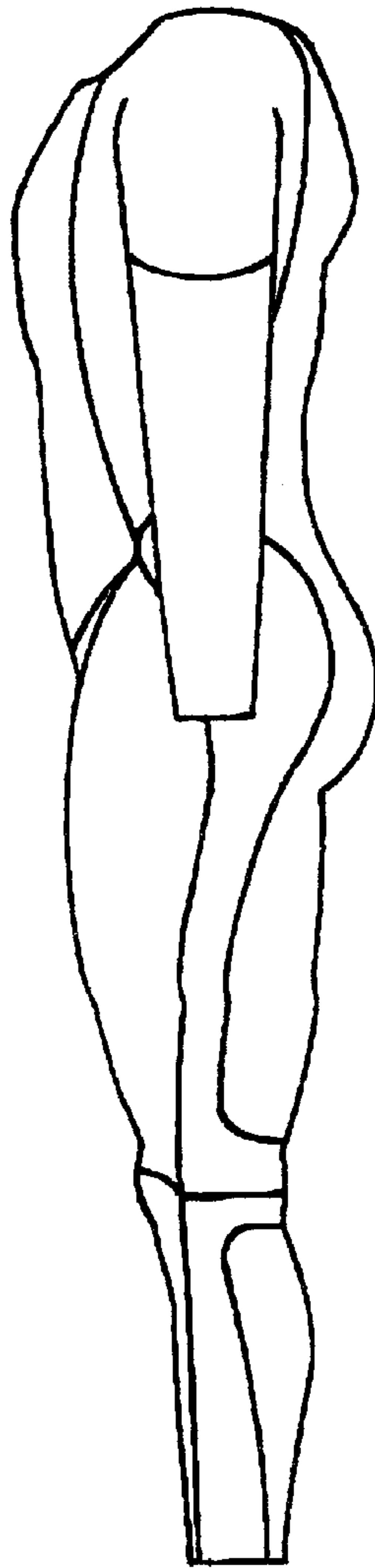
