The ornamental design for a knife handle, as shown and
described.

DESCRIPTION

FIG. 1 is a front elevation view of a knife handle showing
my new design;

FIG. 2 is a top plan view showing the knife handle of FIG.
1;

FIG. 3 is a bottom plan view showing the knife handle of
FIG. 1;

FIG. 4 is a right side elevational view showing the knife
handle of FIG. 1;

FIG. 5 is a left side elevational view showing the knife
handle of FIG. 1;

FIG. 6 is a cross-sectional view taken along line 6—6 of
FIG. 1;

FIG. 7 is a cross-sectional view taken along line 7—7 of
FIG. 1;

FIG. 8 is a cross-sectional view taken along line 8—8 of
FIG. 1;

FIG. 9 is a cross-sectional view taken along line 9—9 of
FIG. 1; and,

FIG. 10 is a perspective view showing the knife handle of
FIG. 1.

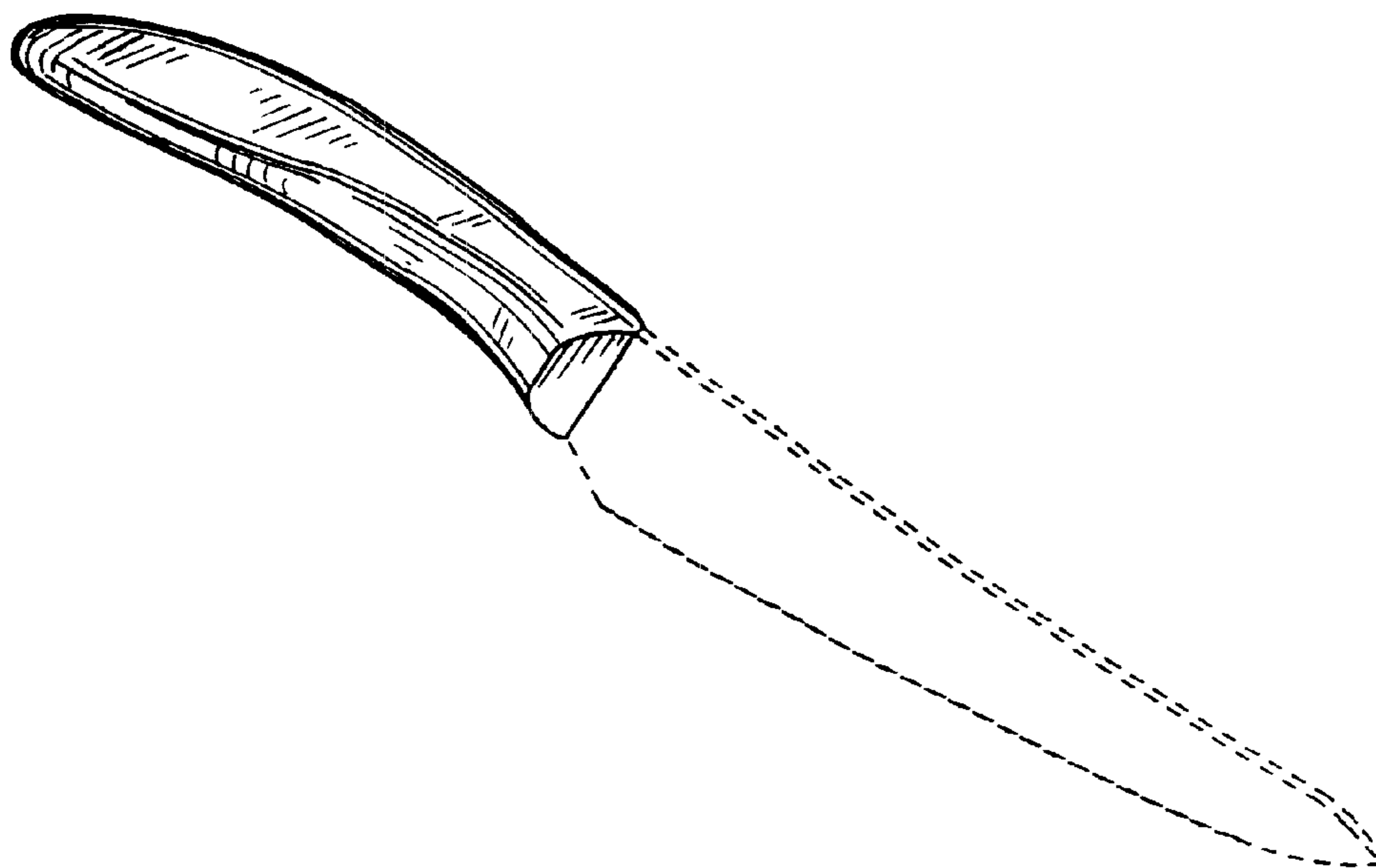

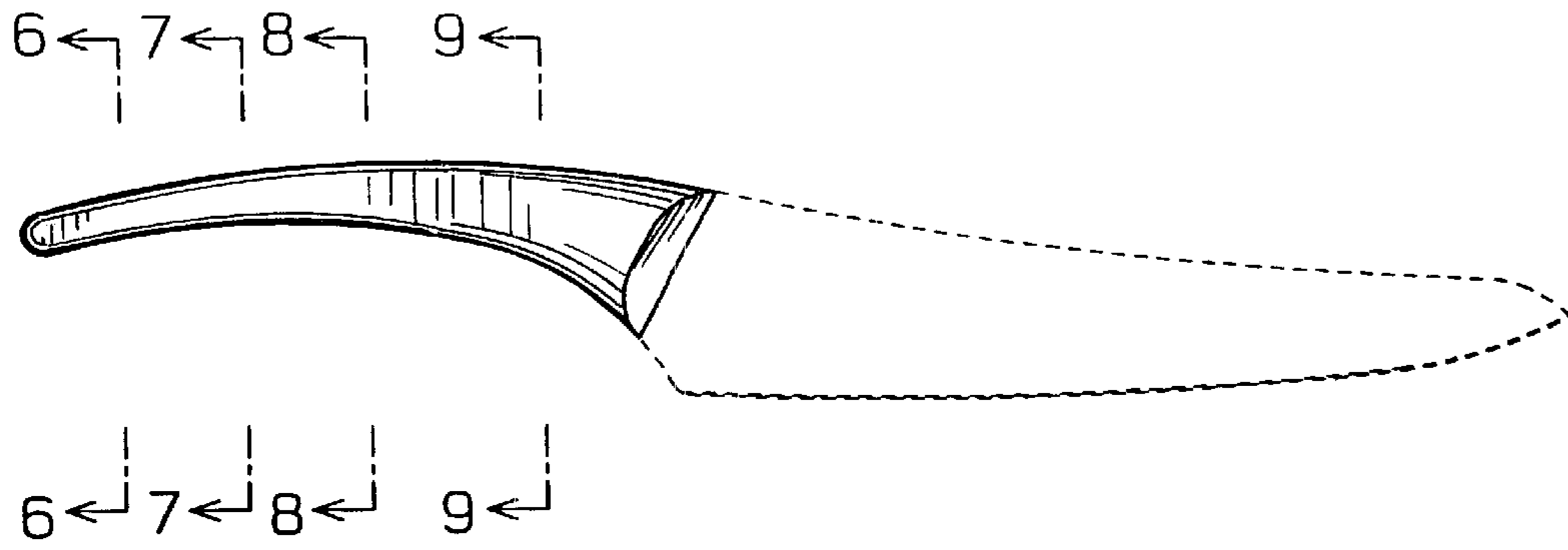

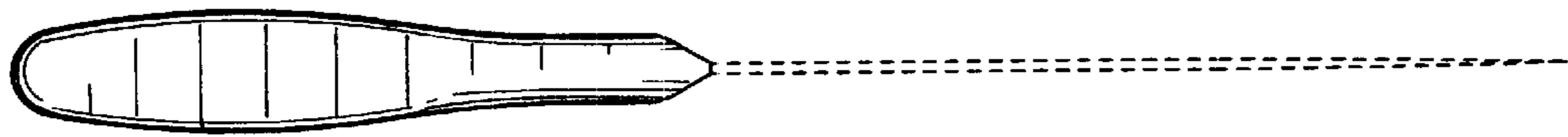

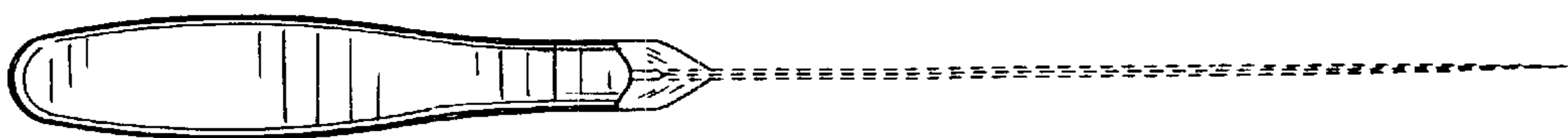

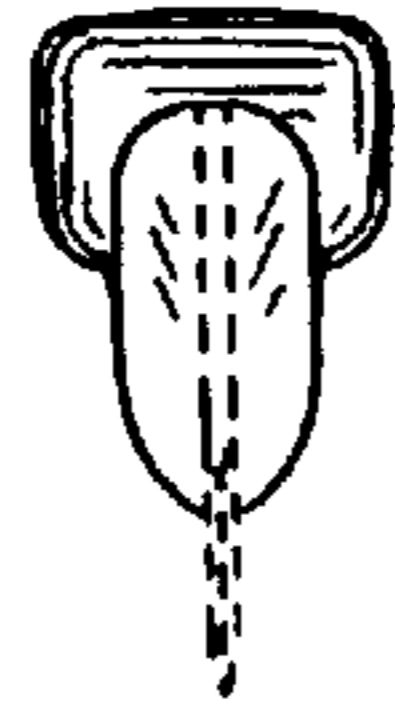

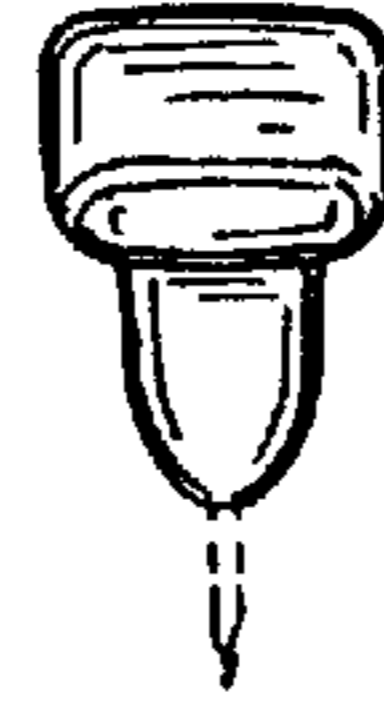

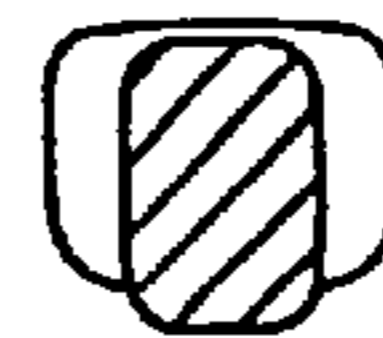
