(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of a container of a first embodiment of the present invention;  
FIG. 2 is a perspective of a container of the first embodiment shown in an alternate position;  
FIG. 3 is a front elevation of the container of the first embodiment;  
FIG. 4 is a rear elevation of the container of the first embodiment;  
FIG. 5 is a right side elevation of the container of the first embodiment, the left side elevation being a mirror image thereof;  
FIG. 6 is a top plan of the container of the first embodiment;  
FIG. 7 is a bottom plan of the container of the first embodiment;  
FIG. 8 is a perspective of a container of a second embodiment of the present invention;  
FIG. 9 is a perspective of the container of the second embodiment shown in an alternate position;  
FIG. 10 is a front elevation of the container of the second embodiment;  
FIG. 11 is a rear elevation of the container of the second embodiment;

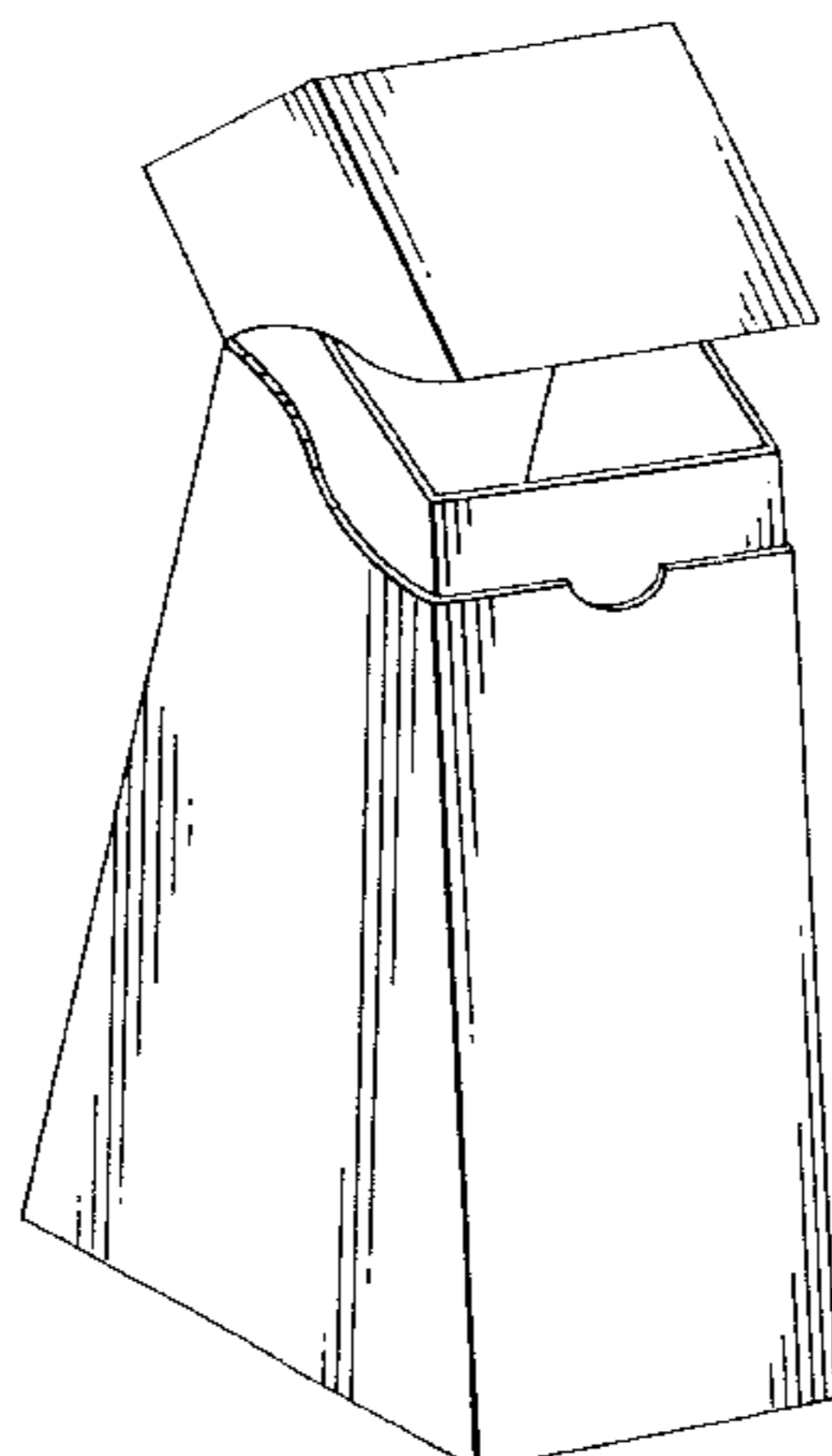


FIG. **12** is a left side elevation of the container of the second embodiment, the right side elevation being a mirror image thereof;

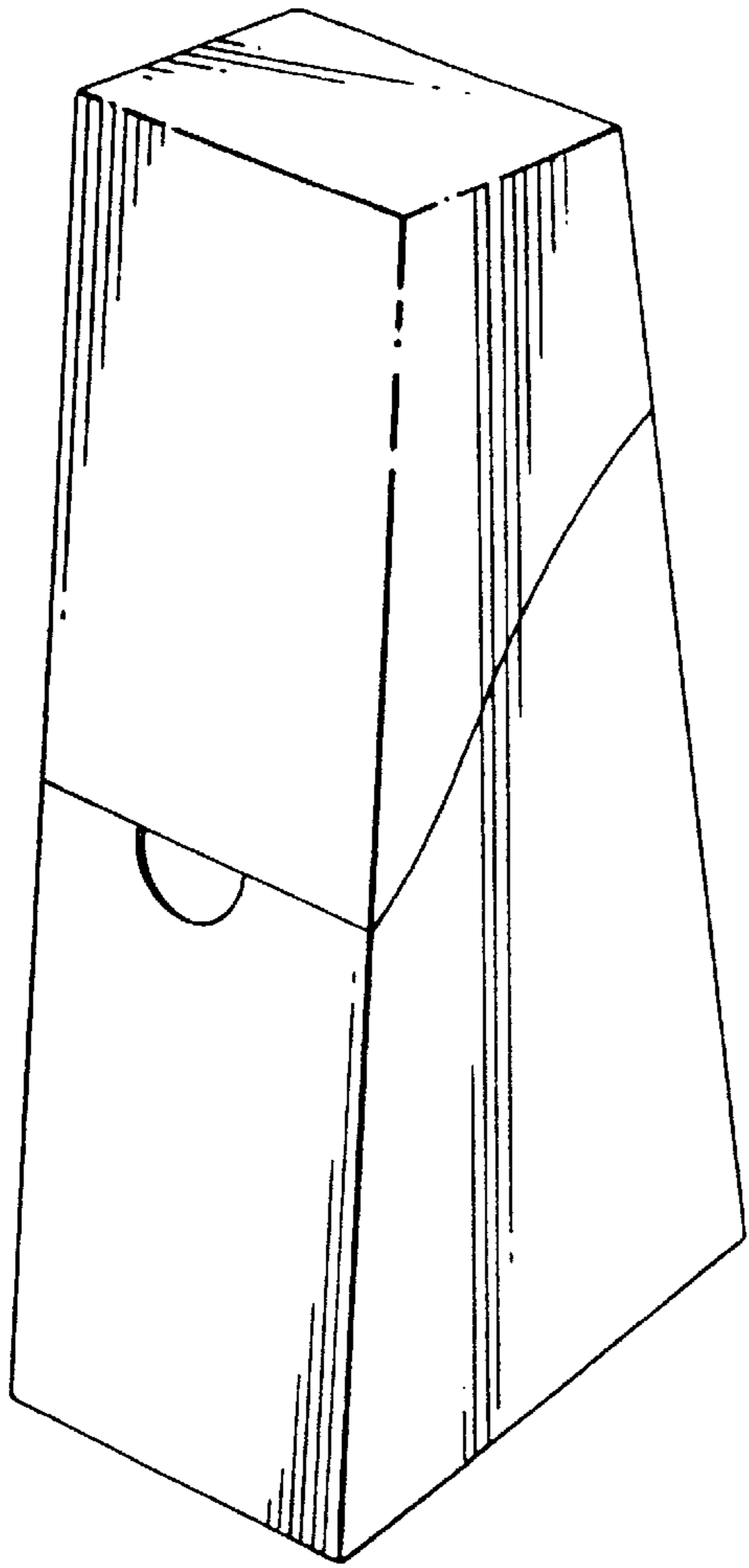

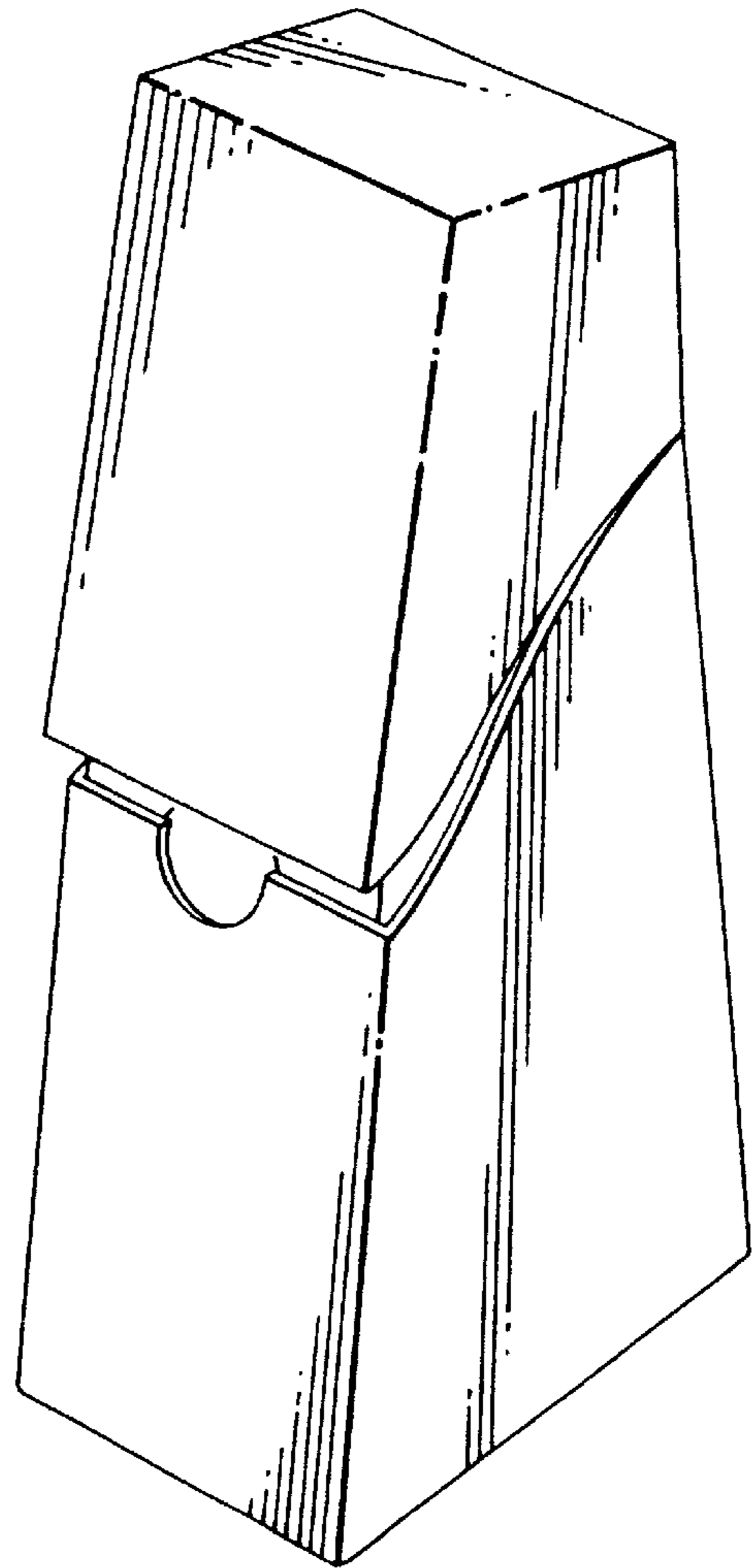

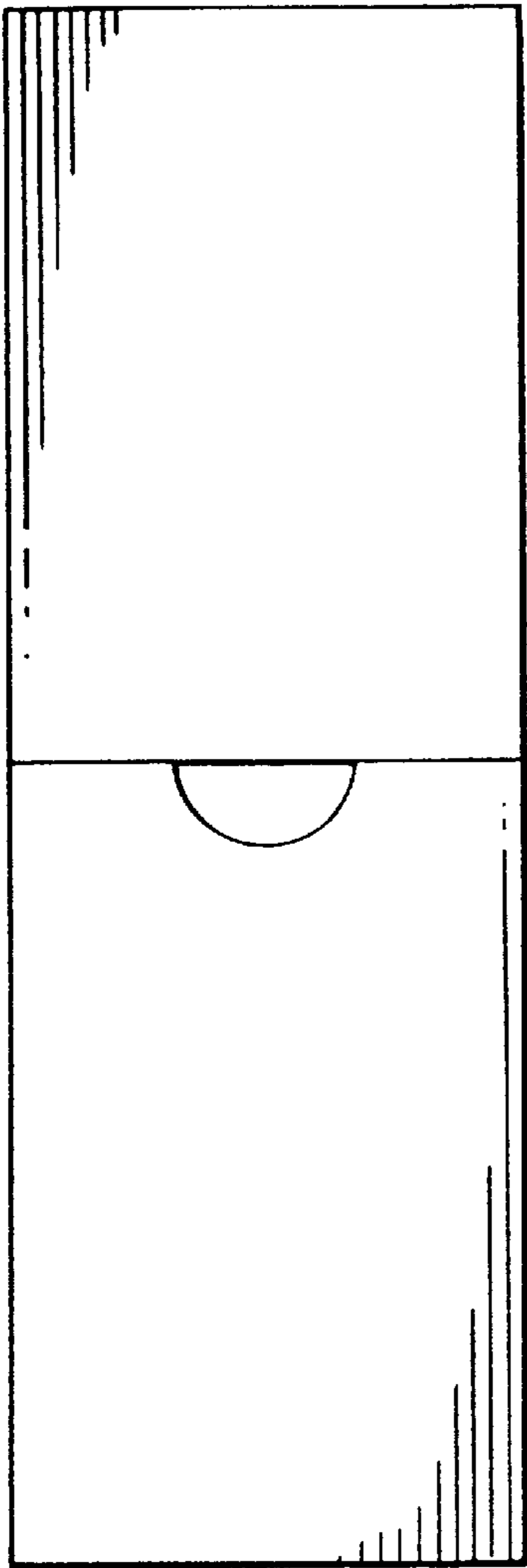

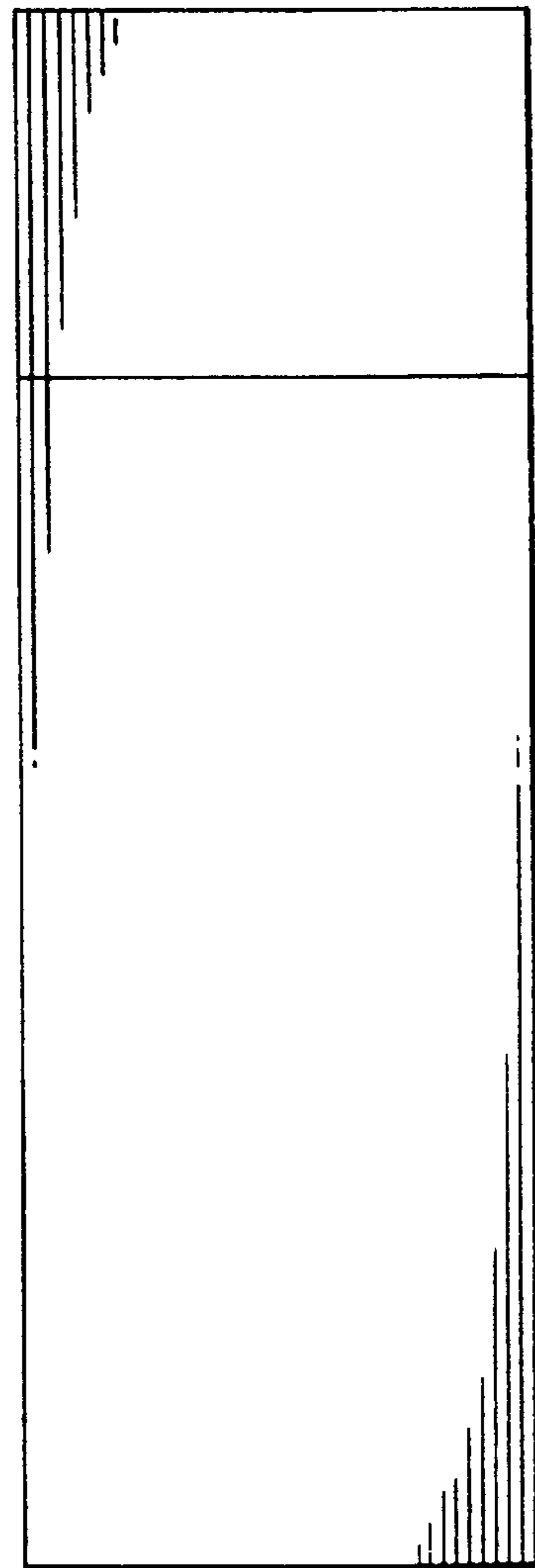

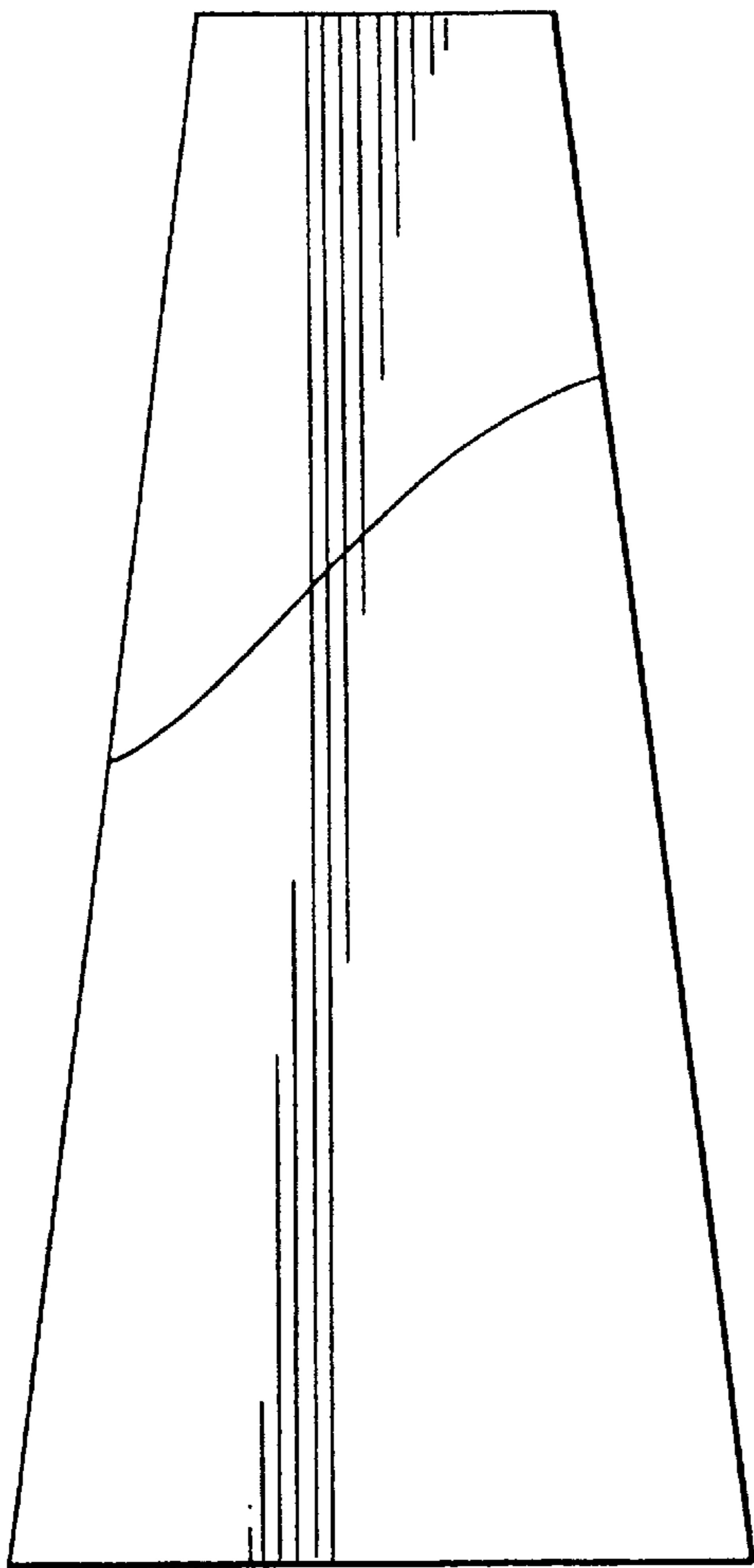

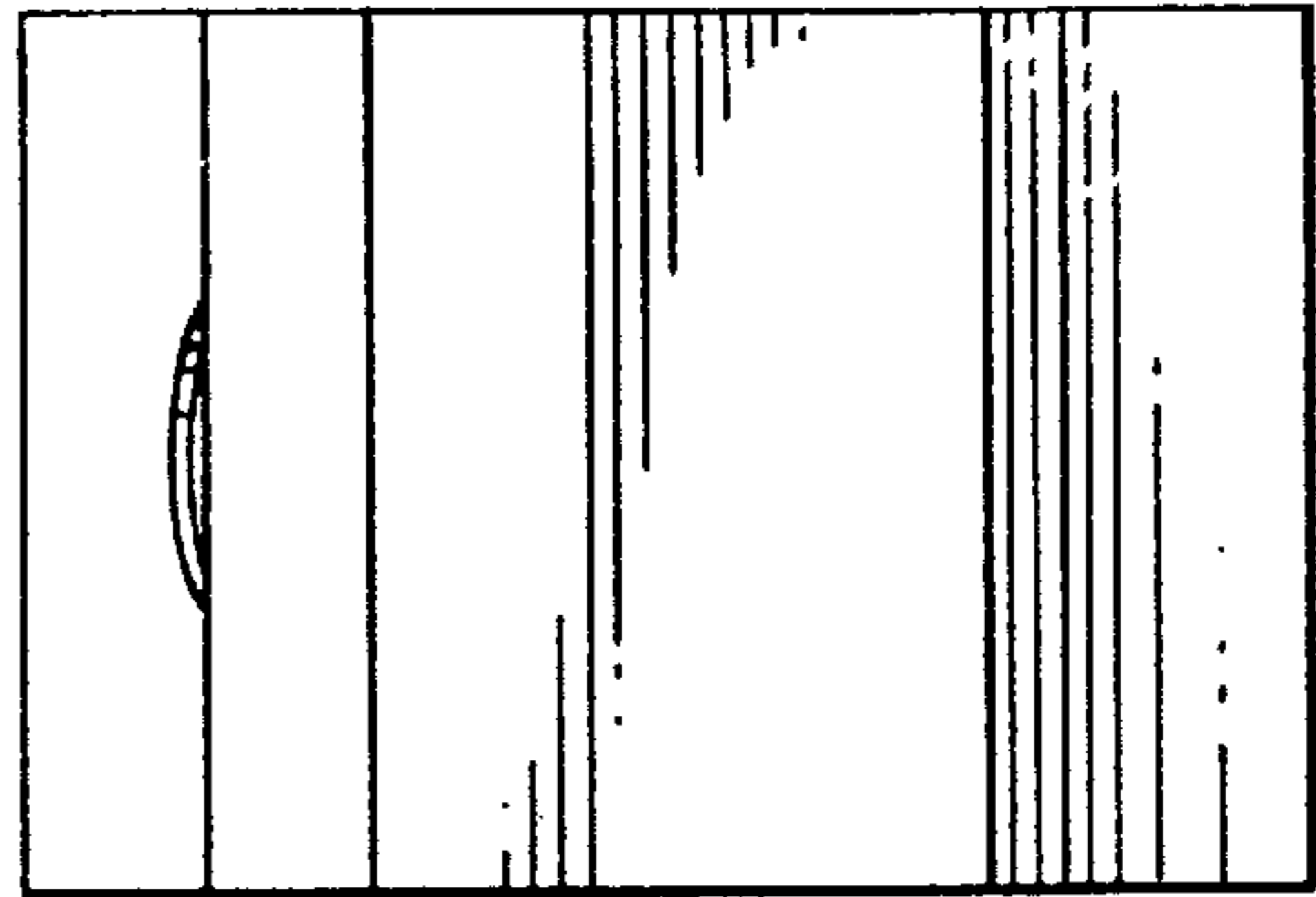

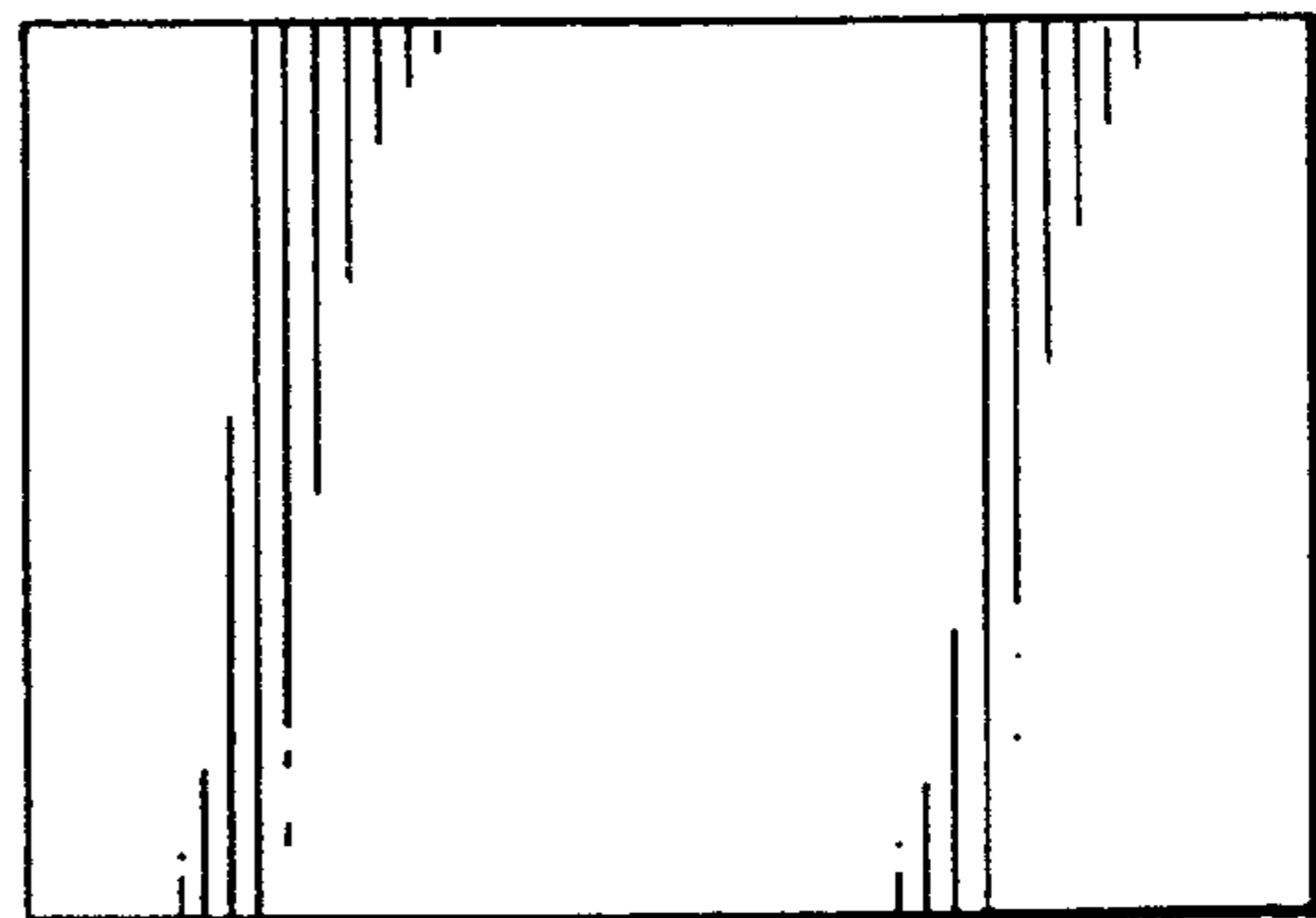

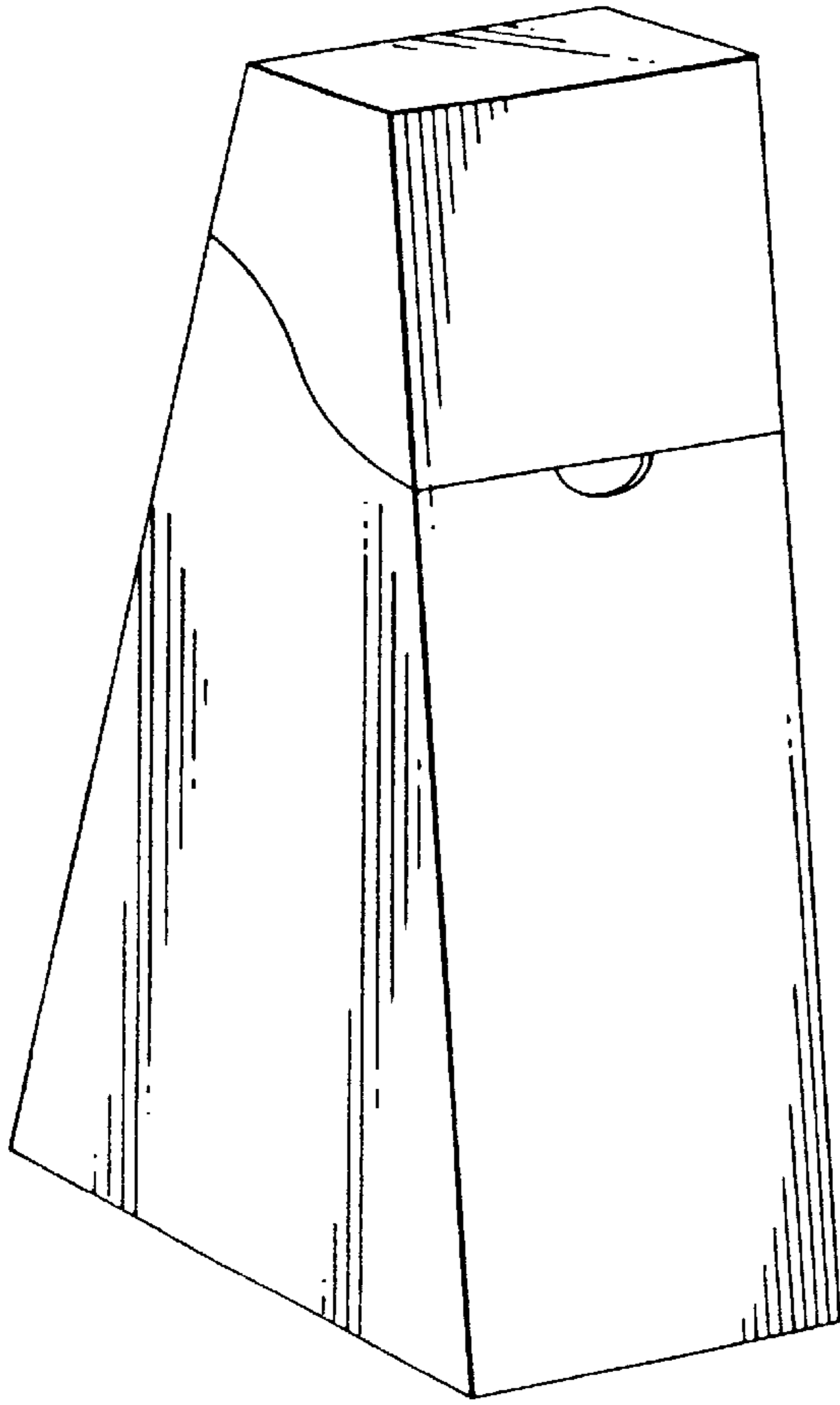

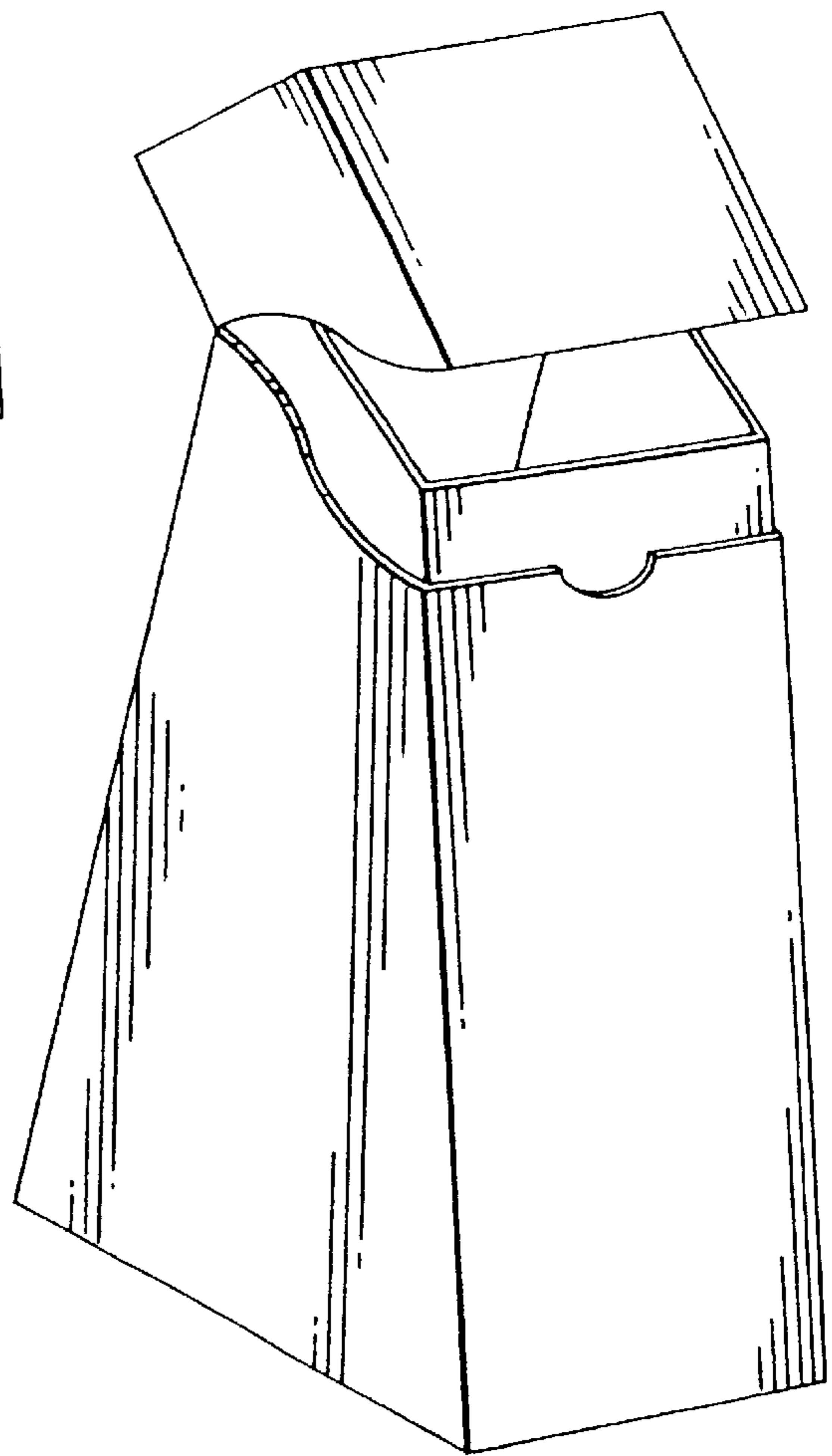

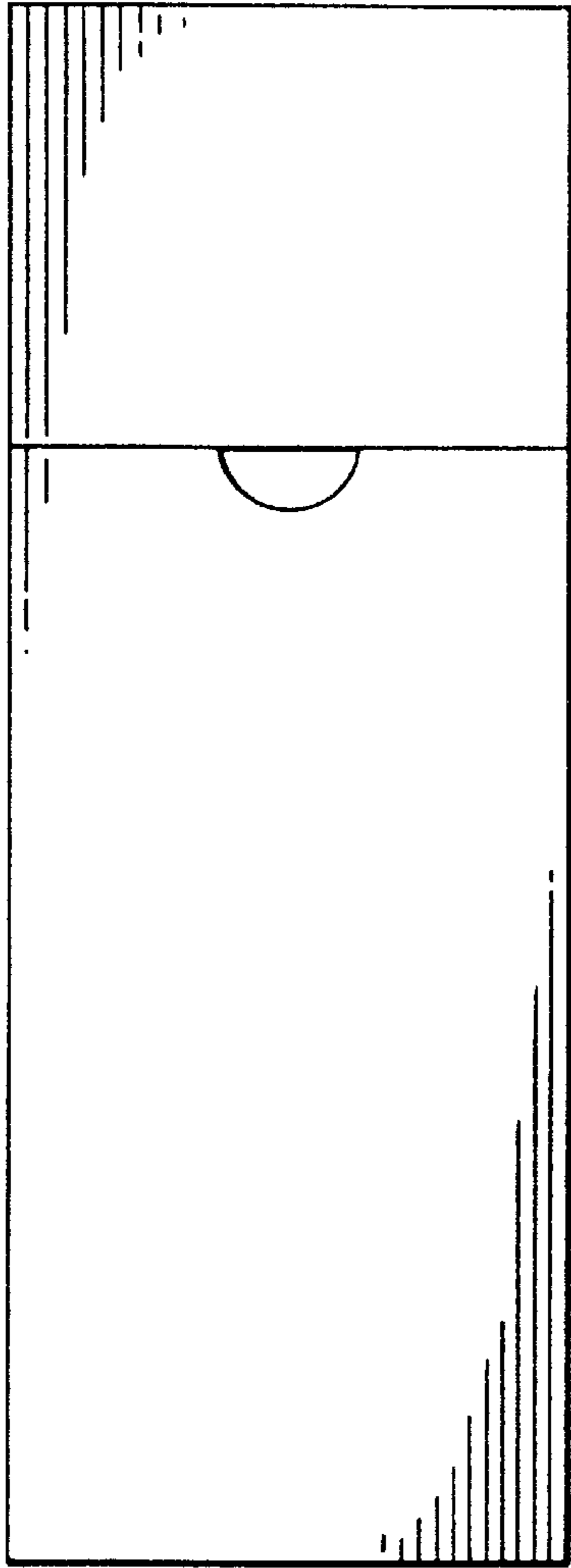

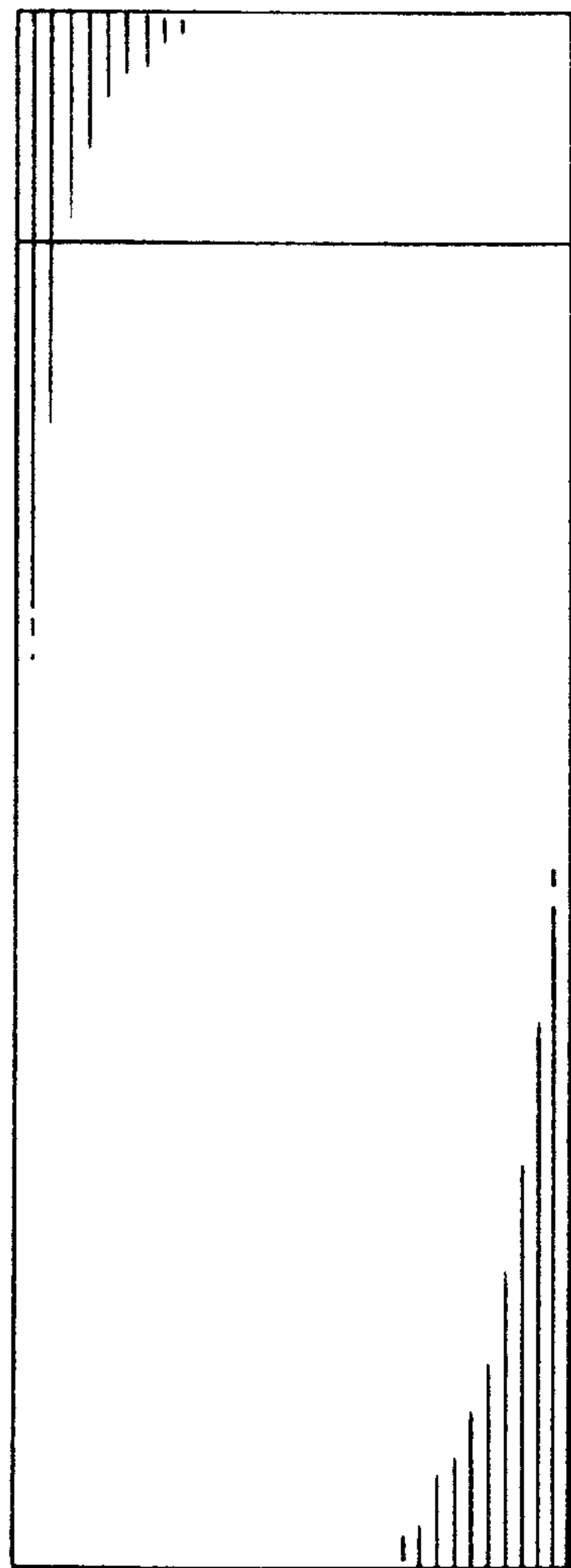

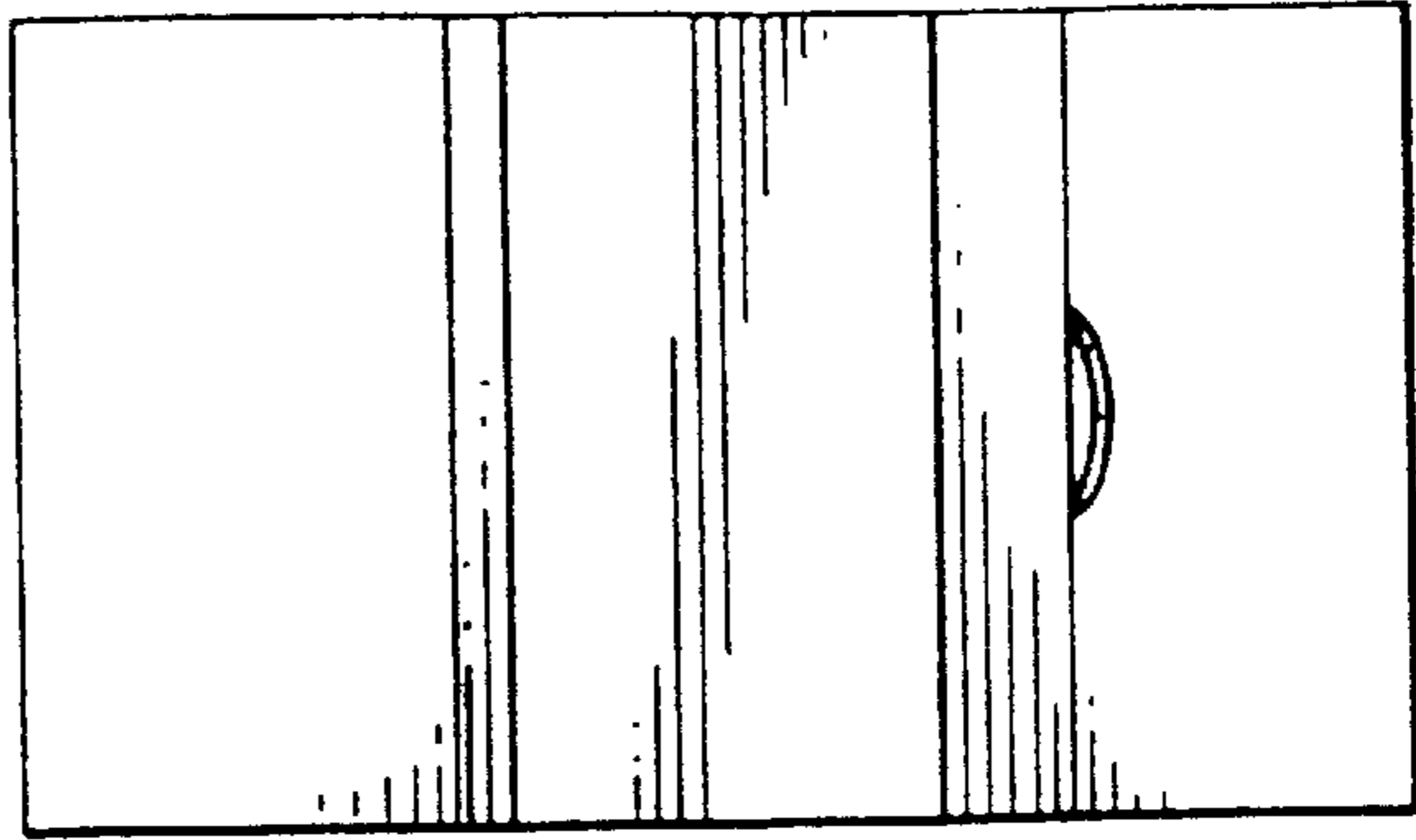

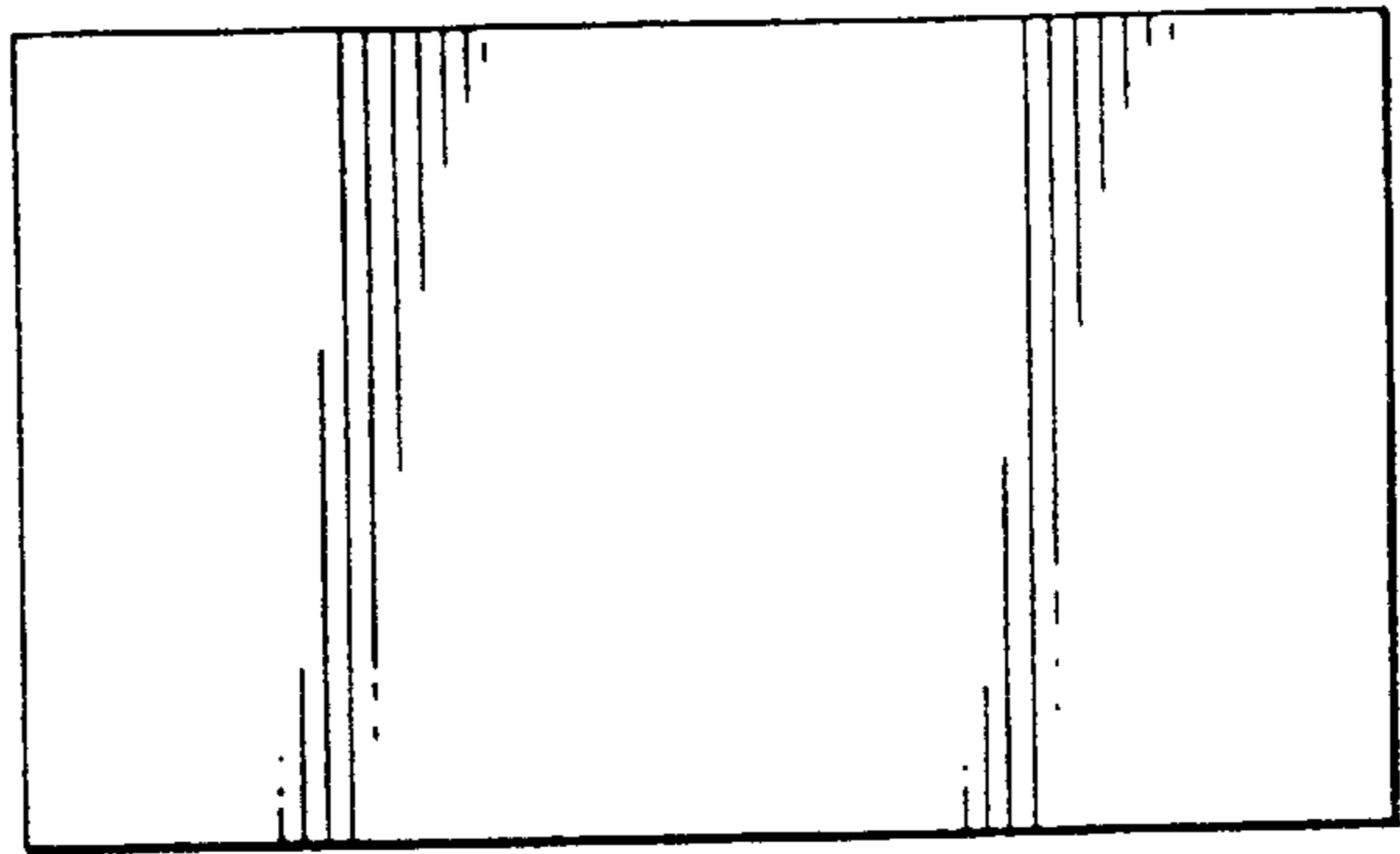

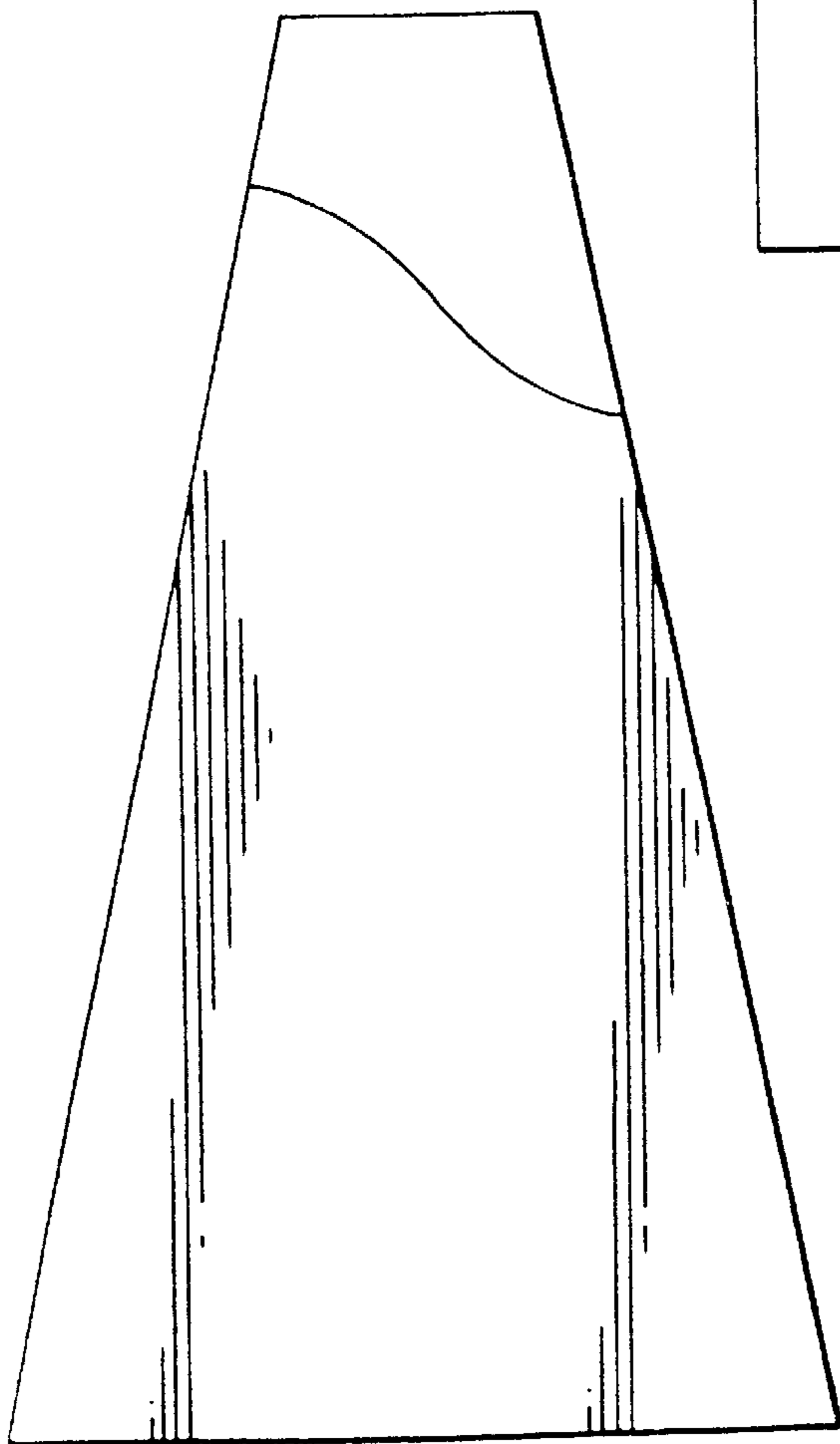

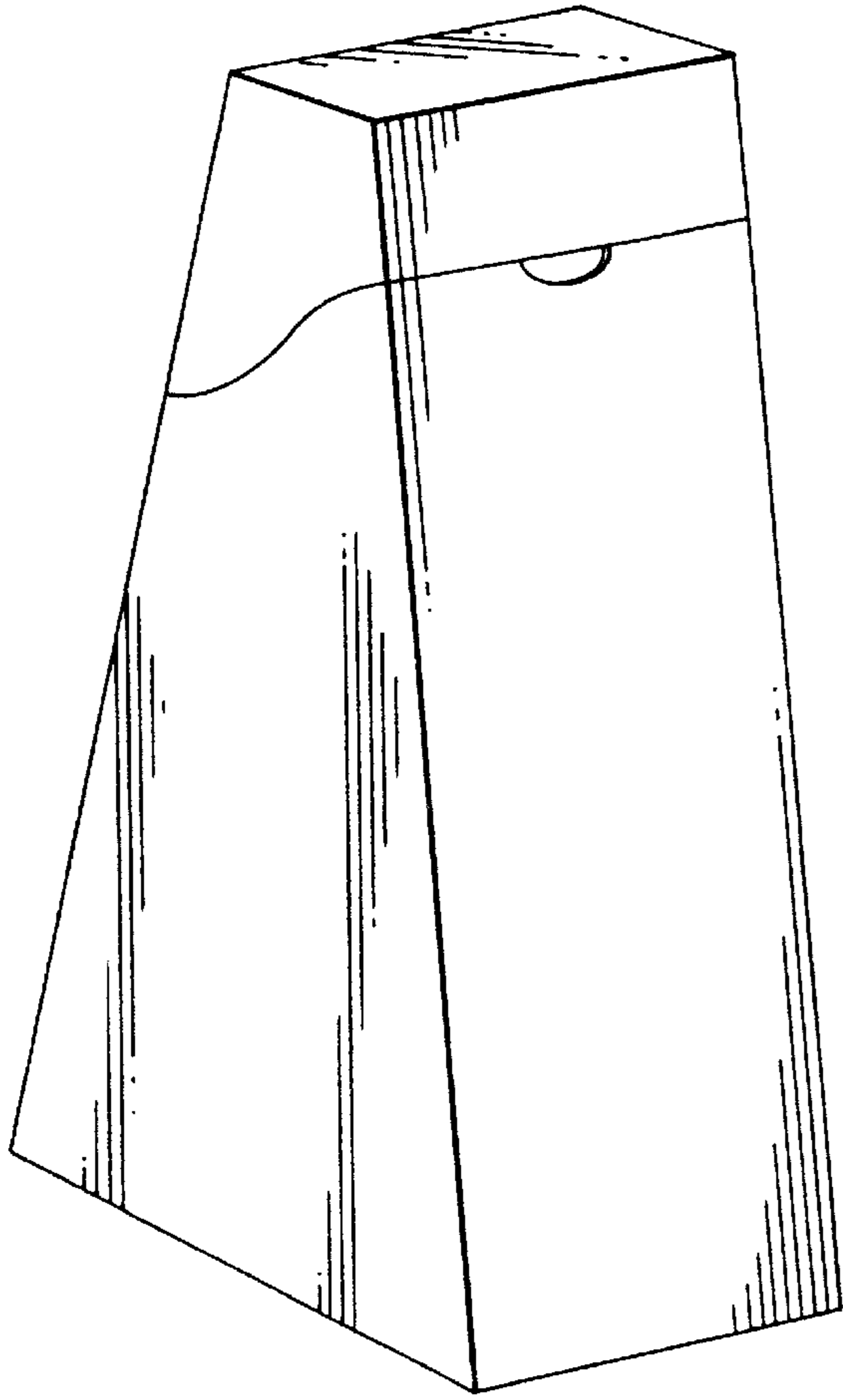

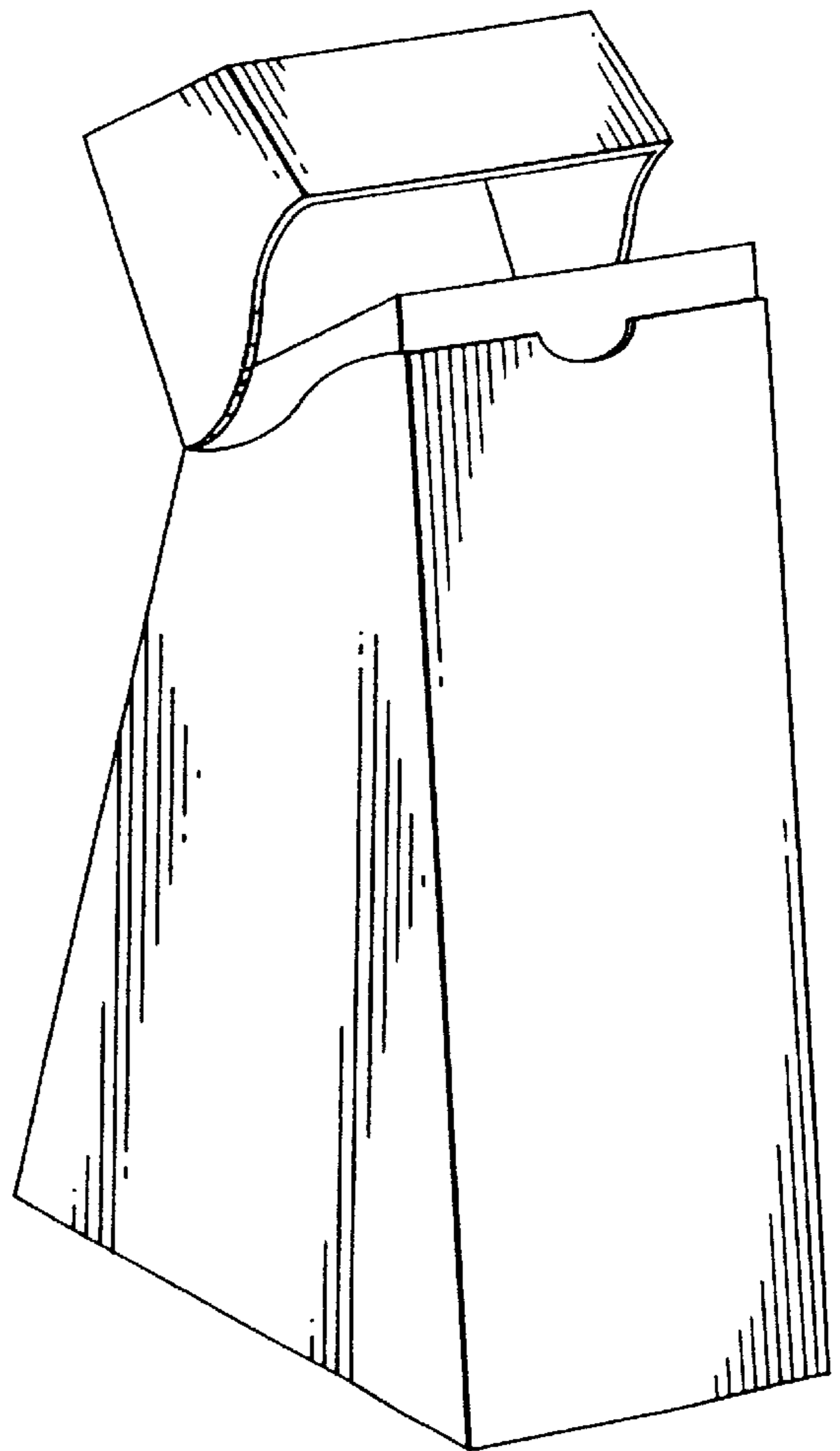

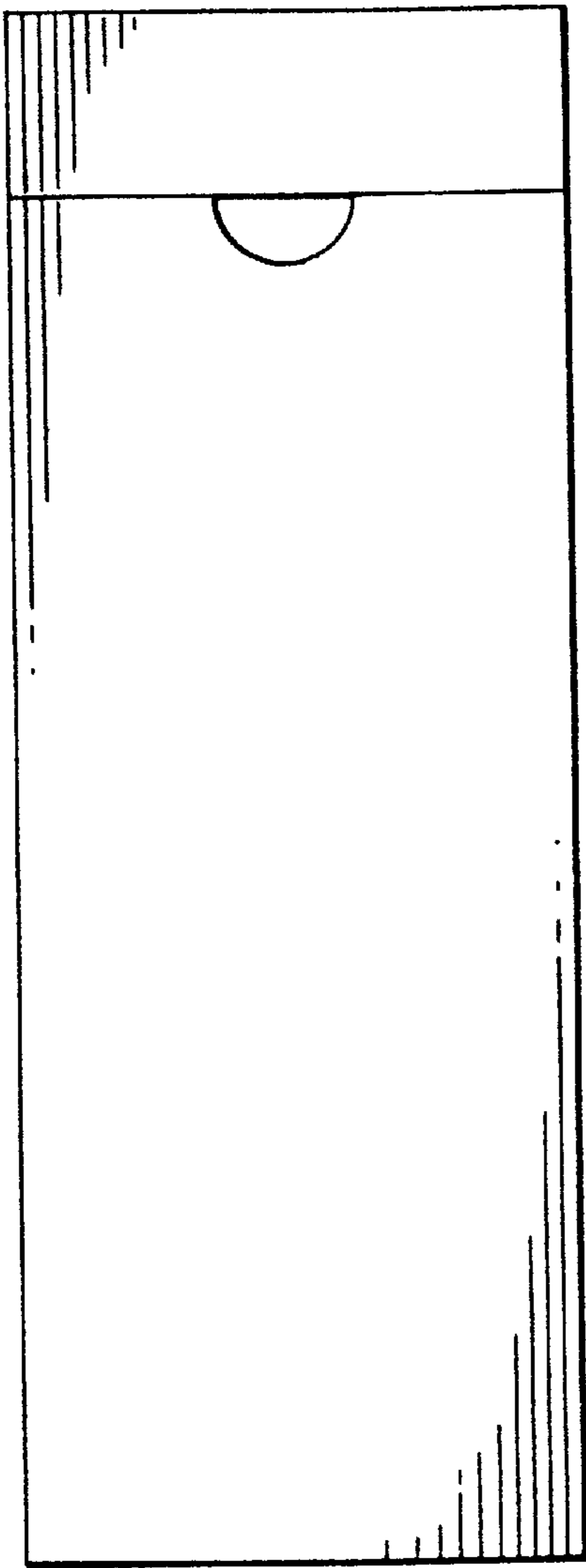

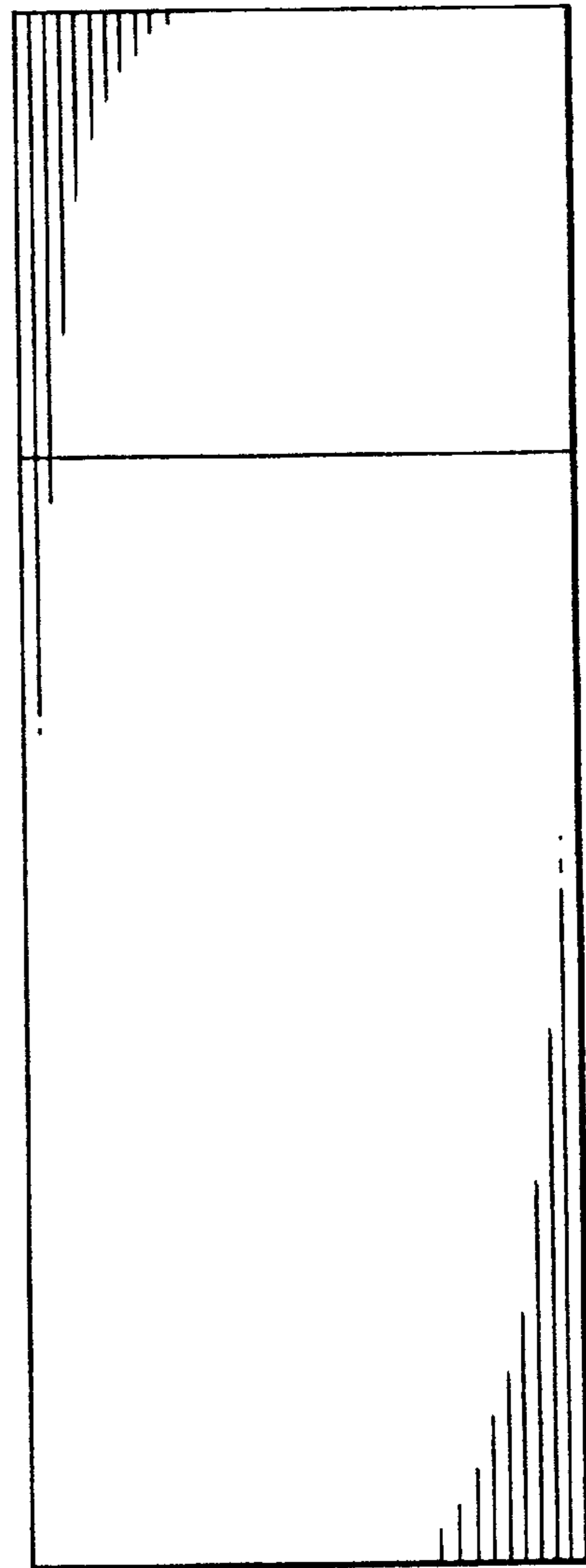

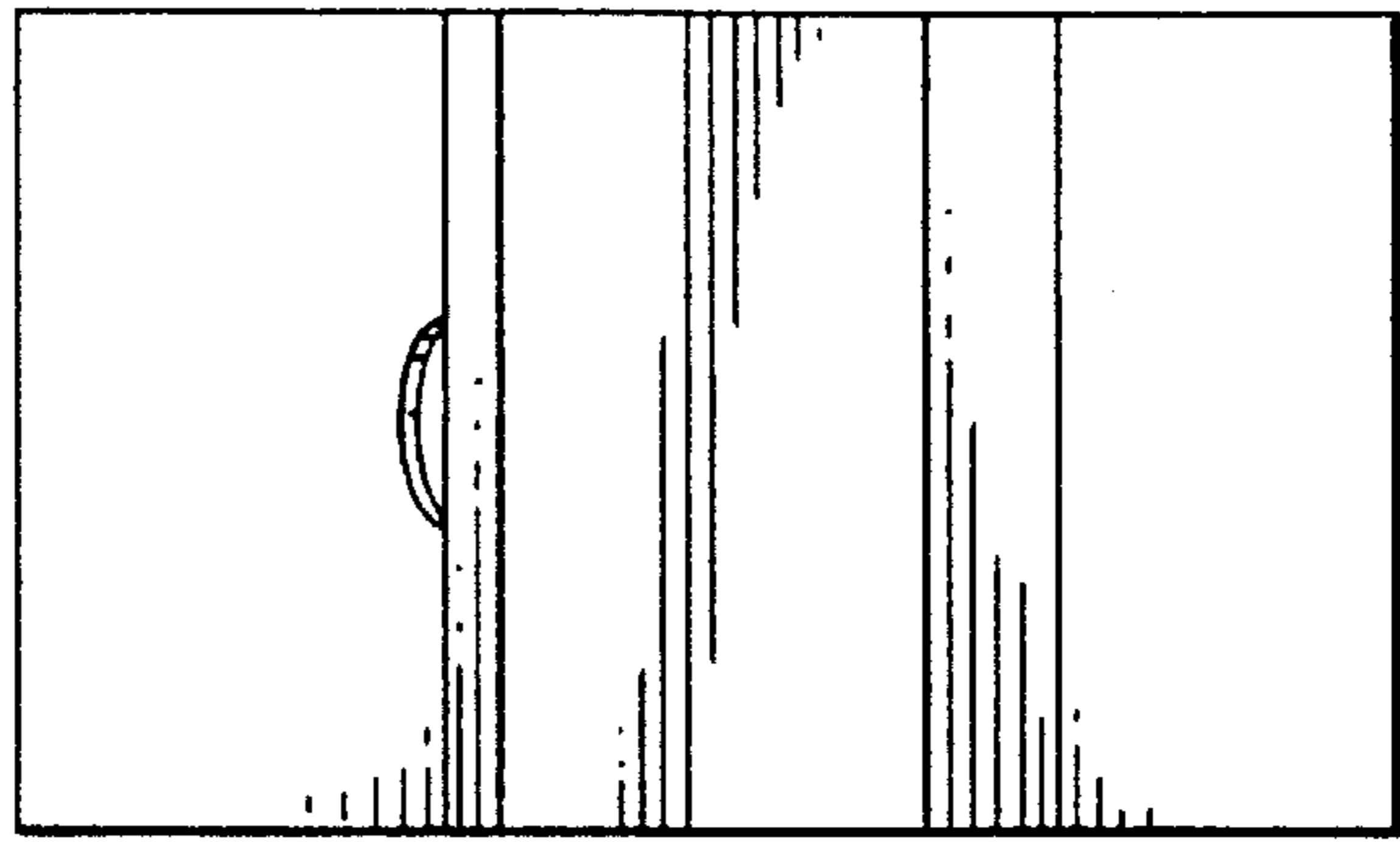

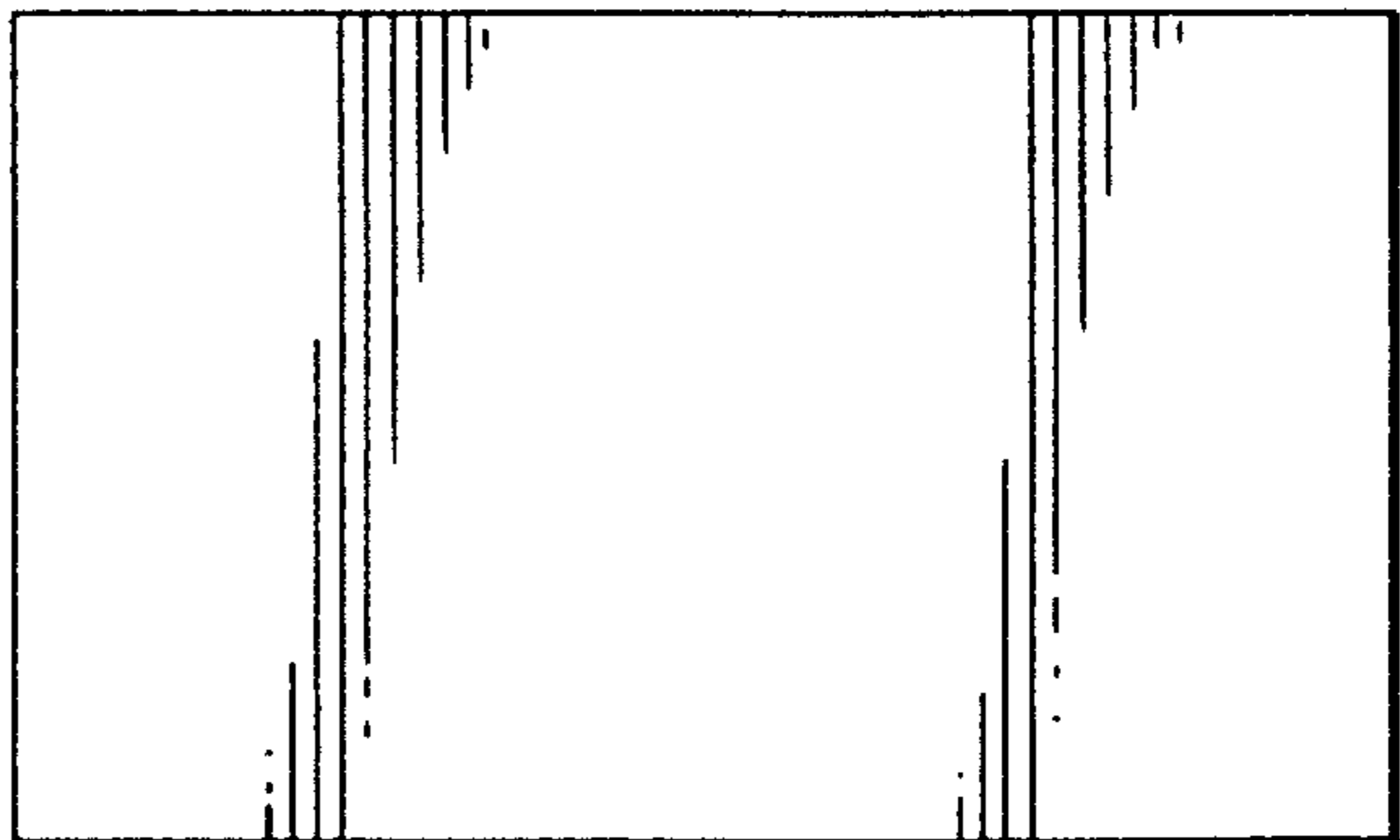

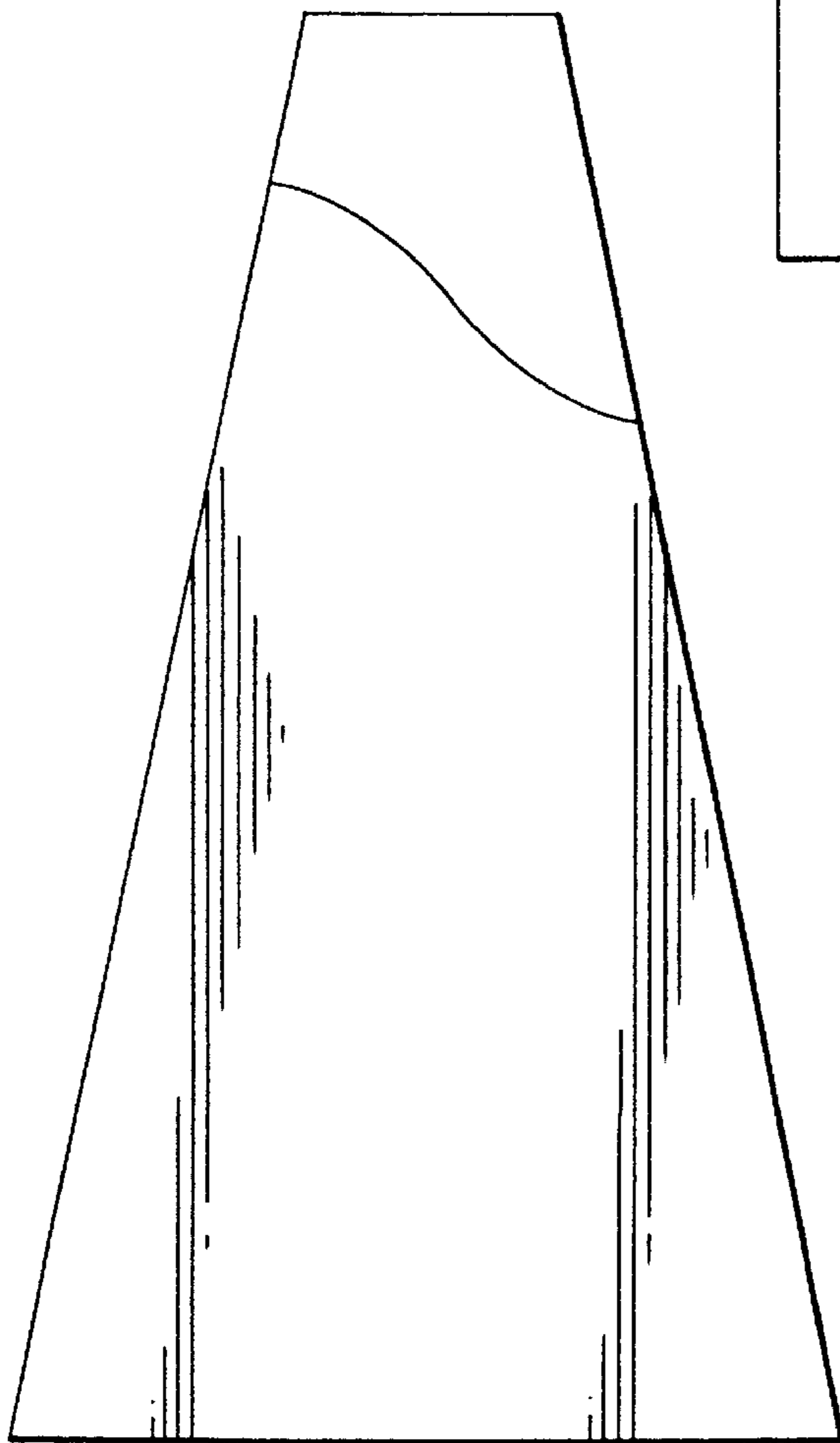
