**DESCRIPTION**

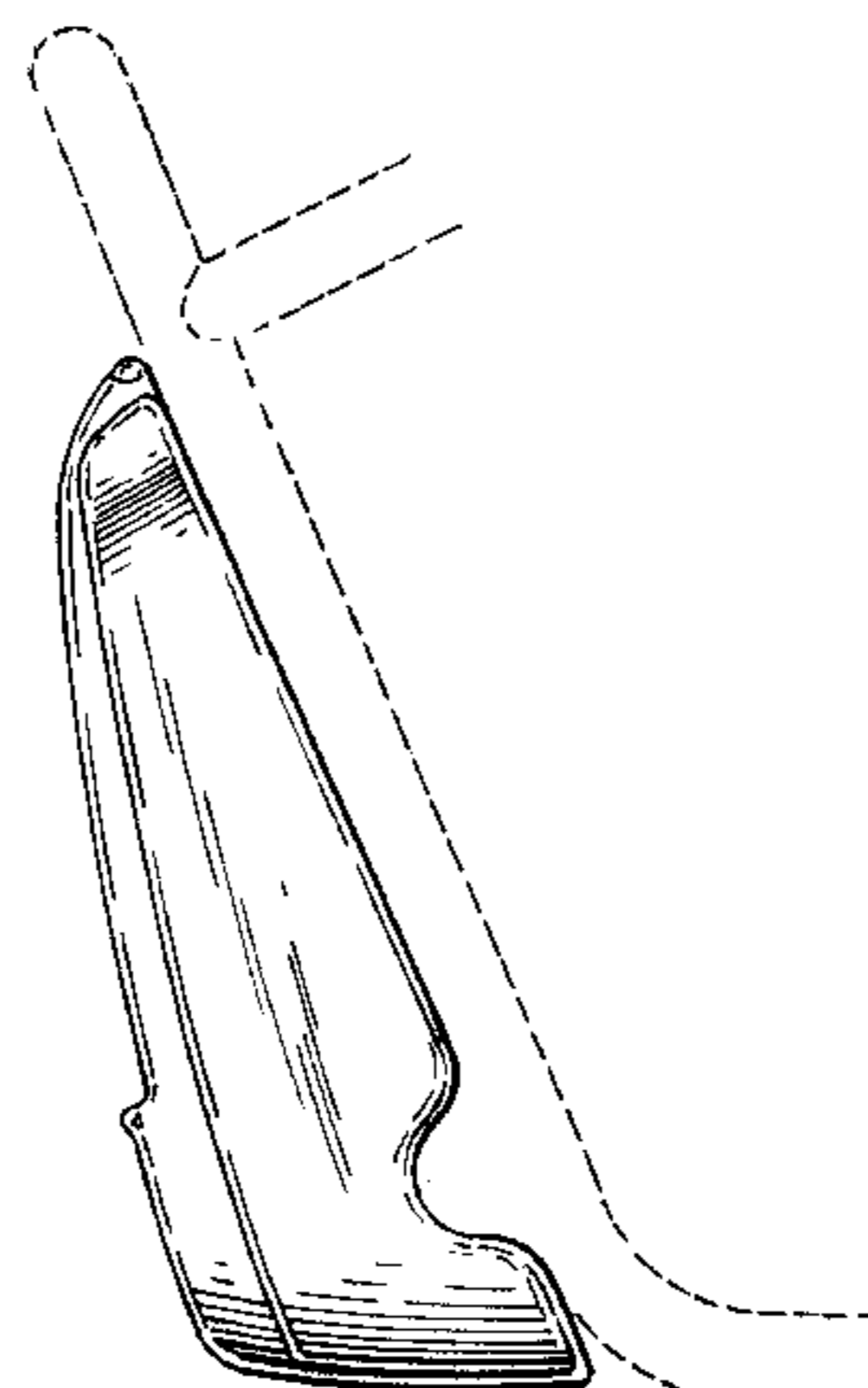
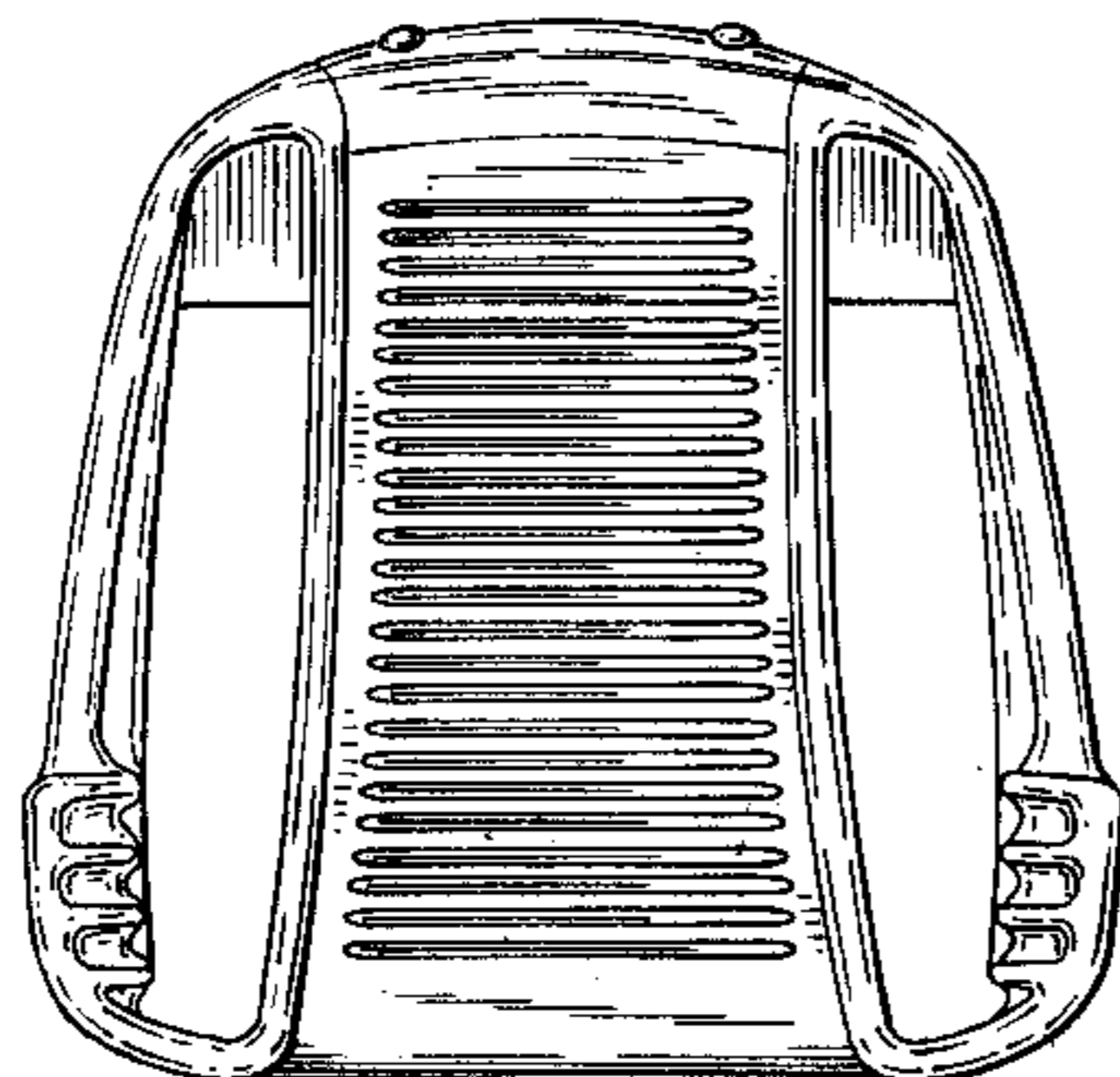
FIG. 1 is a perspective view of the motorcycle radiator cover, shown in position of use from the right side of a motorcycle.

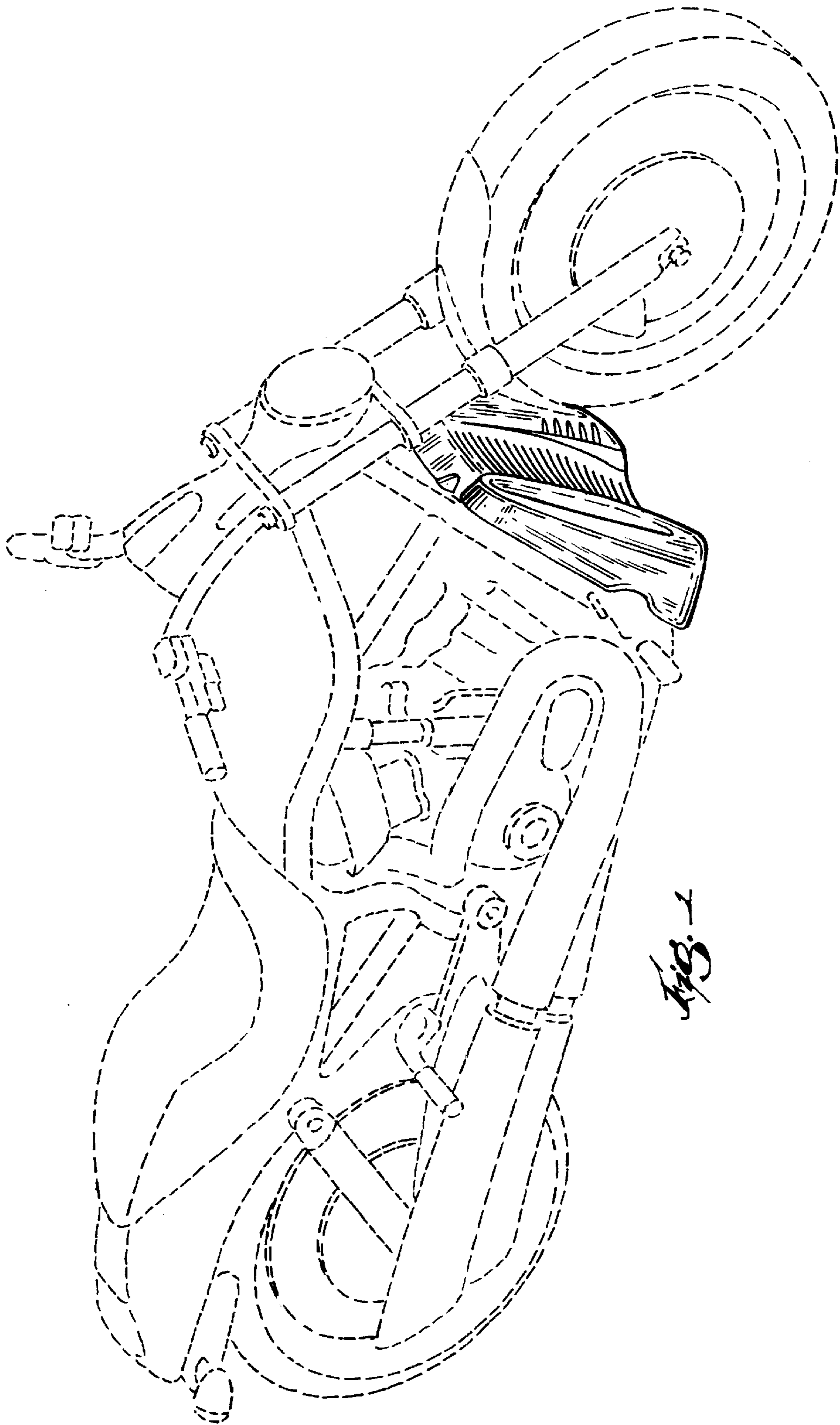
FIG. 2 is an enlarged front view of the motorcycle radiator cover; and,

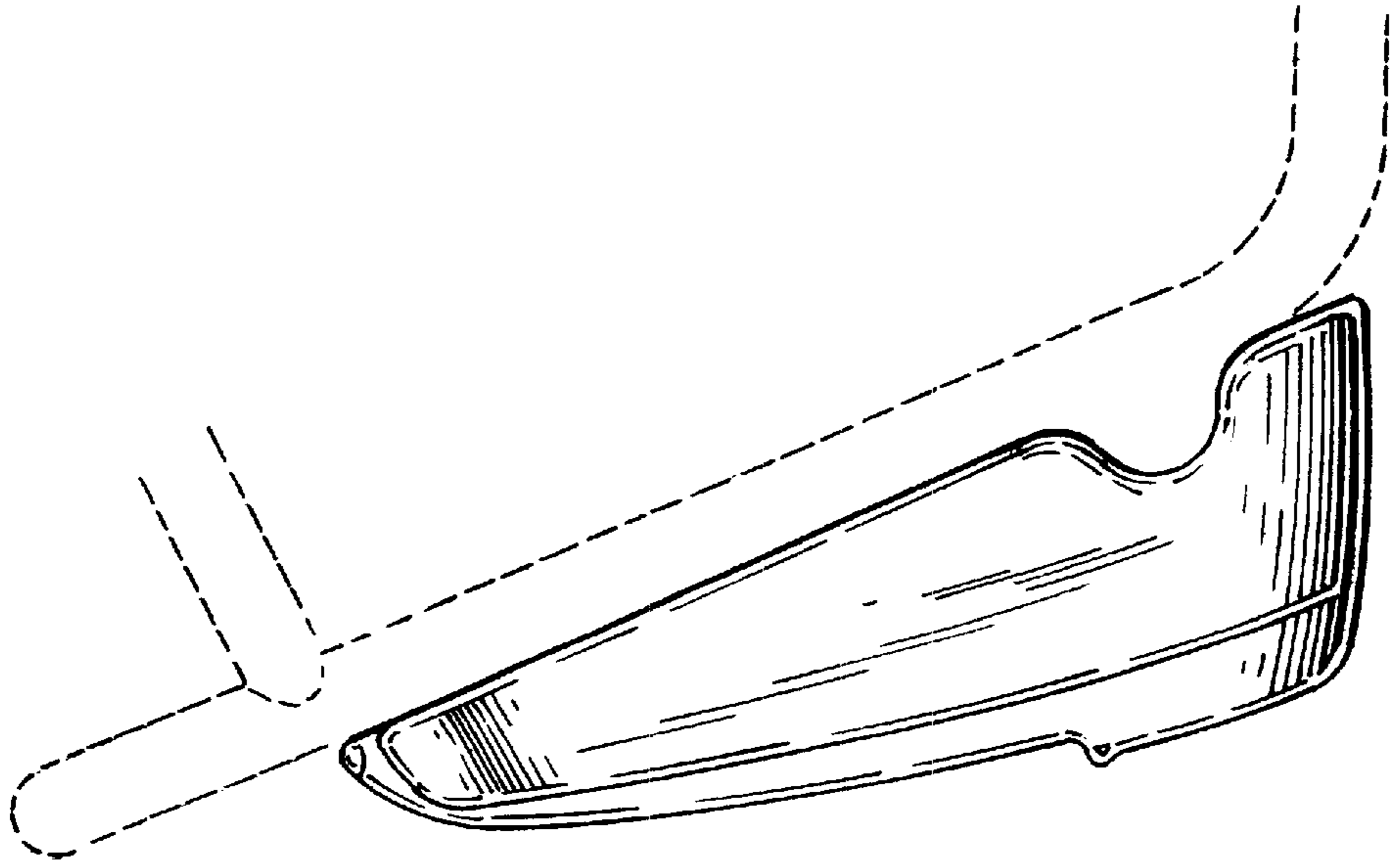
FIG. 3 is a left side view of the motorcycle radiator cover shown in FIG. 2.

The broken line showing of the environment is for illustrative purposes only and forms no part of the claimed design.

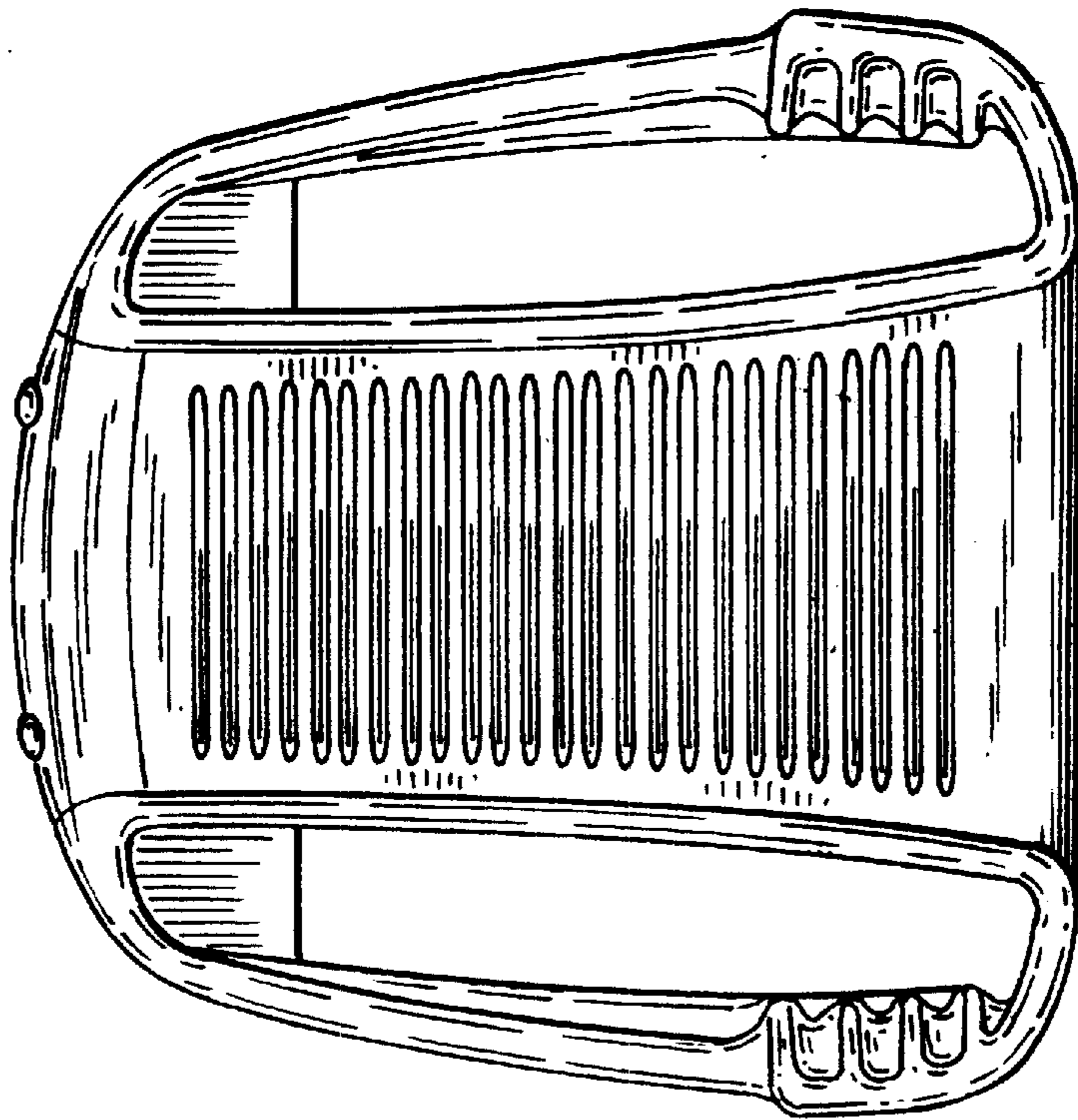
