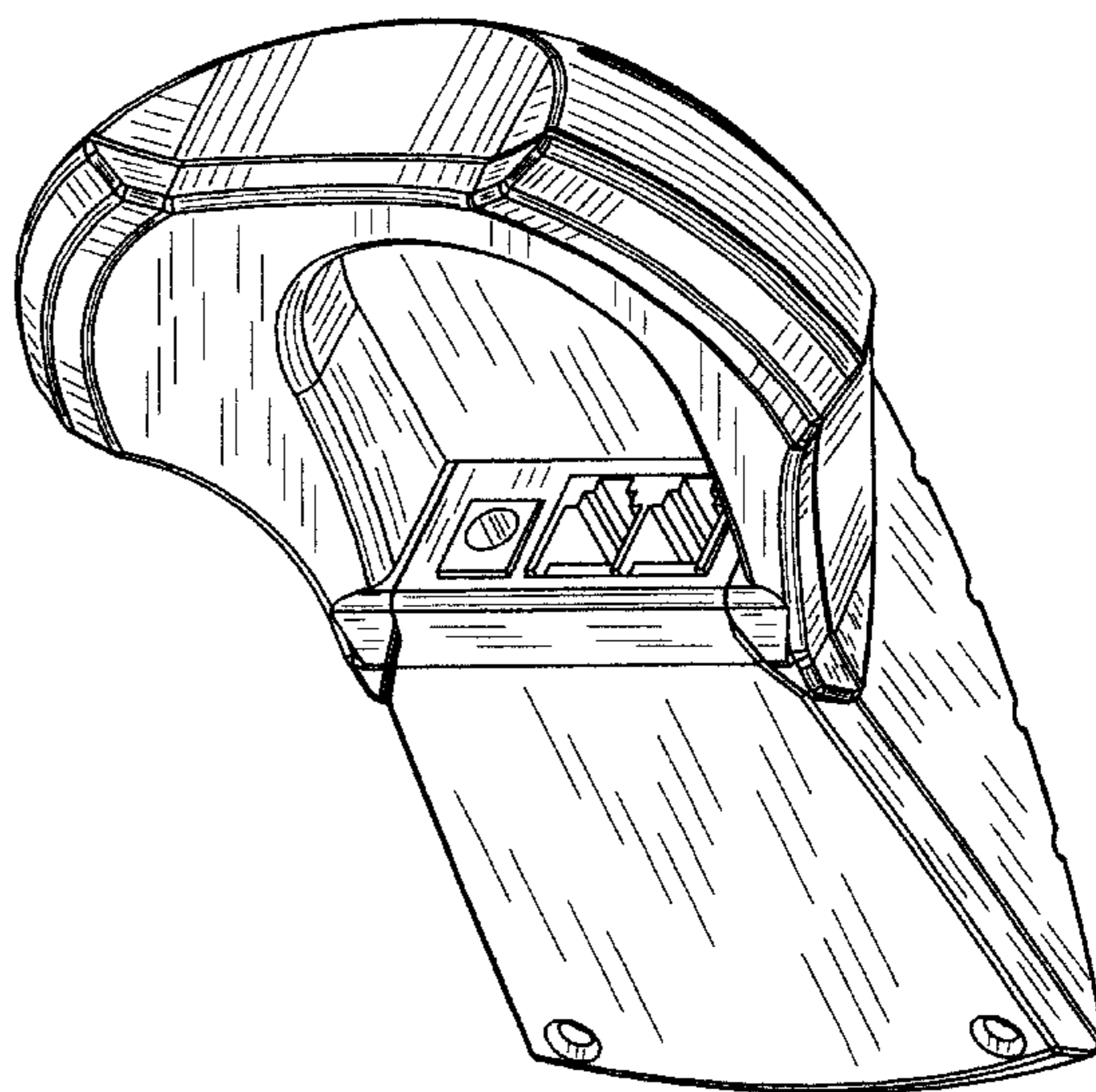
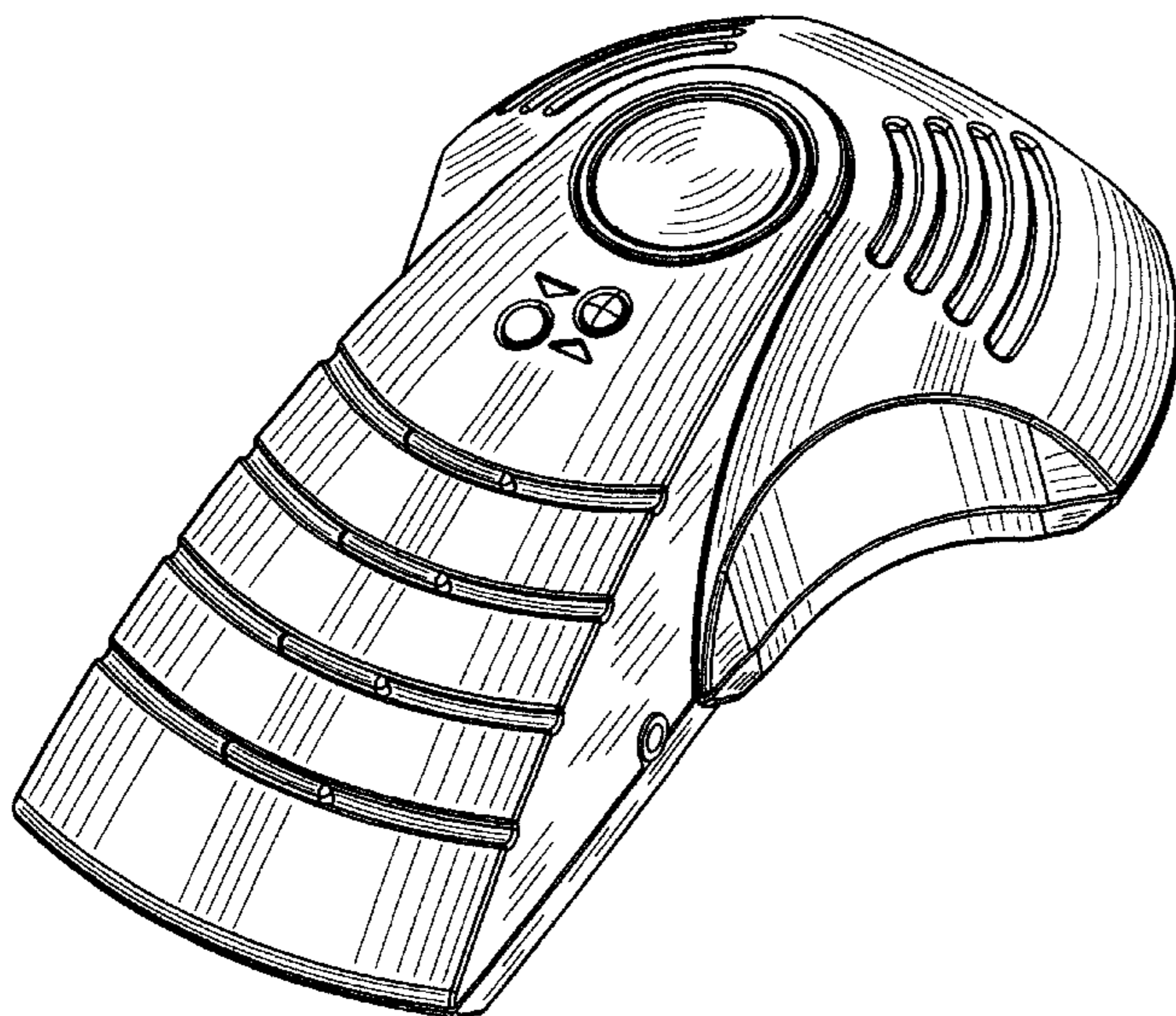
(57) **CLAIM**

The ornamental design for a telephone accessory, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a telephone accessory showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a bottom end view thereof; FIG. 6 is a top end view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

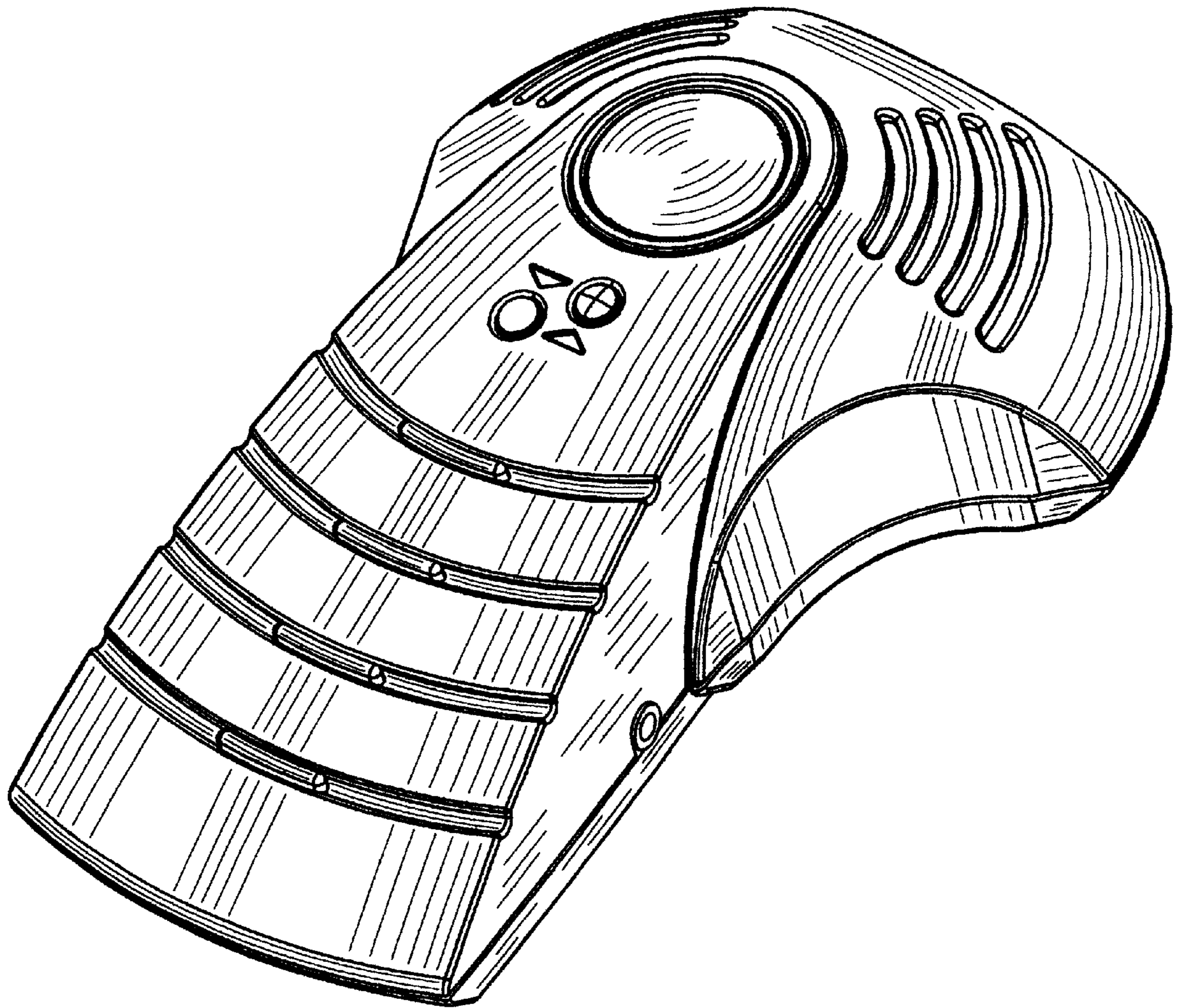

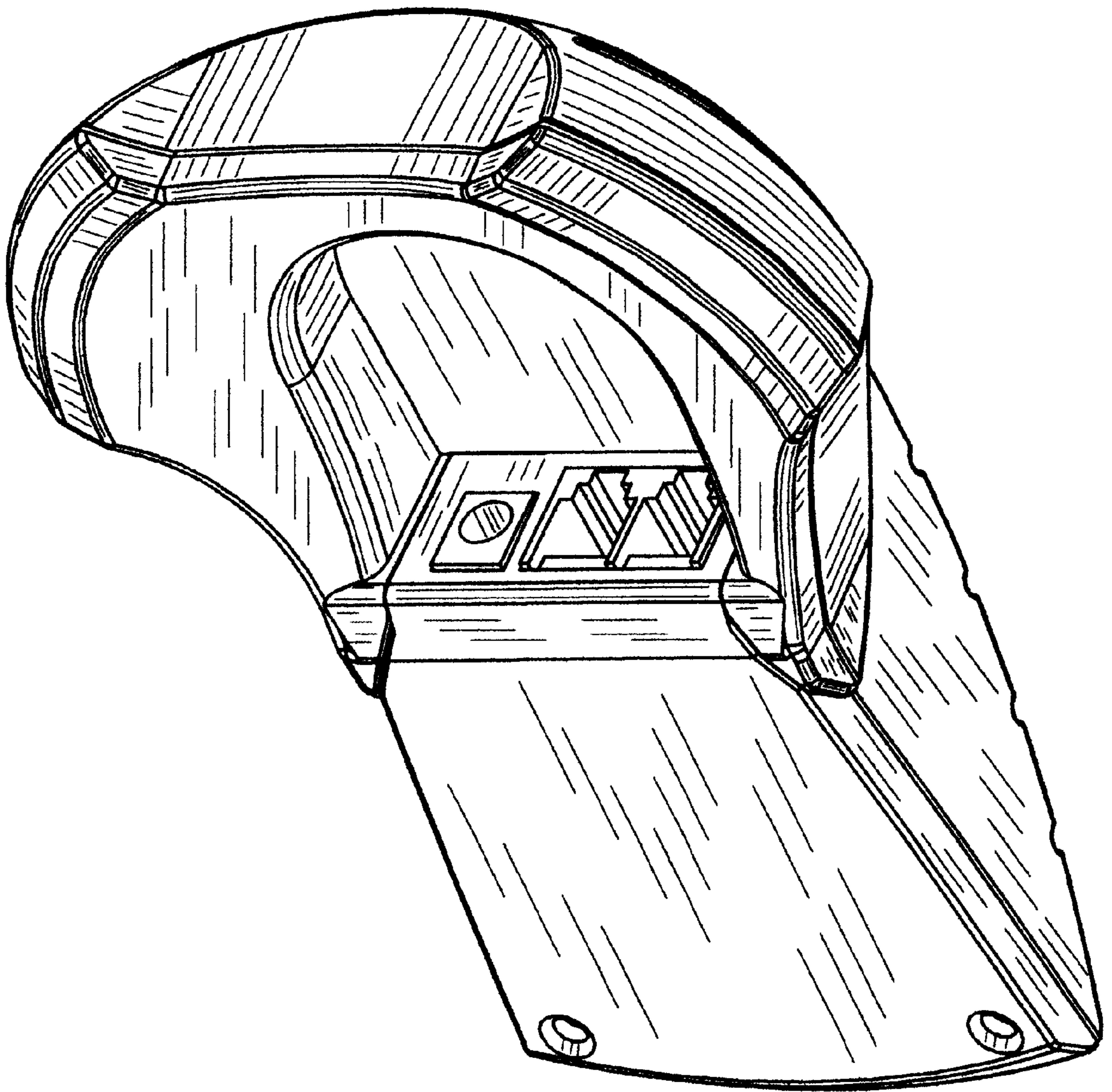

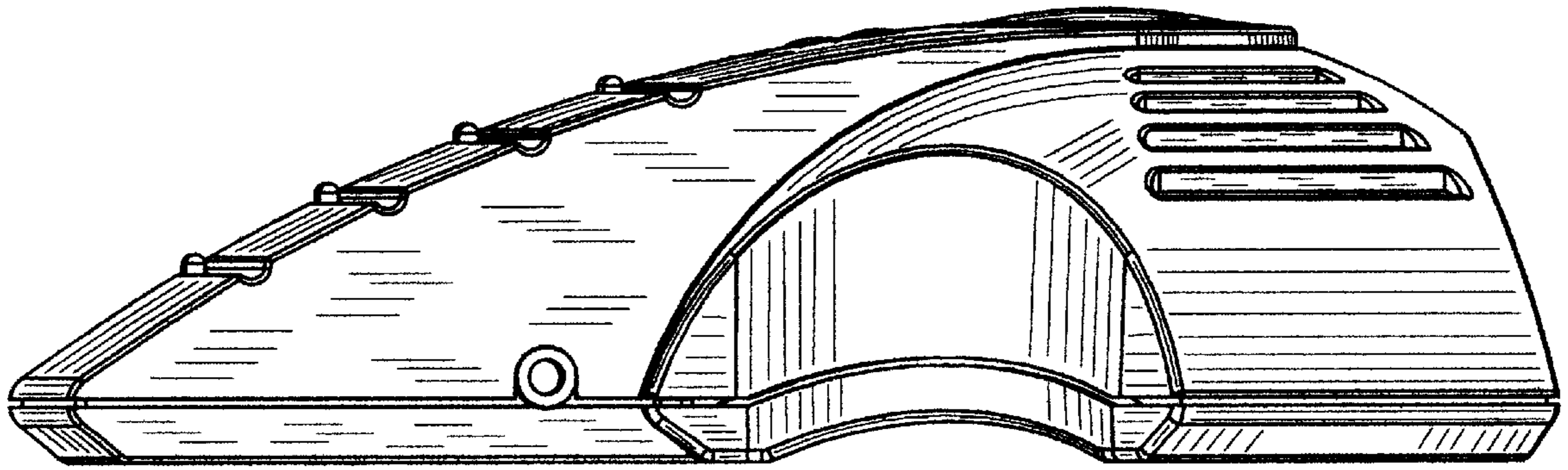

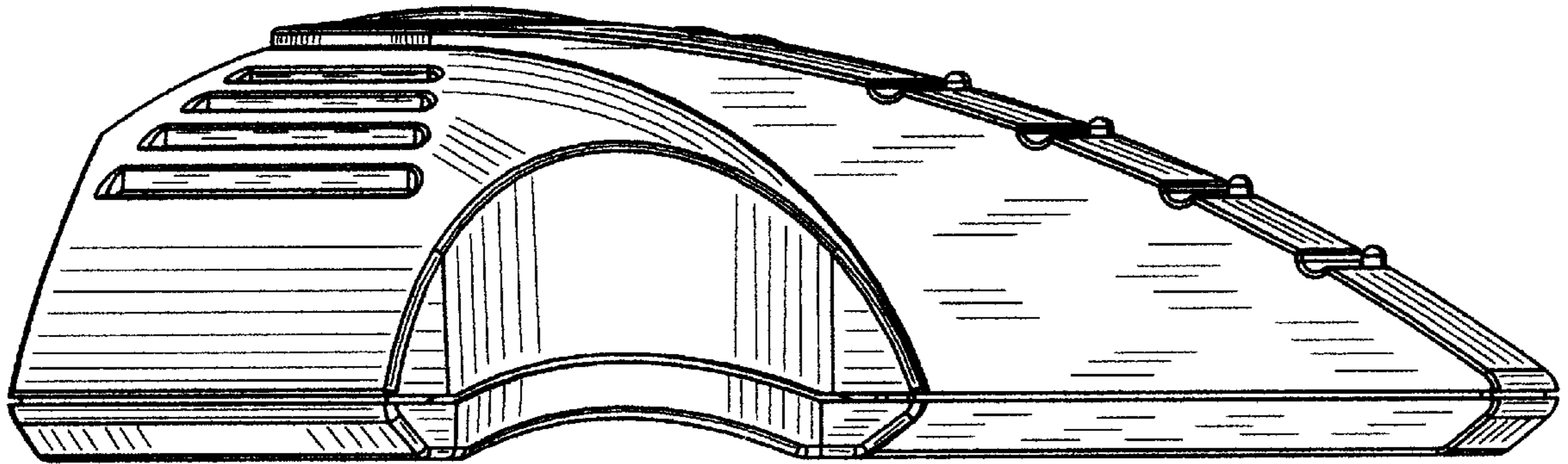

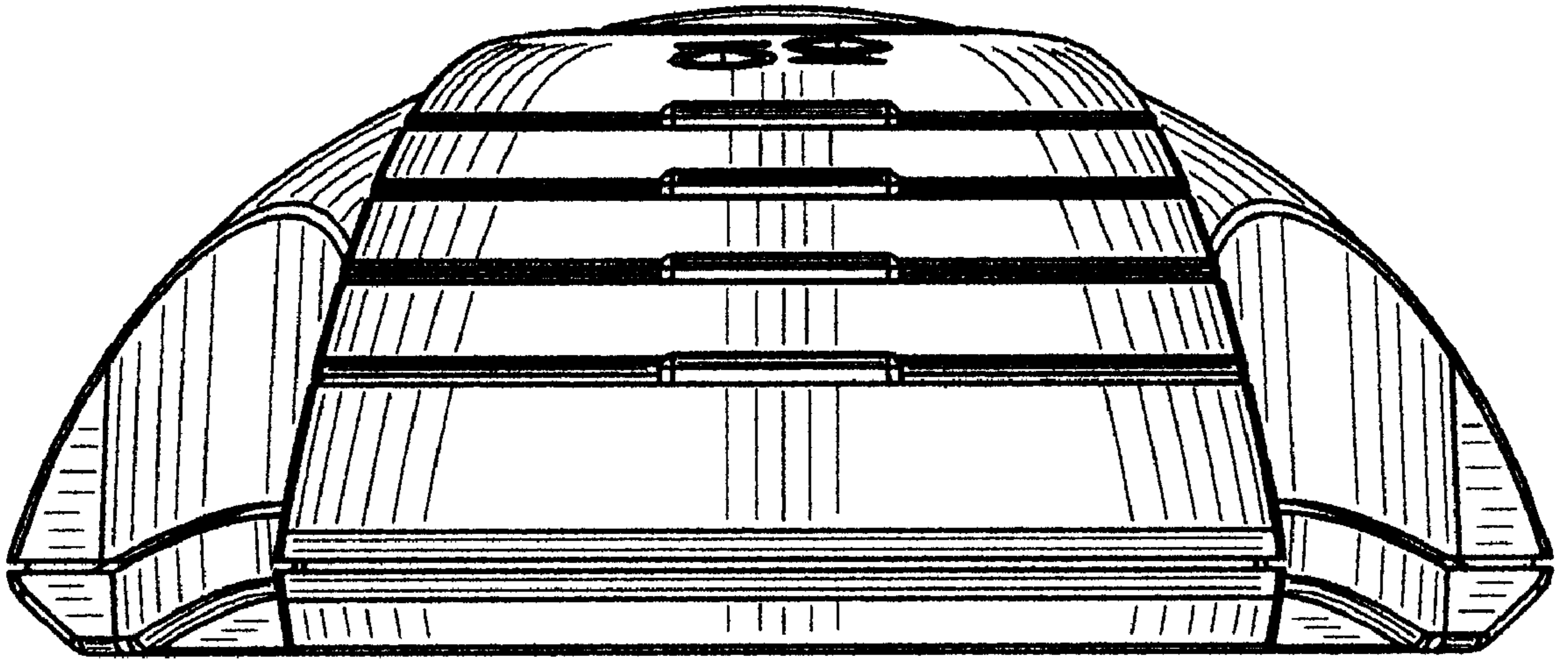

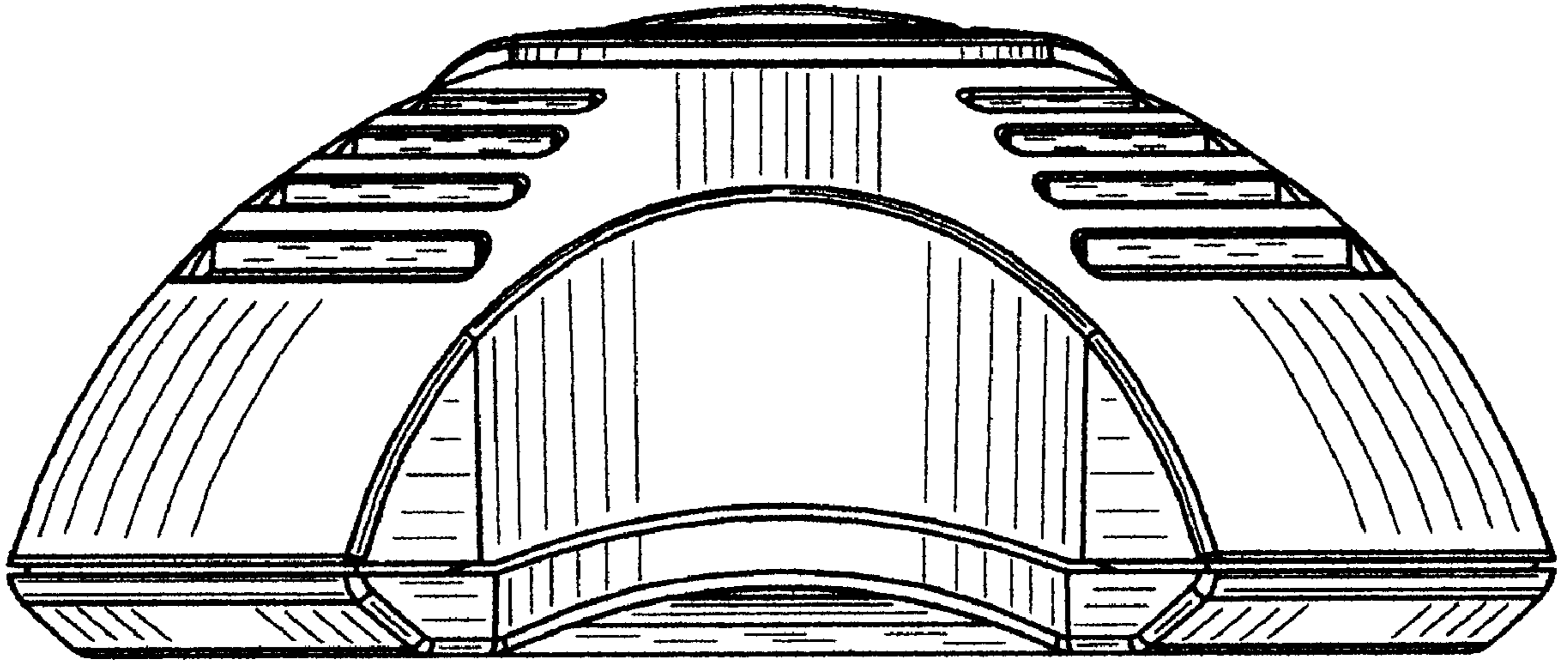

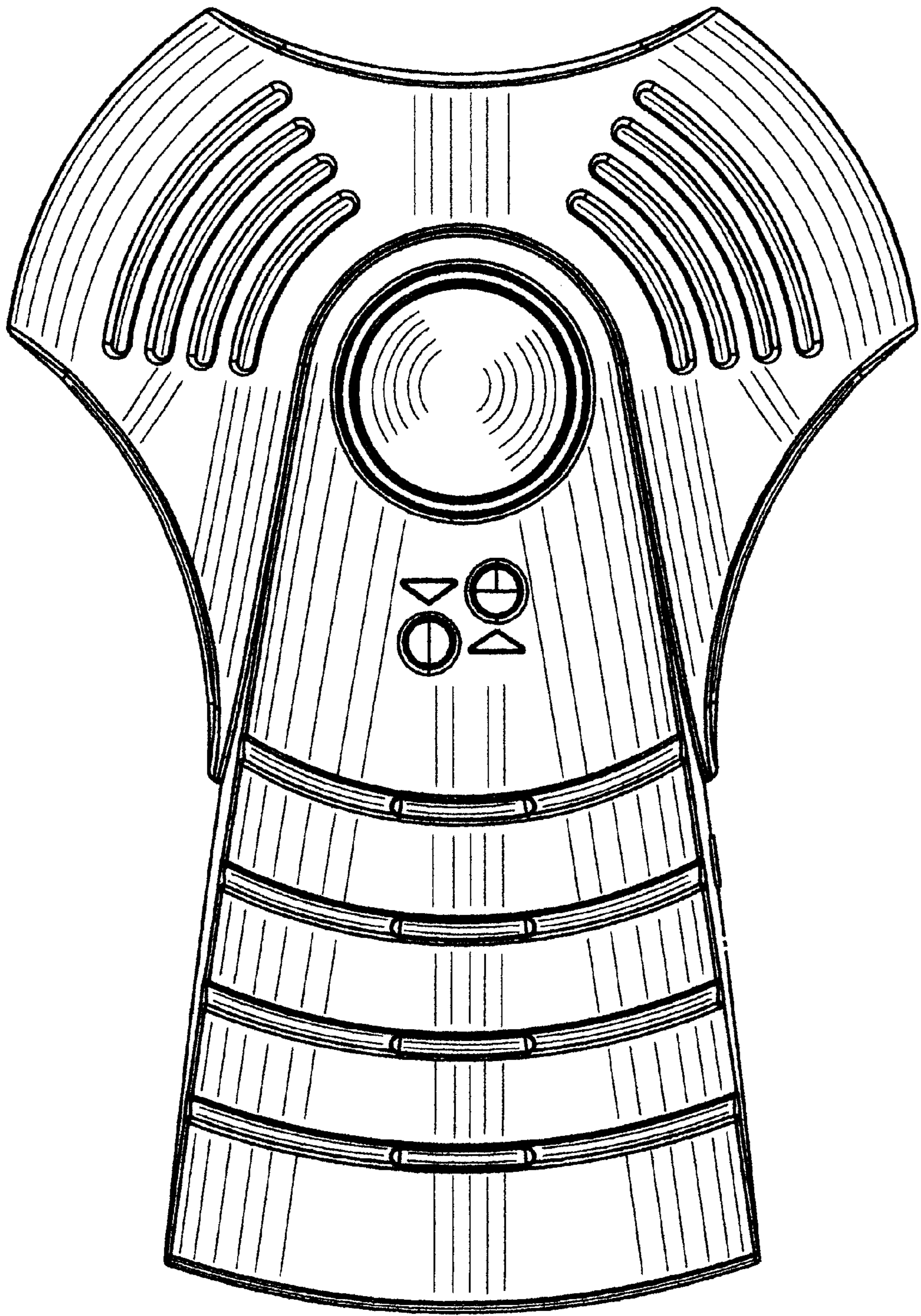

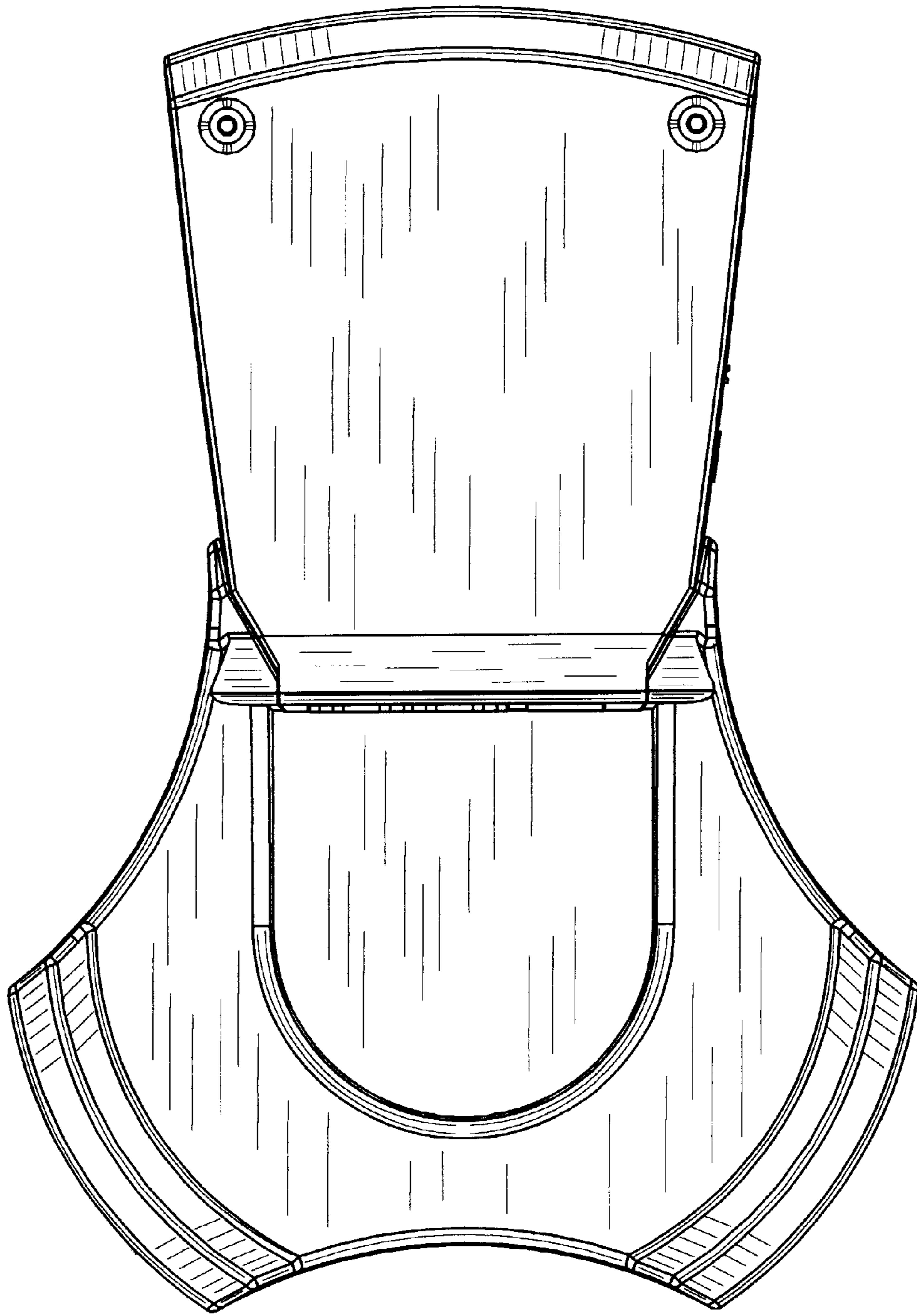
