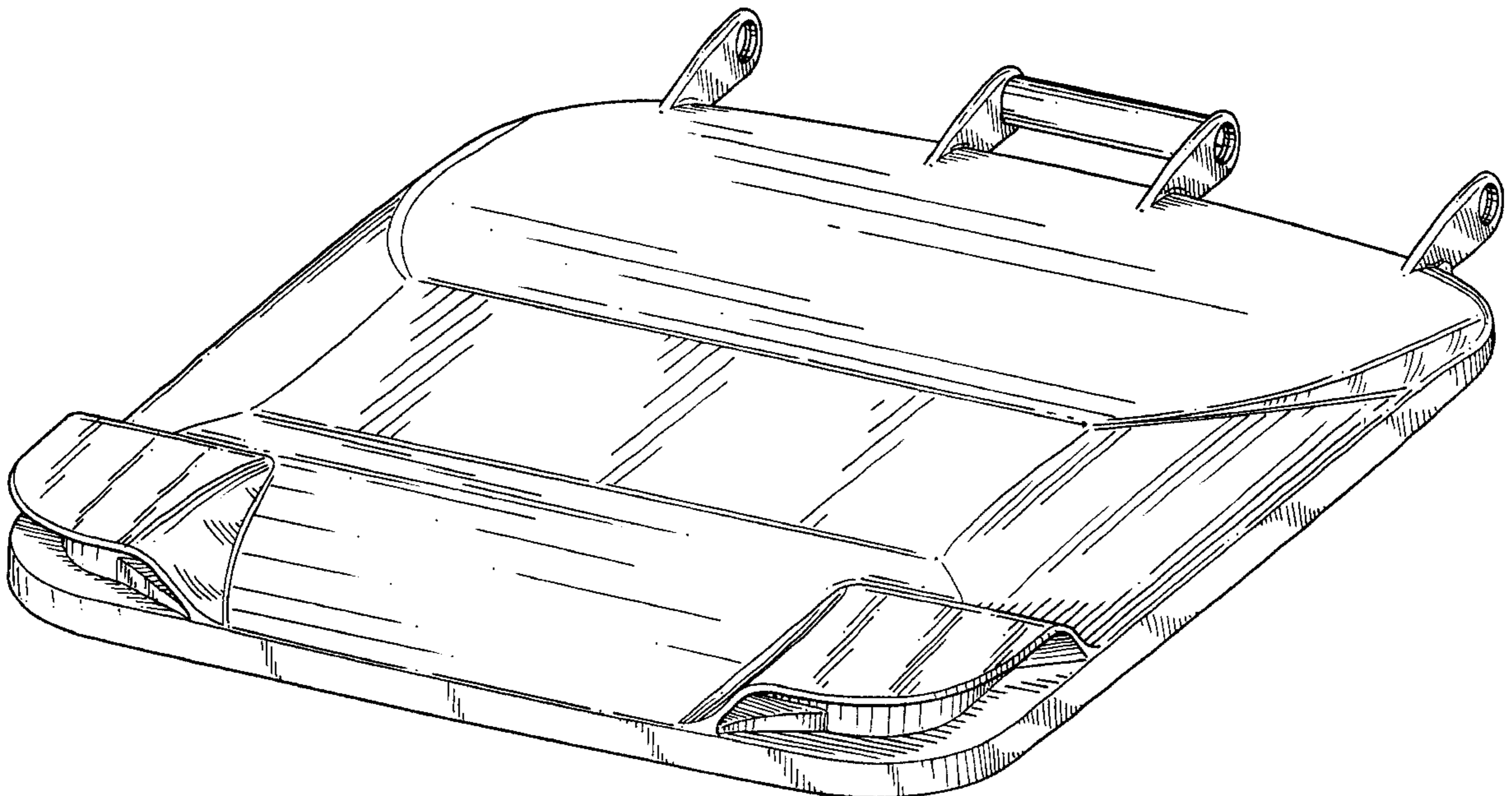
(57) **CLAIM**

The ornamental design for rollout cart lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the rollout cart lid embodying our new design;
FIG. 2 is an top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a right side elevational view thereof, with the left side elevational view being there mirror image.

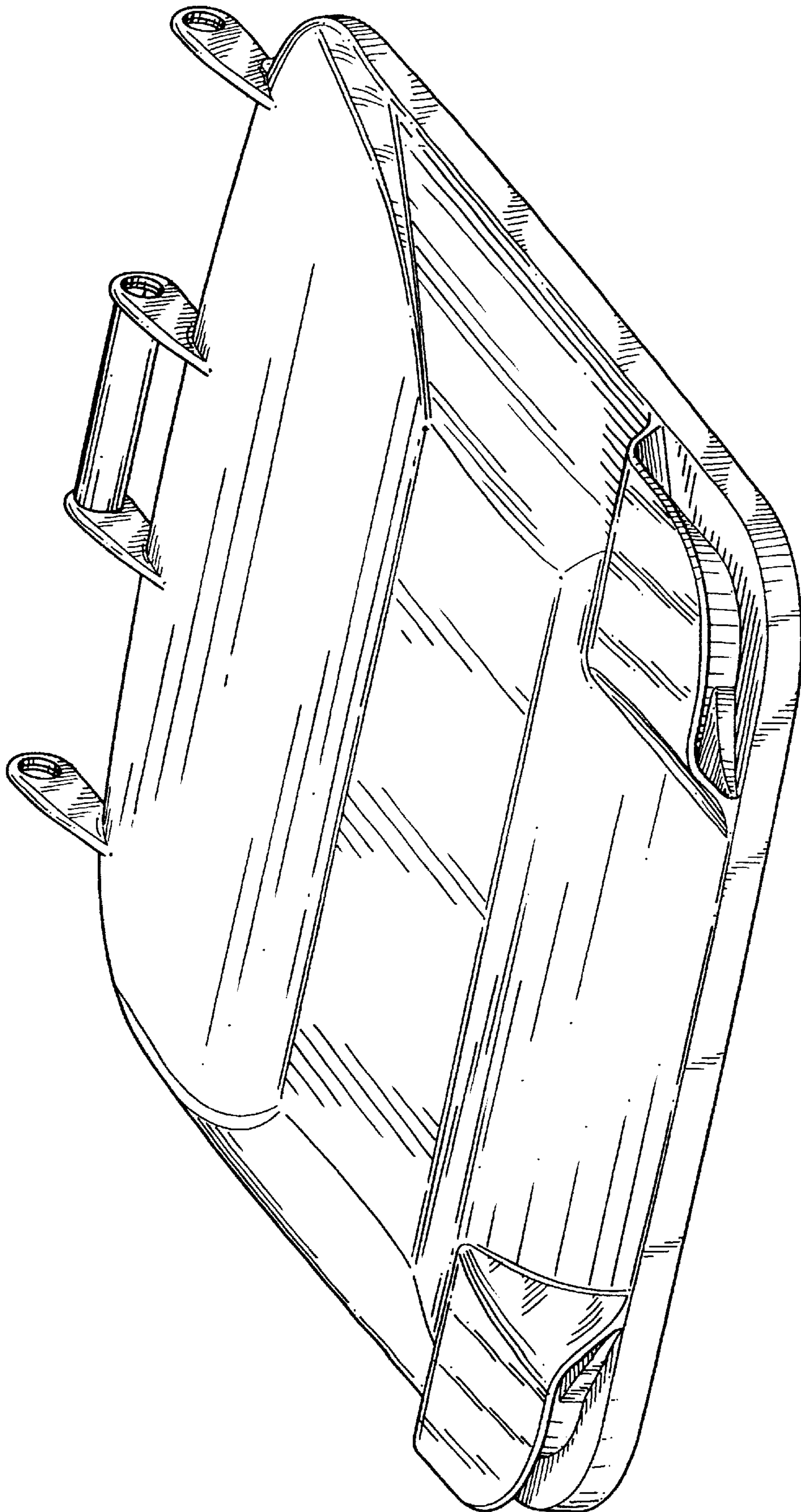

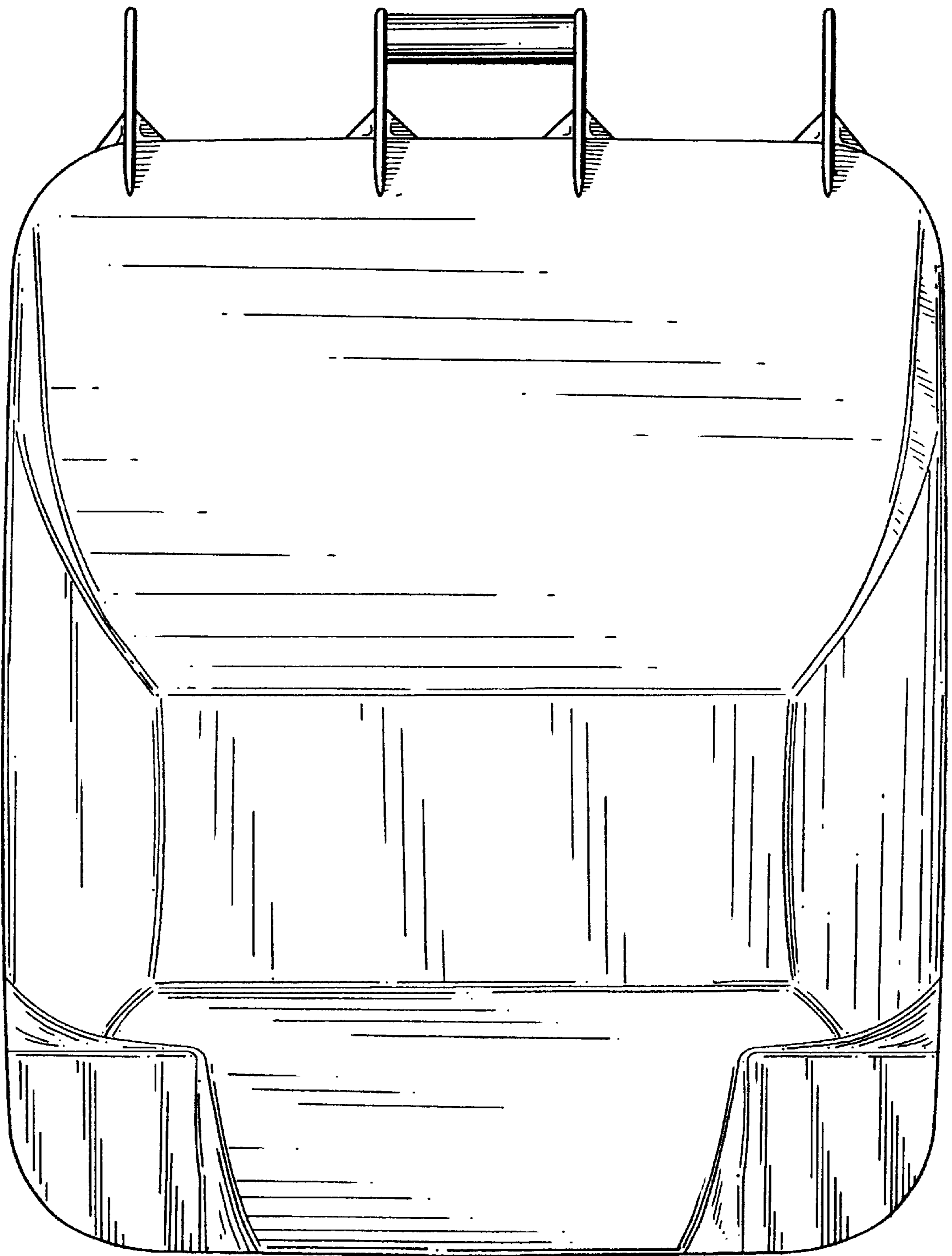

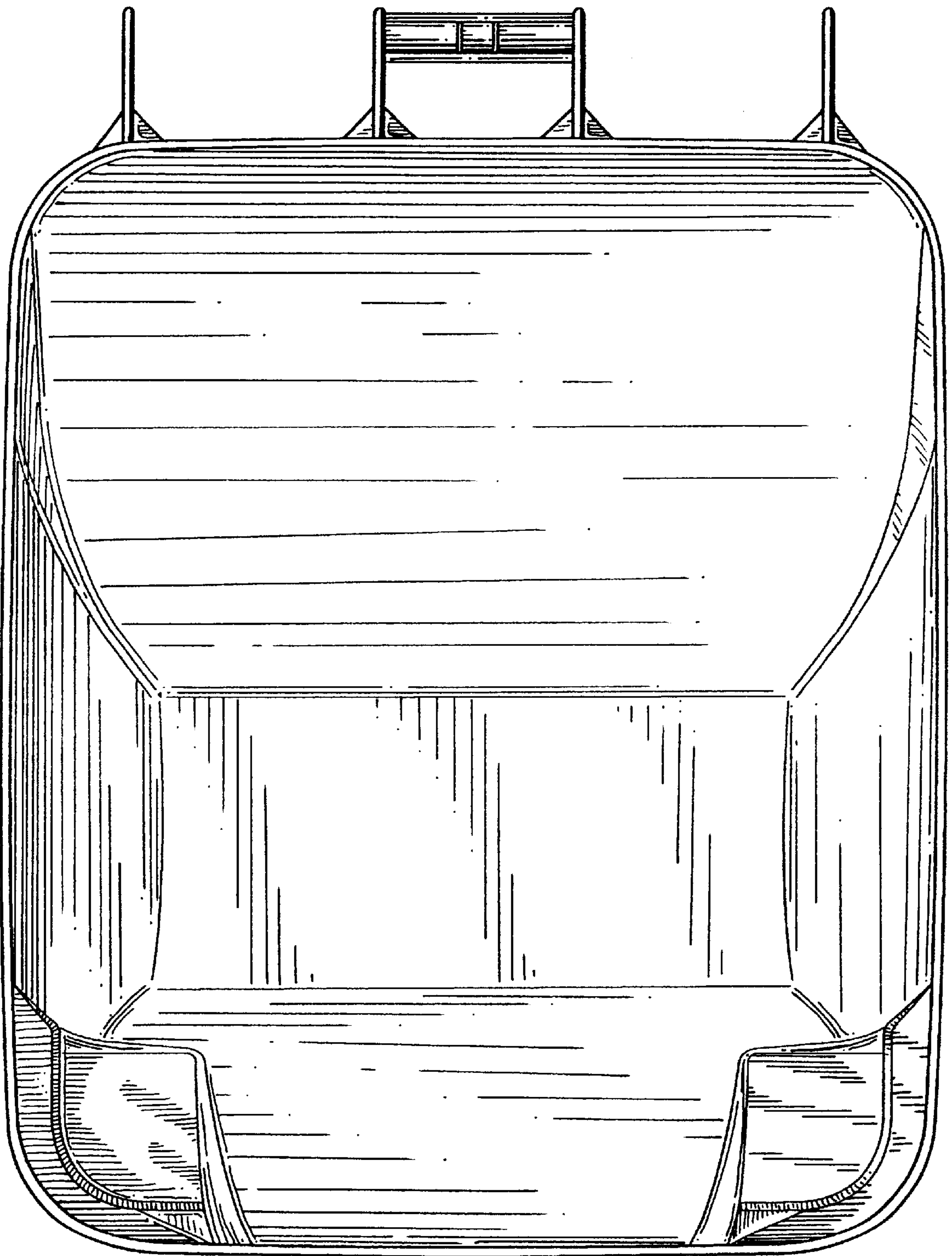

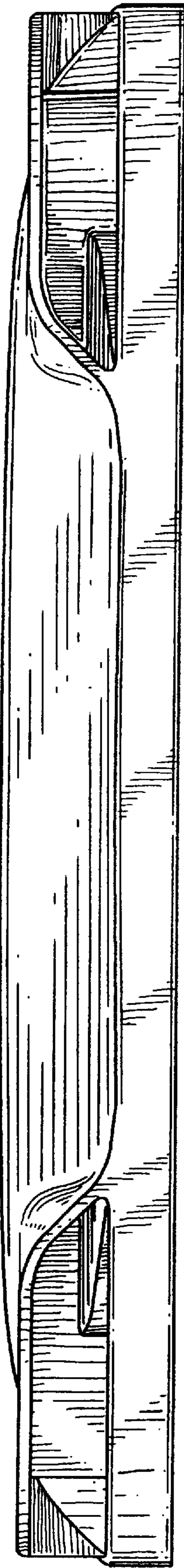
