(57) **CLAIM**

The ornamental design for rocking horse plant holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the rocking horse plant holder embodying my new design, the structure shown in broken lines forming no part of the design sought to be patented;

FIG. 2 is a left side view of the rocking horse plant holder depicted in FIG. 1 embodying my new design, the structure shown in broken lines forming no part of the design sought to be patented;

FIG. 3 is a right side view of the rocking horse plant holder depicted in FIG. 1 embodying my new design, the structure shown in broken lines forming no part of the design sought to be patented;

FIG. 4 is a front view of the rocking horse plant holder depicted in FIG. 1 embodying my new design, the structure shown in broken lines forming no part of the design sought to be patented;

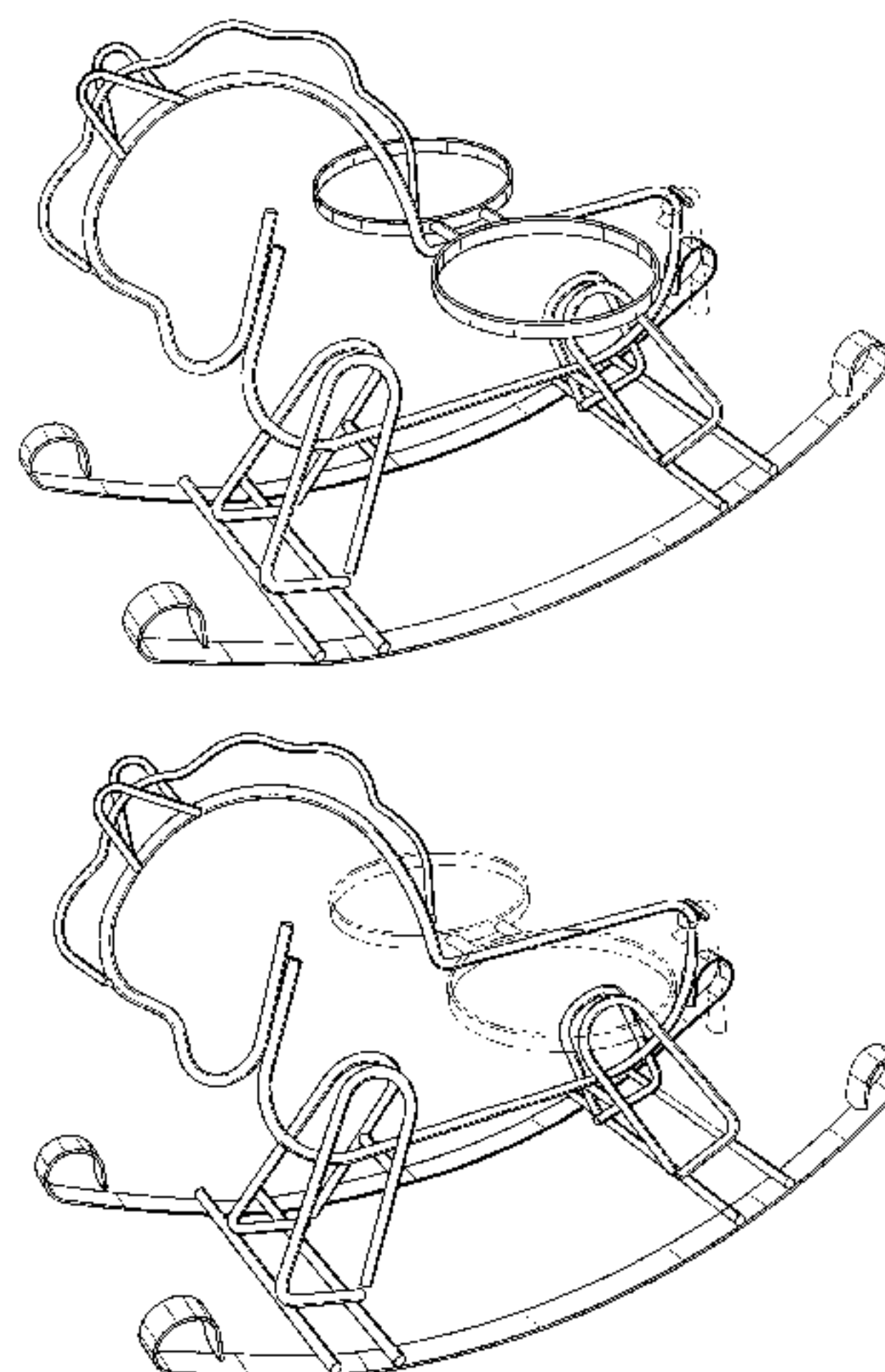

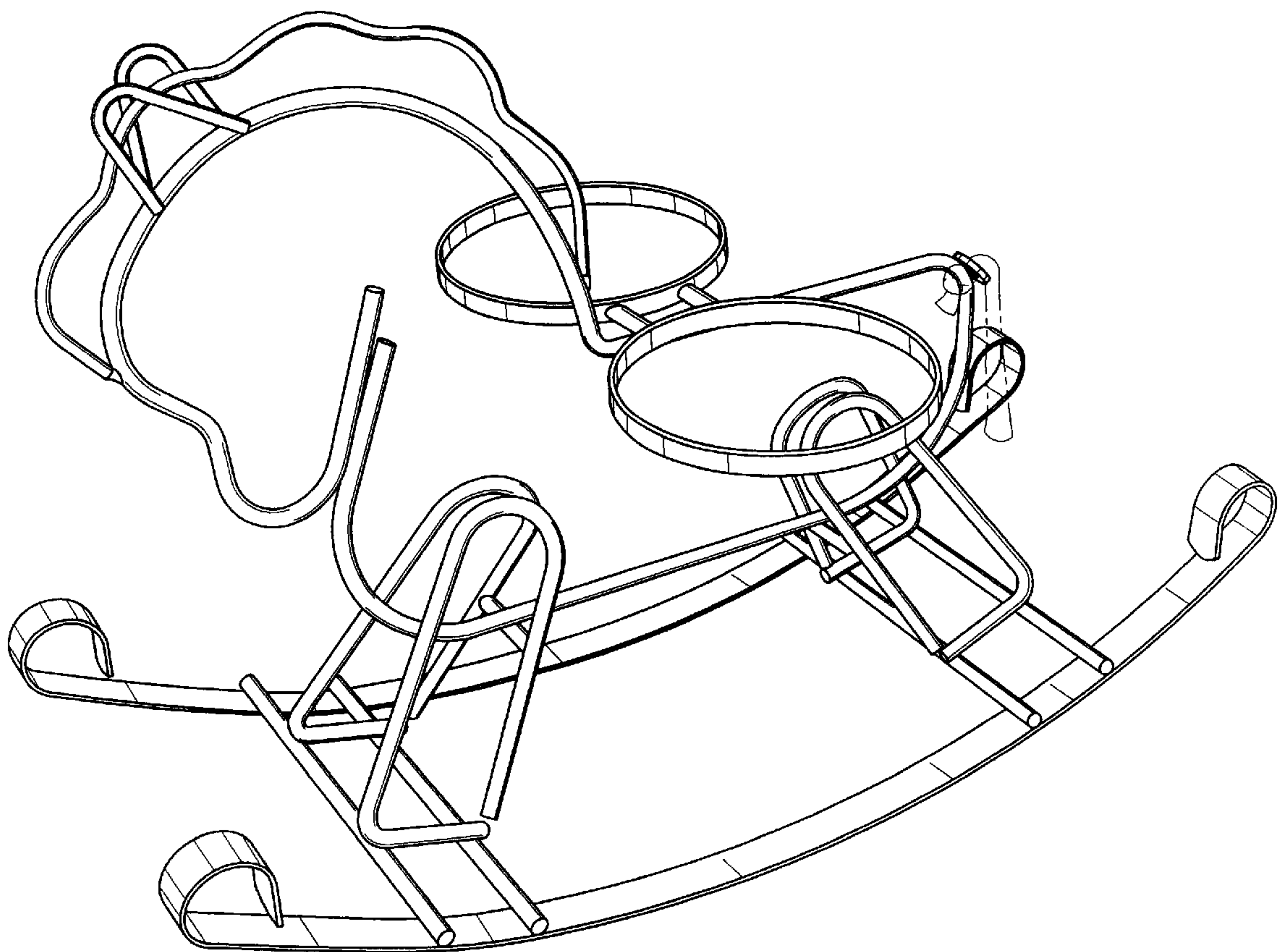

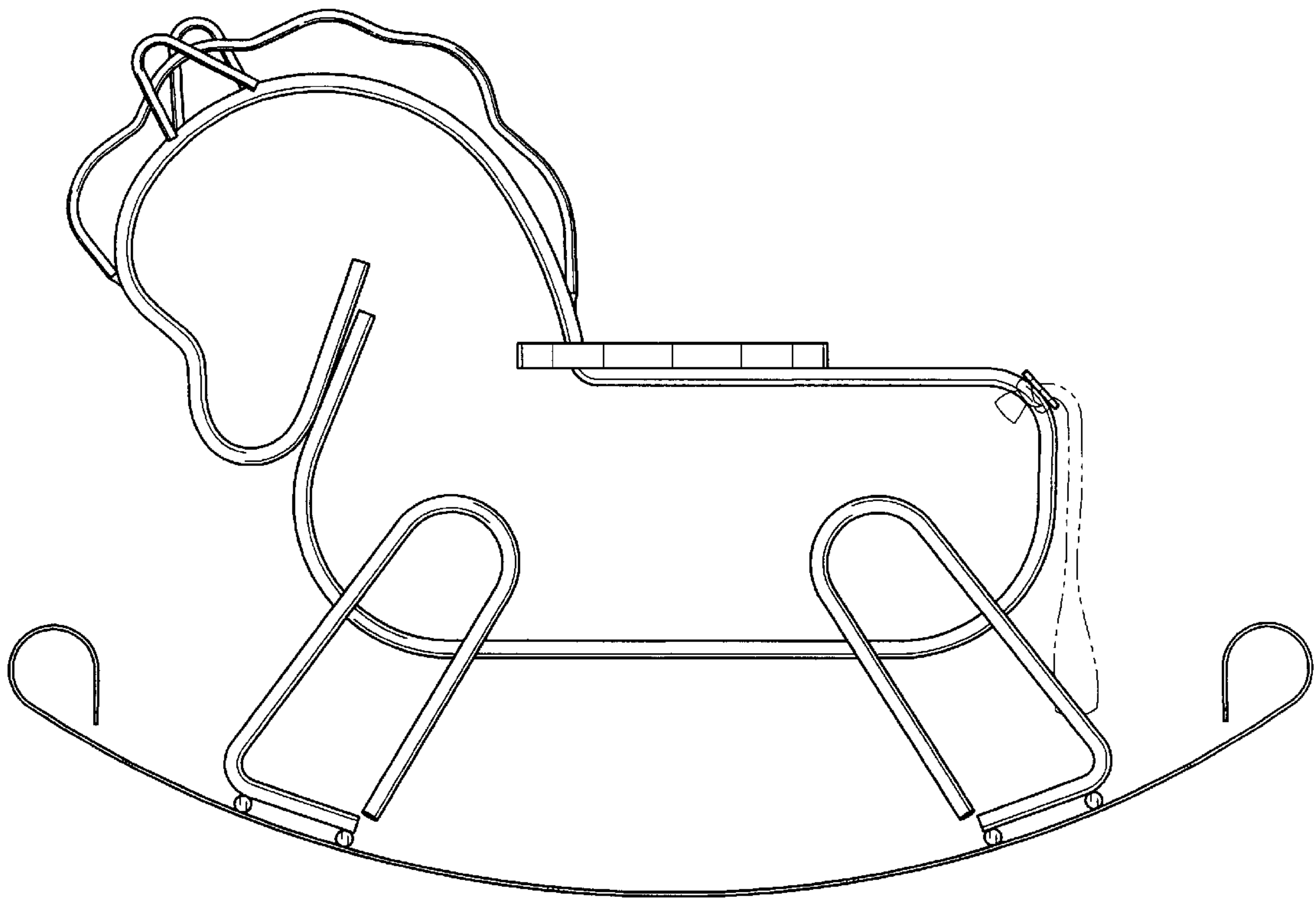

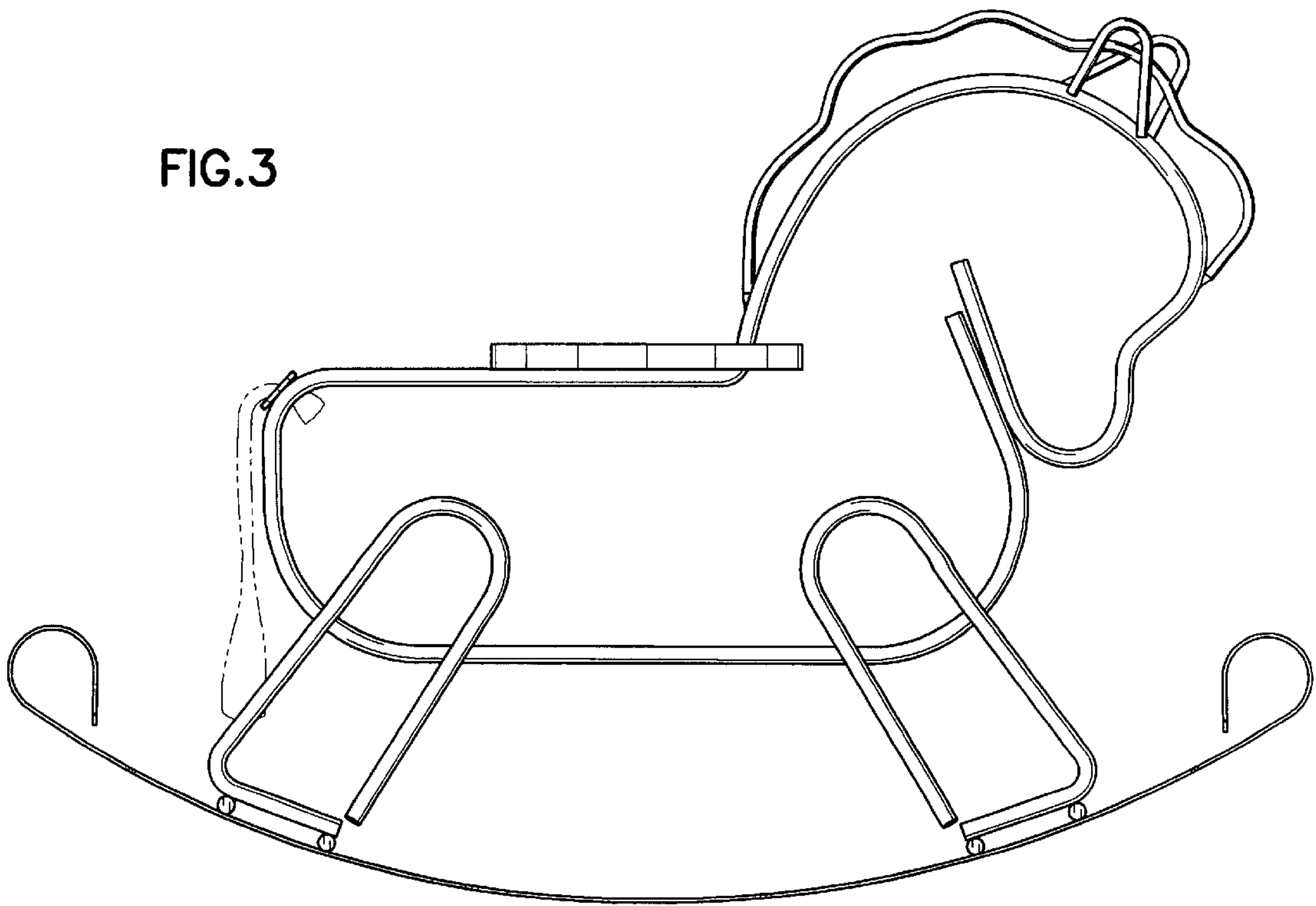

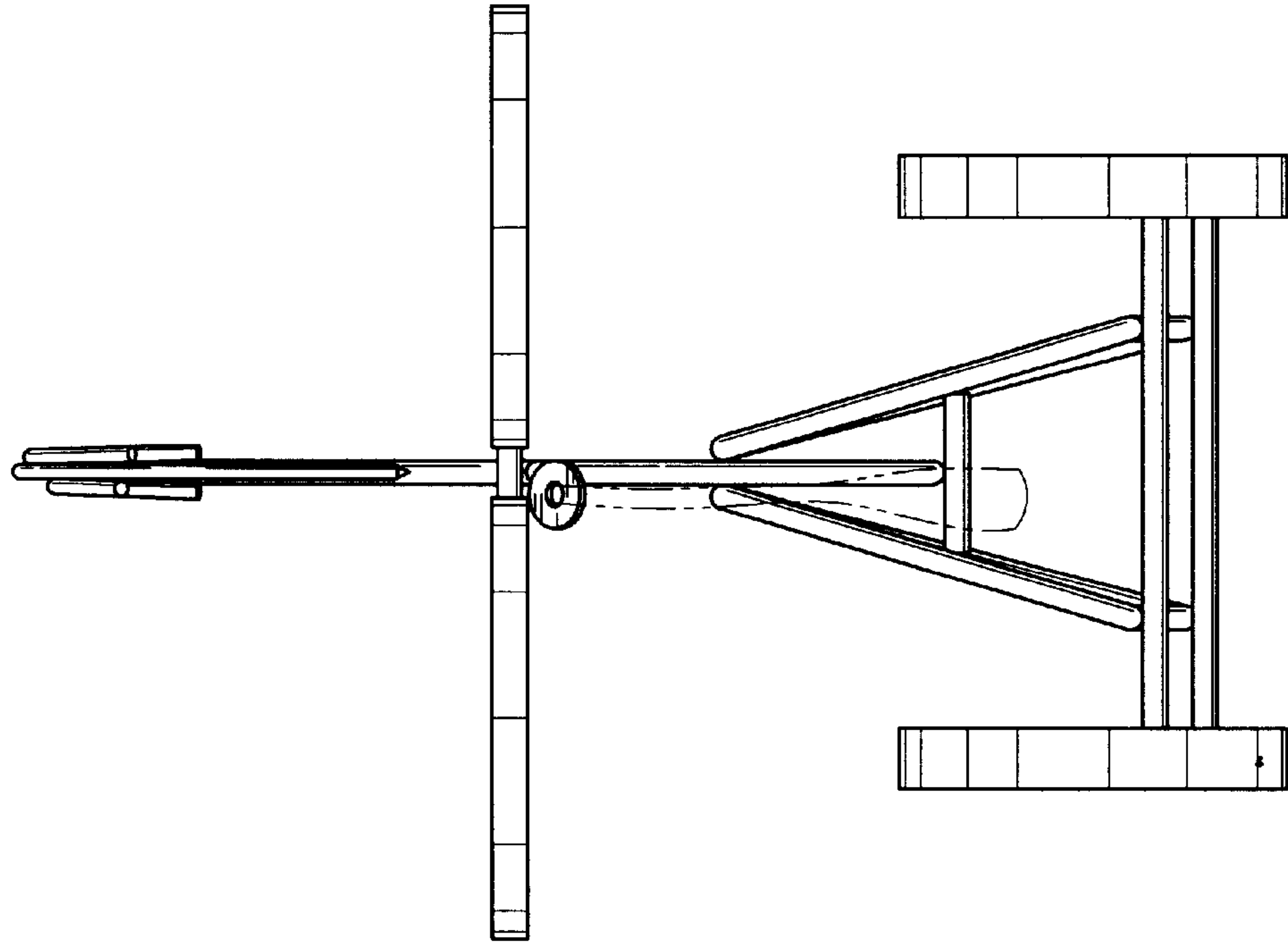

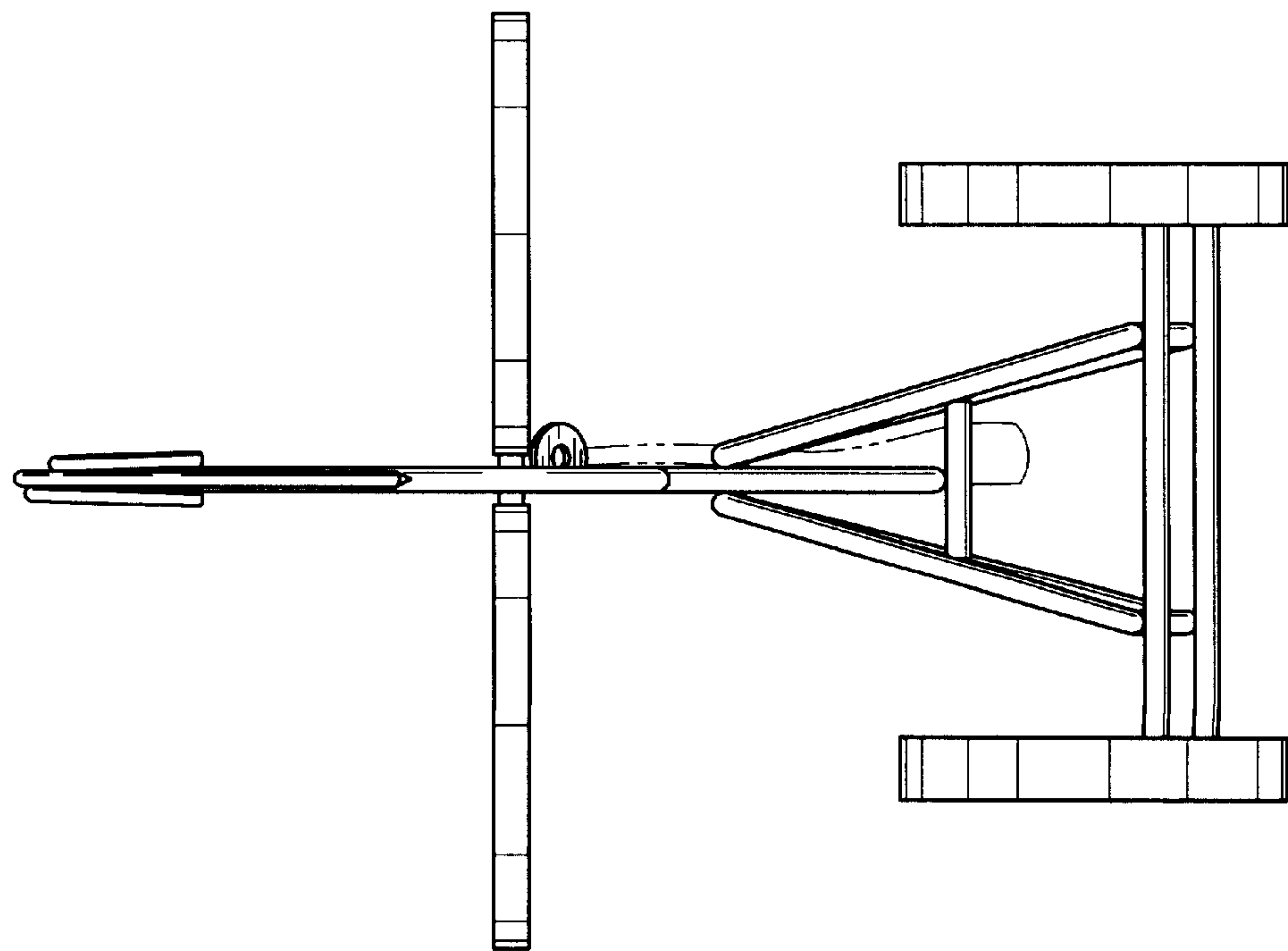

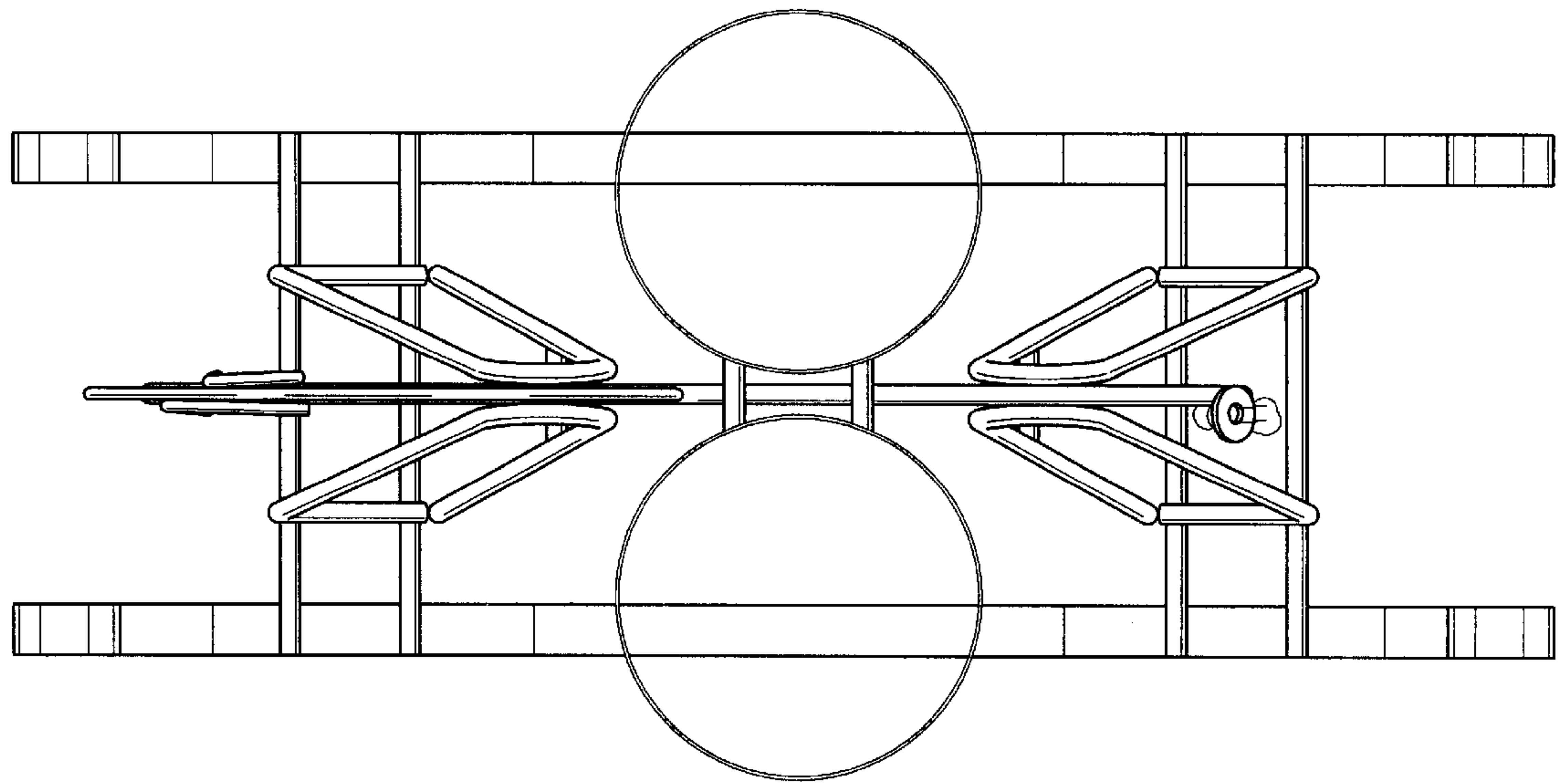

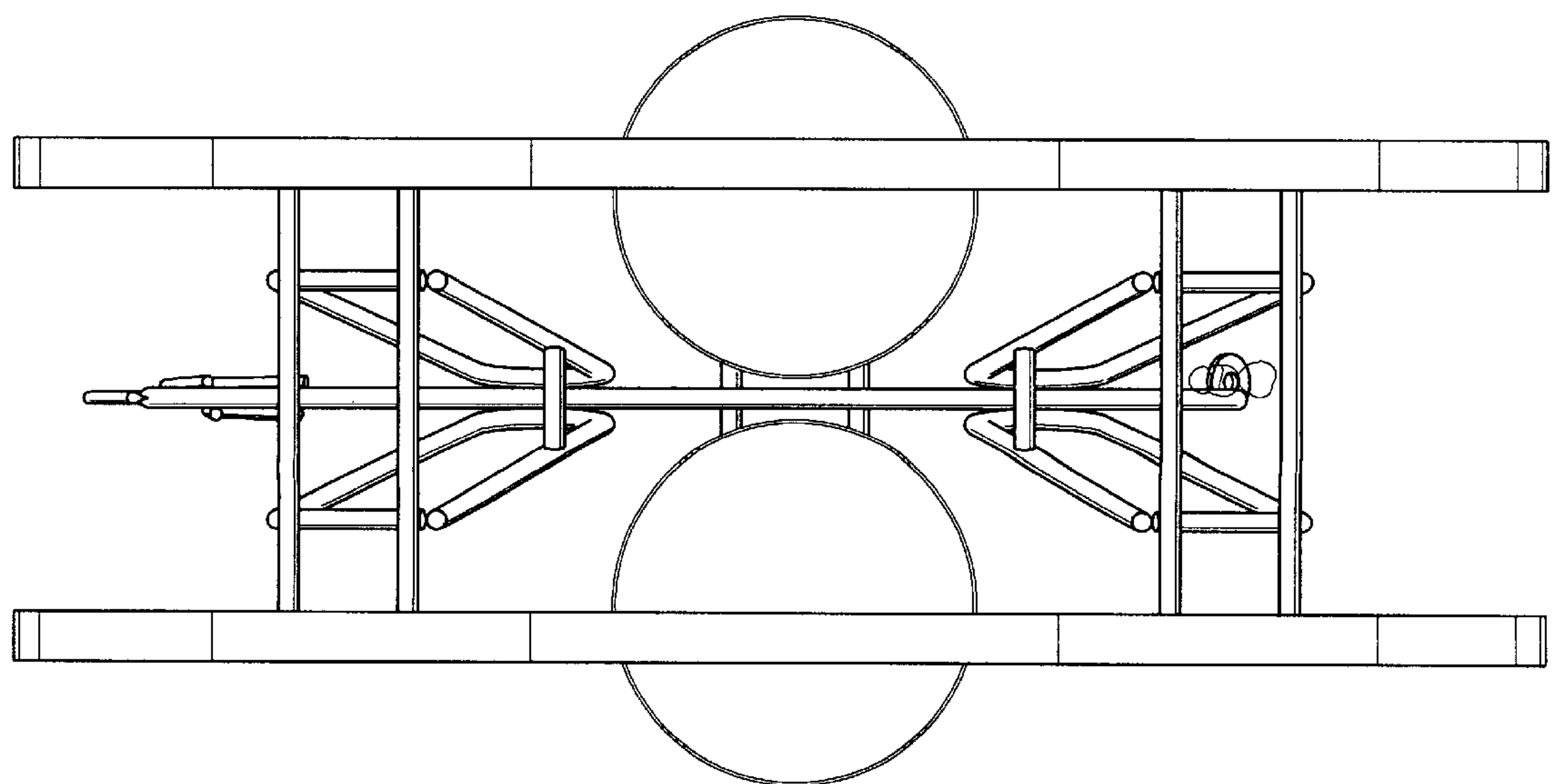

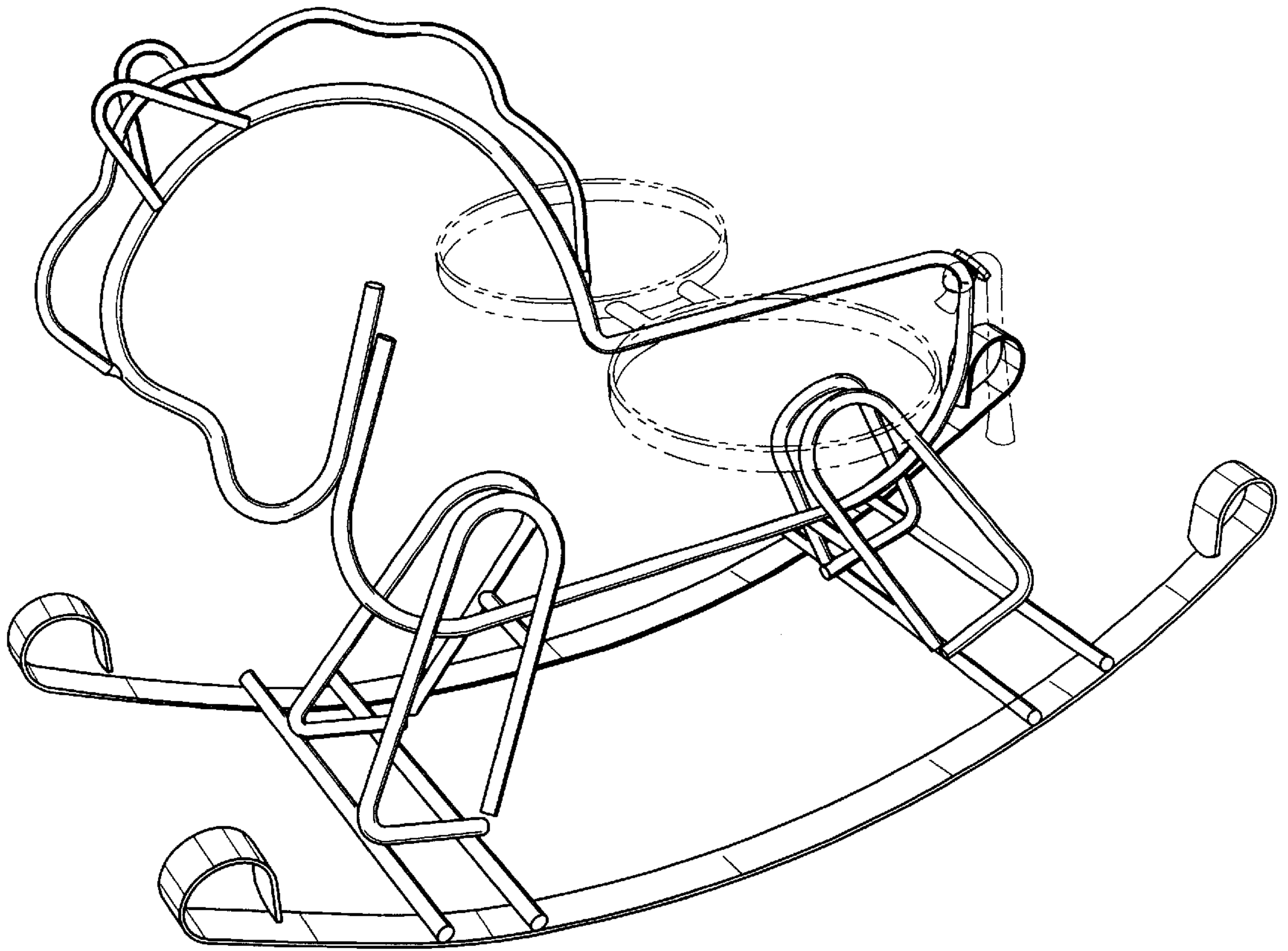

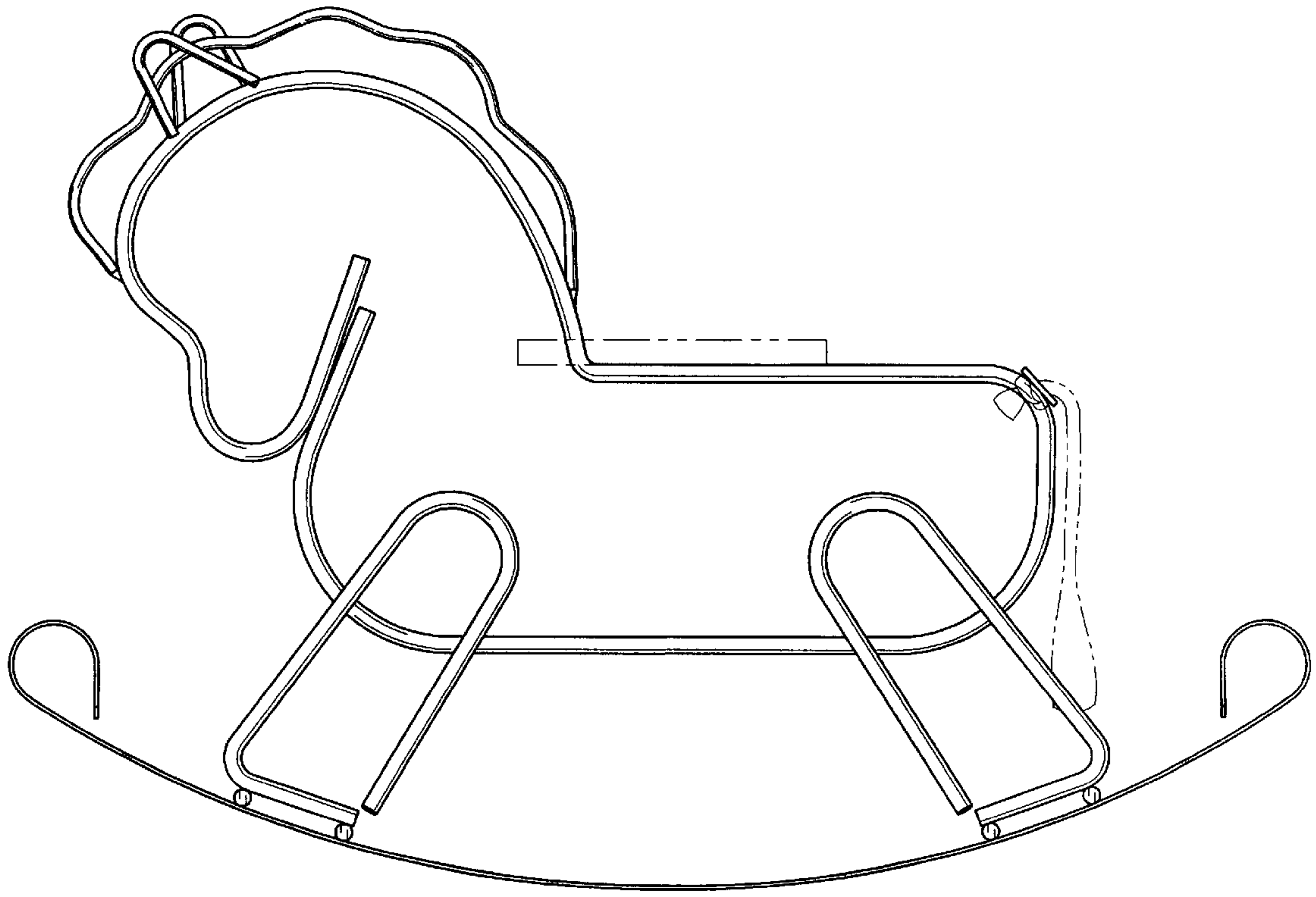

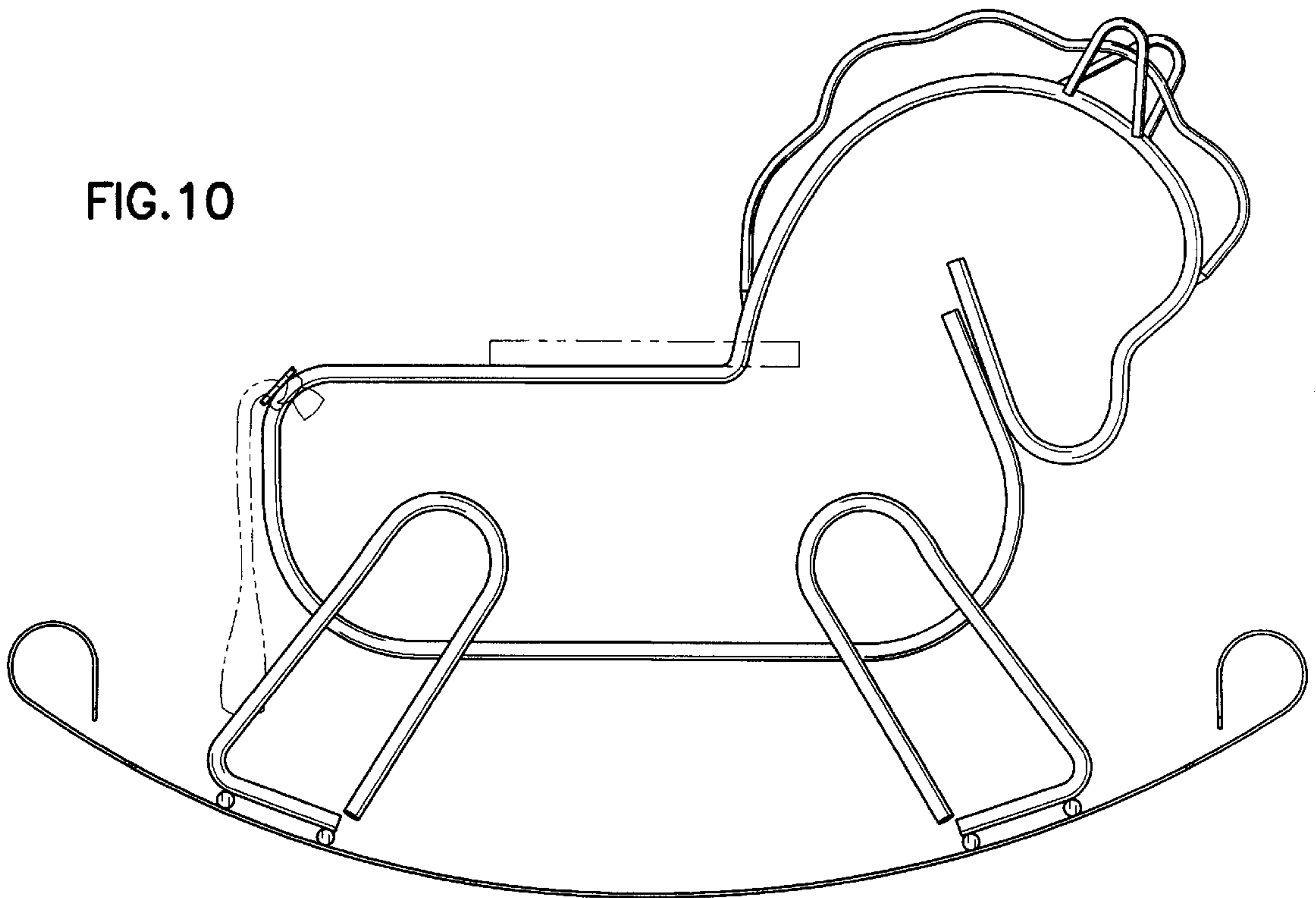

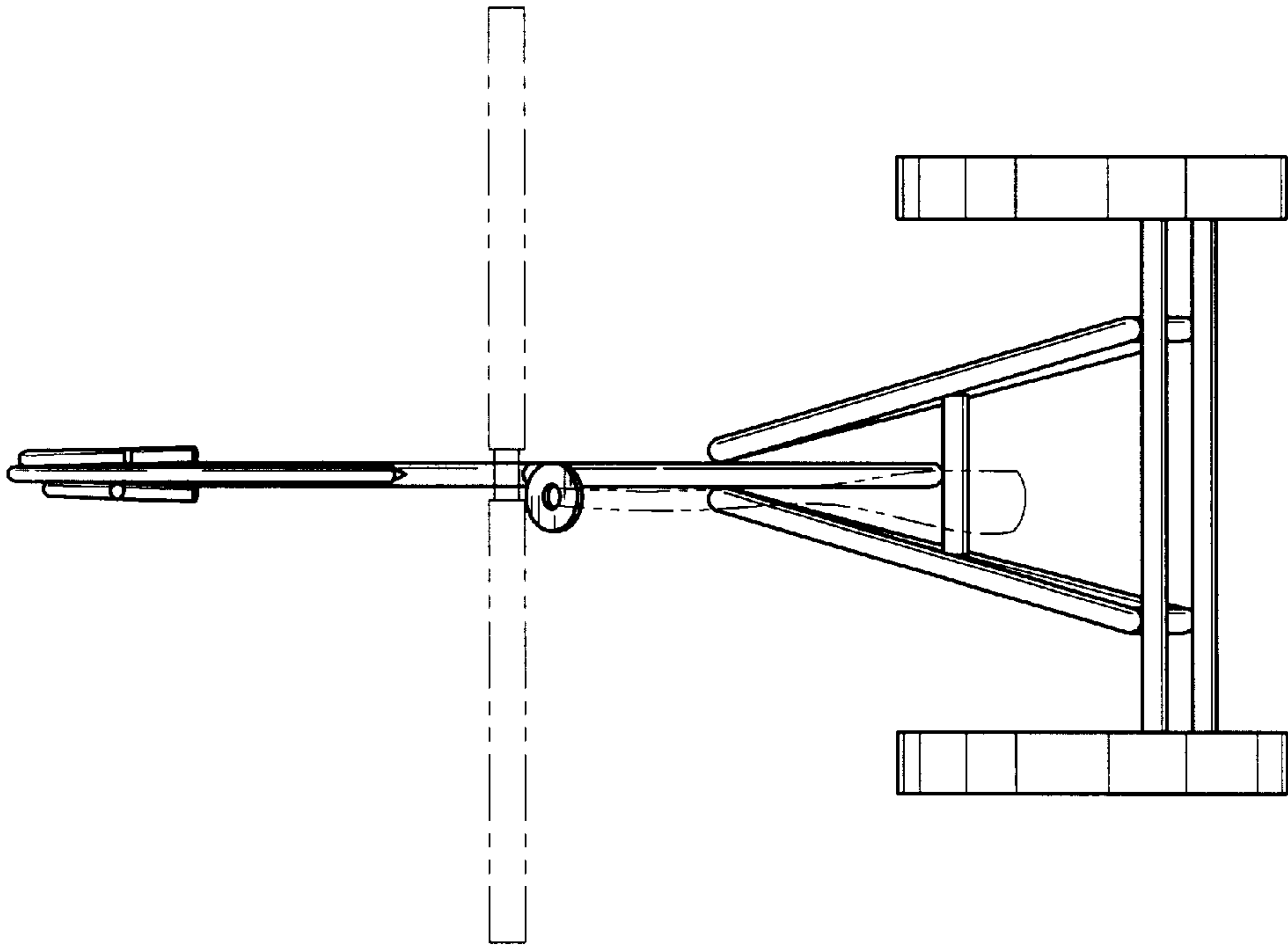

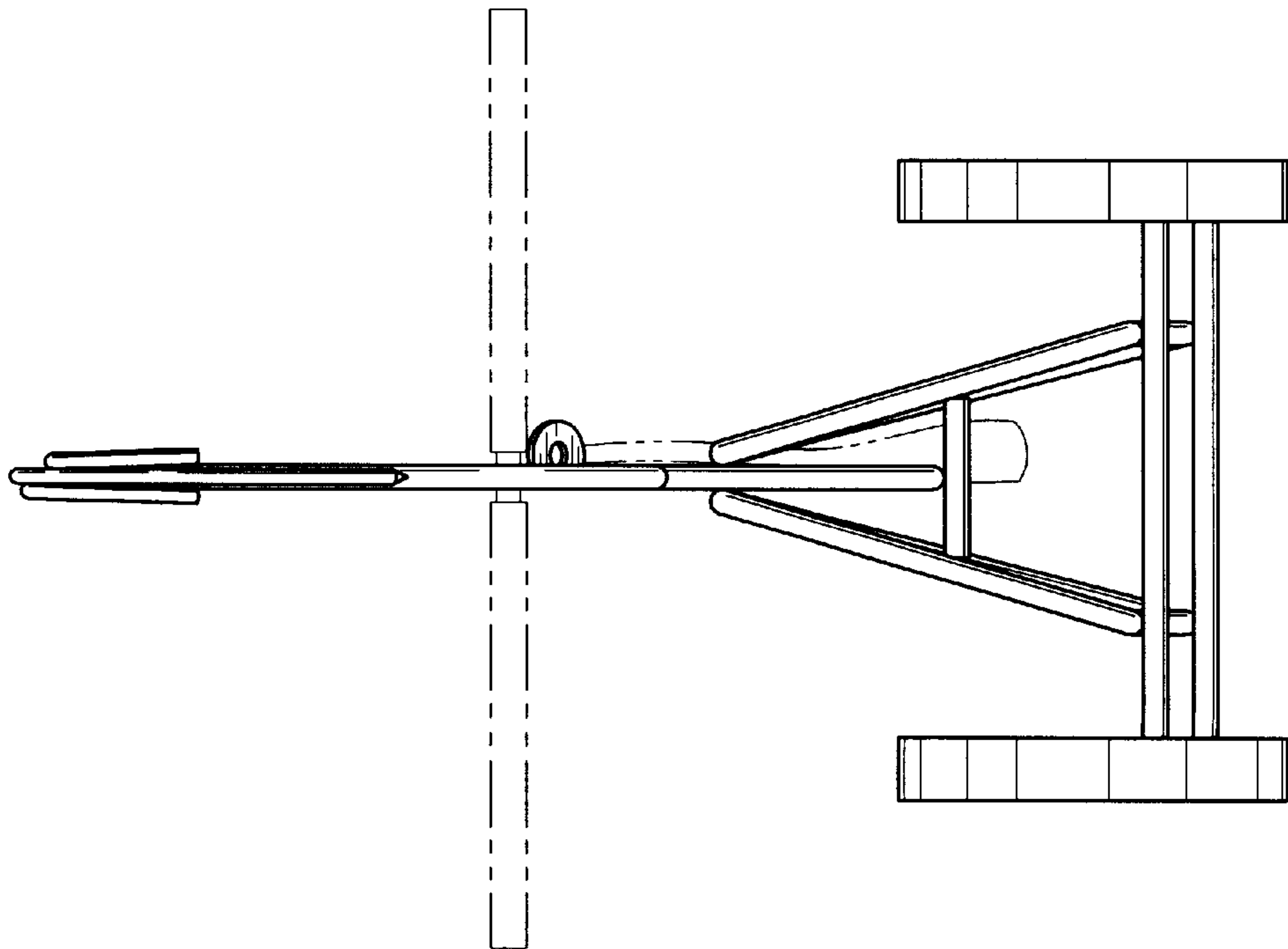

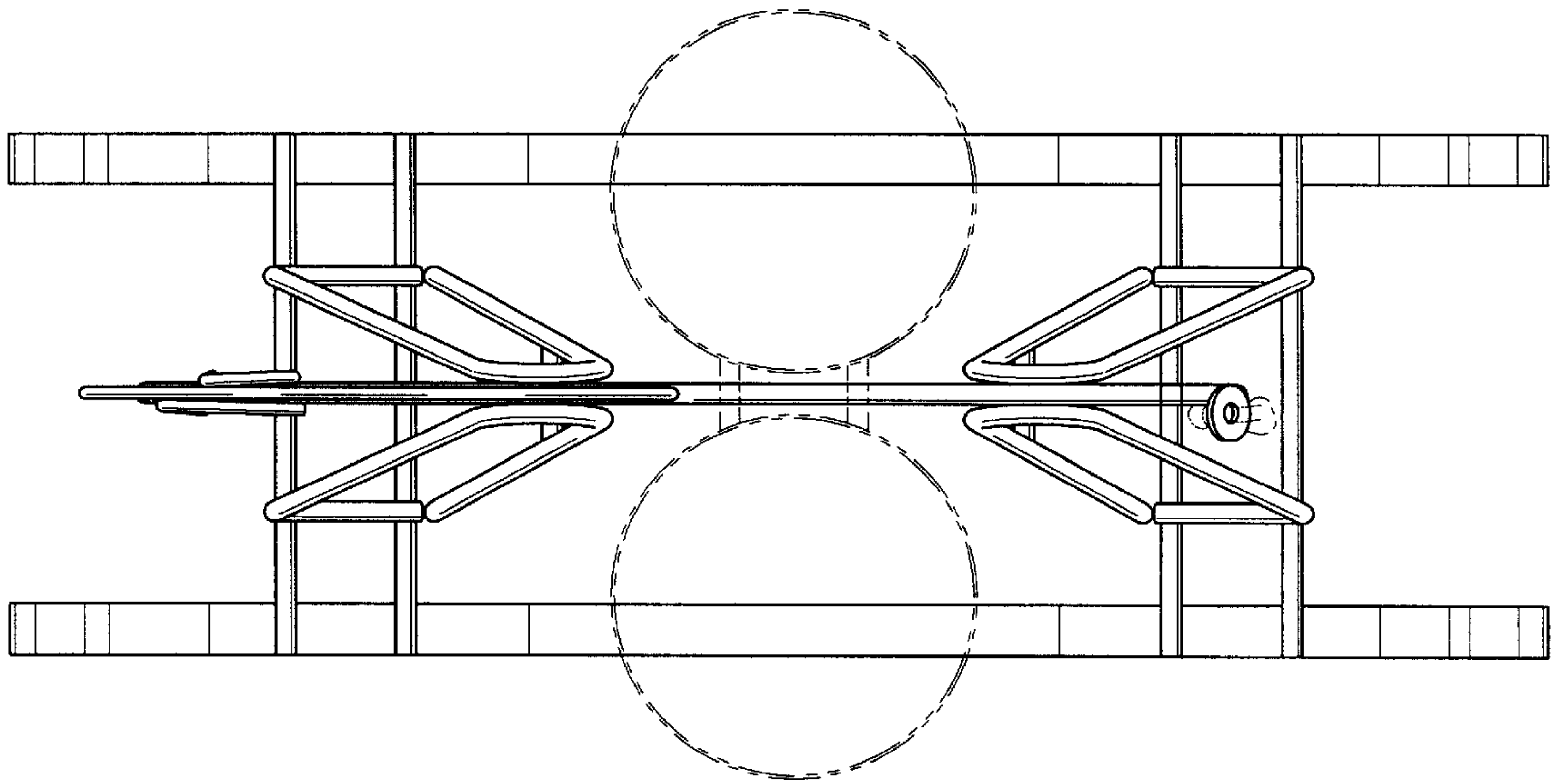
