FIG. 3 is a left side elevation view of the first embodiment of the display.

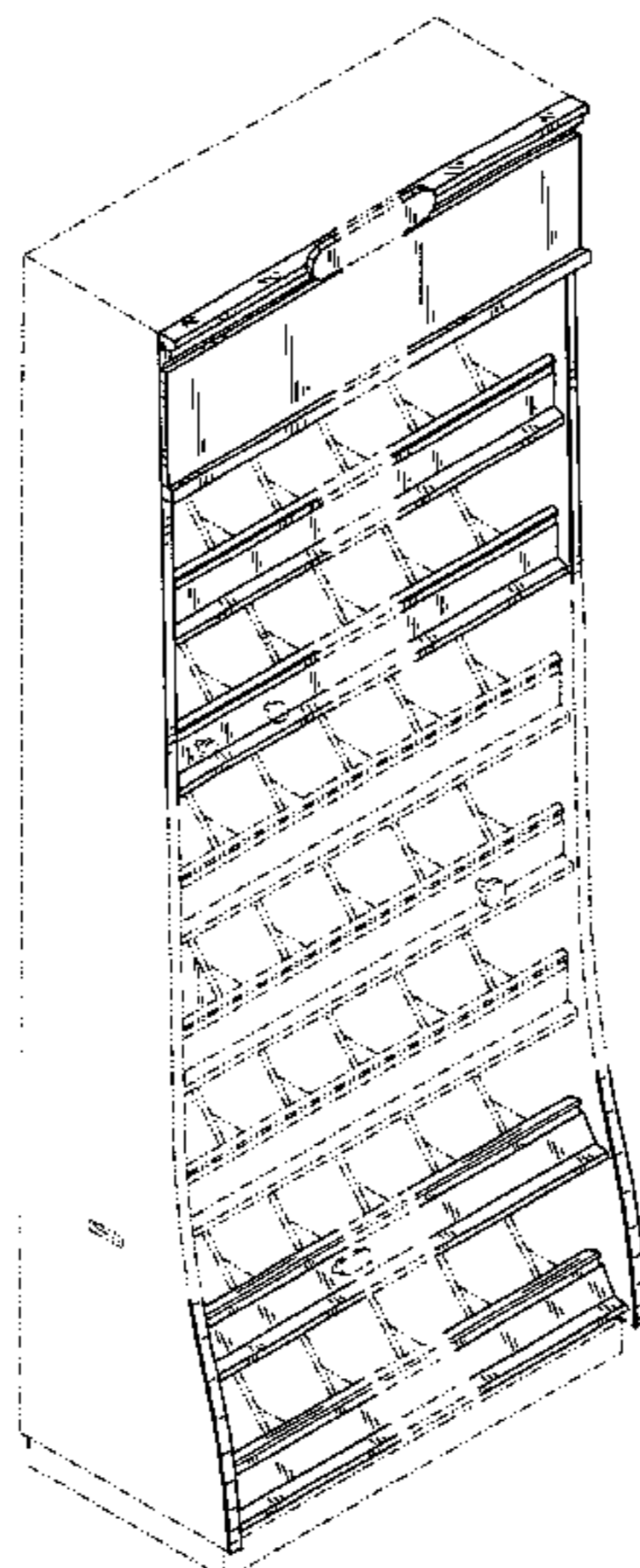
FIG. 4 is a rear elevation view of the first embodiment of the display.

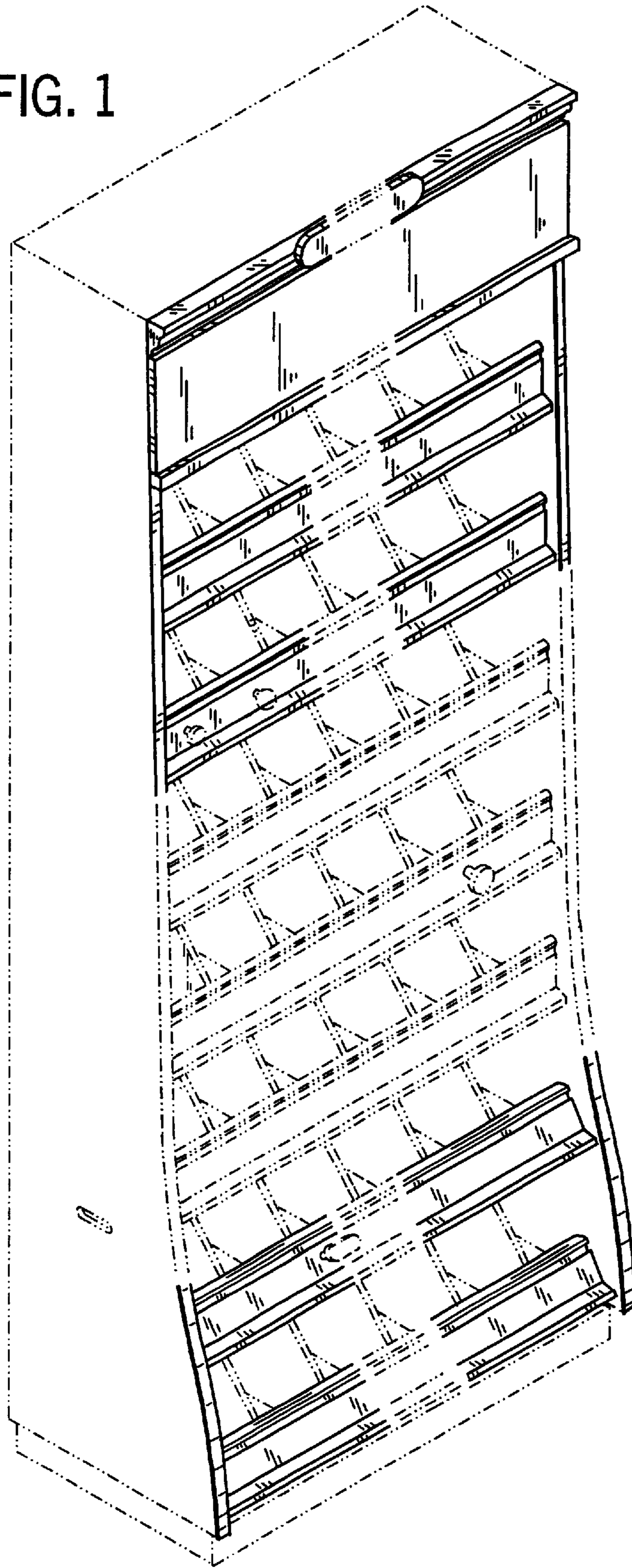

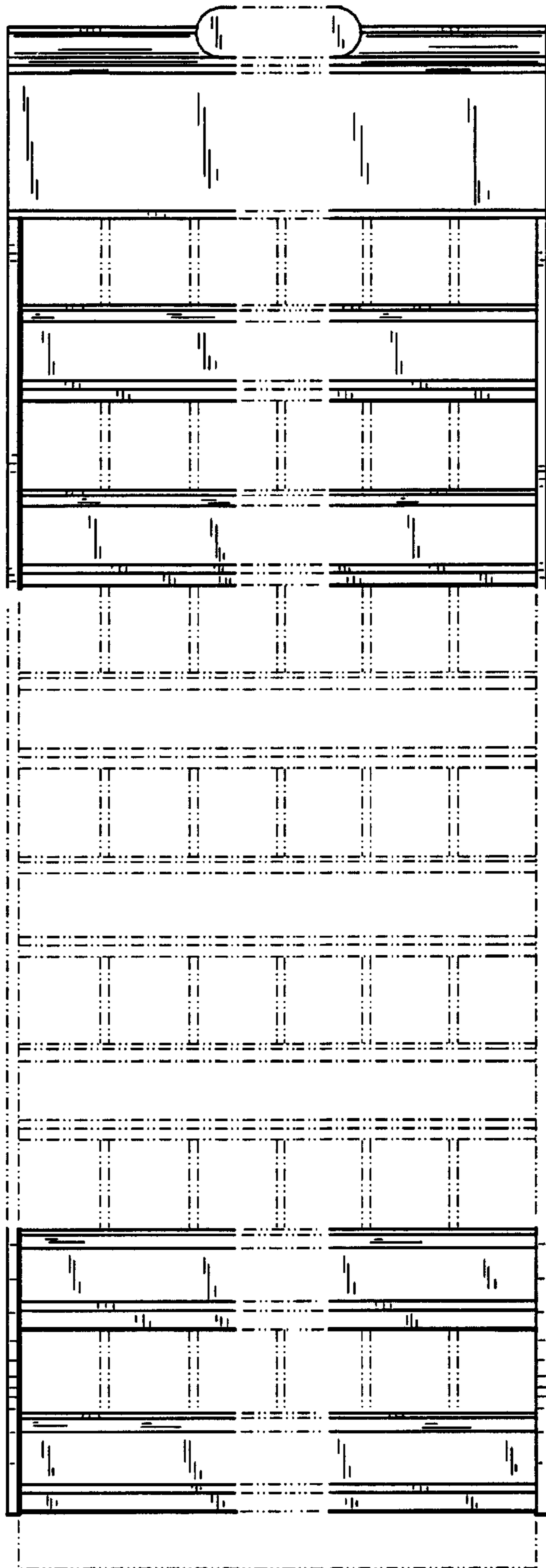

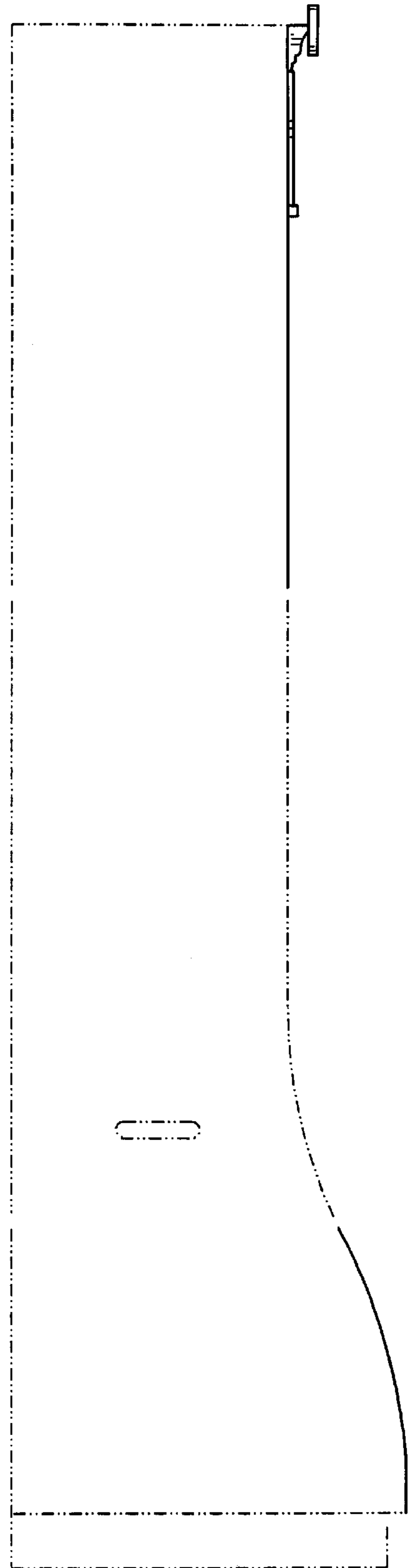

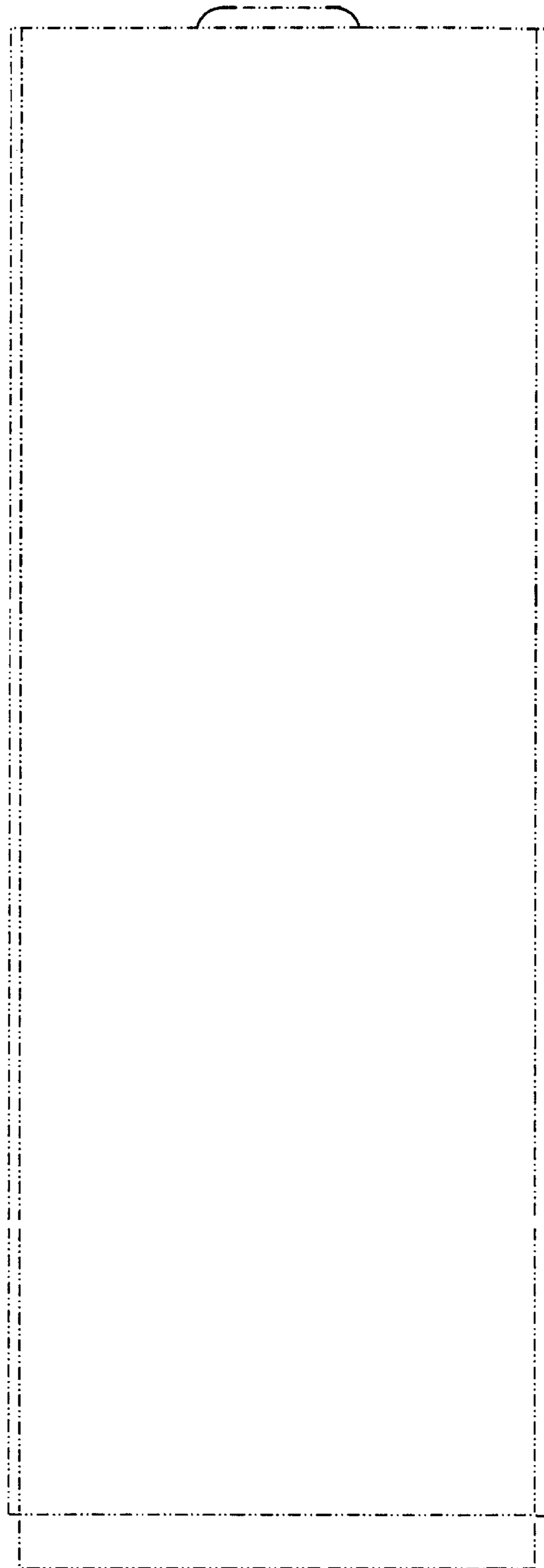

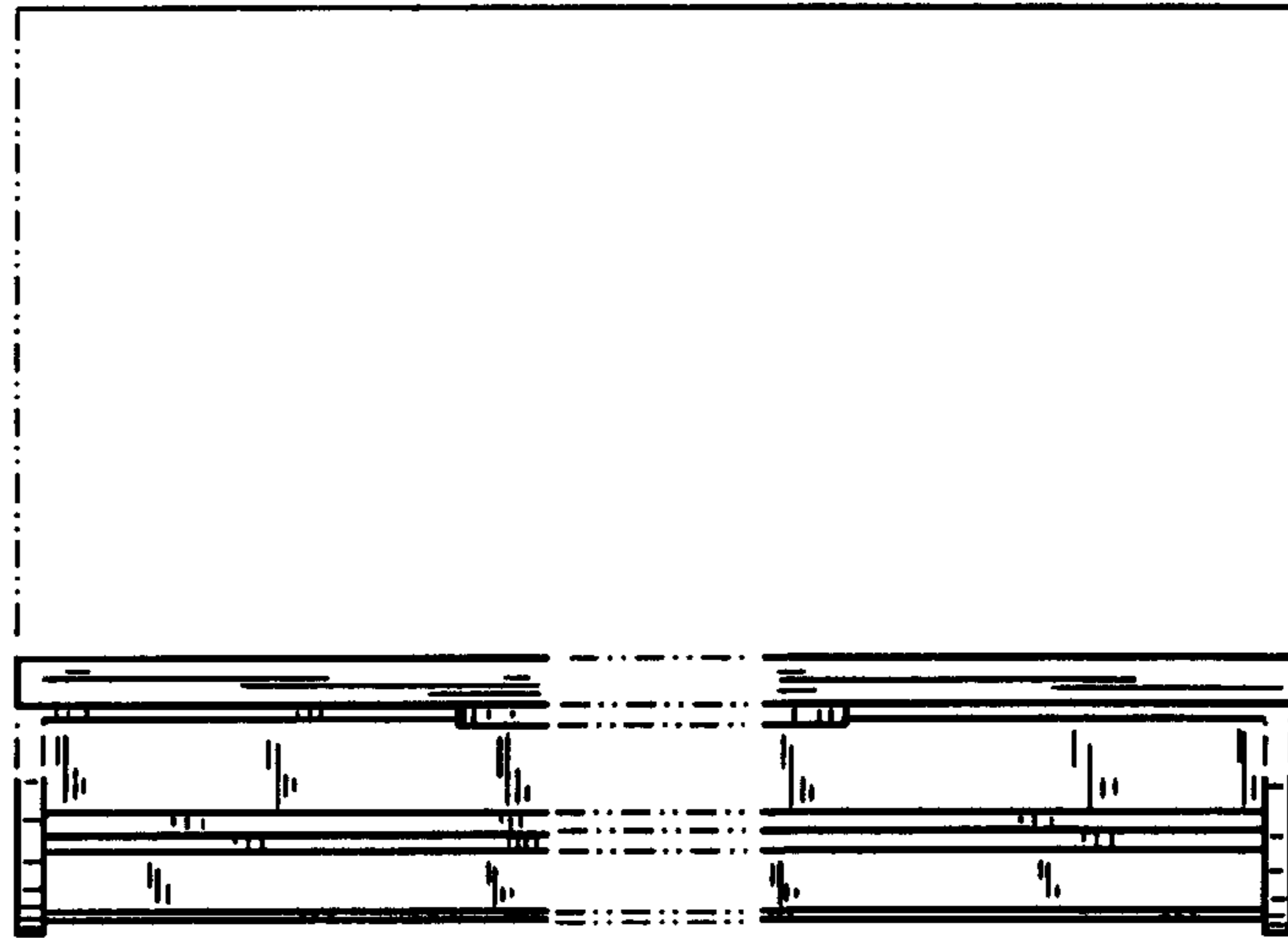
