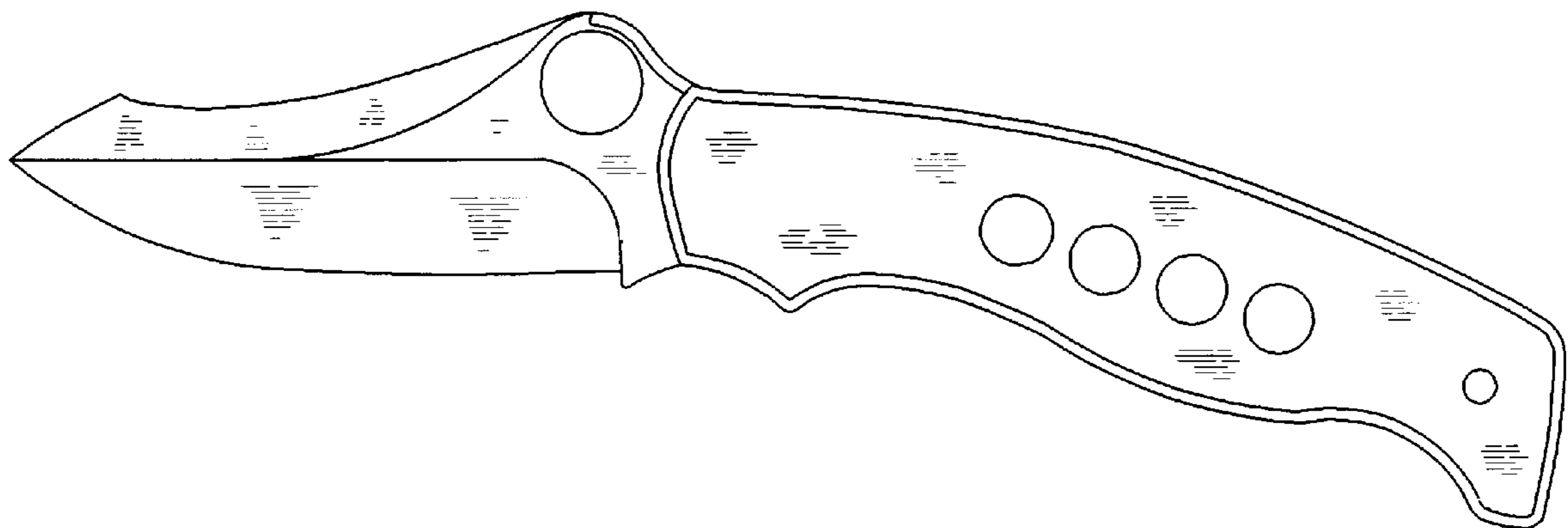
(57) **CLAIM**

The ornamental design for a folding knife, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a folding knife, showing my new design;
 FIG. 2 is a top plan view of the folding knife illustrated in FIG. 1;
 FIG. 3 is a rear elevation view of the folding knife illustrated in FIG. 1;
 FIG. 4 is a bottom plan view of the folding knife illustrated in FIG. 1;
 FIG. 5 is a right end view of the folding knife illustrated in FIG. 1;
 FIG. 6 is a left end view of the folding knife illustrated in FIG. 1;
 FIG. 7 is a front elevation view of the folding knife of FIG. 1, shown in a closed position;
 FIG. 8 is a top plan view of the folding knife of FIG. 1, shown in a closed position;
 FIG. 9 is a rear elevation view of the folding knife of FIG. 1, shown in a closed position;
 FIG. 10 is a bottom plan view of the folding knife of FIG. 1, shown in a closed position;
 FIG. 11 is a left elevation view of the folding knife of FIG. 1, shown in a closed position; and,
 FIG. 12 is a right elevation view of the folding knife FIG. 1, shown in a closed position.

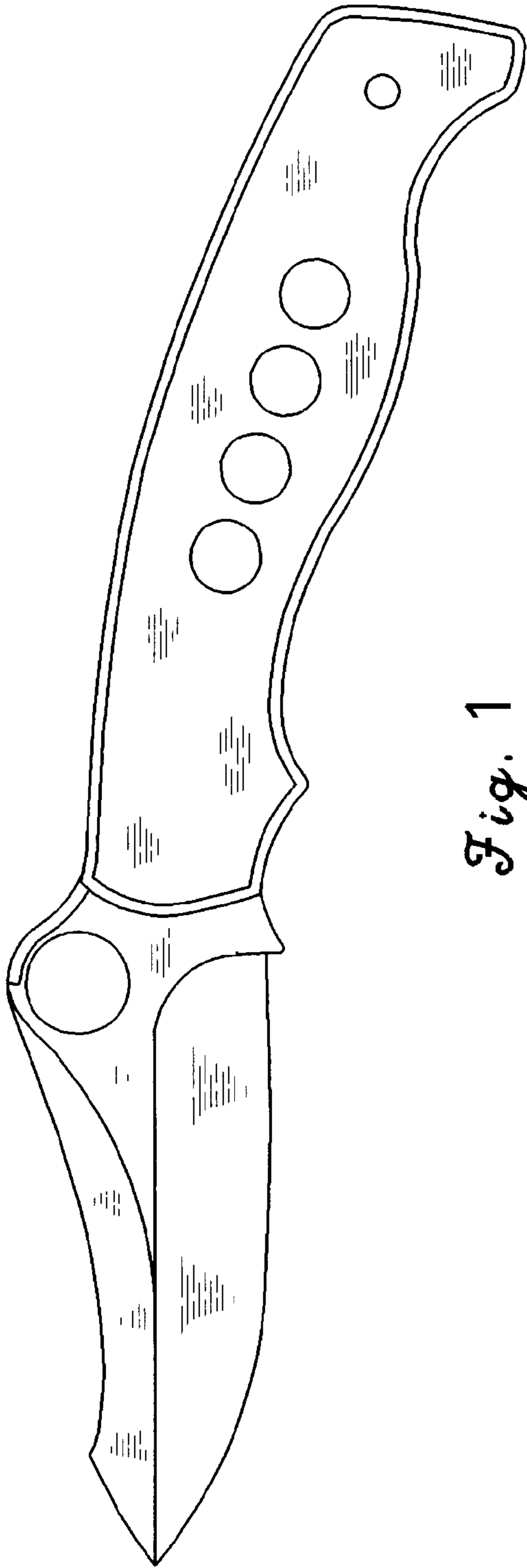

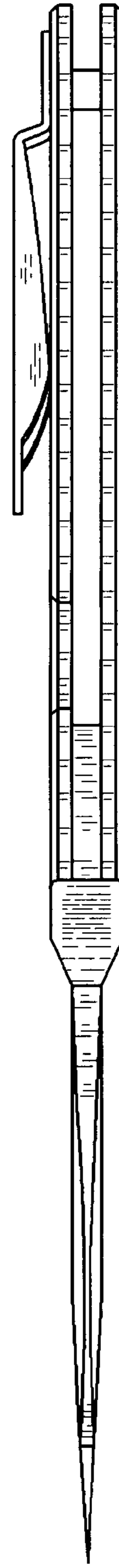

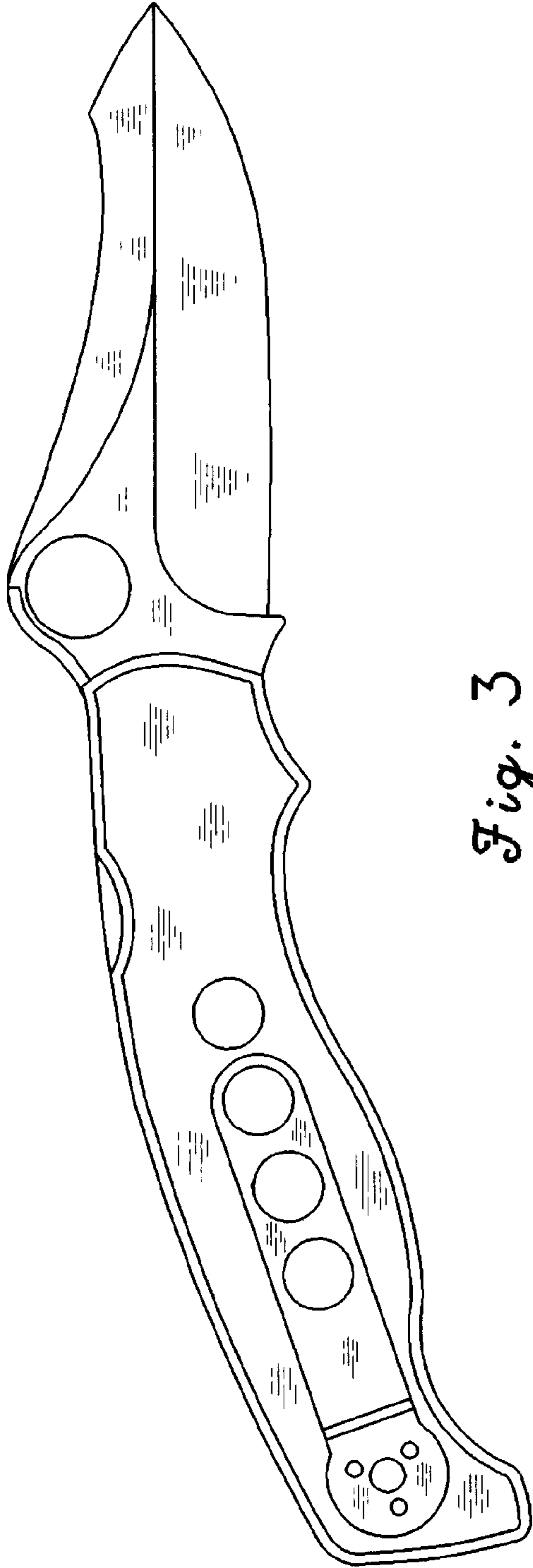

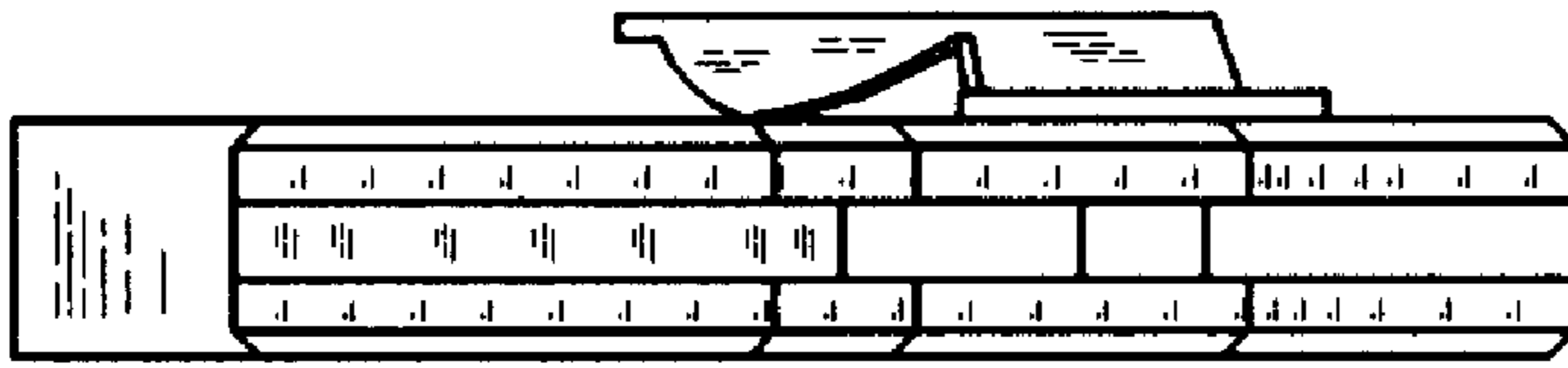

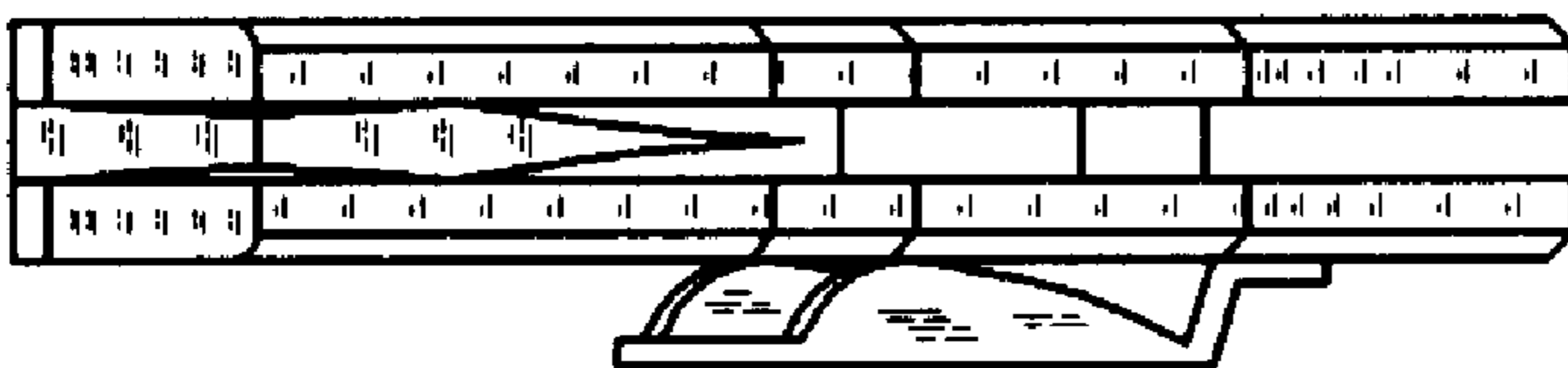

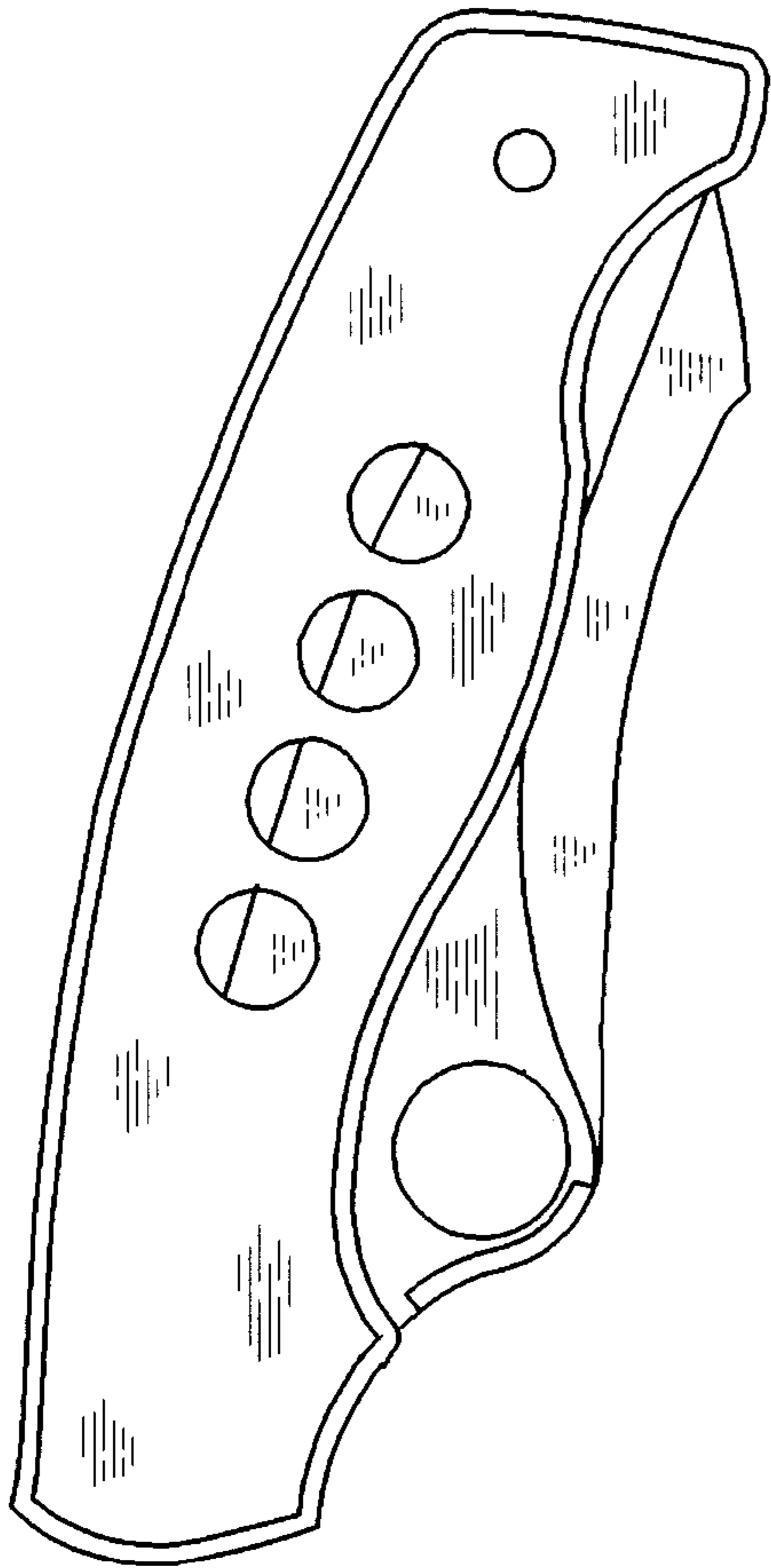

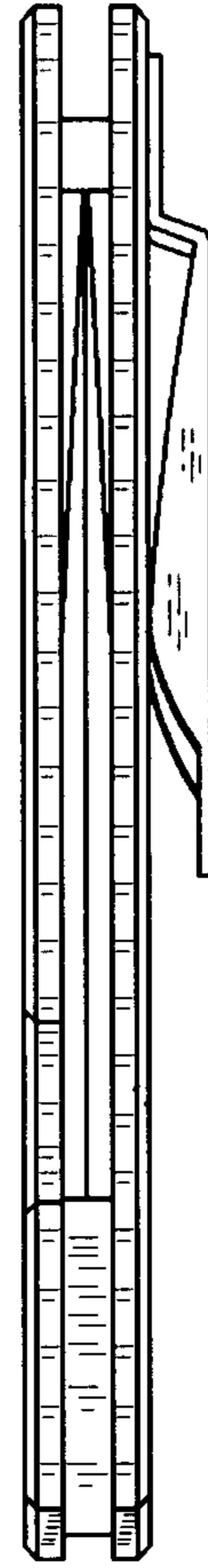

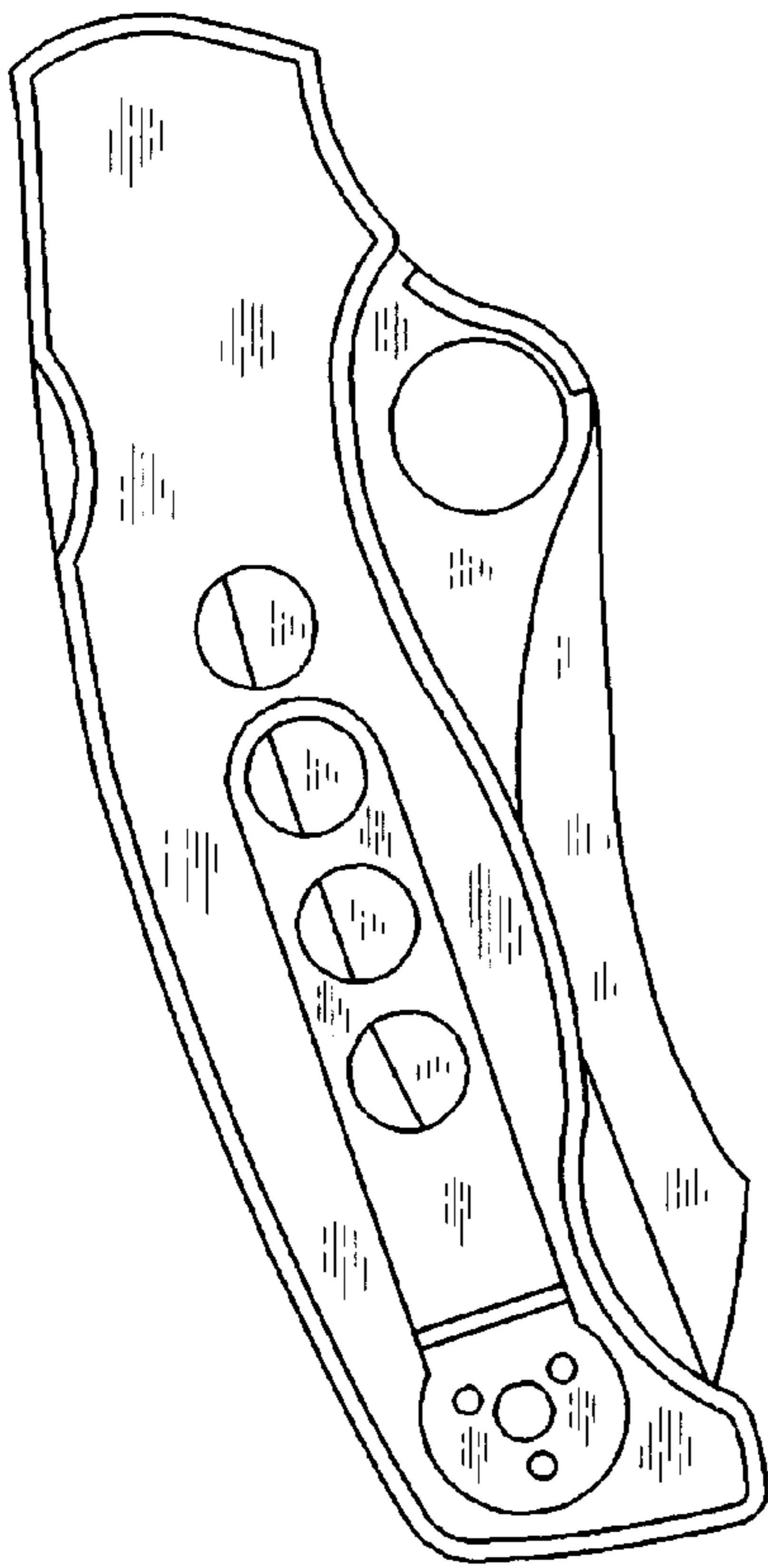

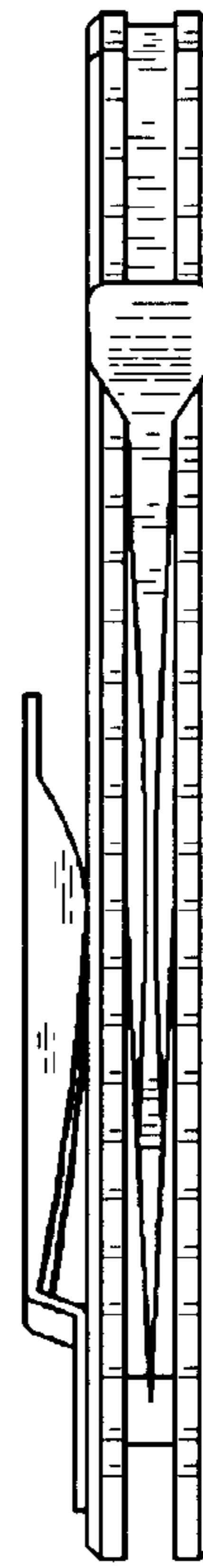

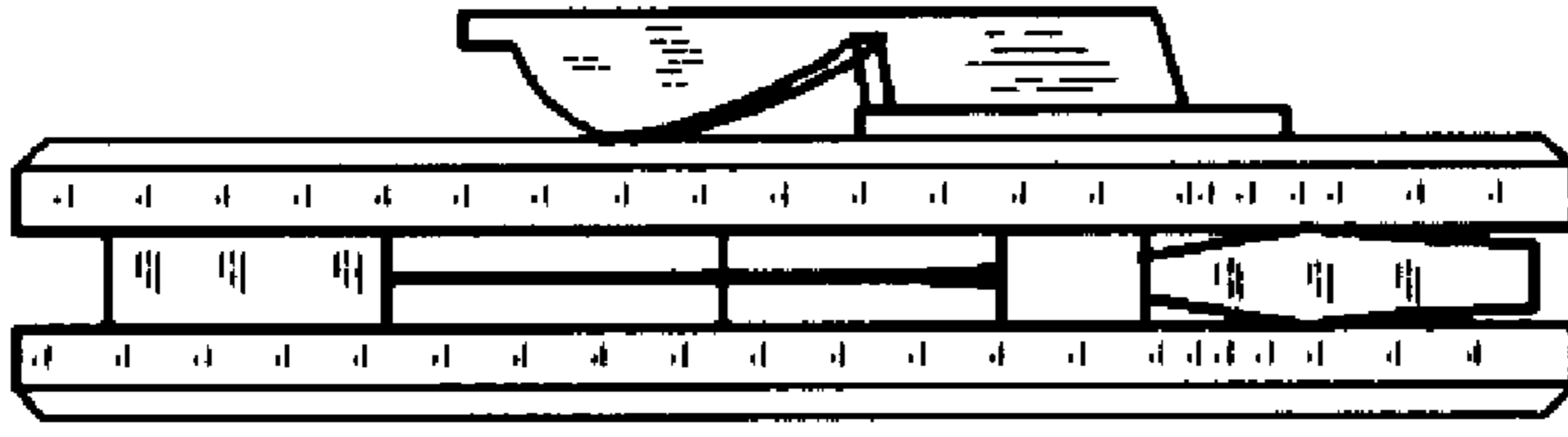

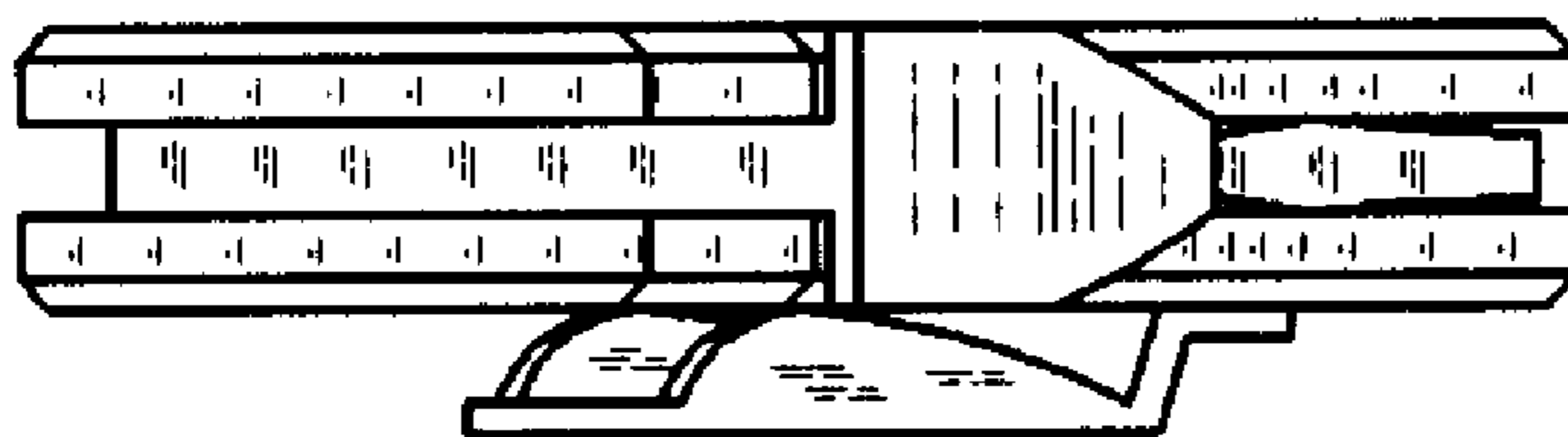
