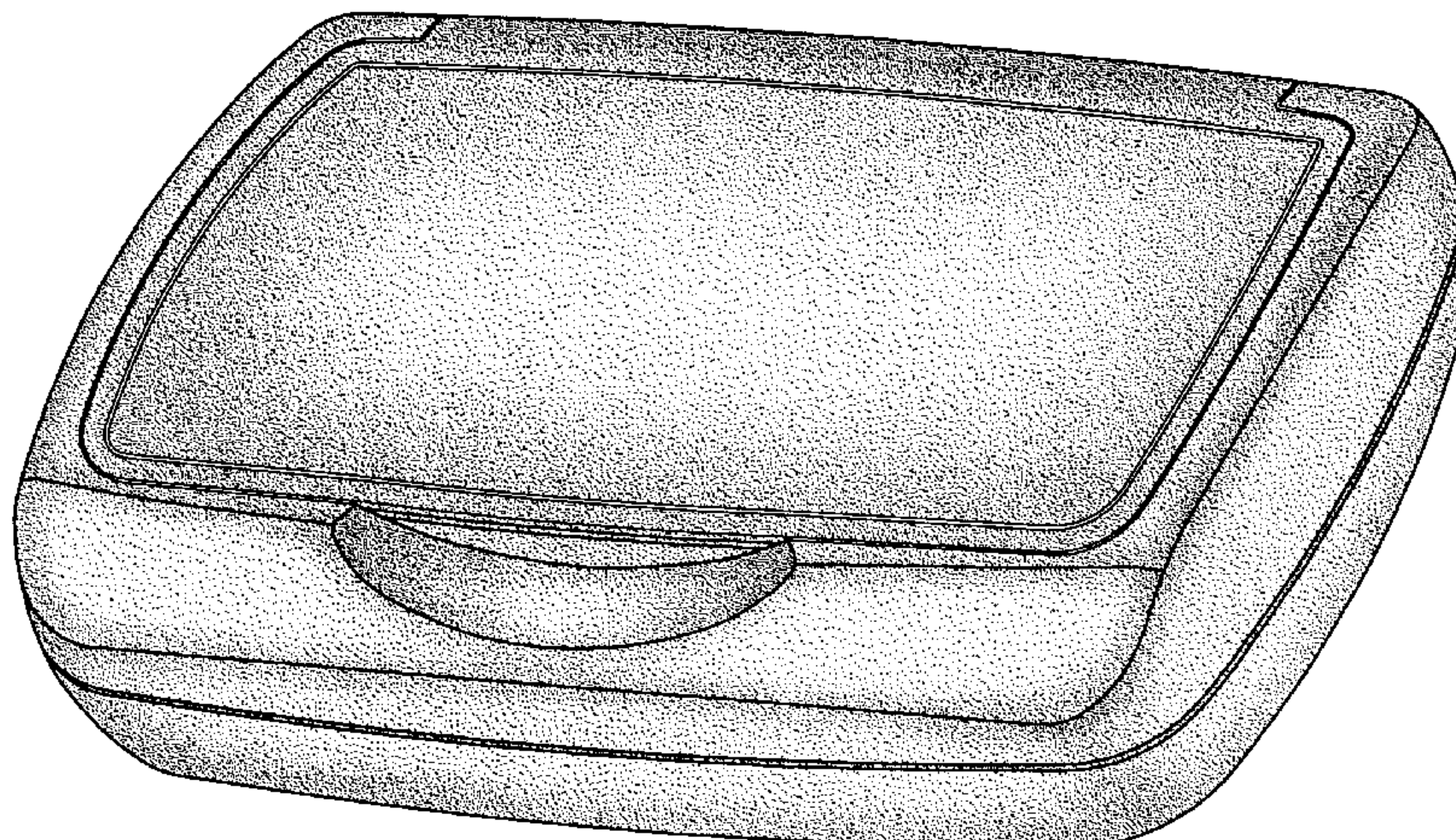
(57) **CLAIM**

The ornamental design for the wipes container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a wipes container according to the present invention; FIG. 2 is a first side view of the wipes container of FIG. 1, the opposite side being identical; FIG. 3 is a top view of the wipes container of FIG. 1; FIG. 4 is a bottom view of the wipes container of FIG. 1; FIG. 5 is a front view of the wipes container of FIG. 1; FIG. 6 is a rear view of the wipes container of FIG. 1; and, FIG. 7 is a top perspective view of the wipes container of FIG. 1 showing the lid in an open position.

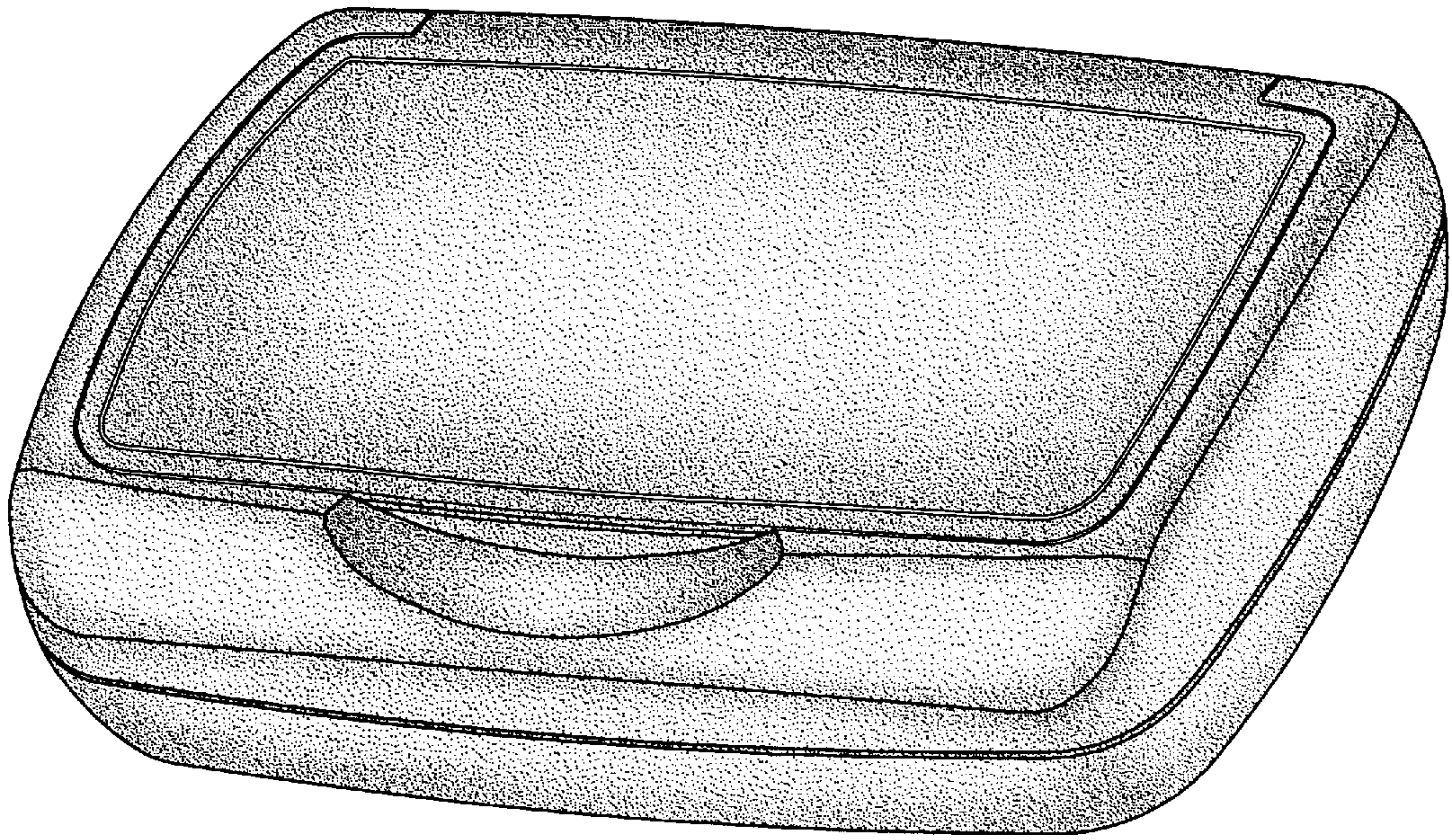

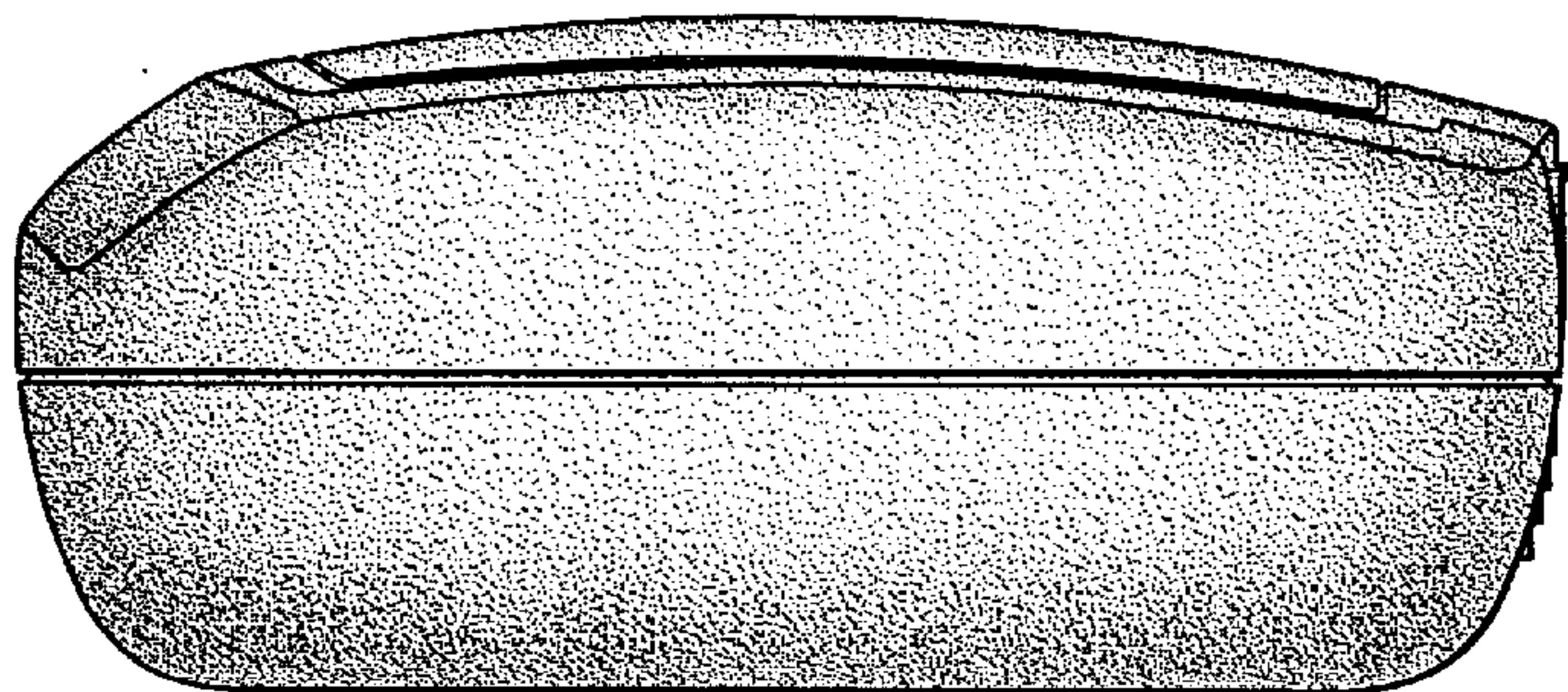

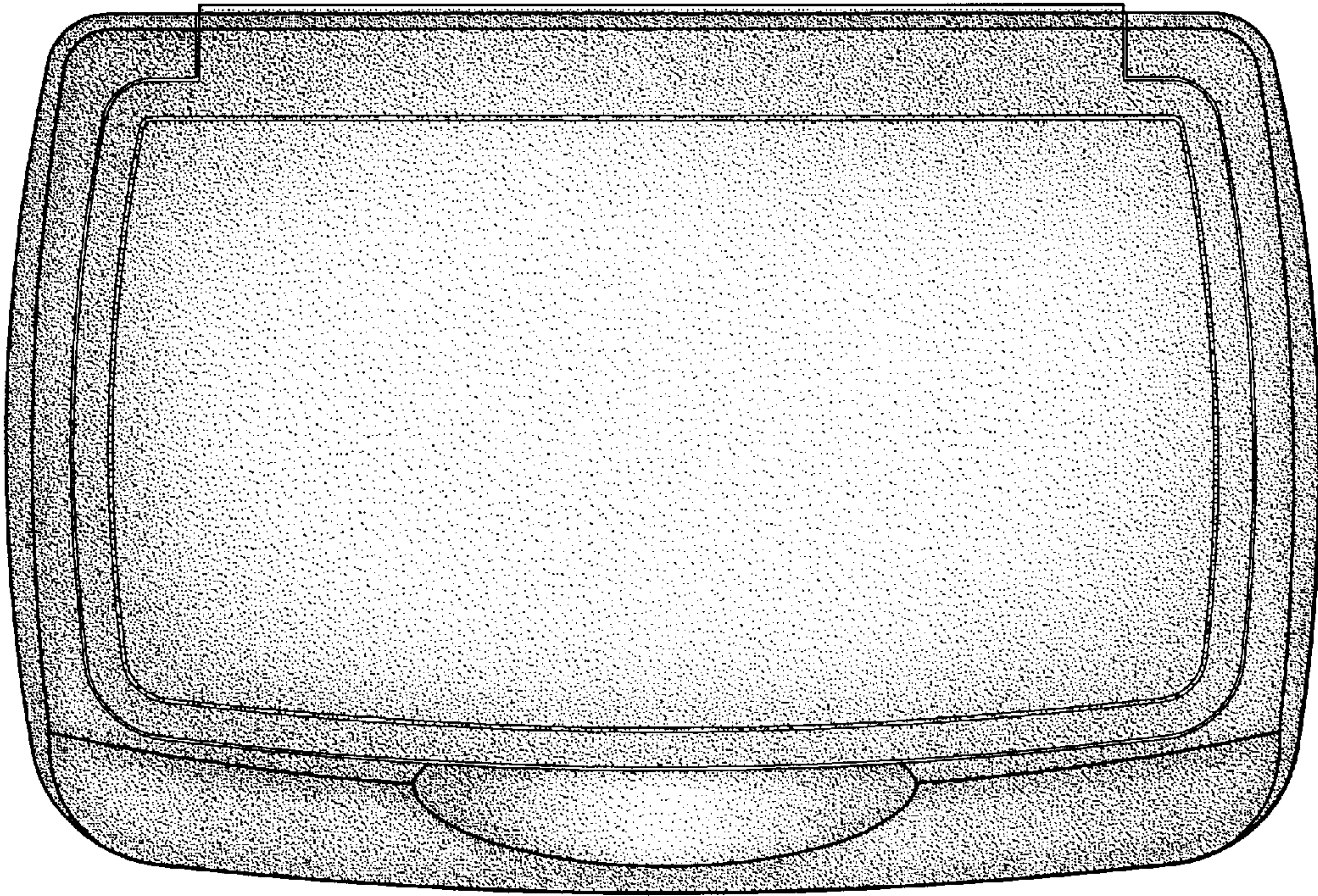

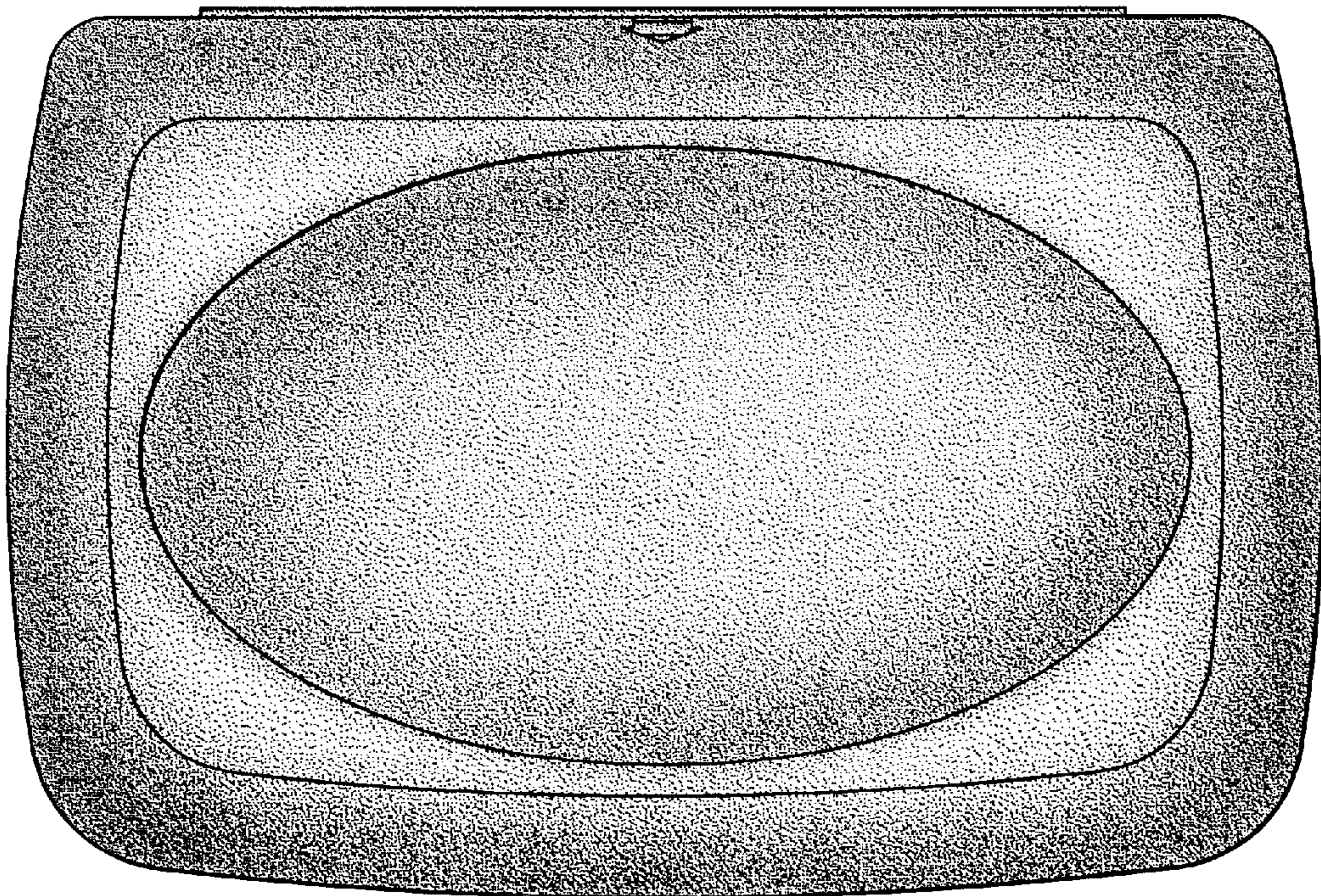

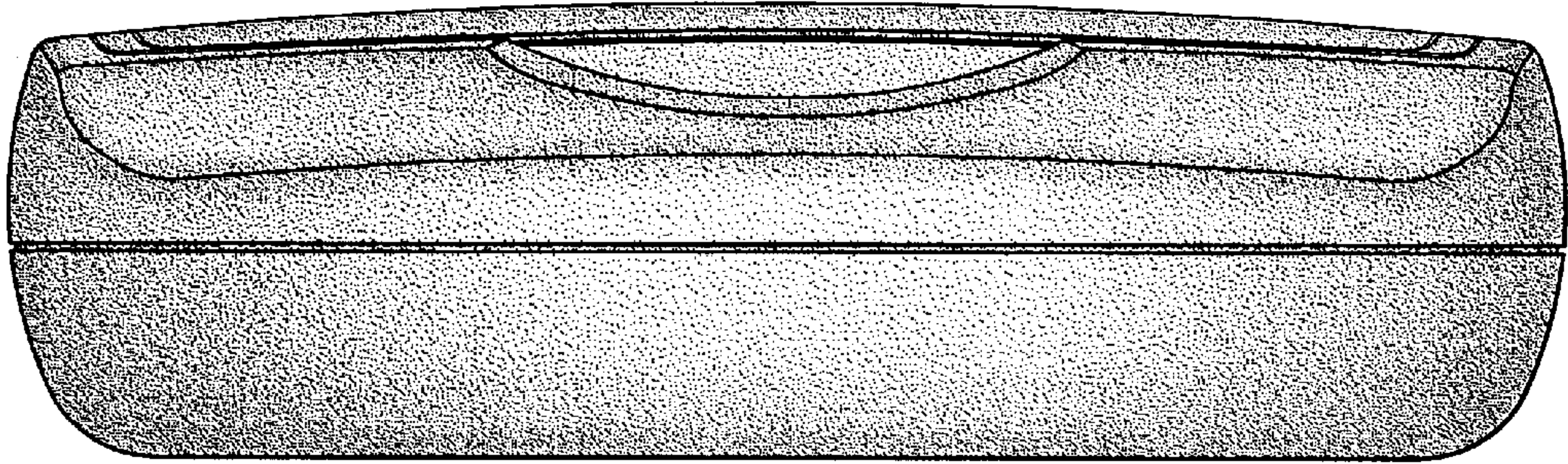

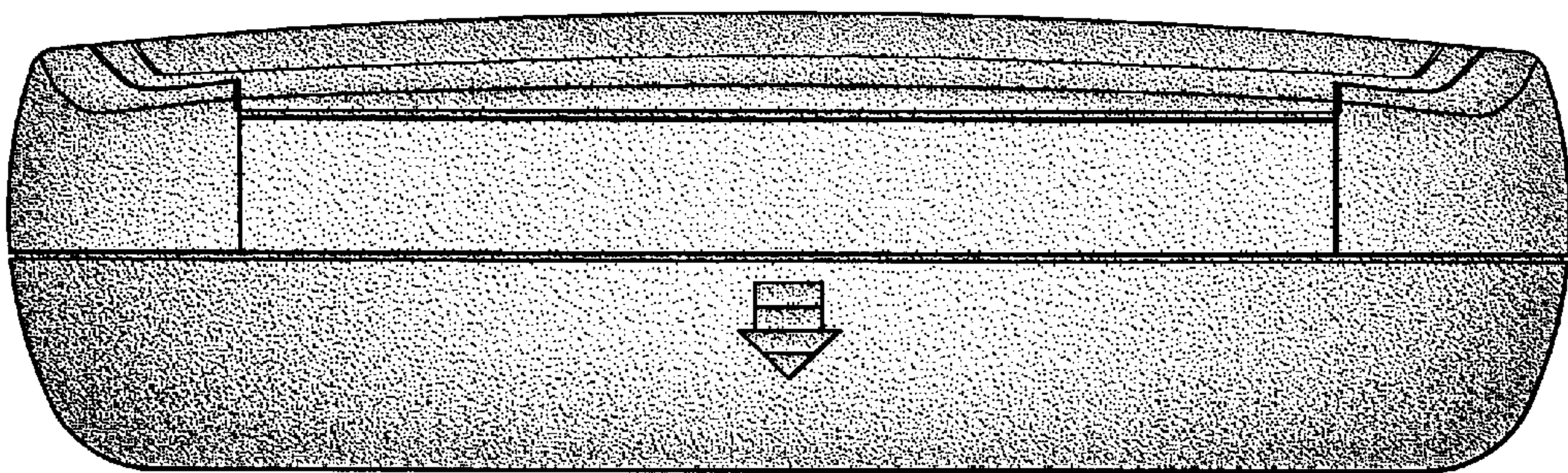

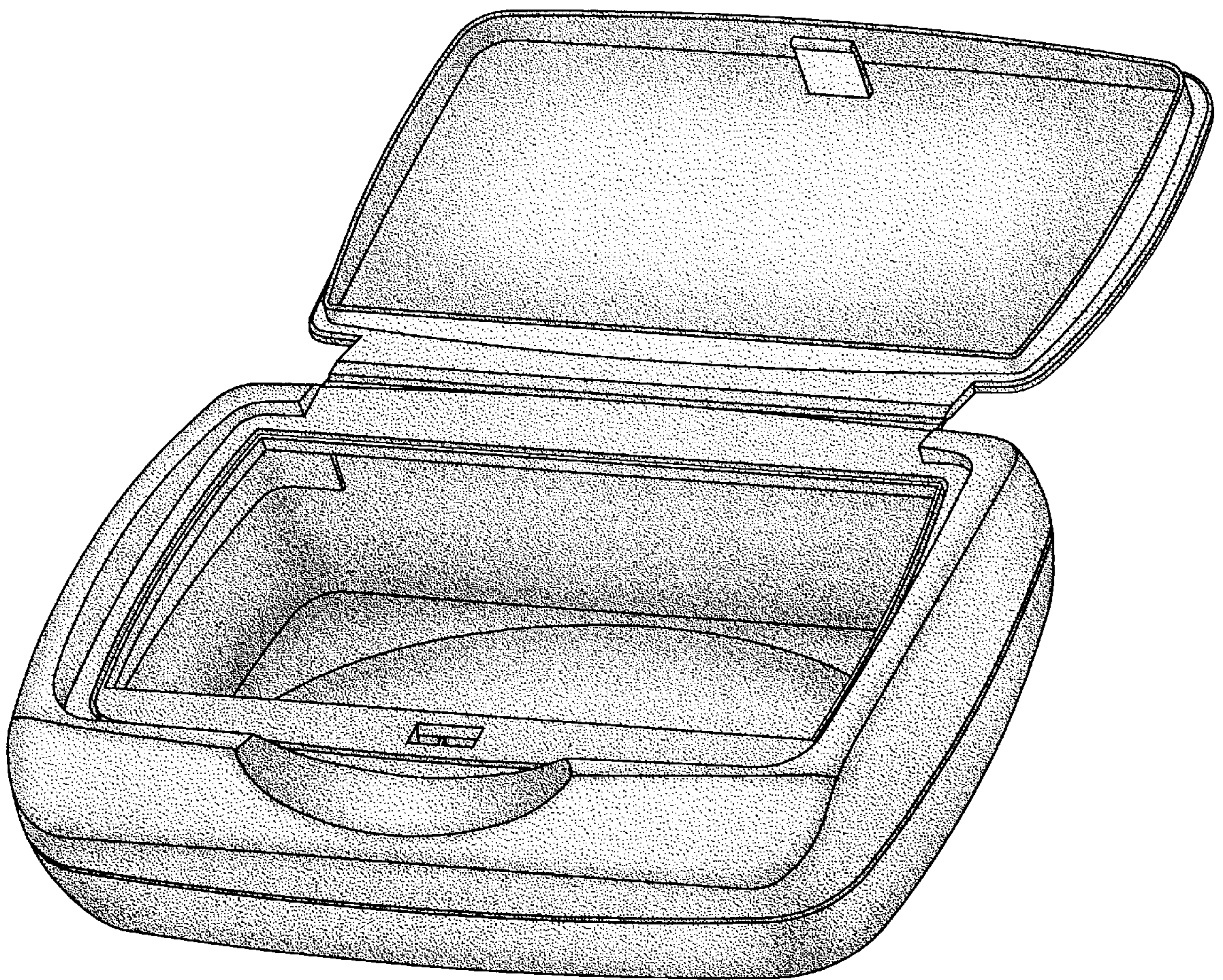
