FIG. 5 is another side view of the disposable food tray of FIG. 1; and,

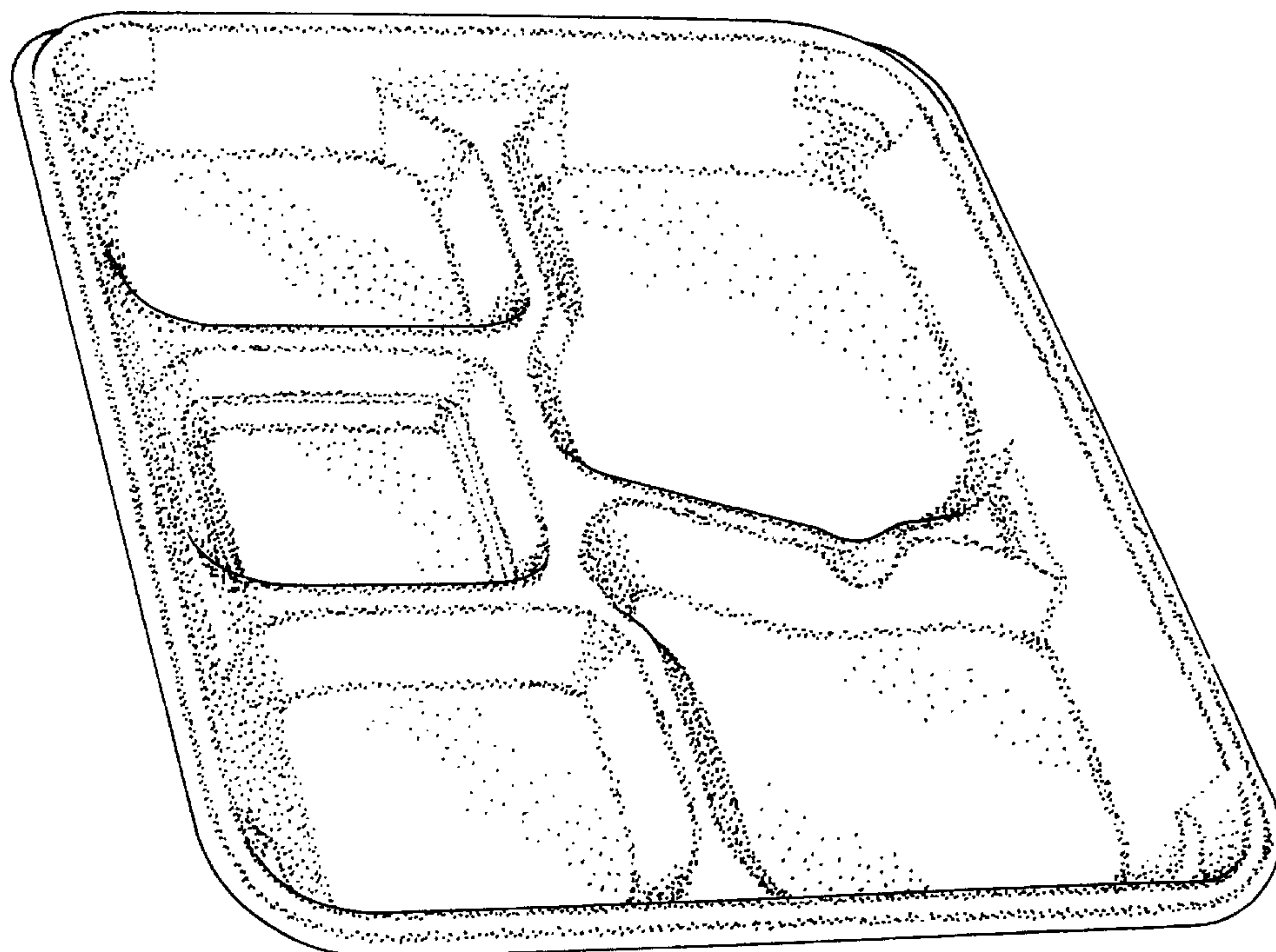
FIG. 6 is a bottom view of the disposable food tray of FIG. 1.

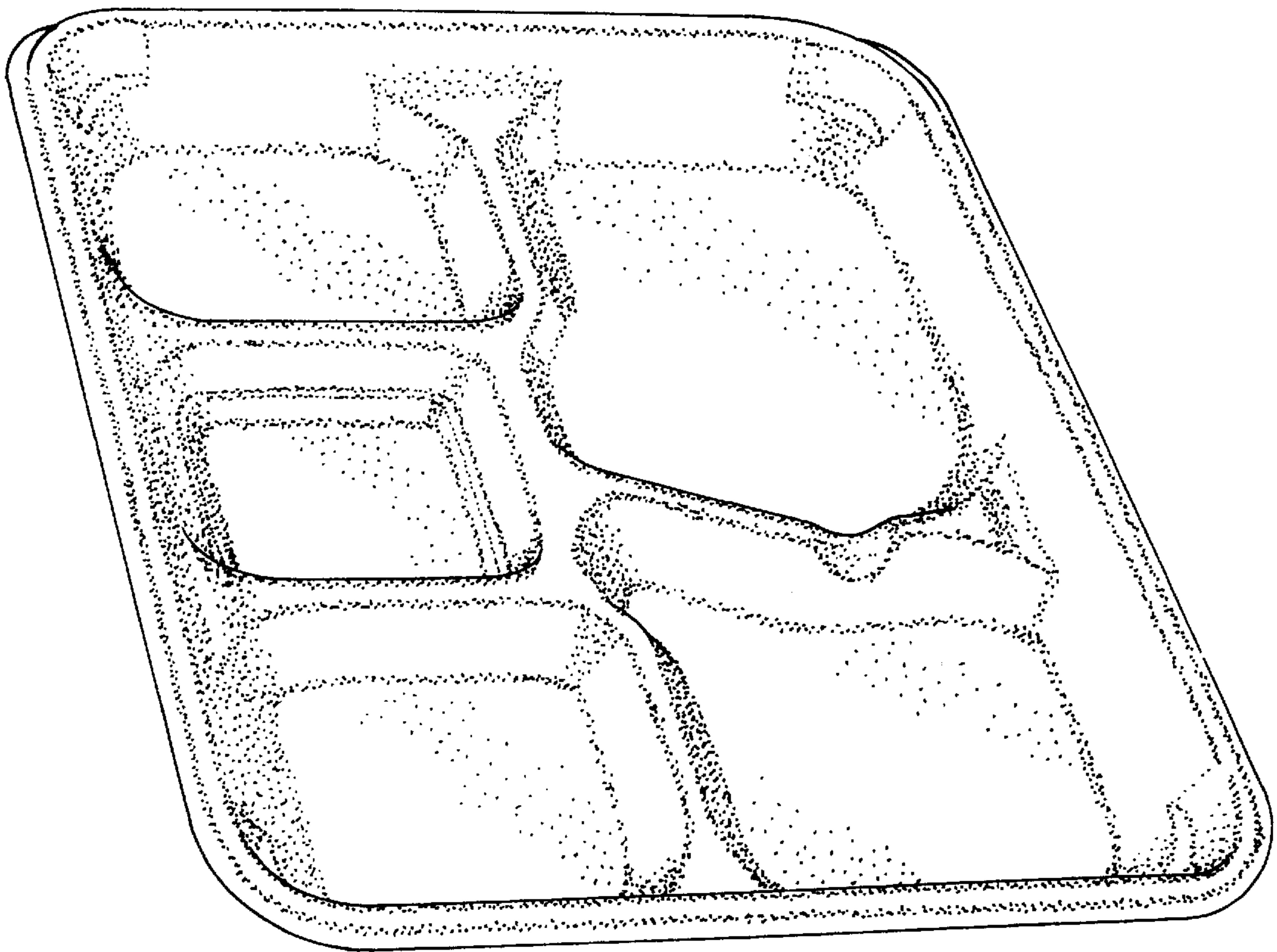

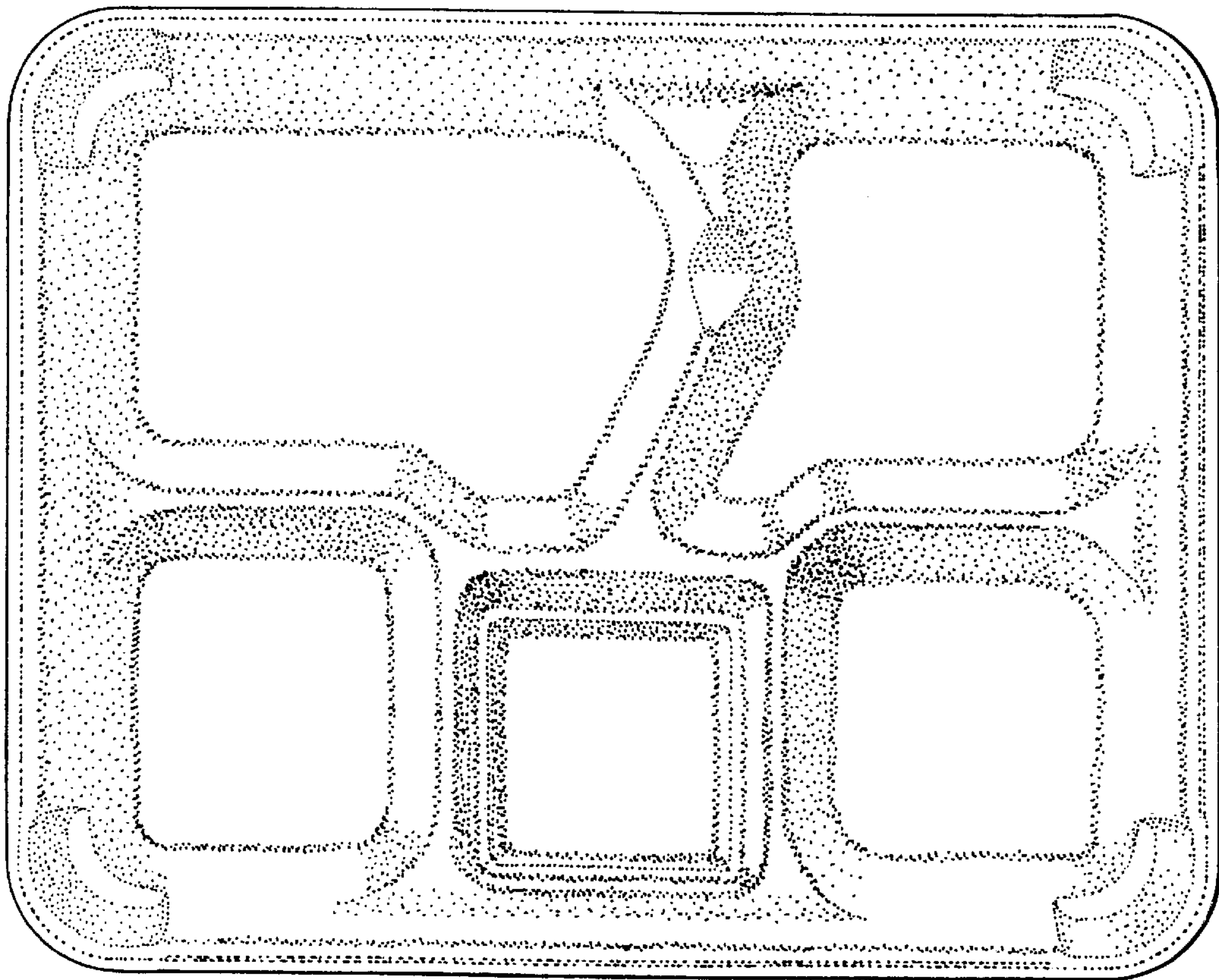

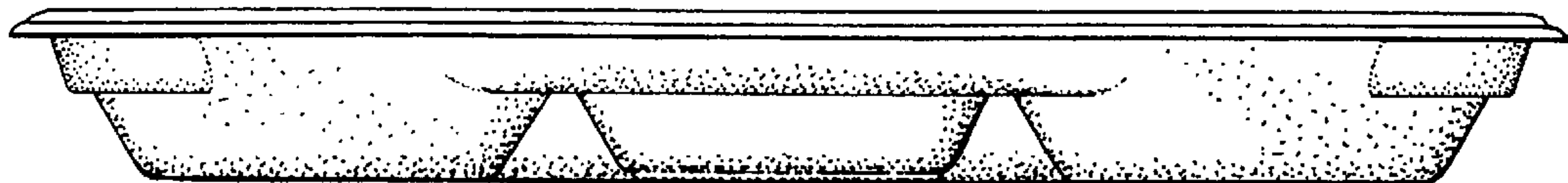

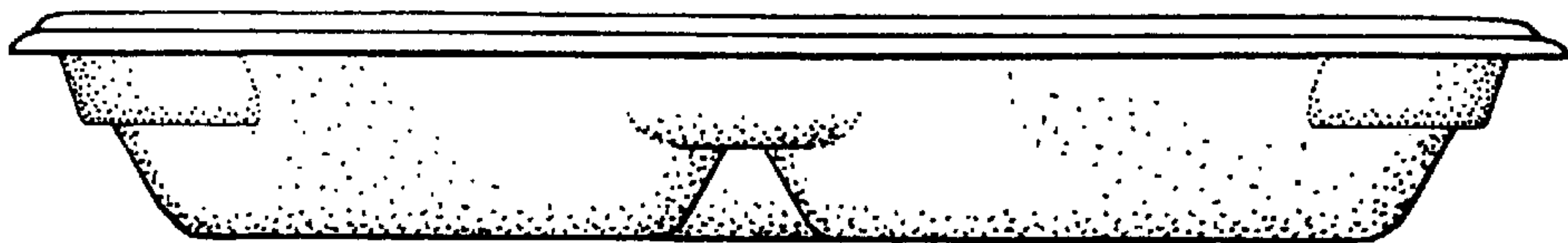

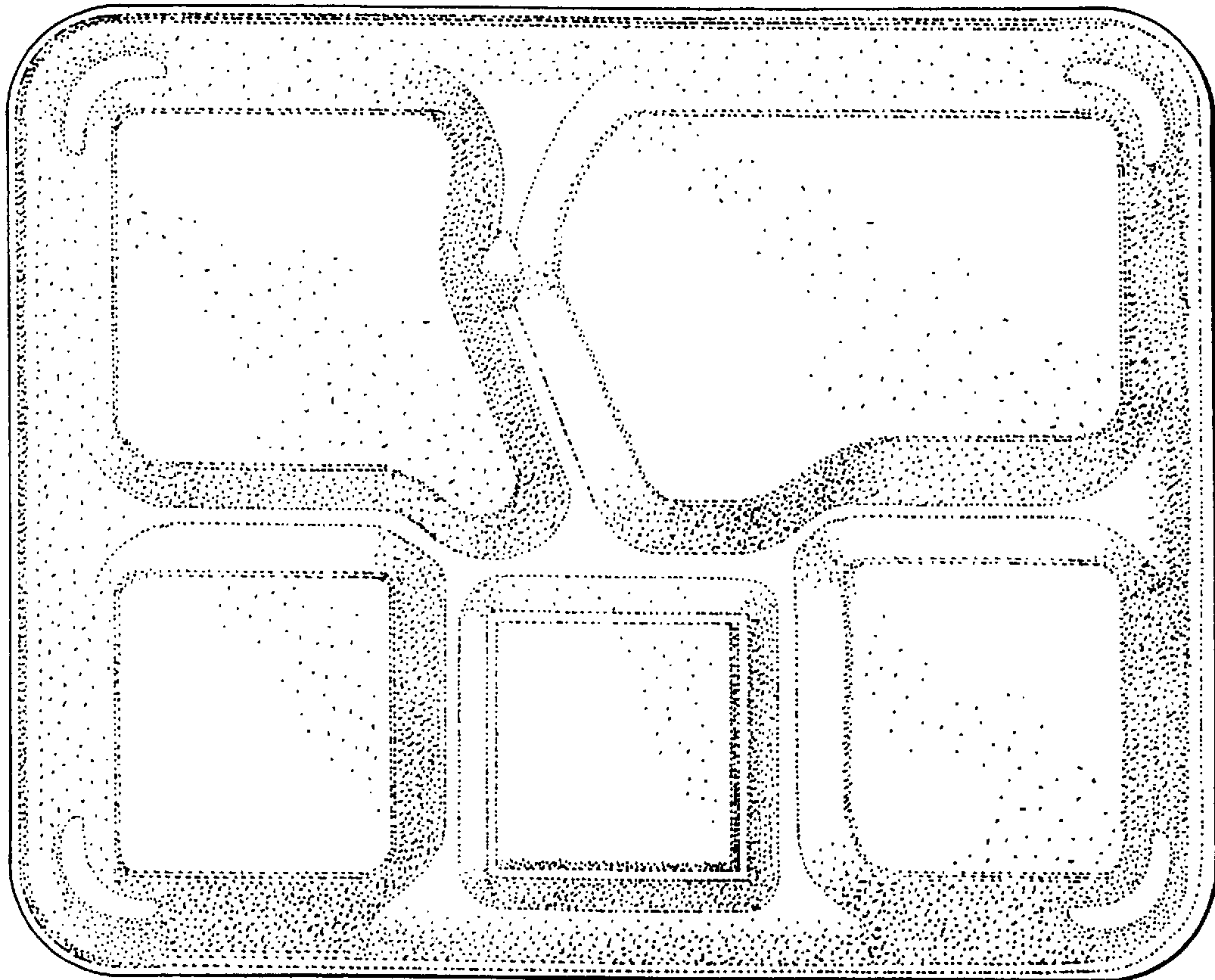
