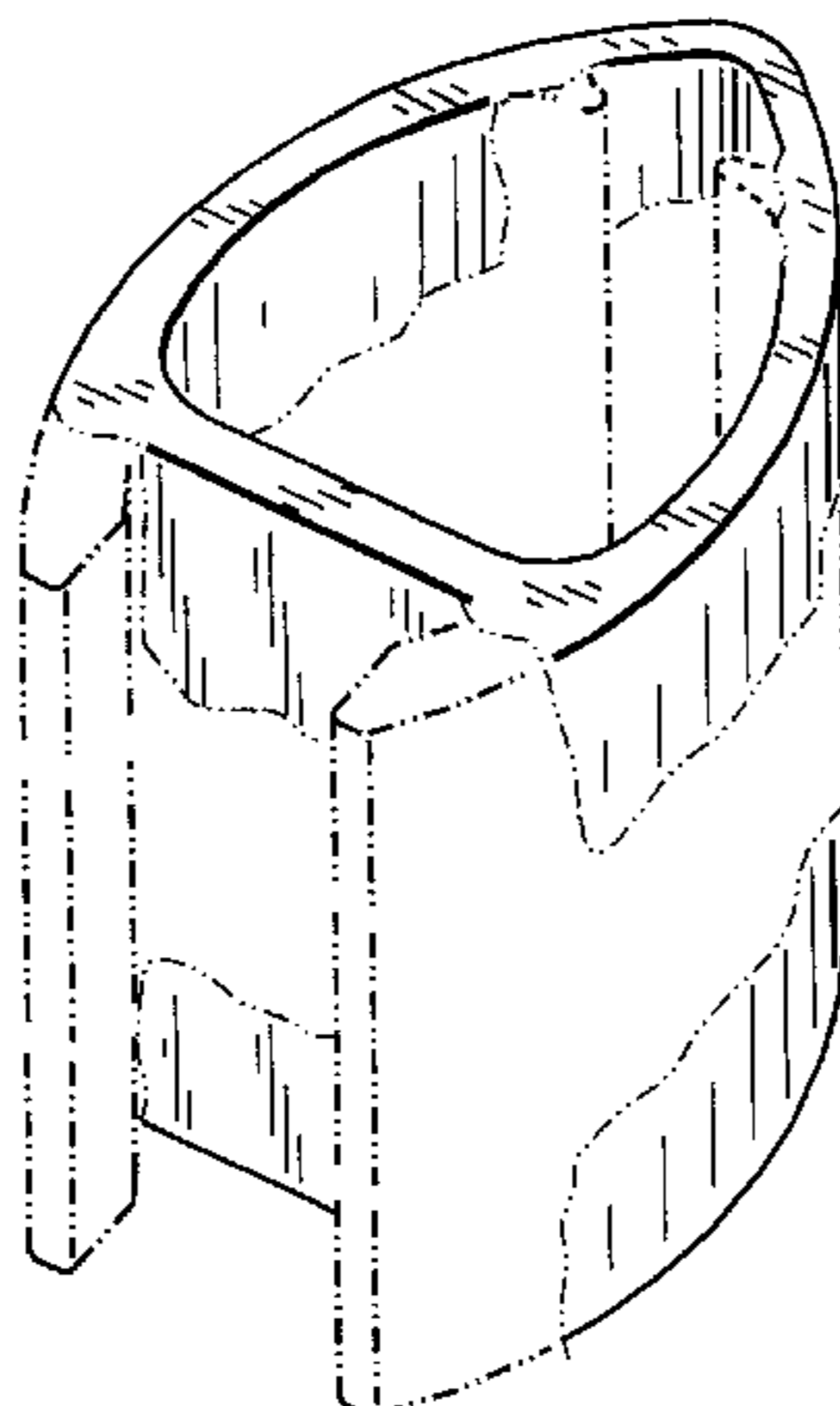
(57) **CLAIM**

The ornamental design for a trolling motor propulsion unit support shaft, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the trolling motor support shaft of the present invention with portions of an adjacent trolling motor shown in phantom;
FIG. 2 is an enlarged perspective view of the trolling motor support shaft of FIG. 1;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a front elevational view thereof; the rear elevational view being a mirror image thereof; and,
FIG. 6 is a left end elevational view thereof.
The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

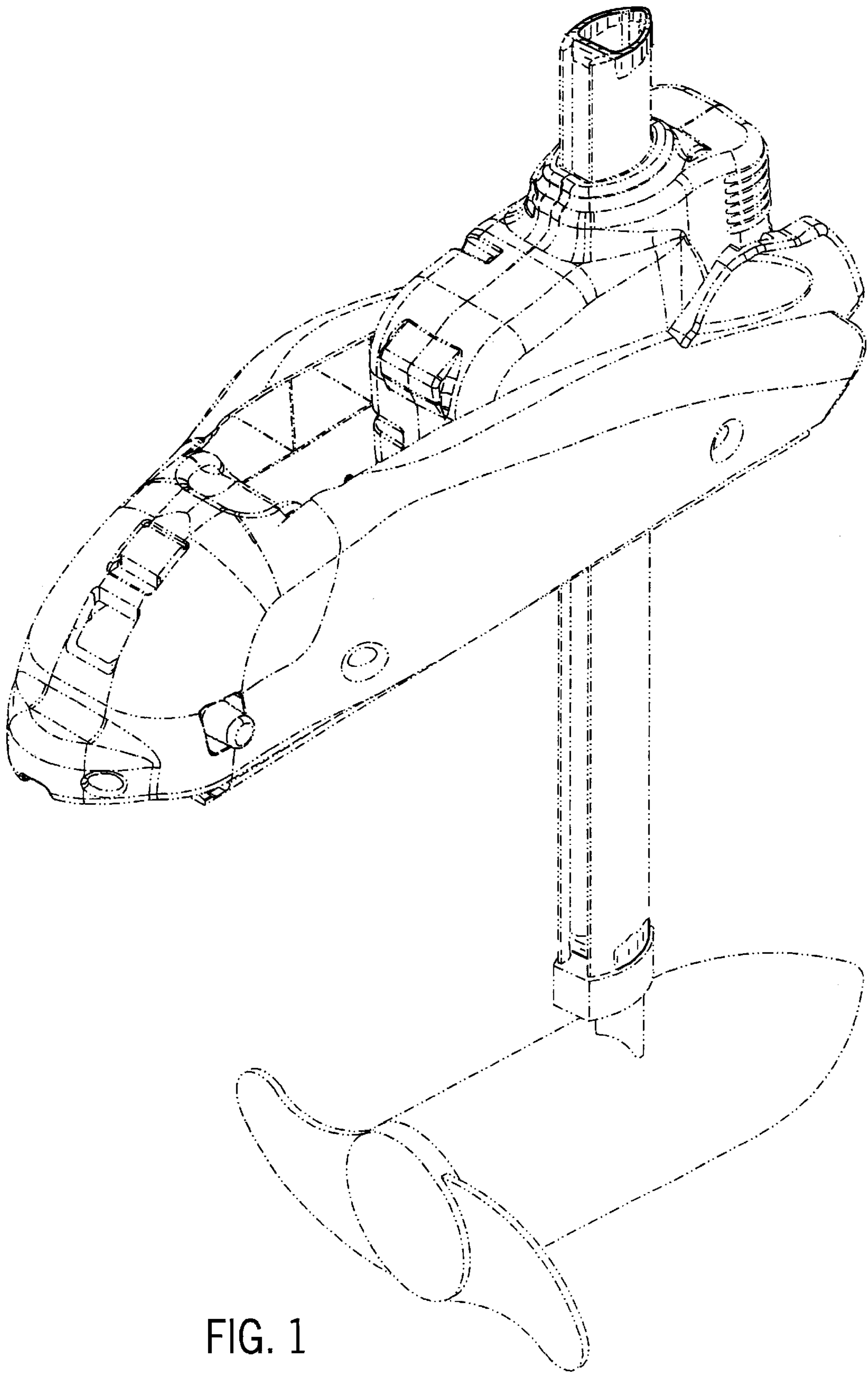

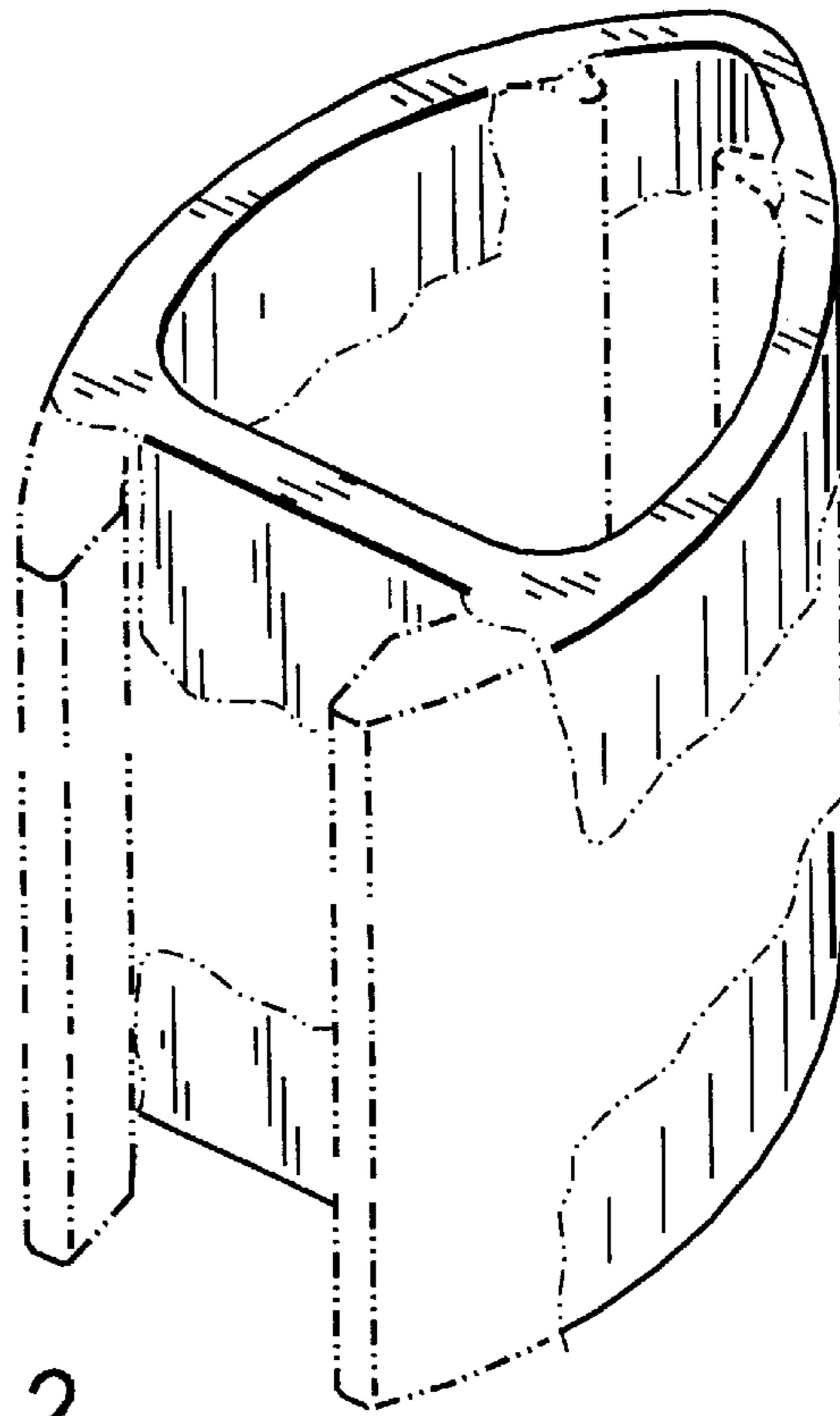

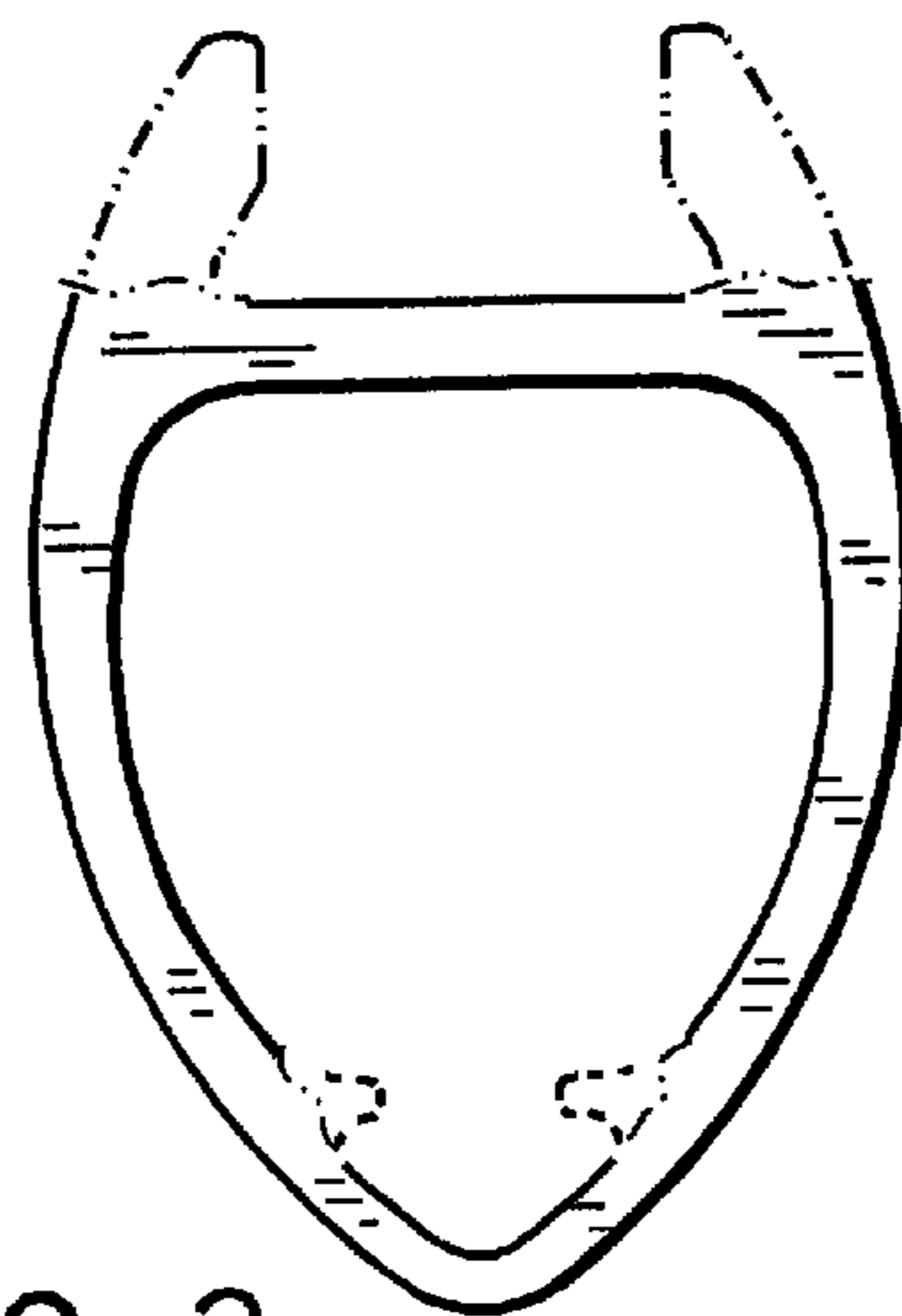

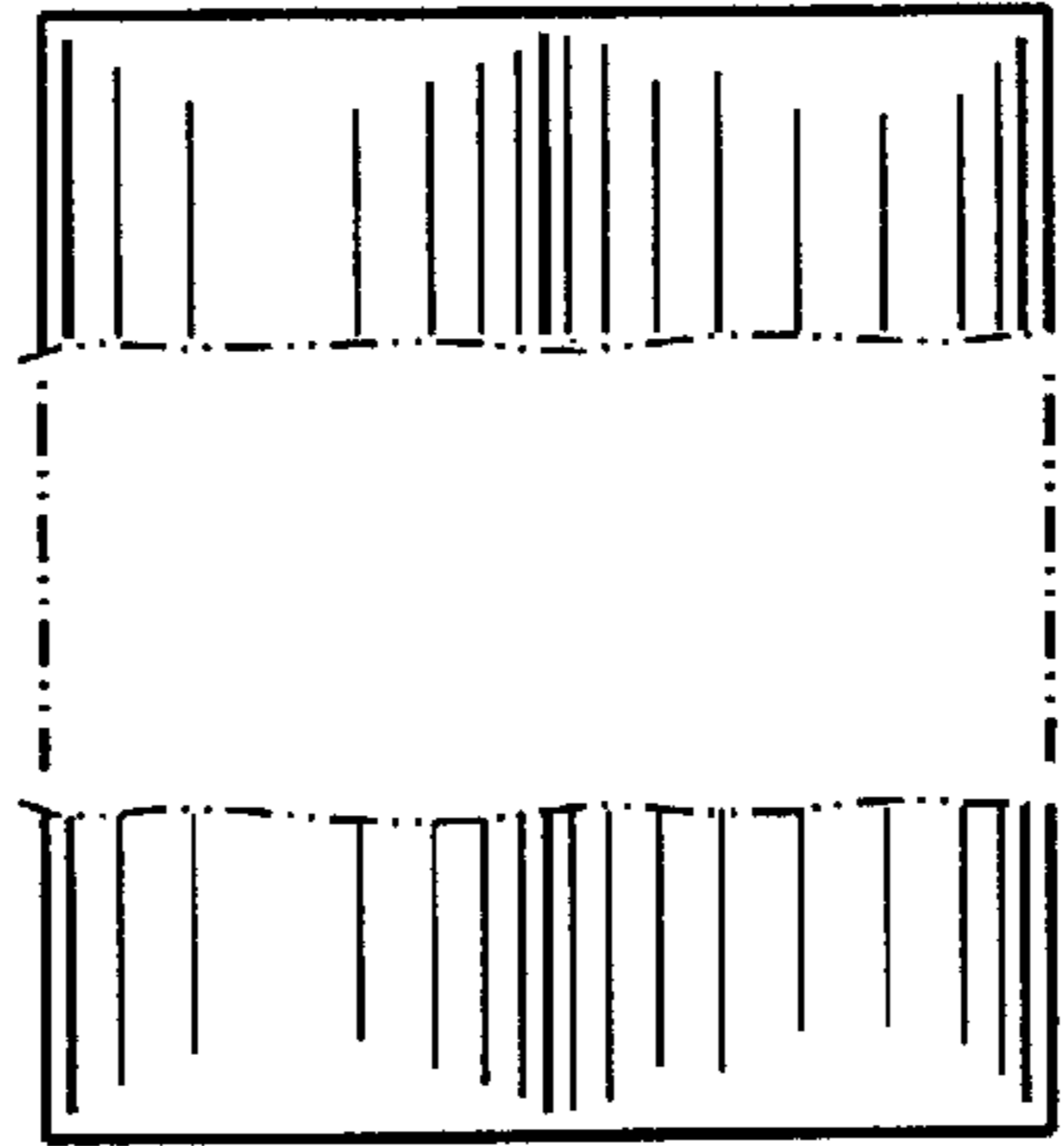

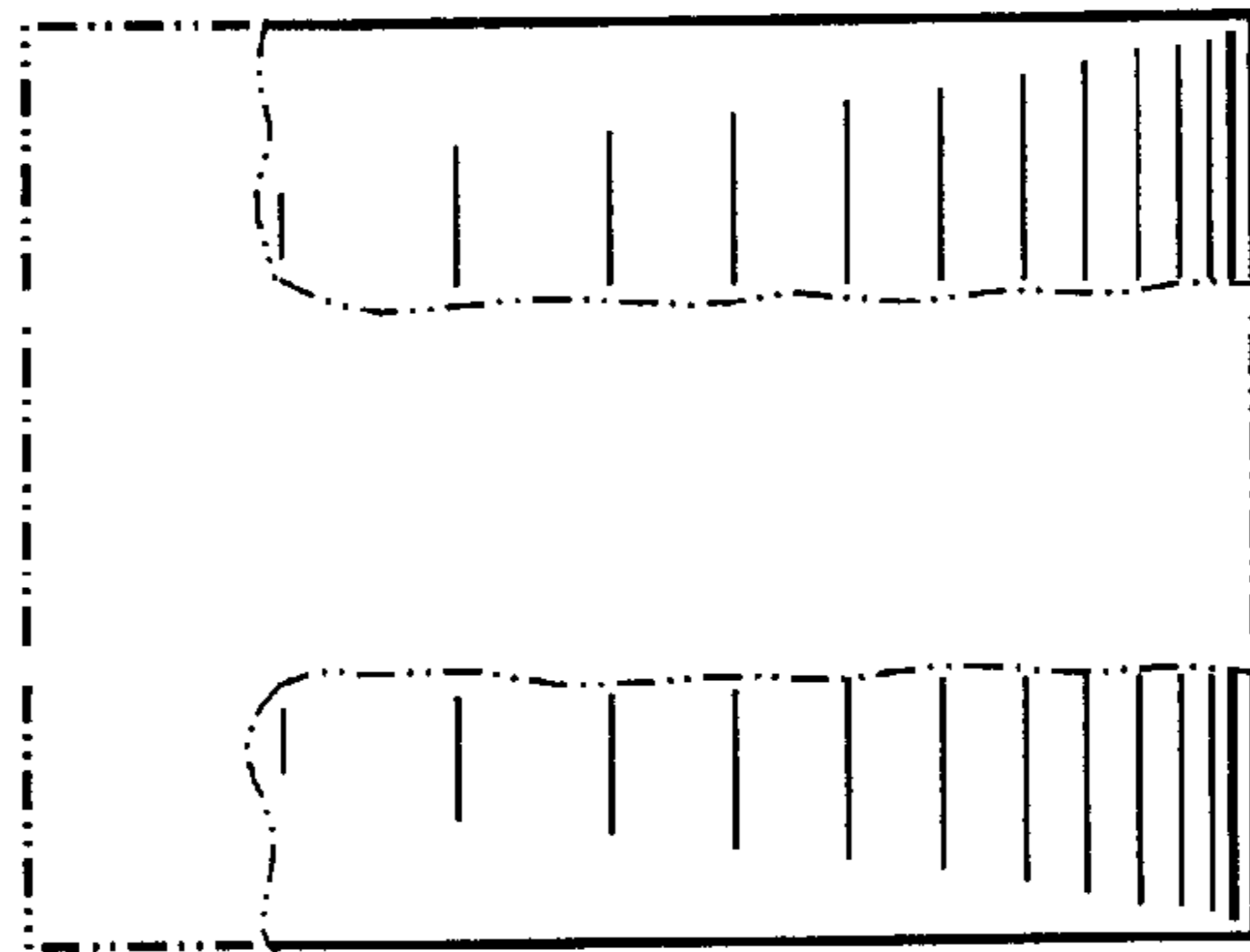

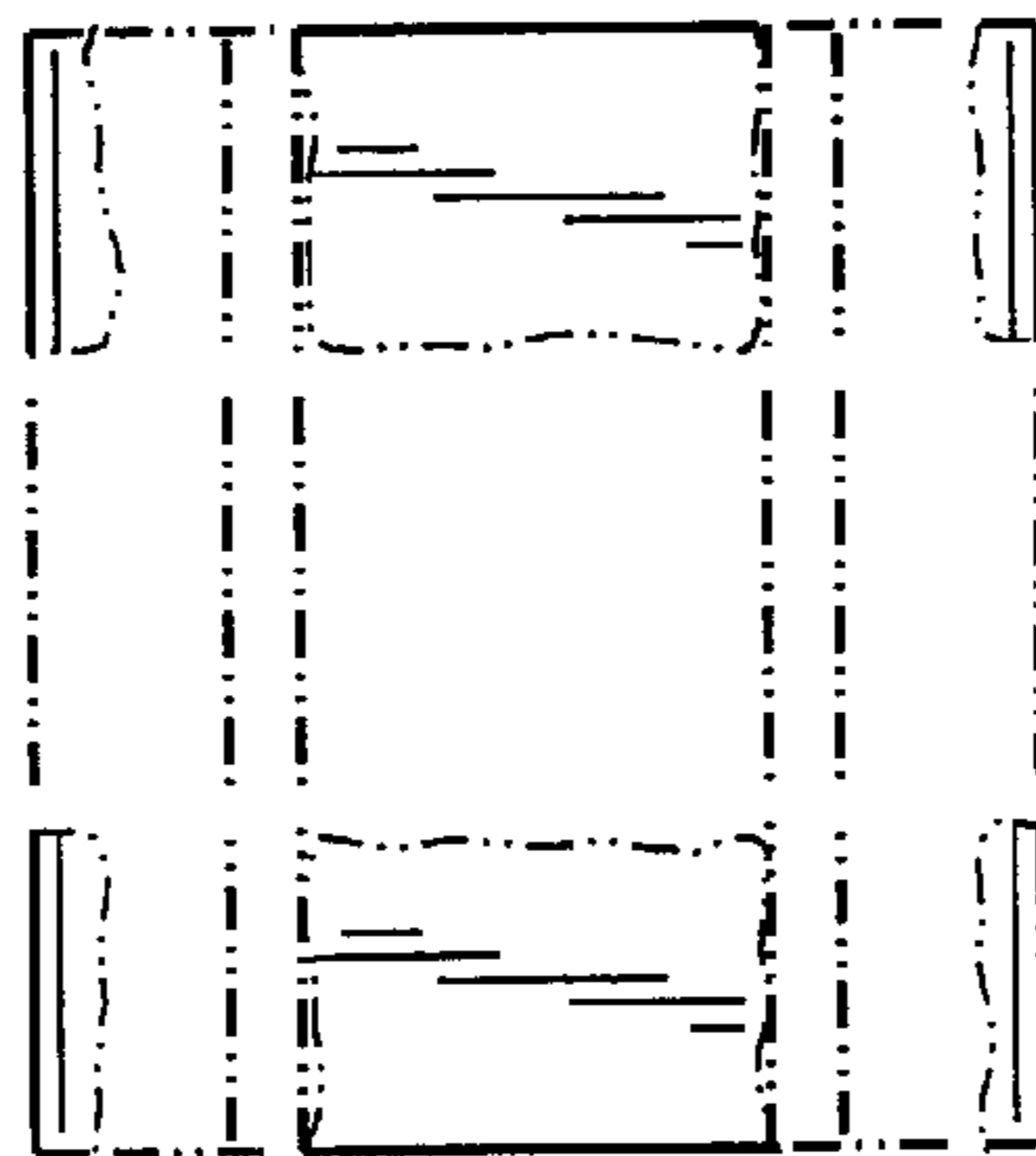
