FIG. 1 is a front perspective view of a toilet seat and cover combination showing my new design with the cover raised; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front perspective view of the toilet seat and cover combination with the cover lowered; FIG. 4 is a top plan view thereof, indicating cross-sectional lines through which FIGS. 8 and 9 are taken; FIG. 5 is a left side elevational view with the cover raised, the right side view being a mirror image of that shown; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front elevational view thereof; FIG. 8 is a cross-sectional view taken along line 8—8 in FIG. 4; and, FIG. 9 is a cross-sectional view taken along line 9—9 in FIG. 4.

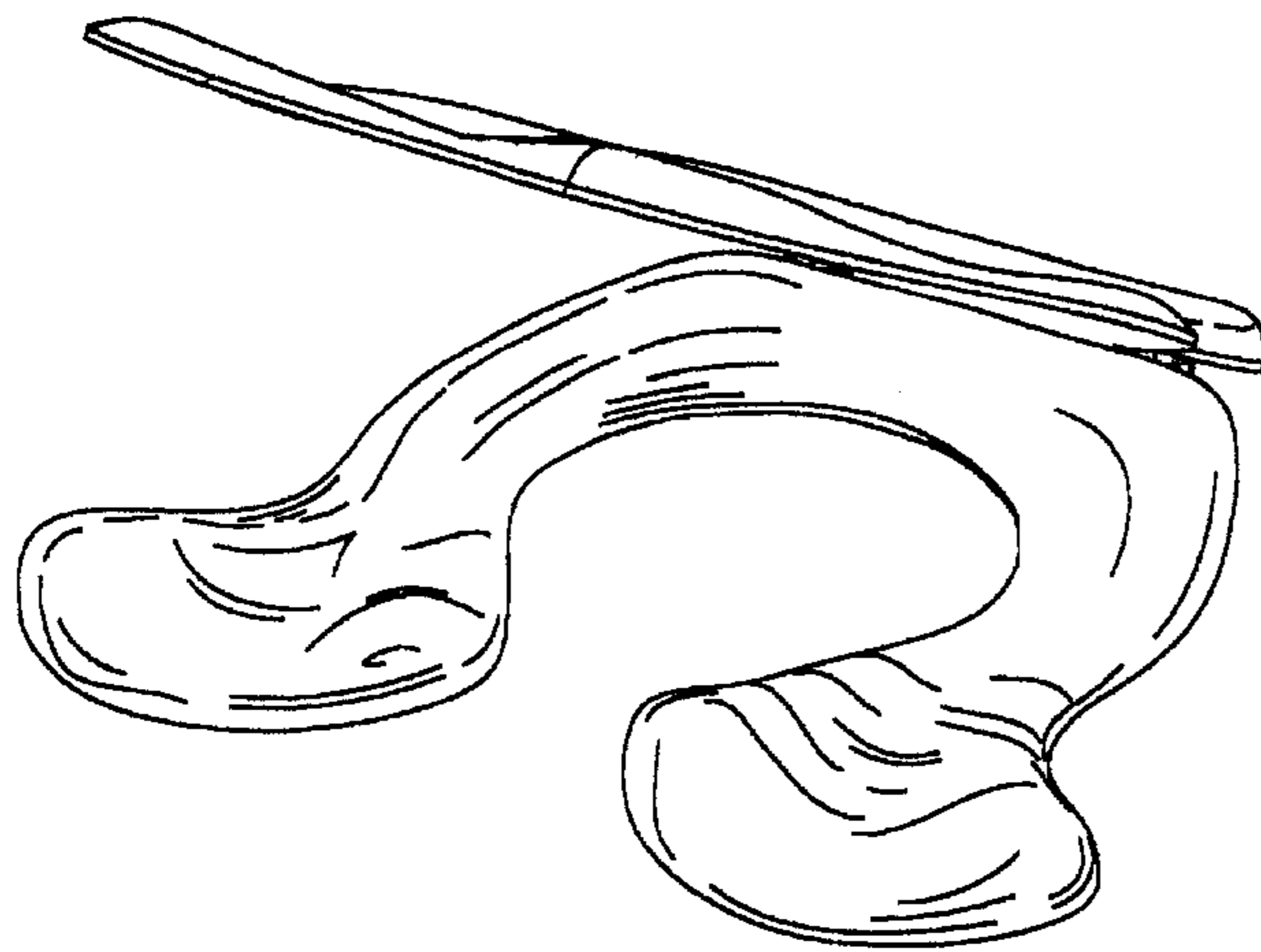

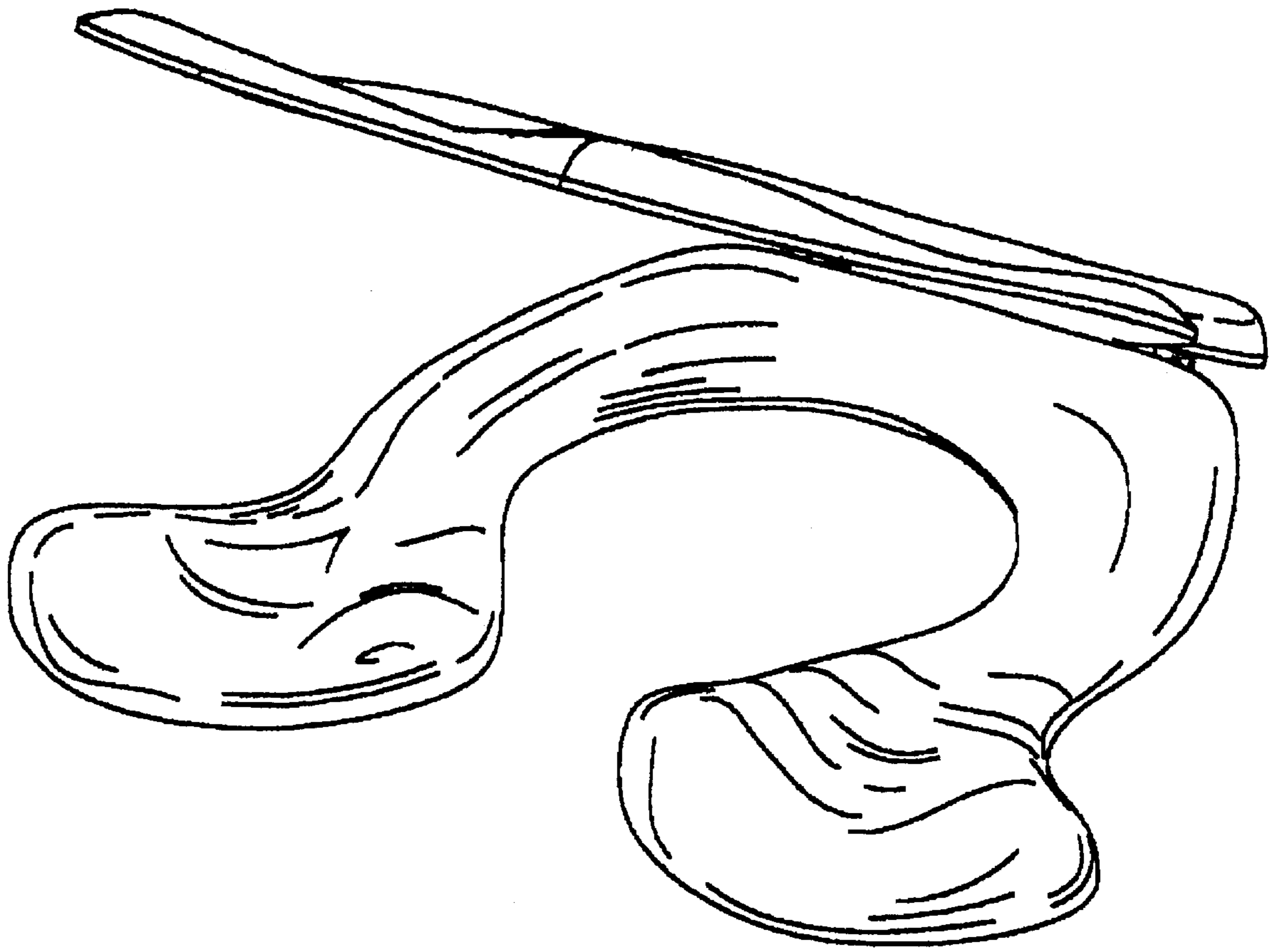

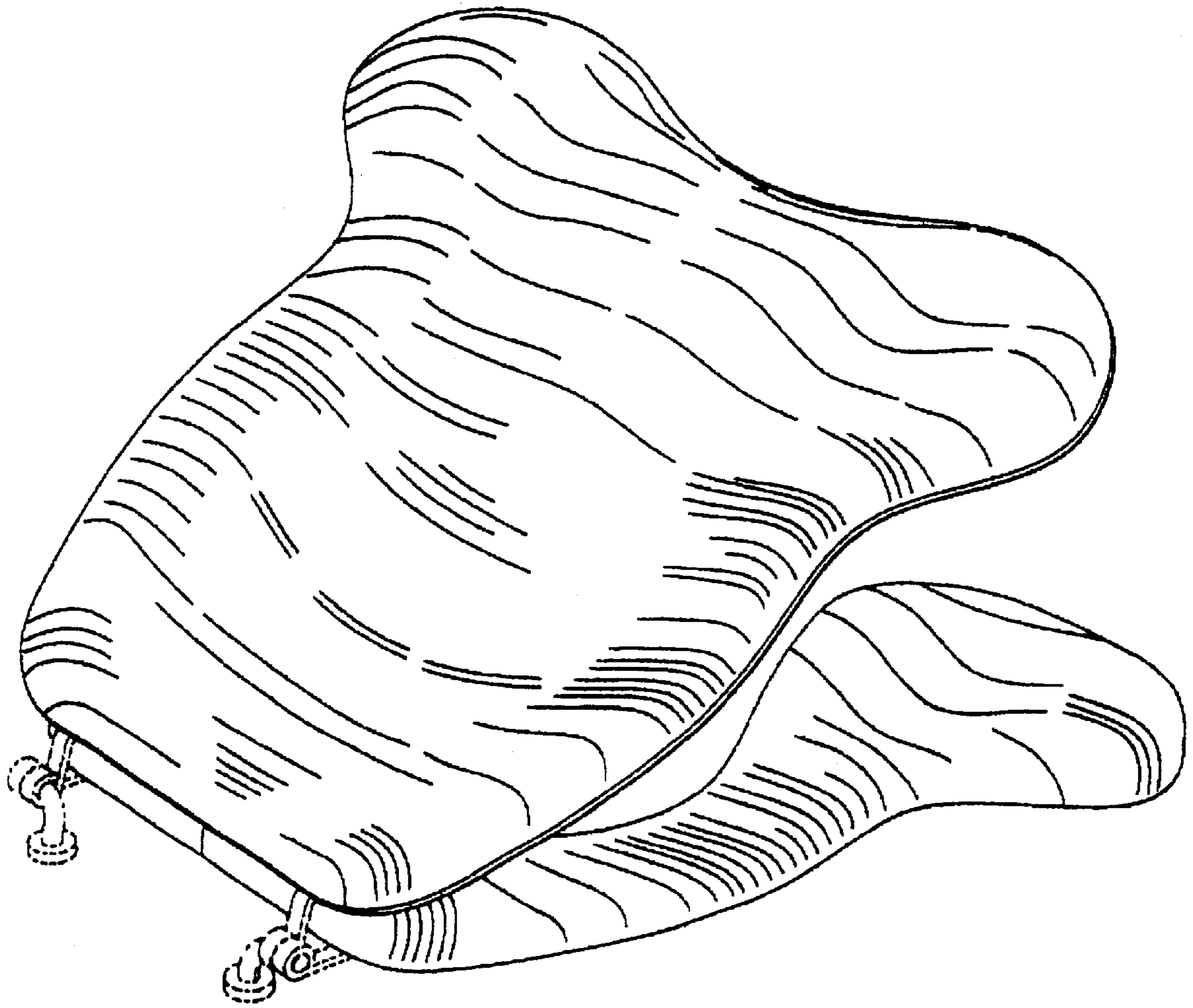

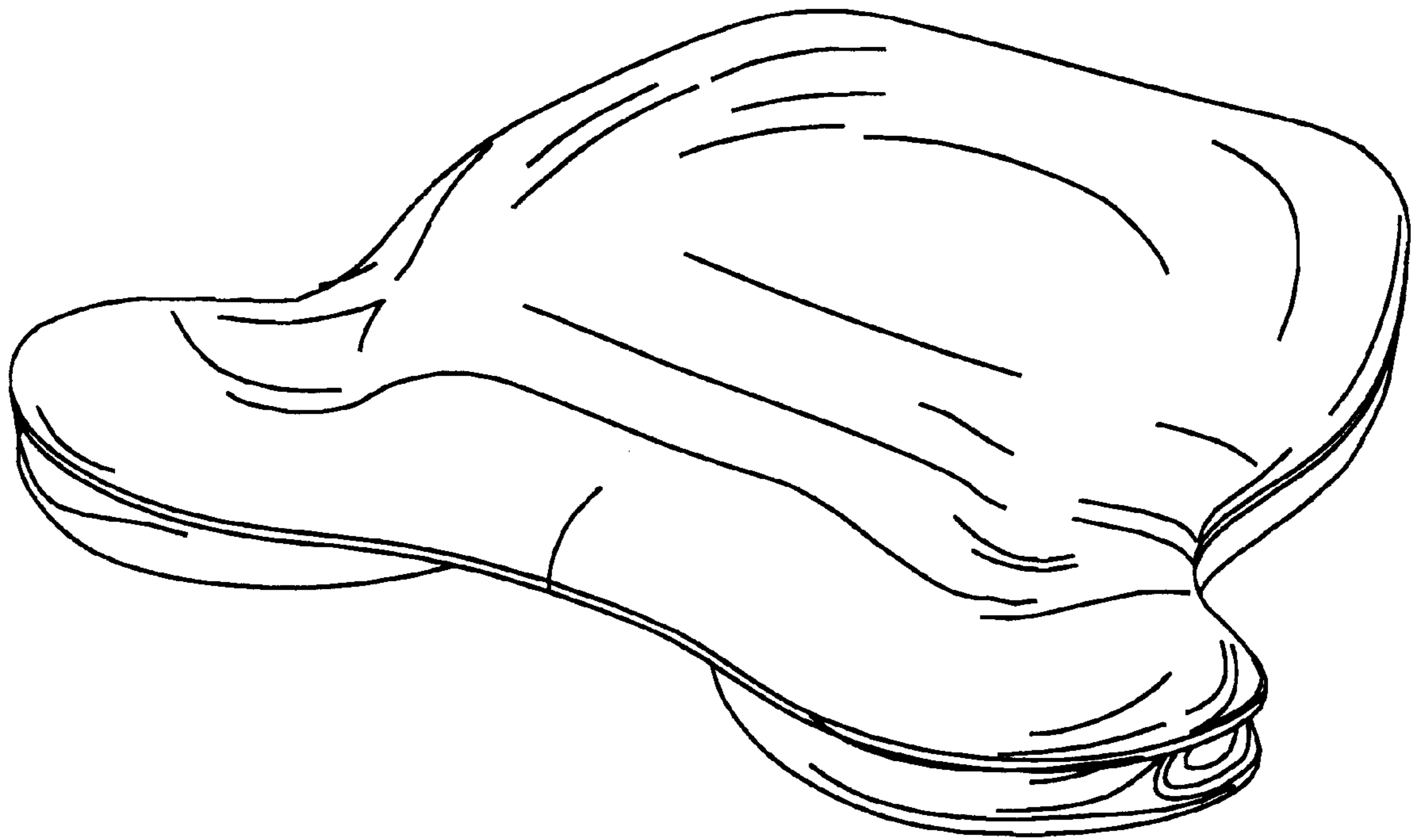

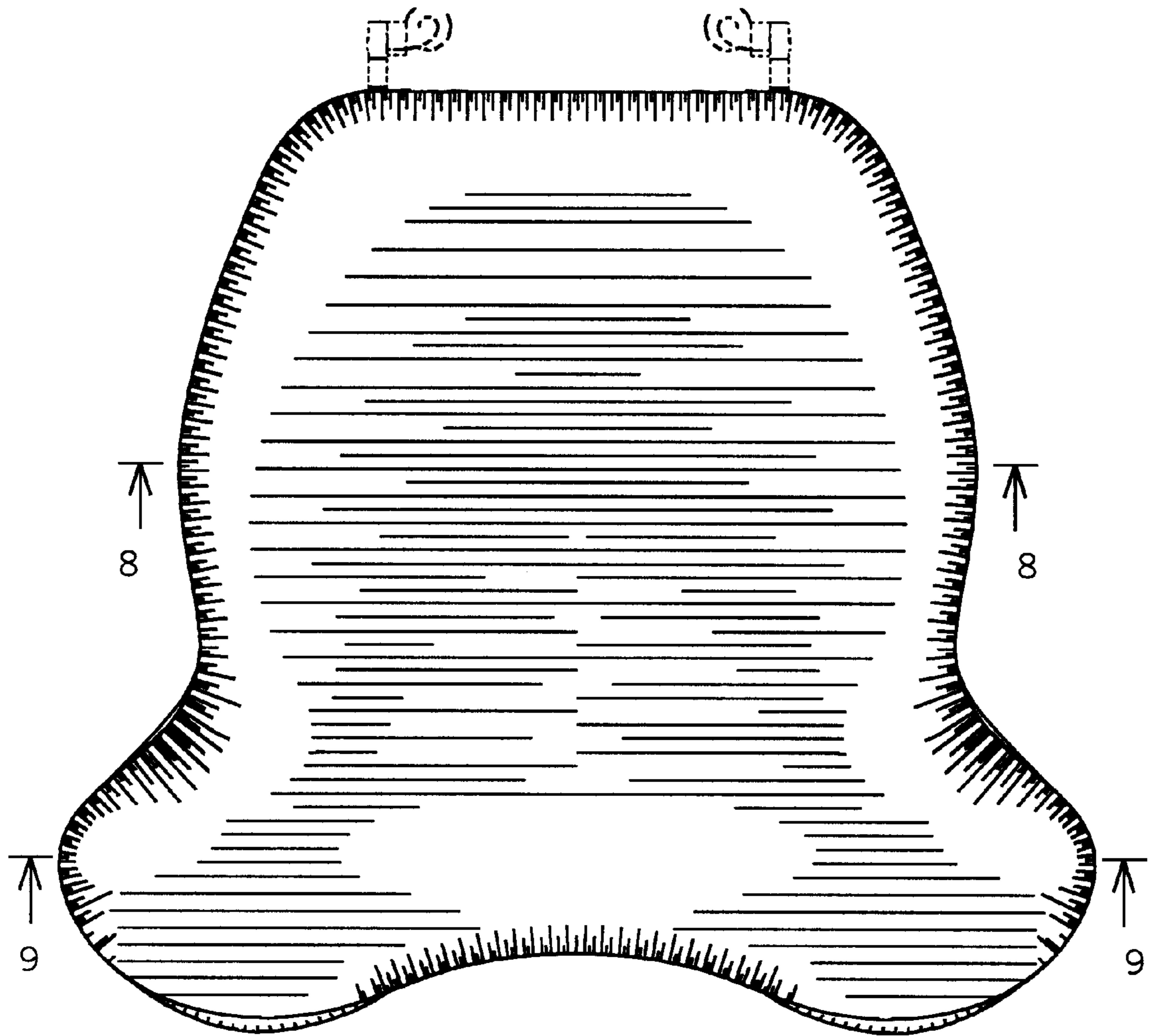

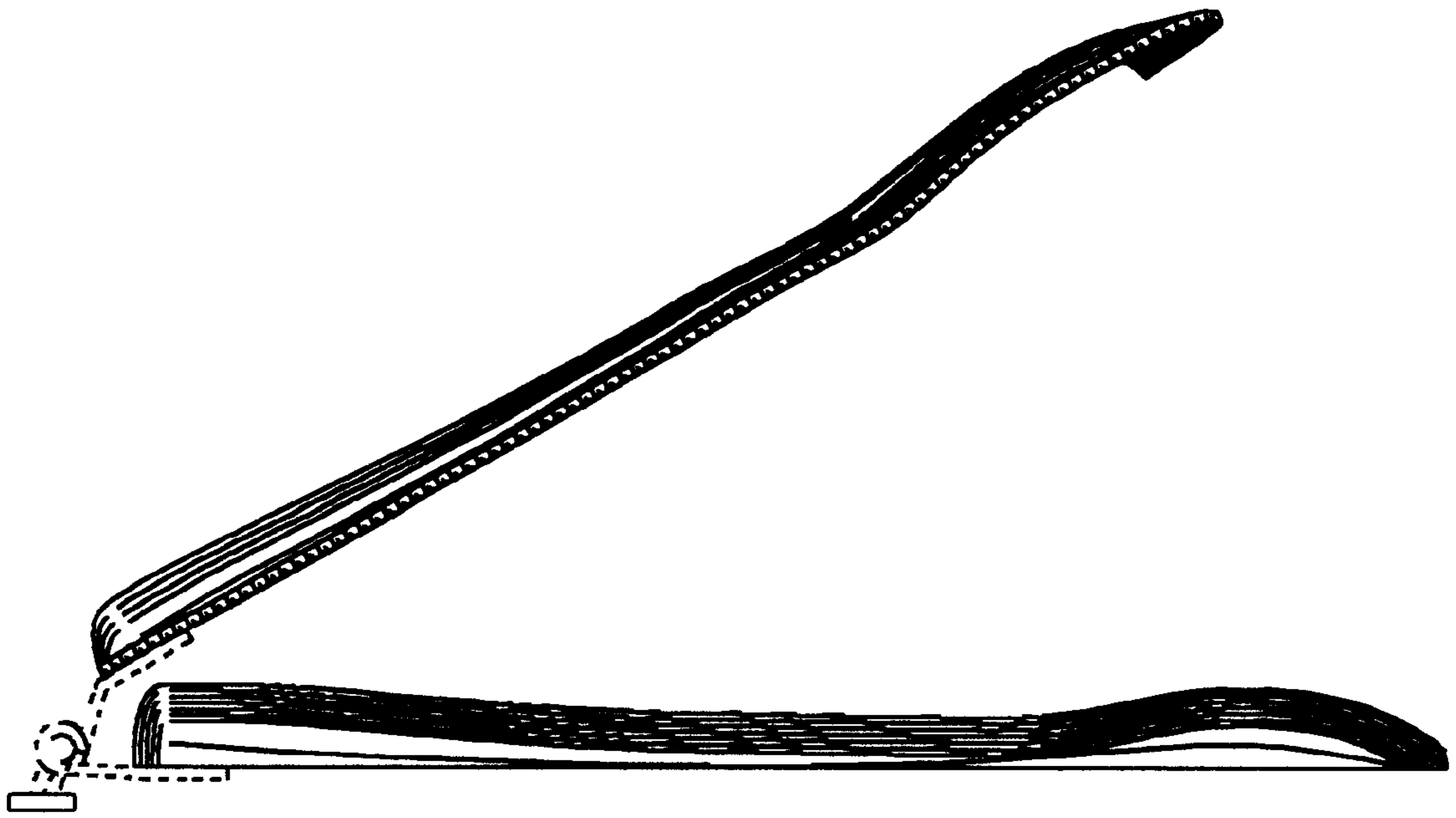

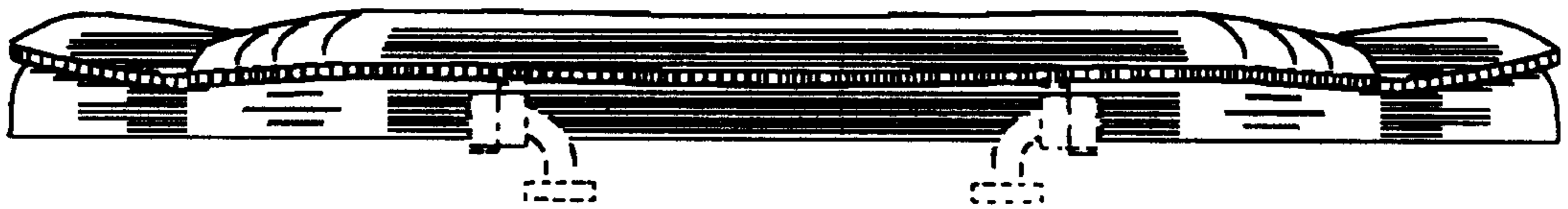

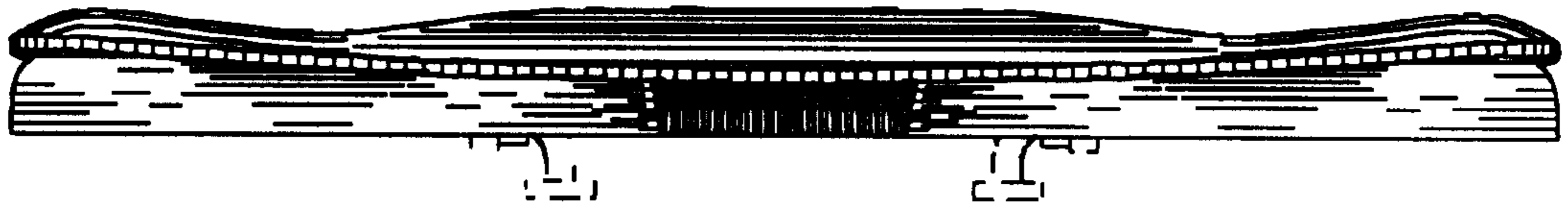
