(57) **CLAIM**

The ornamental design for the lamp support arm, as shown and described.

**DESCRIPTION**

FIG. 2 is a top plan view of the lamp support arm in accordance with my design;

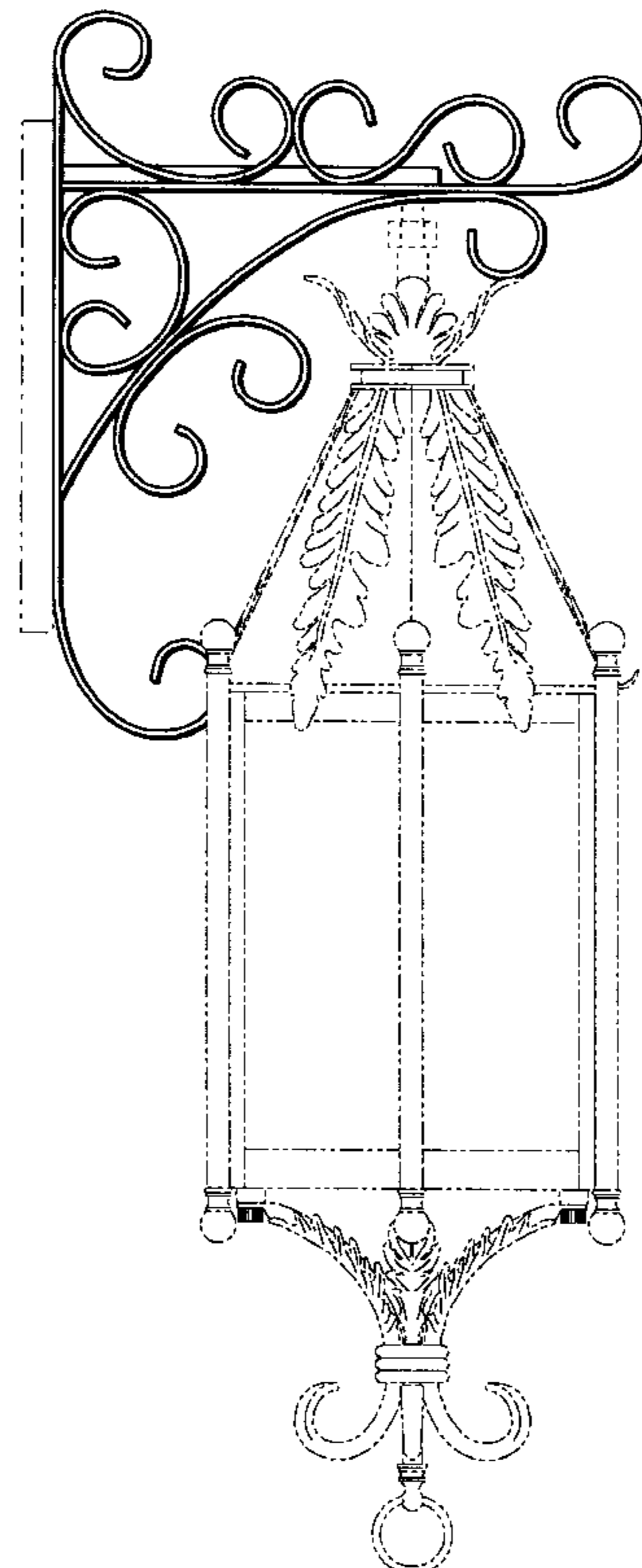
FIG. 3 is a side elevation view of the lamp support arm in accordance with my design;

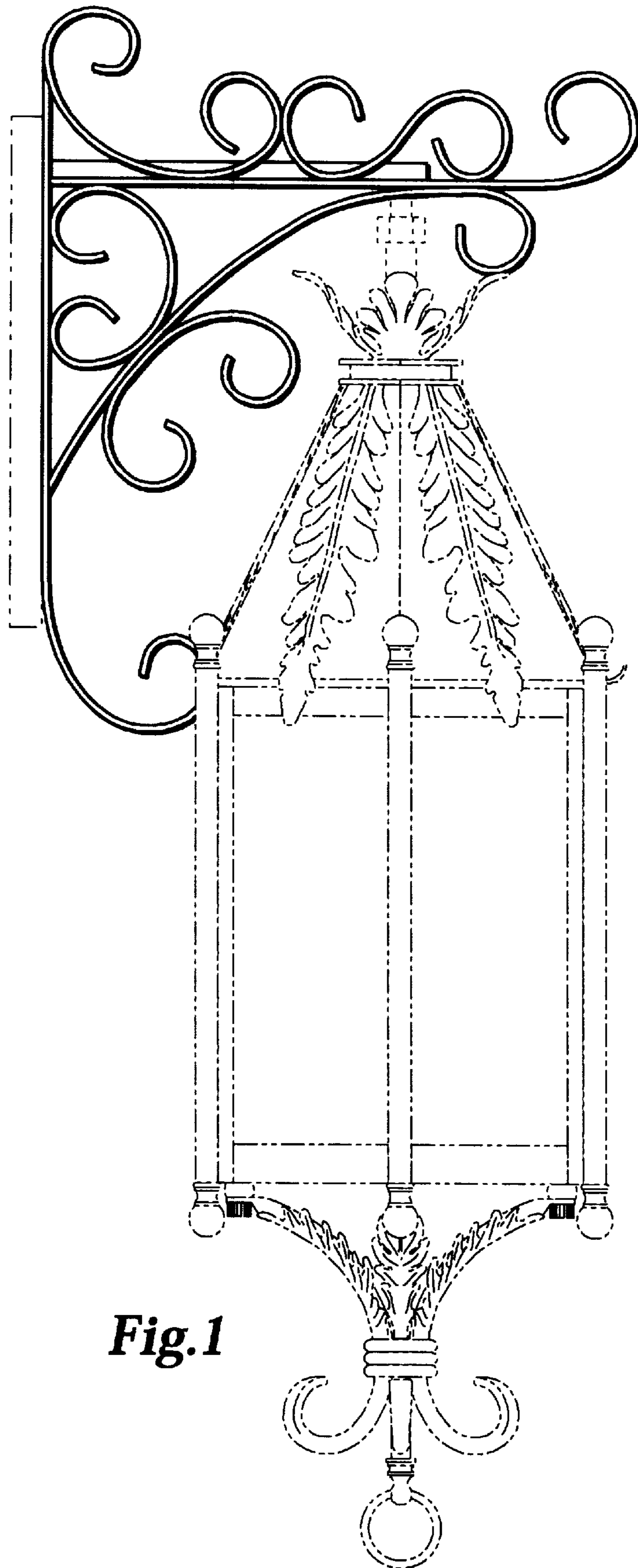
FIG. 4 is a front elevation view of the lamp support arm in accordance with my design; and,

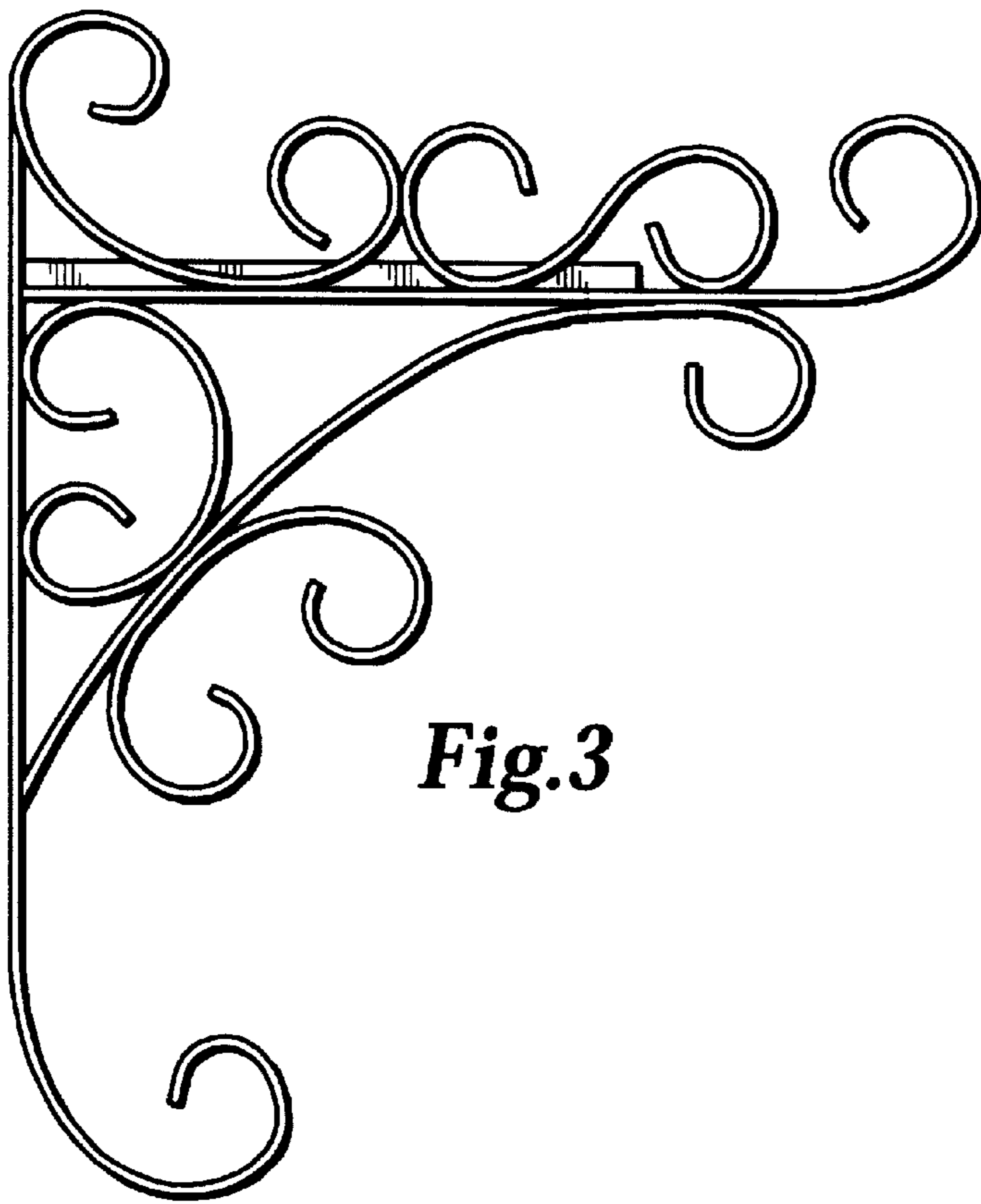

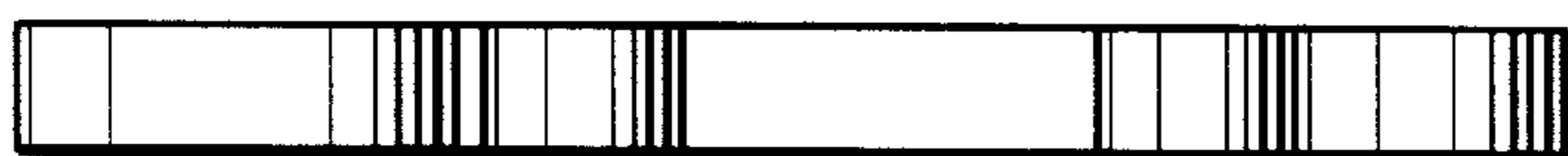
