continuous screw threading on the neck; and,

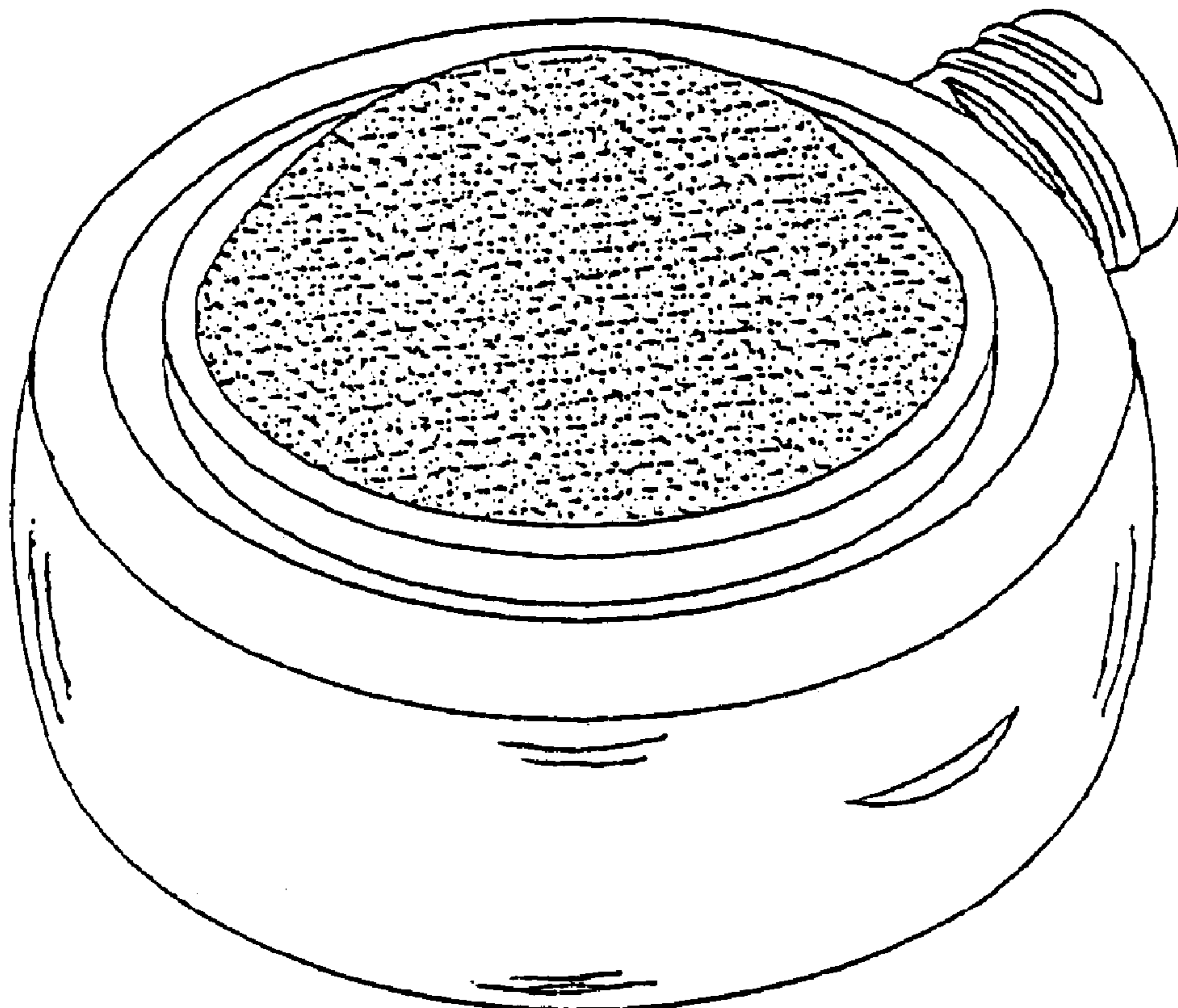
FIG. 7 illustrates a top plan view of the second embodiment,

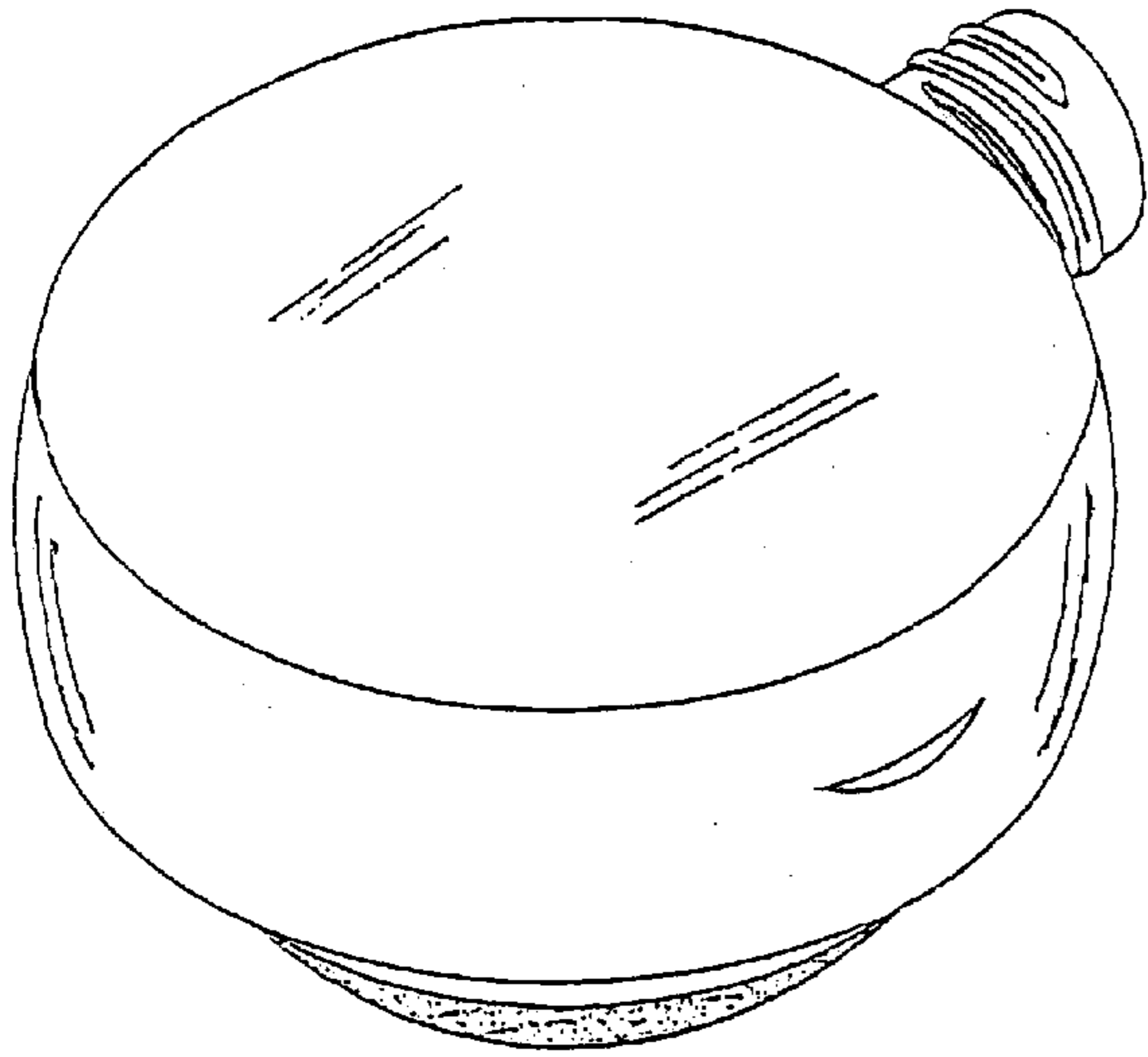

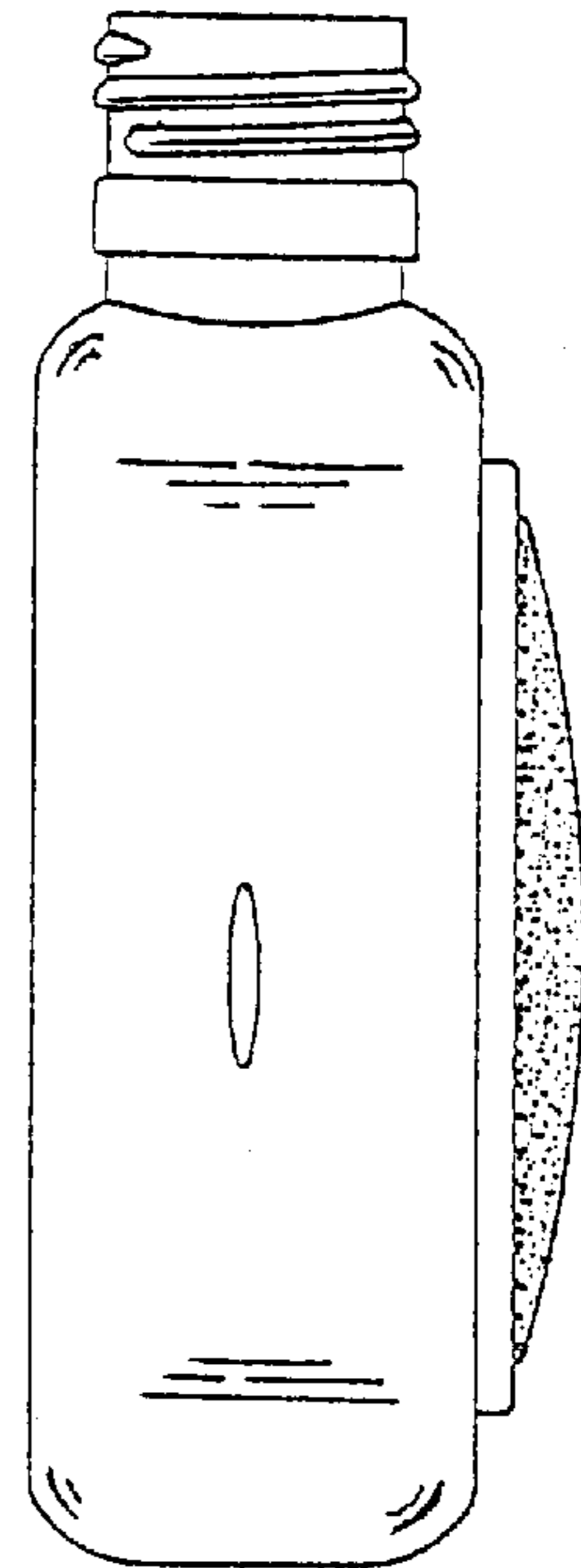

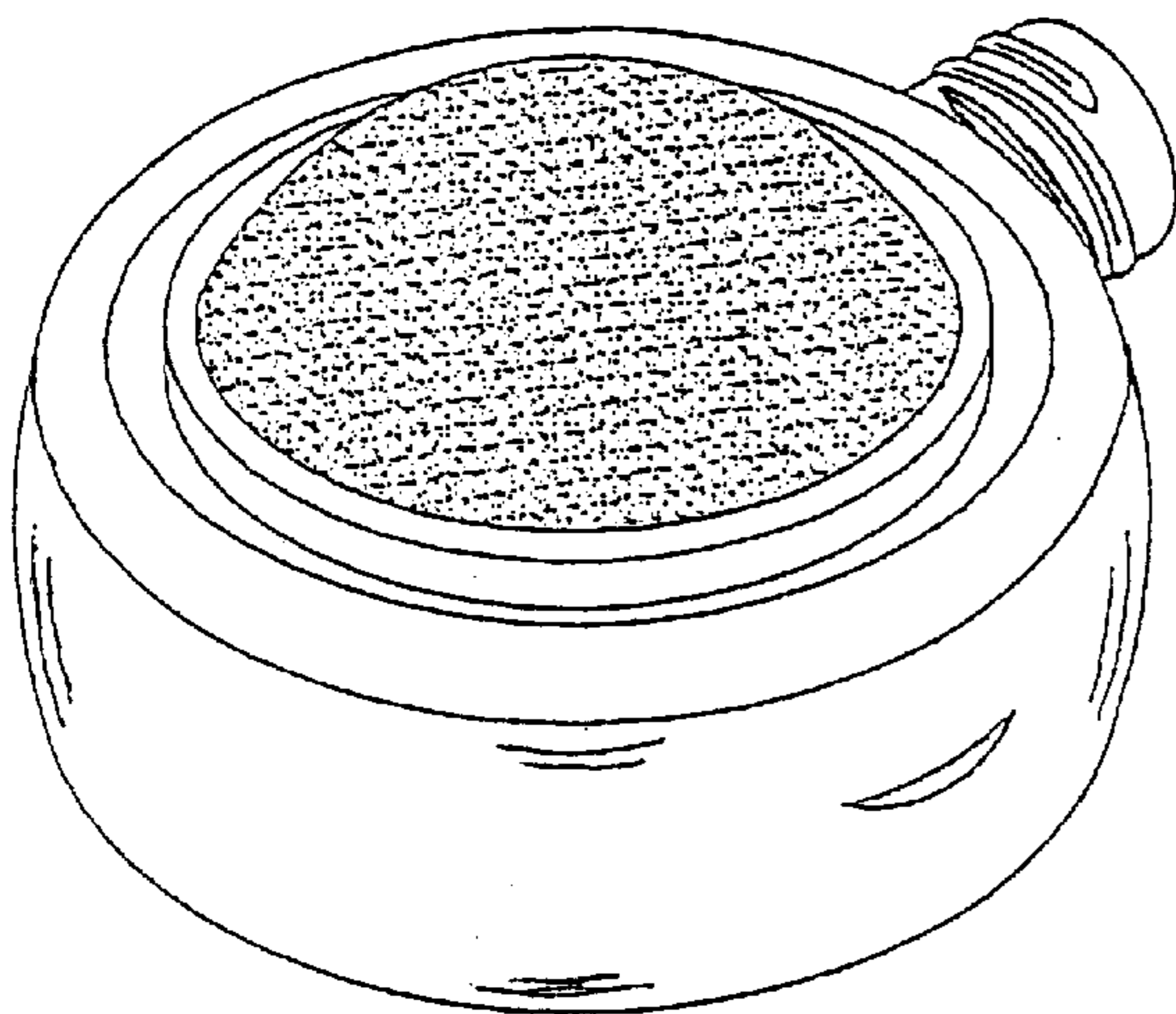
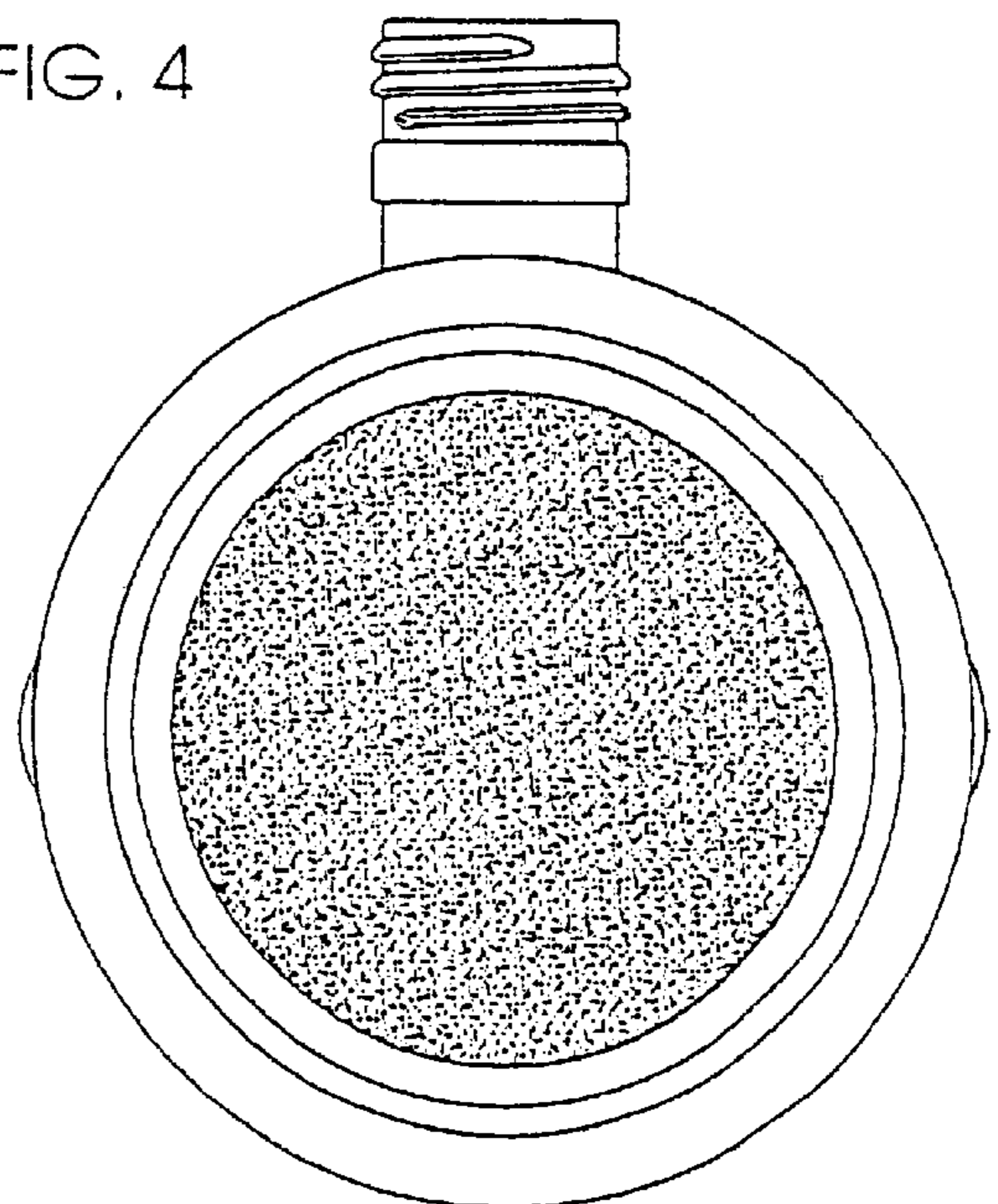

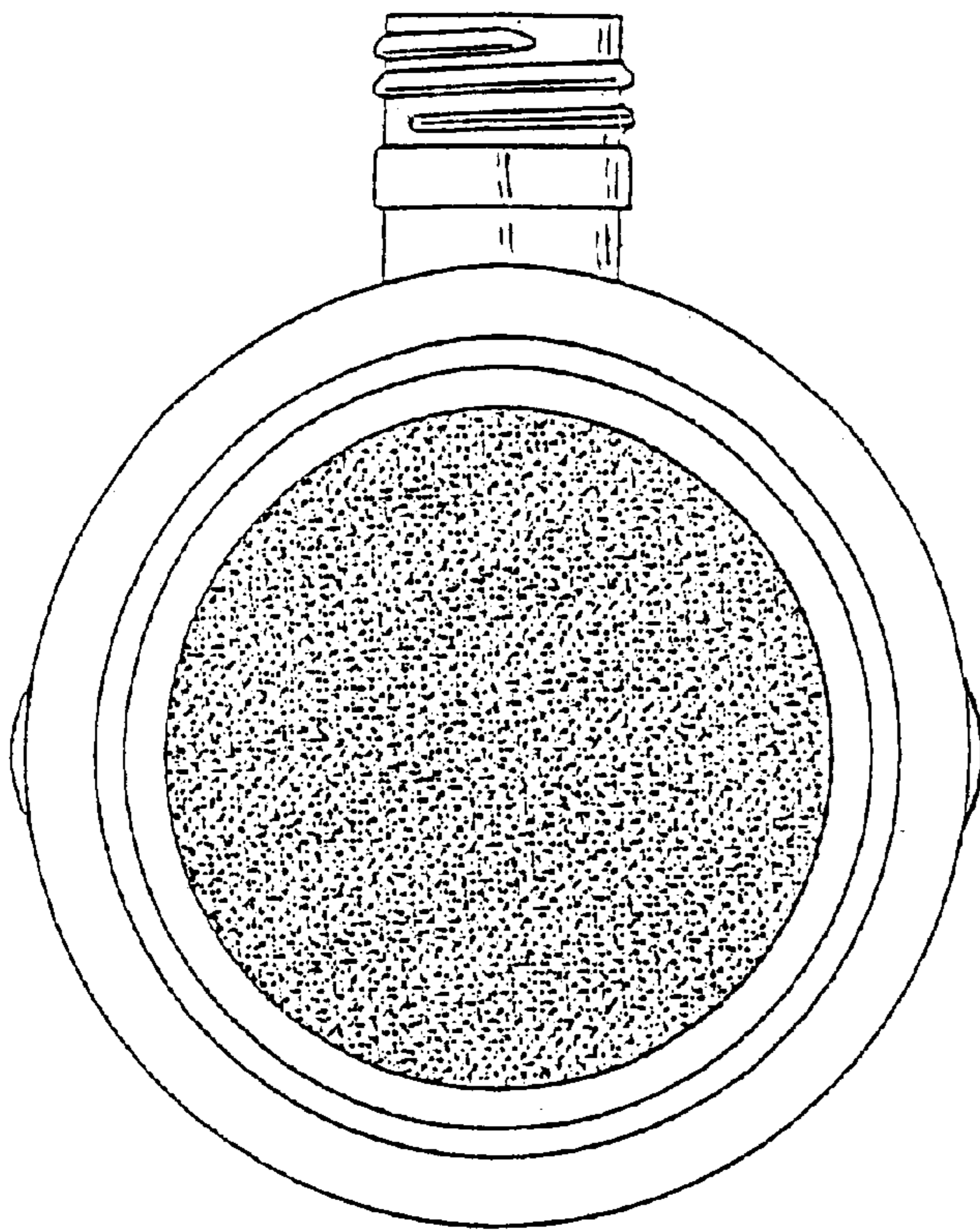

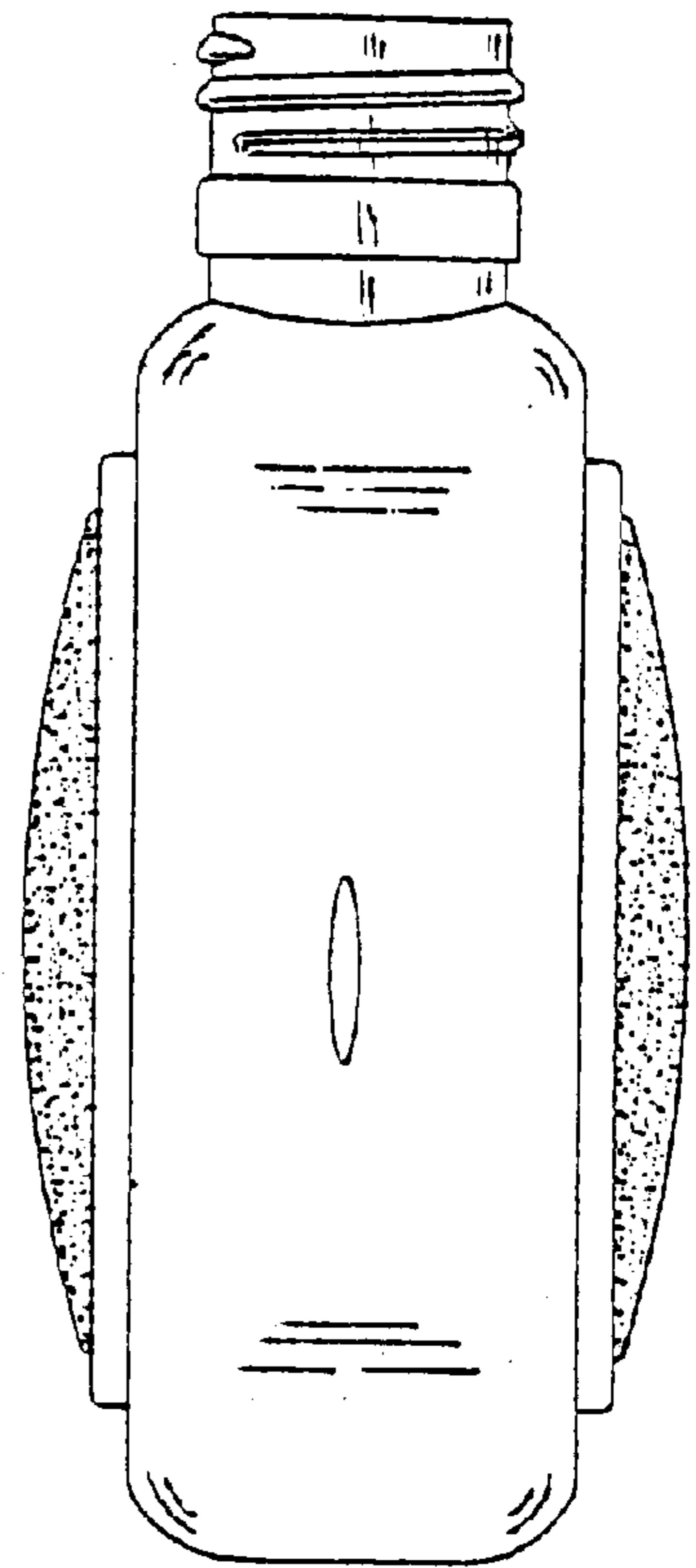

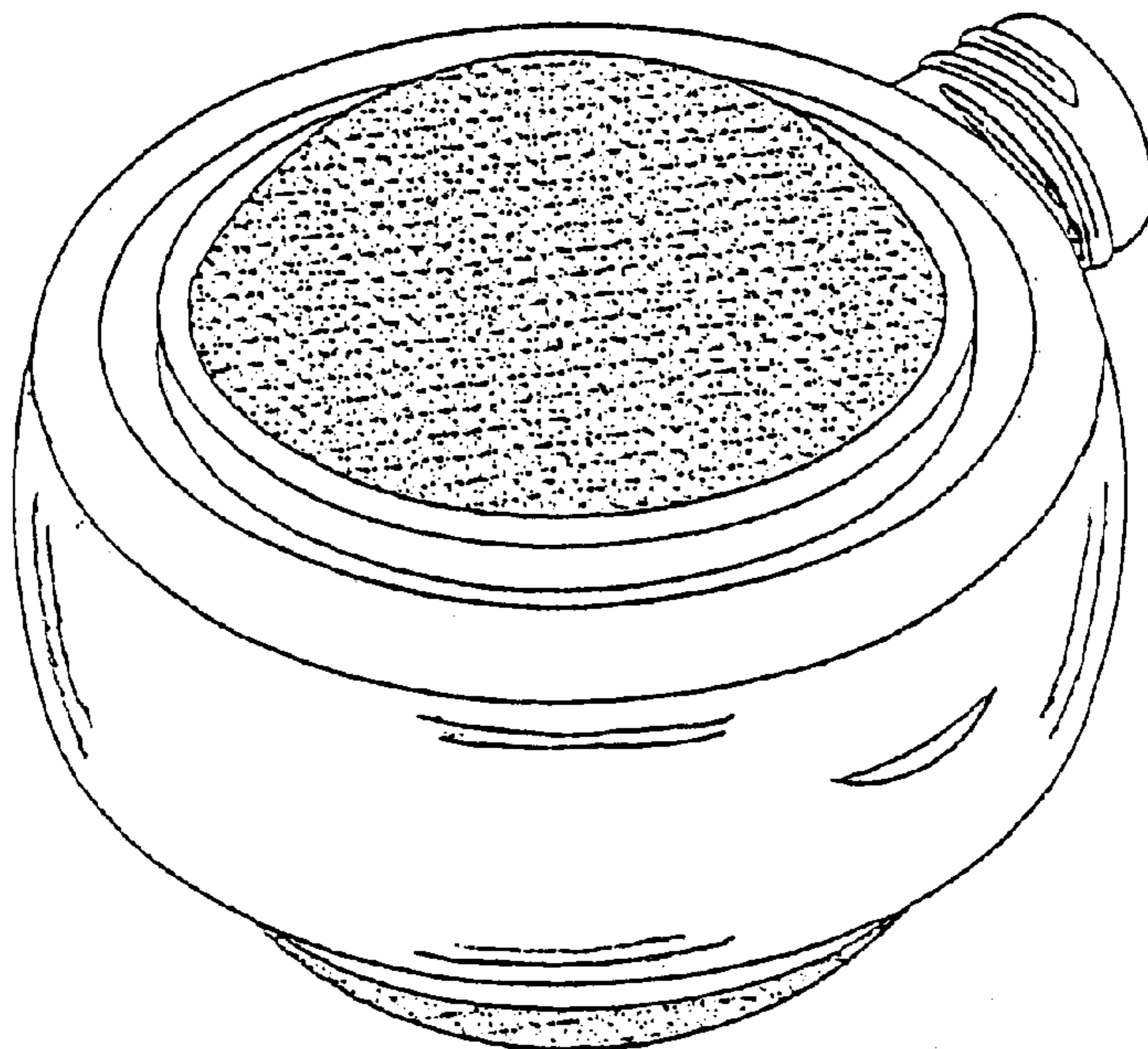
