(57) **CLAIM**

I claim the ornamental design for a ponytail flag, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of ponytail flag showing my new design, the undisclosed rear is not part of the claimed design;

FIG. 2 is a front elevational view of a second embodiment of a ponytail flag showing my new design, the undisclosed rear is not part of the claimed design;

FIG. 3 is a front elevational view of a third embodiment of a ponytail flag showing my new design, the undisclosed rear is not part of the claimed design;

FIG. 4 is a front elevational view of a fourth embodiment of a ponytail flag showing my new design, the undisclosed rear is not part of the claimed design;

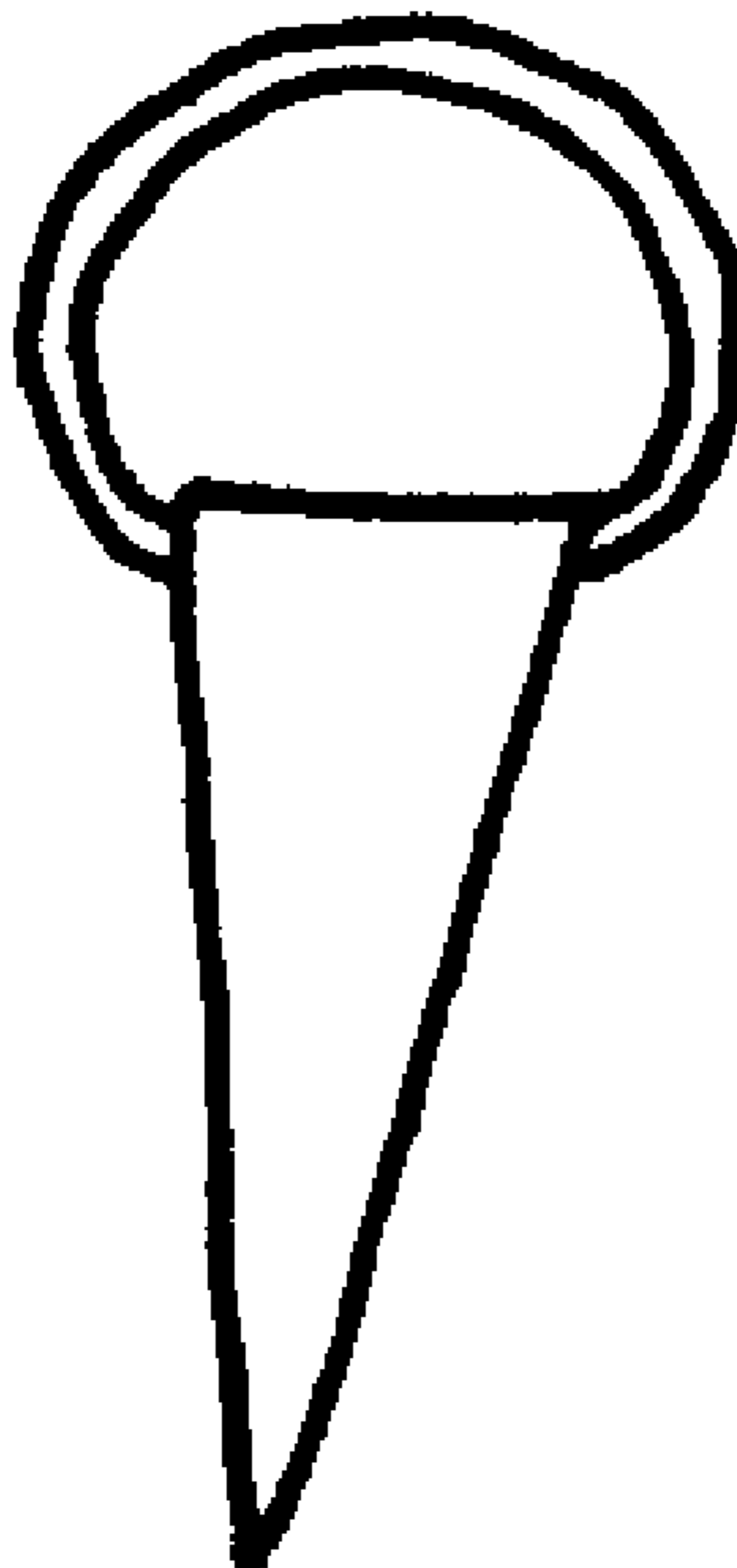
FIG. 5 is a front elevational view of a fifth embodiment of a ponytail flag showing my new design, the undisclosed rear is not part of the claimed design;

FIG. 6 is a front elevational view of a sixth embodiment of a ponytail flag showing my new design, the undisclosed rear is not part of the claimed design; and,

FIG. 7 is a front elevational view of a second embodiment of a ponytail flag shown worn on a wearer's ponytail. The undisclosed rear of the ponytail flag is not part of the claimed design.

The broken line showing of the human form in FIG. 7 is for illustrative purposes only and forms no part of the claimed design.

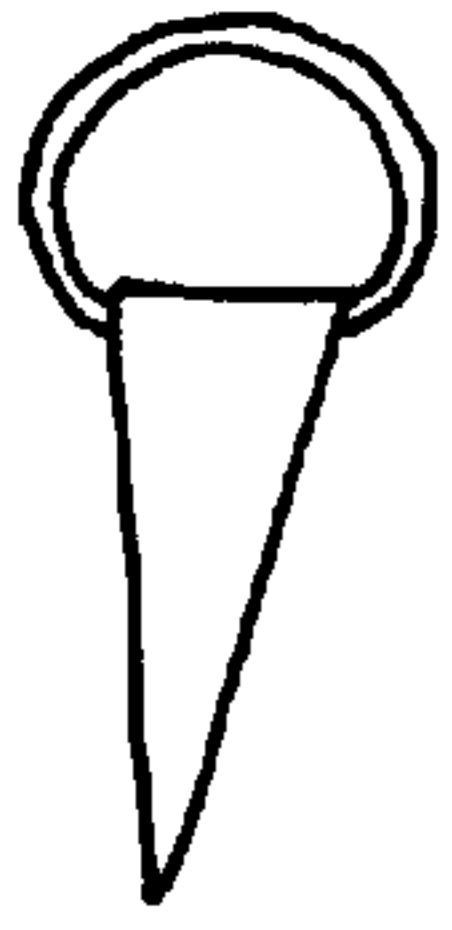

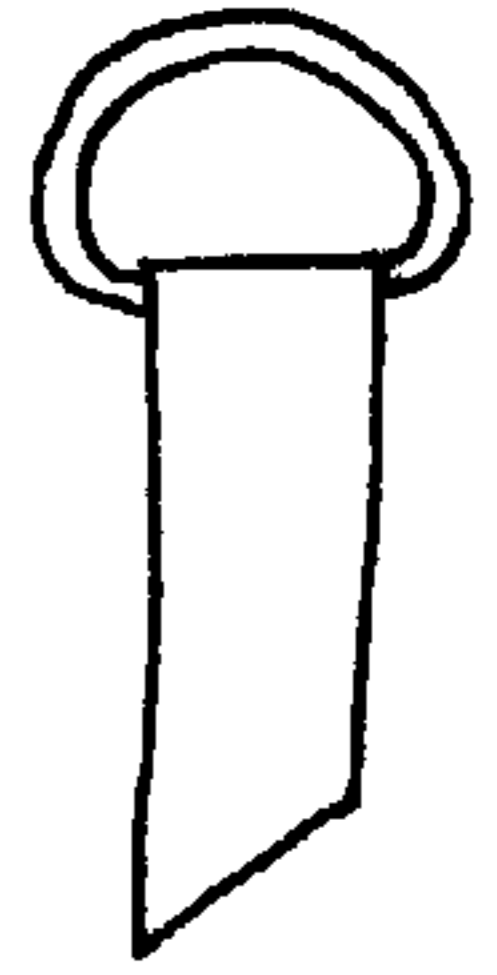

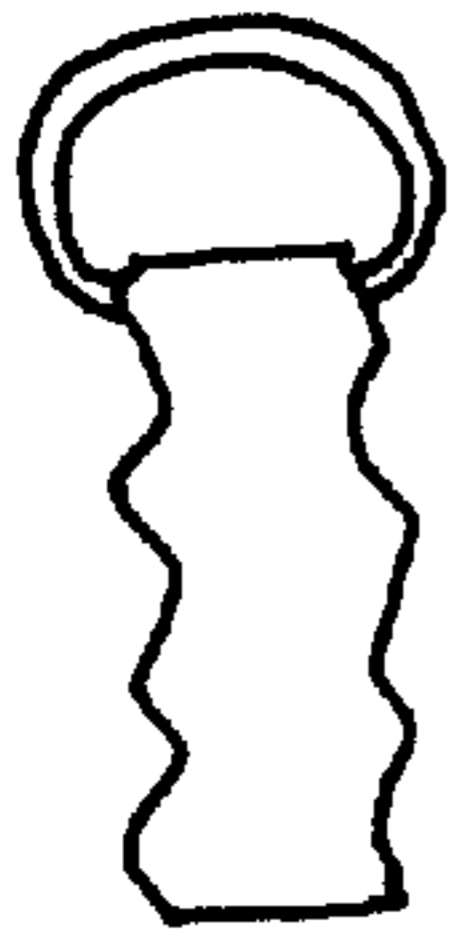

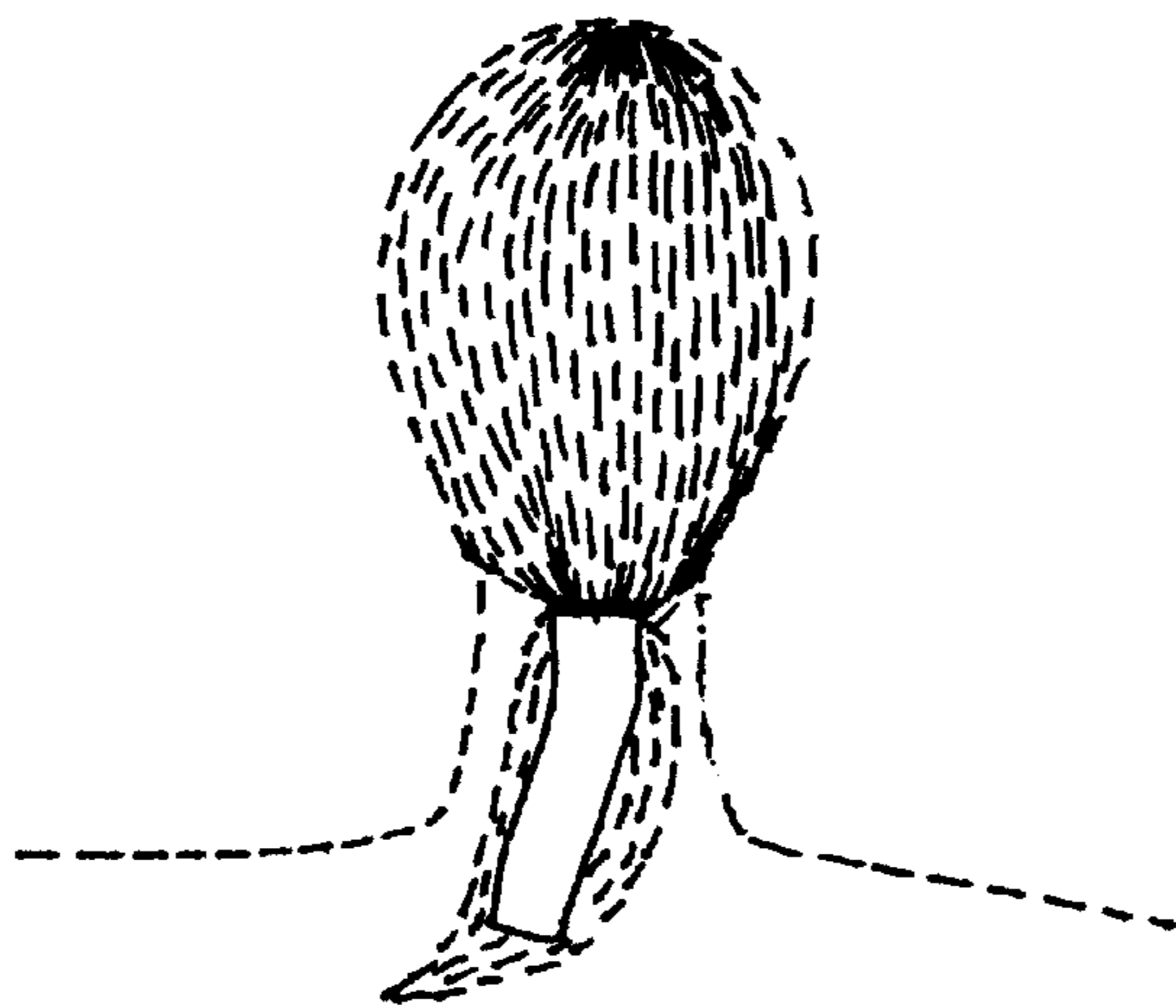
