(57) **CLAIM**

The ornamental design for a portion of a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a glove showing my new design;

FIG. 2 is a top plan view of the portion of a glove shown in FIG. 1;

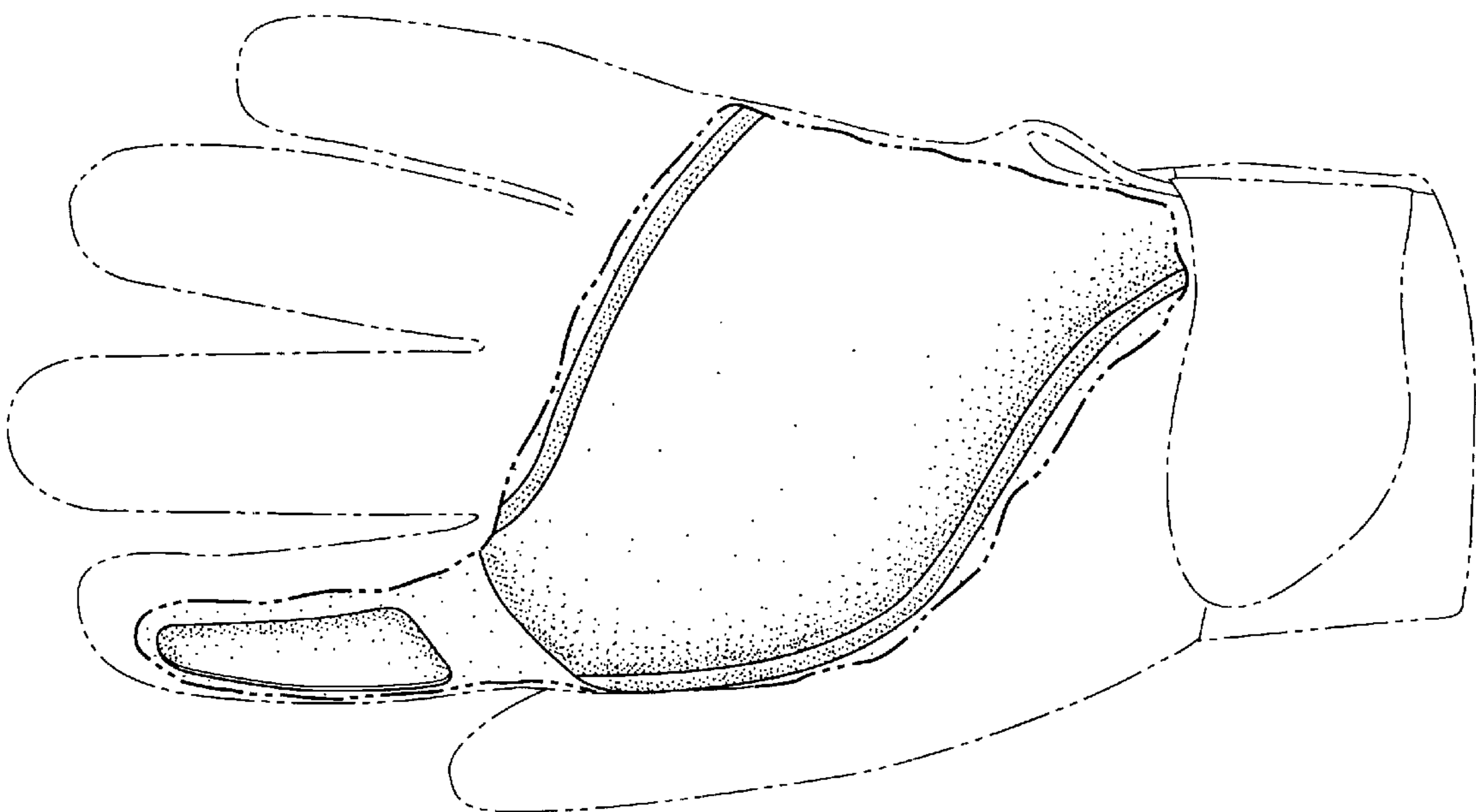
FIG. 3 is a side view of the portion of a glove shown in FIG. 1;

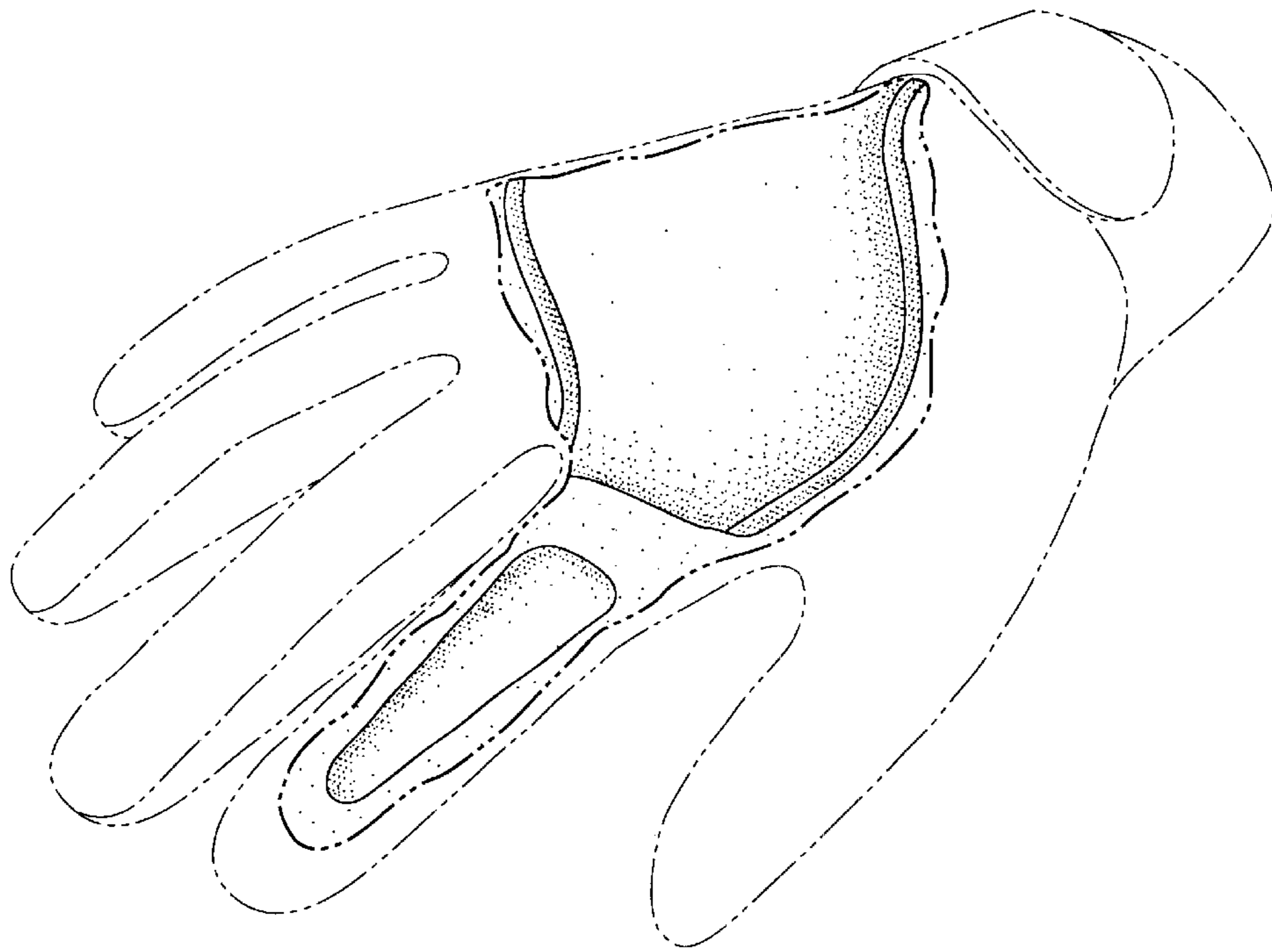
FIG. 4 is another side view of the portion of a glove shown in FIG. 1; and,

FIG. 5 is a front view of the portion of a glove shown in FIG. 1.

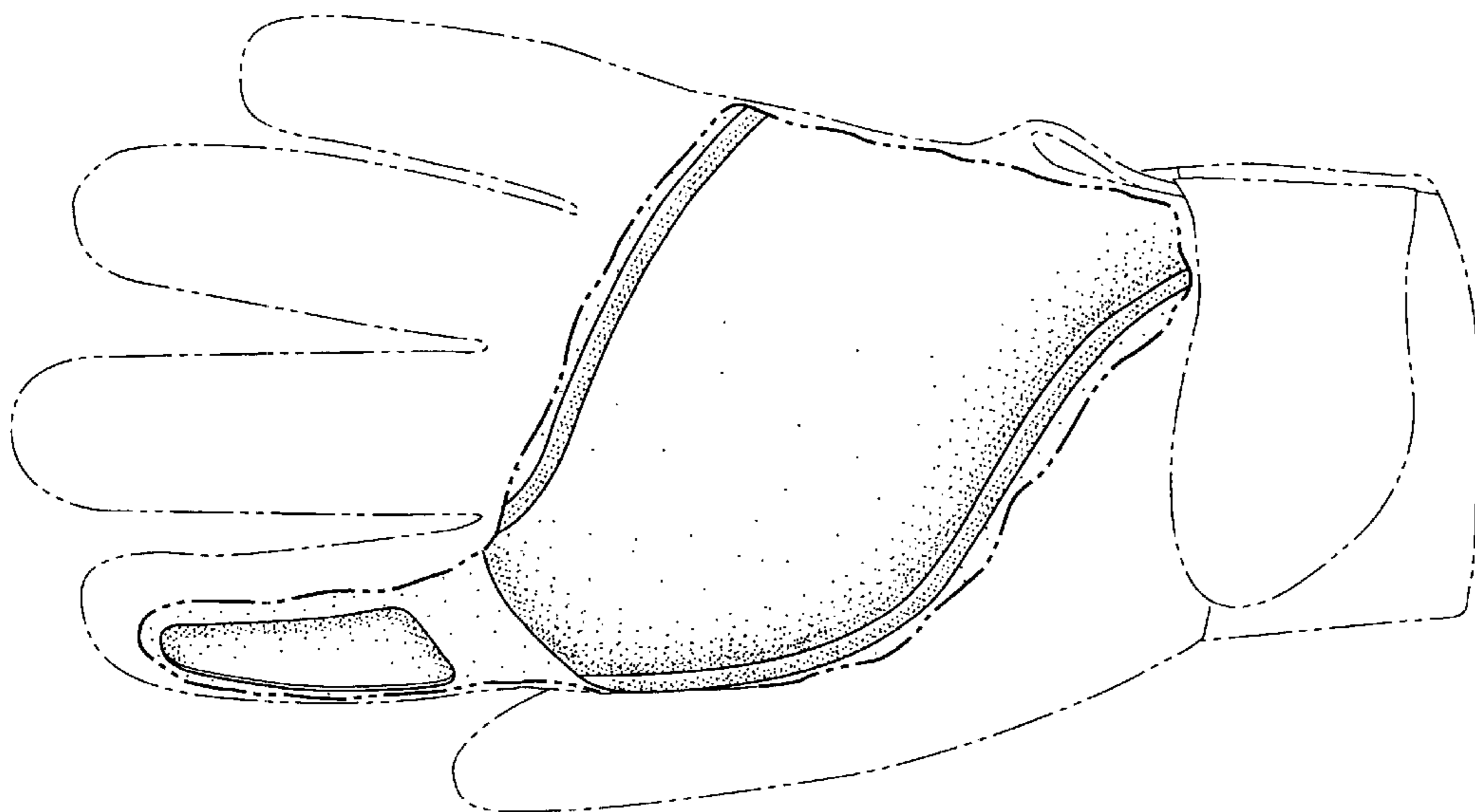

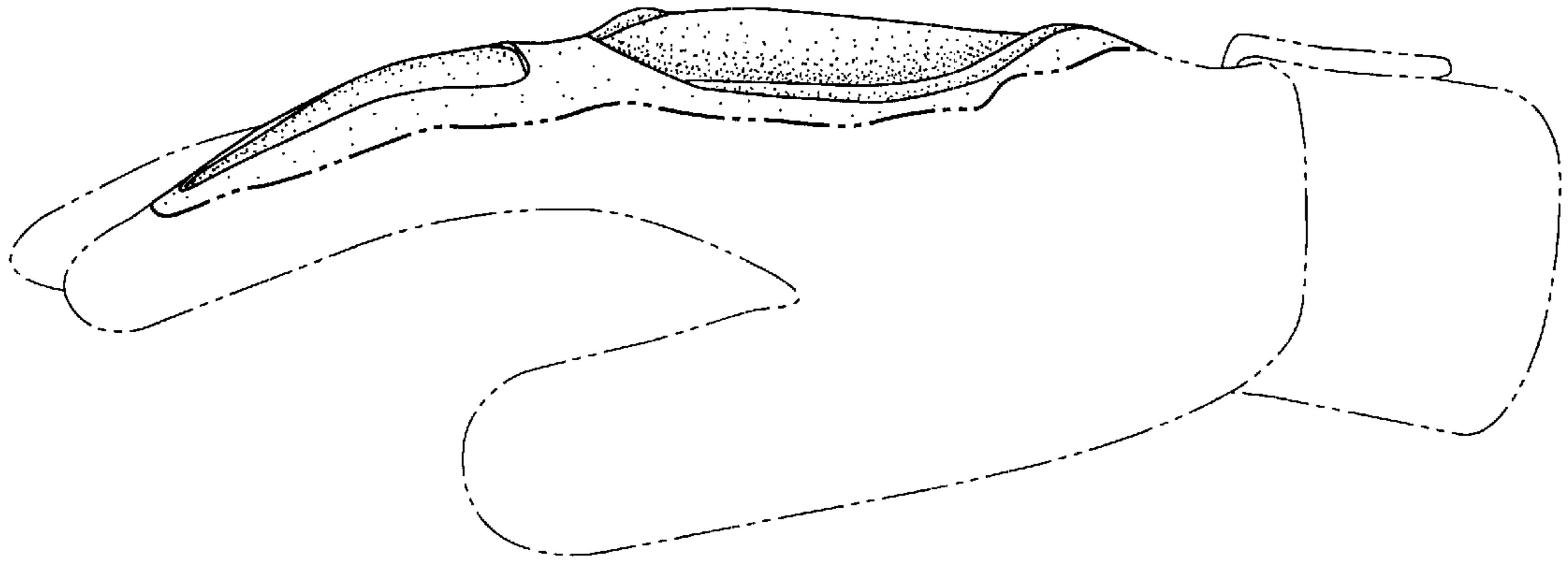




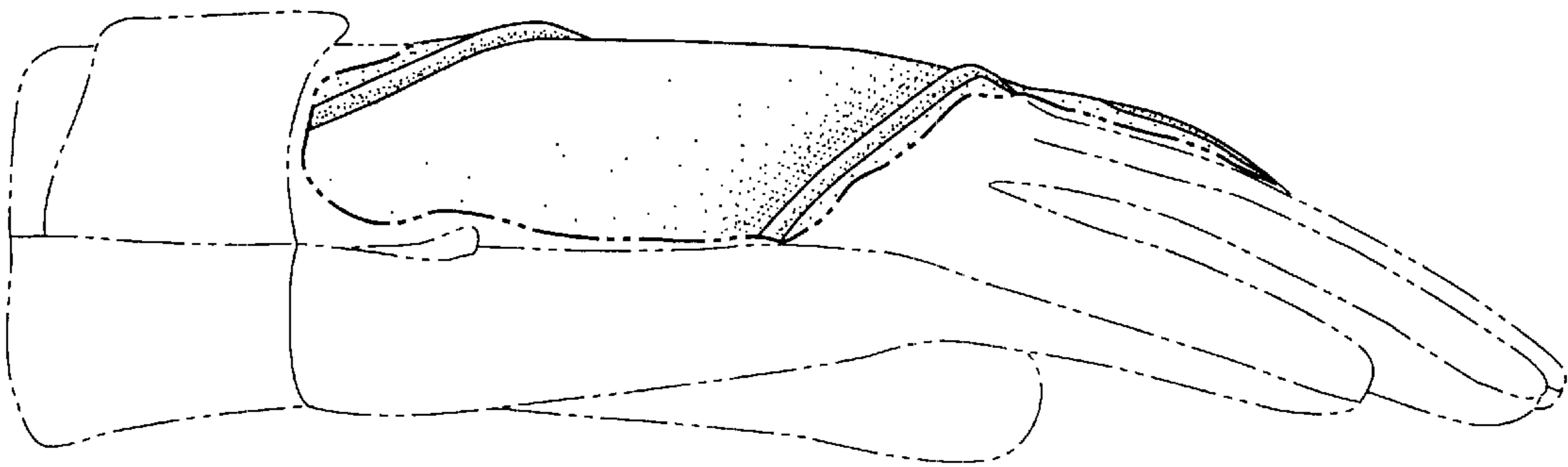

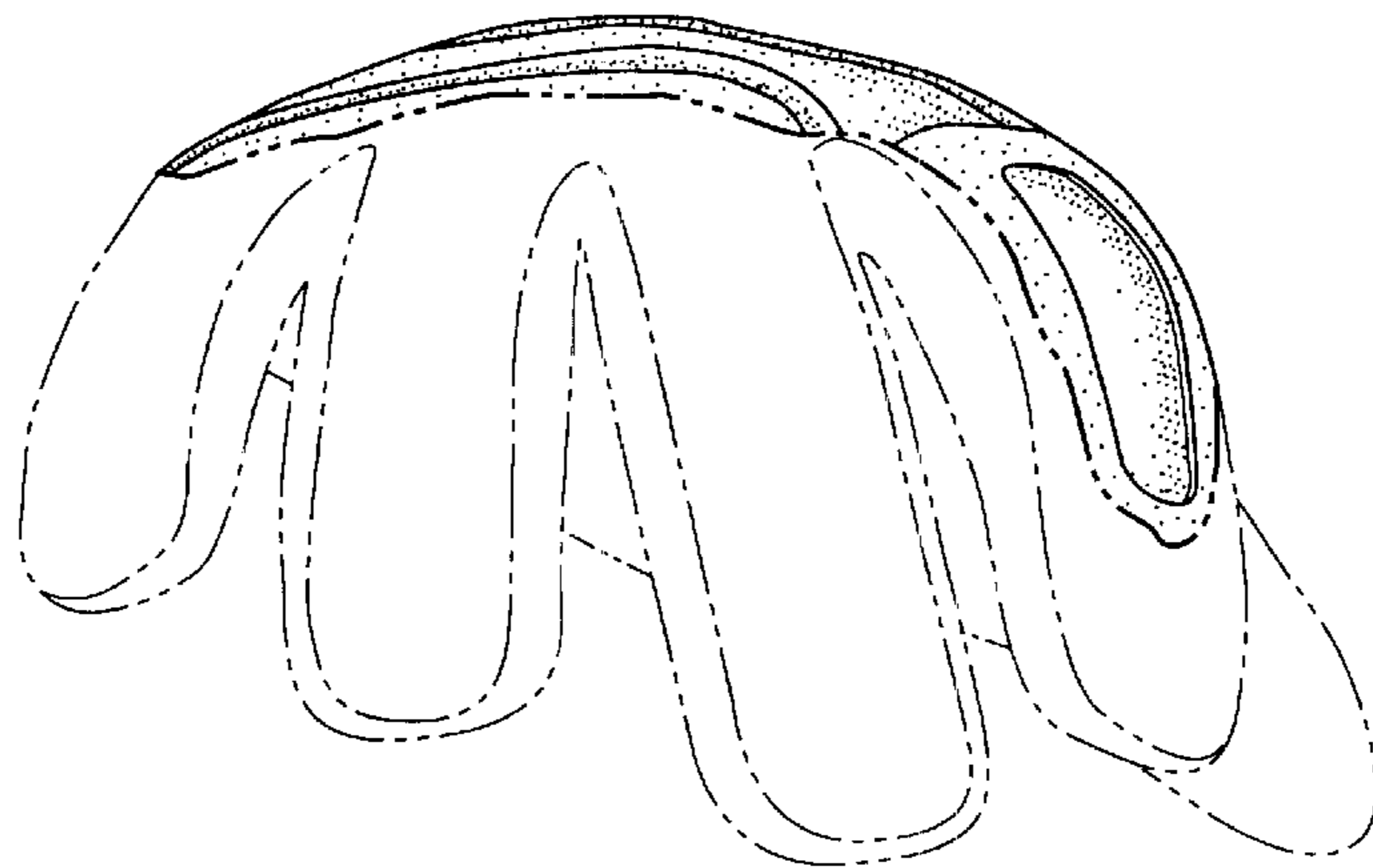
