(57) **CLAIM**

The design for men's underwear/inner liner for athletic shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front view of men's underwear embodying my new design;

FIG. 2 is a right side view thereof, the left side being a mirror image of the right side view;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front view of the men's inner liner for athletic shorts embodiment of my new design; and,

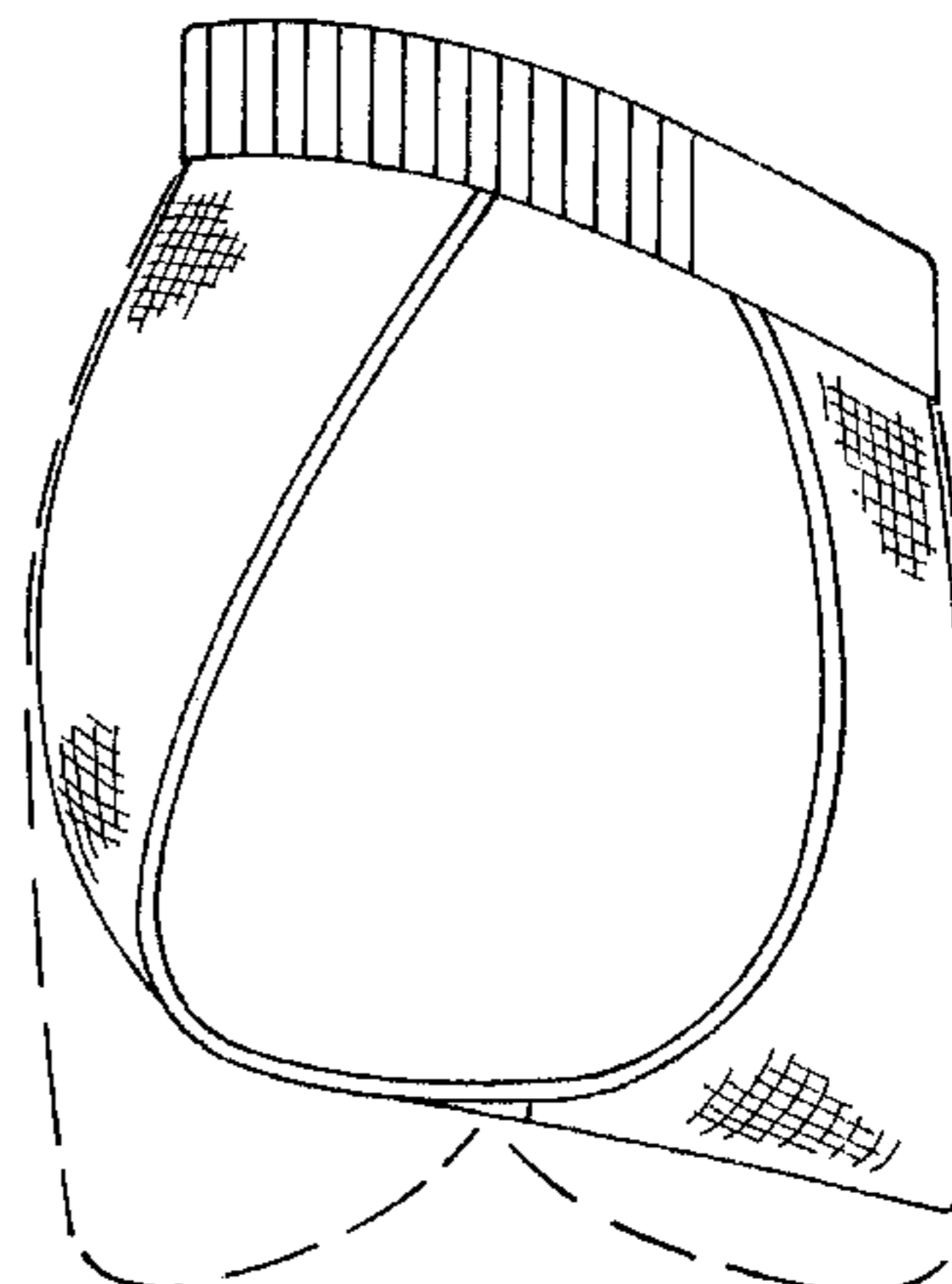
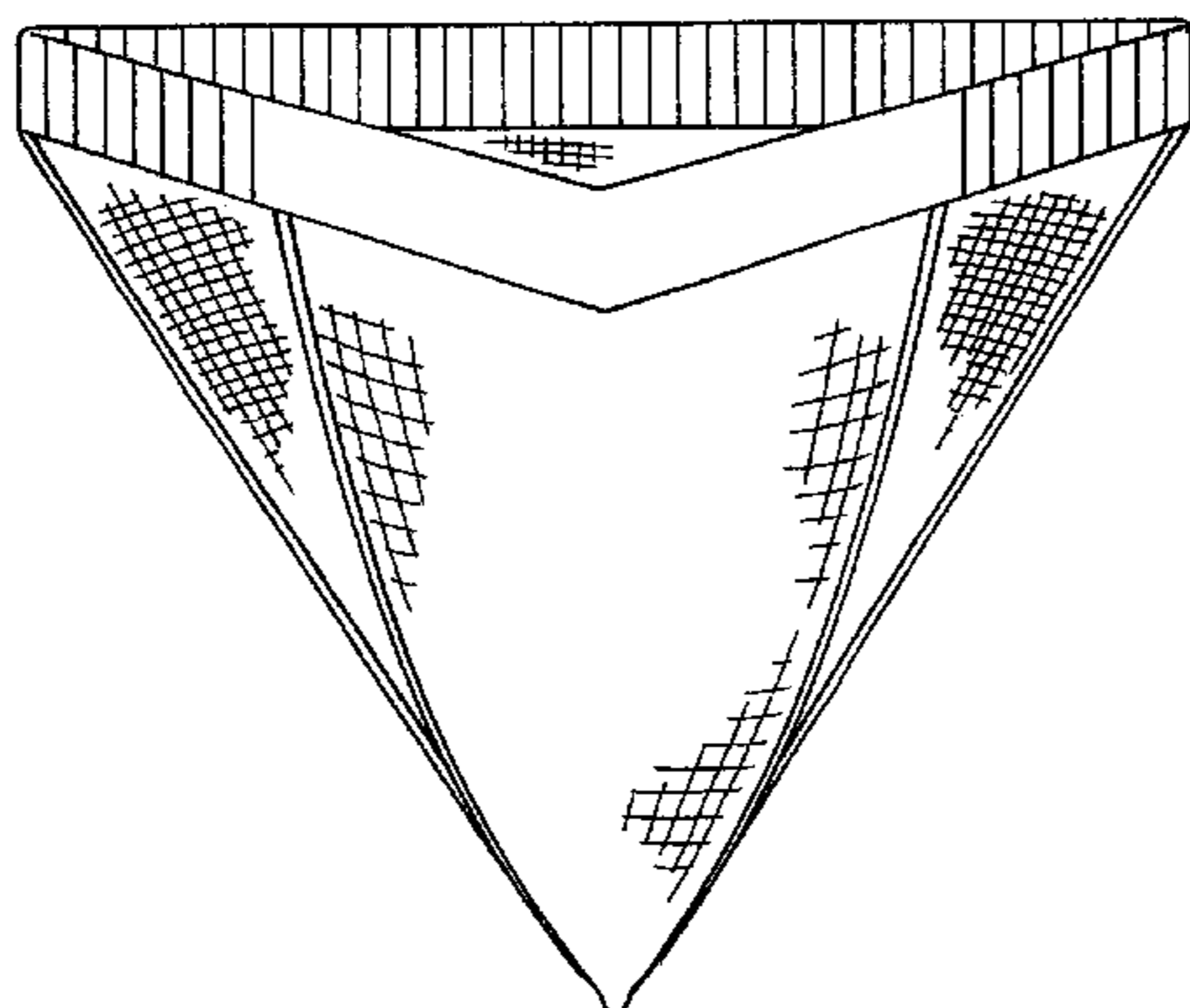
FIG. 7 is a right side view of the men's inner liner for athletic shorts embodiment shown in FIG. 6, the left side being a mirror image of the right side view.

The broken lines showing of exterior environmental structure of the athletic shorts shown in FIGS. 6 and 7 of the drawing views form no part of the claimed design.

The crosshatch shading shown in the drawings is to indicate fabric.

The area of the waistband including vertical lines indicates the inclusion of elastic material, and the area of the waistband devoid of vertical lines indicates the inclusion of non-elastic material.

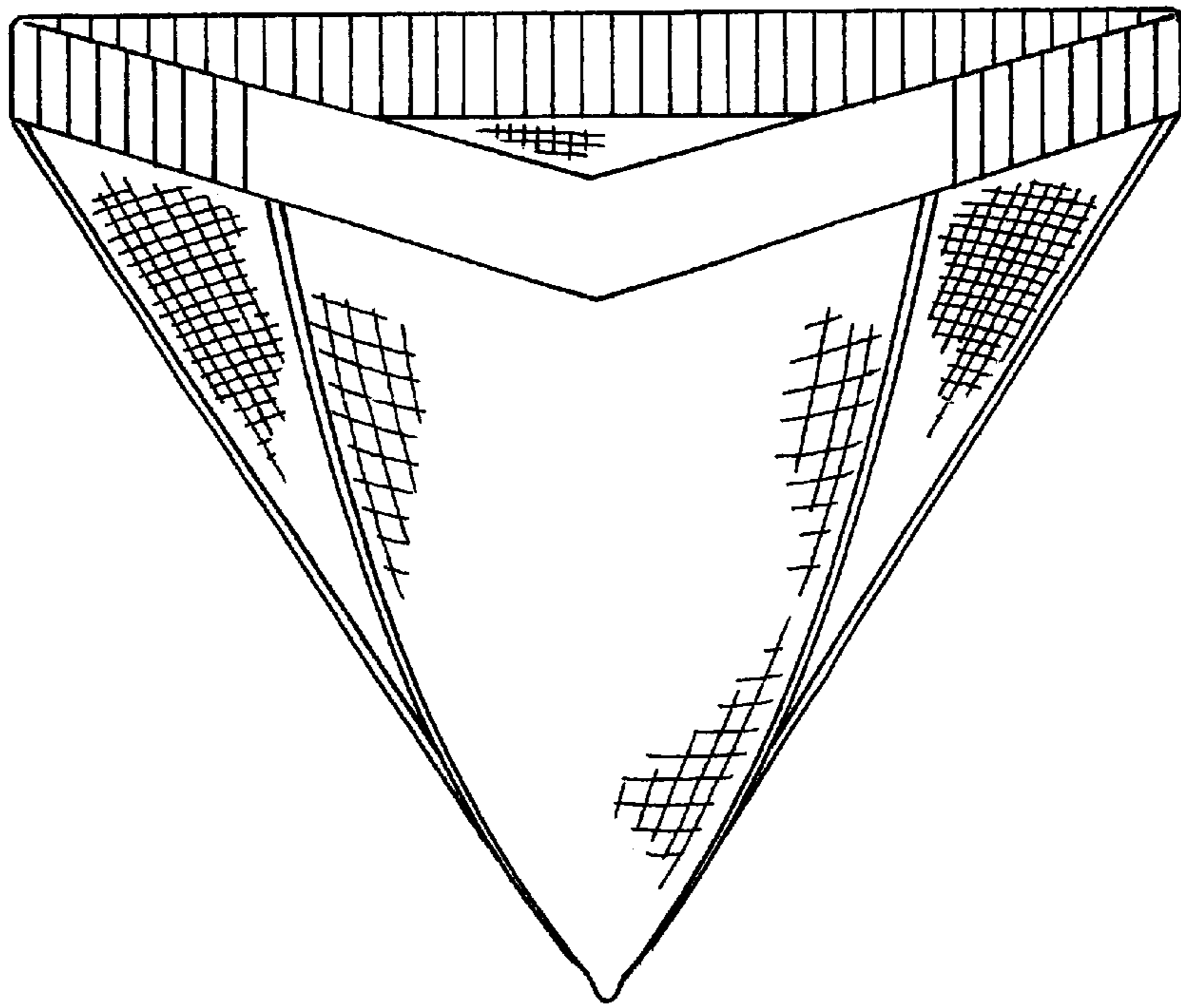

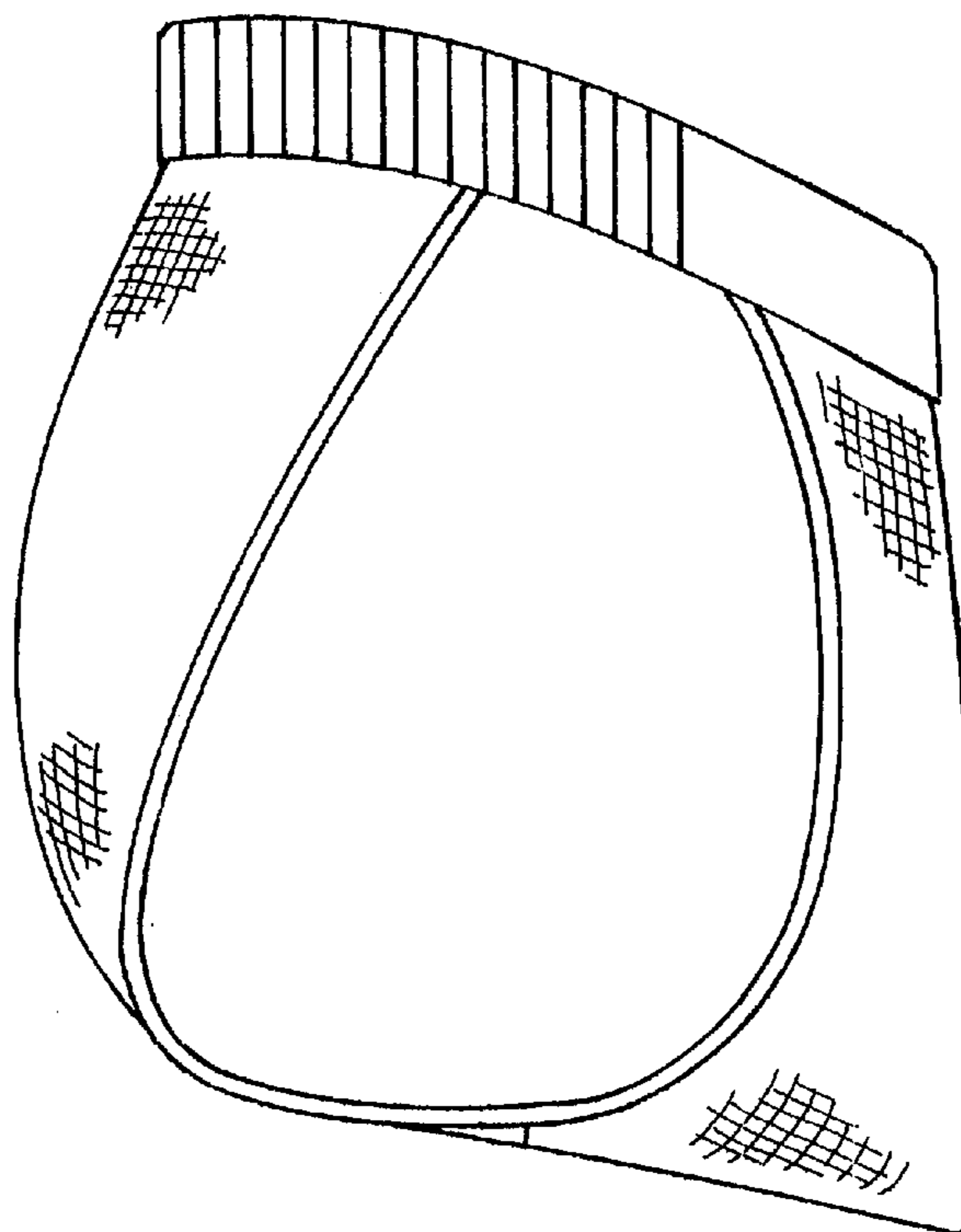

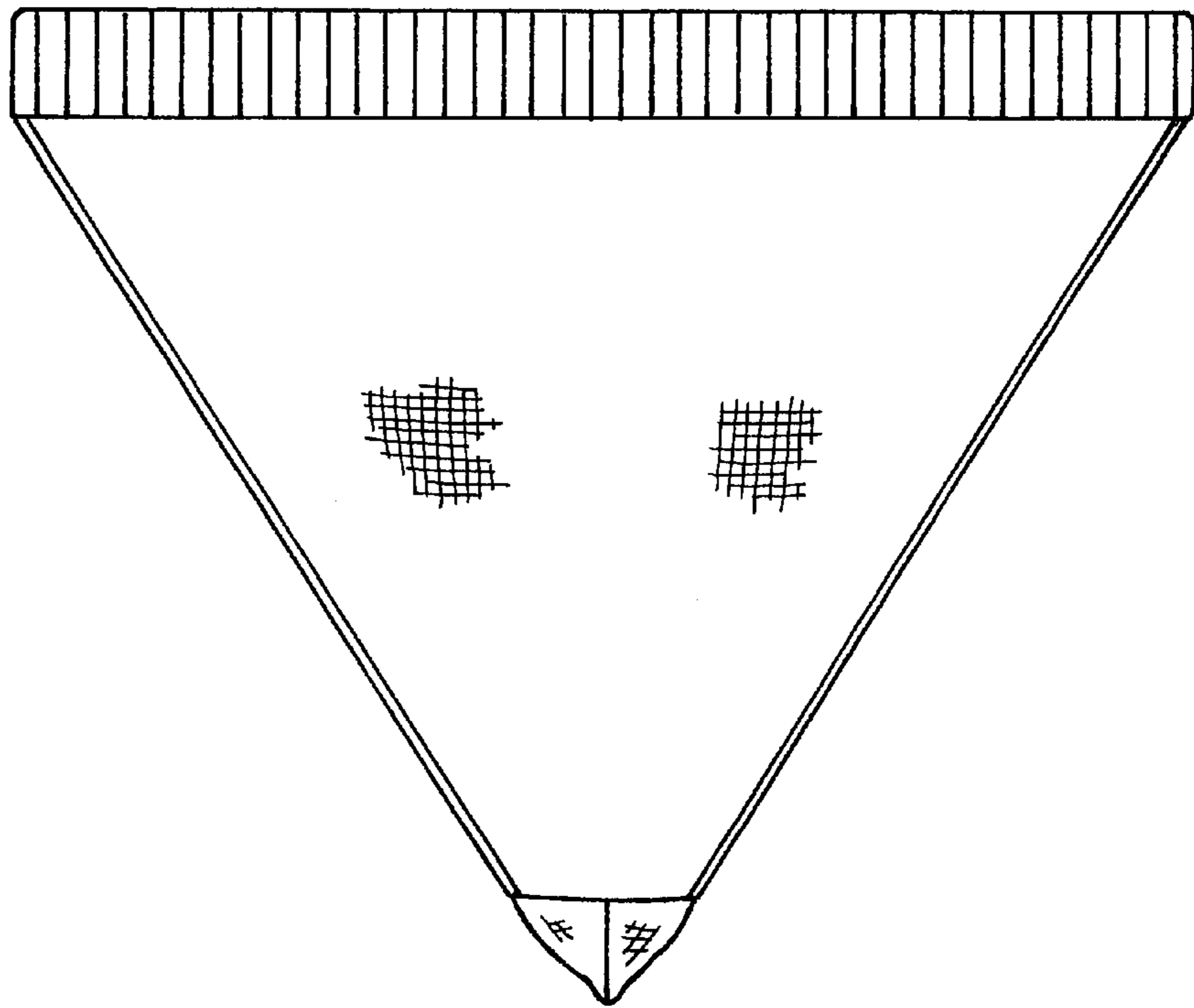

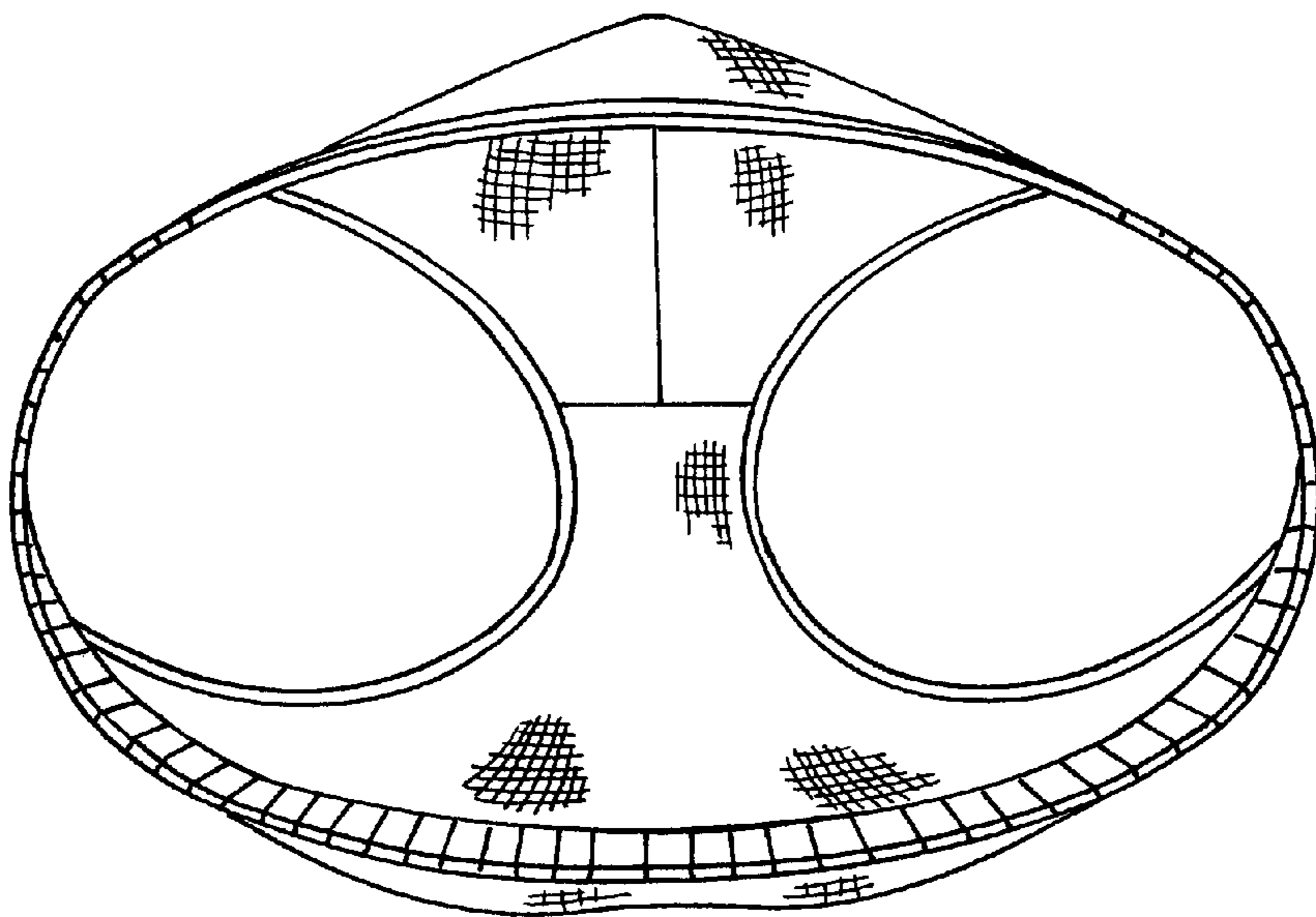

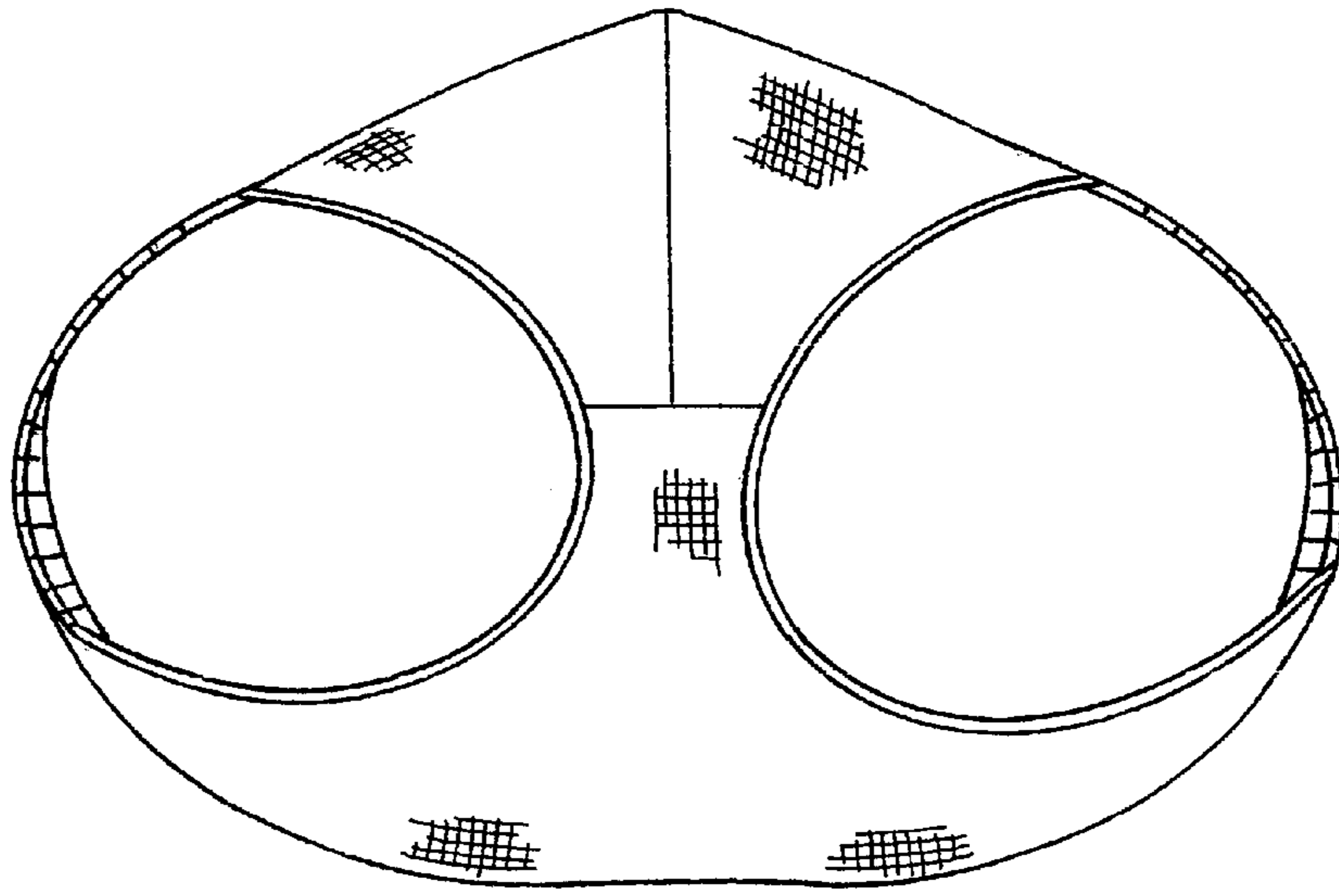

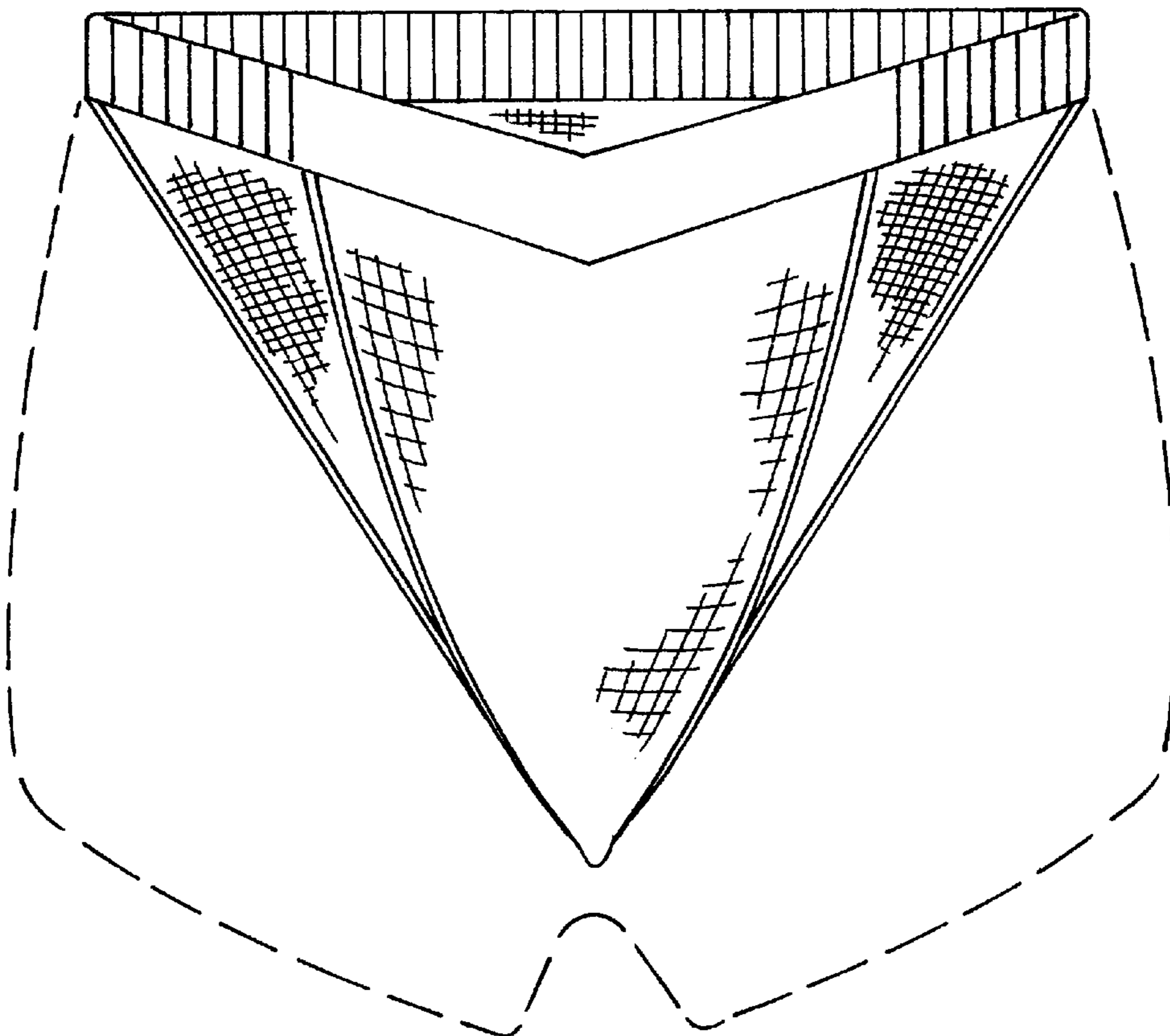
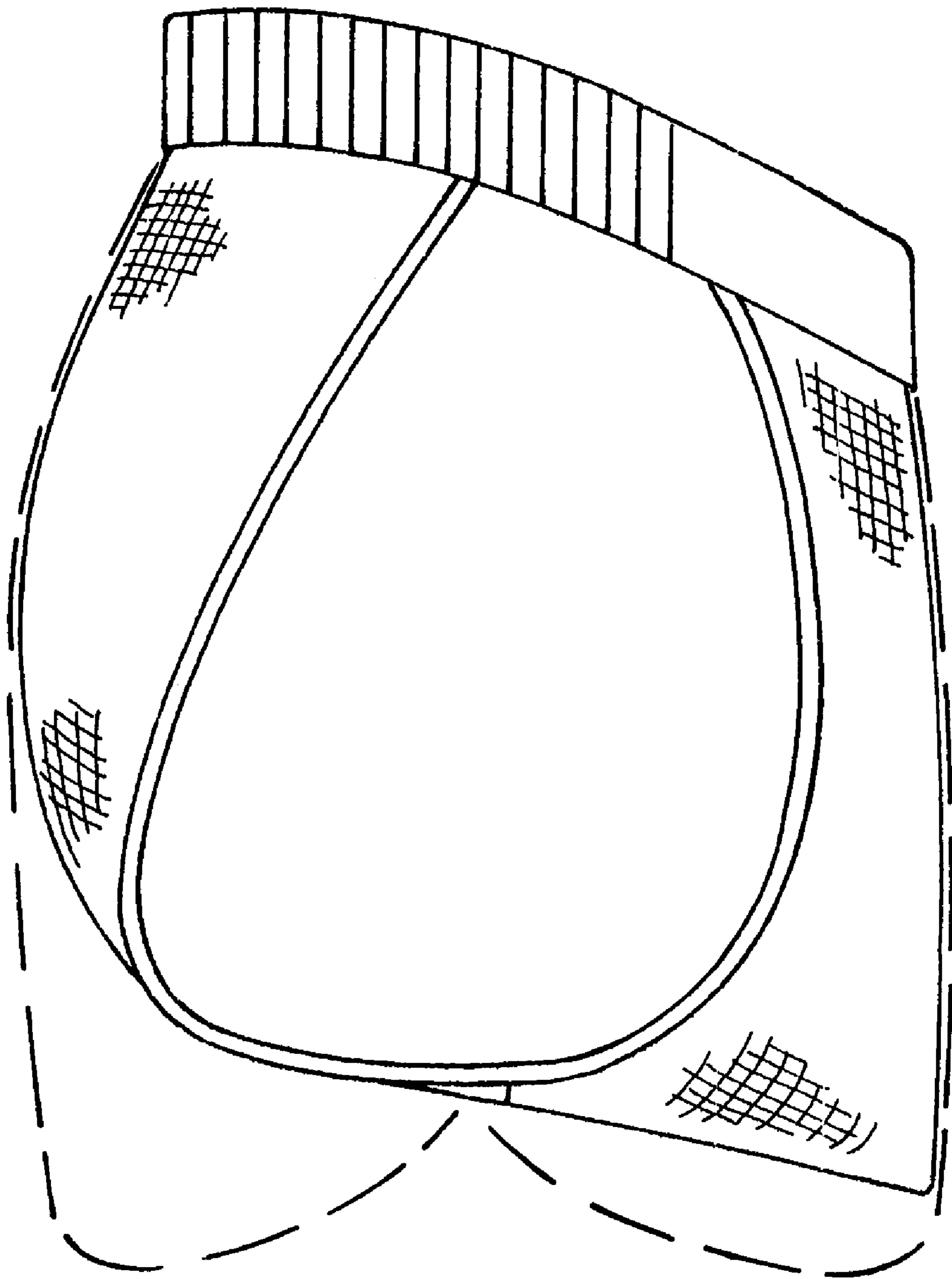
