FIG. 1 is a perspective view of the plastic base;

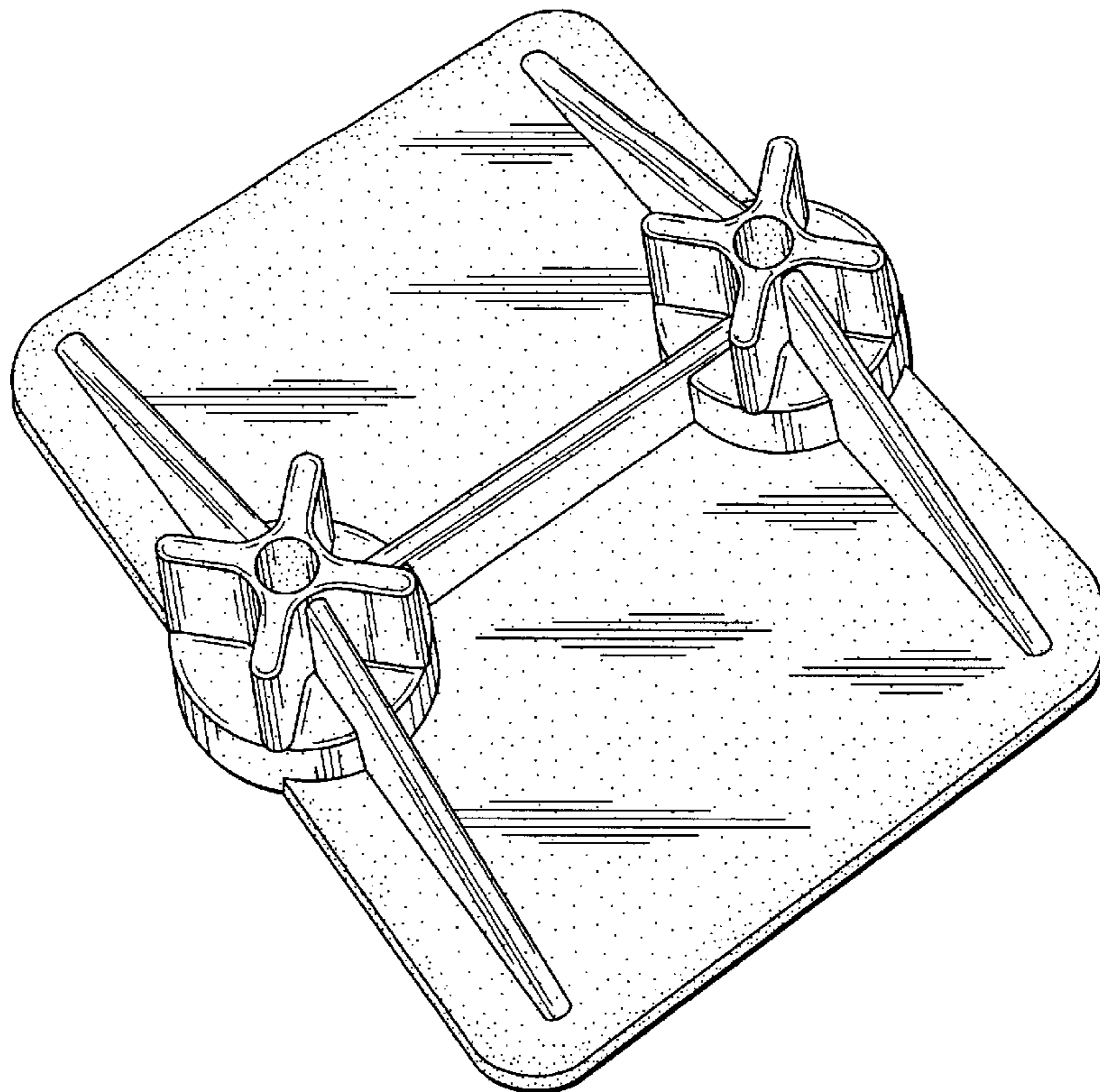
FIG. 2 is a top plan view;

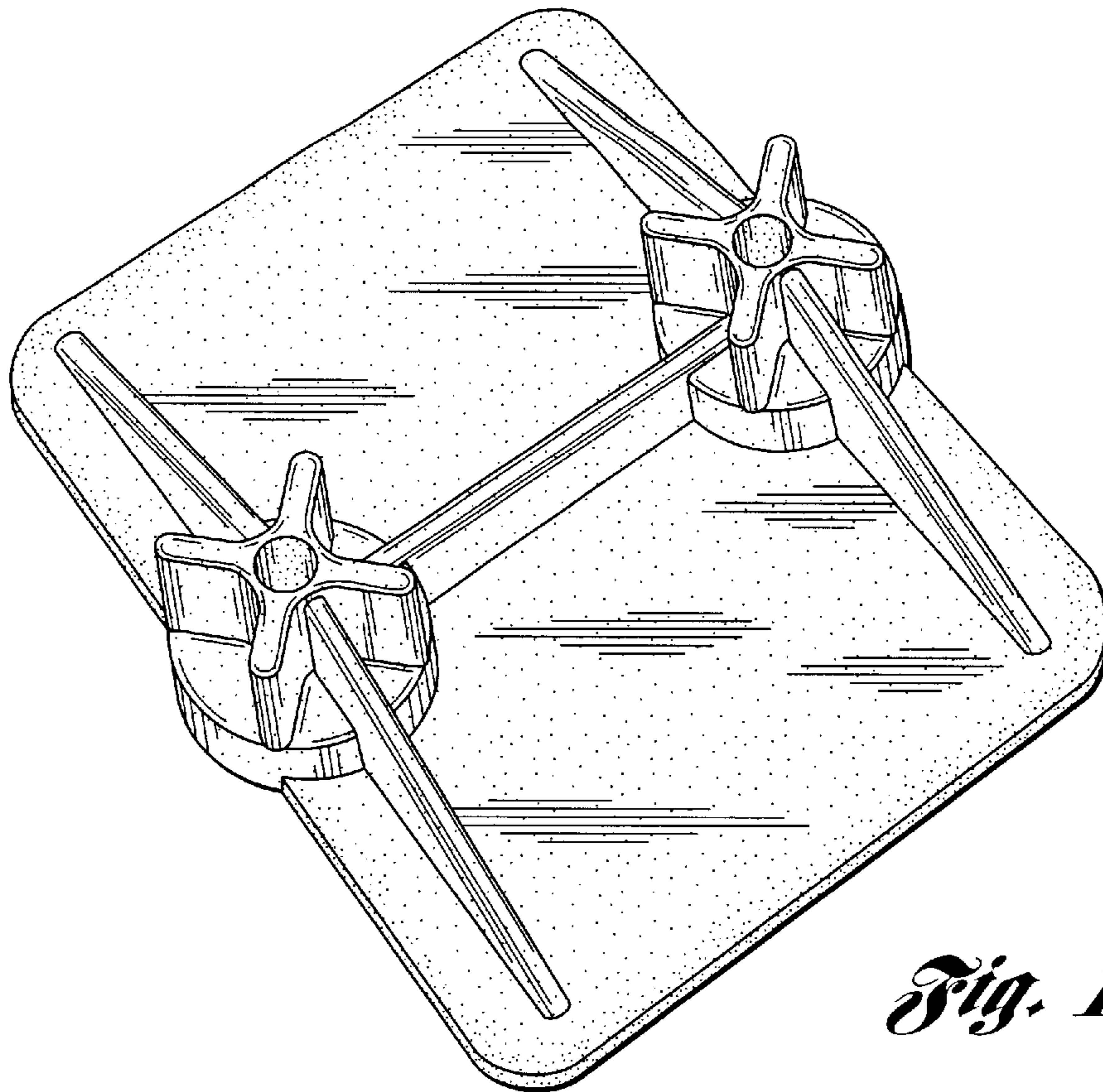
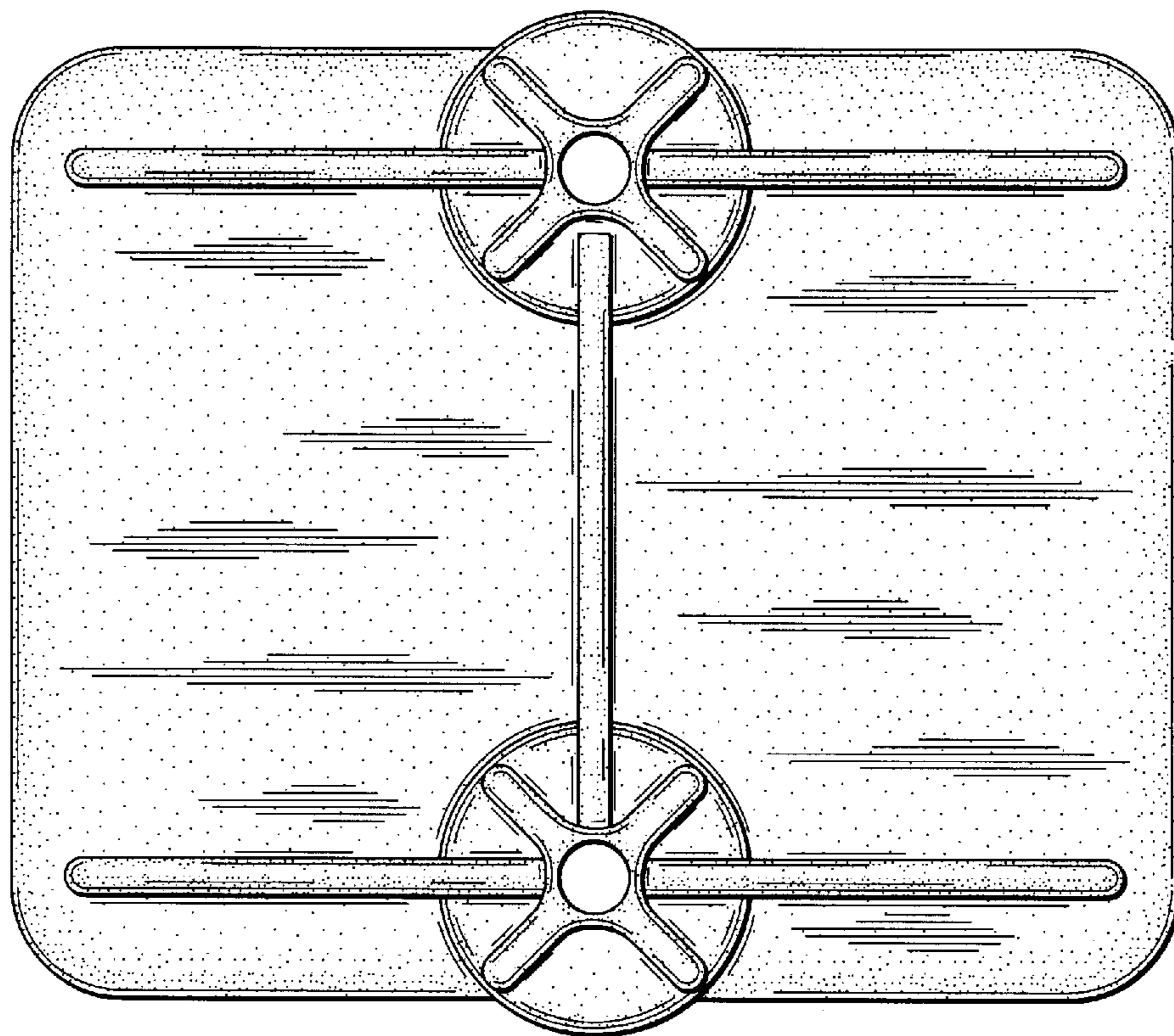

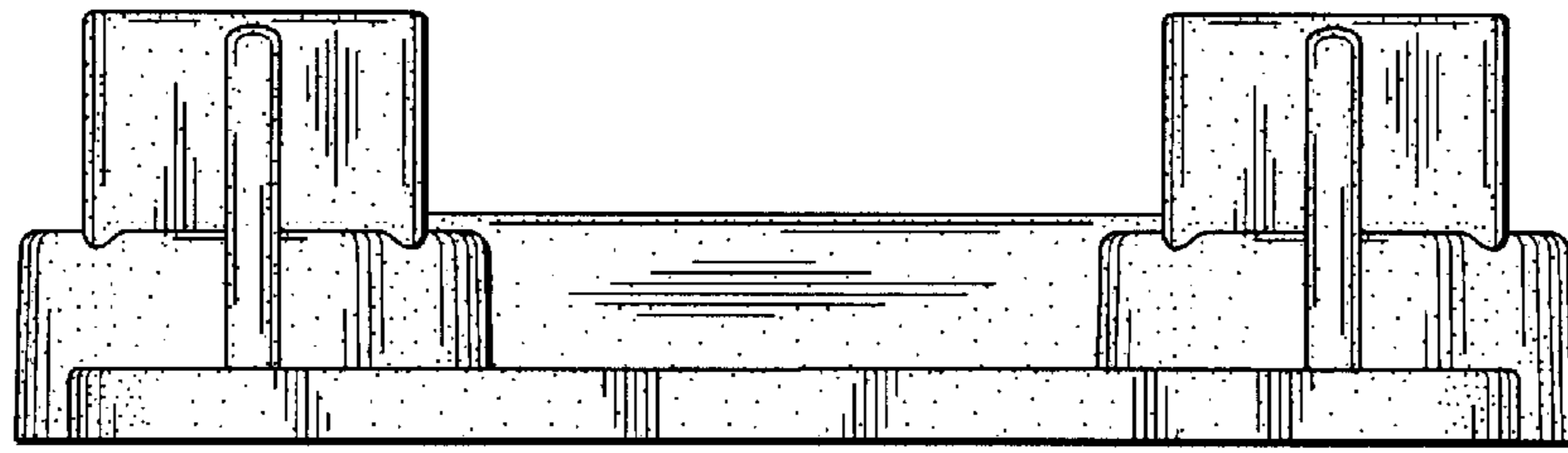

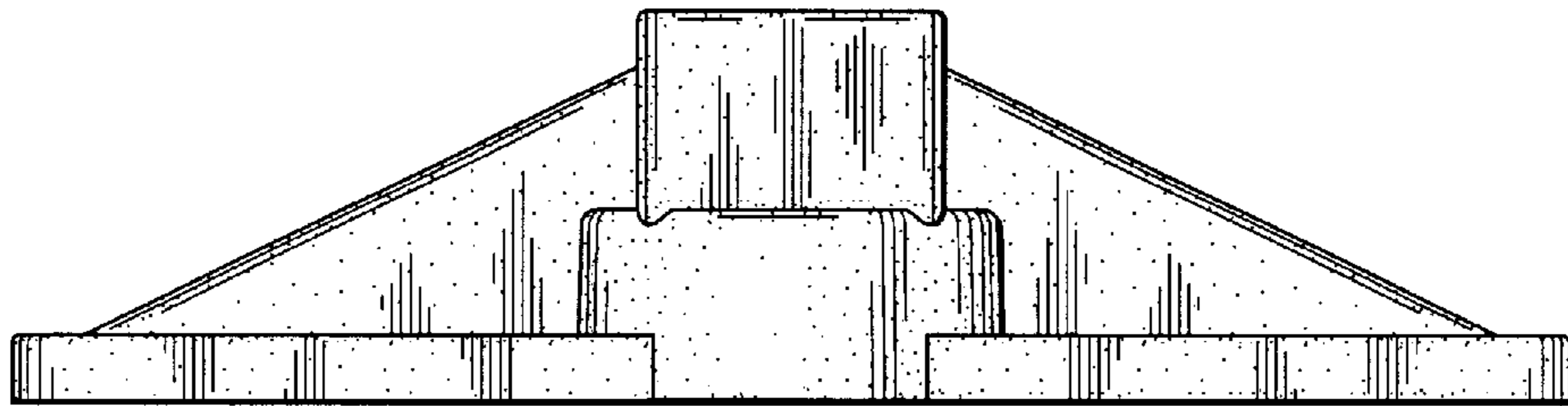

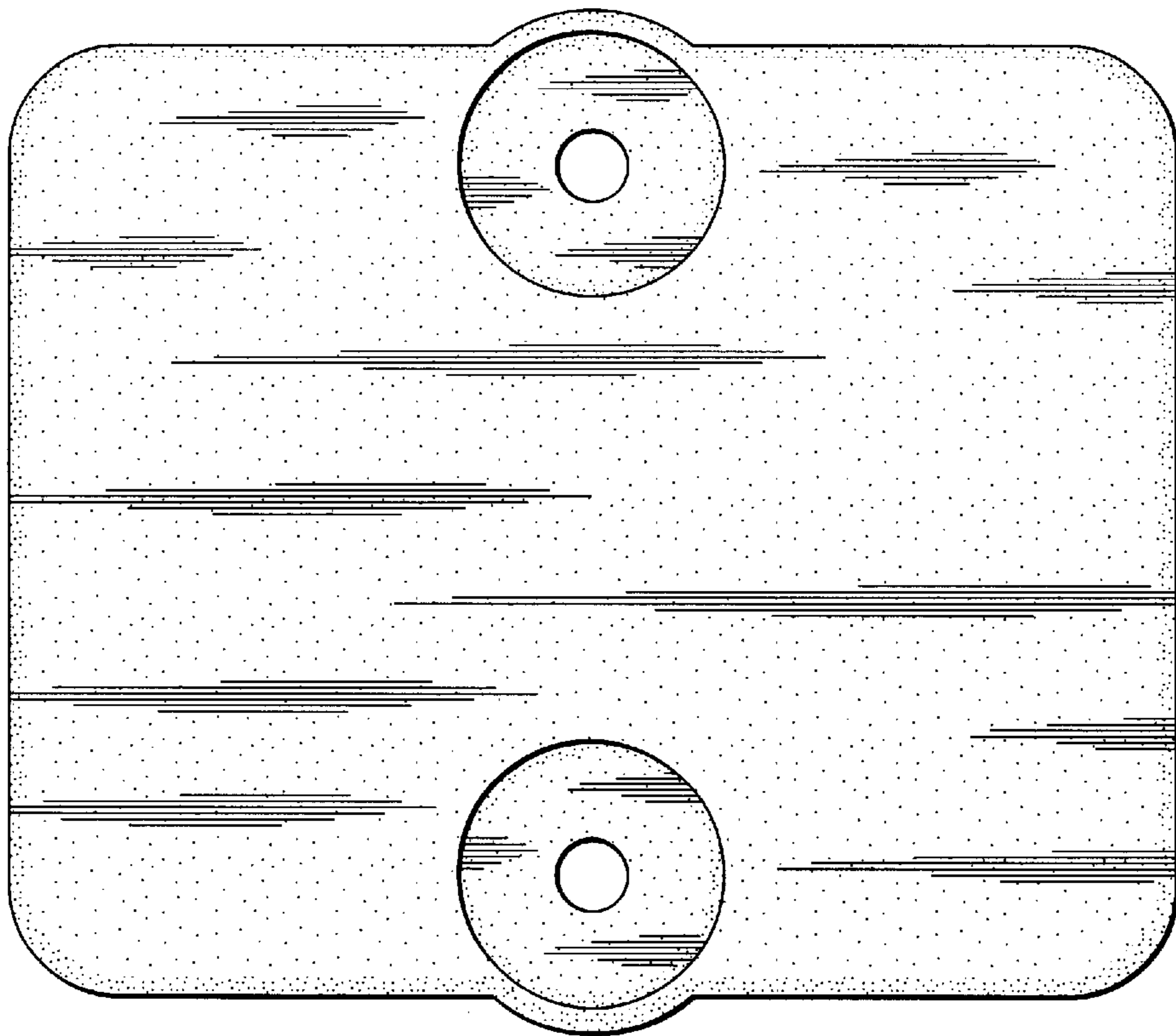
