(57) **CLAIM**

The ornamental design for a beverage and food carrier, as shown and described.

FIG. 1 is a perspective view of the beverage and food carrier showing my new design the dashed lines shown on upper portion of the beverage and food carrier represent the folding lines.

FIG. 2 is a right side elevational view of the beverage and food carrier, shown in FIG. 1;

FIG. 3 is a perspective view showing the lower portion of the beverage and food carrier of FIG. 1 with the upper removable tray removed for clarity of illustration;

FIG. 4 is a front elevational view of the lower portion of the beverage and food carrier shown in FIG. 3;

FIG. 5 is a left side elevational view of the lower portion of the beverage and food carrier shown in FIG. 3;

FIG. 6 is a right side elevational view of the lower portion of the beverage and food carrier shown in FIG. 3;

FIG. 7 is a top plan view of the lower portion of the beverage and food carrier shown in FIG. 3;

FIG. 8 is a bottom plan view of the lower portion of the beverage and food carrier shown in FIG. 3;

FIG. 9 is a perspective view of the topside of the removable upper tray portion of the beverage and food carrier of FIG. 1;

FIG. 10 is a perspective view of the bottom side of the removable upper tray portion of the beverage and food carrier shown in FIG. 9;

FIG. 11 is an enlarged side elevational view of two of the sides of the upper tray portion of the beverage and food carrier shown in FIG. 9.

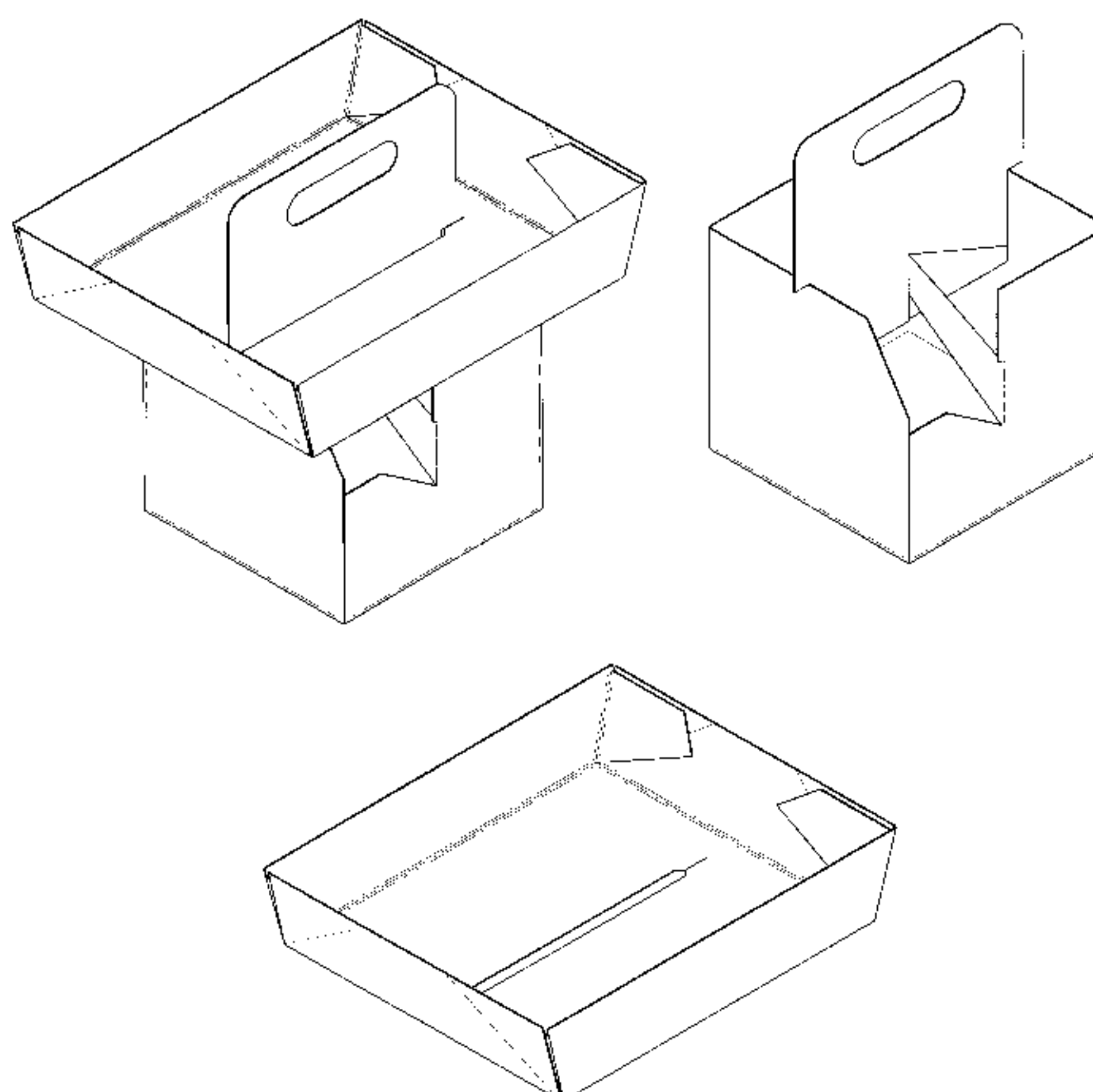
FIG. 12 is an enlarged side elevational view of the other two sides of the upper tray portion of the beverage and food carrier shown in FIG. 9.

FIG. 13 is an enlarged bottom view of the upper tray portion of the beverage and food carrier shown in FIG. 9; and,

FIG. 14 is an enlarged top view of the upper tray portion of the beverage and food carrier shown in FIG. 9.

The topside of the removable upper tray portion of the beverage and food carrier shown in FIGS. 9-14 is shown separately for clarity of illustration only.

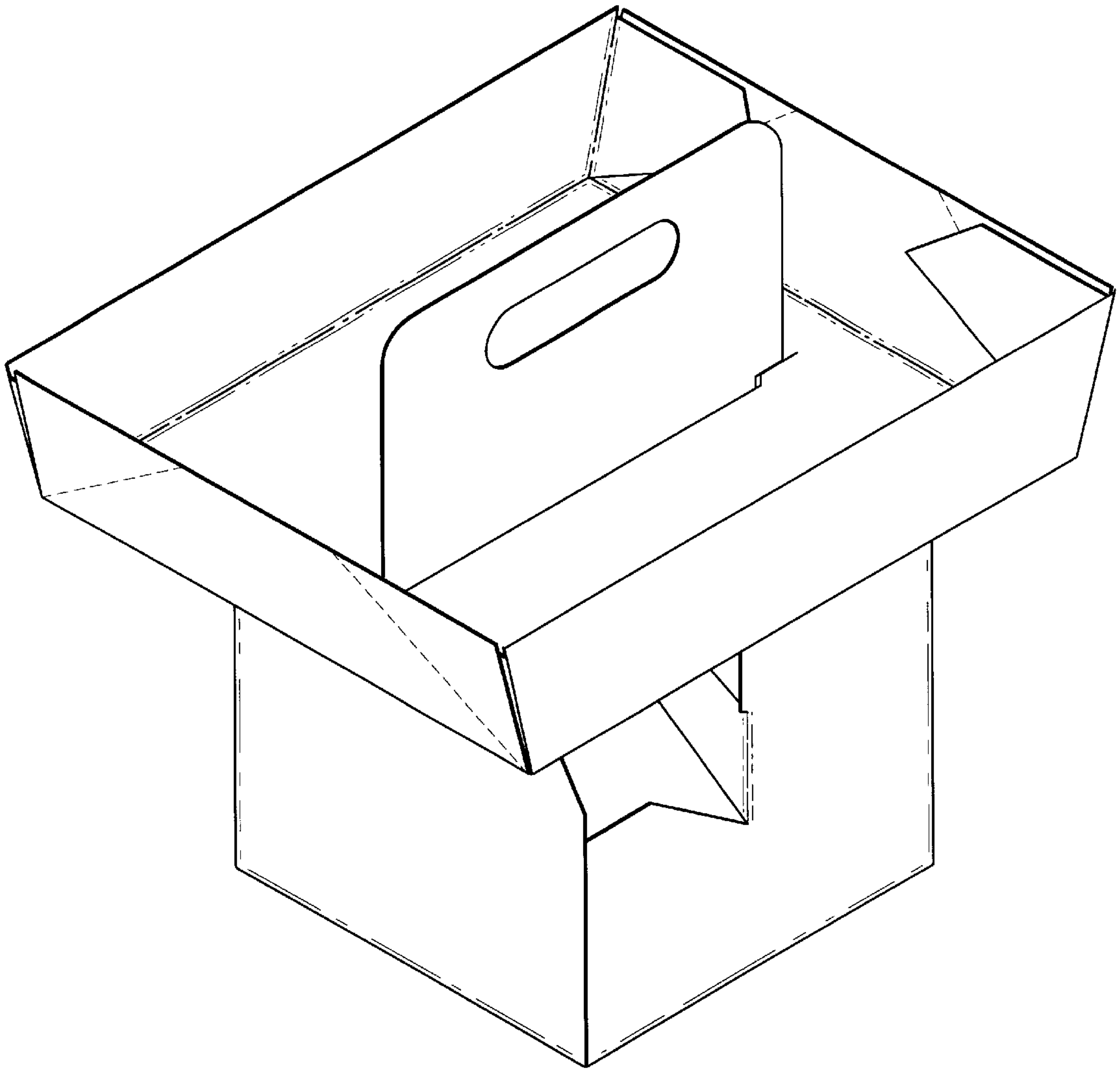

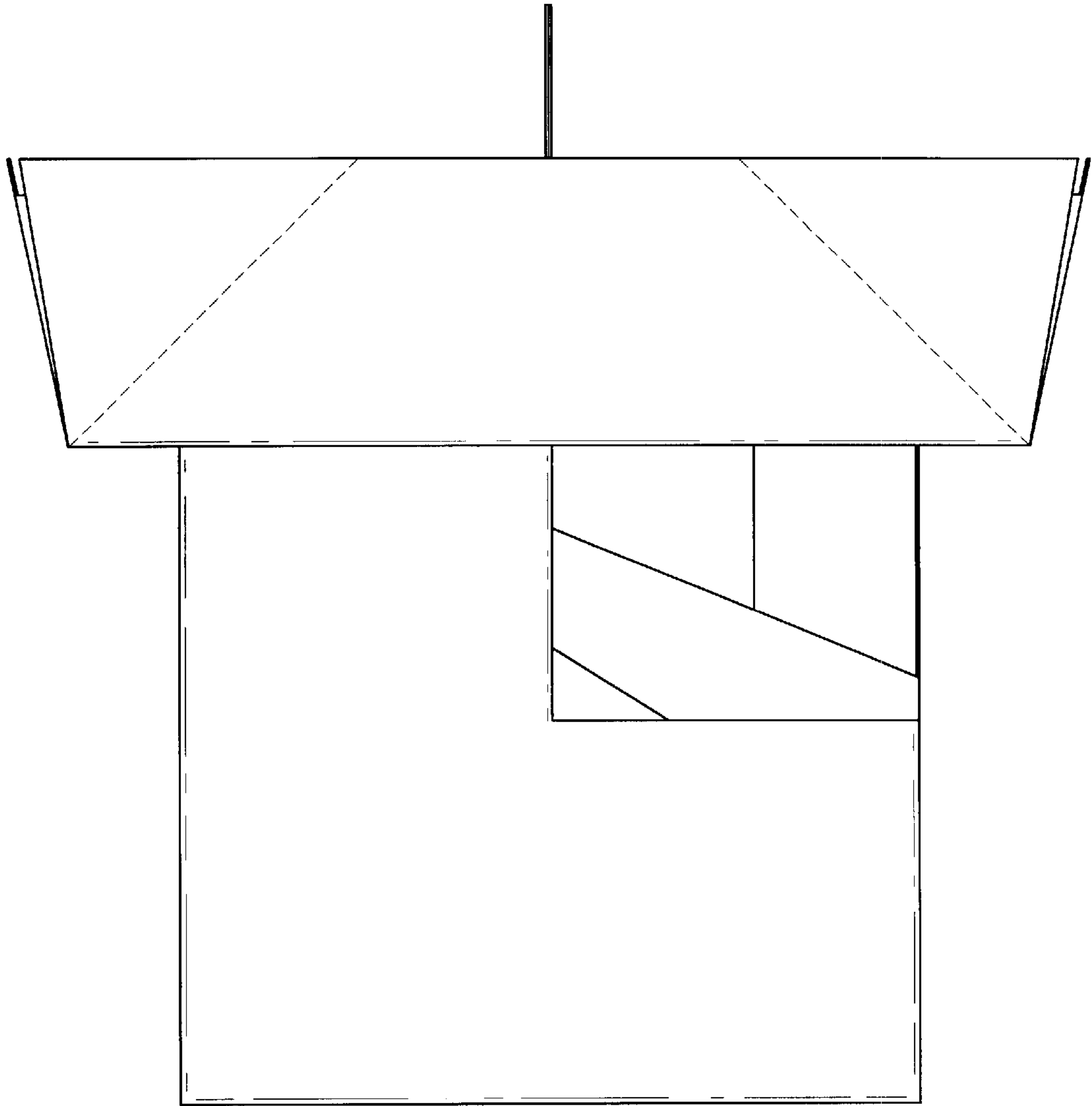
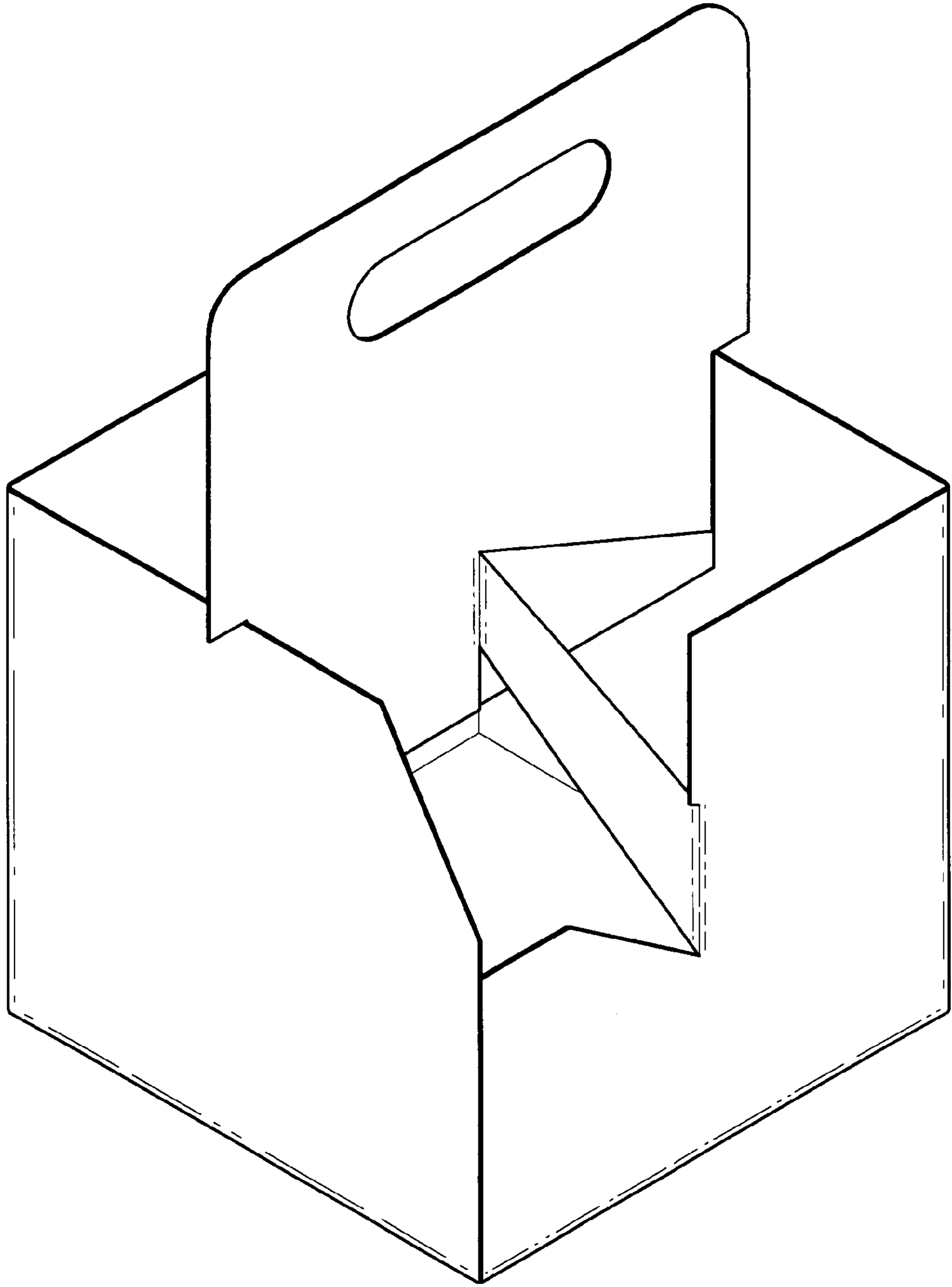
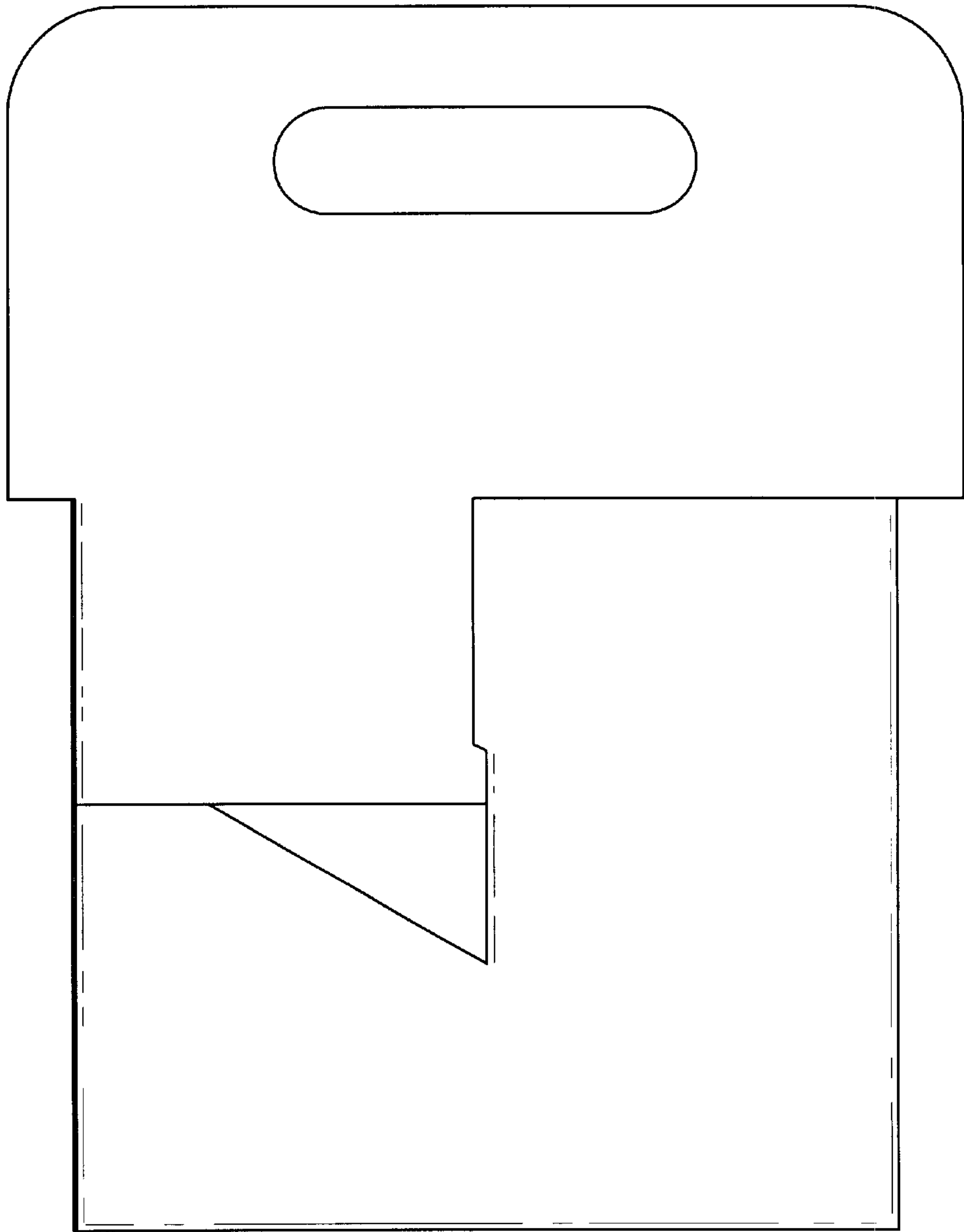


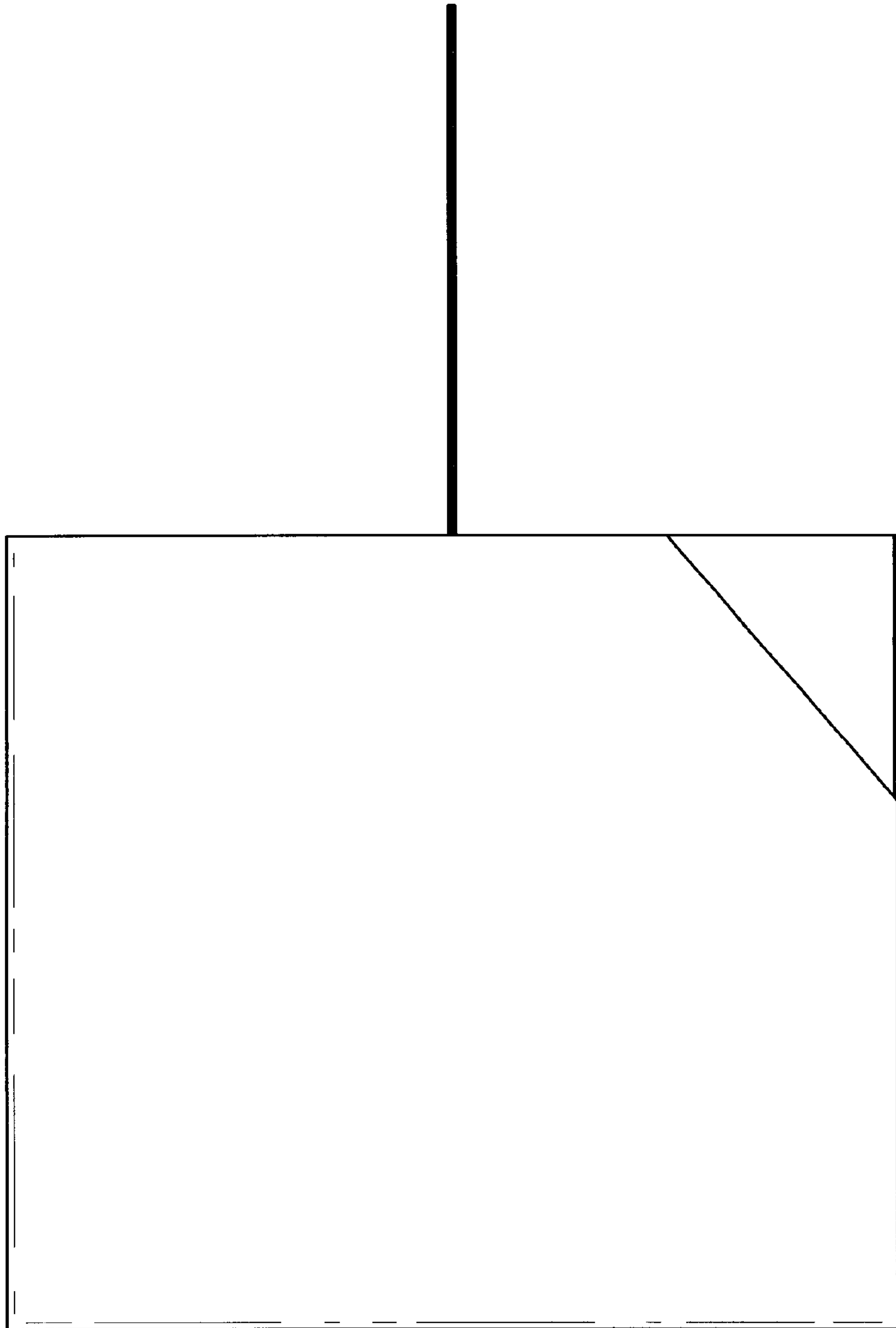

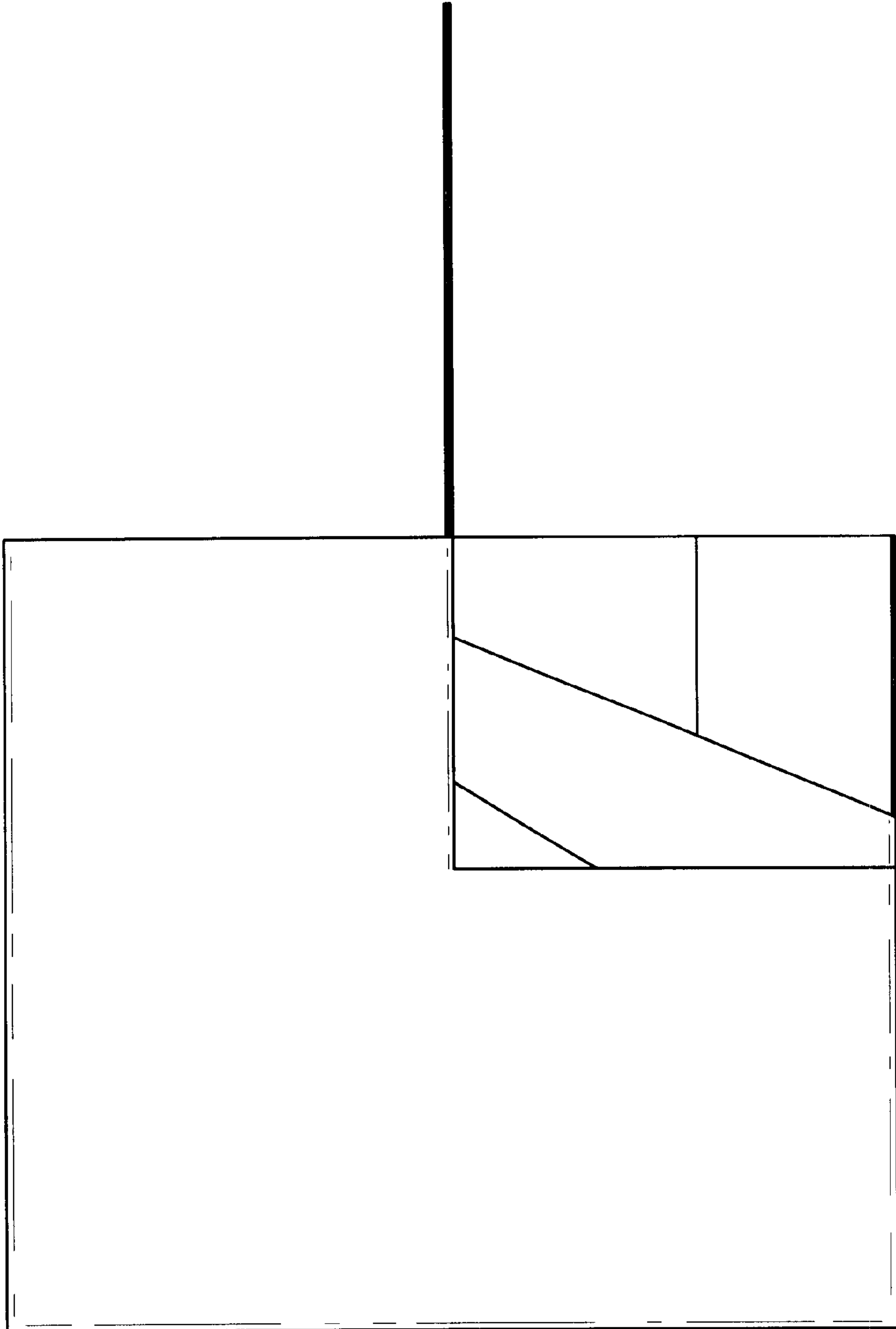

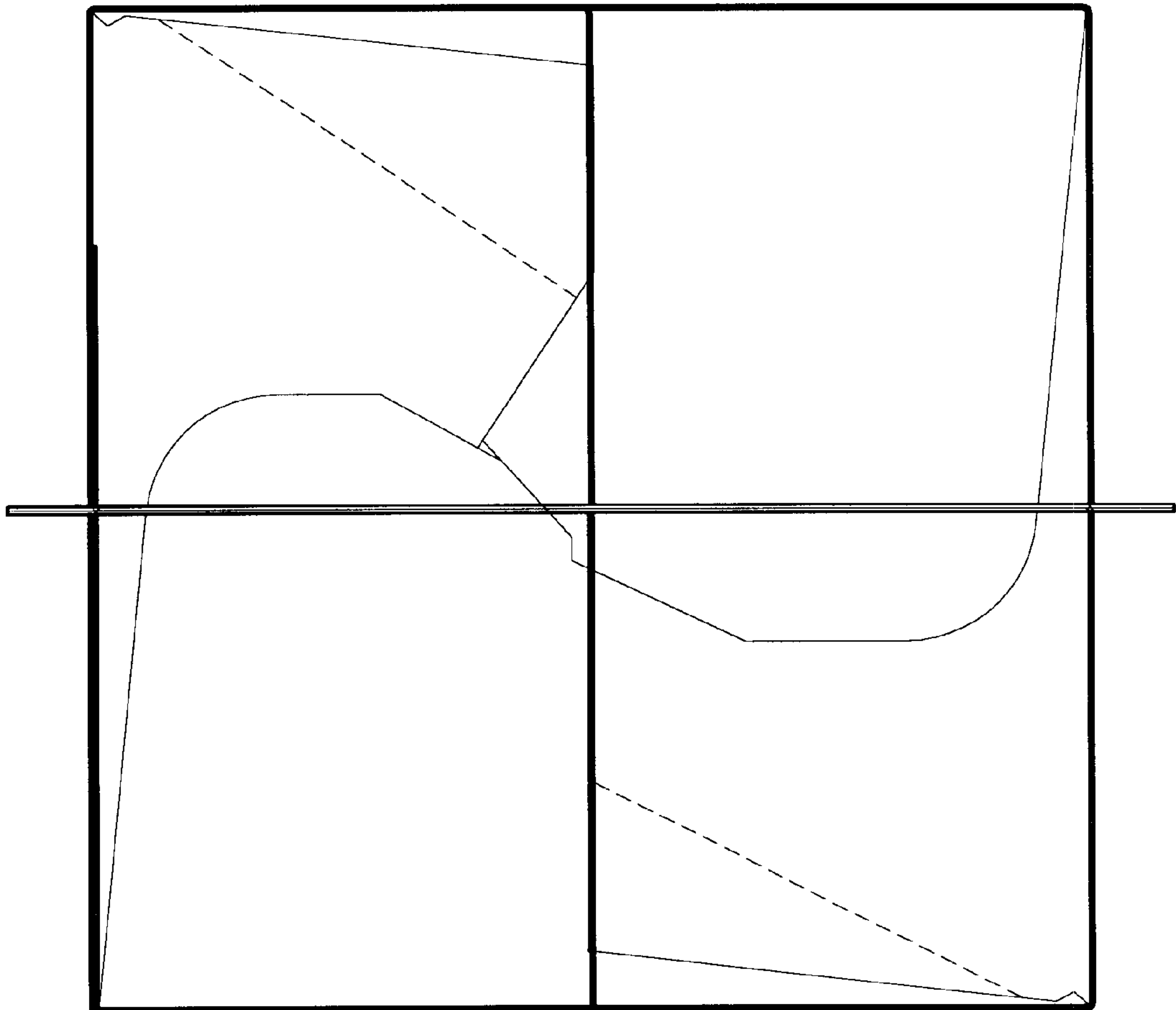

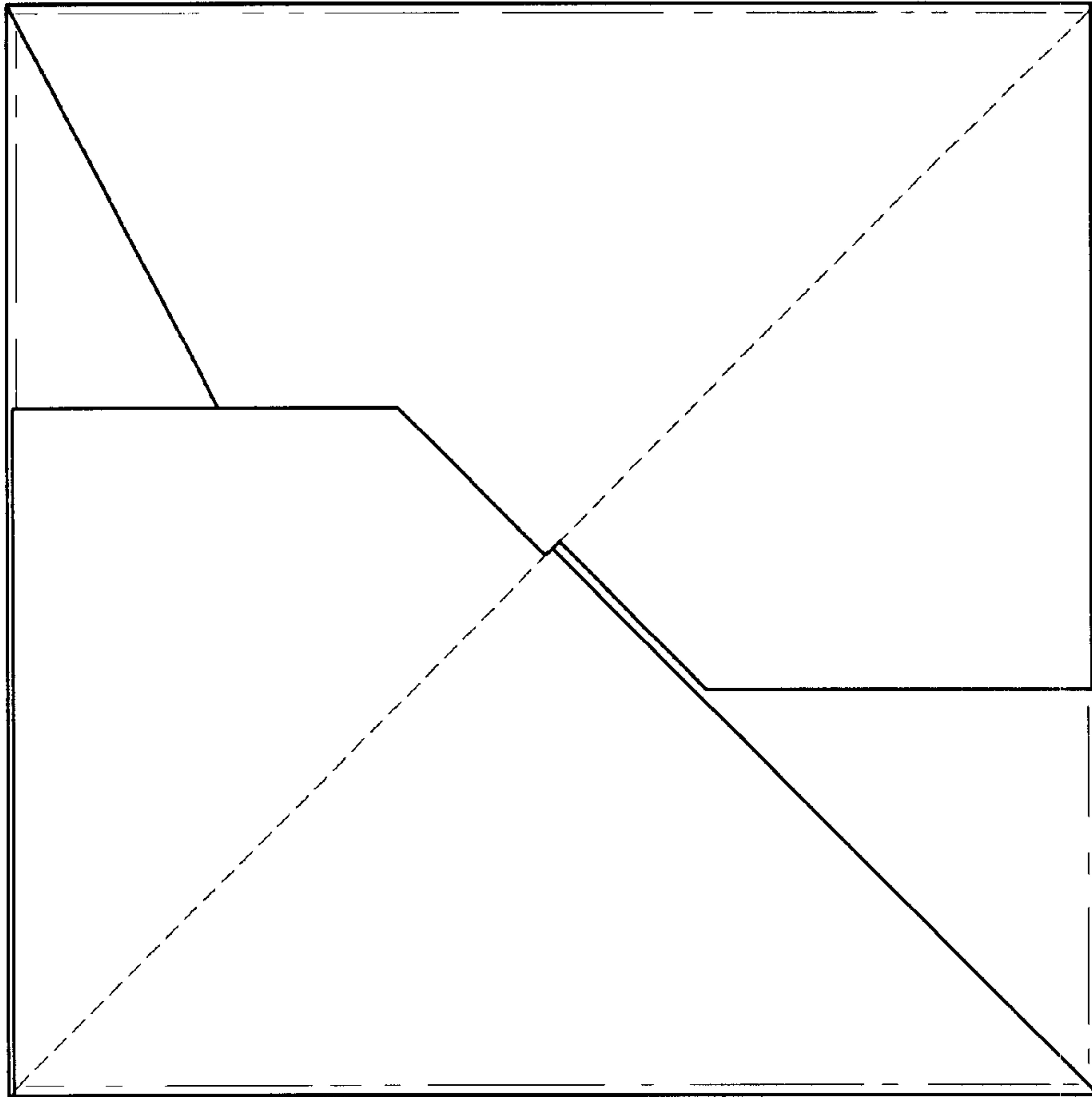

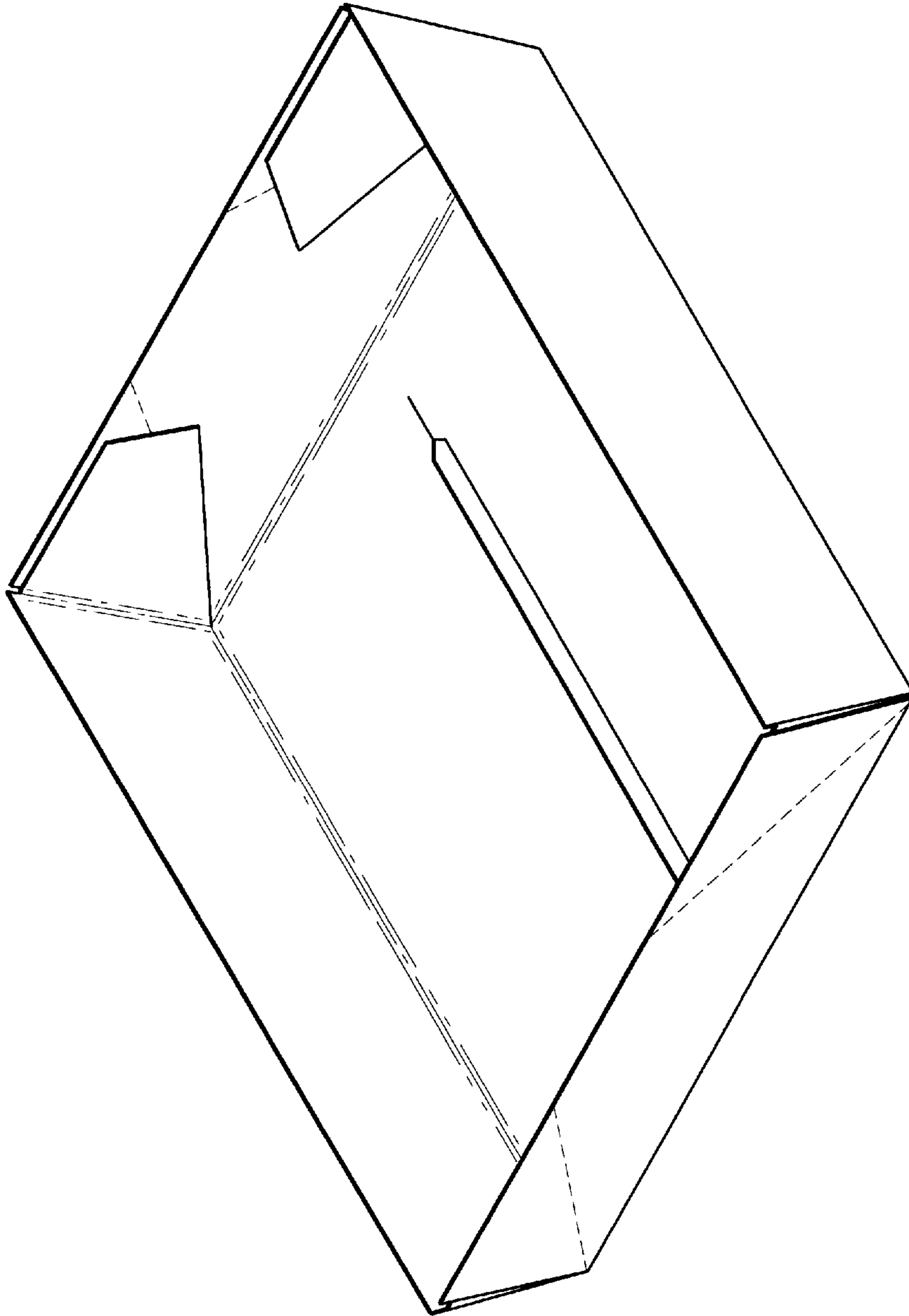

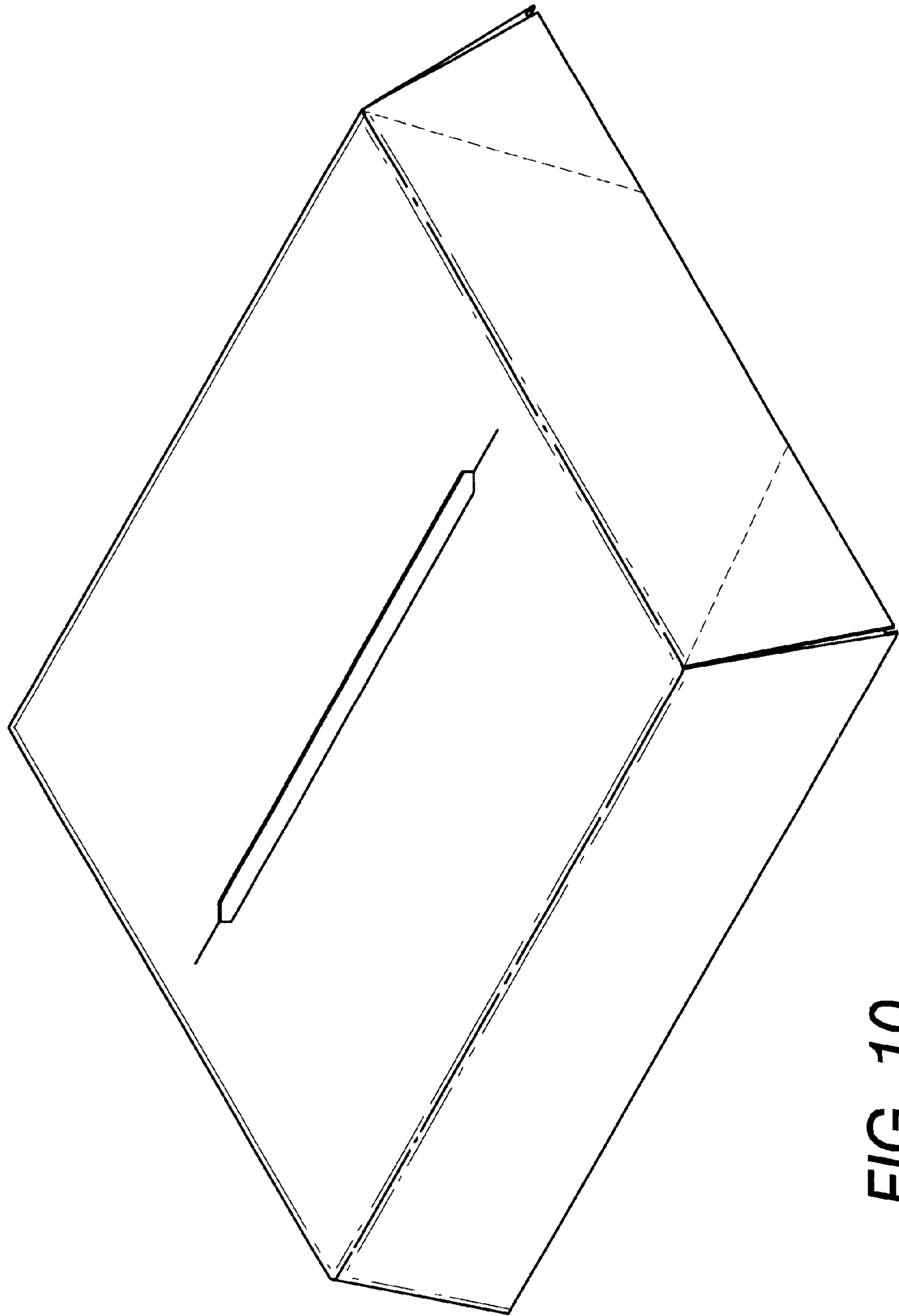

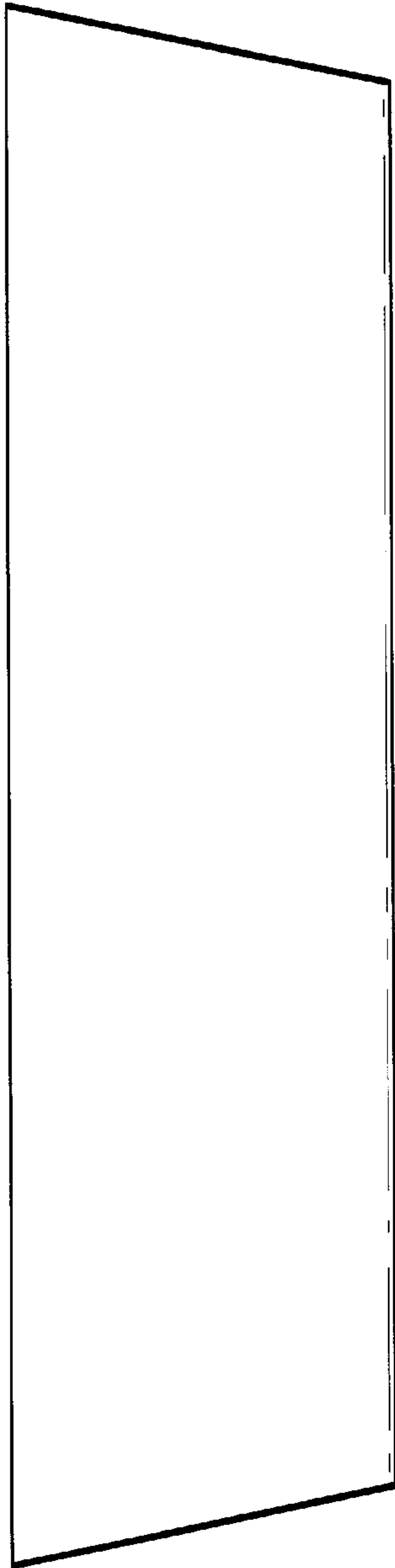

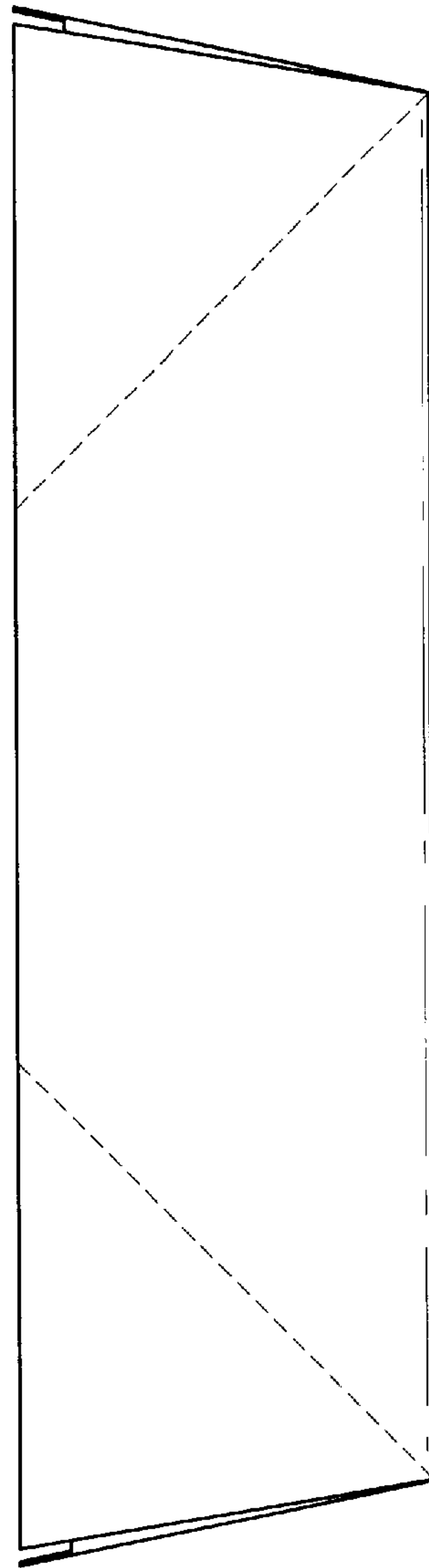

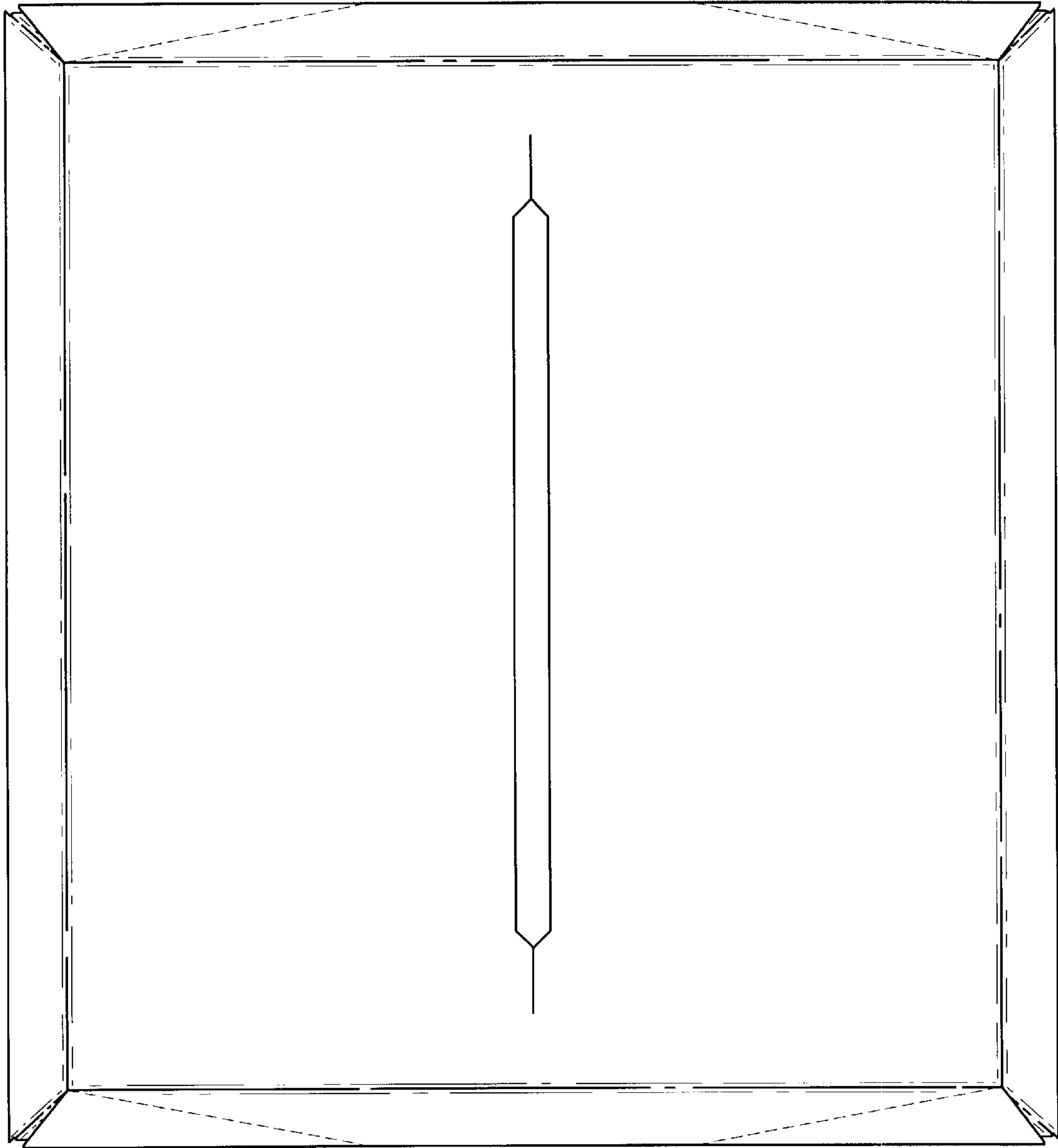

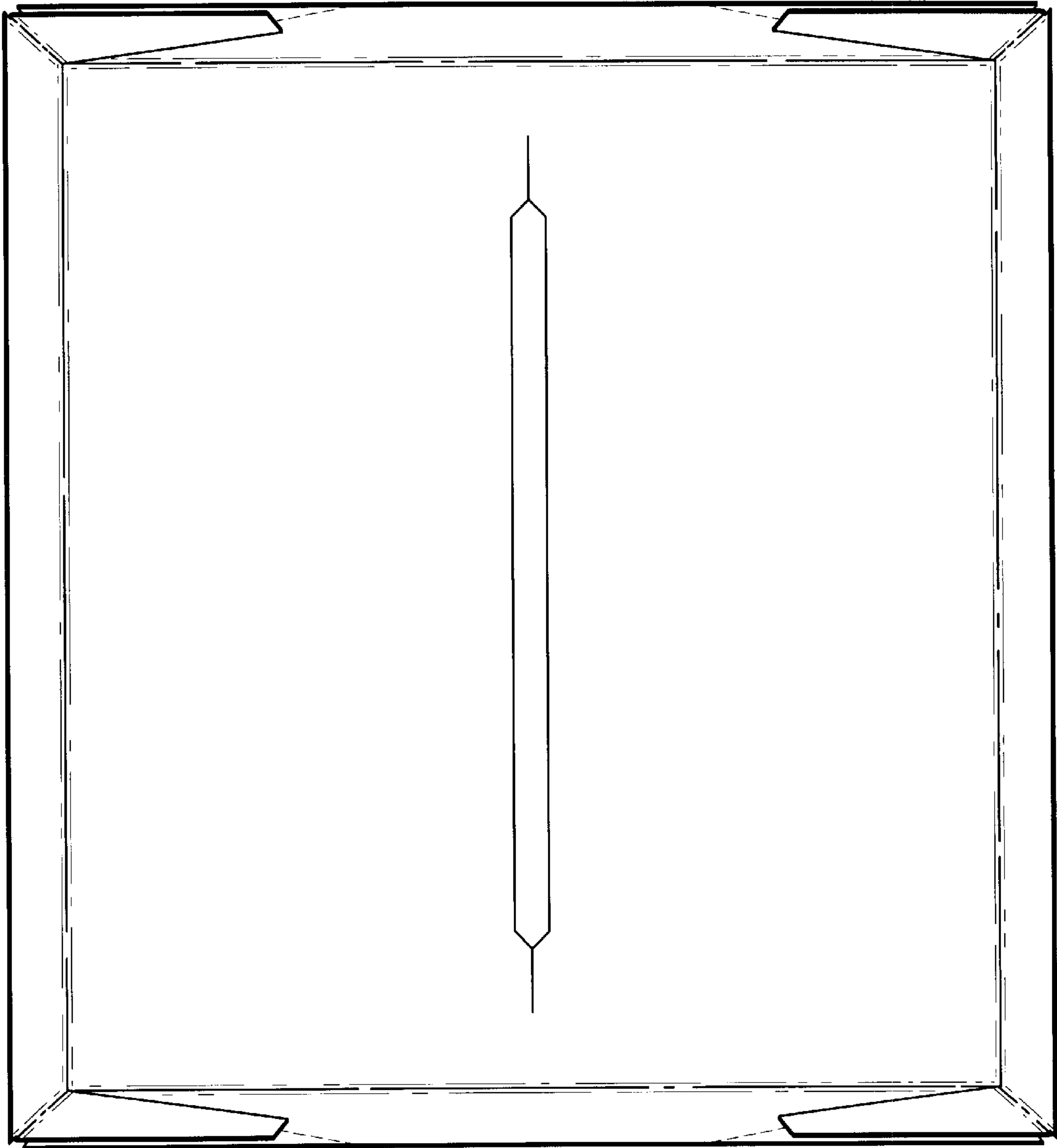
