FIG. 3 is a right side view of the glass bottle in accordance with the invention;

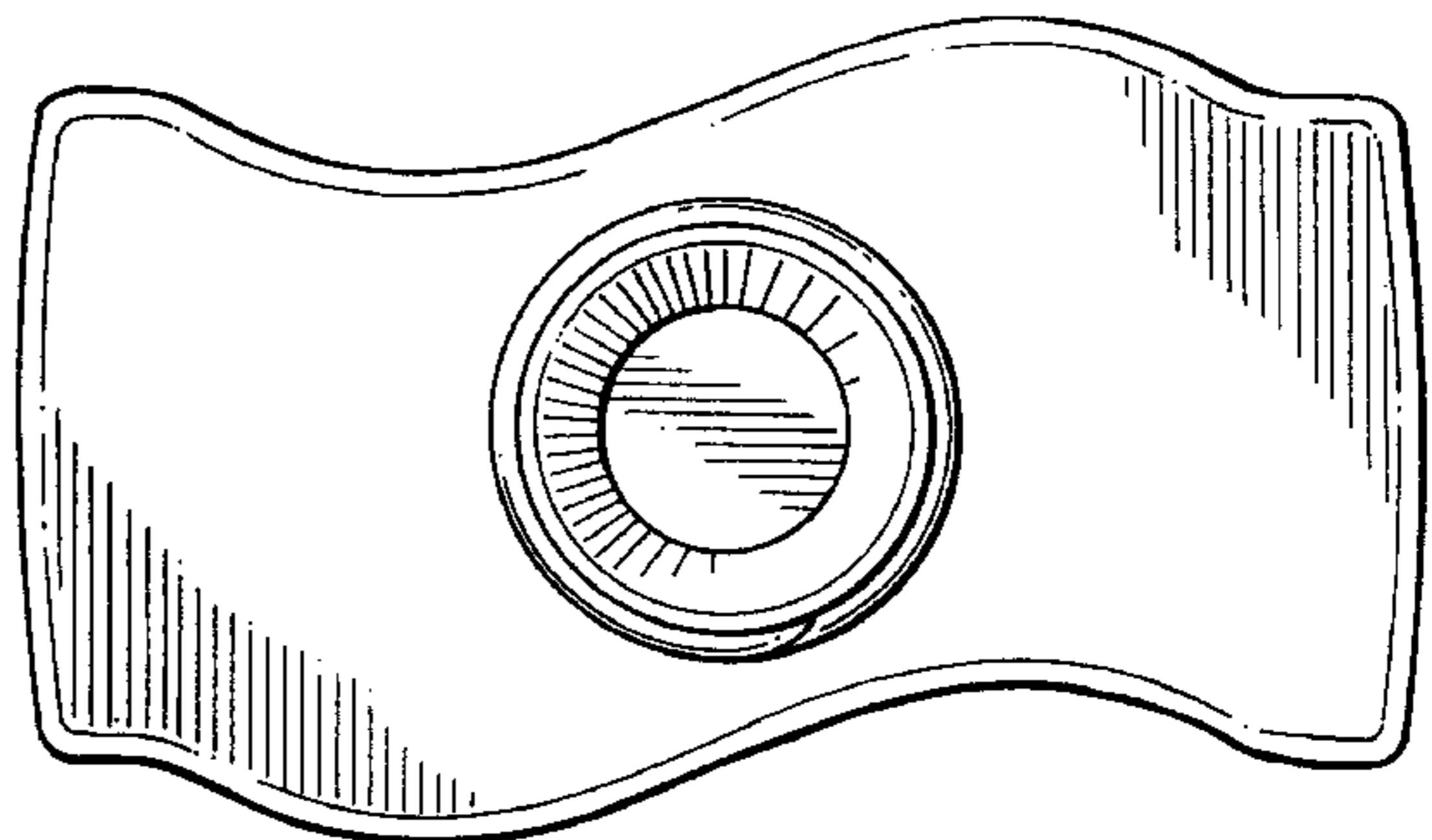
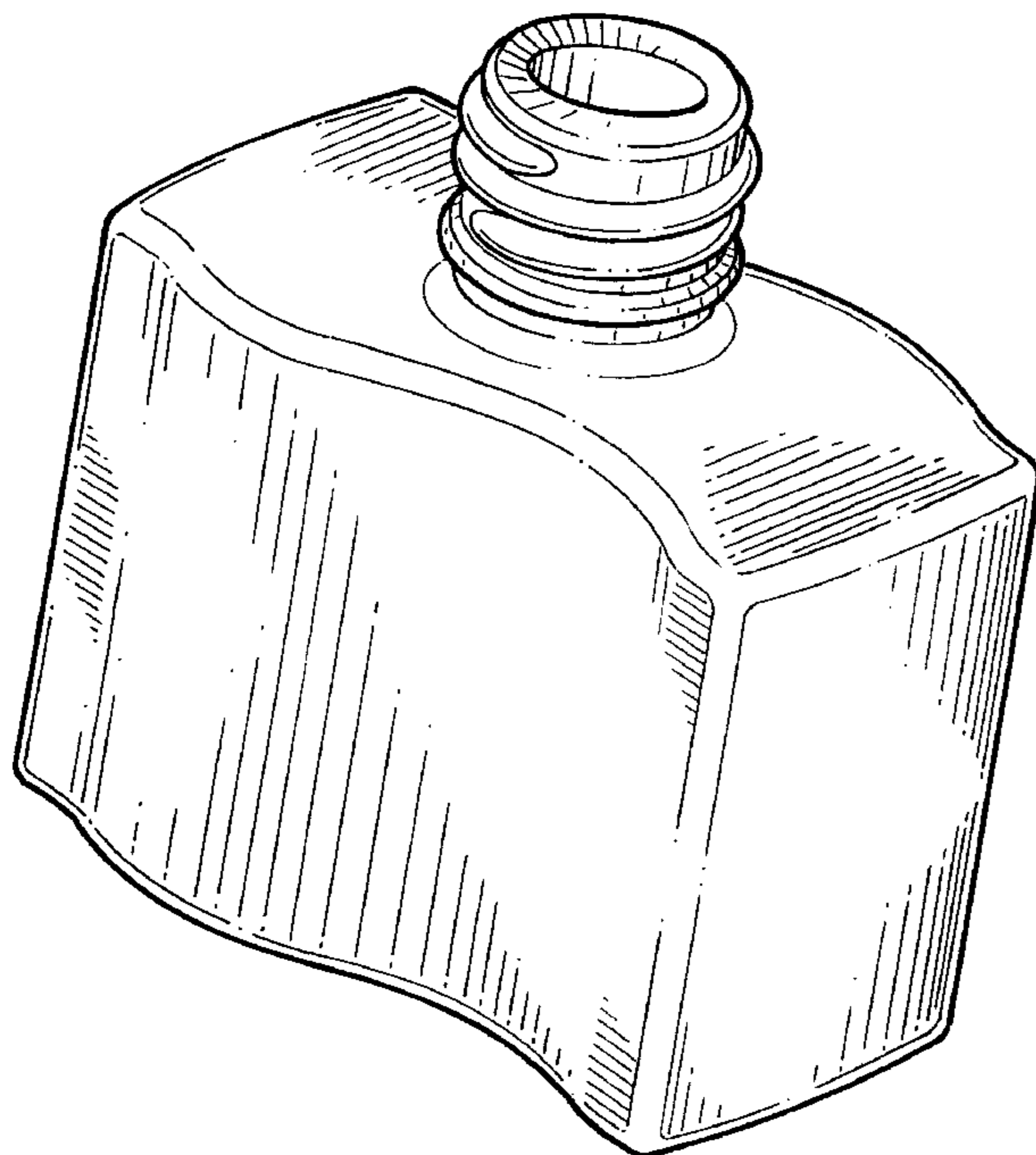
FIG. 4 is a left side view of the glass bottle in accordance with the invention;

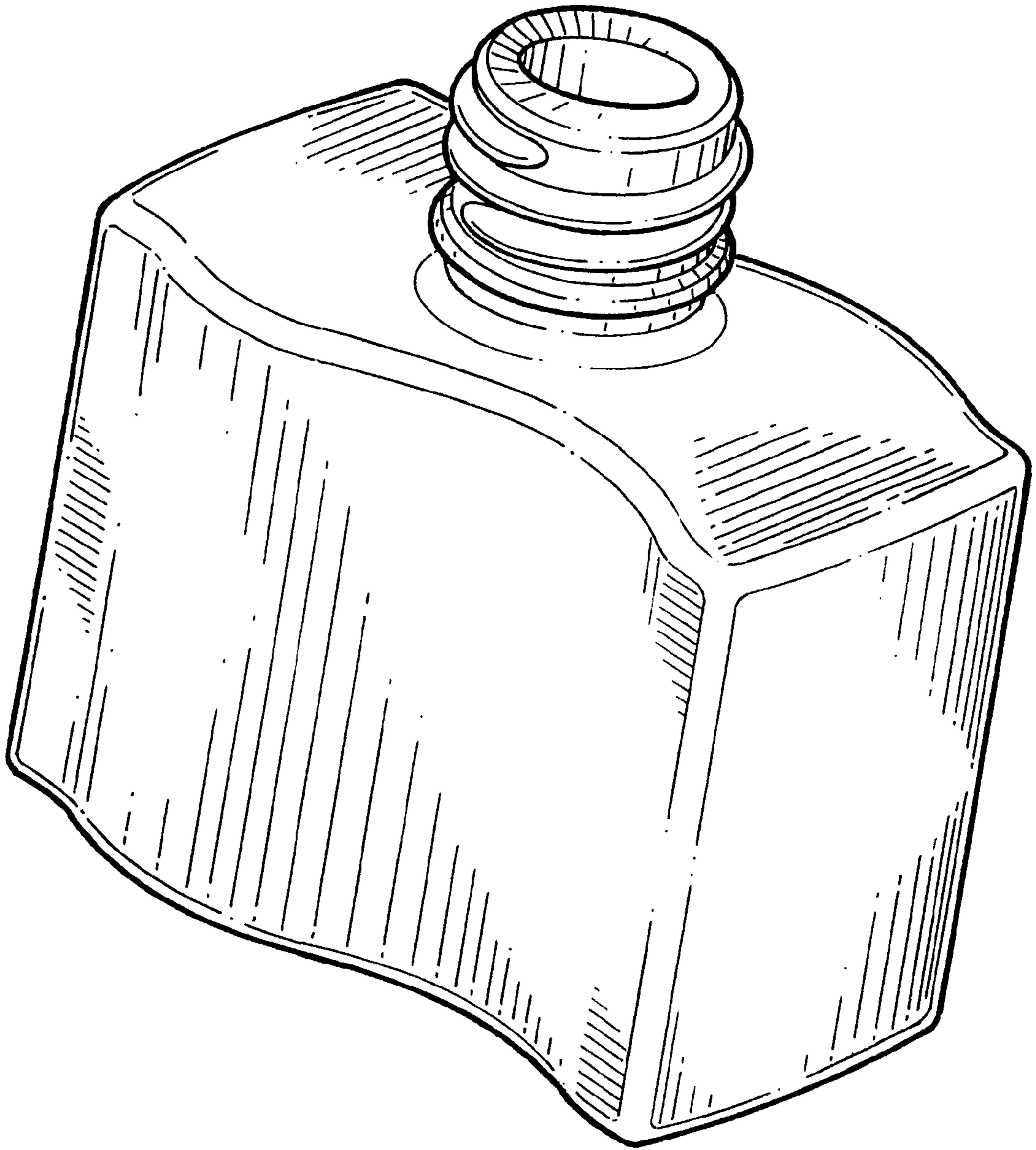

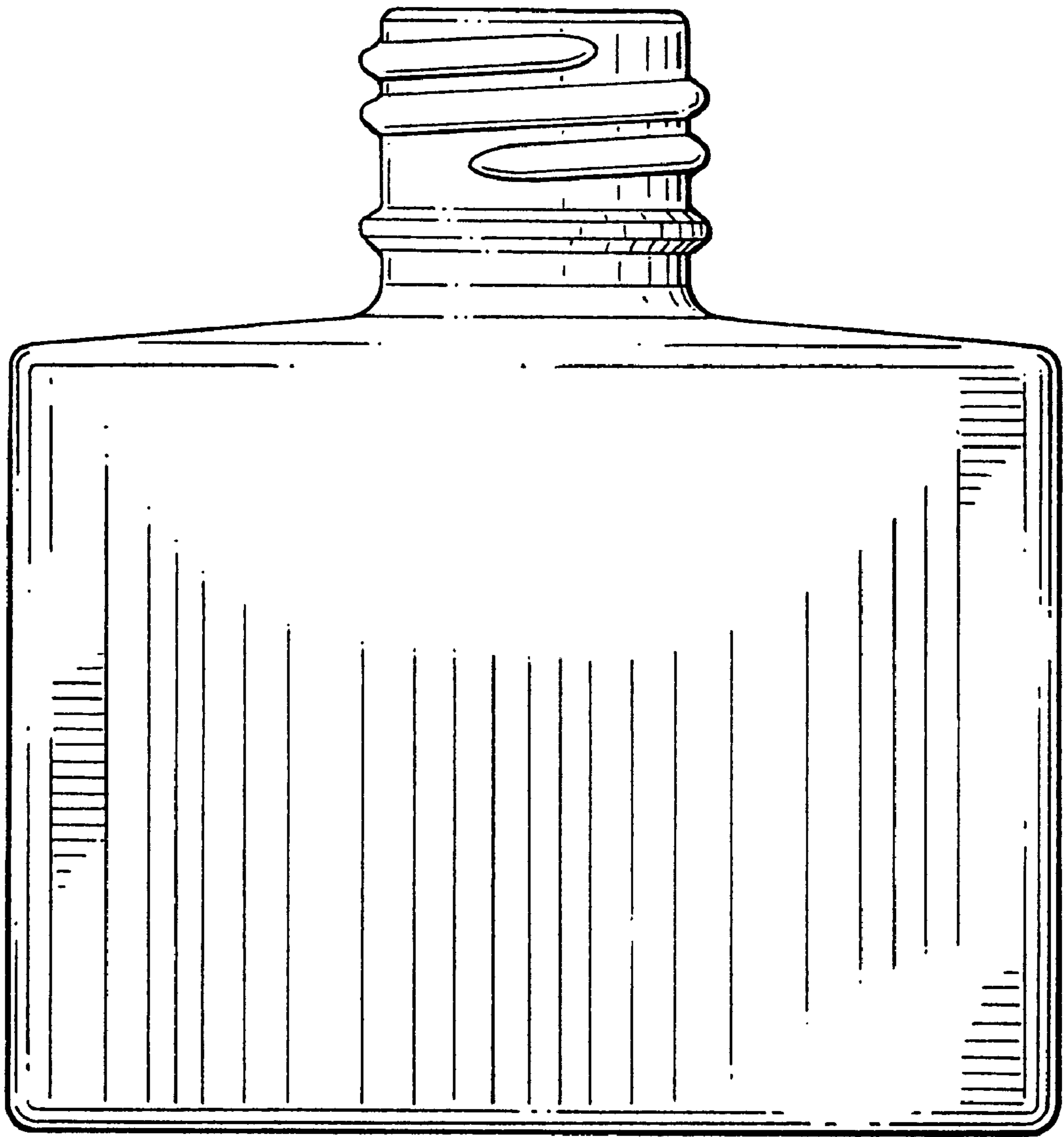

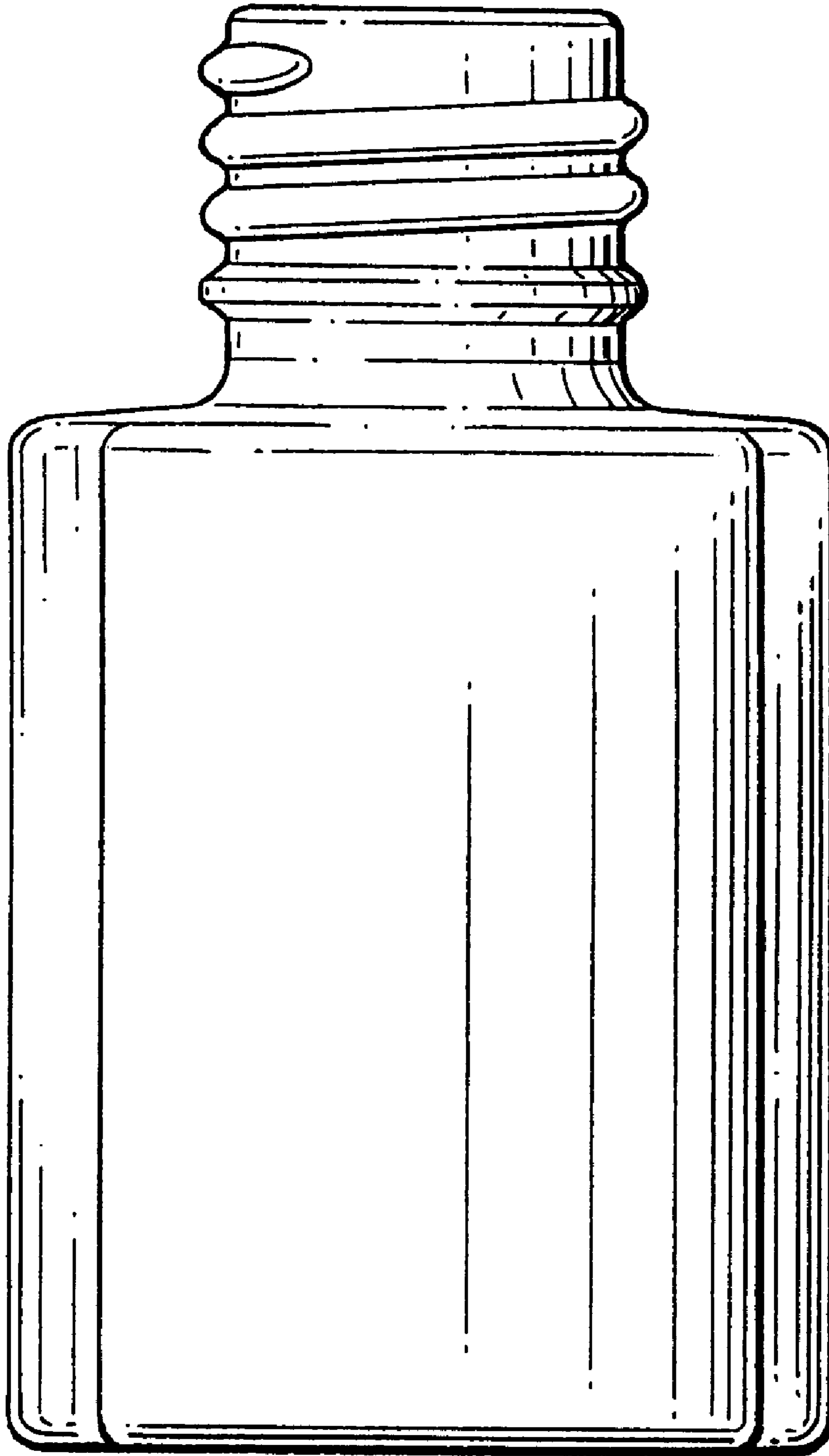

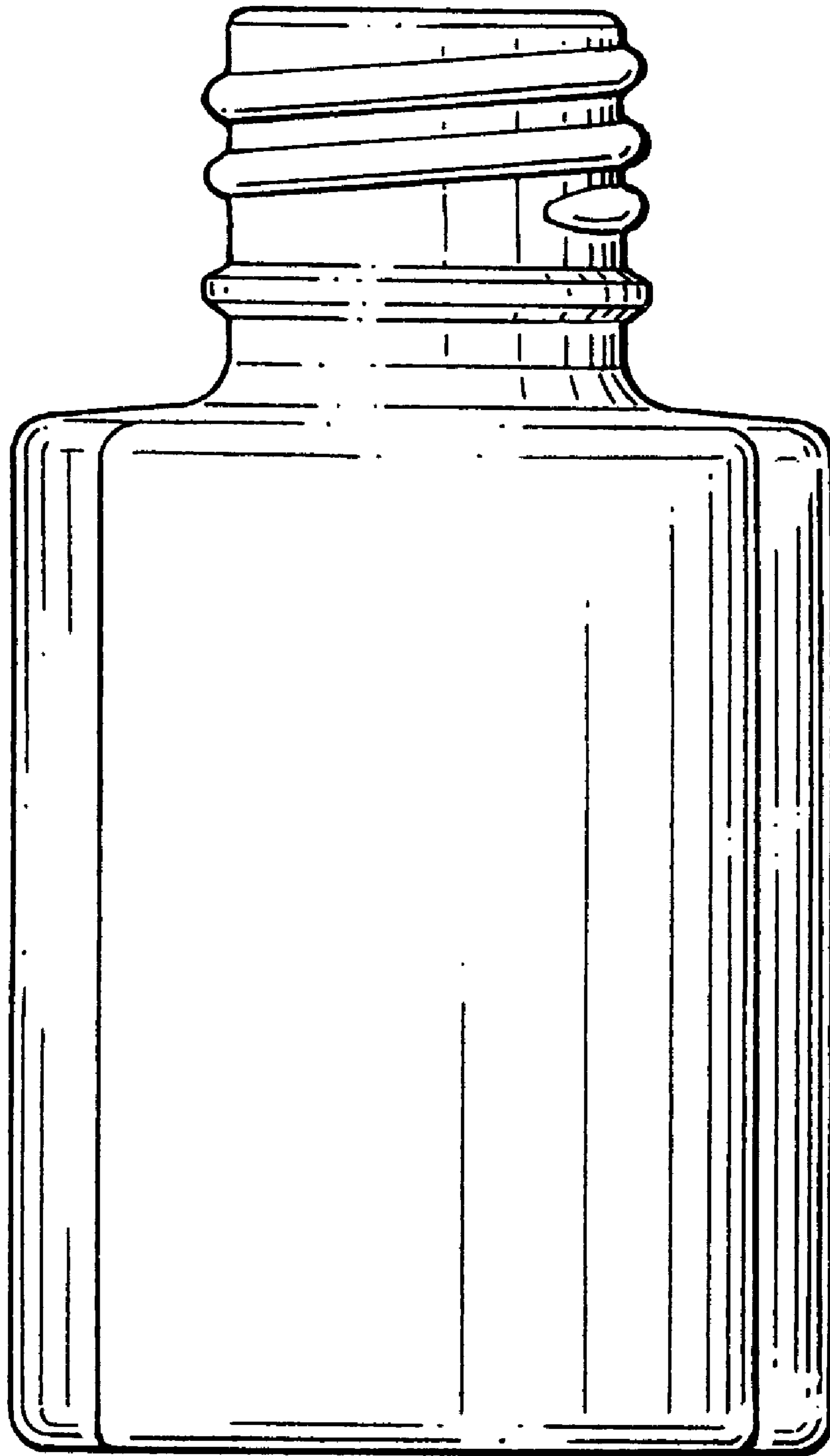

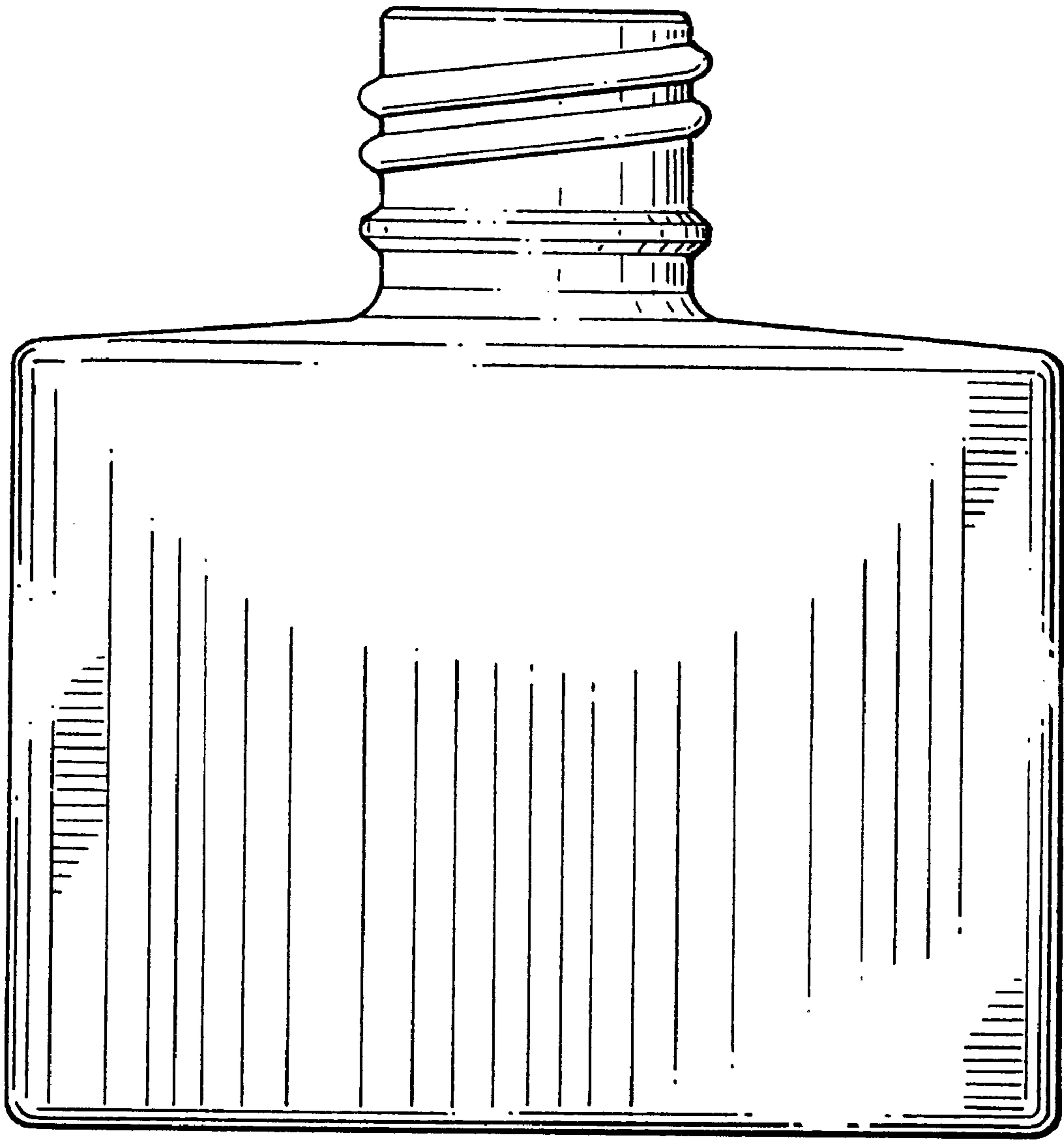

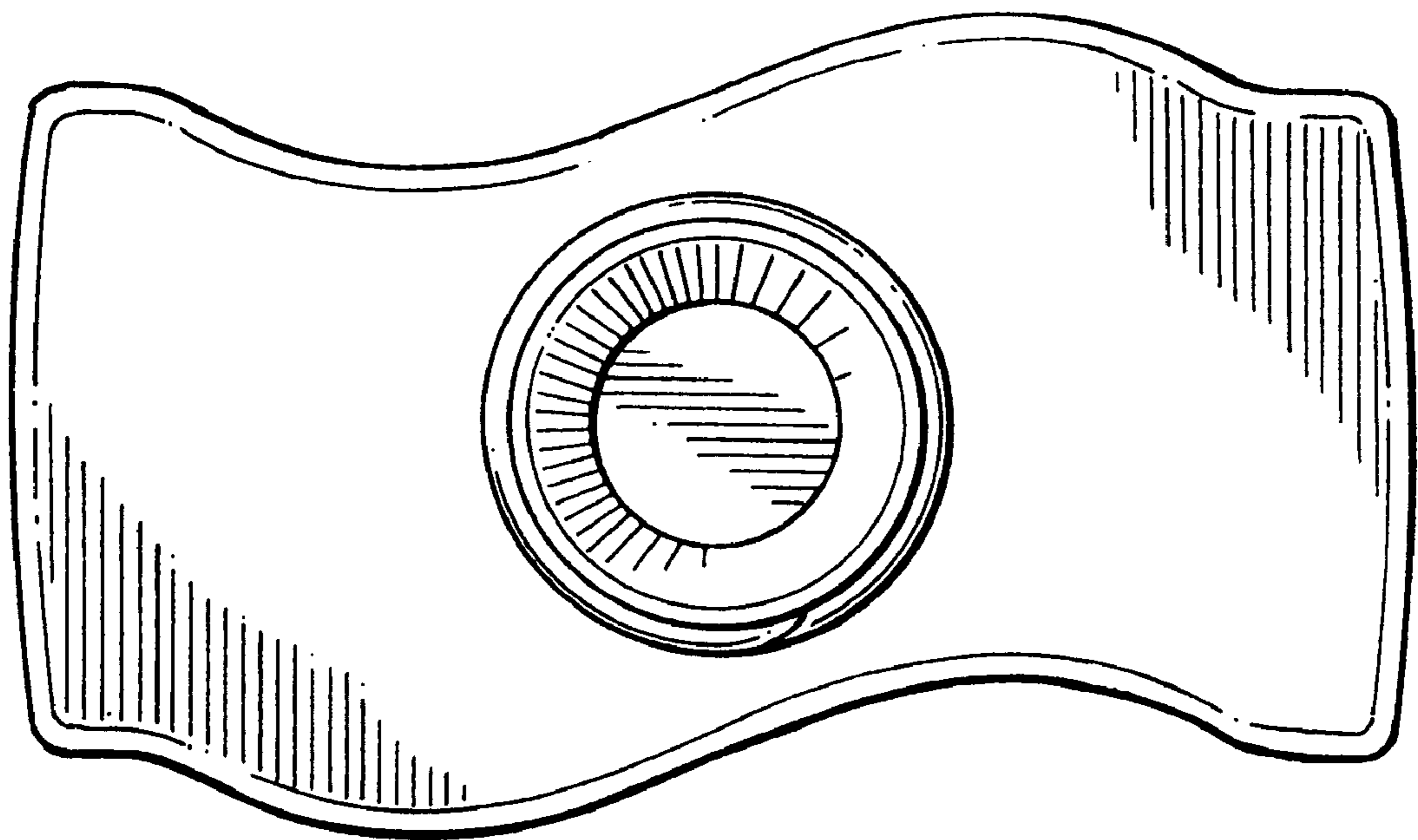

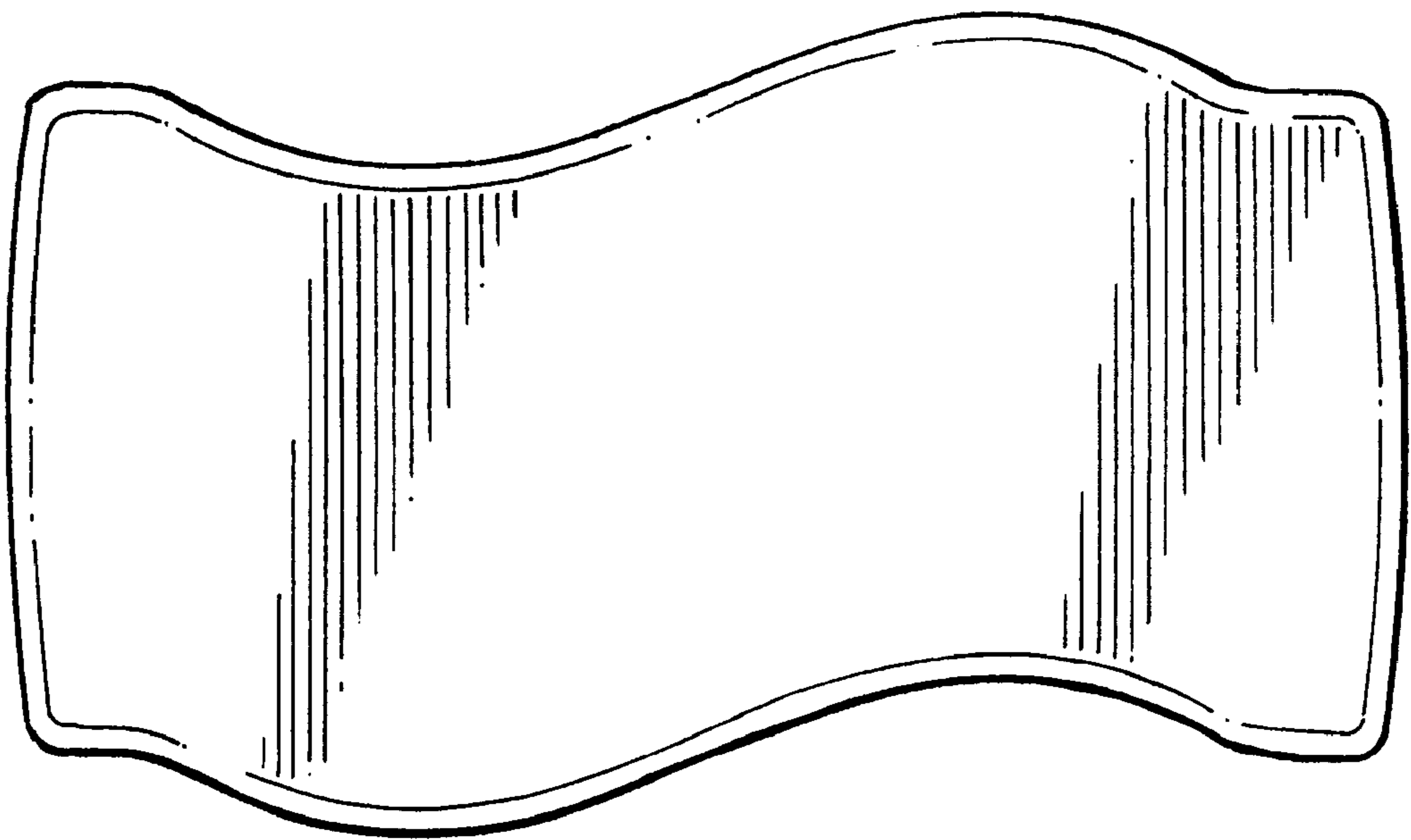
